[57] CLAIM

The ornamental design for a combined wristwatch and toy aircraft, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front side elevational view of a combined wristwatch and toy aircraft showing my new design, the rear side elevational view being substantially a mirror image thereto;

FIG. 2 is a top plan view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a right side elevational view of FIG. 6;

FIG. 5 is a left side elevational view of FIG. 6;

FIG. 6 is a top and left front perspective view of the toy aircraft watch with the holder/strap omitted for clarity of illustration;

FIG. 7 is a top and left front perspective view of the holder/strap with the toy aircraft watch omitted for clarity of illustration;

FIG. 8 is a front side elevational view of FIG. 6;

FIG. 9 is a side elevational view of FIG. 6;

FIG. 10 is a top plan view of FIG. 6;

FIG. 11 is a bottom plan view of FIG. 6;

FIG. 12 is a right side elevational view of FIG. 6;

FIG. 13 is a left side elevational view of FIG. 6;

FIG. 14 is an inverted right end elevational view of FIG. 6 reconfigured into the form of a toy aircraft;

FIG. 15 is a rear elevational view of FIG. 14;

FIG. 16 is a top plan view of FIG. 14;

FIG. 17 is a bottom plan view of FIG. 15;

FIG. 18 is a right side elevational view of FIG. 14;

FIG. 19 is a left side elevational view of FIG. 14;

FIG. 20 is a fragmentary top plan view of FIG. 7.

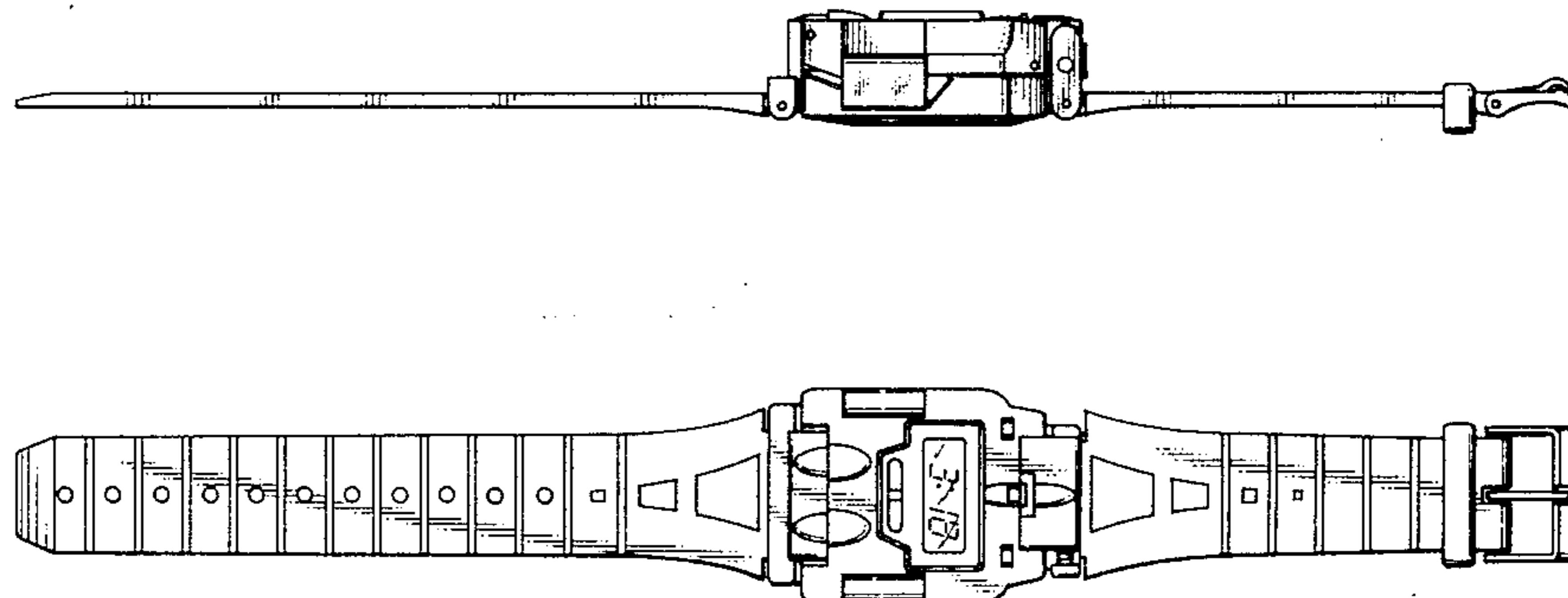

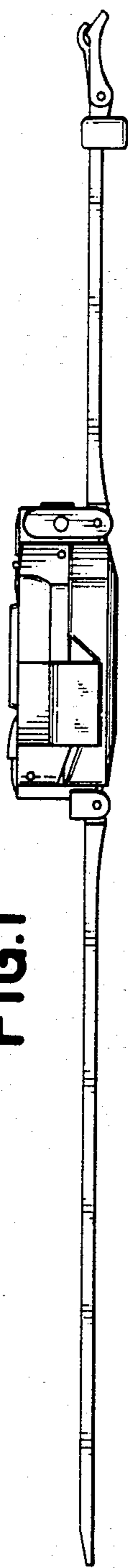

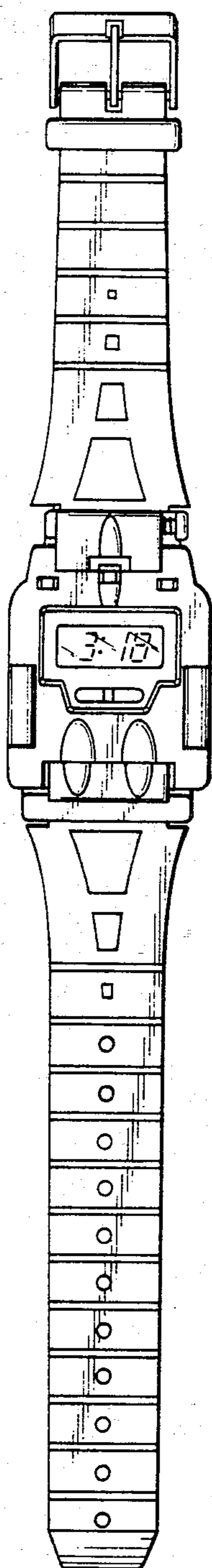

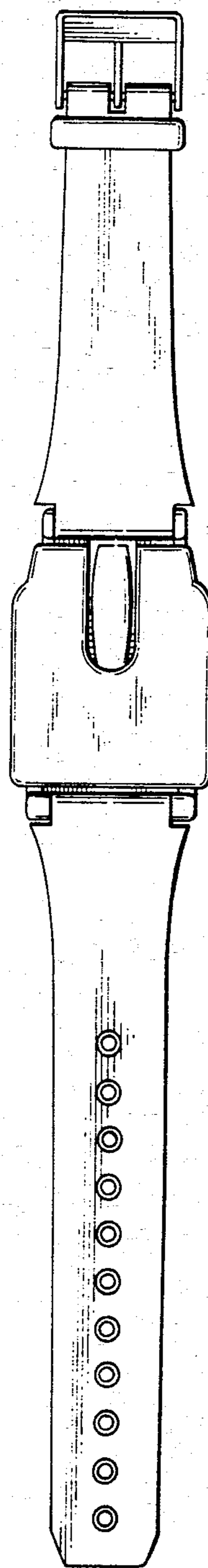

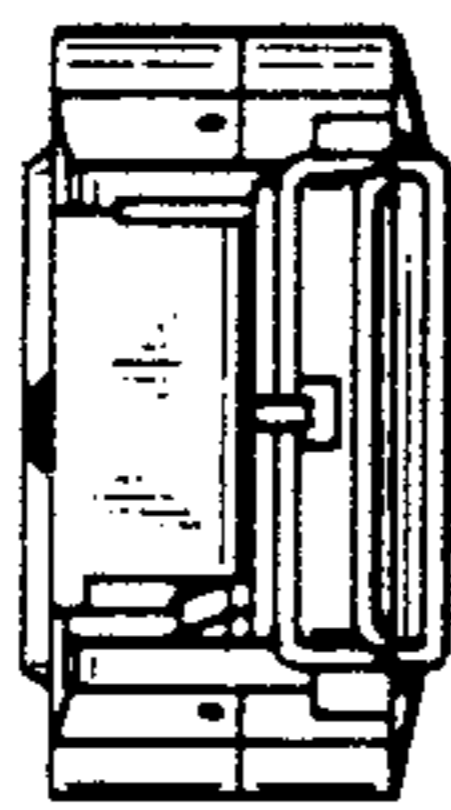

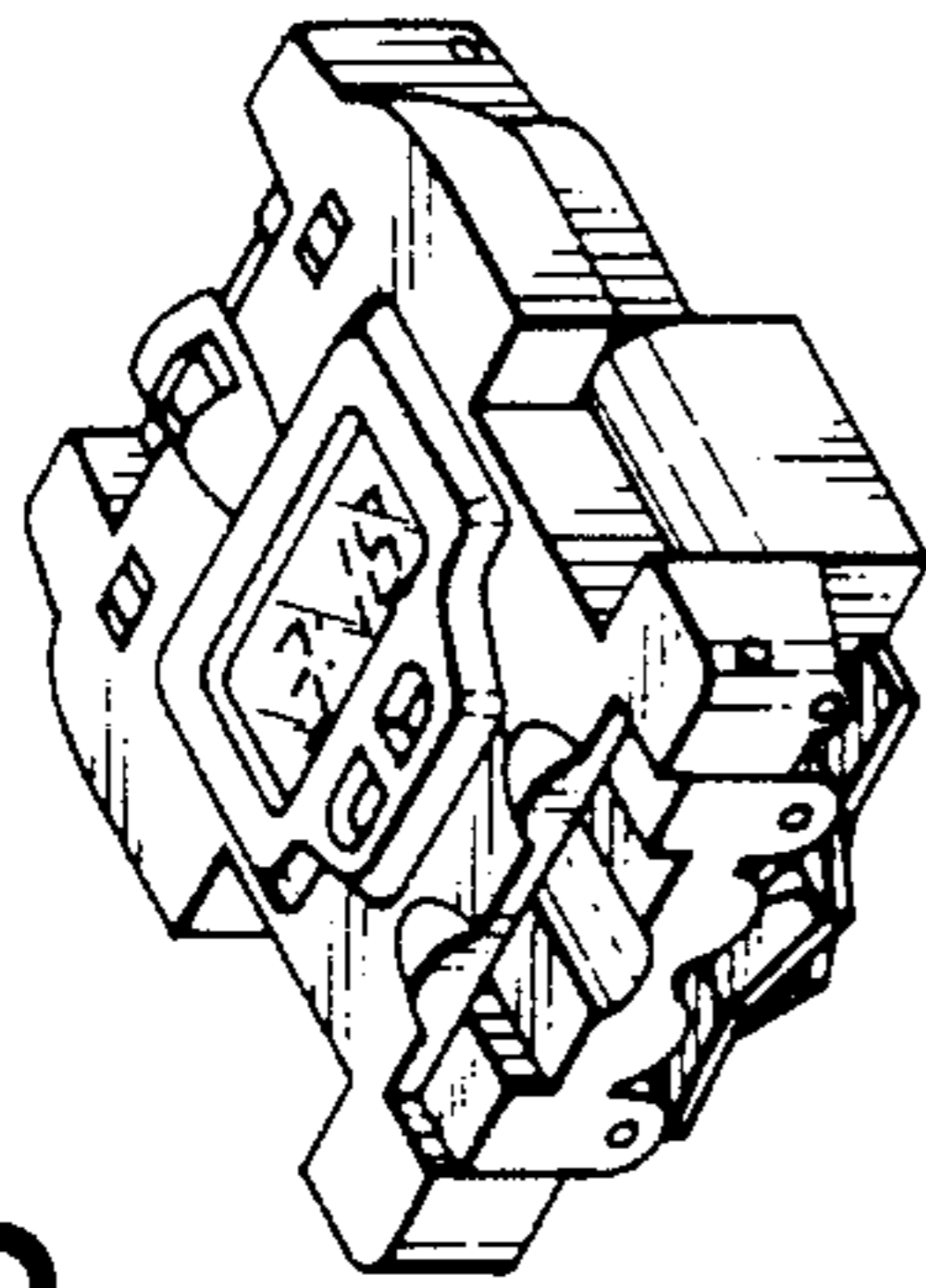

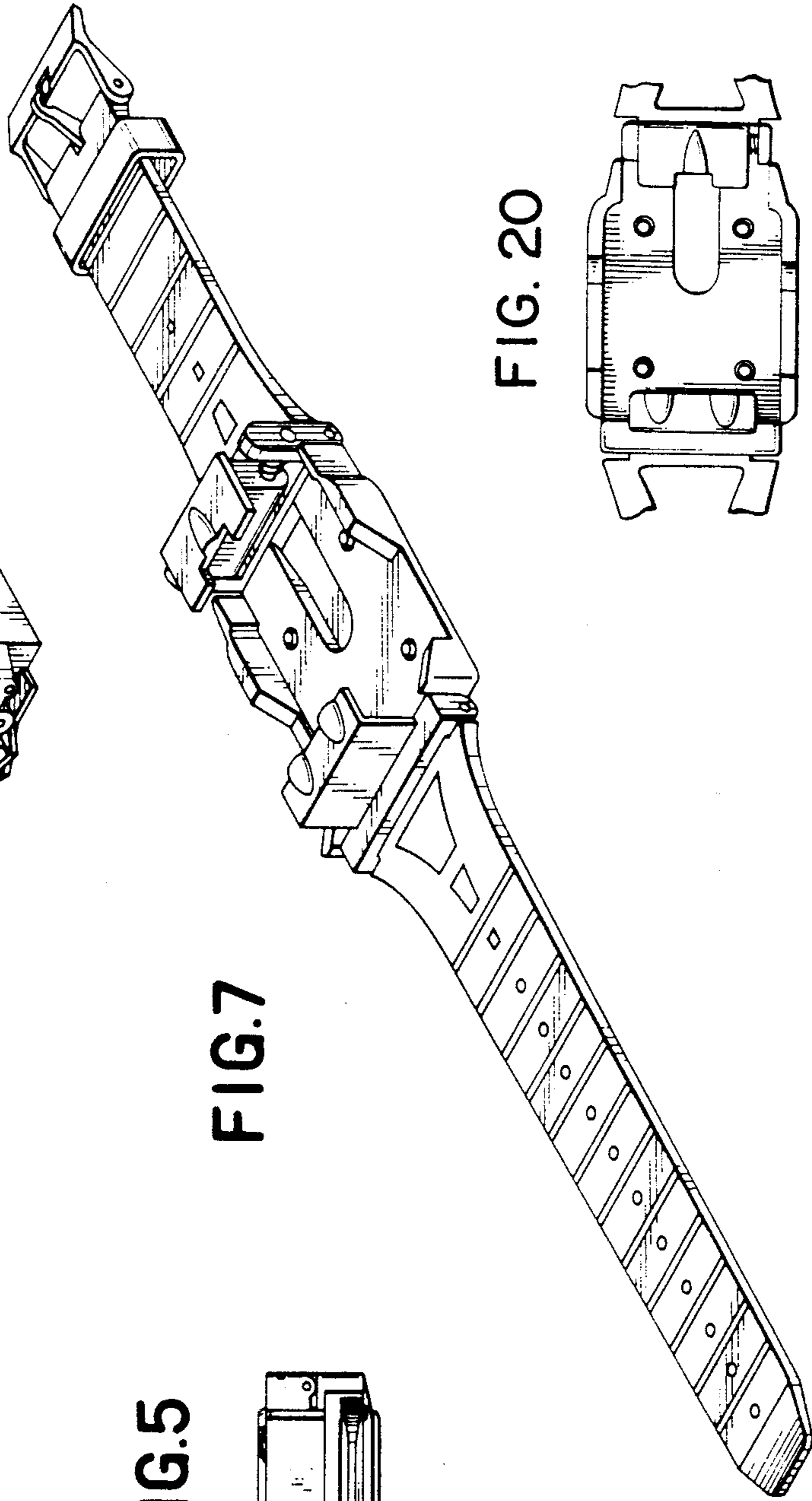
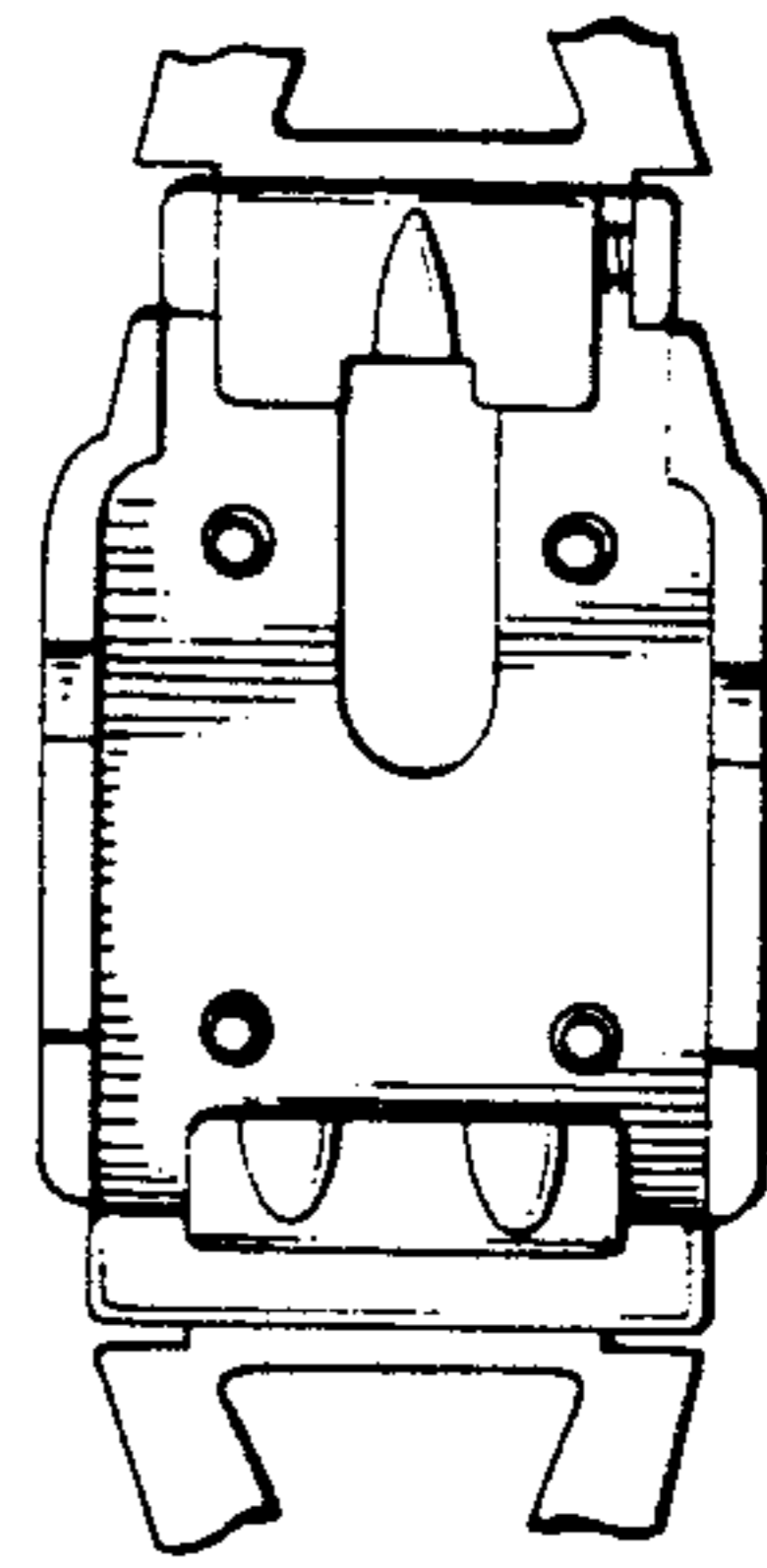
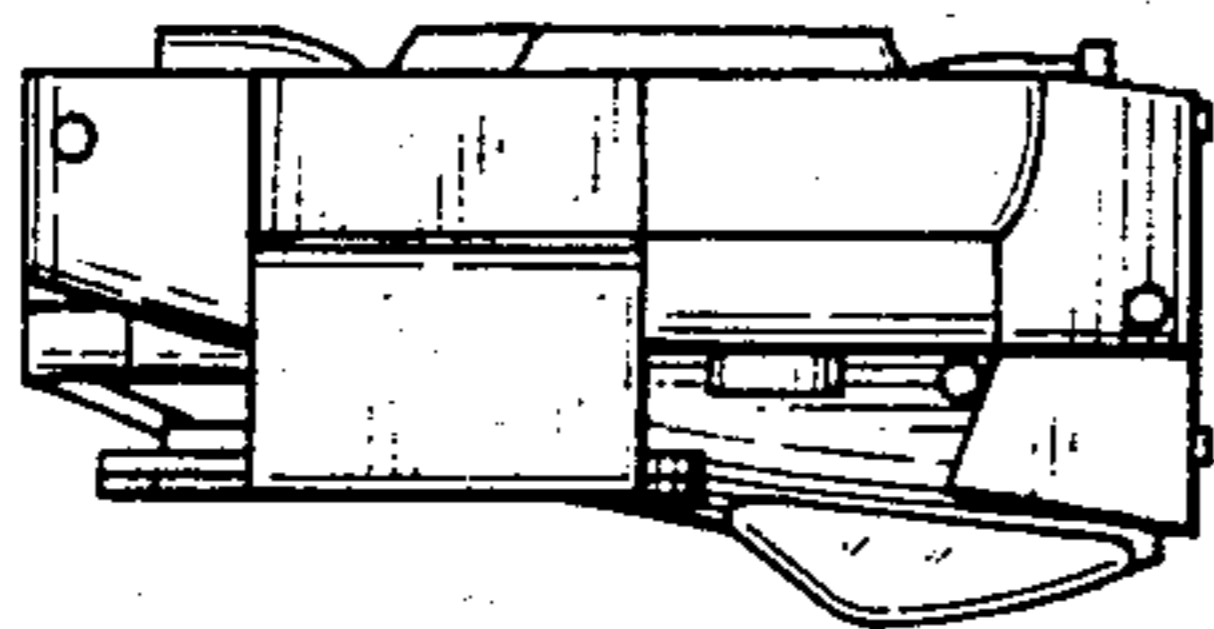


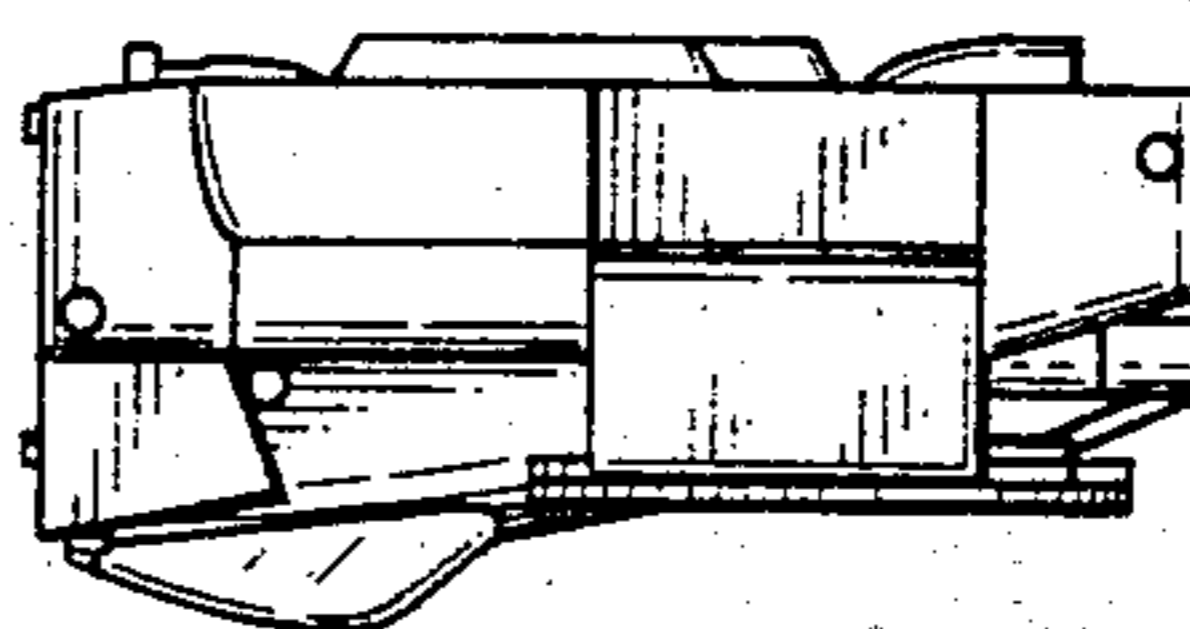

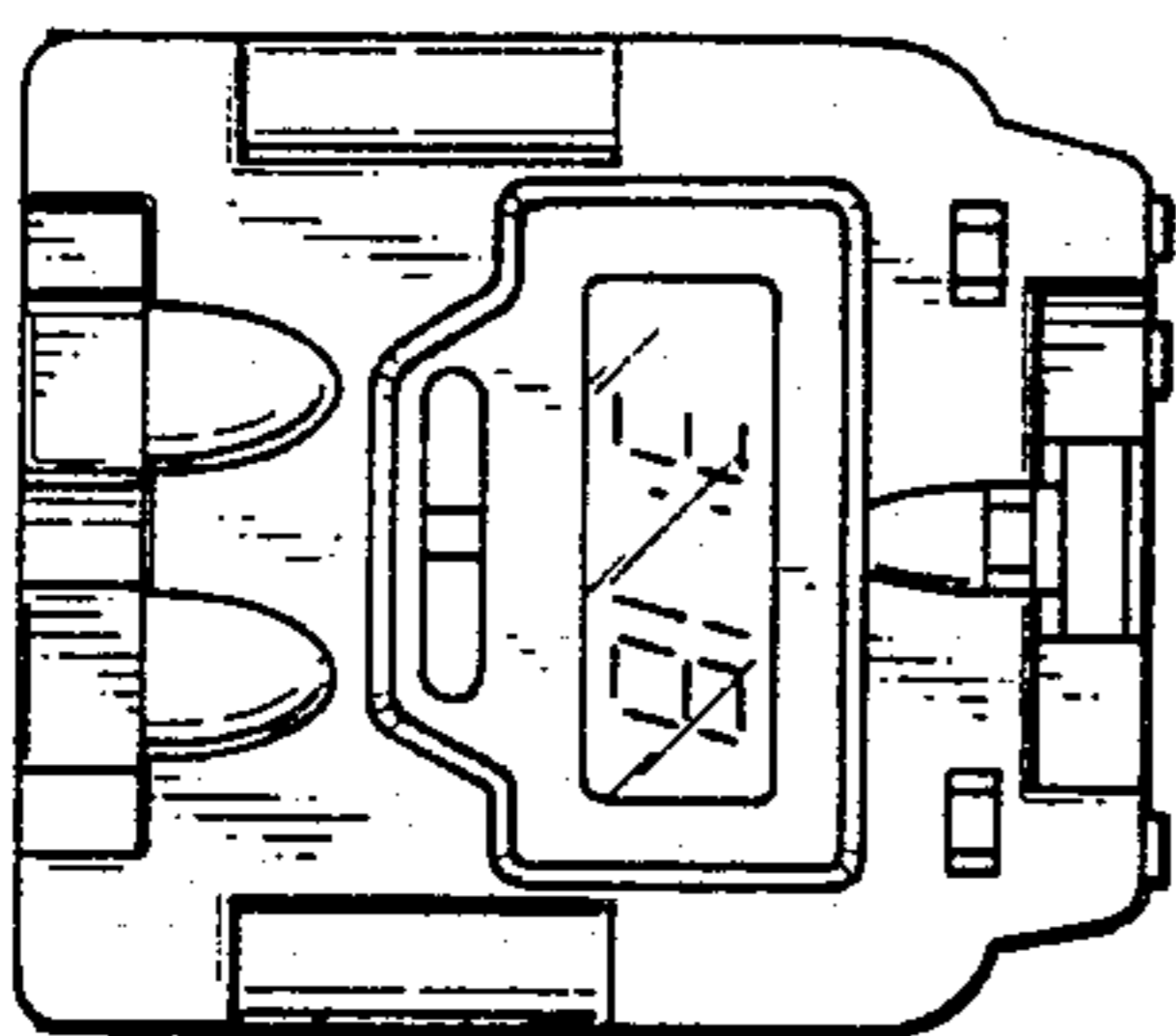

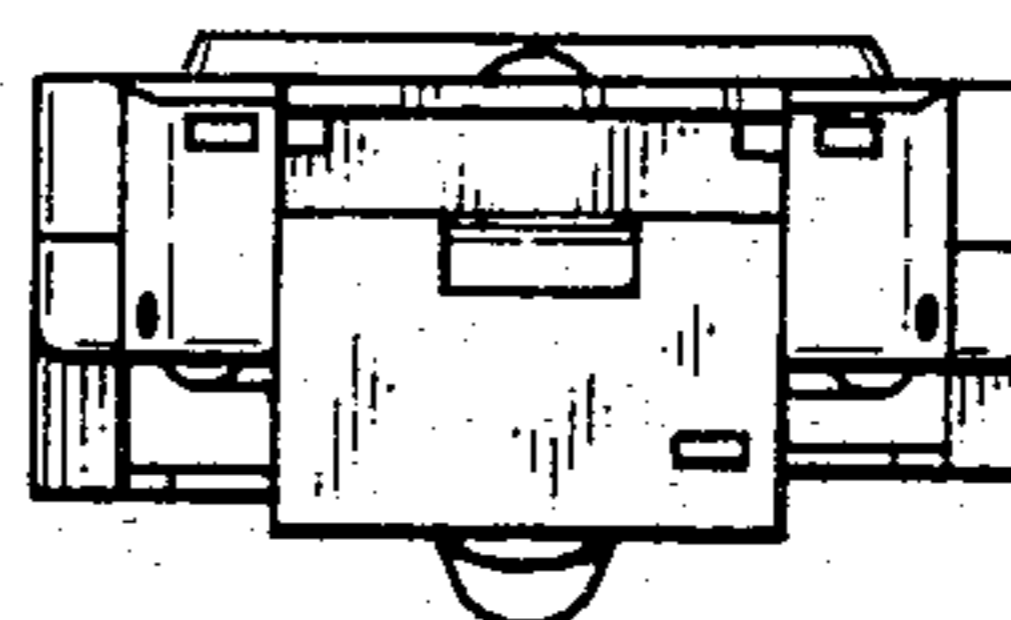

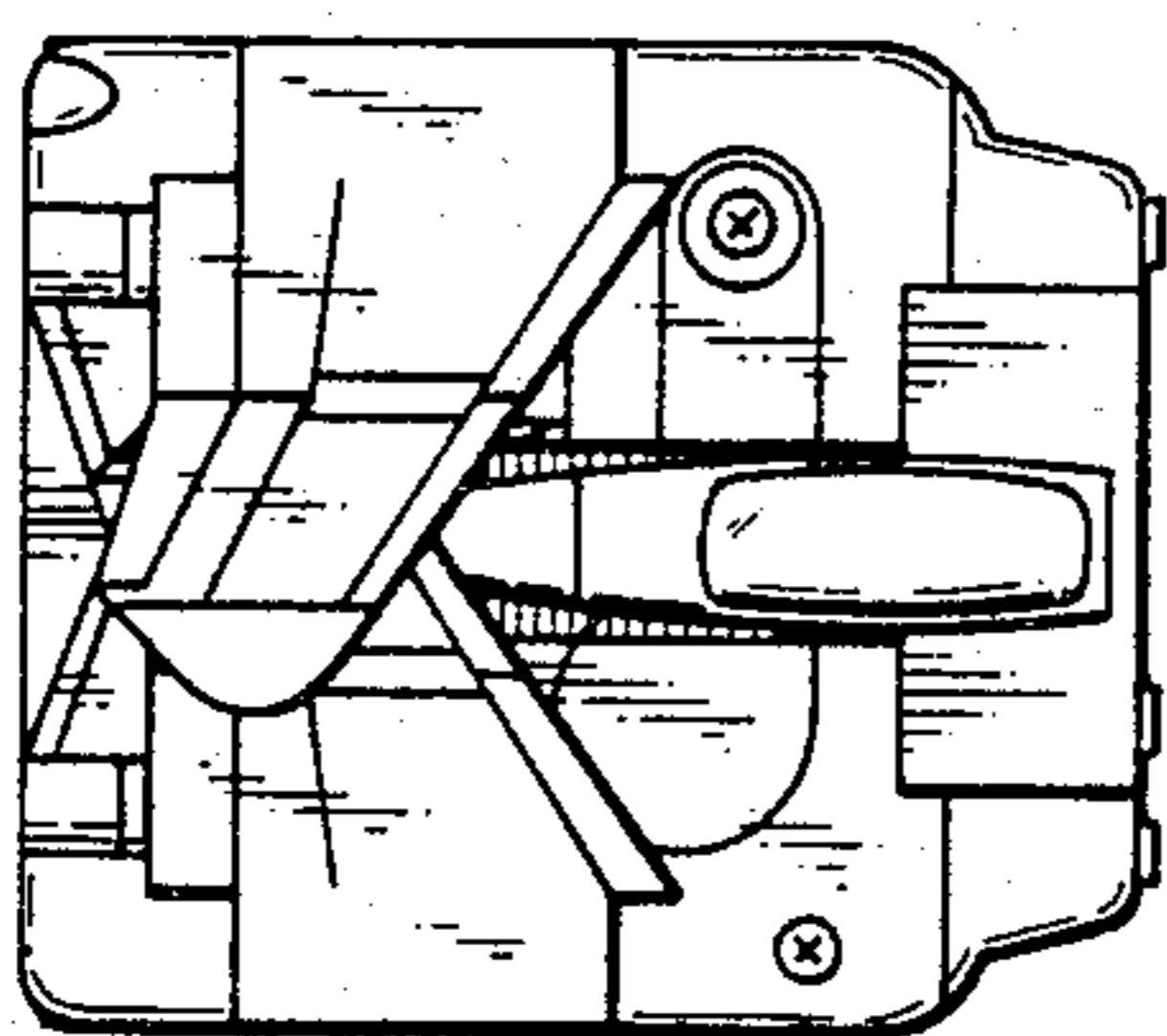

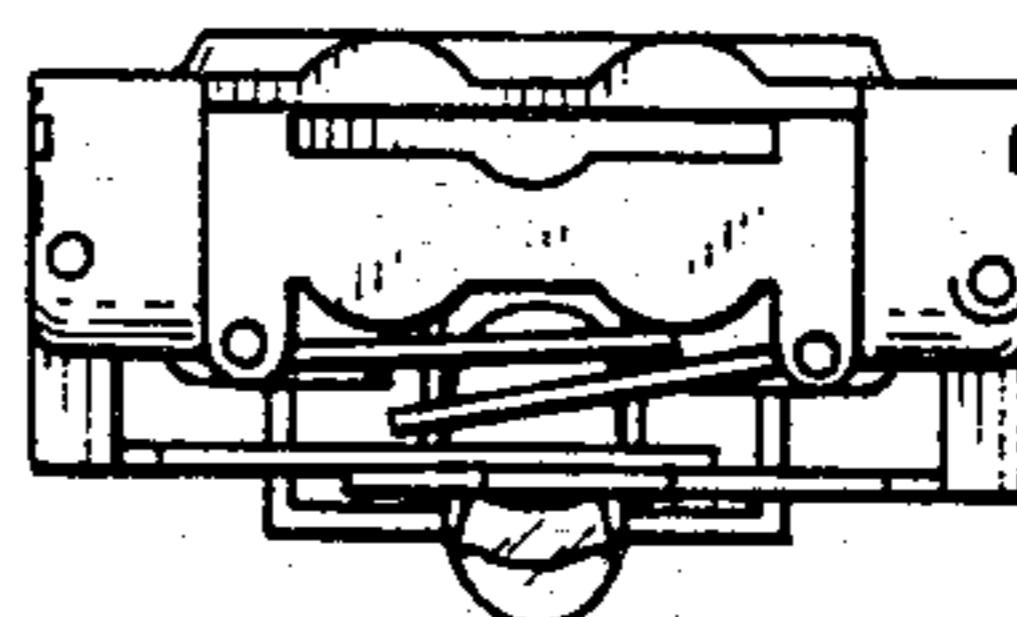

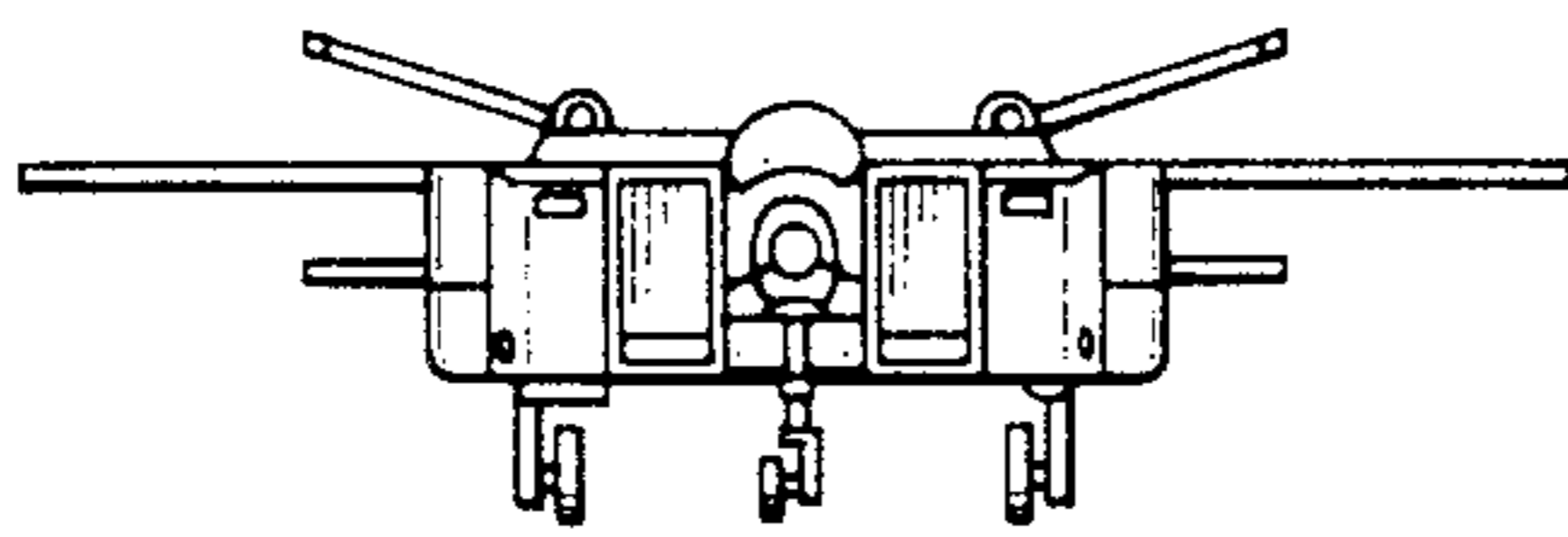

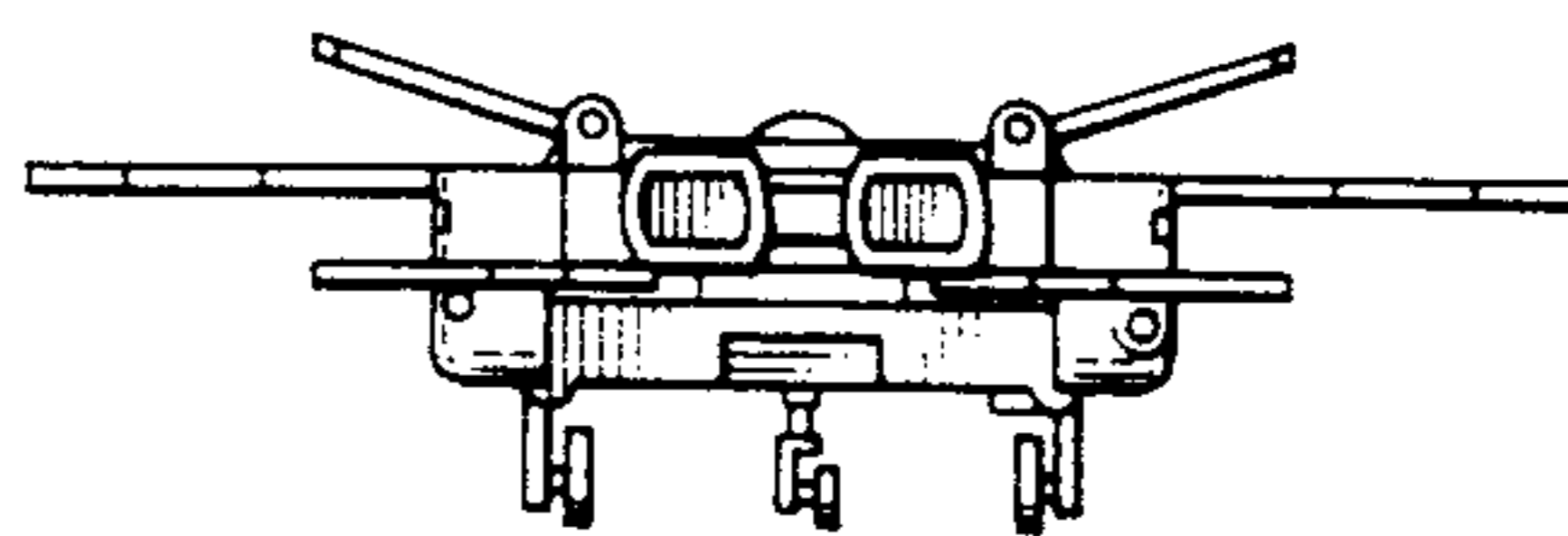

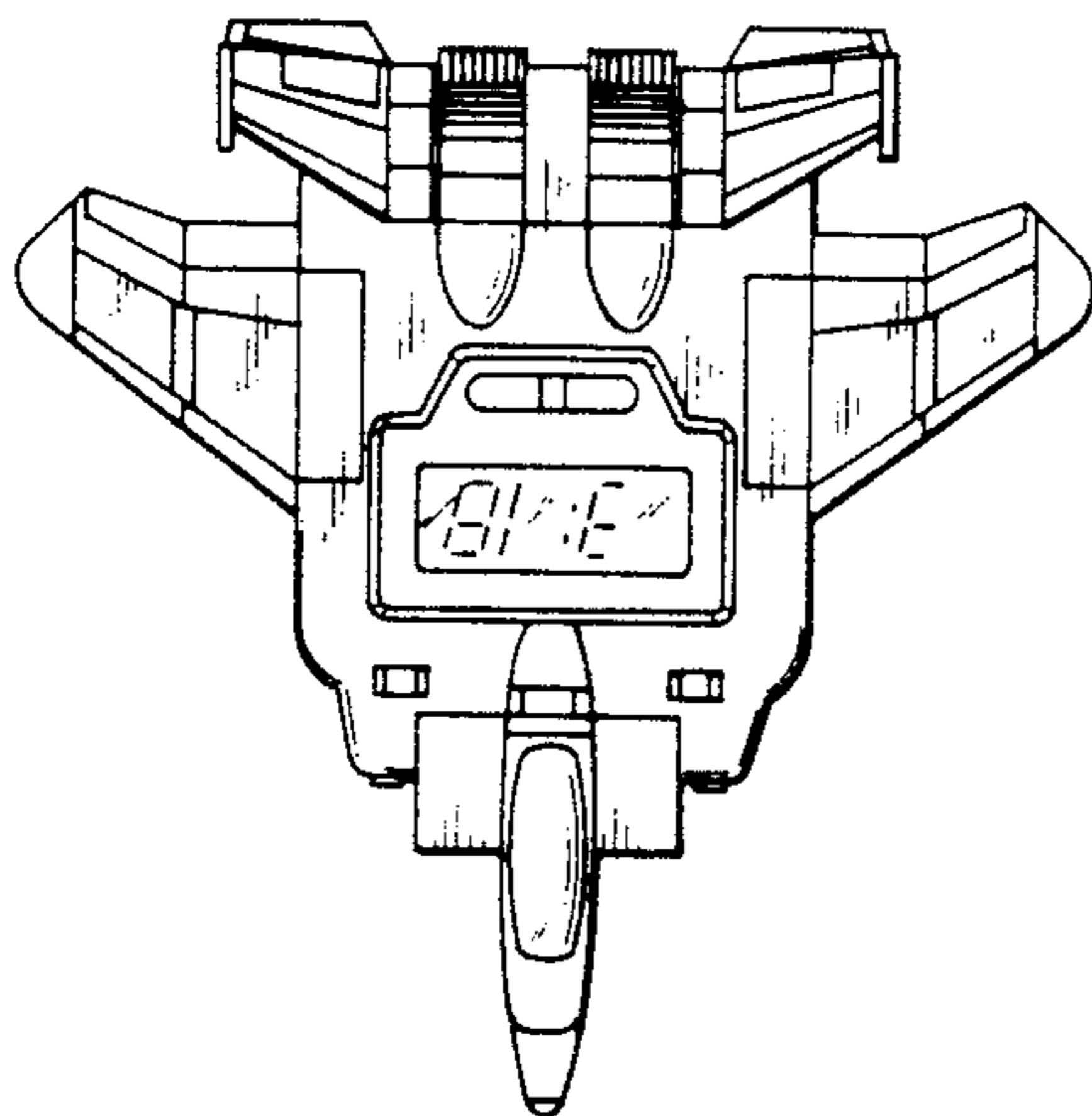

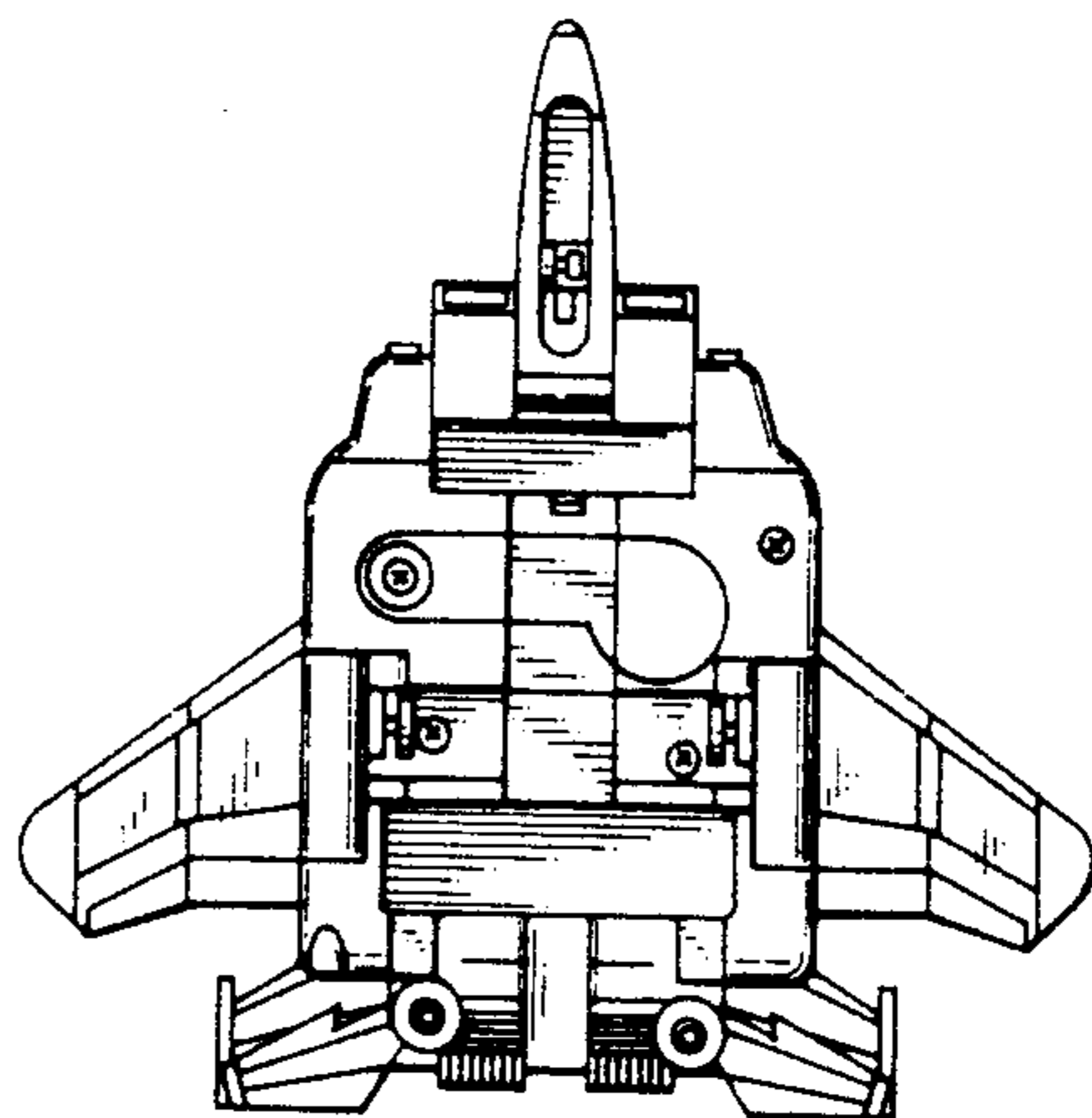

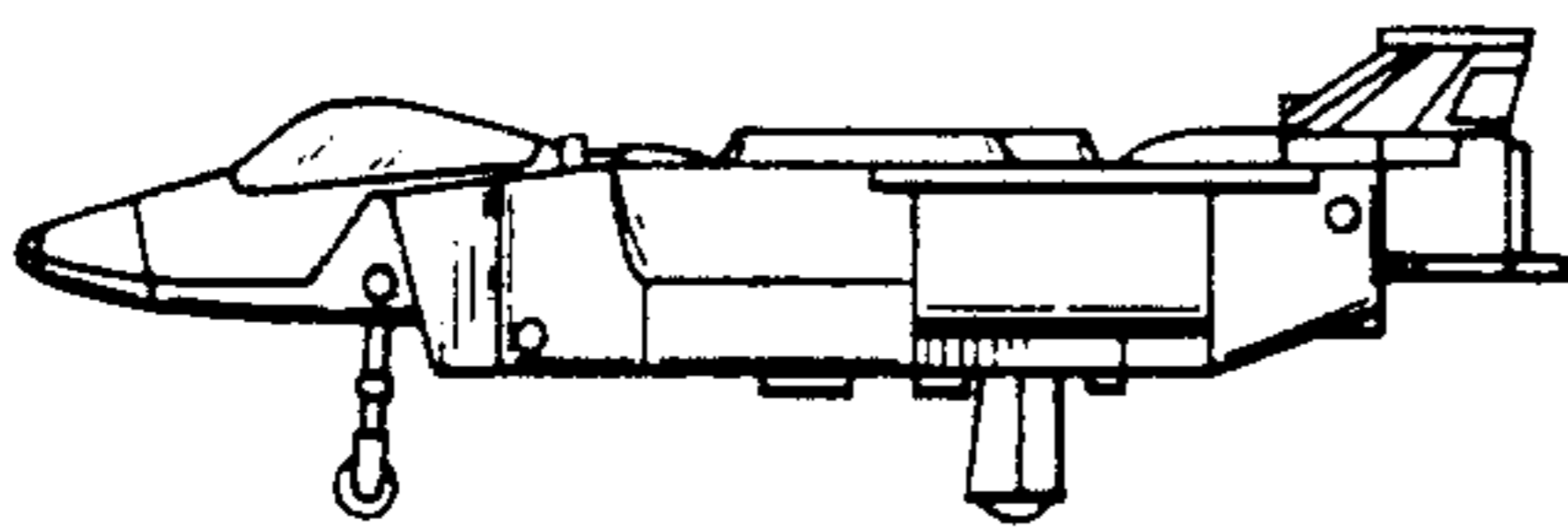
