[57] **CLAIM**

The ornamental design for a housing for a medical disk filter, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view, looking from above, of a housing for a medical disk filter showing my new design;

FIG. 2 is a perspective view thereof, looking from below;

FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a right side elevational view thereof, the left side elevational view being substantially identical;

FIG. 6 is a front view thereof, the rear view being substantially identical;

FIG. 7 is a perspective view, looking from above, of a modified form of FIG. 1;

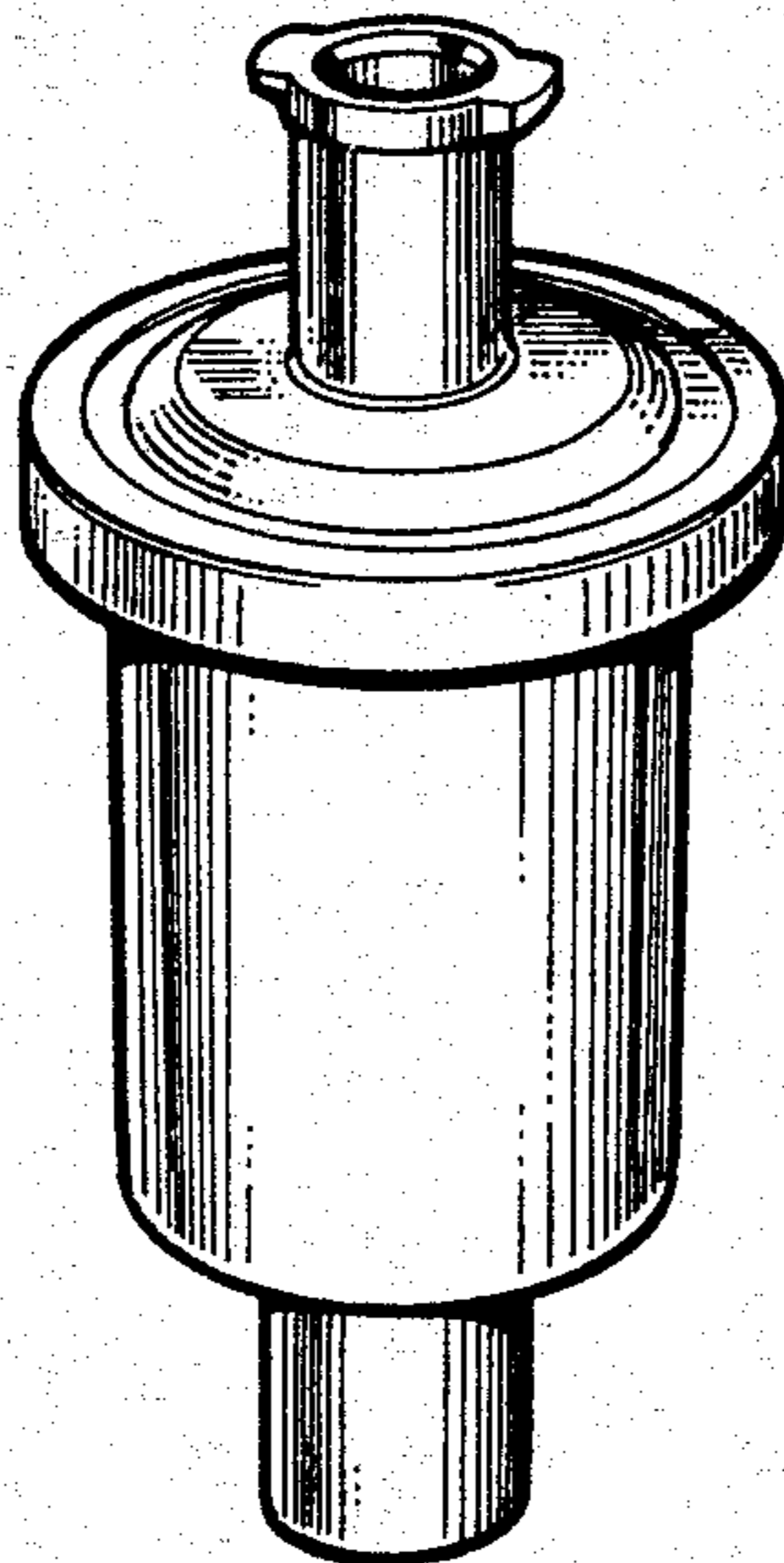
FIG. 8 is a perspective view thereof, looking from below;

FIG. 12 is a front view thereof, the rear view being substantially identical.



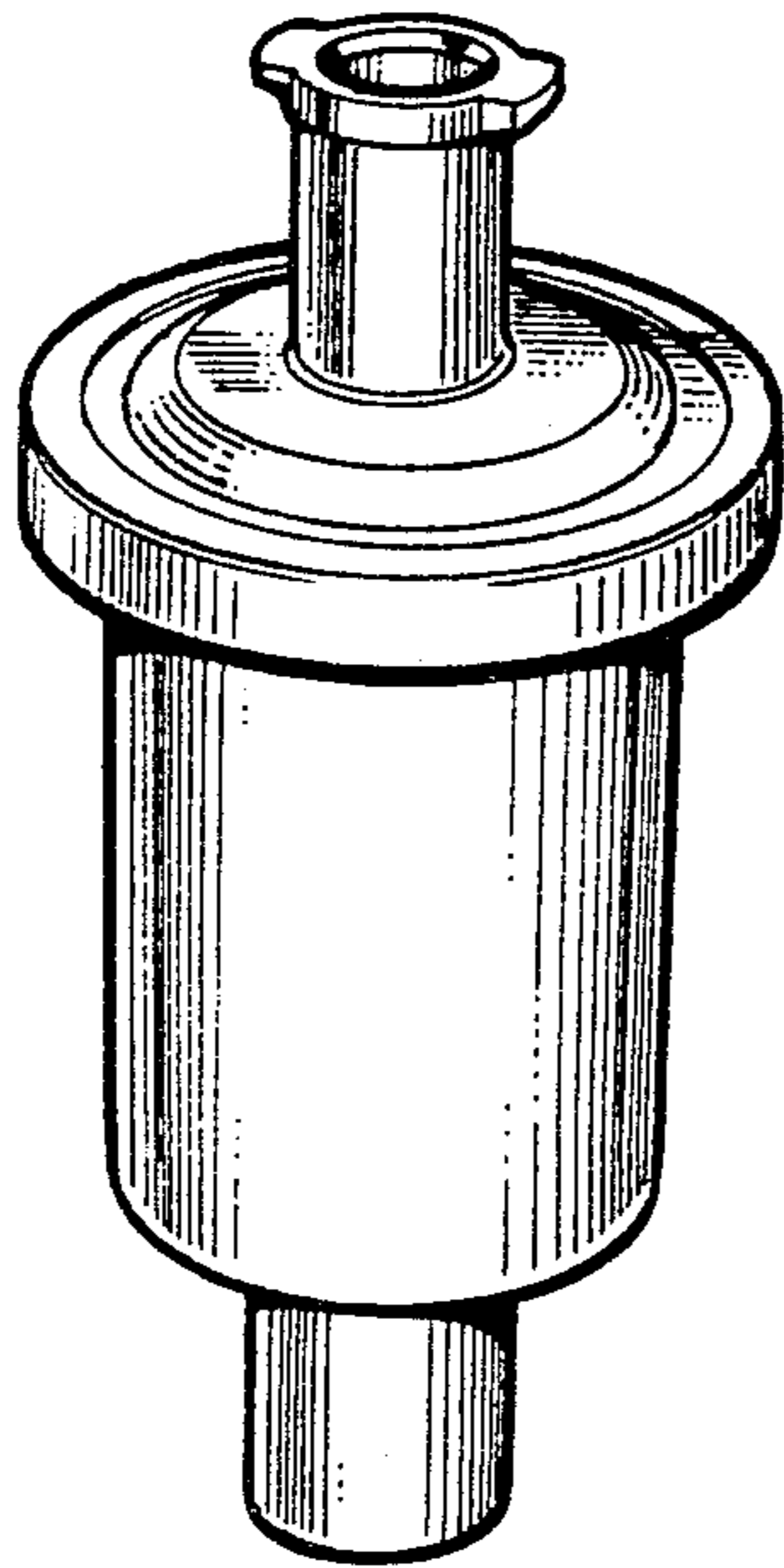

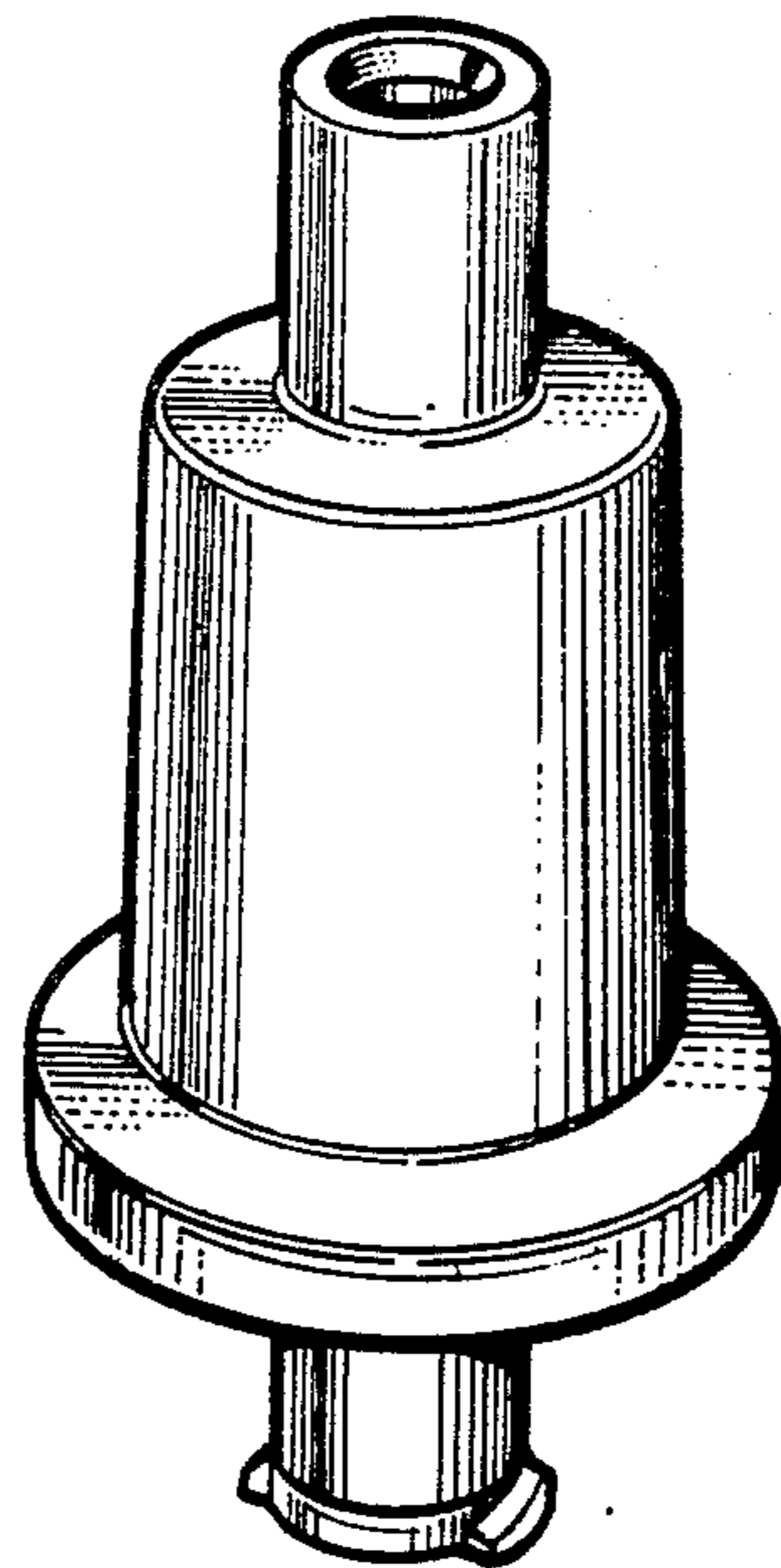

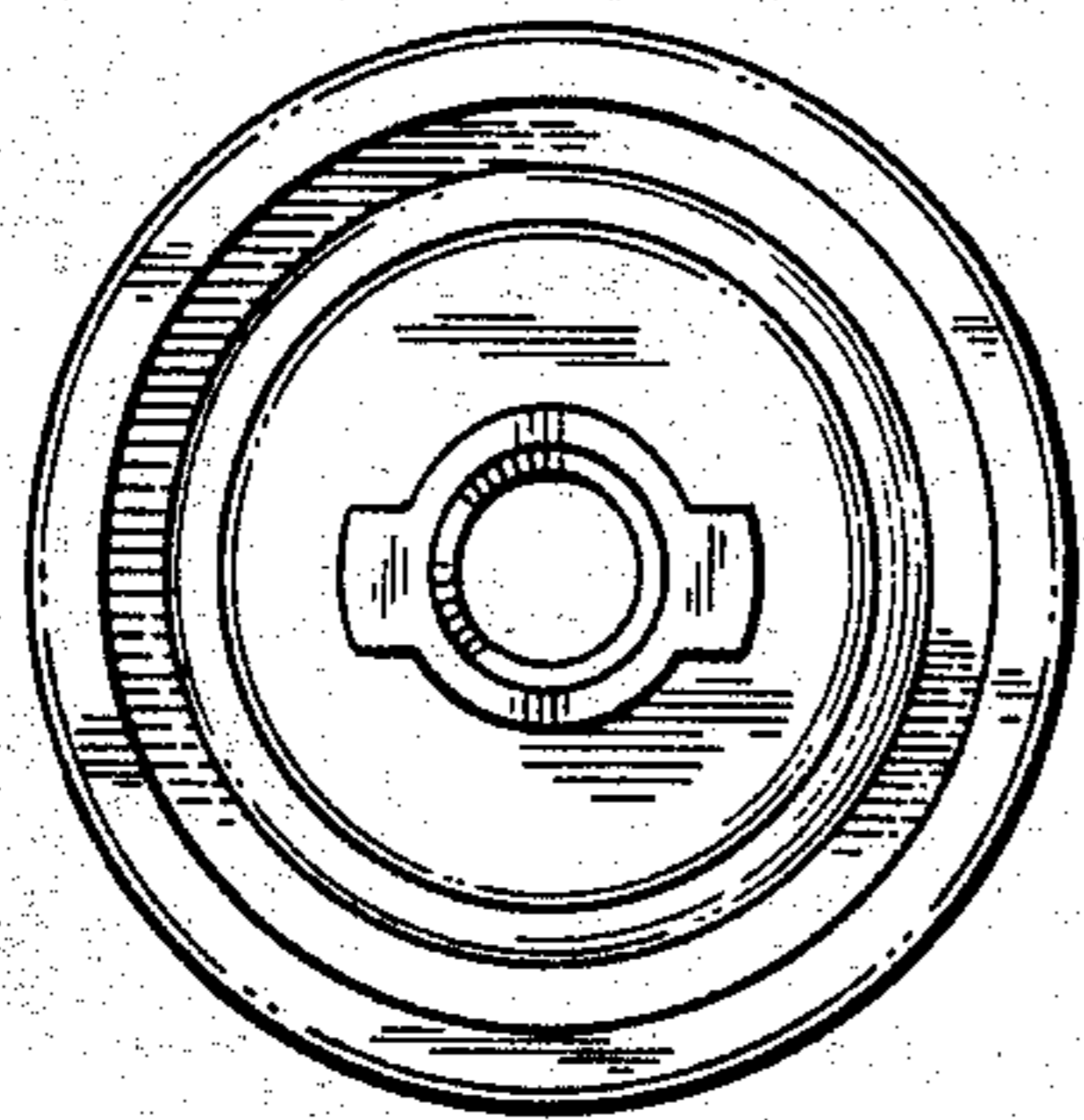

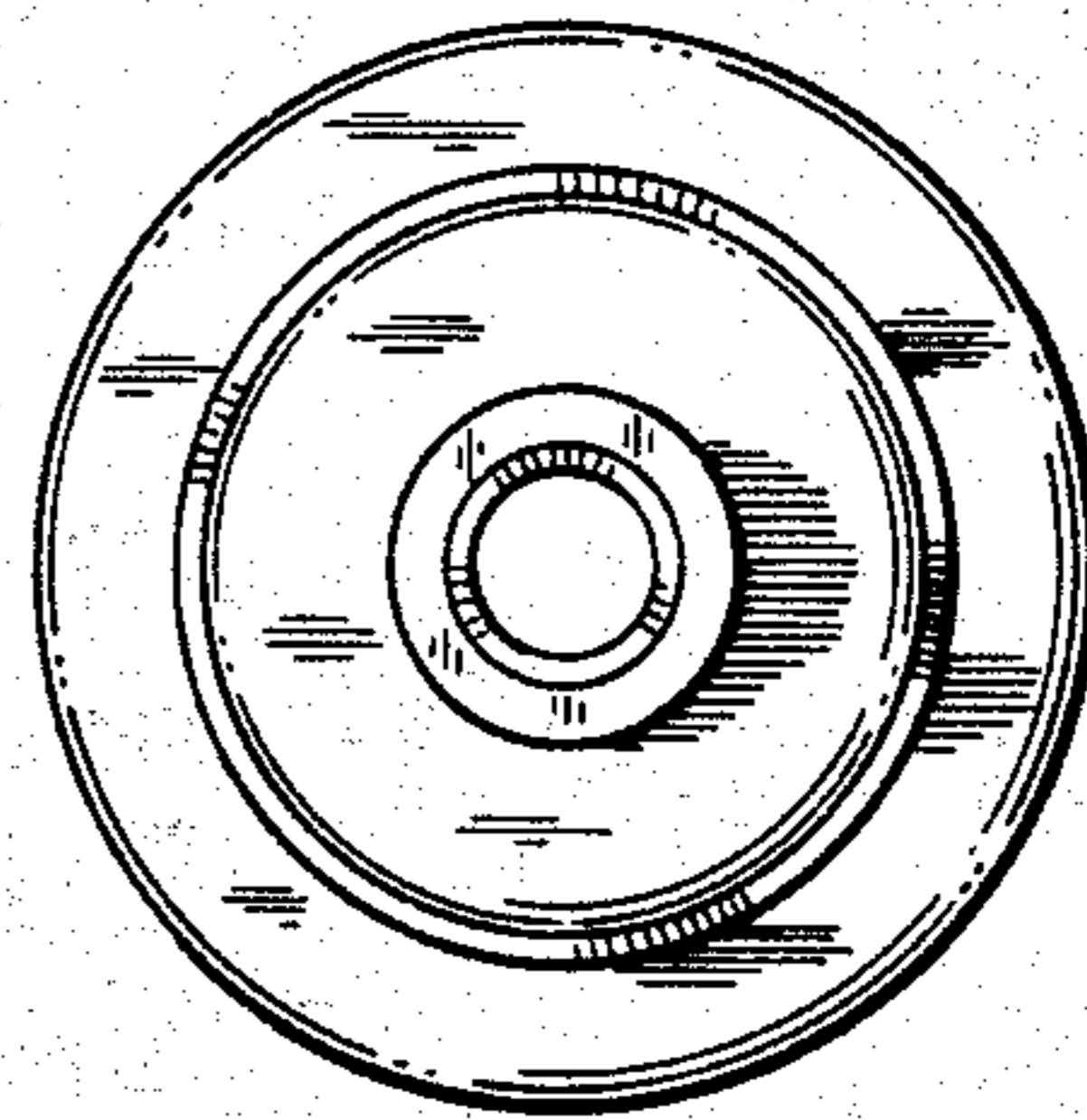

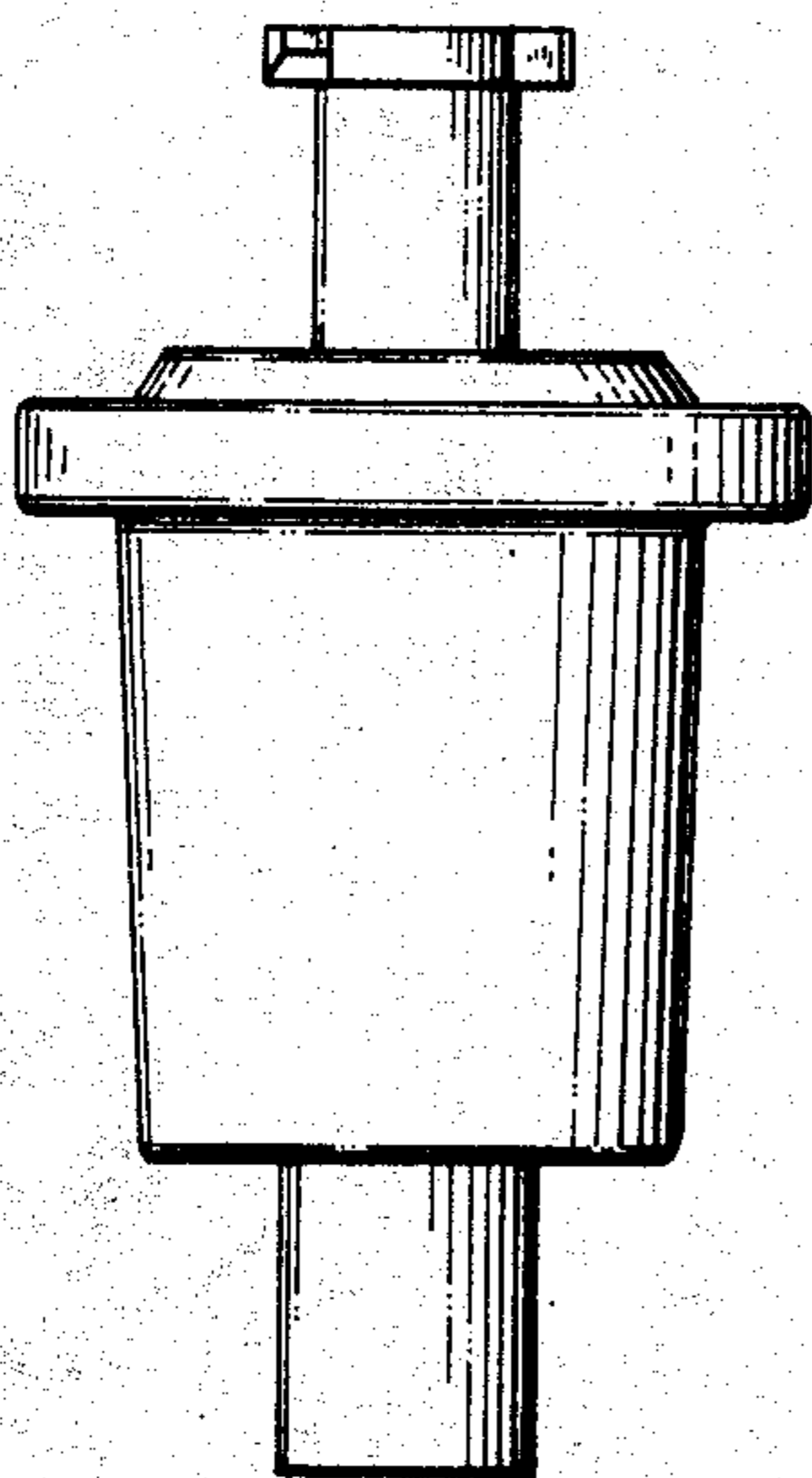

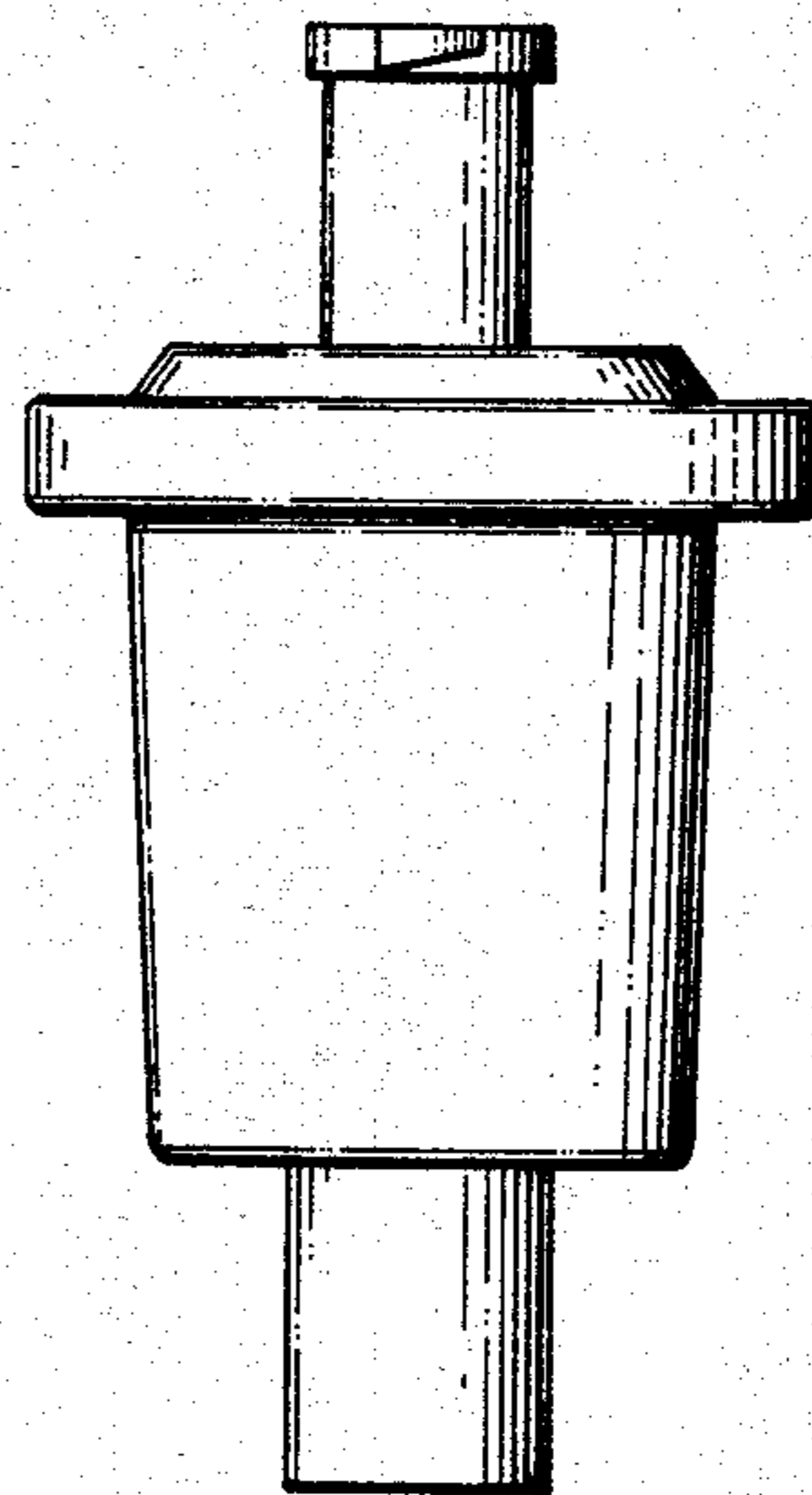

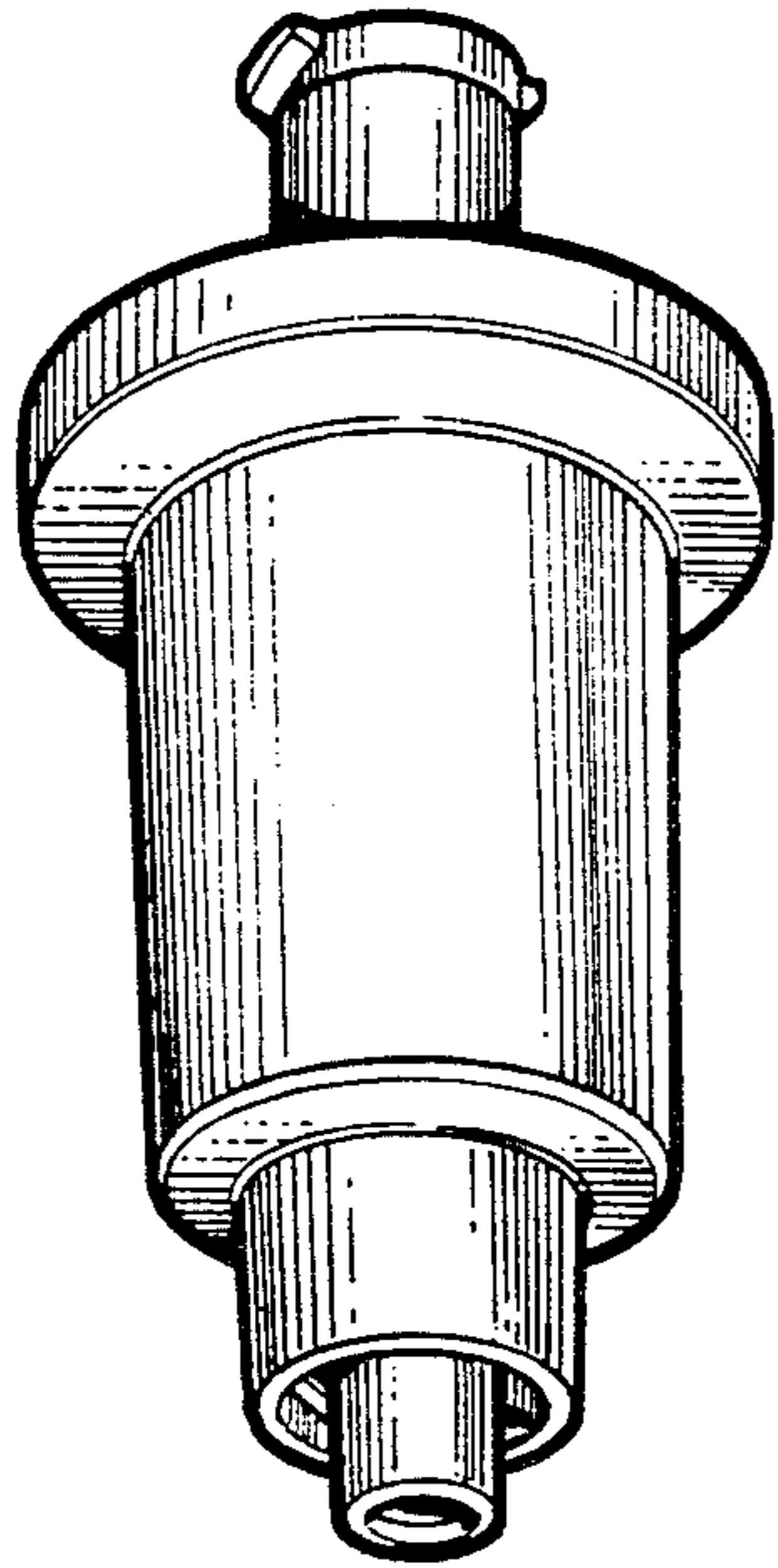

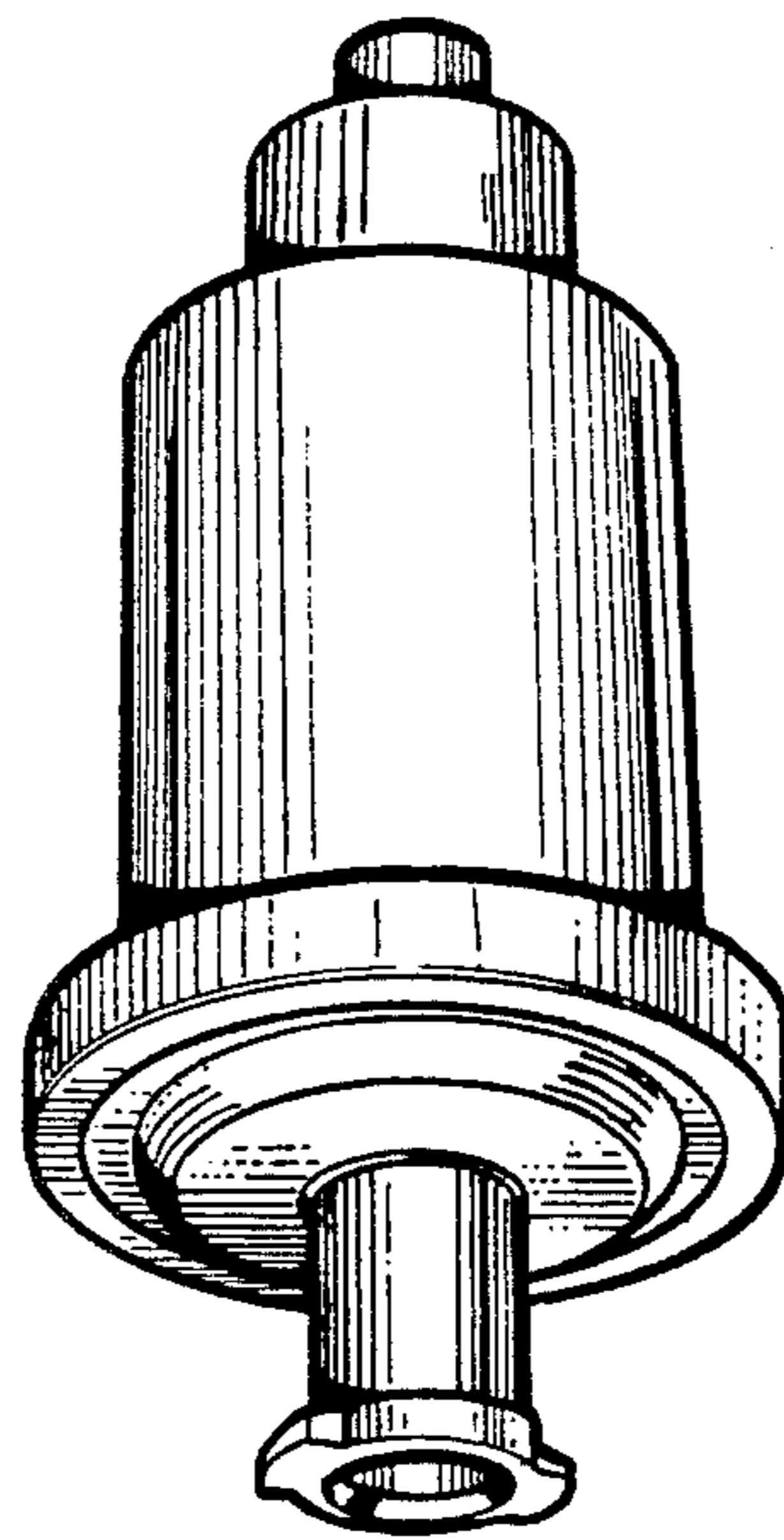

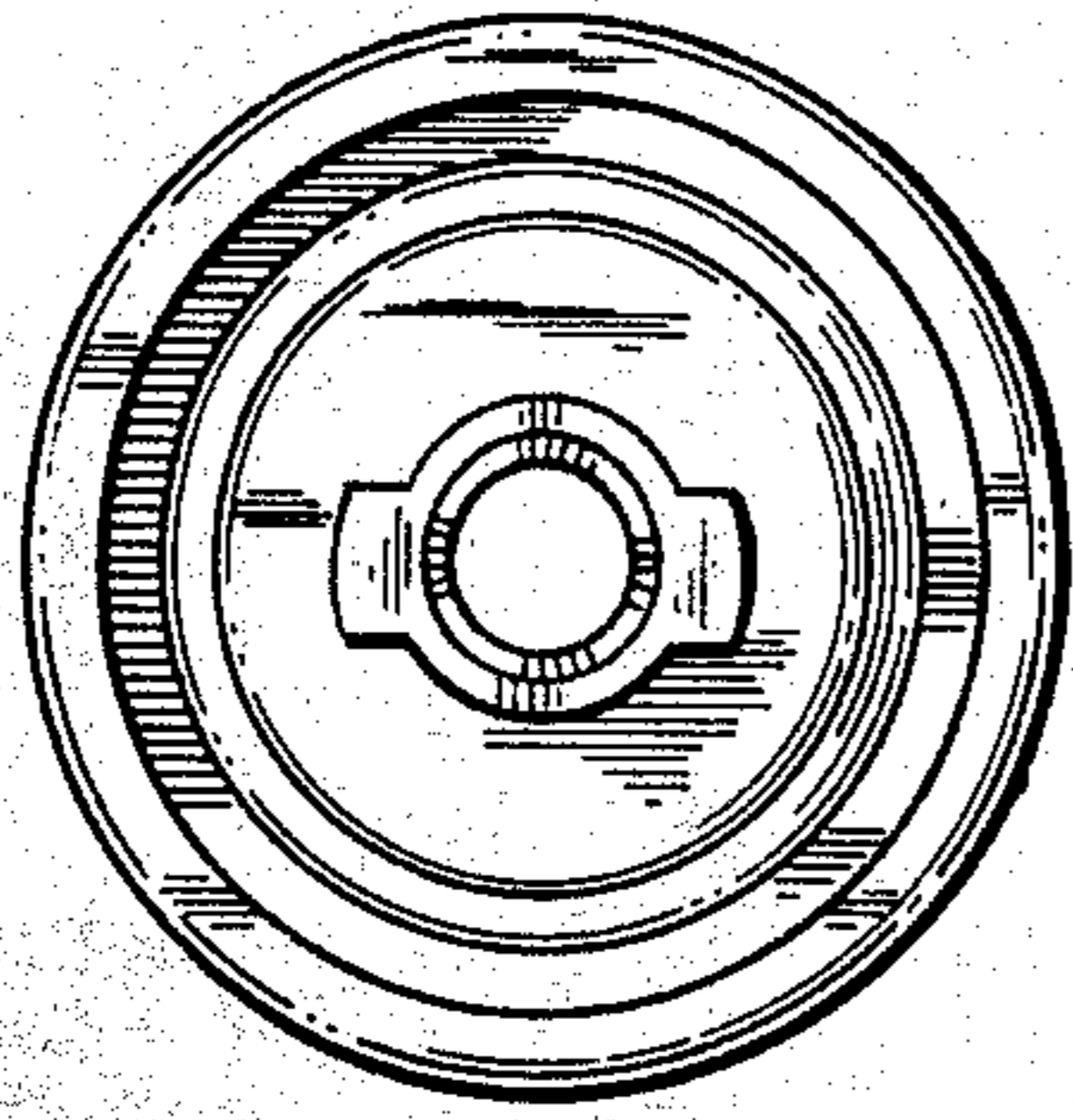

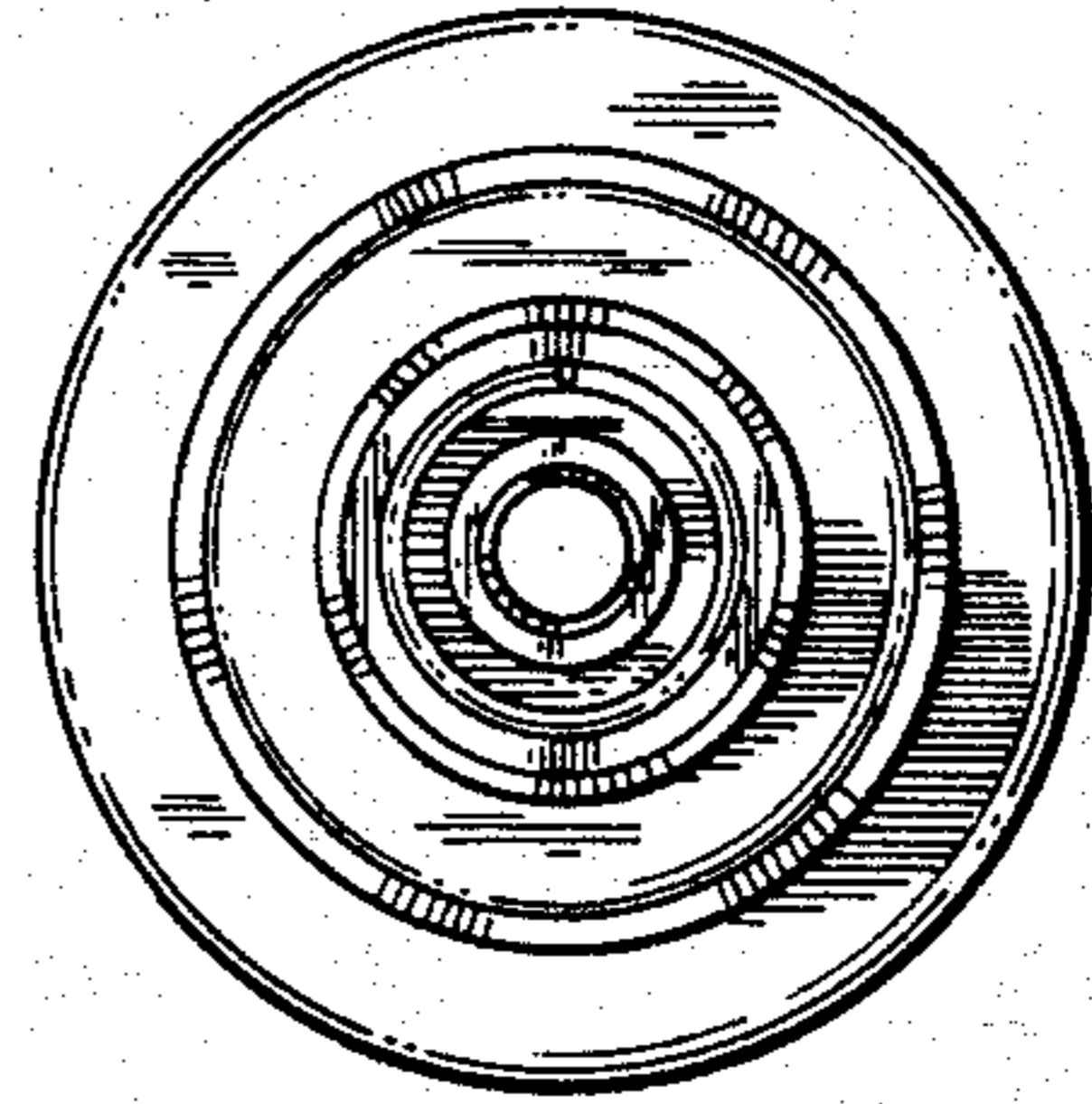

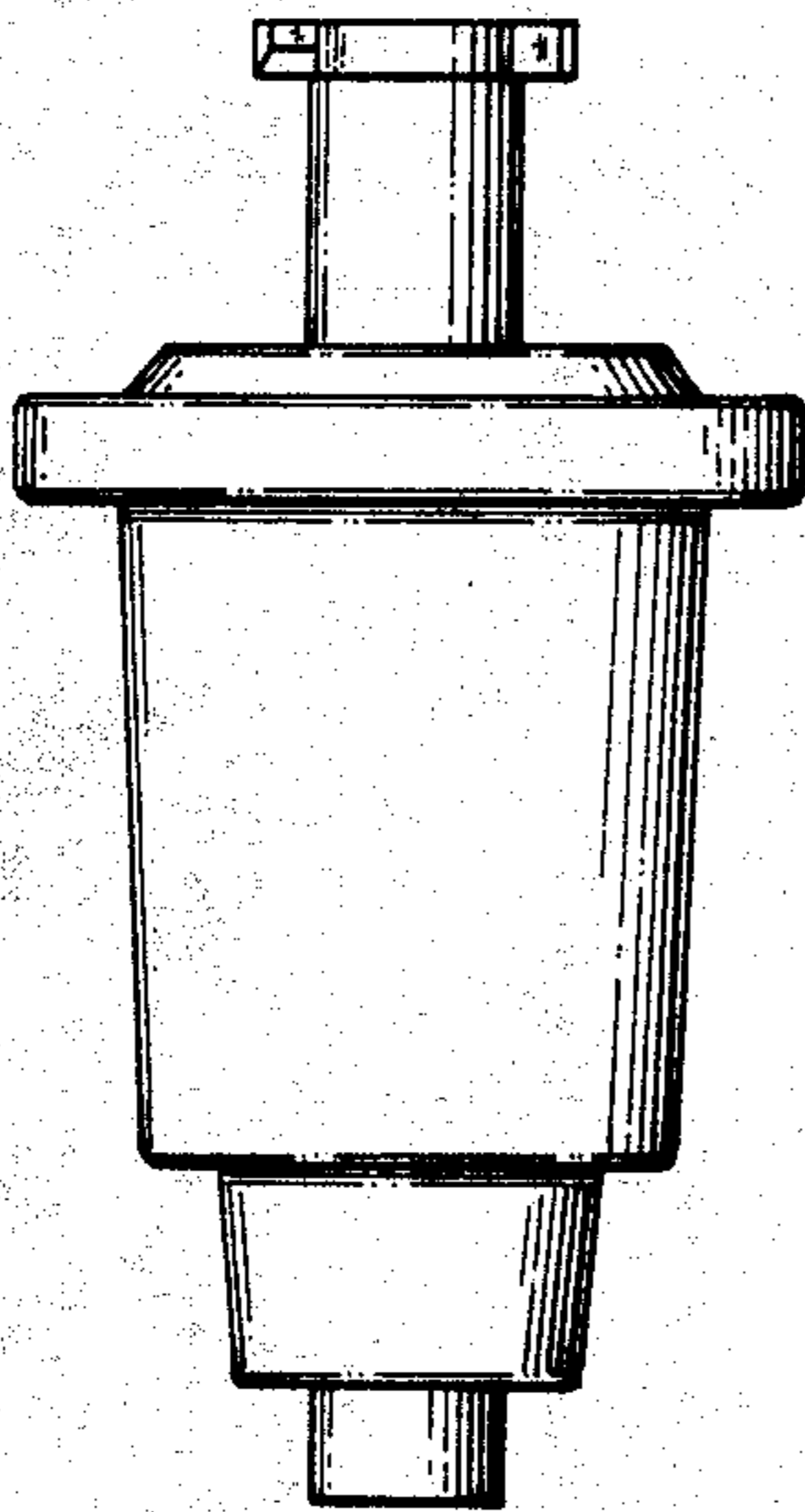

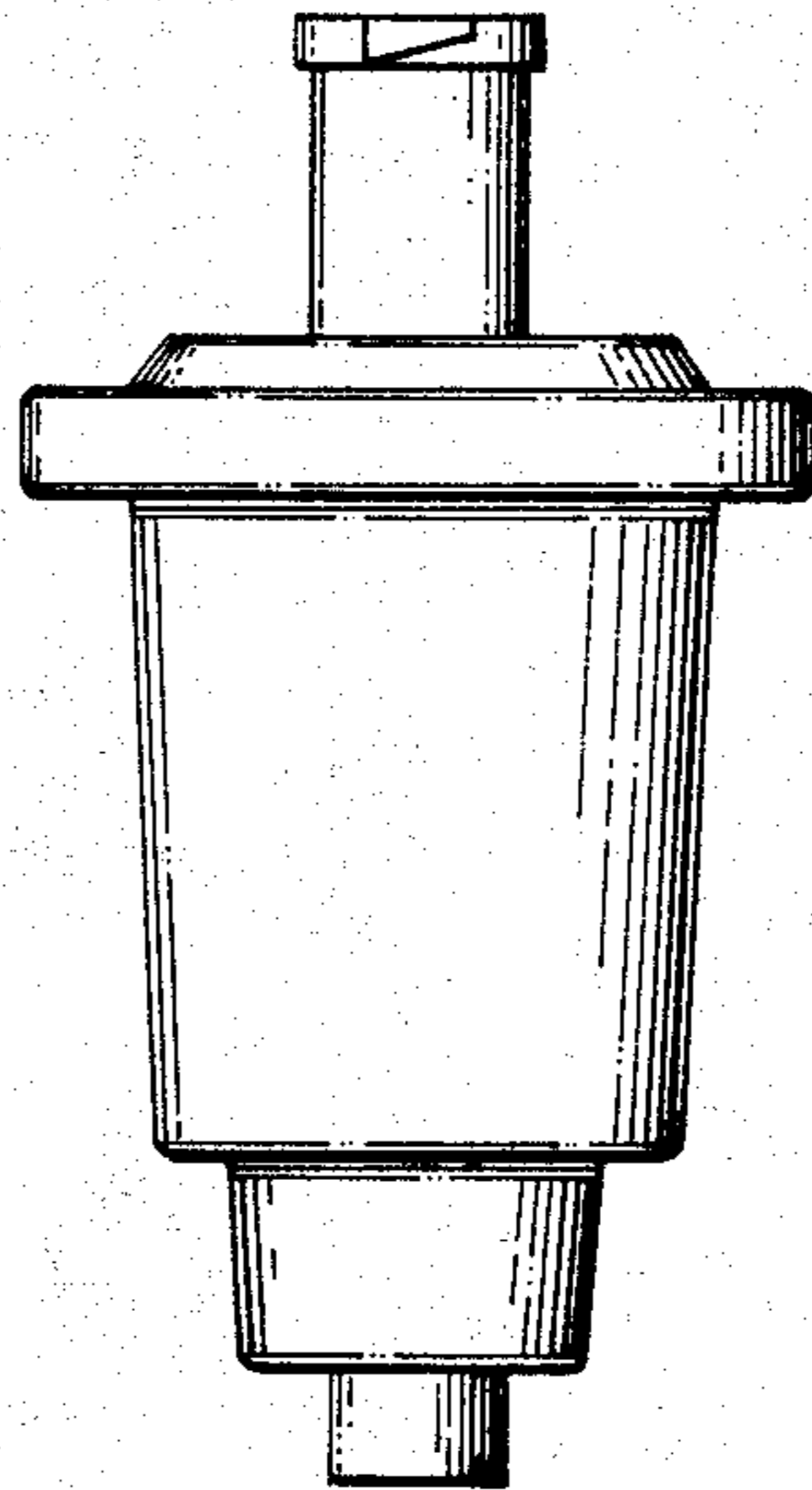
