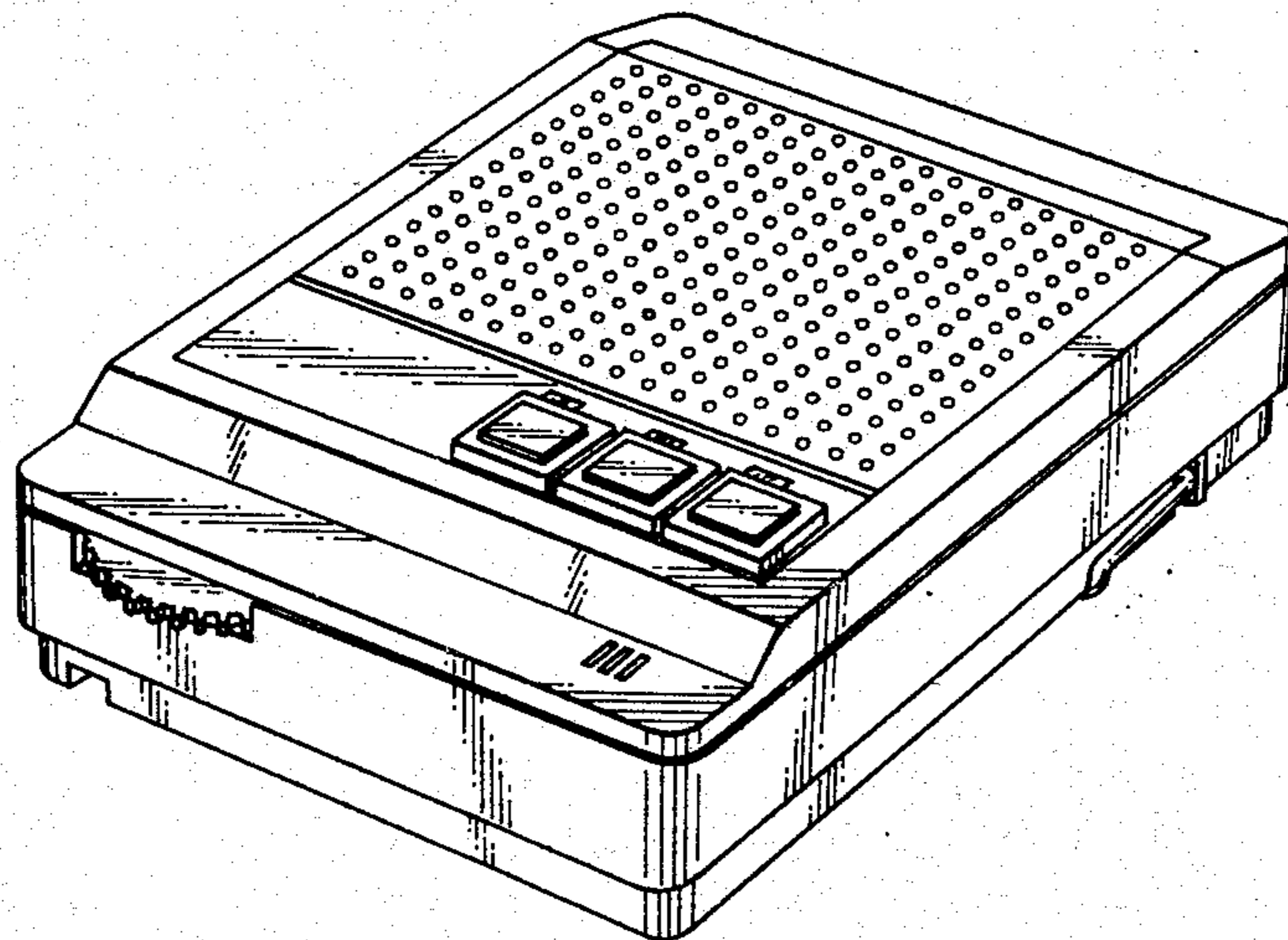

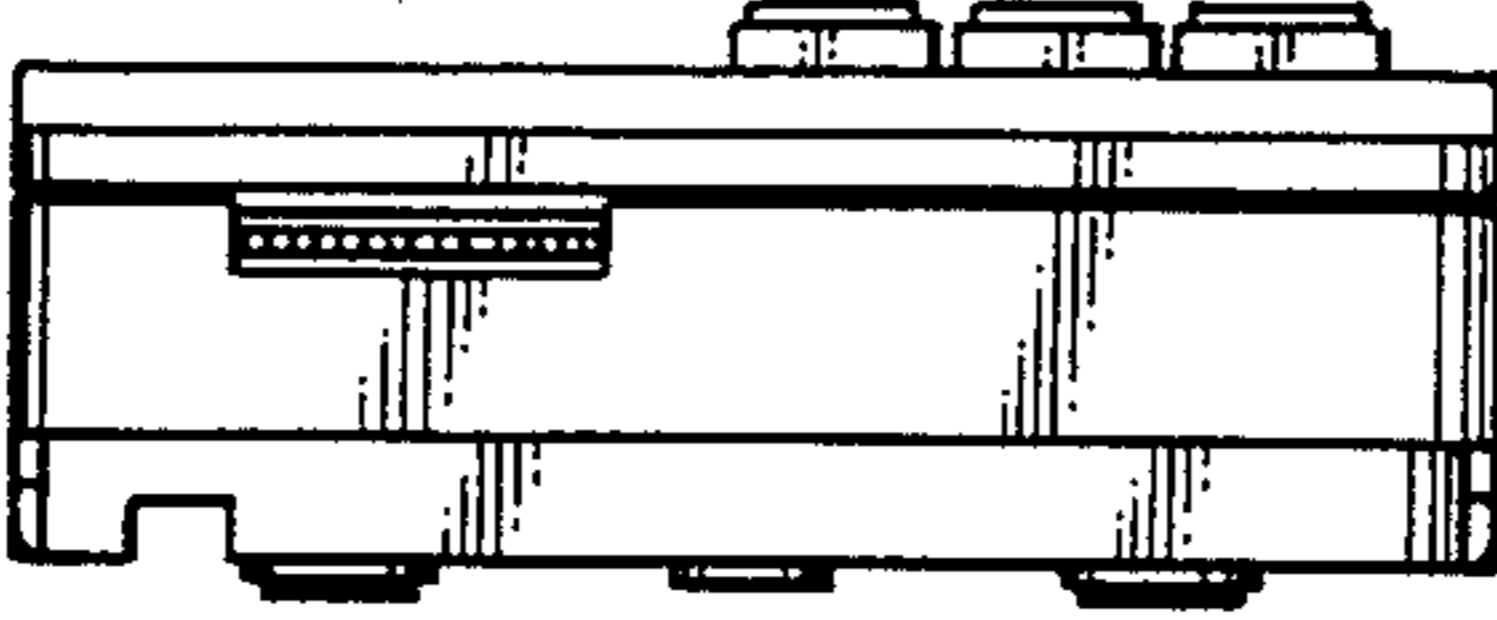
The ornamental design for an electronic intercommunication unit, as shown and described.

DESCRIPTION

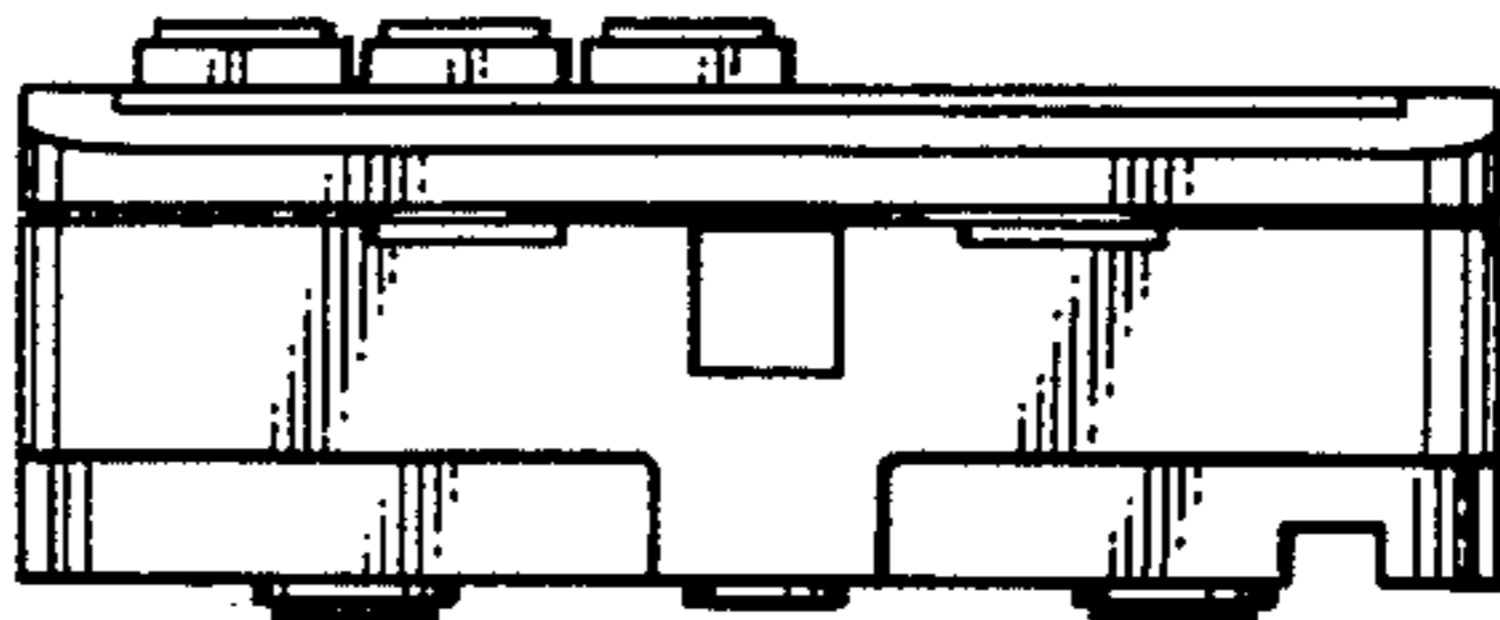

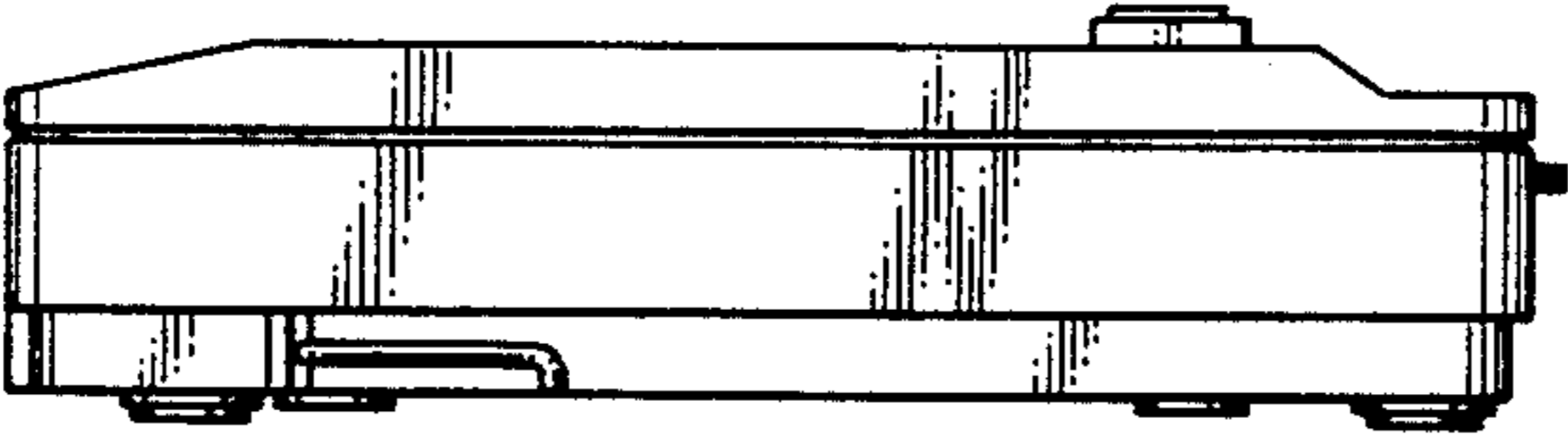

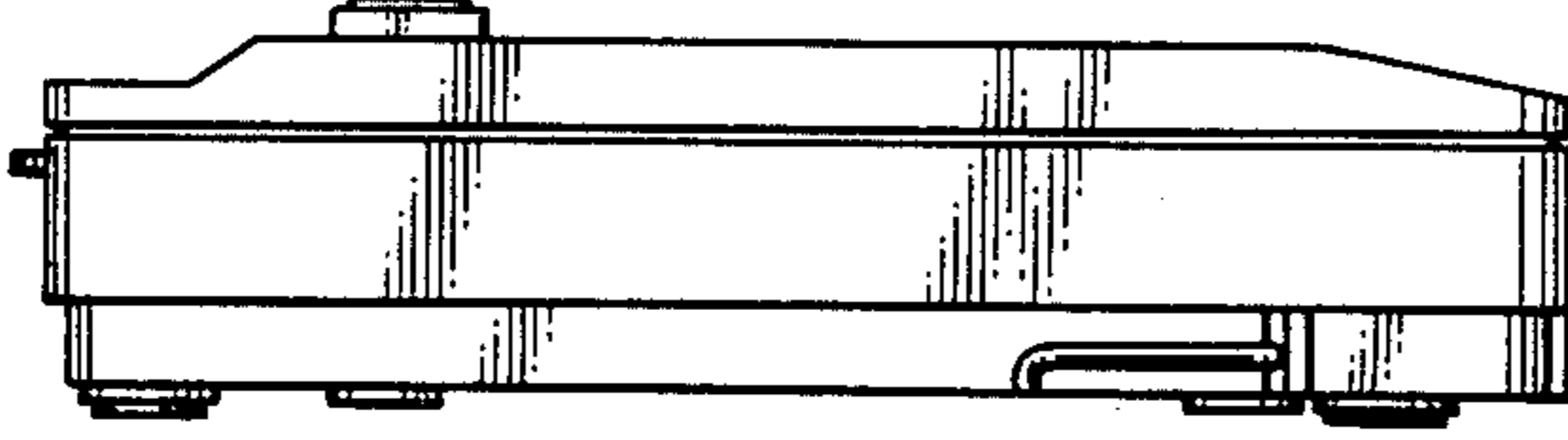

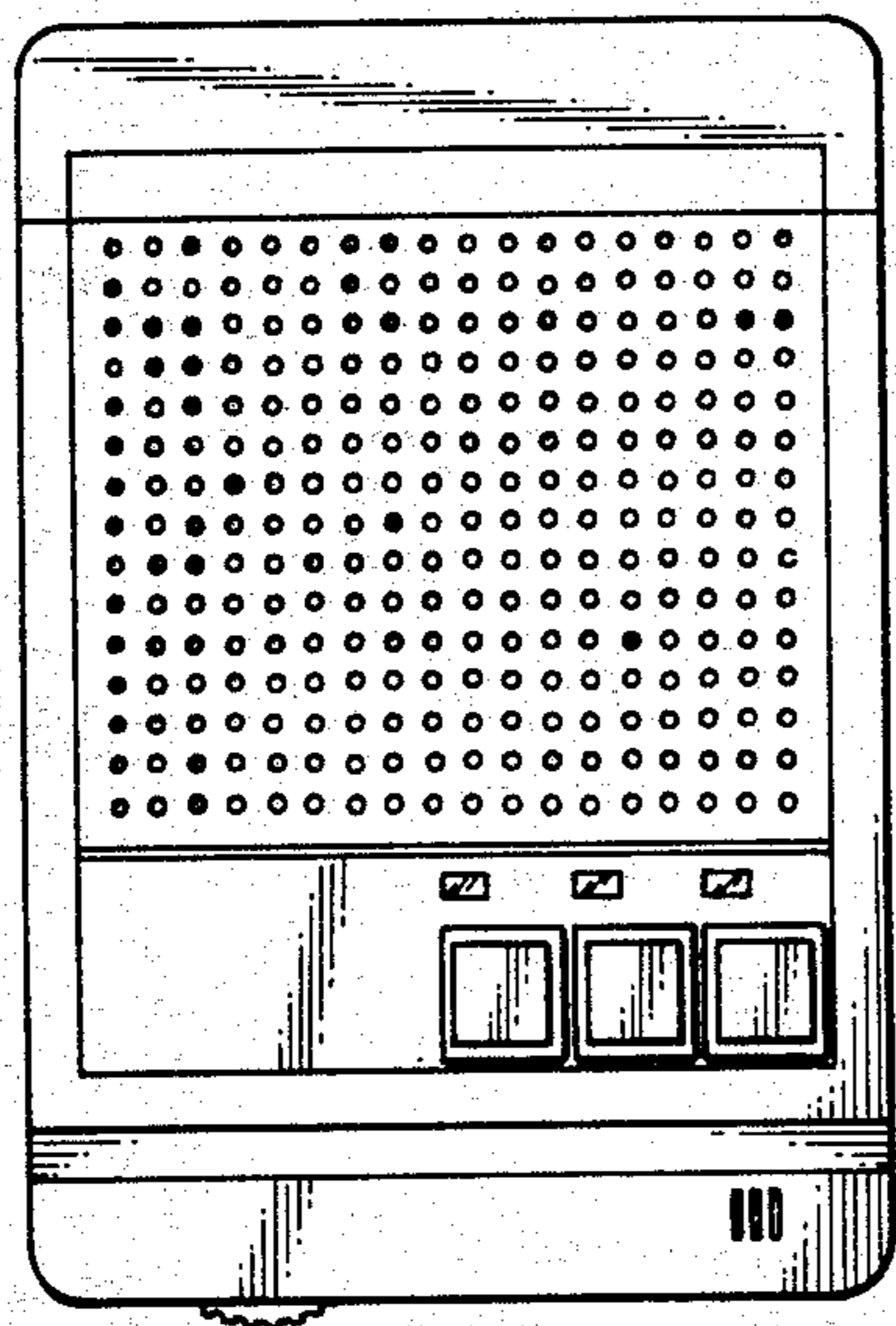

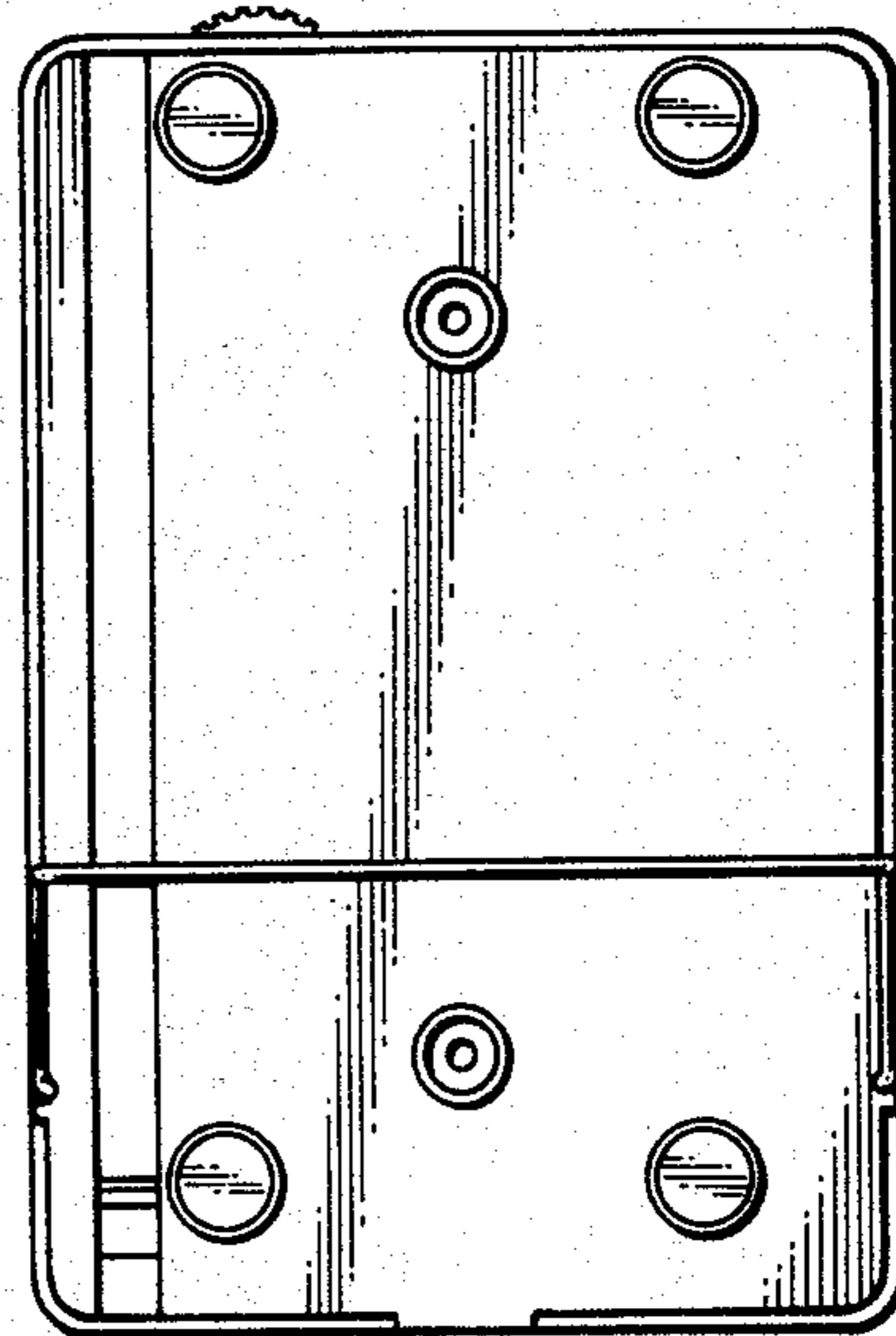
