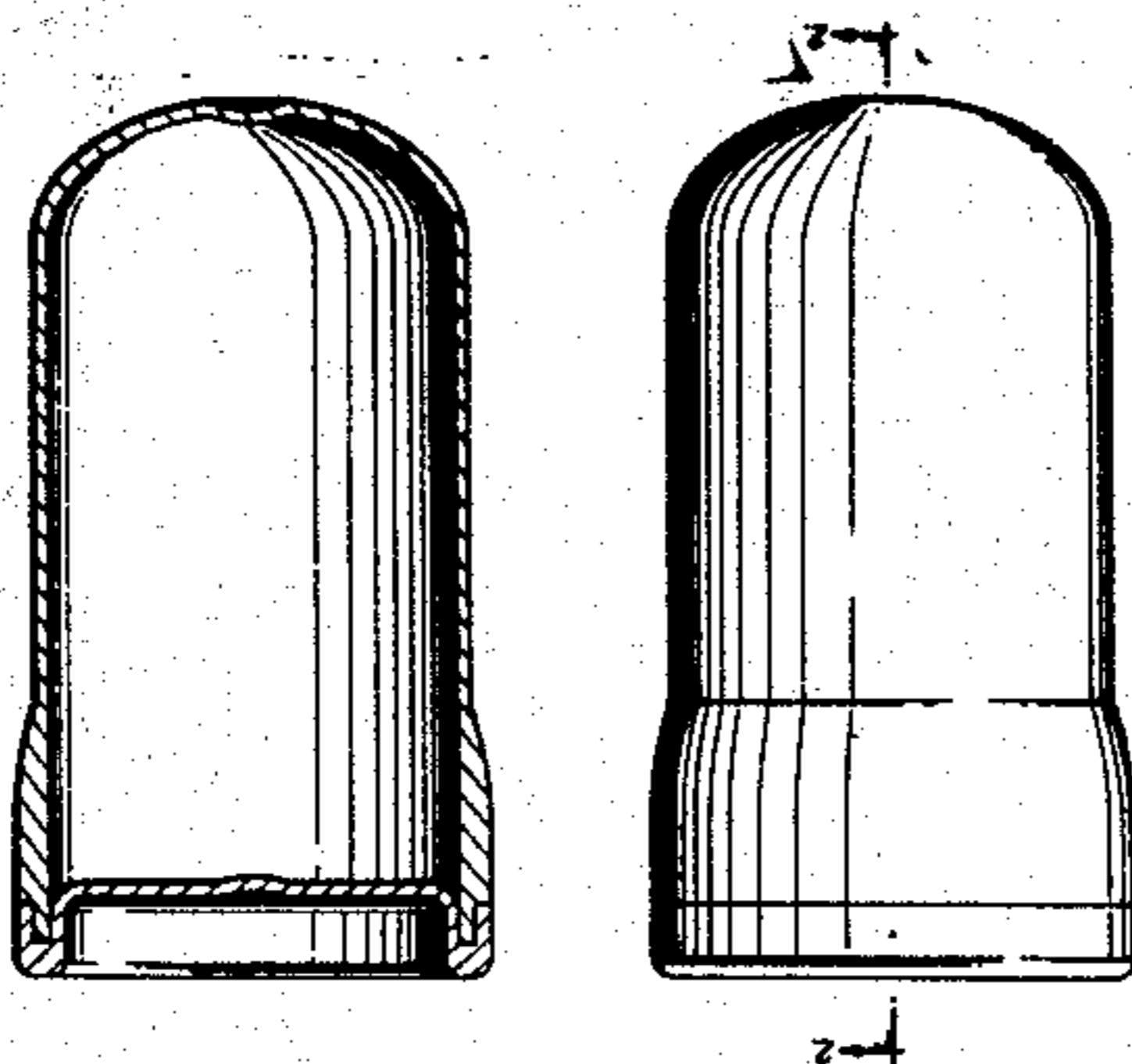

[57] **CLAIM**

The ornamental design for a pharmaceutical capsule, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a pharmaceutical capsule showing my new design; and the rear elevational view and both side elevational views are understood to be identical to FIG. 1;
 FIG. 2 is a sectional view thereof taken along the line 2-2 of FIG. 1;
 FIG. 3 is a bottom plan view thereof; and
 FIG. 4 is a top plan view thereof.

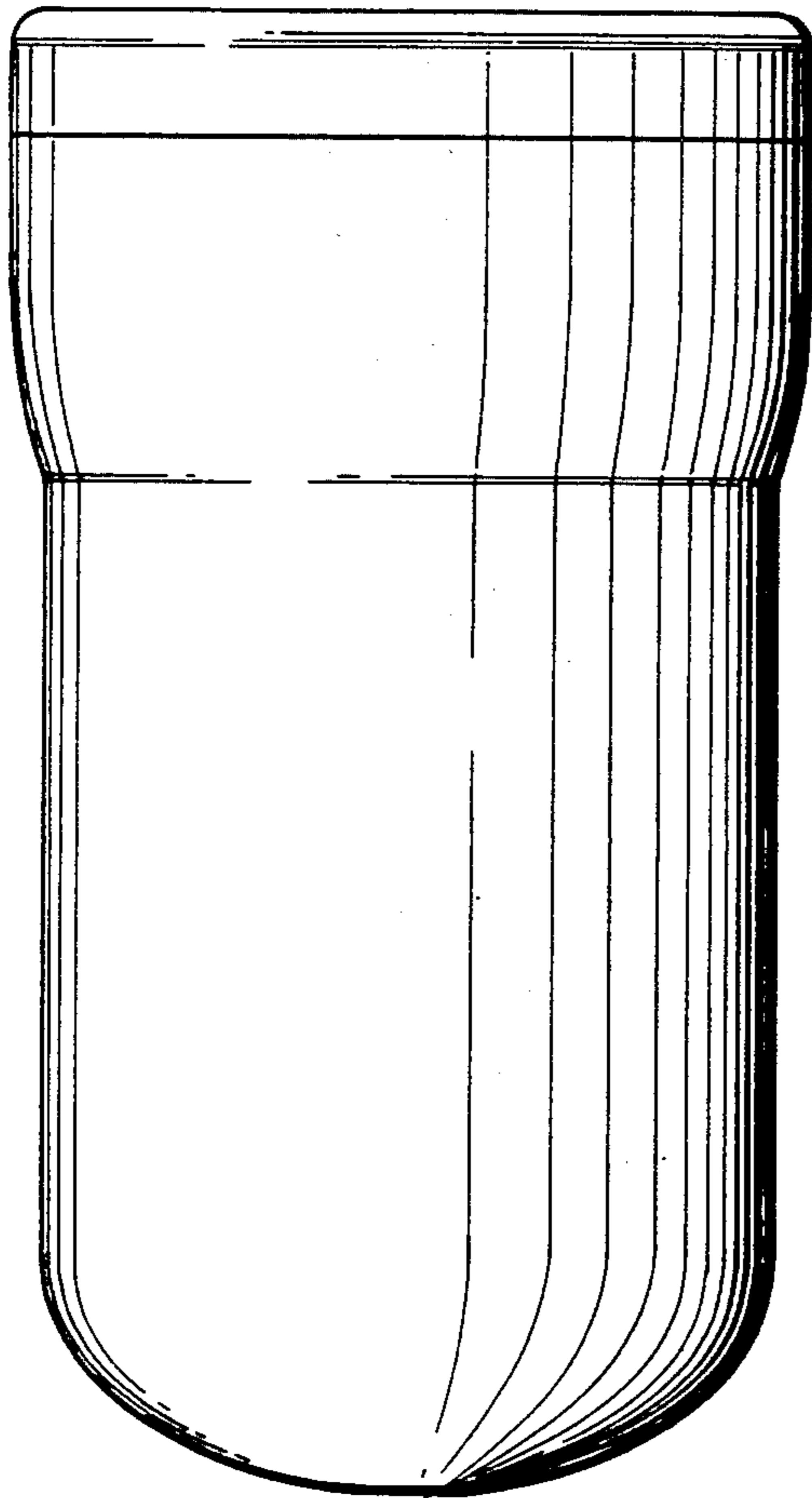

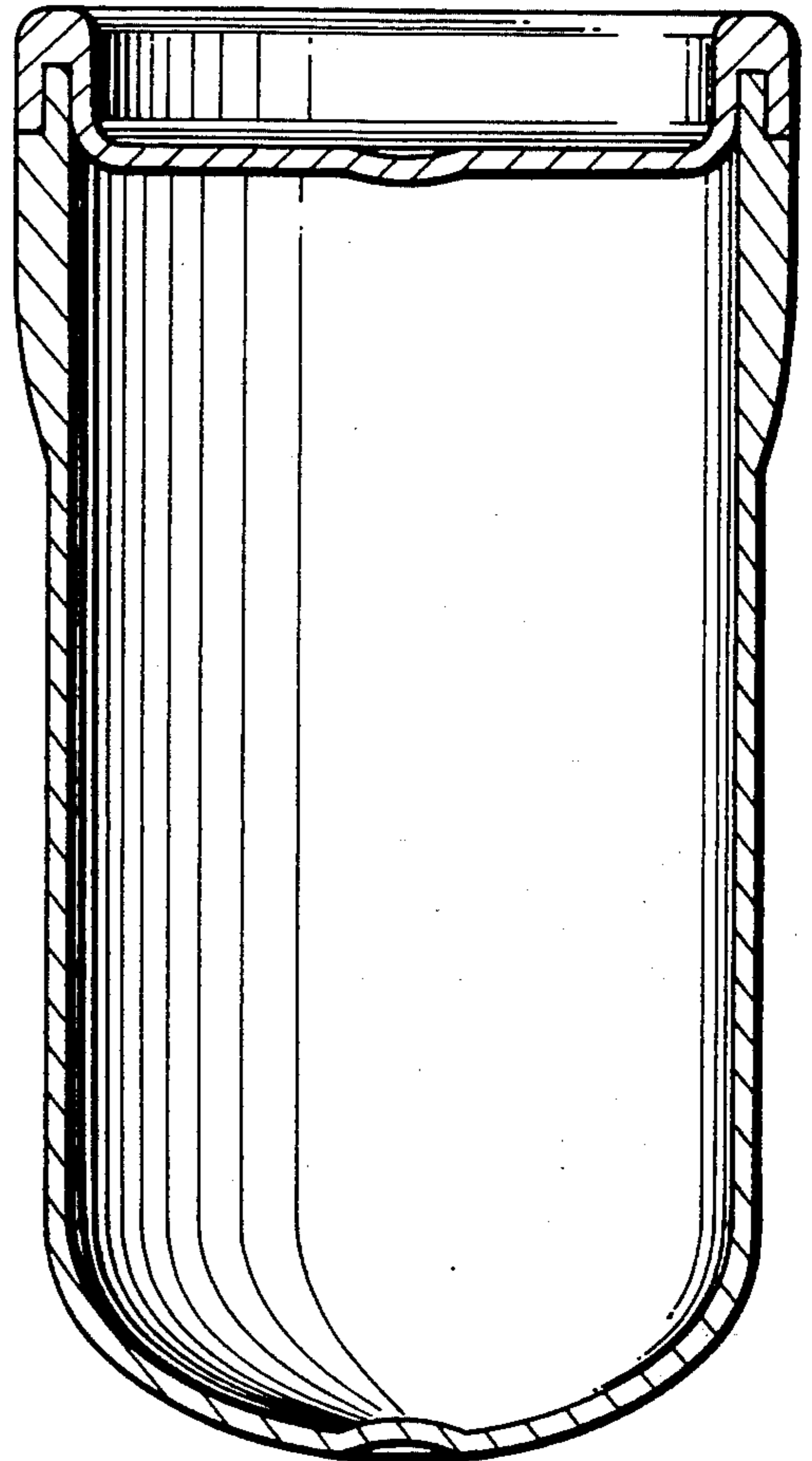

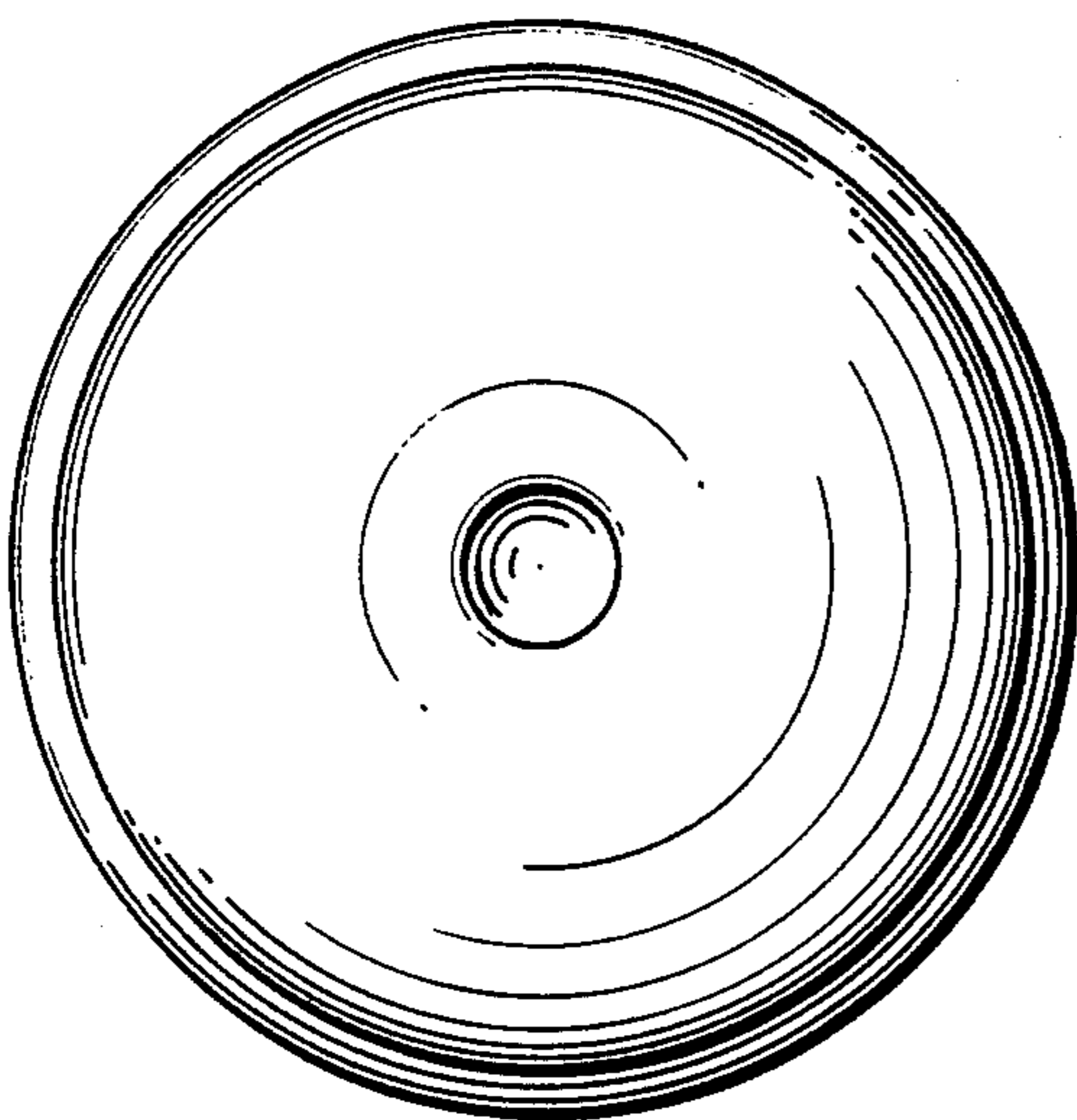

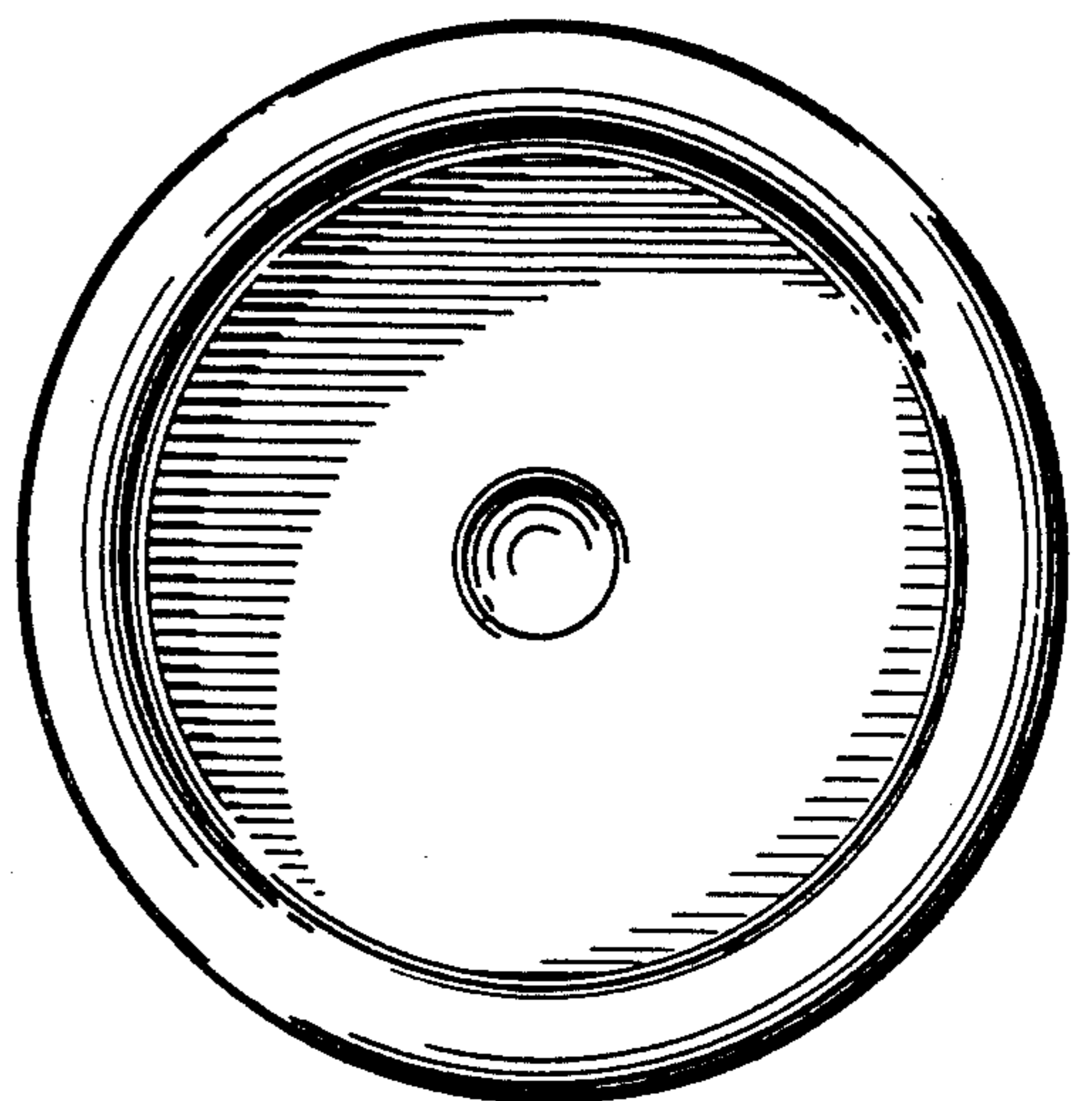
