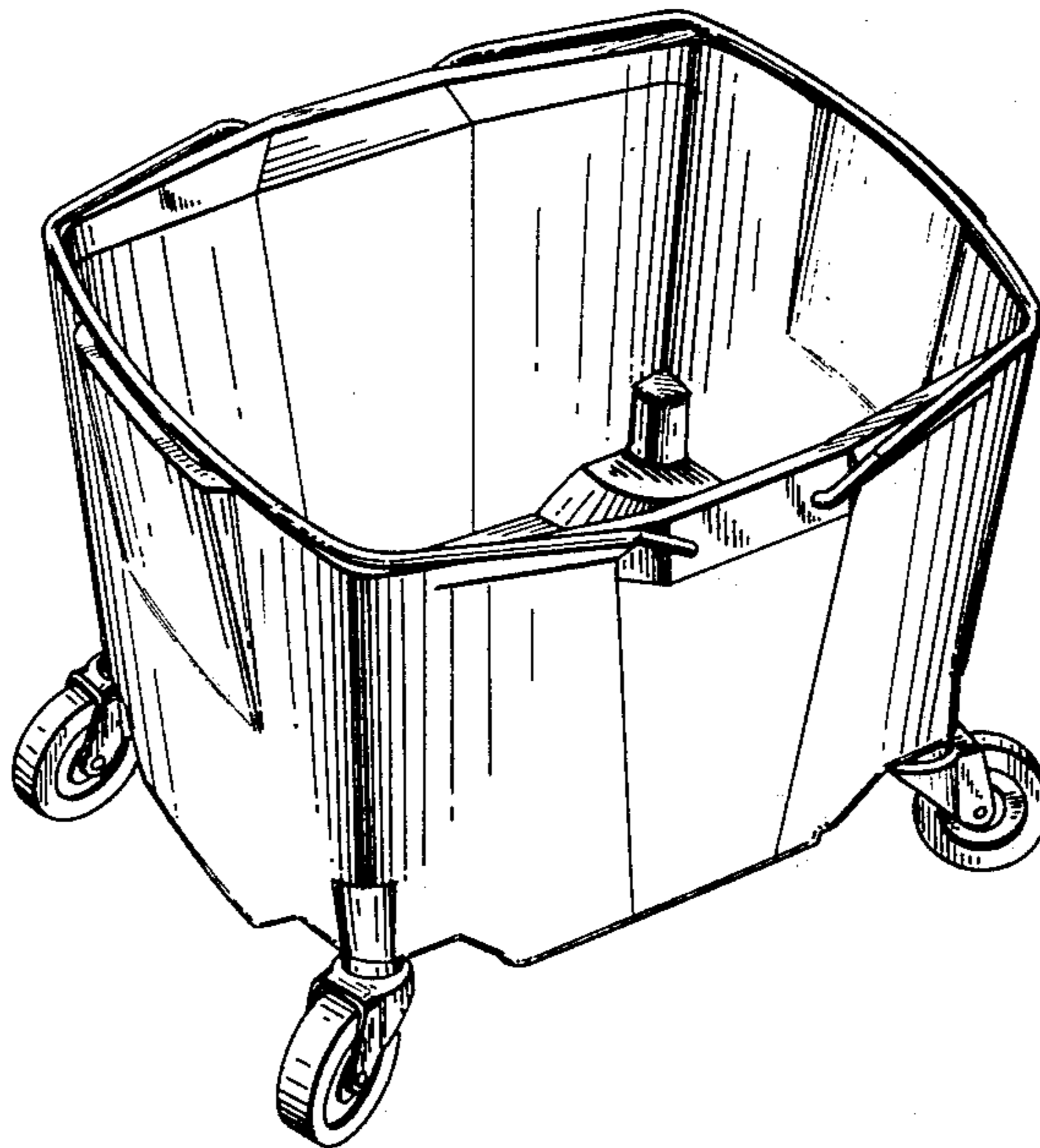

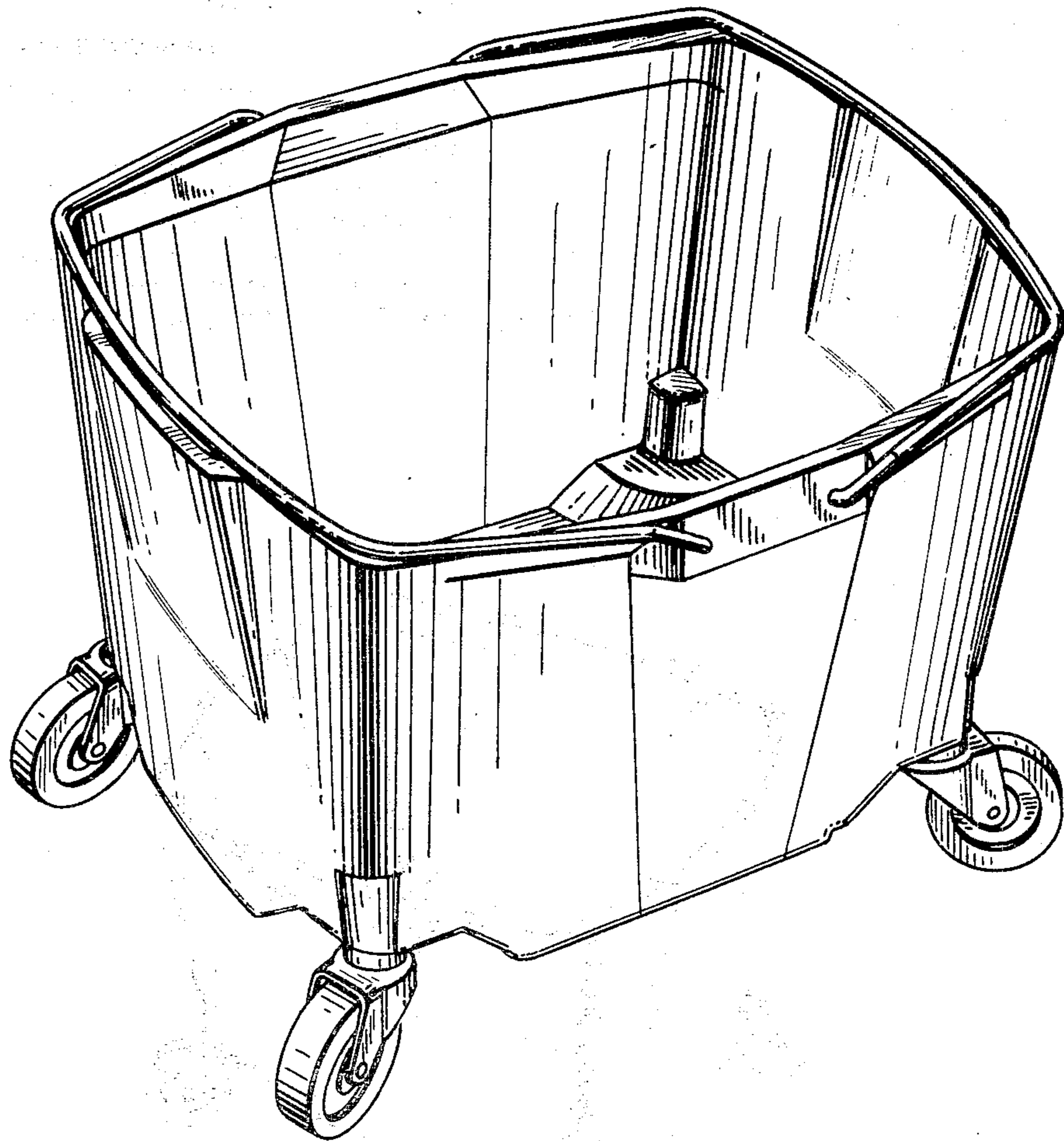
The ornamental design for a bucket, substantially as shown and described.

### DESCRIPTION

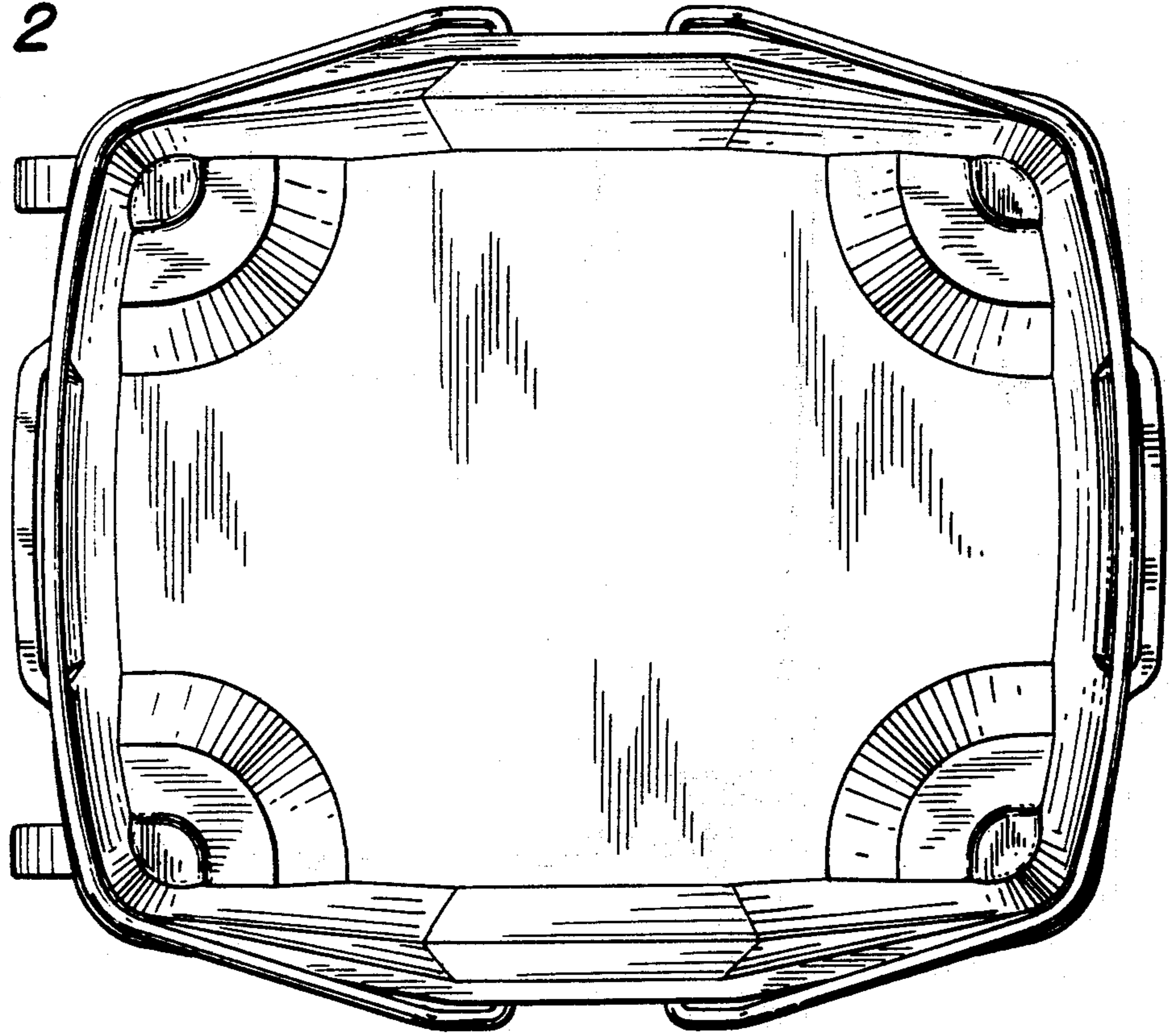
FIG. 1 is a top perspective view of a bucket showing our new design;

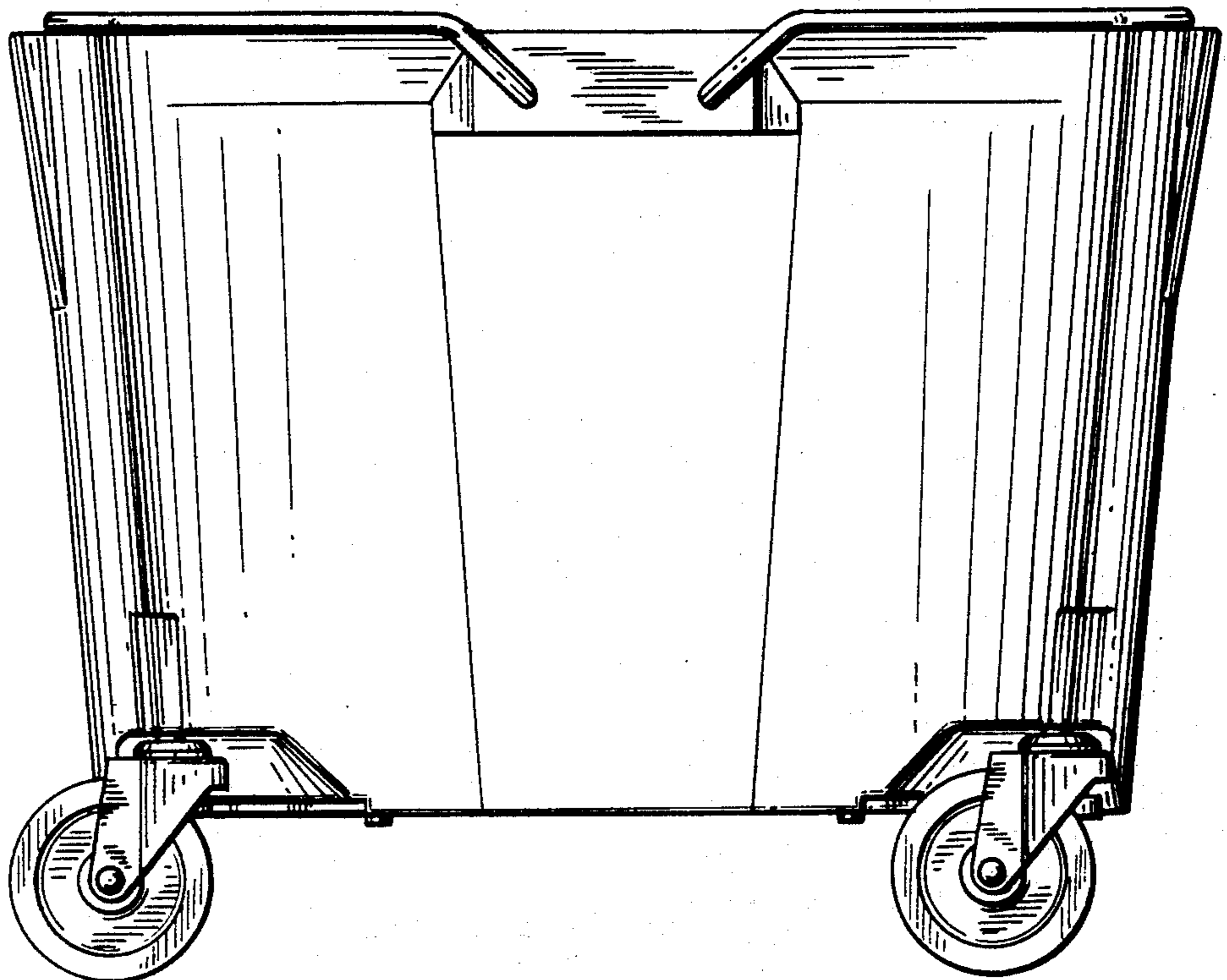

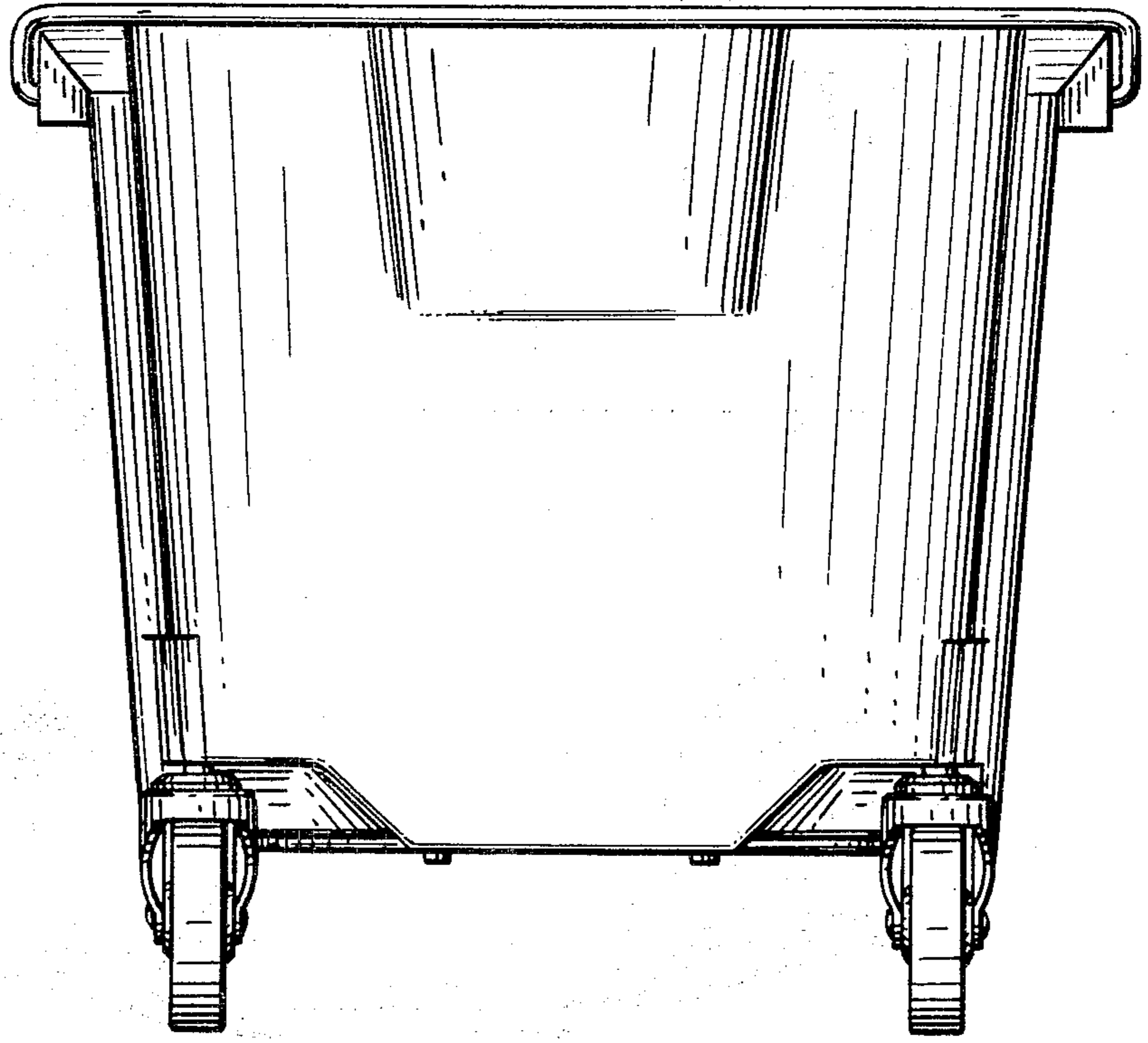
