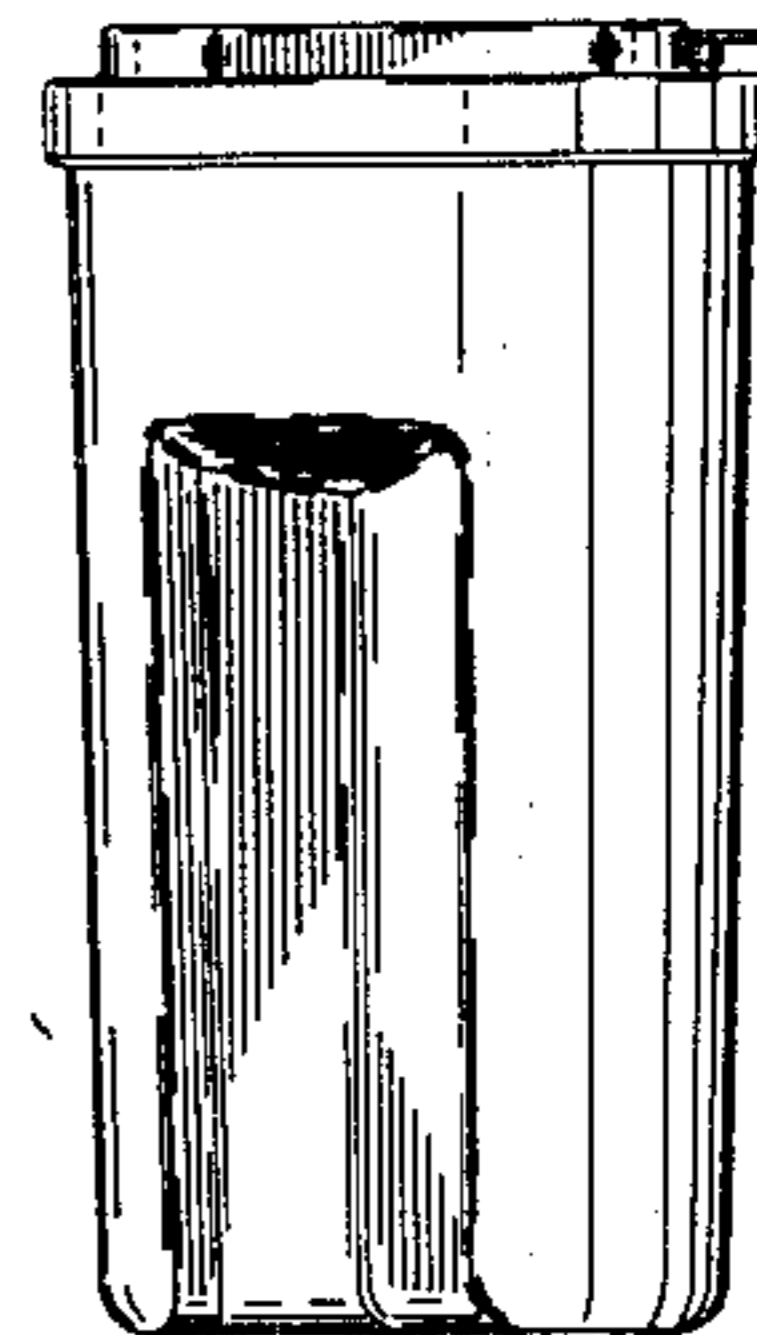
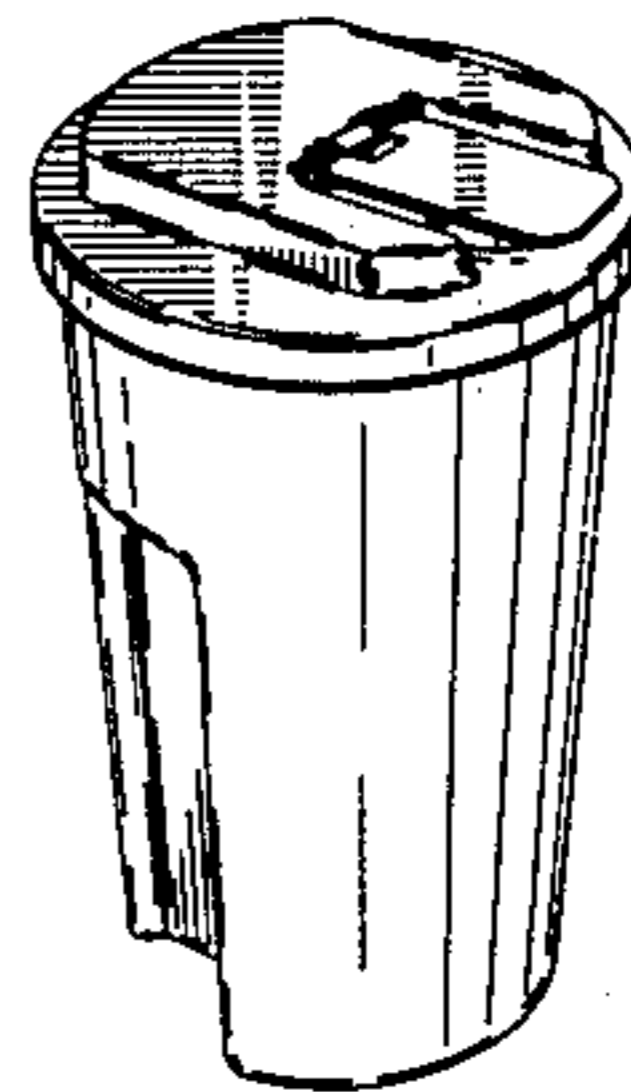
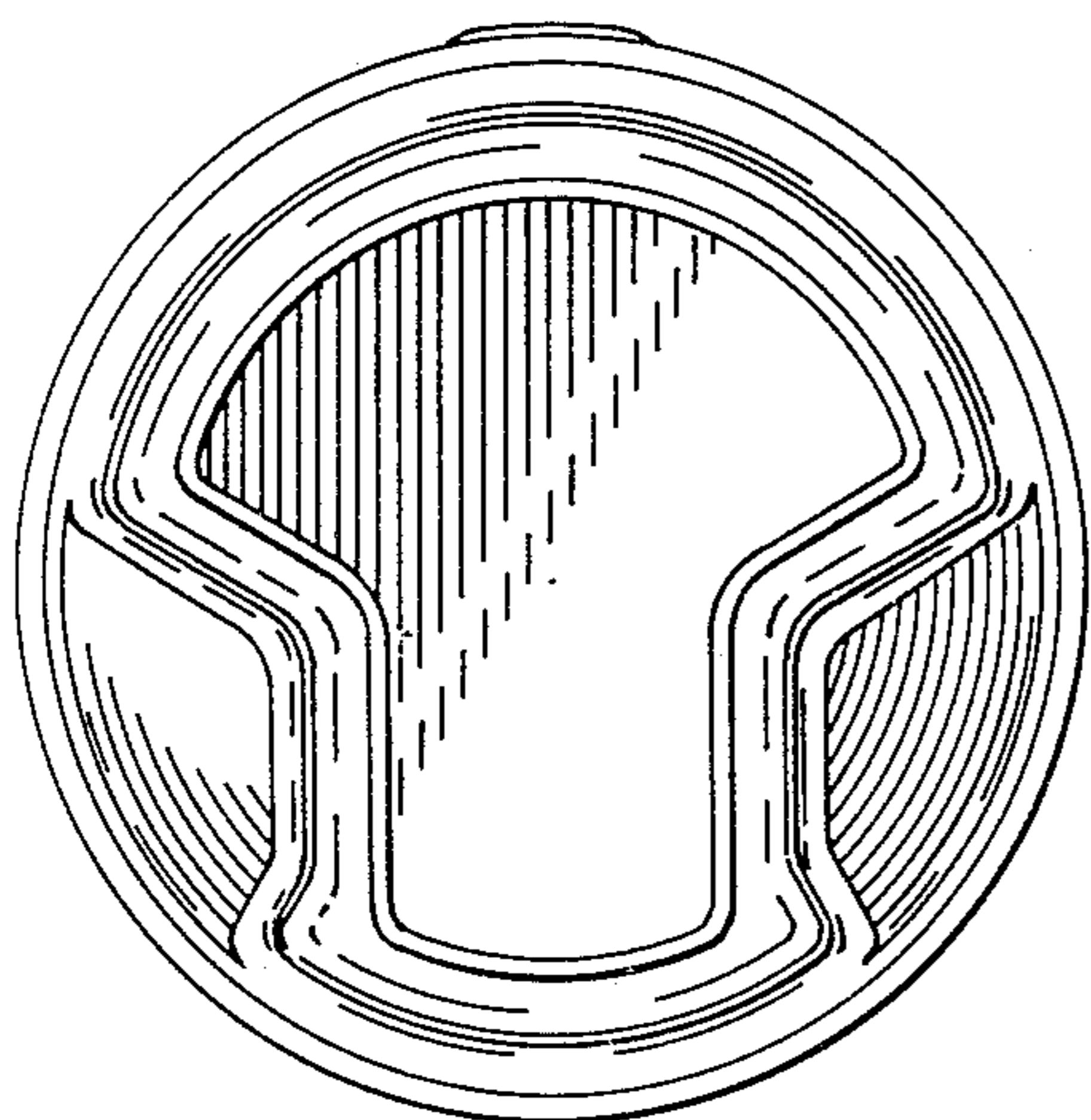

The ornamental design for a beverage decanter, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a beverage decanter embodying my new design;
 FIG. 2 is an enlarged rear elevational view thereof;
 FIG. 3 is an enlarged side elevational view thereof;
 FIG. 4 is an enlarged front elevational view thereof;
 FIG. 5 is a top plan view thereof;
 FIG. 6 is a bottom plan view thereof;
 The side opposite to that shown in FIG. 3 is a mirror image thereof.



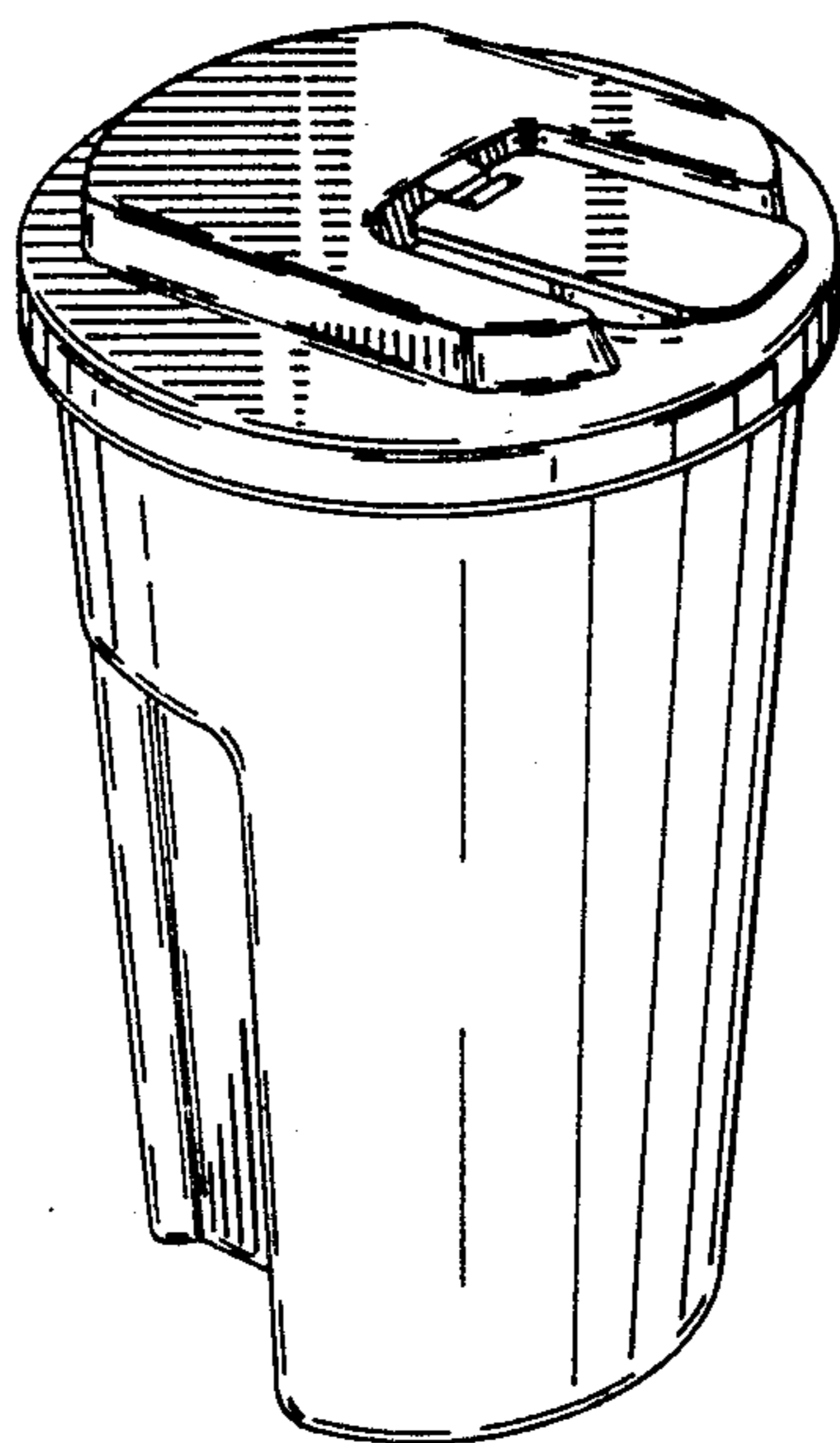

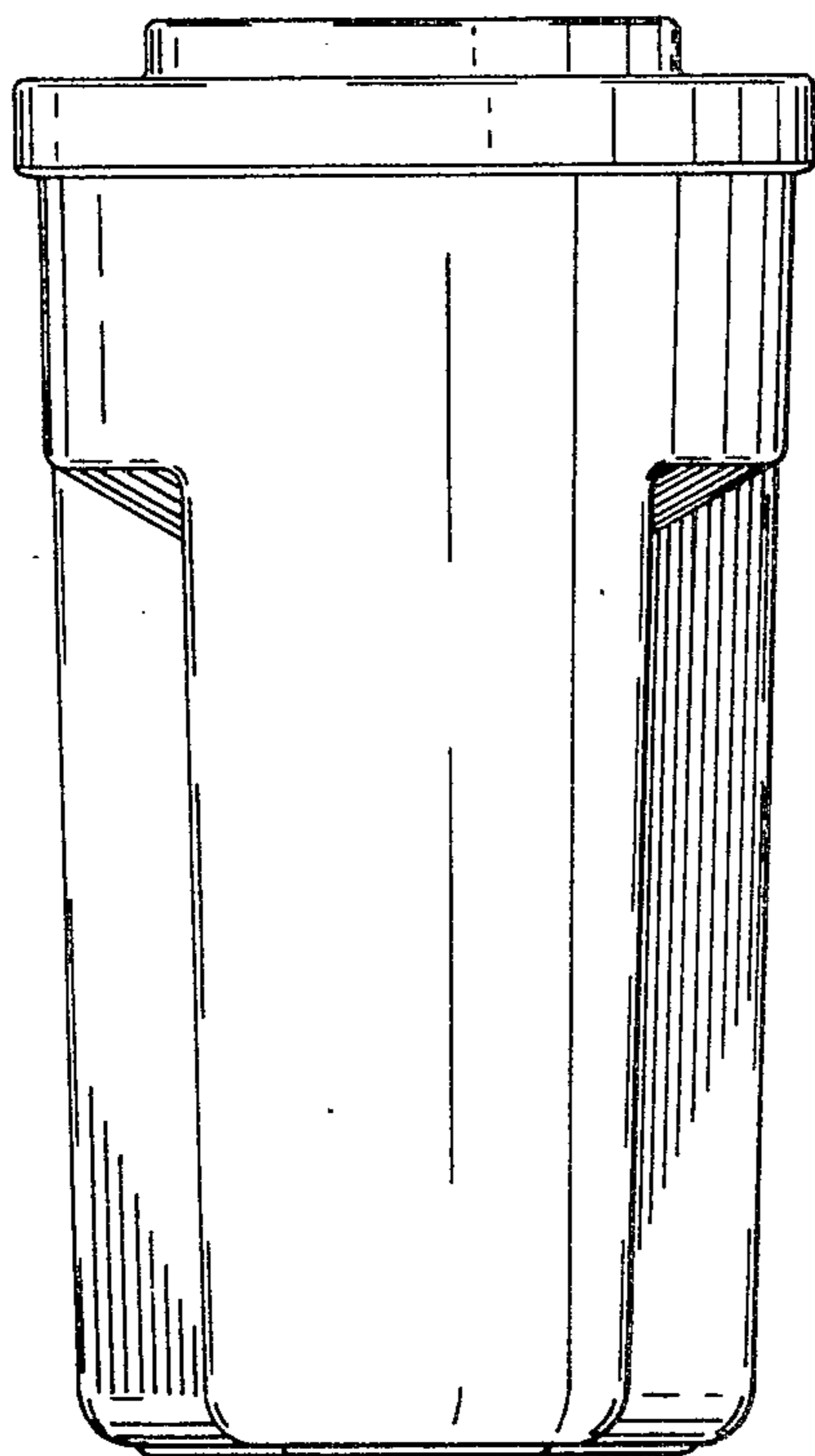
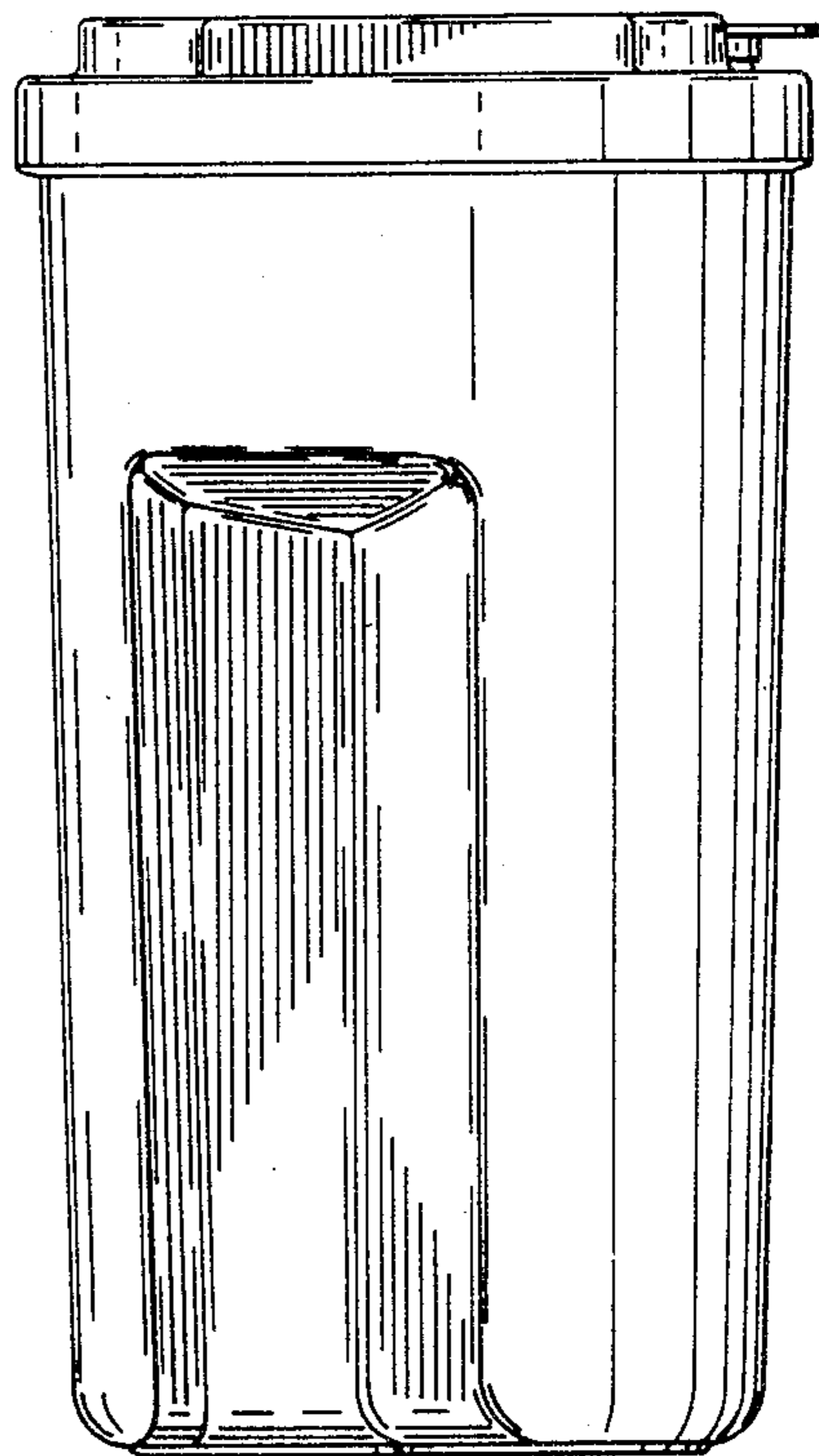

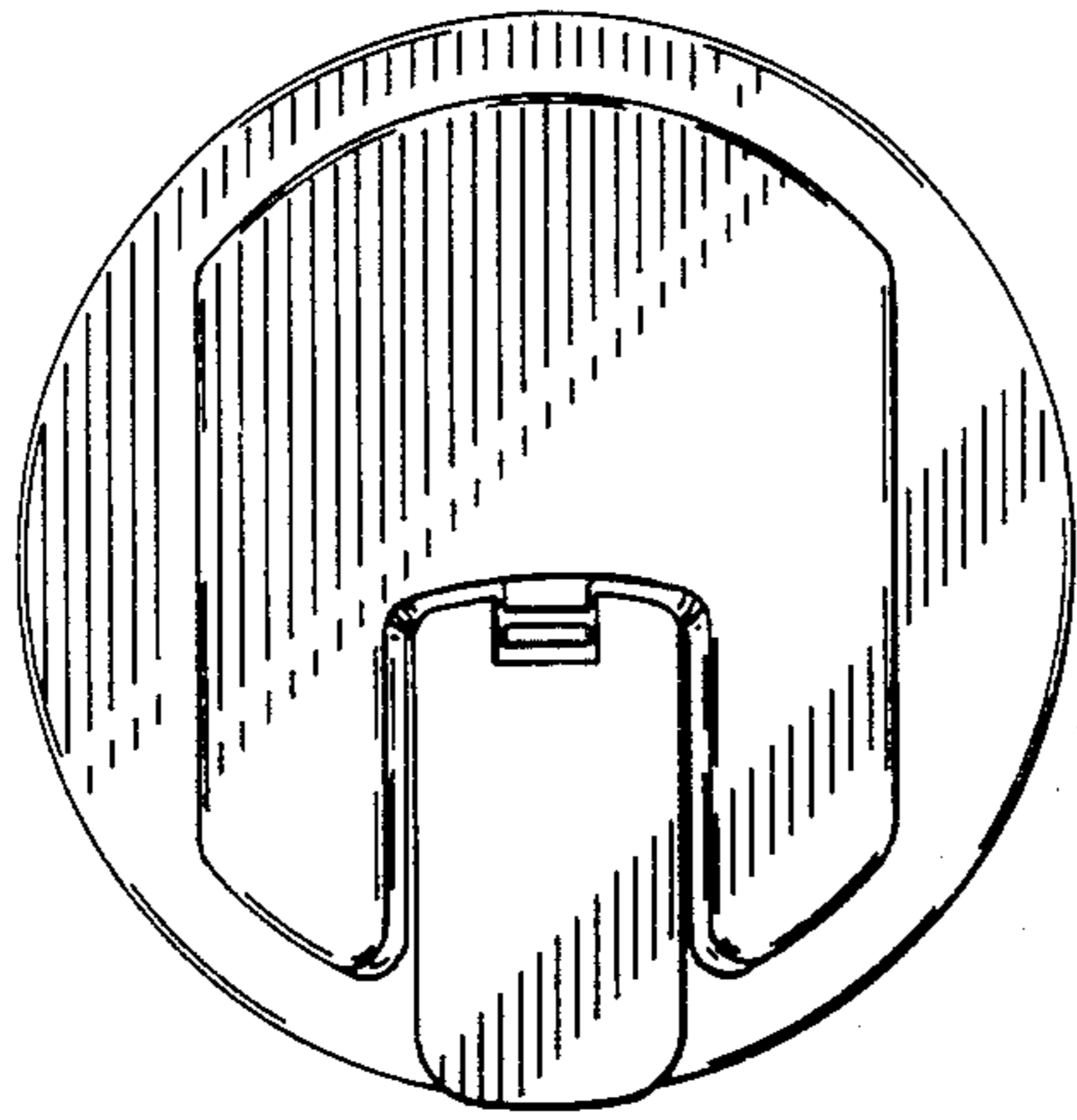

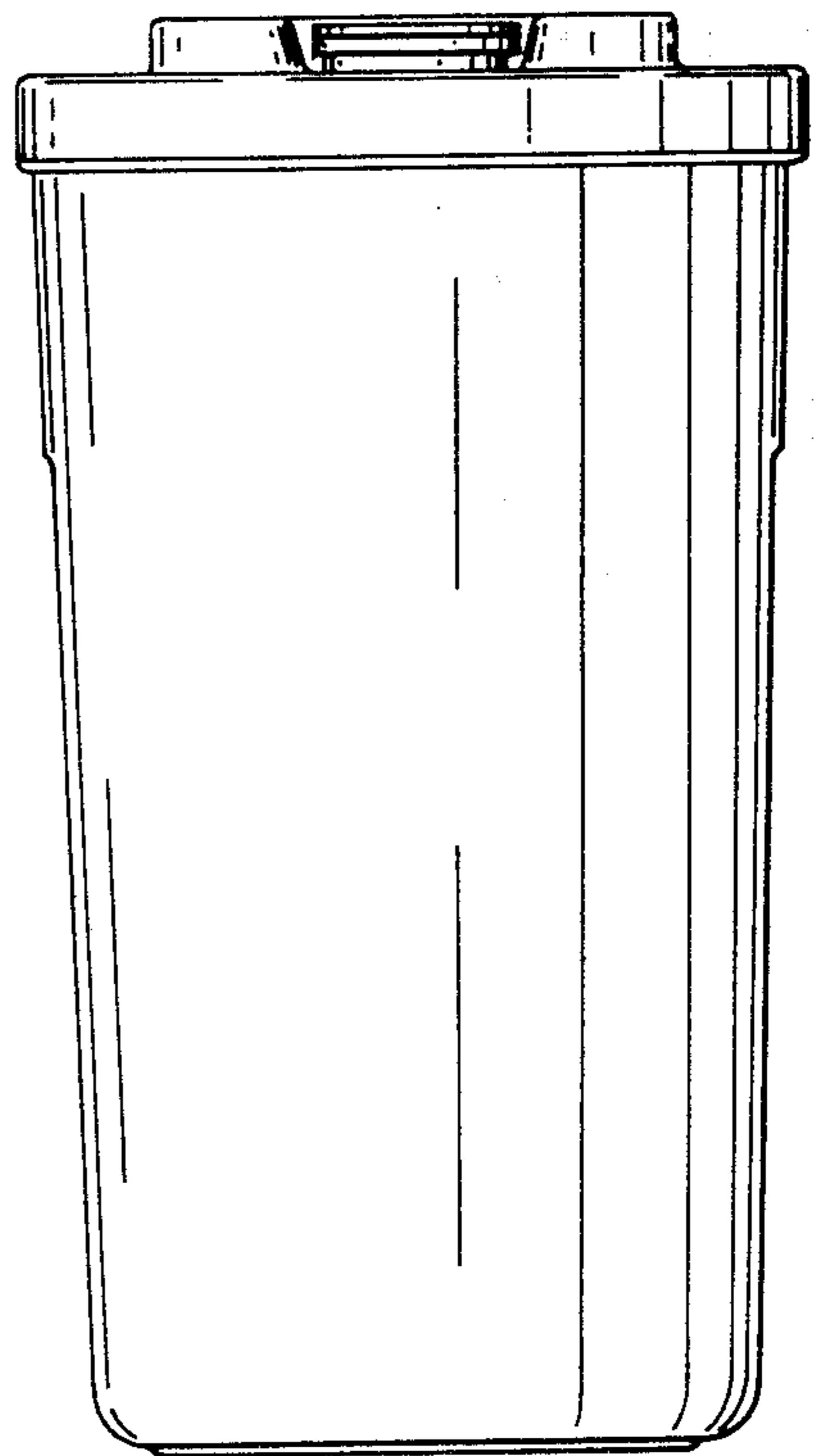
