[57] CLAIM

The ornamental design for a magnetic sign holder, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a sign holder embodying my new design;  
FIG. 2 is a side elevational view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a front elevational view thereof;  
FIG. 5 is a rear perspective view thereof;  
FIG. 6 is a rear elevational view thereof; and  
FIG. 7 is a bottom plan view thereof.

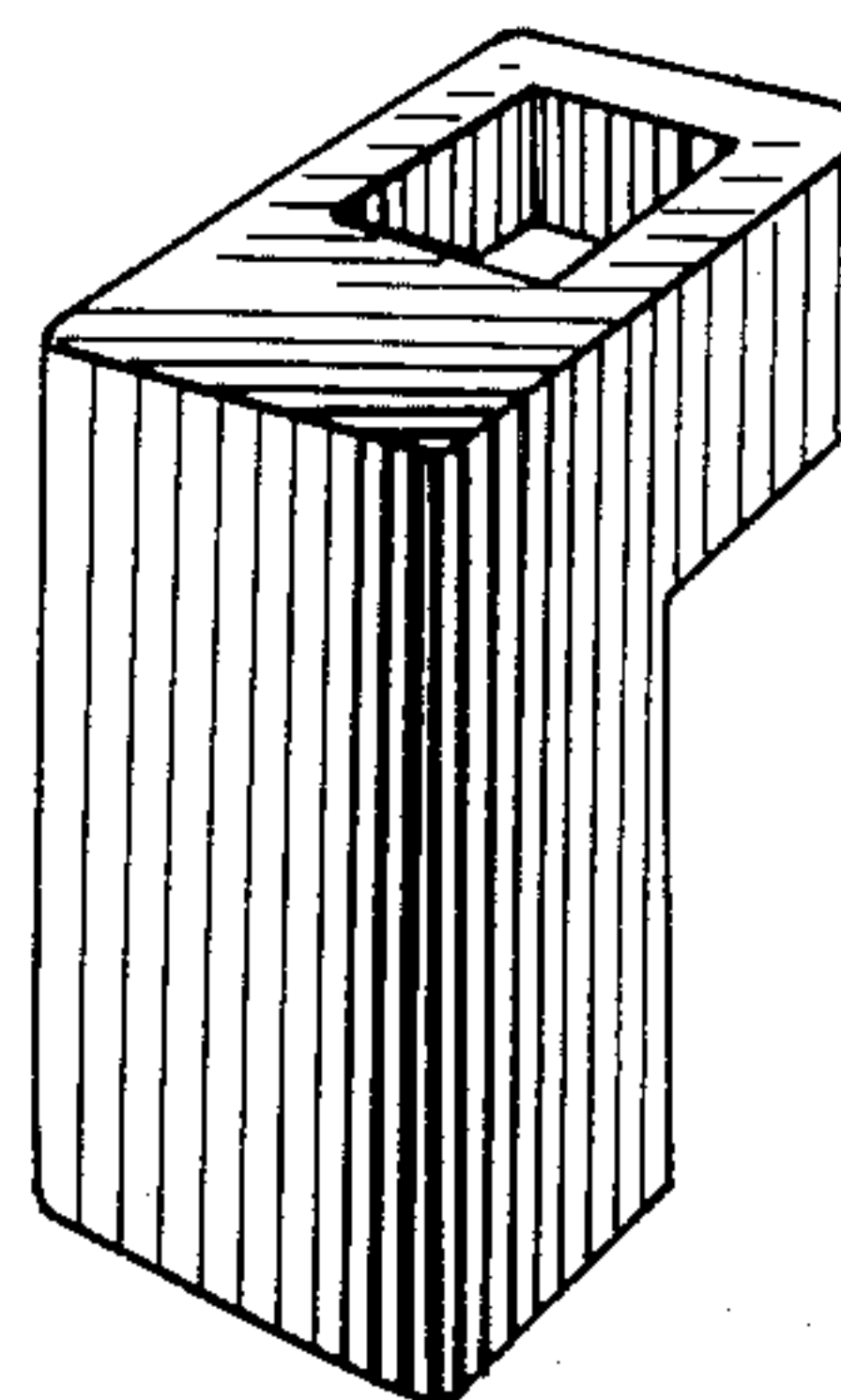
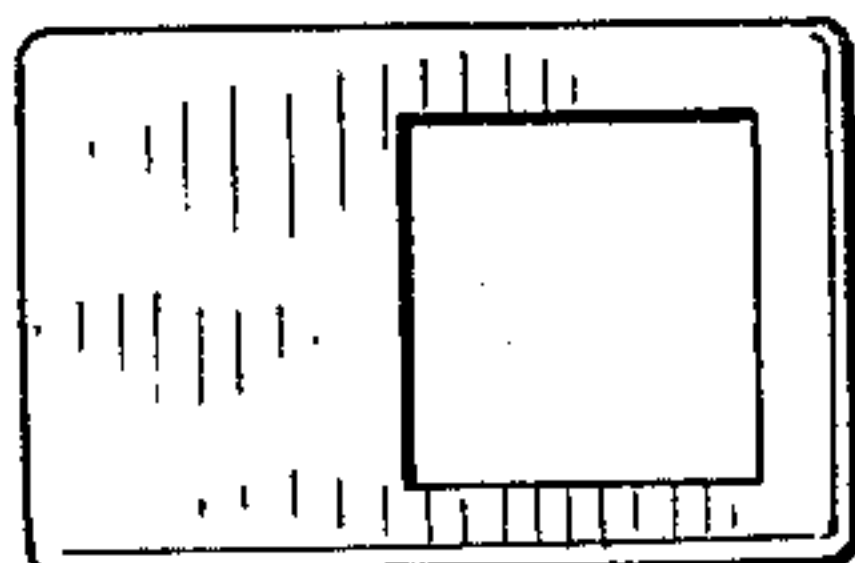

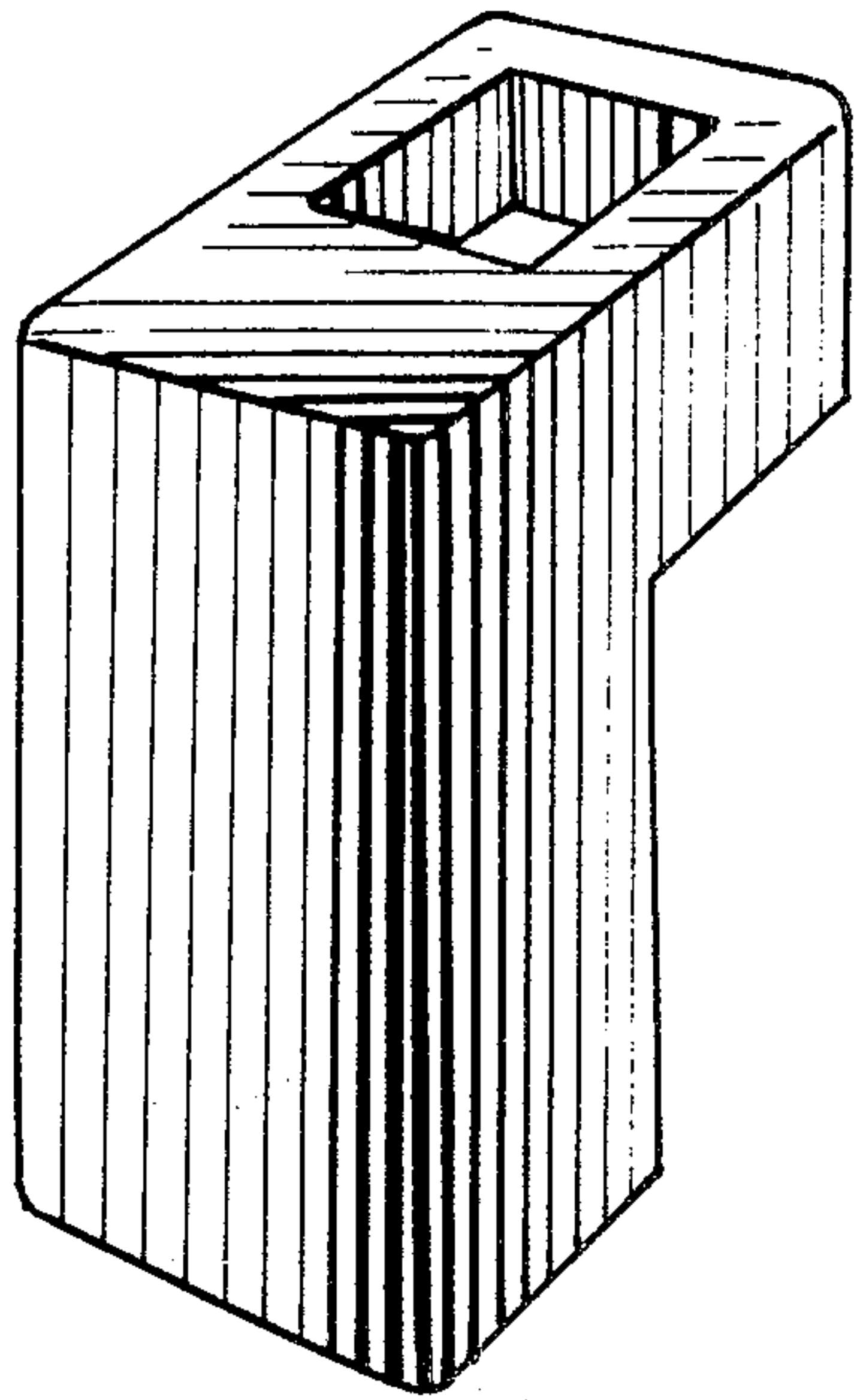

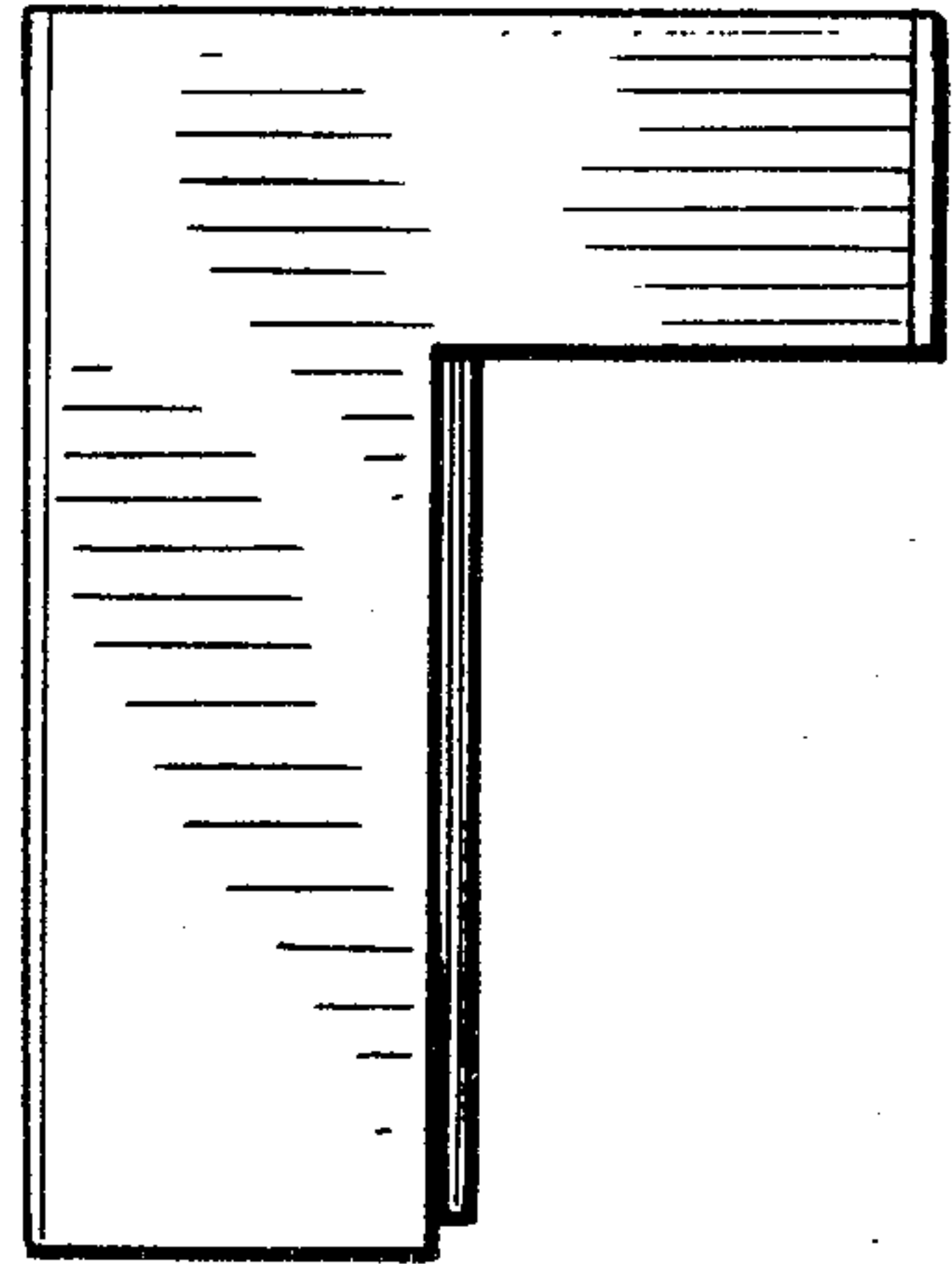

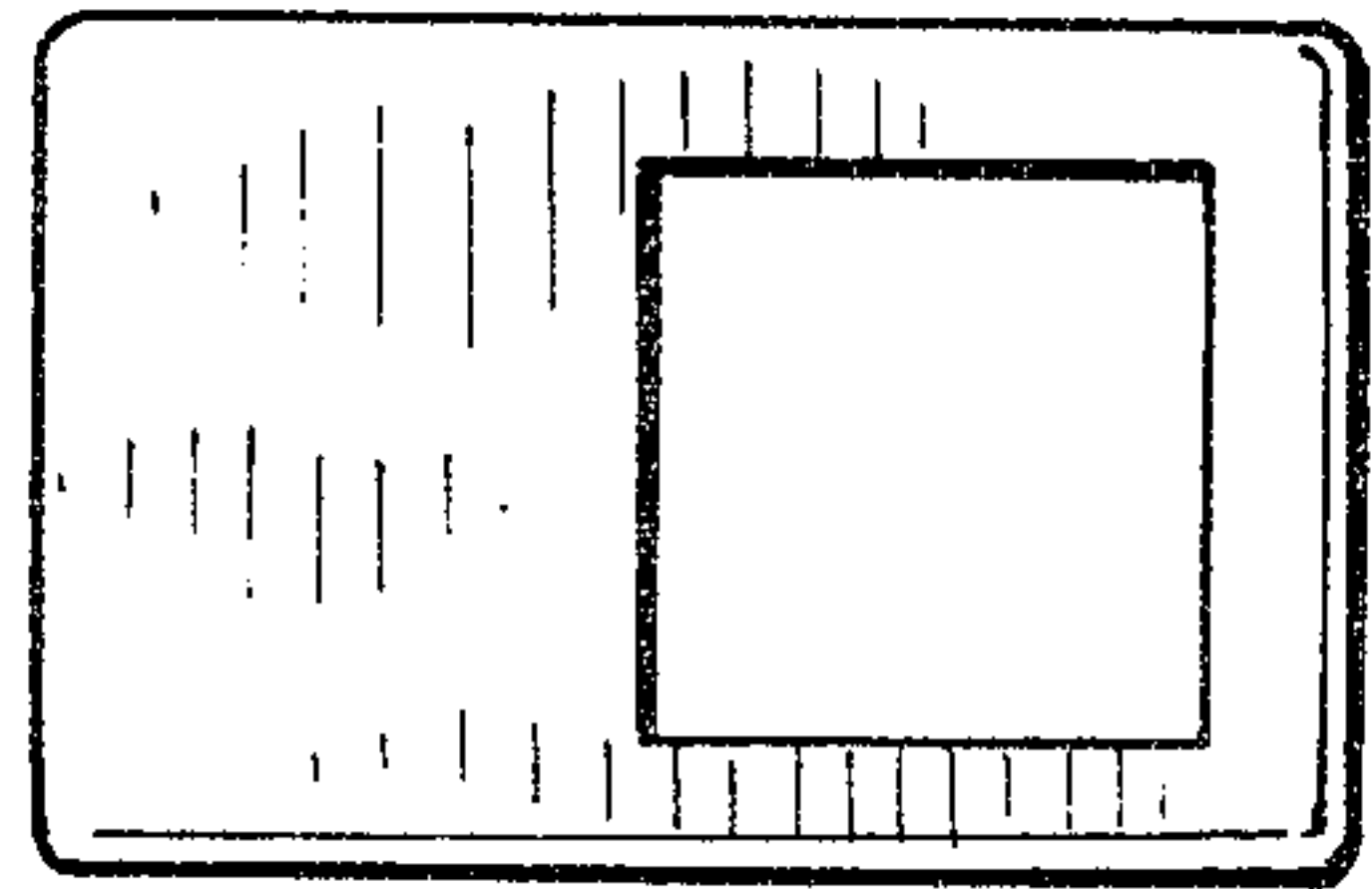

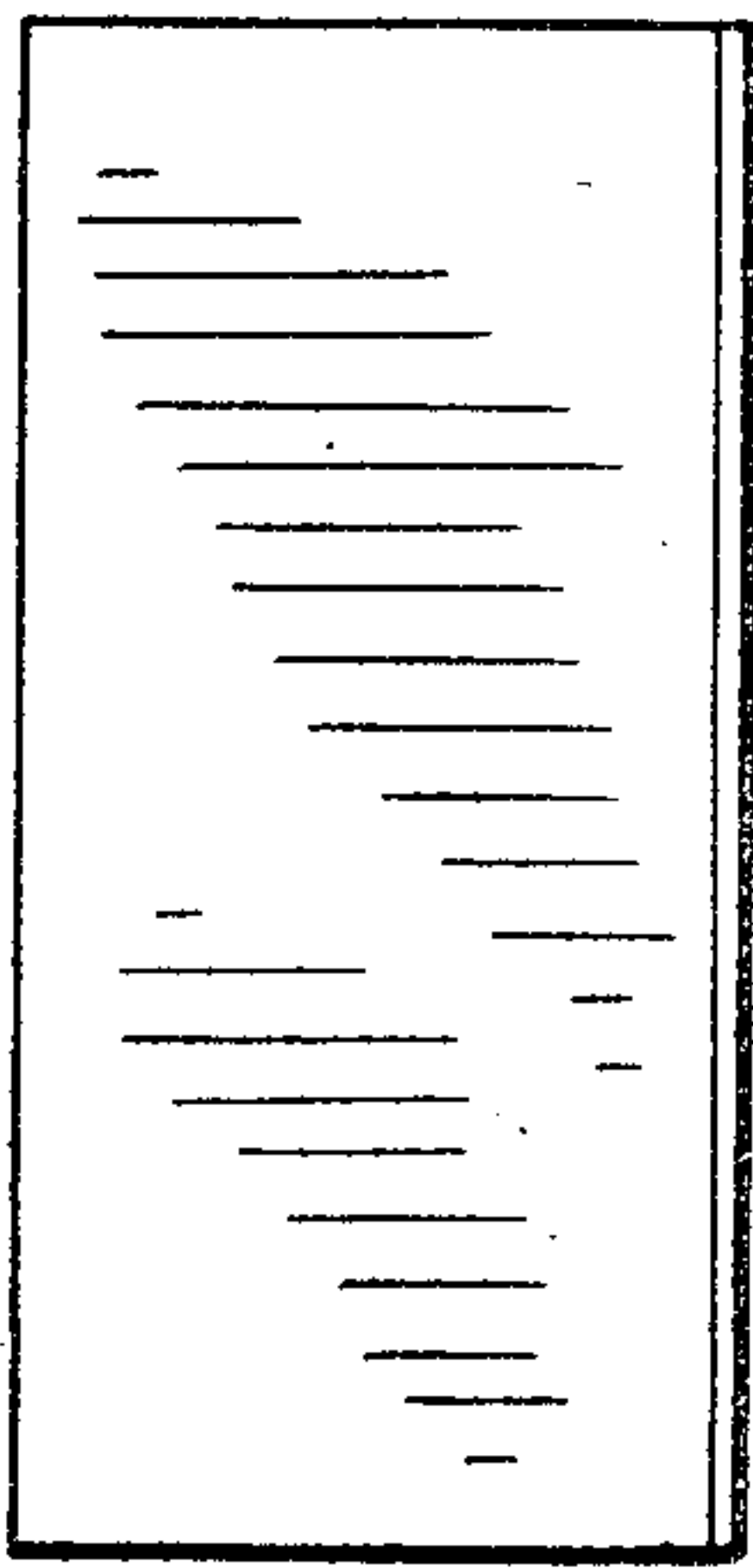

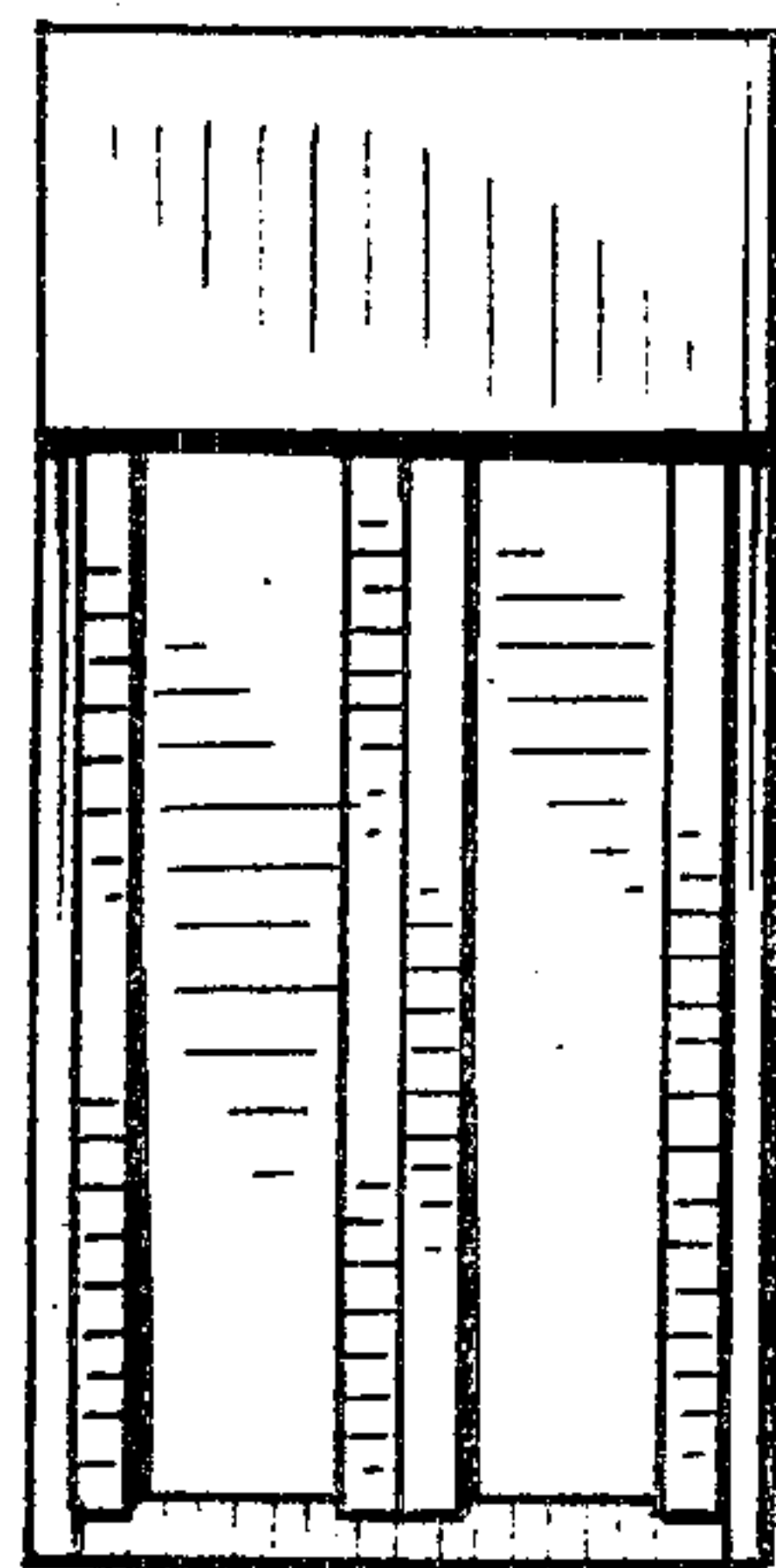

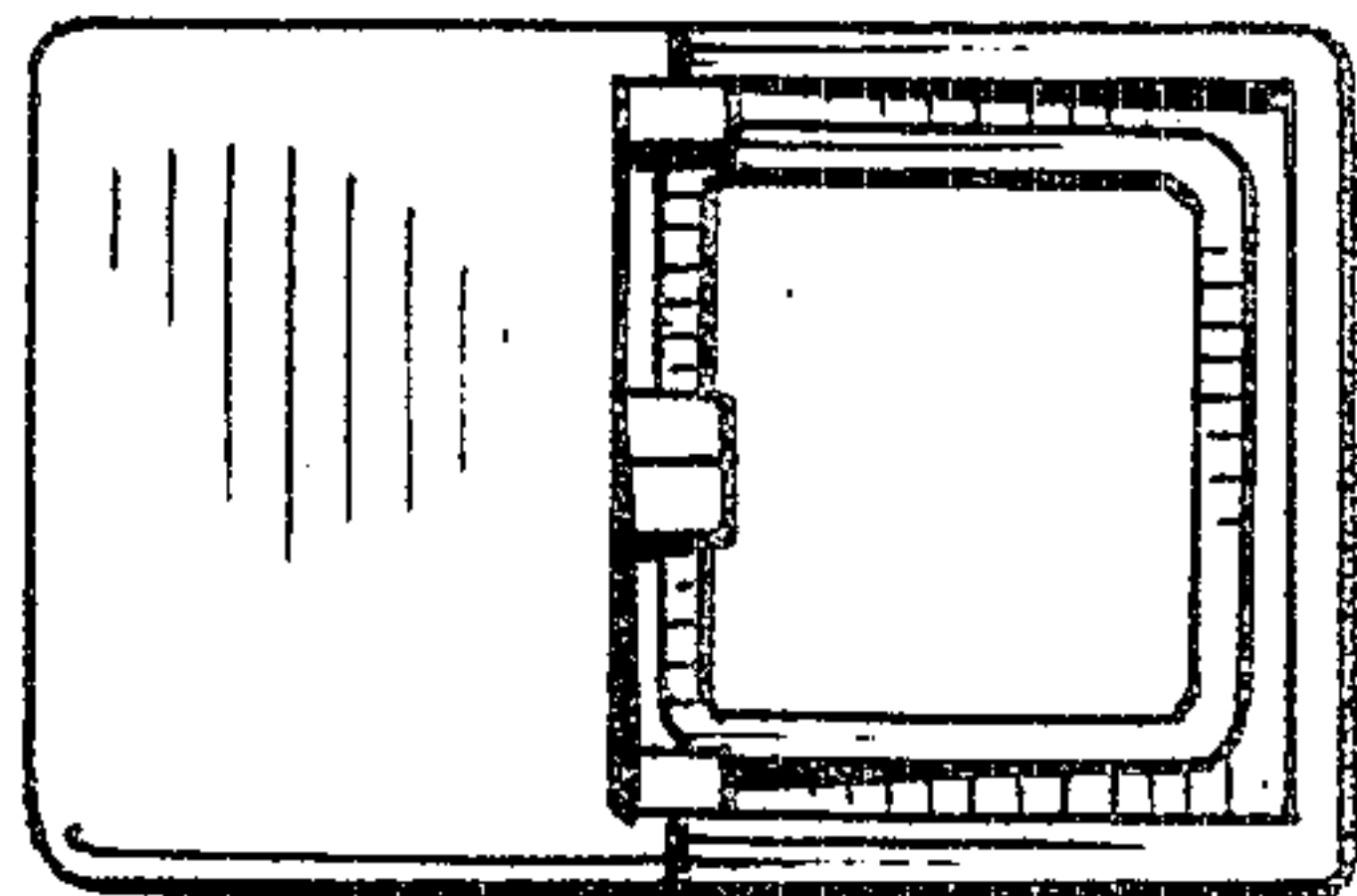
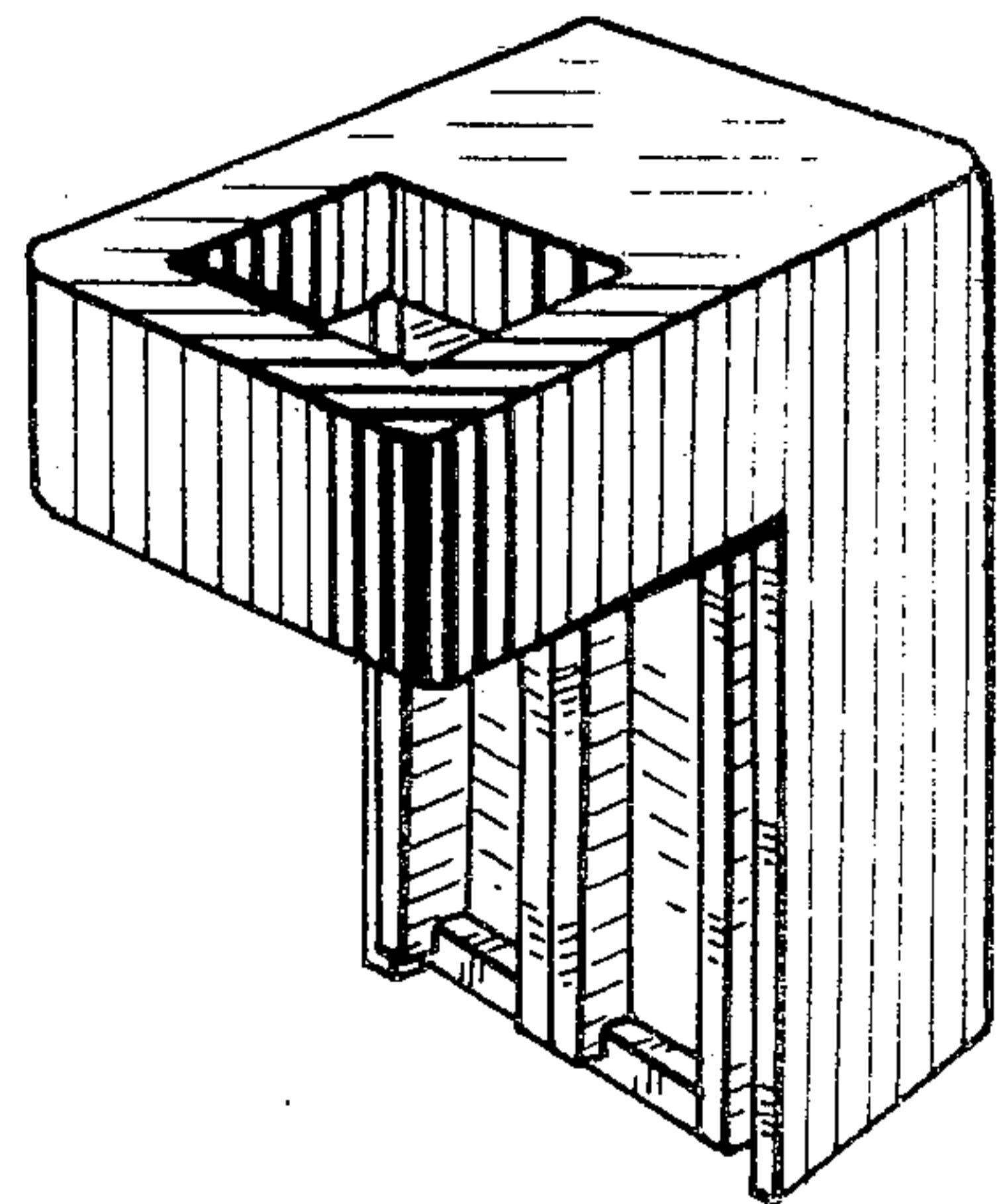
