DESCRIPTION

FIG. 1 is a perspective view of a container for the preparation of ready to be used liquid detergents showing my new design;

FIG. 2 is a side elevational view;

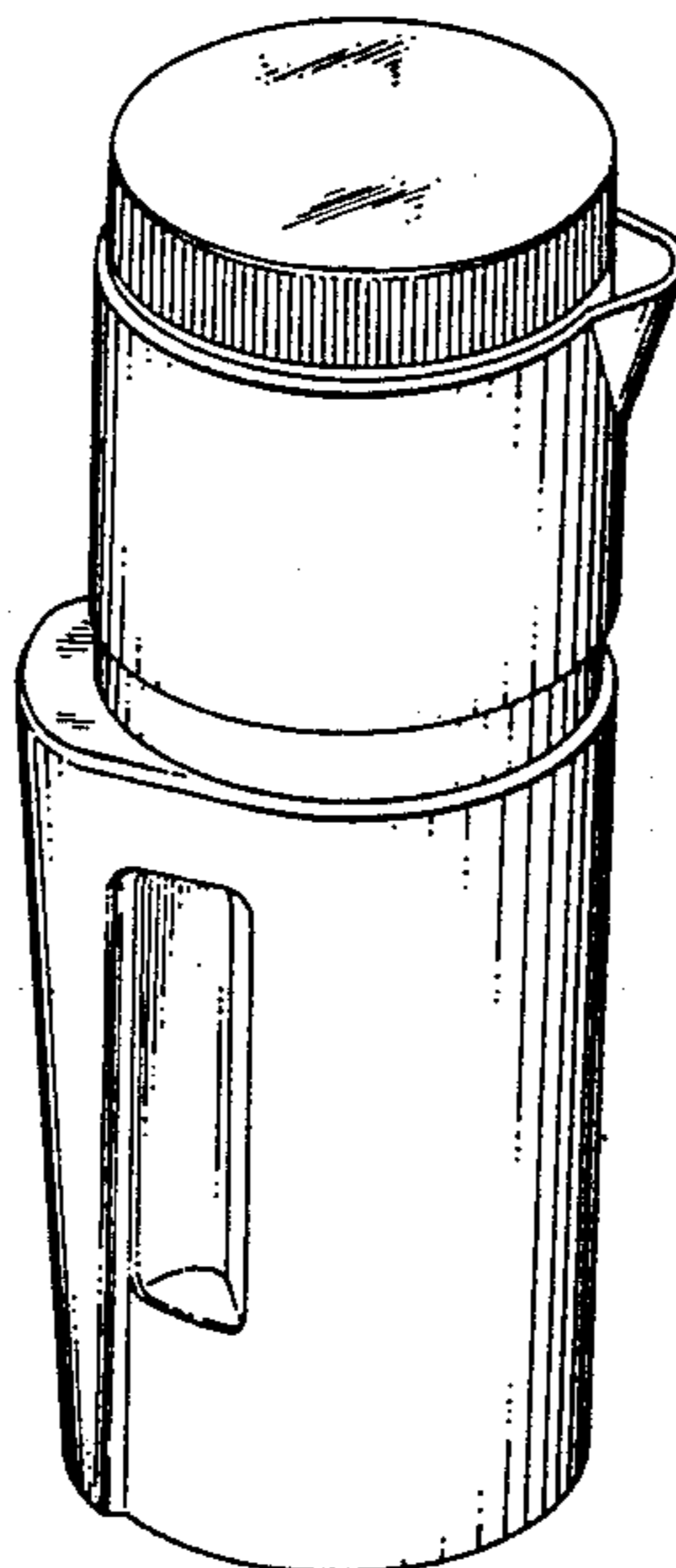
FIG. 3 is a rear elevational view;

FIG. 7 is a bottom plan view.



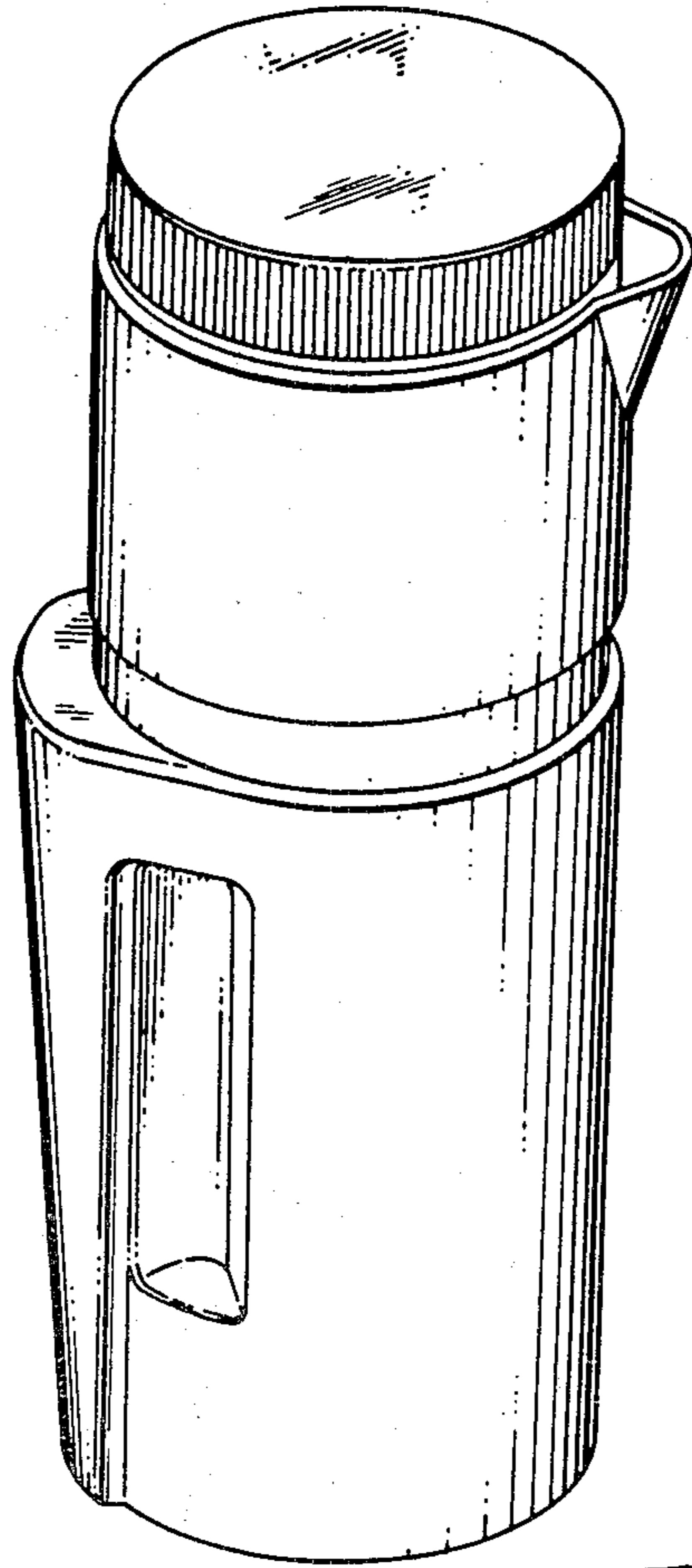

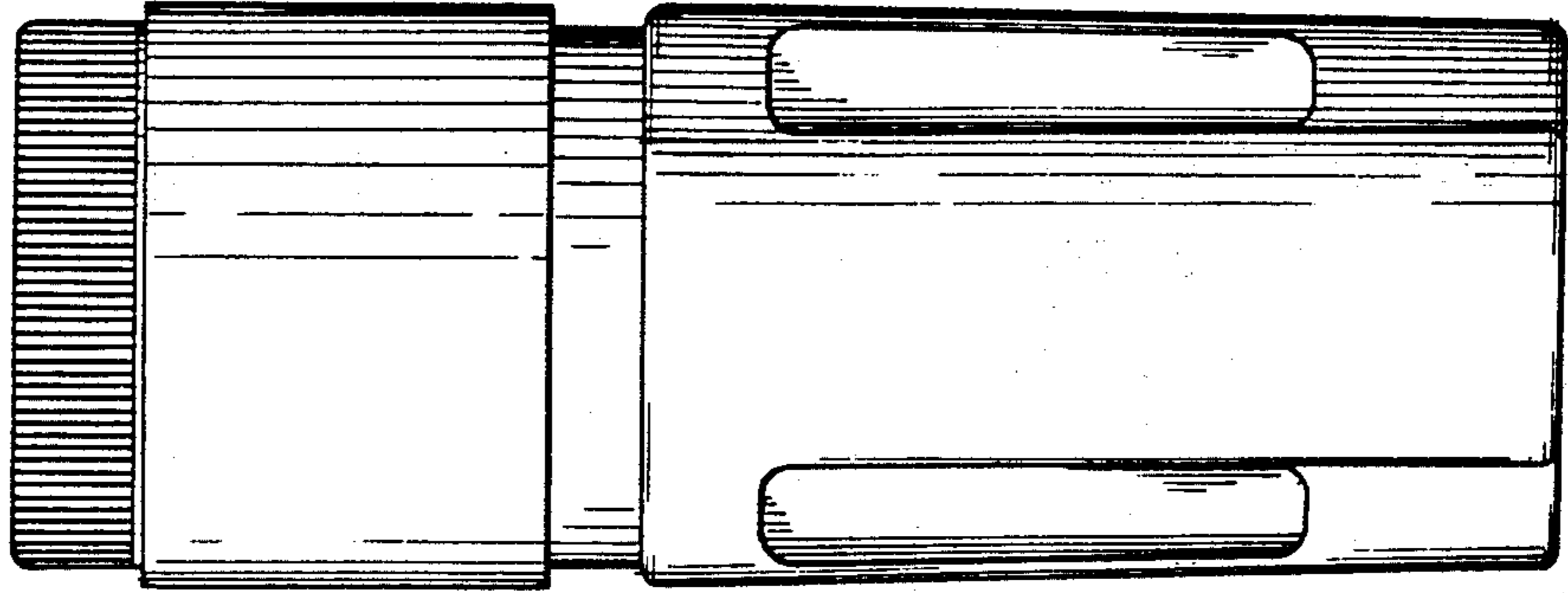

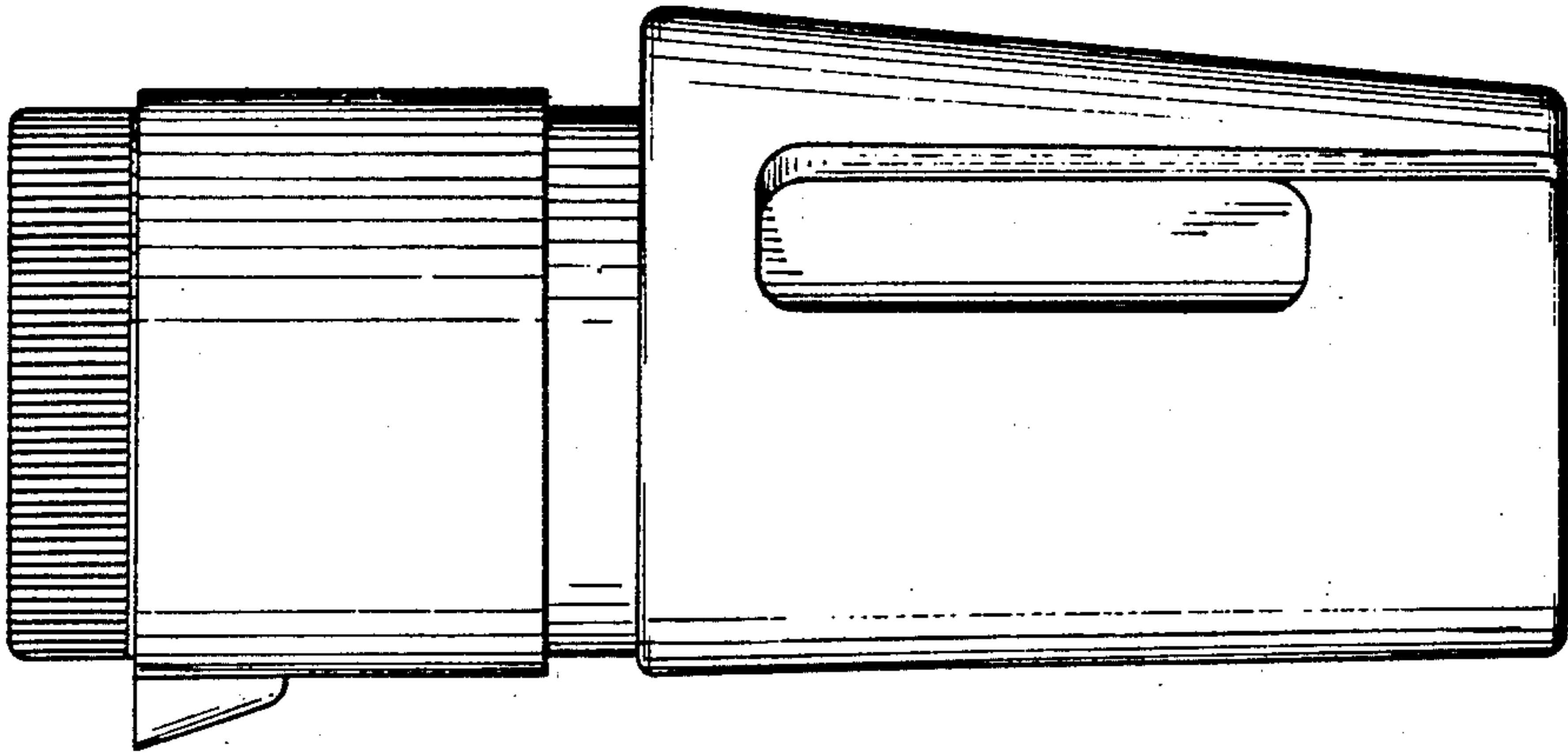

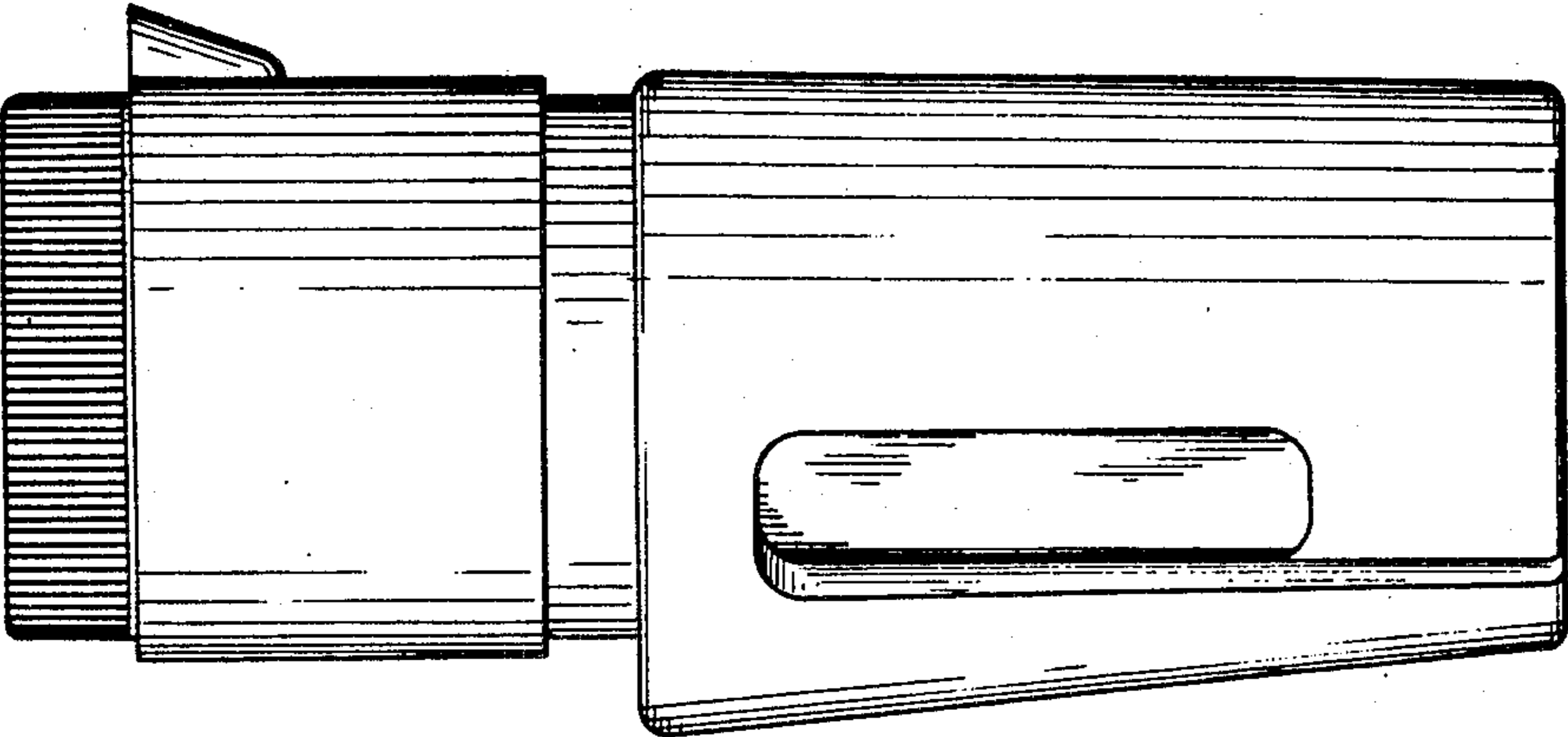

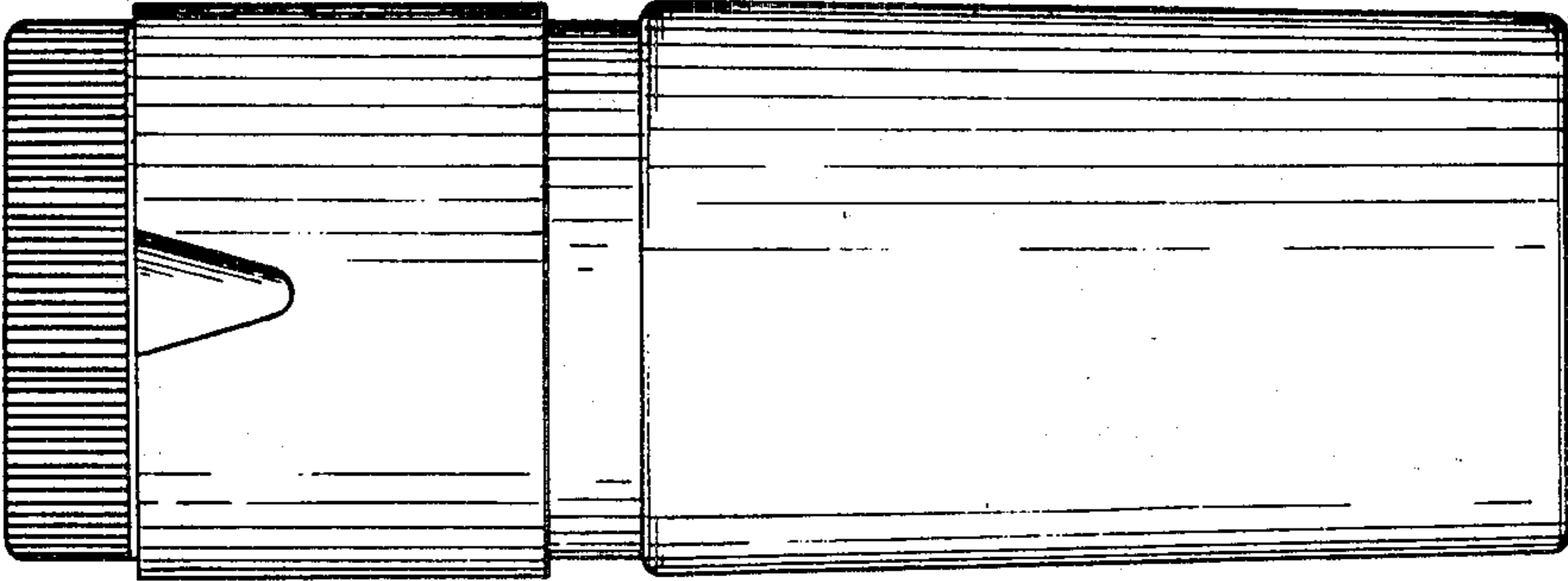

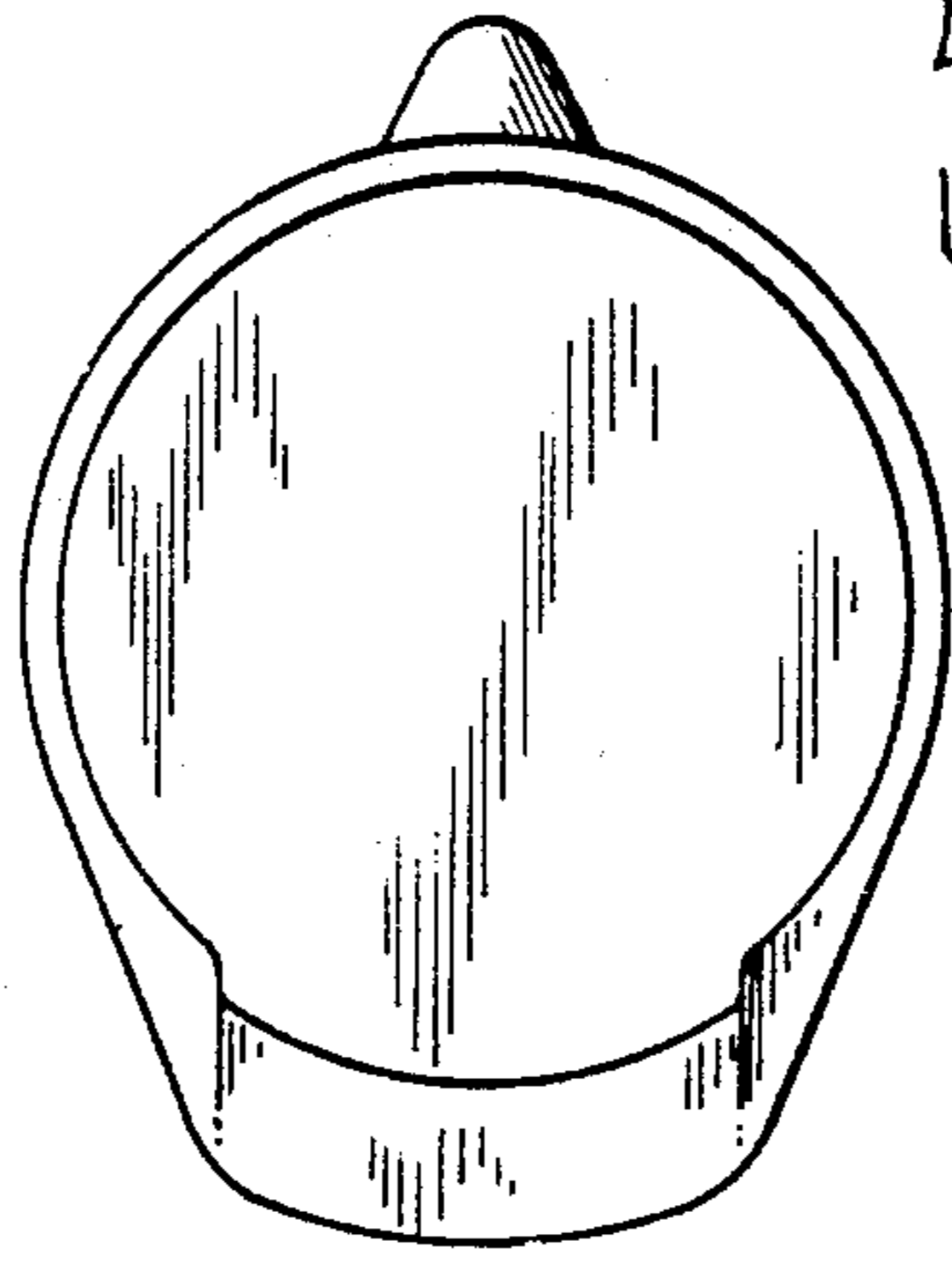

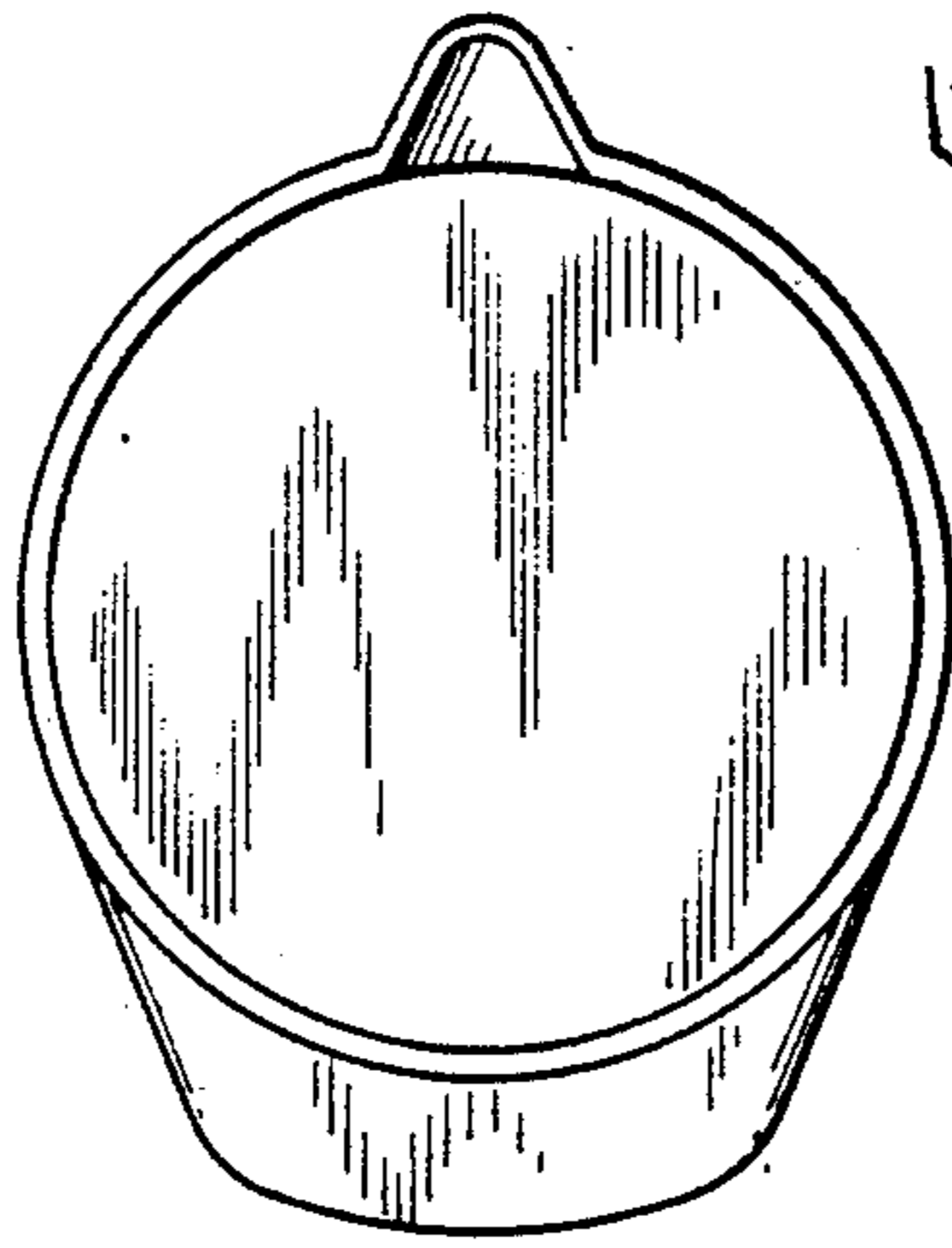
