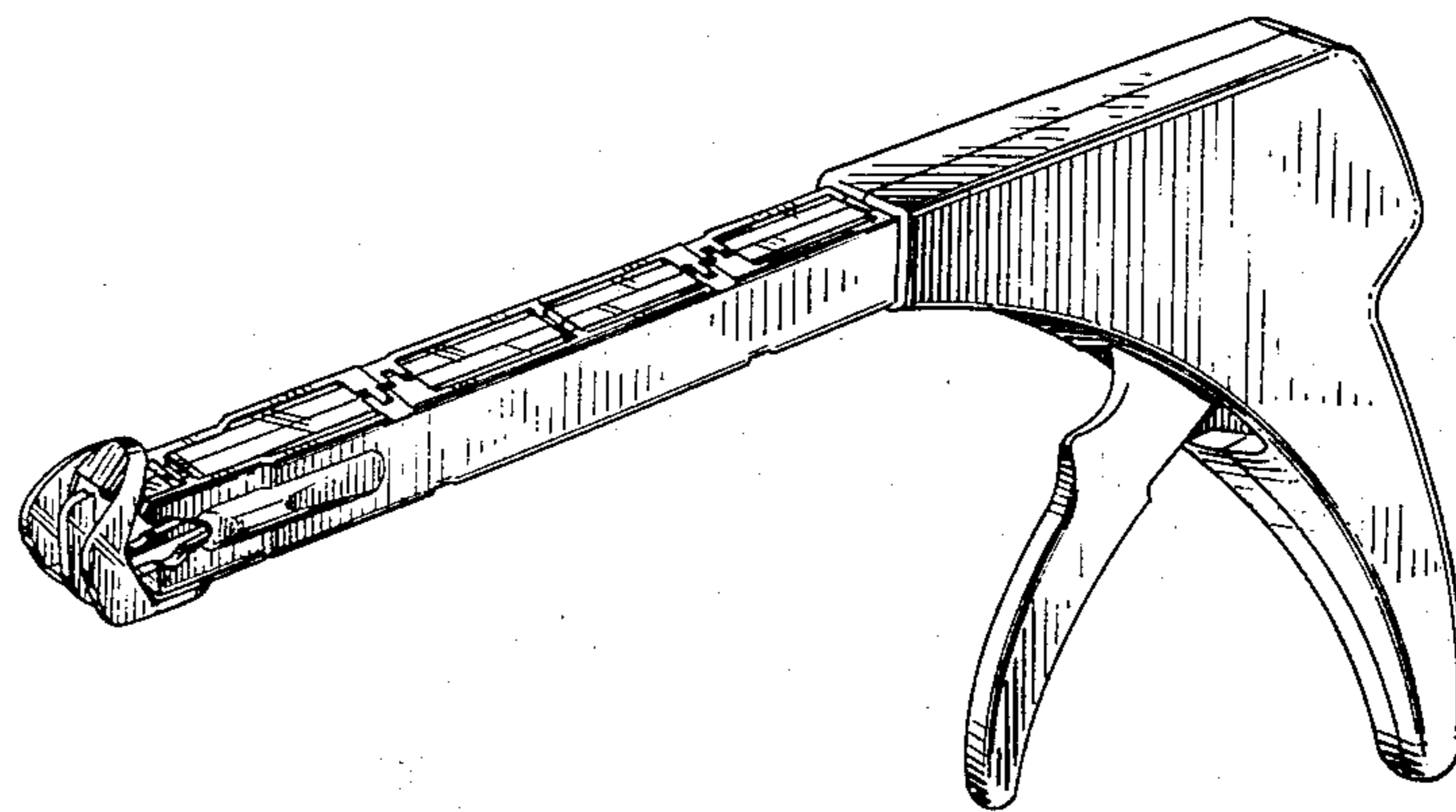

[57] **CLAIM**

The ornamental design for a combined surgical occluding and cutting instrument, substantially as shown and described.

DESCRIPTION

FIG. 1 is a side perspective view of a combined surgical occluding and cutting instrument showing our new design;
 FIG. 2 is a side elevational view of the device of FIG. 1;
 FIG. 3 is a right side elevational view thereof;
 FIG. 4 is a left side elevational view thereof;
 FIG. 5 is a top plan view as seen from FIG. 1; and
 FIG. 6 is a bottom plan view as seen from FIG. 1.



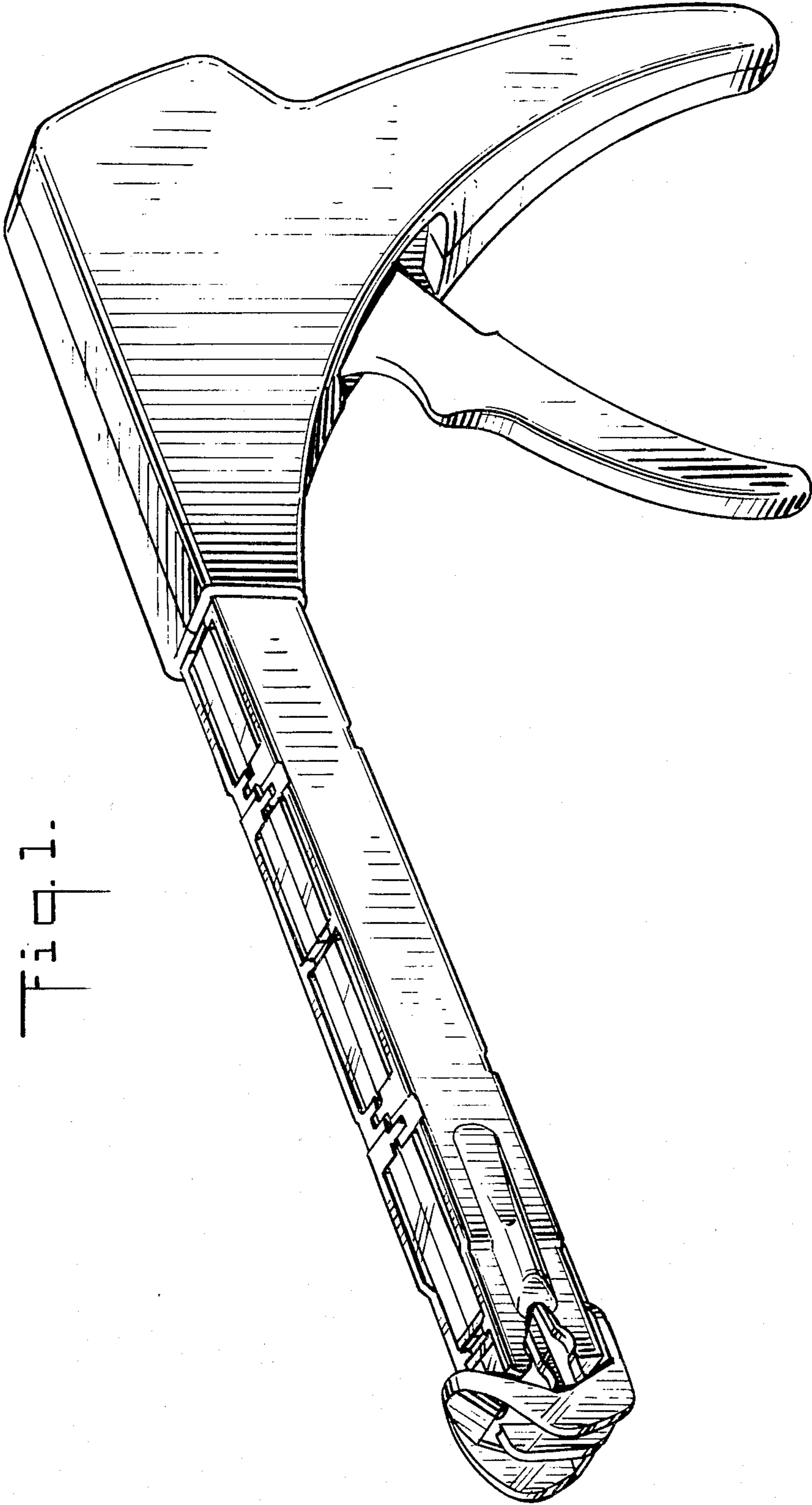

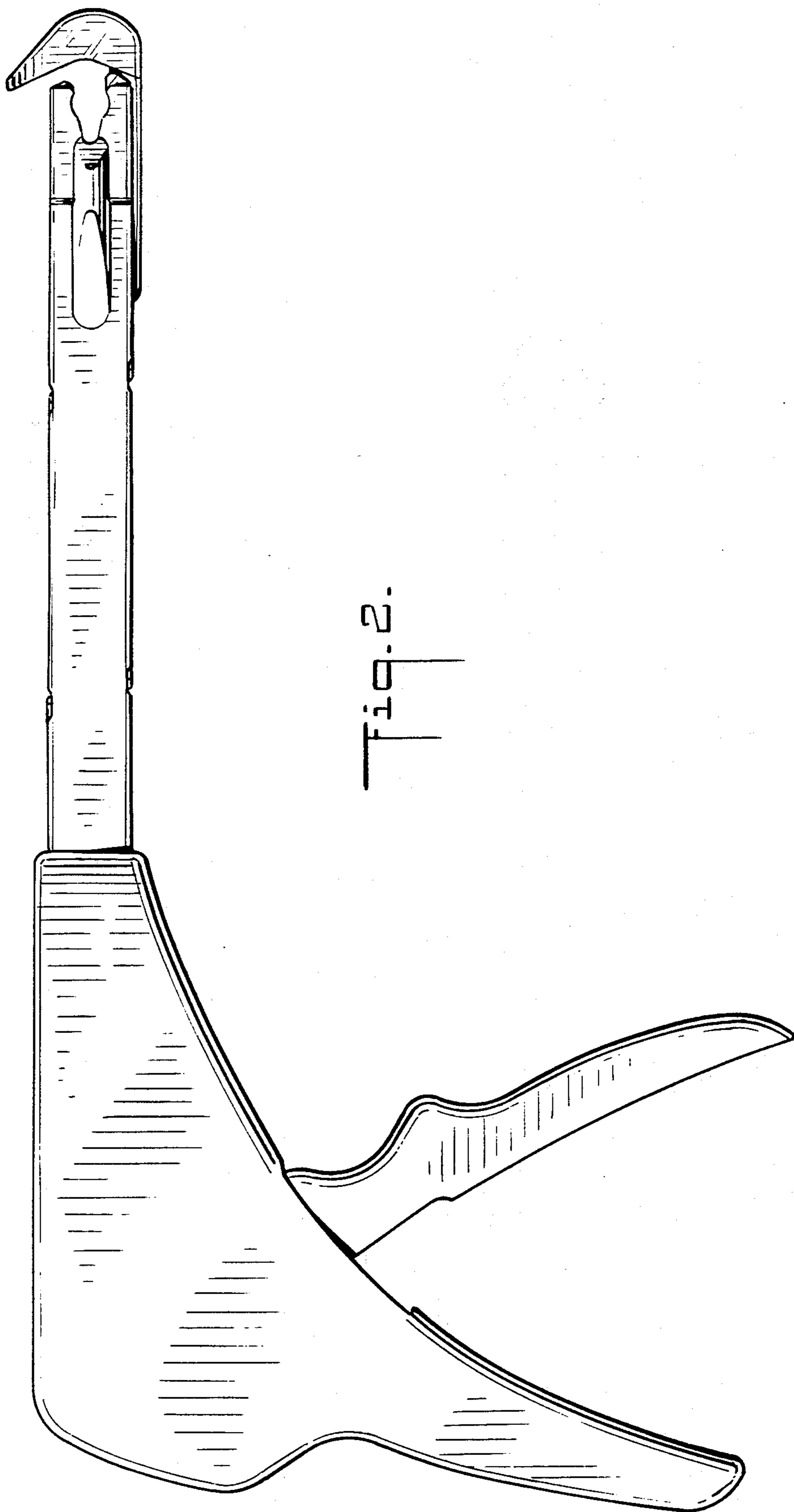

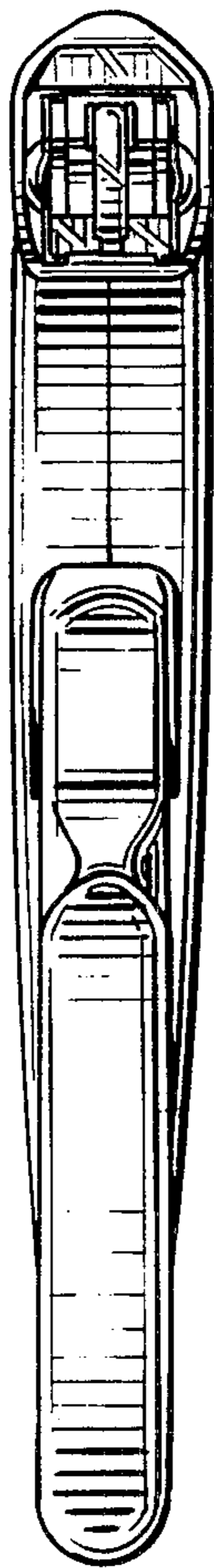

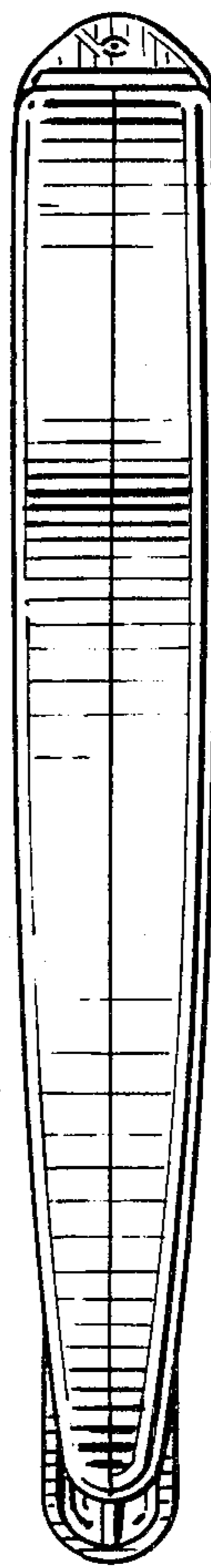

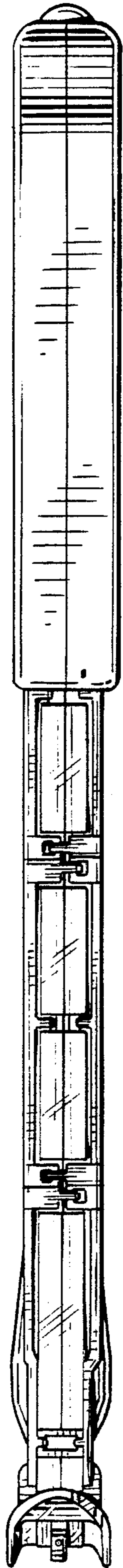
