FIG. 1 is a front elevational view of an ashtray, showing my new design.

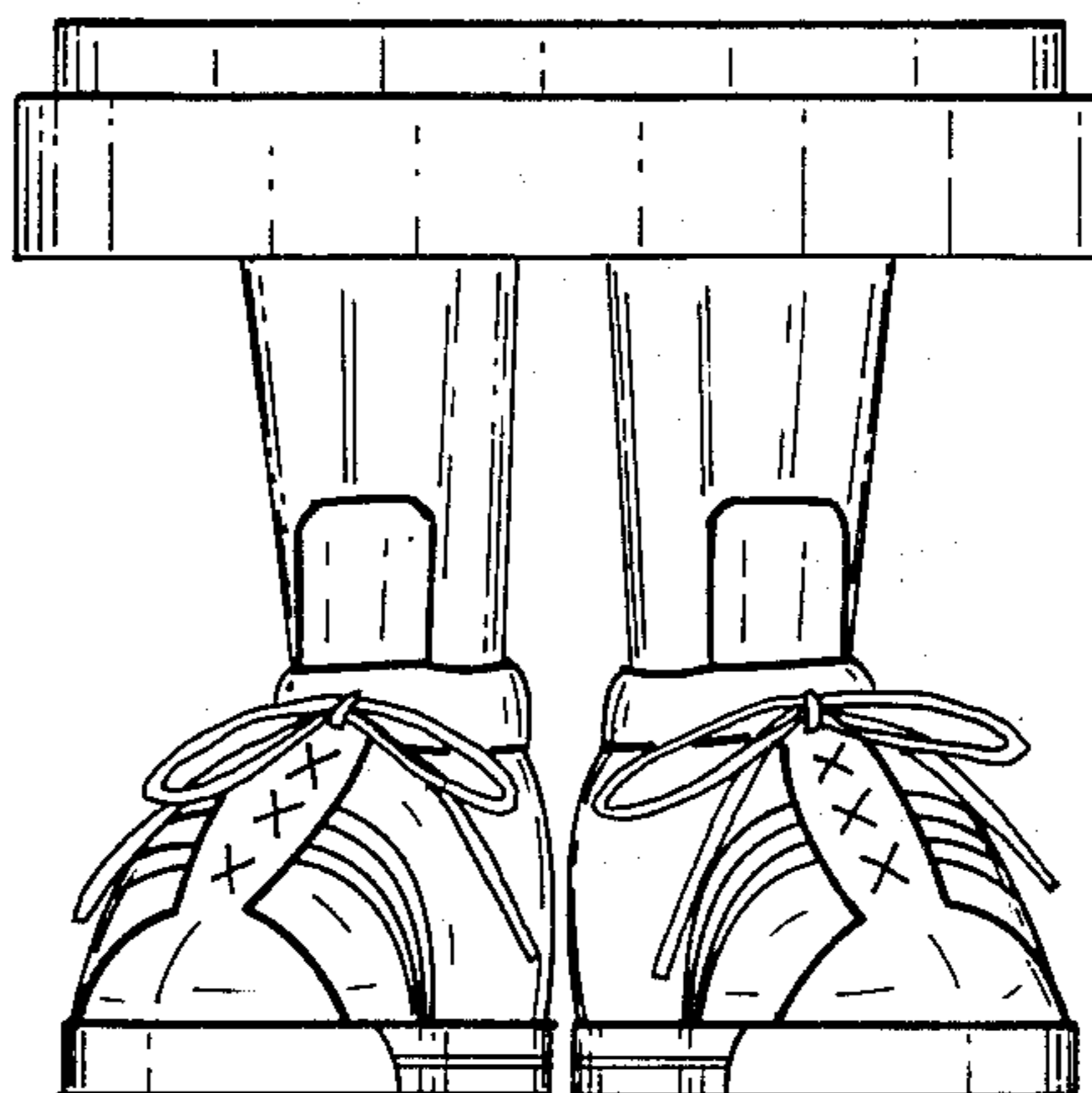
FIG. 2 is a rear elevational view of an ashtray, showing my new design.

FIG. 6 is a bottom plan view of an ashtray, showing my new design.



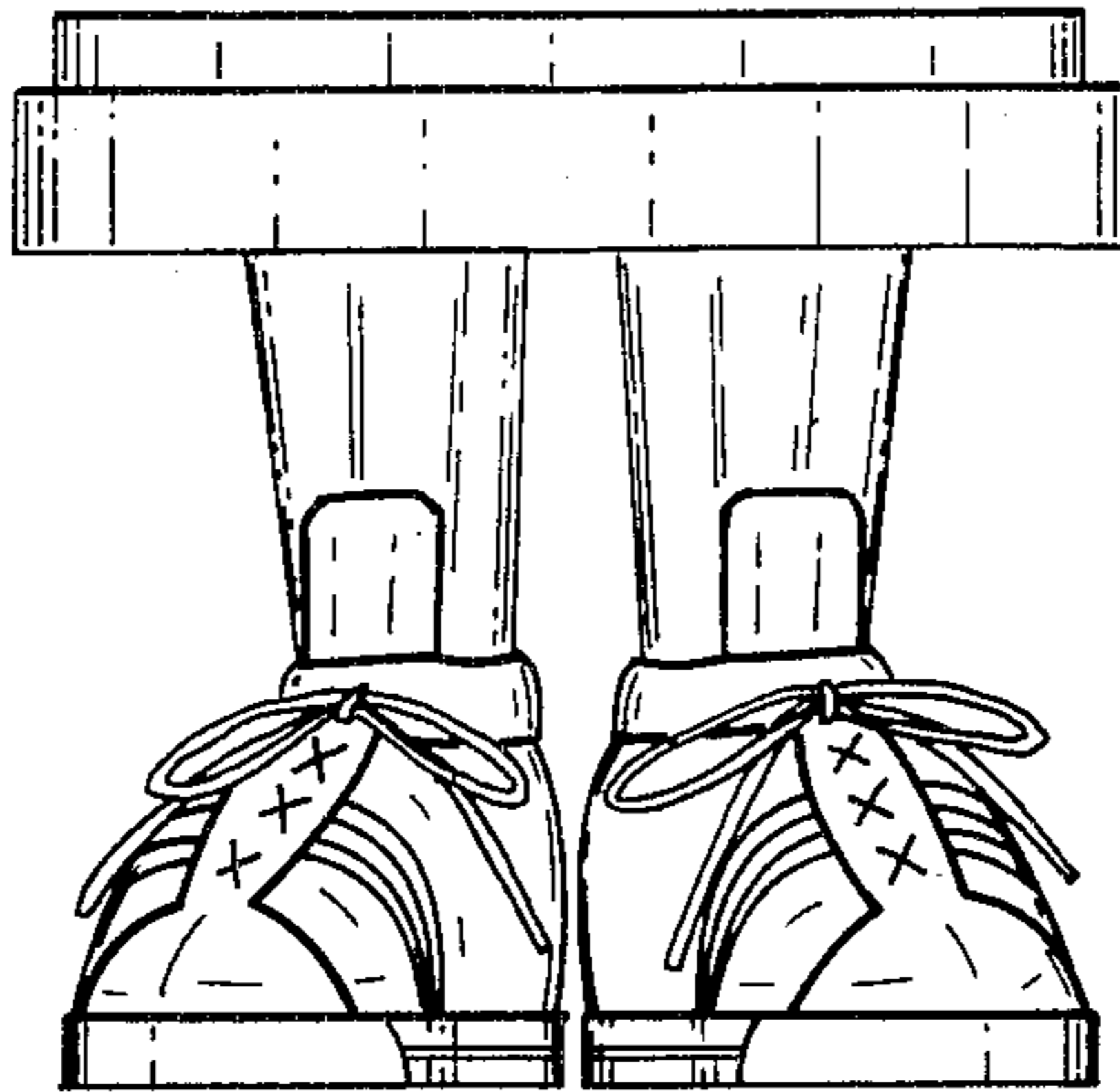

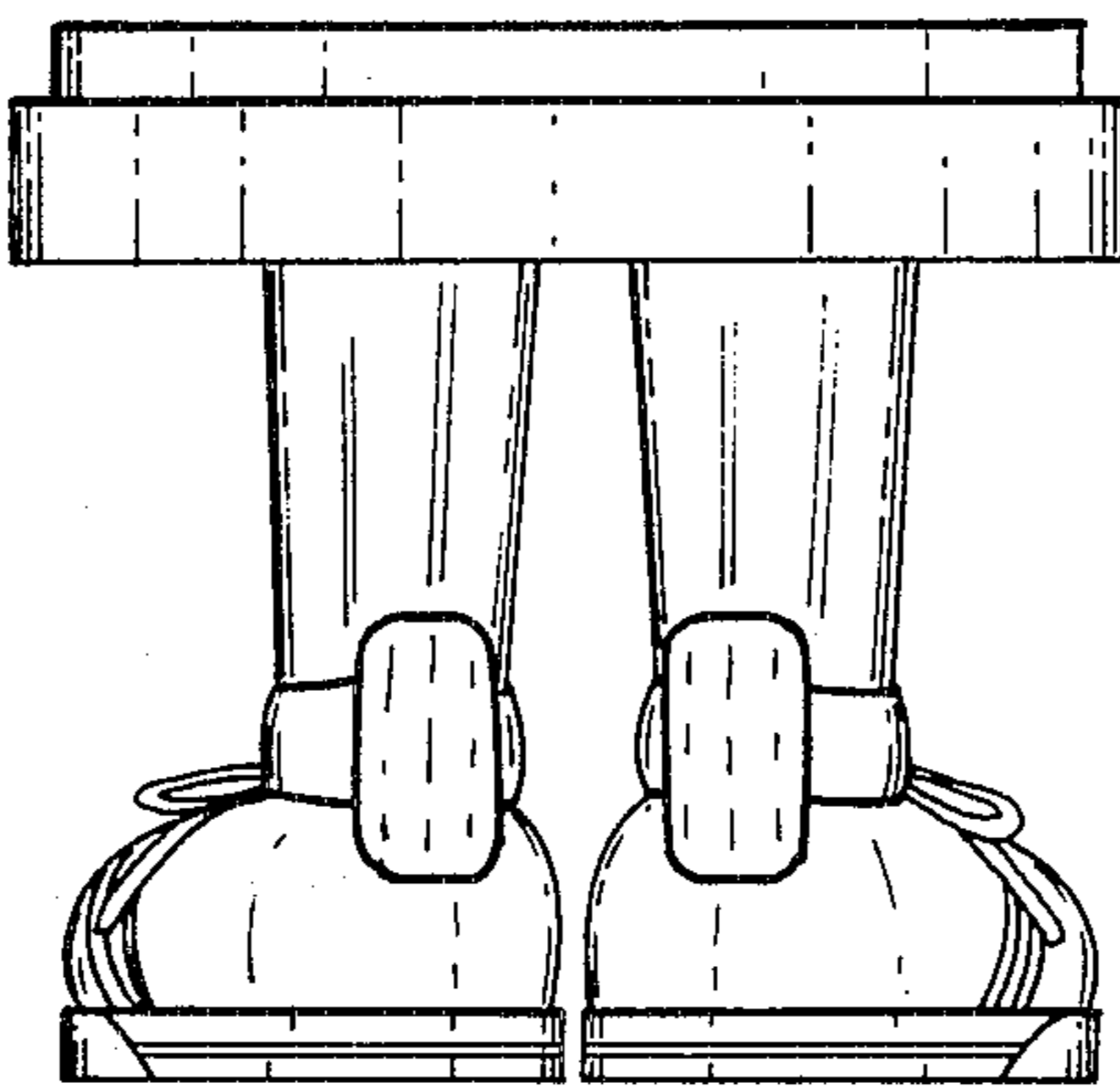

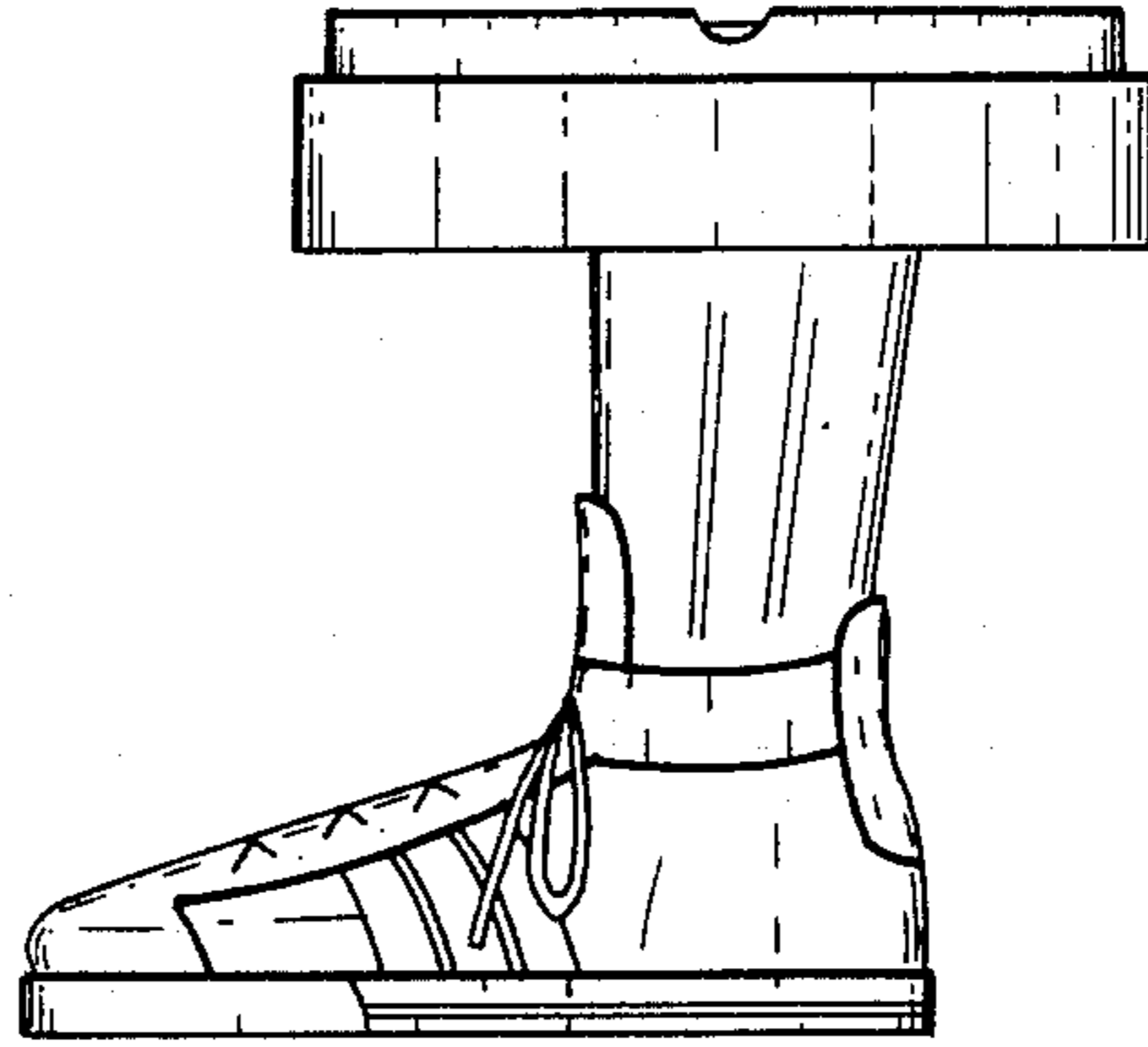

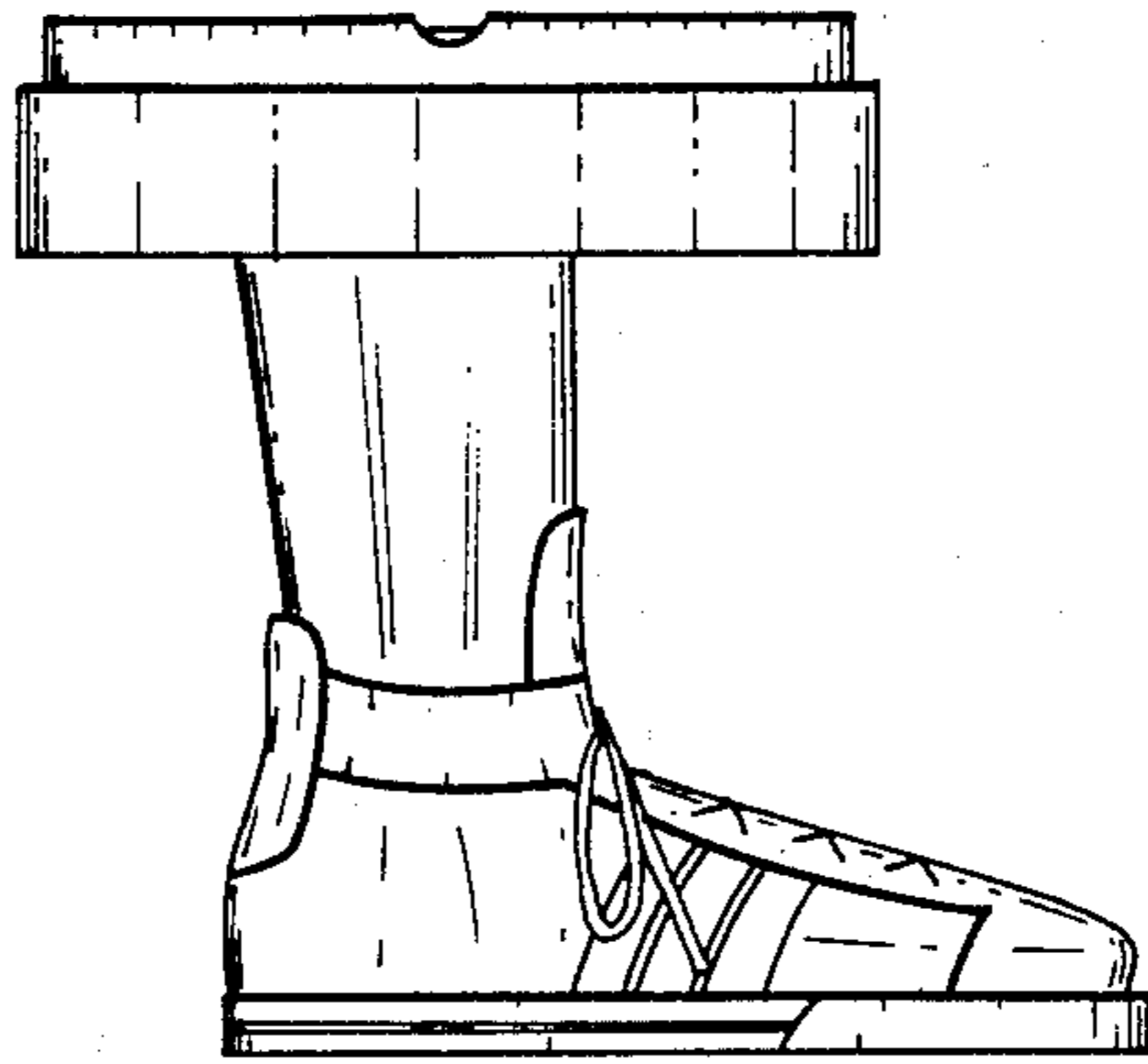

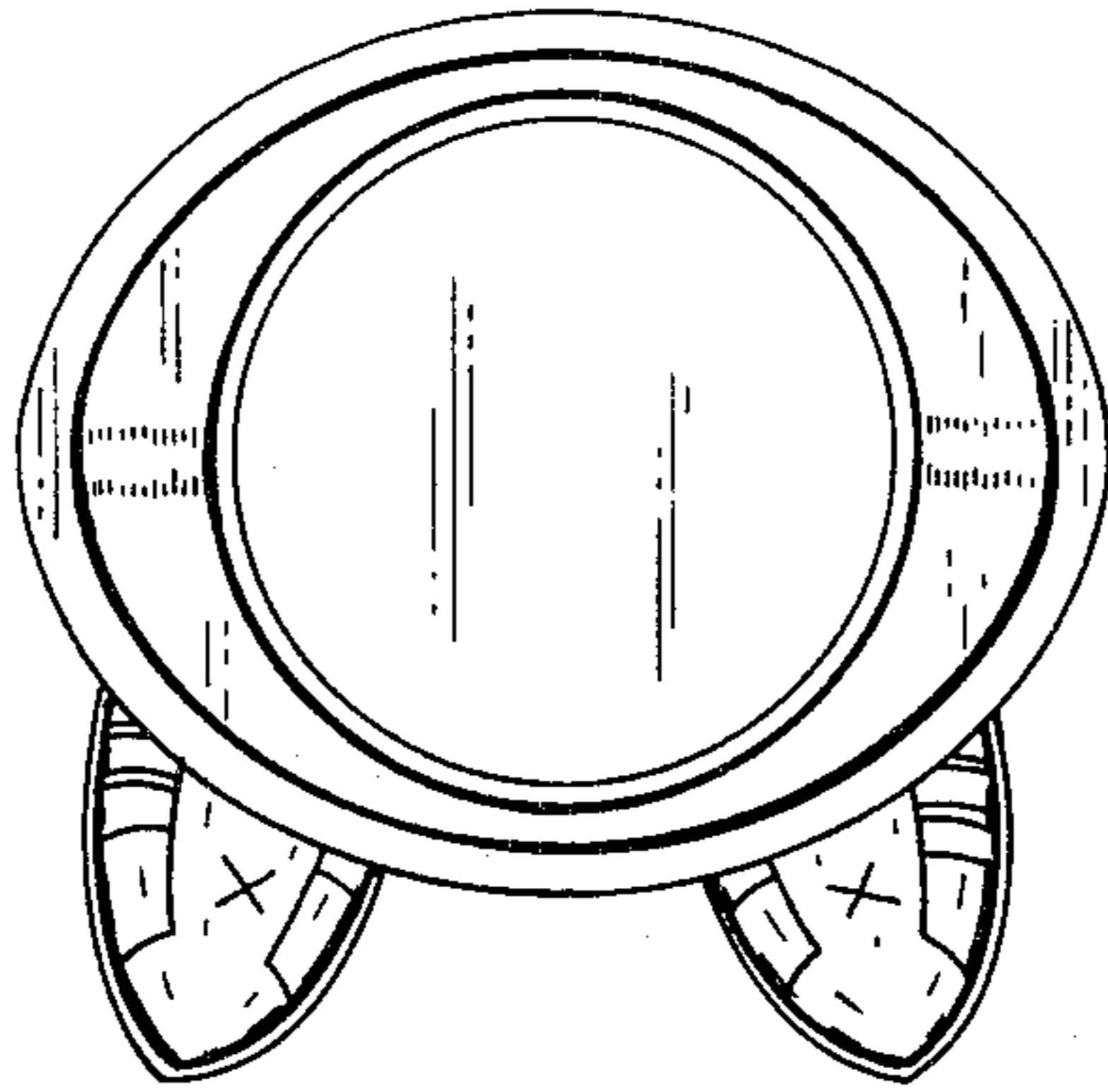

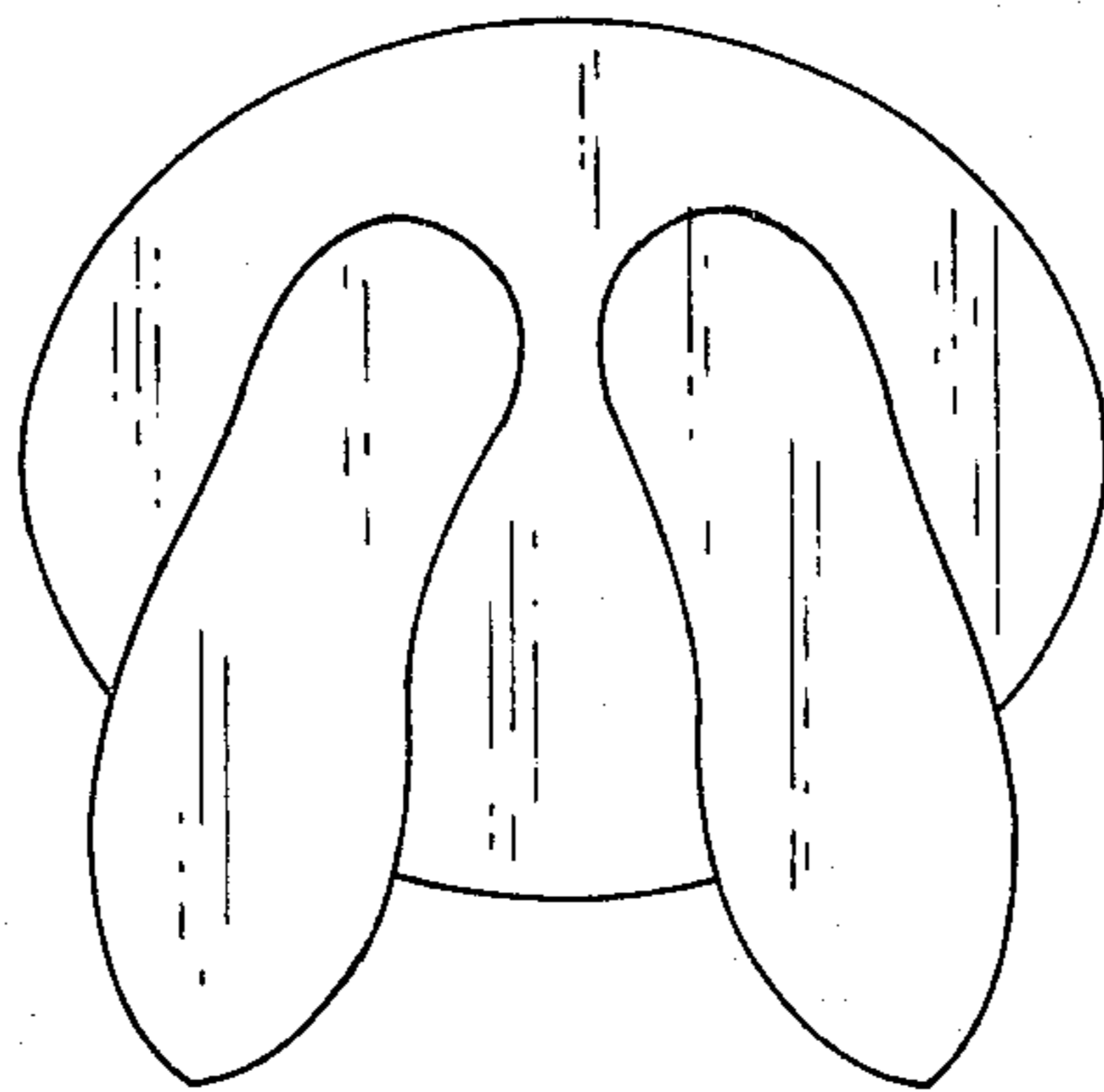
