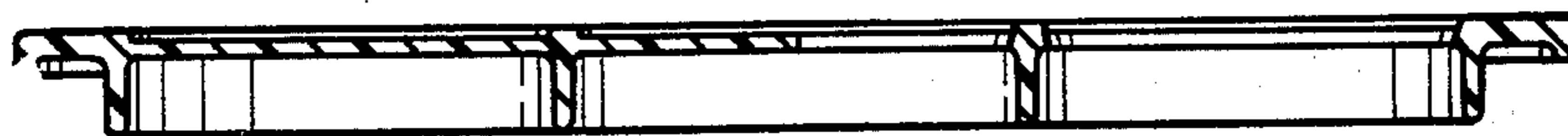
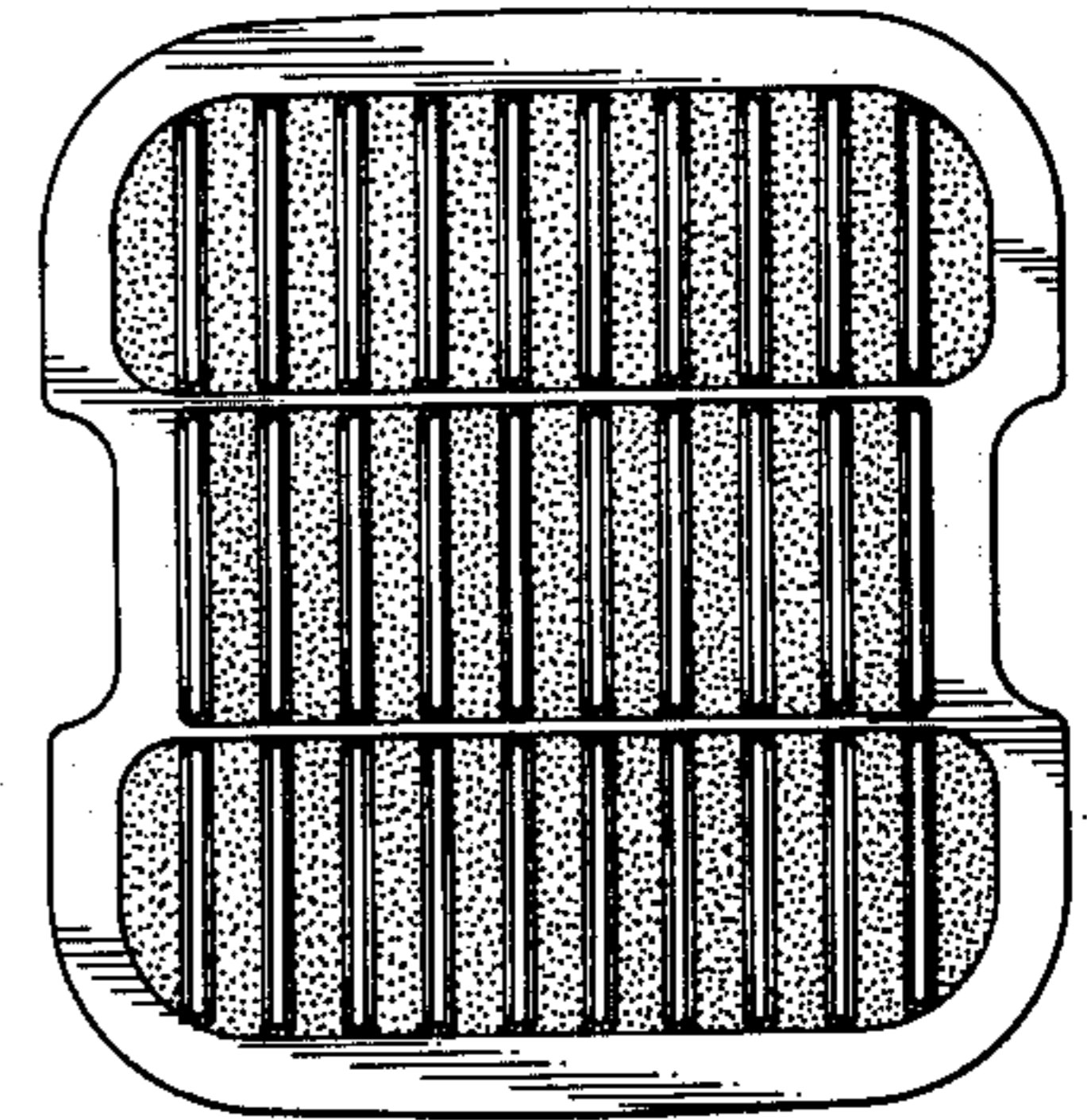
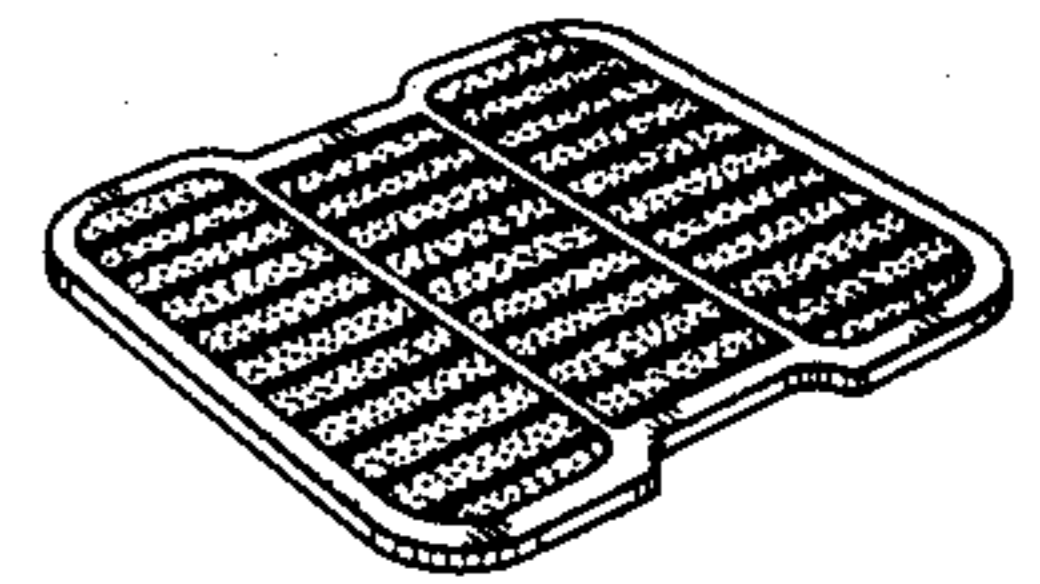
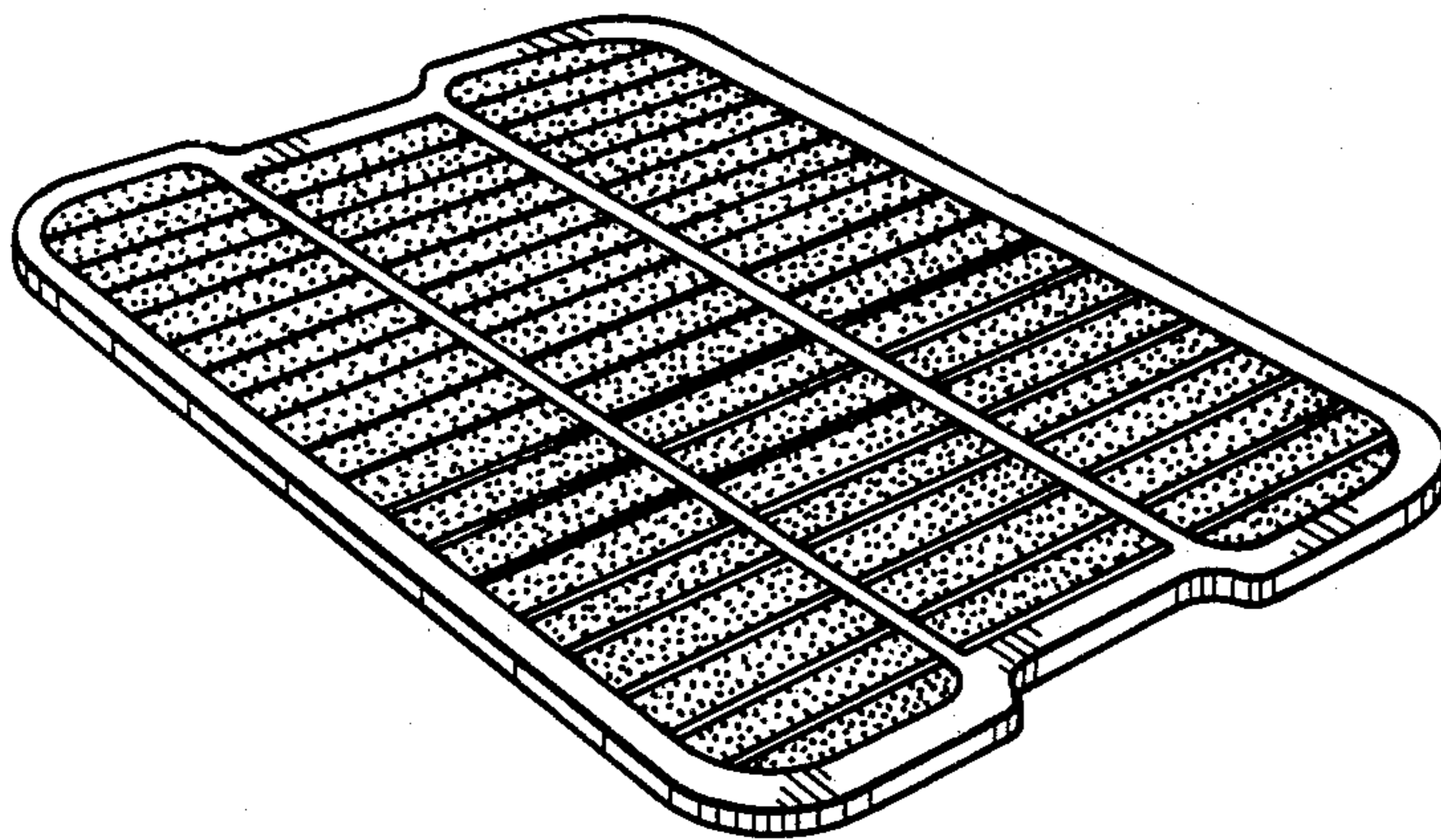

[57] CLAIM

The ornamental design for a drain tray for a food storage container, substantially as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a drain tray for a food storage container showing our new design; FIG. 2 is a top plan view of FIG. 1; FIG. 3 is a side elevational view of FIG. 1; the opposite side being identical thereto; FIG. 4 is an end elevational view of FIG. 1; the opposite end being identical thereto; FIG. 5 is a bottom plan view of FIG. 1; FIG. 6 is a modification of the tray shown in FIG. 1; FIG. 7 is a top plan view of FIG. 6; FIG. 8 is a side elevational view of FIG. 6; the opposite side being identical thereto; FIG. 9 is an end elevational view of FIG. 6; the opposite end being identical thereto; FIG. 10 is a bottom plan view of FIG. 6; FIG. 11 is a cross sectional view taken along line 11—11 of FIG. 2.



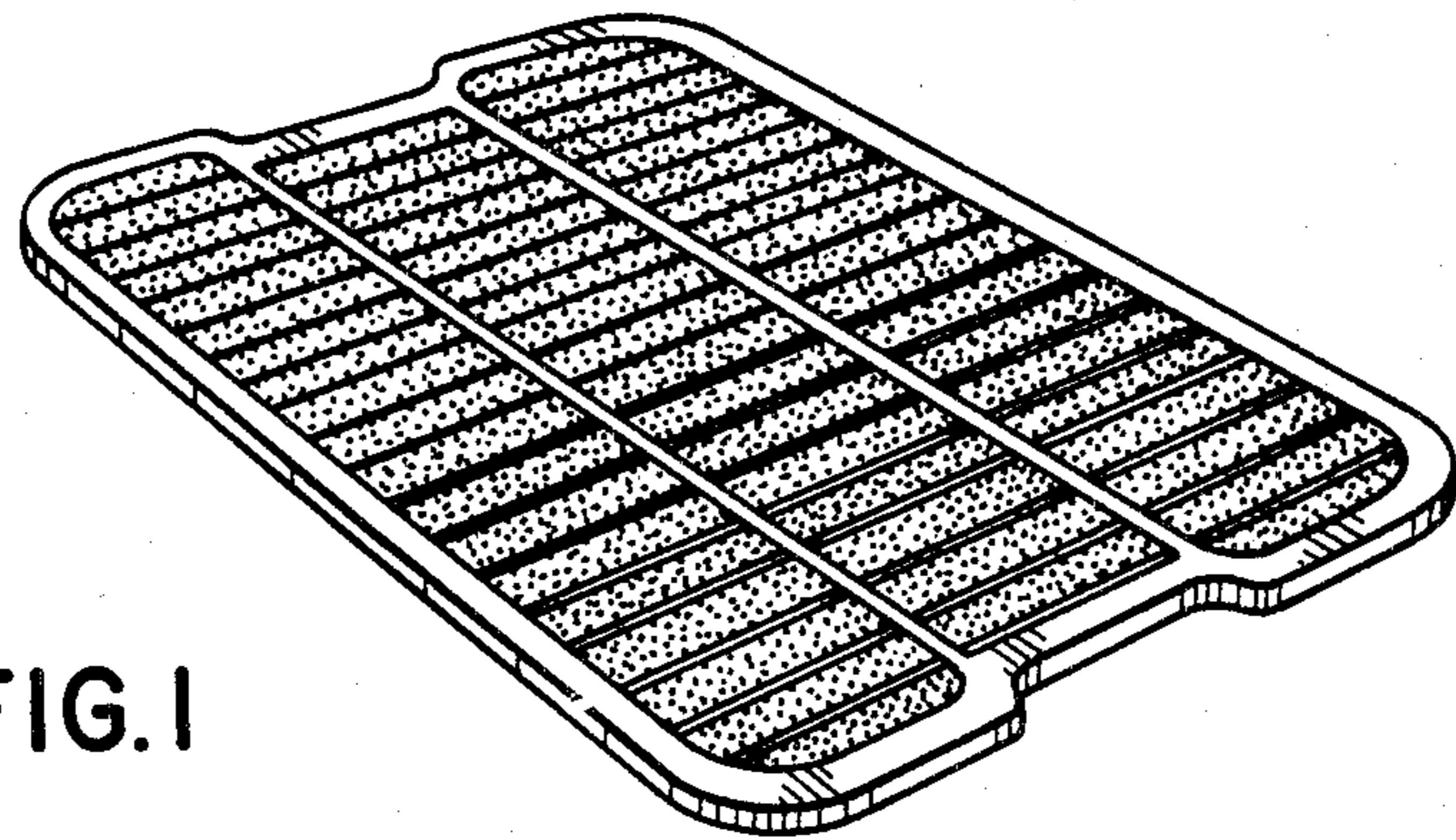

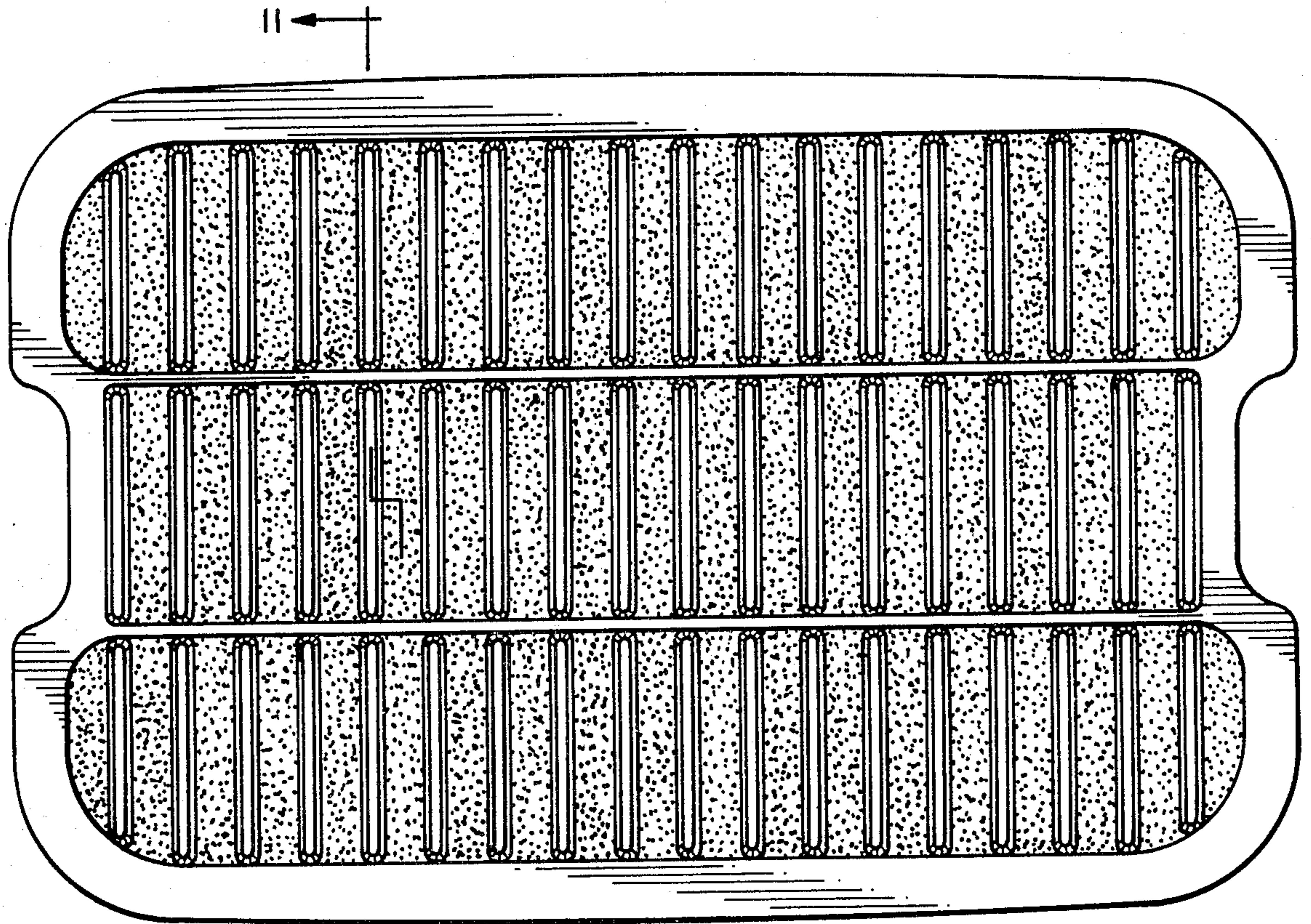

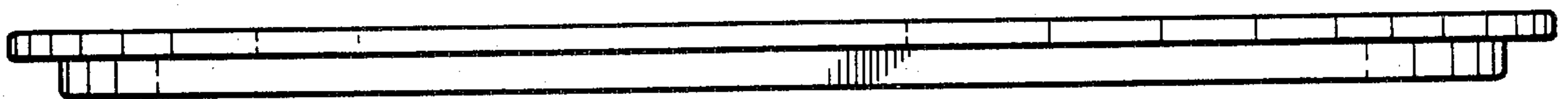

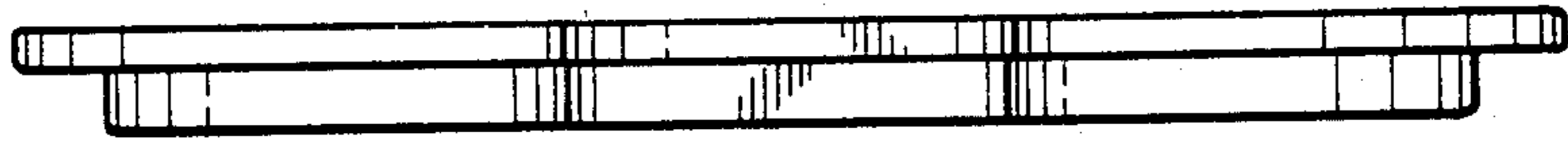

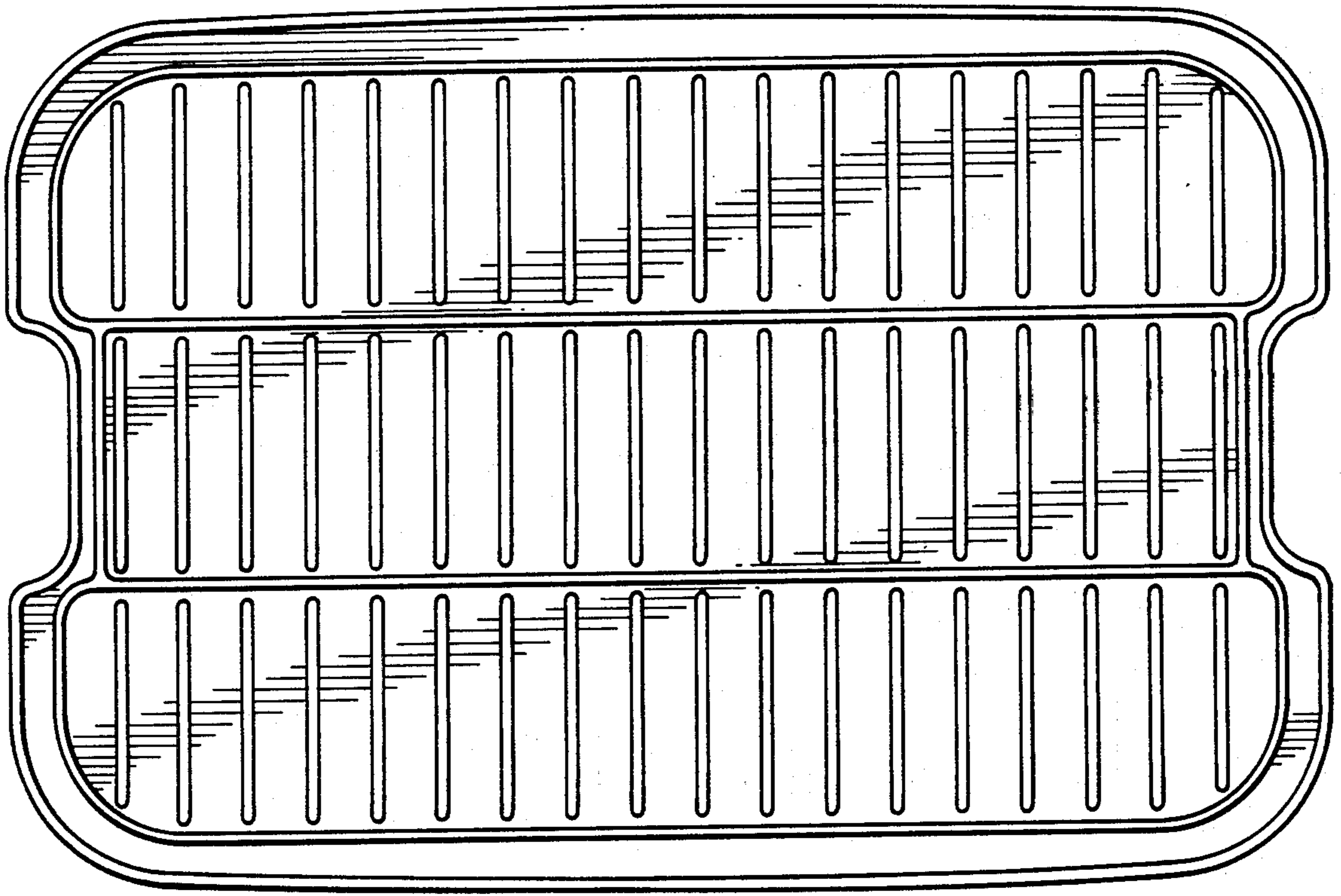

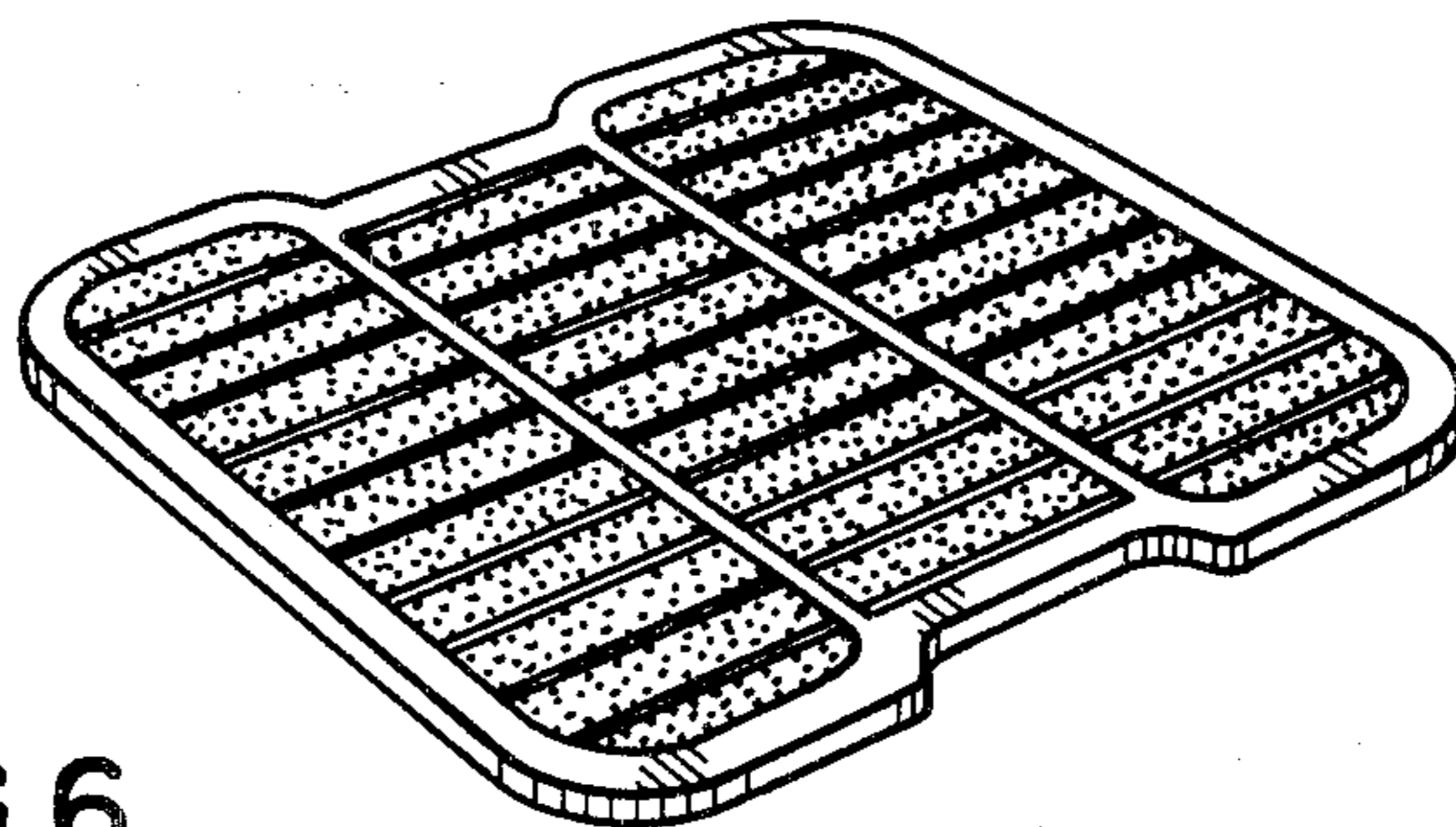

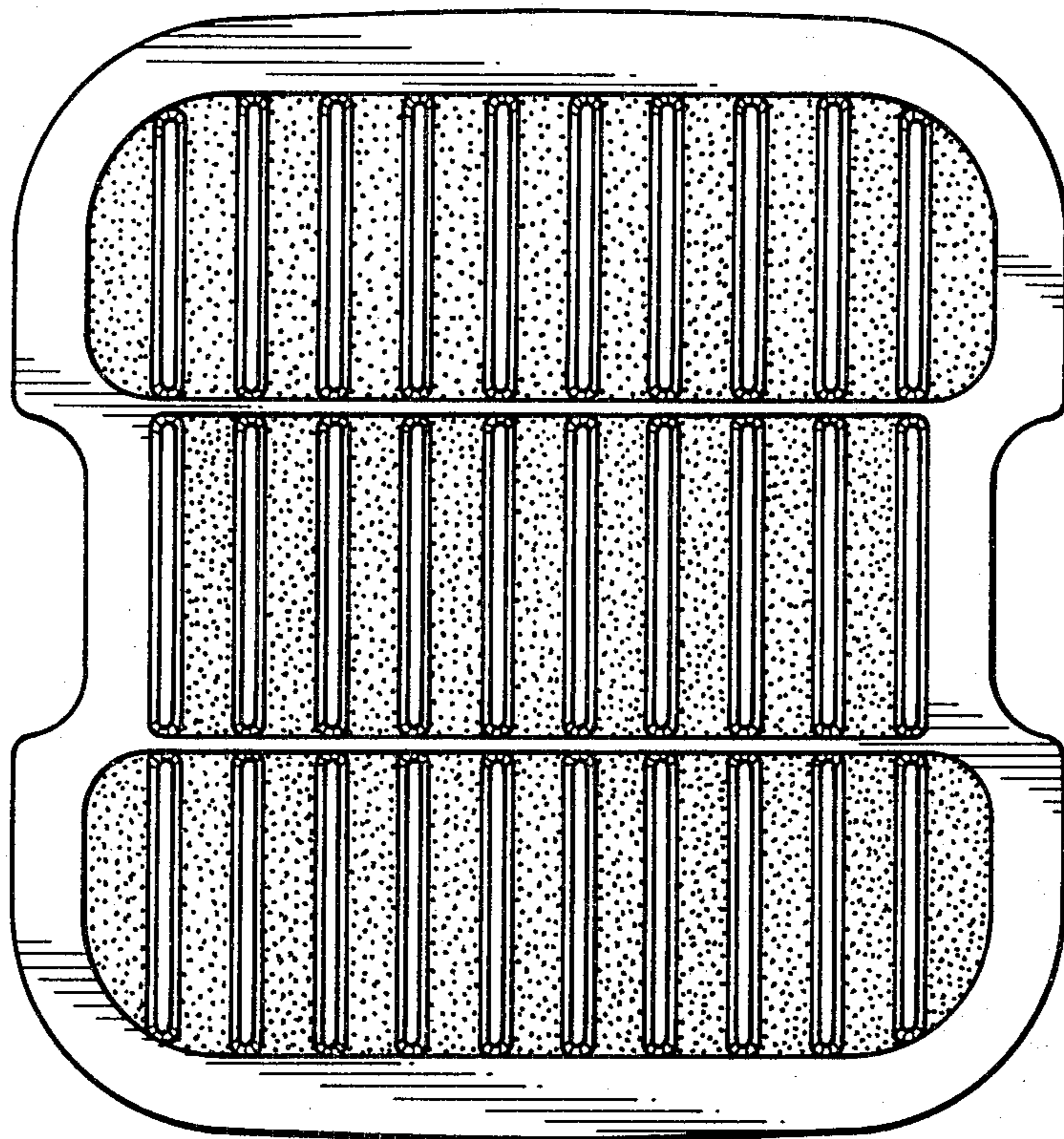

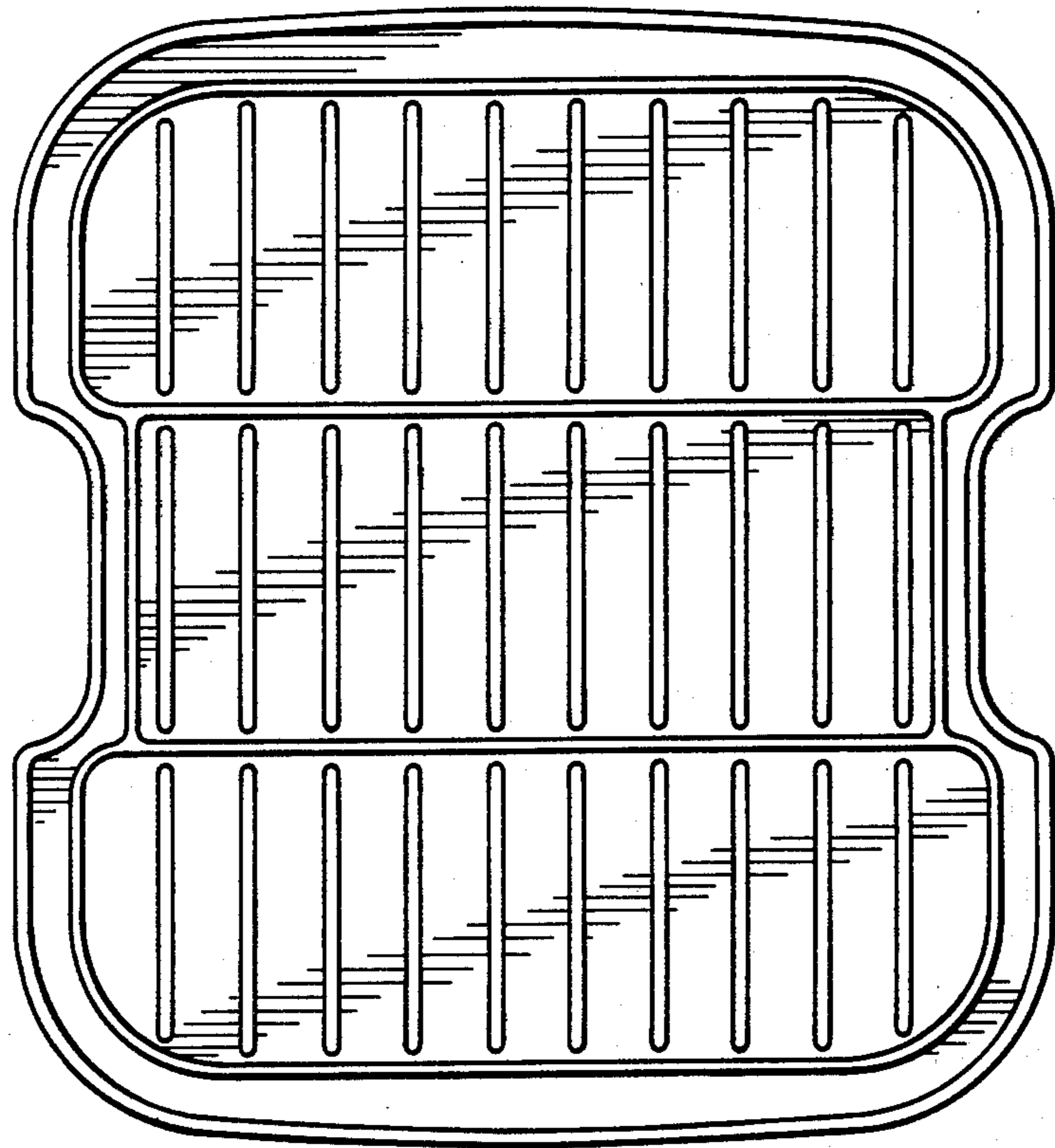

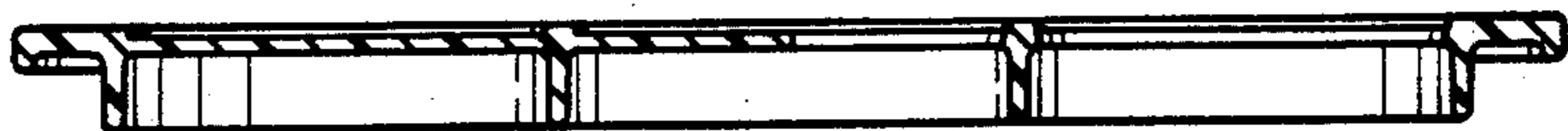
