[57] CLAIM

The ornamental design for a whirlpool bathing shell, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a whirlpool bathing shell embodying my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a right side elevational view thereof;
FIG. 4 is a rear side elevational view thereof;
FIG. 5 is a front elevational view thereof;
FIG. 6 is a left side elevational view thereof;
FIG. 7 is a bottom plan view thereof.
FIG. 8 is a sectional view taken on the line 8—8 of FIG. 2;
FIG. 9 is a fragmentary sectional view thereof, taken on the line 9—9 of FIG. 8;
FIG. 10 is a fragmentary sectional view thereof, taken on the line 10—10 of FIG. 8;
FIG. 11 is a perspective view of a second embodiment of the whirlpool bathing shell embodying my new design;
FIG. 12 is a perspective view of a third embodiment of the whirlpool bathing shell embodying my new design;
FIG. 13 is a top plan view of the third embodiment;
FIG. 14 is a right side elevational view of the third embodiment;
FIG. 15 is a rear elevational view of the third embodiment;
FIG. 16 is a front elevational view of the third embodiment;
FIG. 17 is a left side elevational view of the third embodiment;
FIG. 18 is a bottom plan view of the third embodiment.
FIG. 19 is a fragmentary sectional view of the third embodiment, taken on the line 19—19 of FIG. 13;
FIG. 20 is a fragmentary sectional view of the third embodiment, taken on the line 20—20 of FIG. 19;
FIG. 21 is a fragmentary sectional view of the third embodiment, taken on the line 21—21 of FIG. 19;
FIG. 22 is a perspective view of a fourth embodiment of the whirlpool bathing shell embodying my new design.

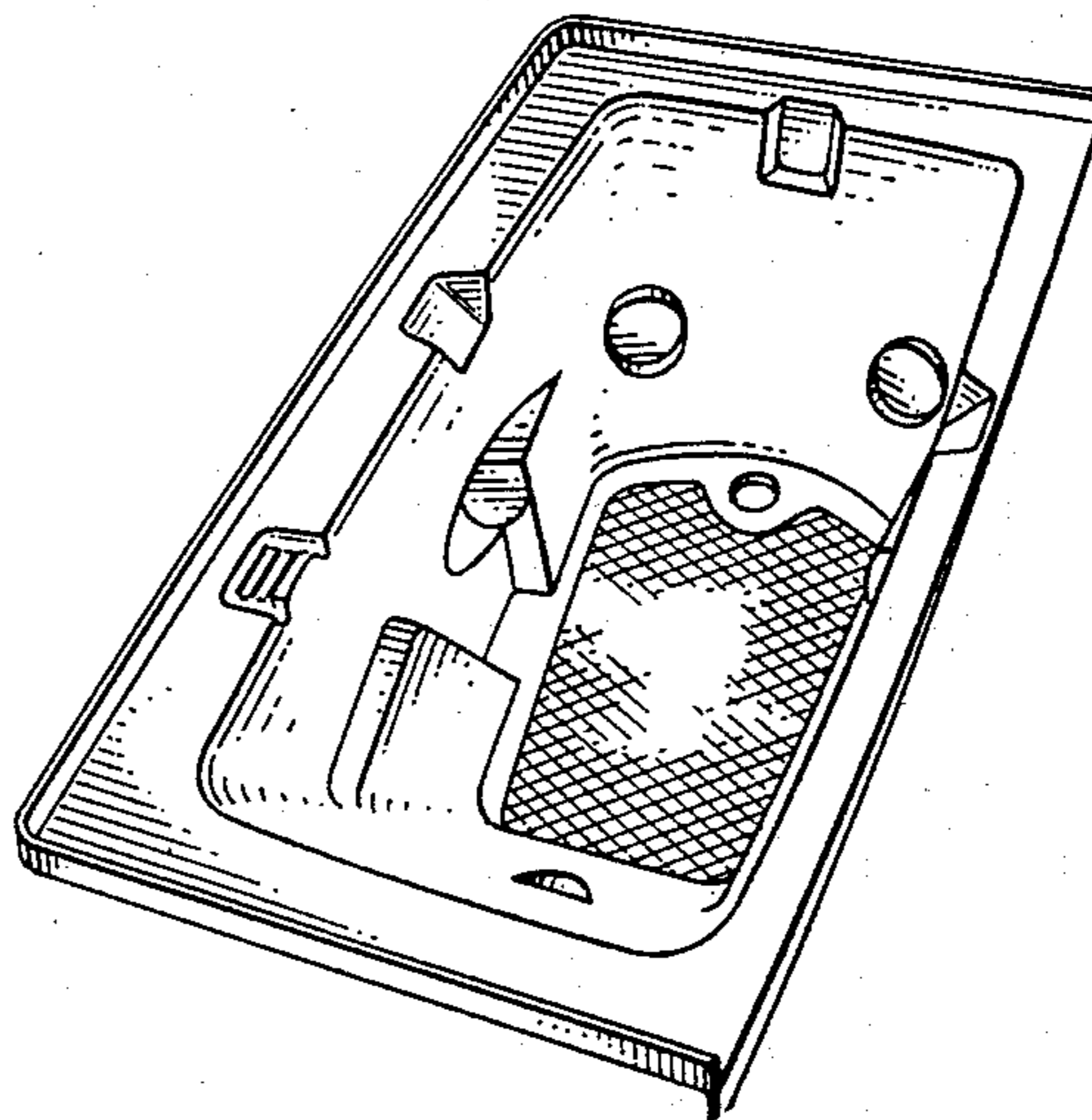

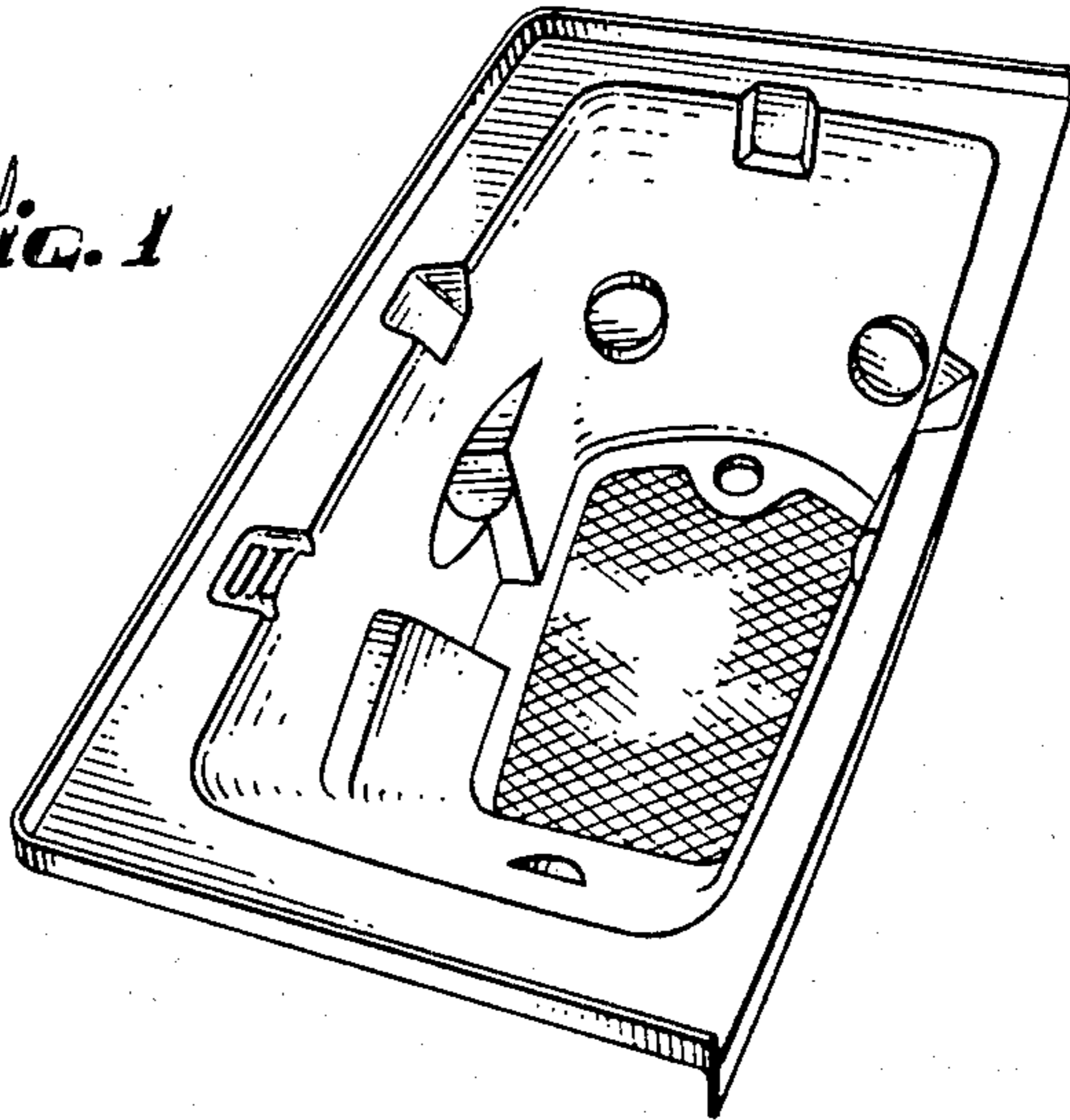

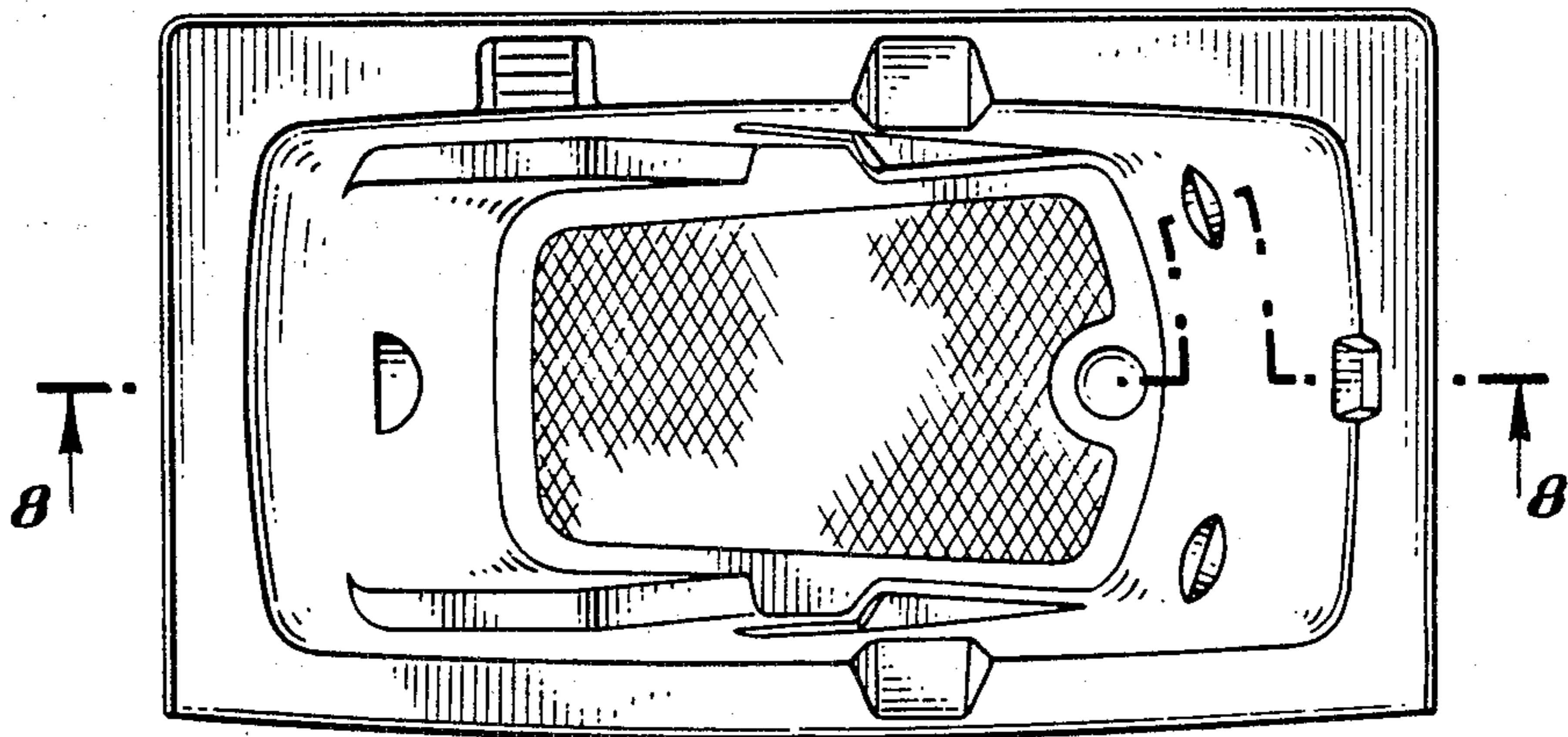

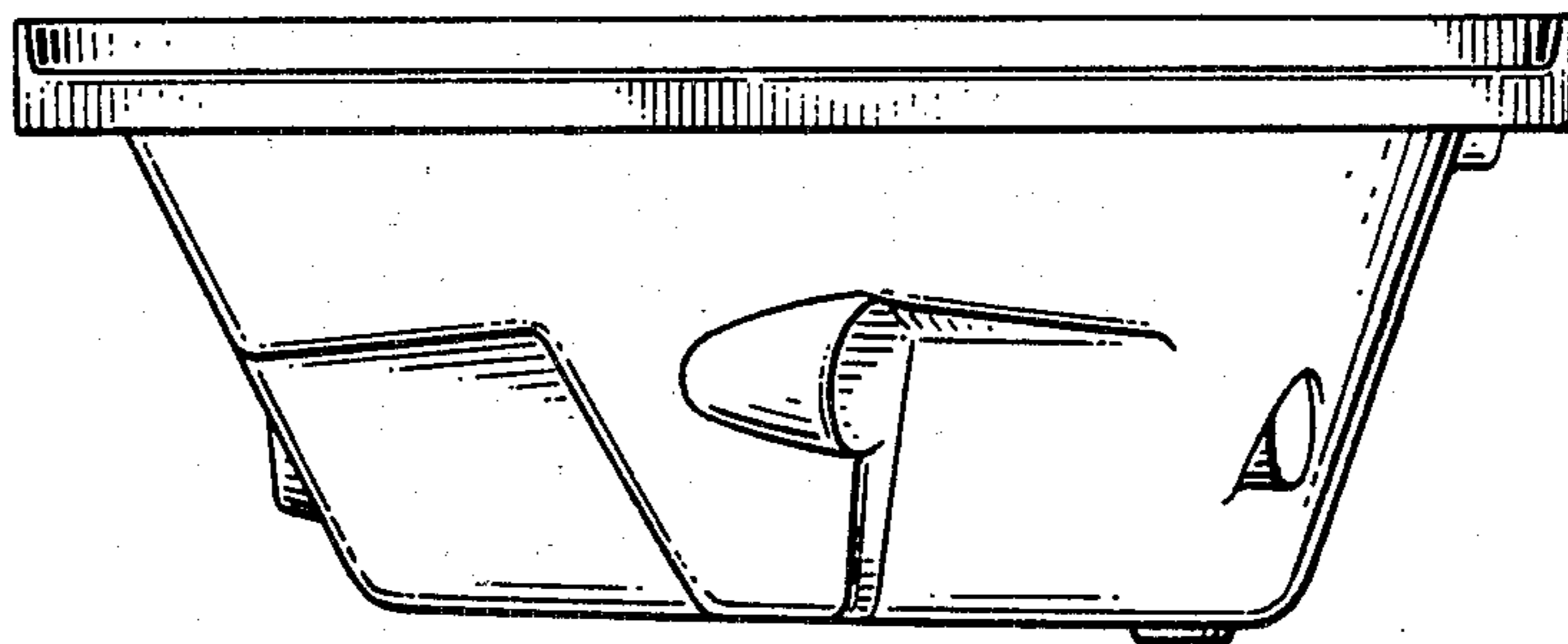

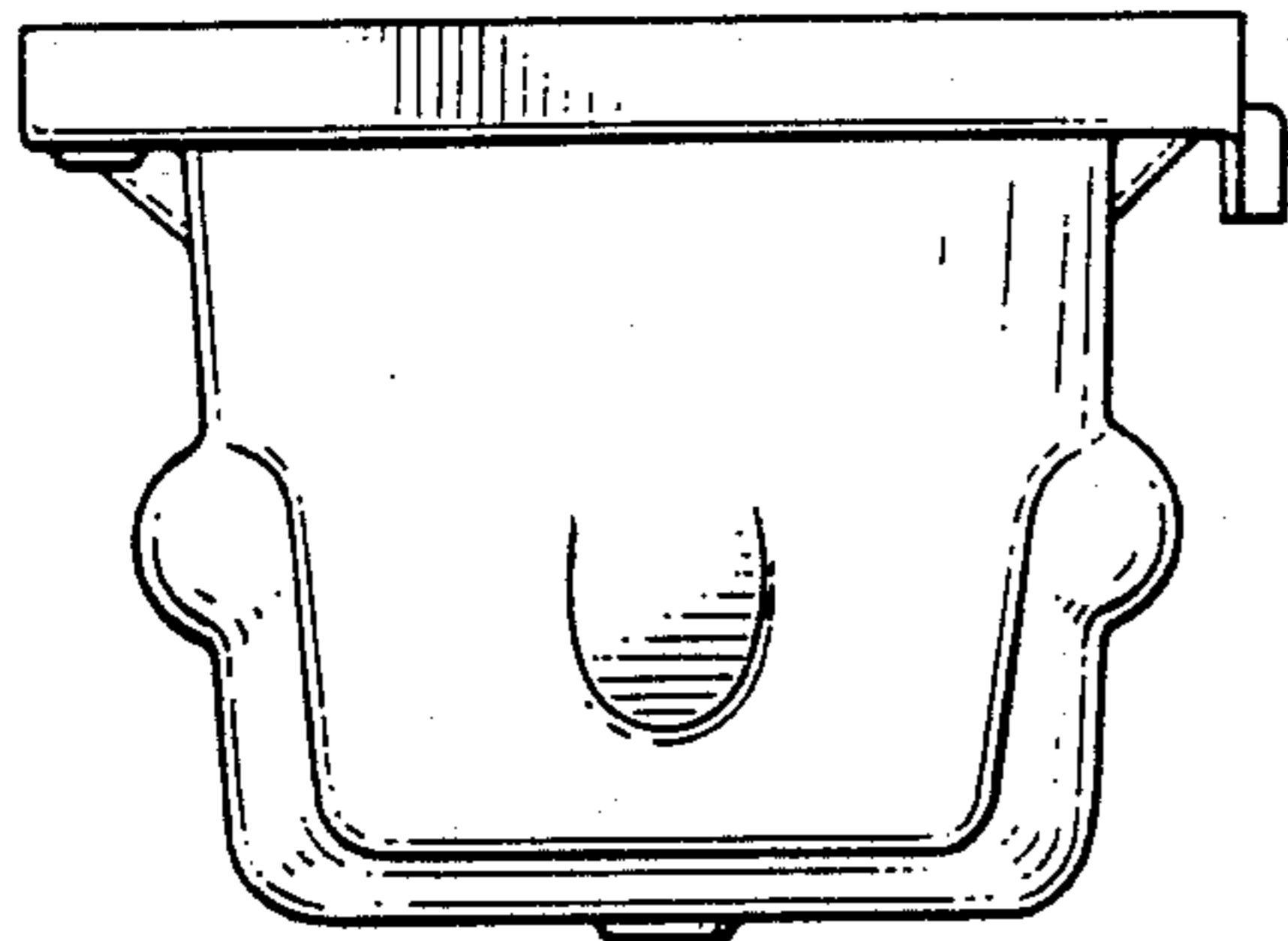

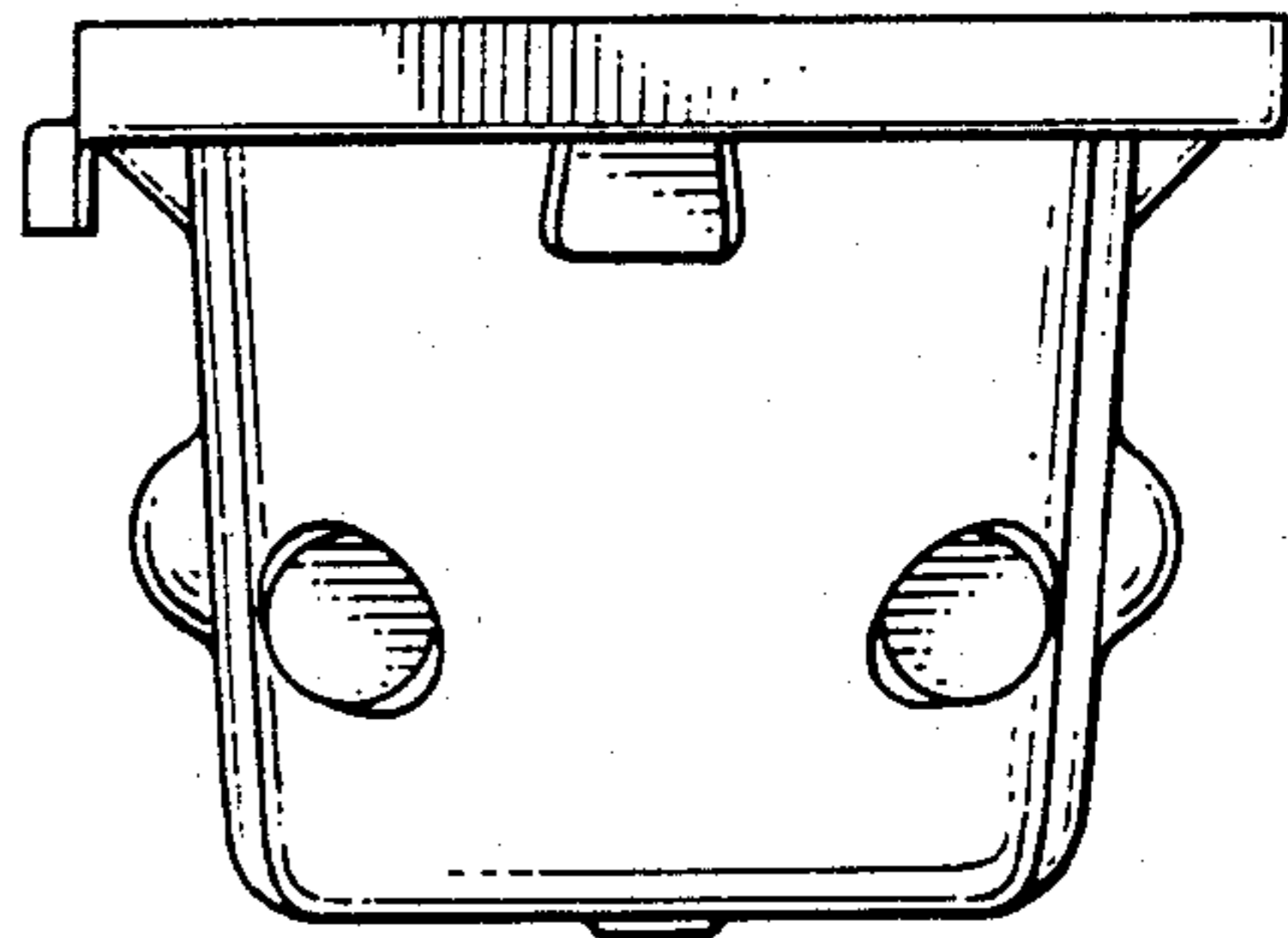

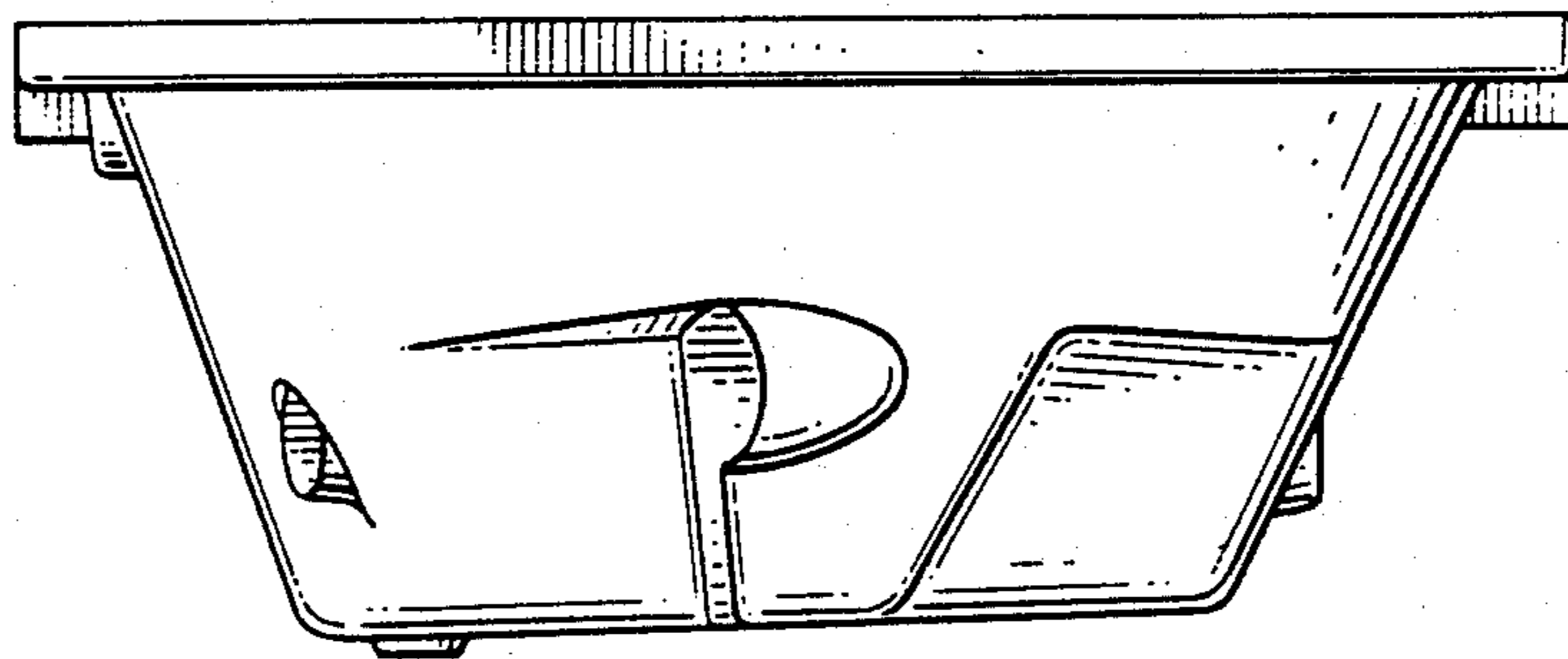

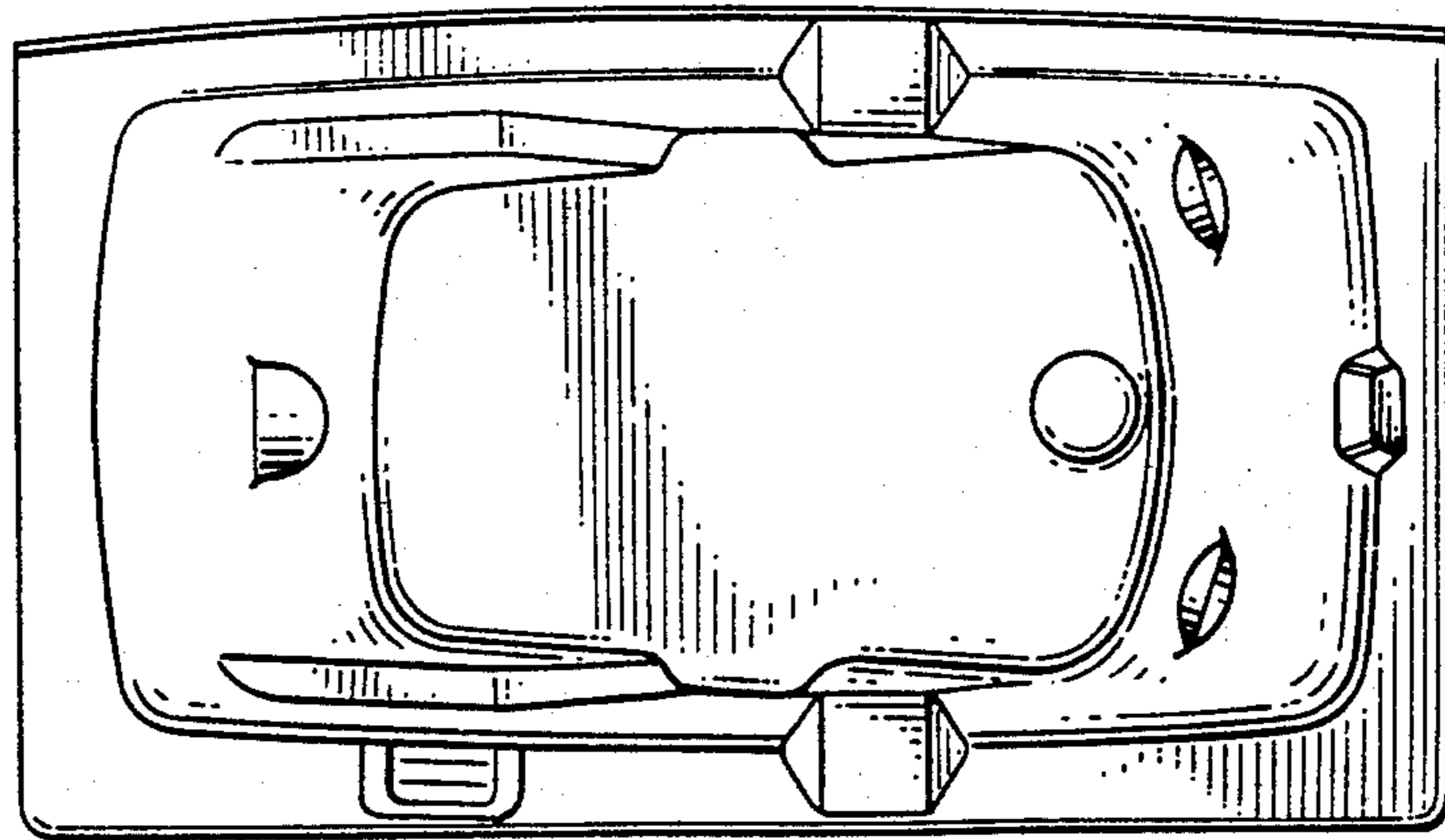

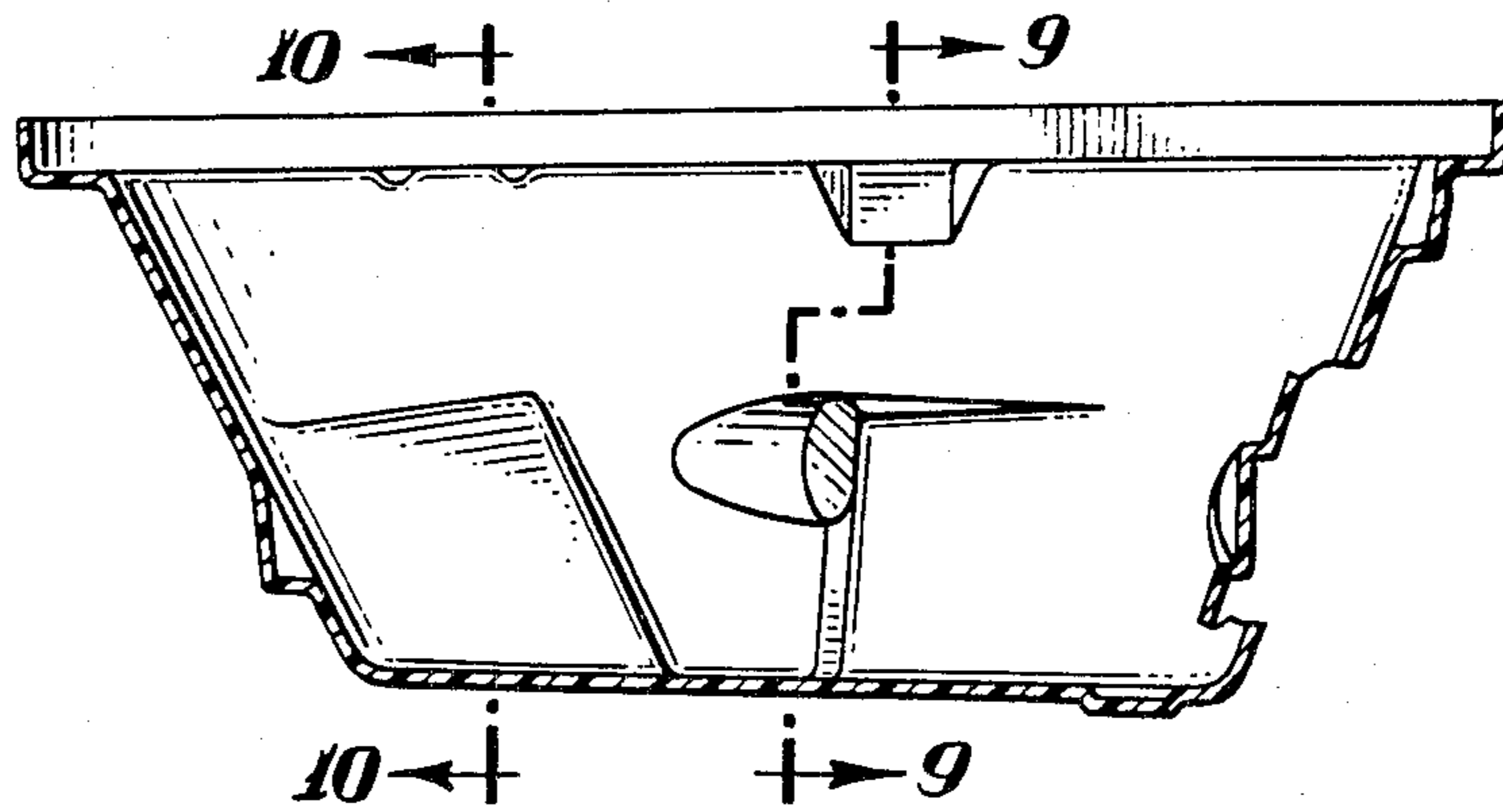

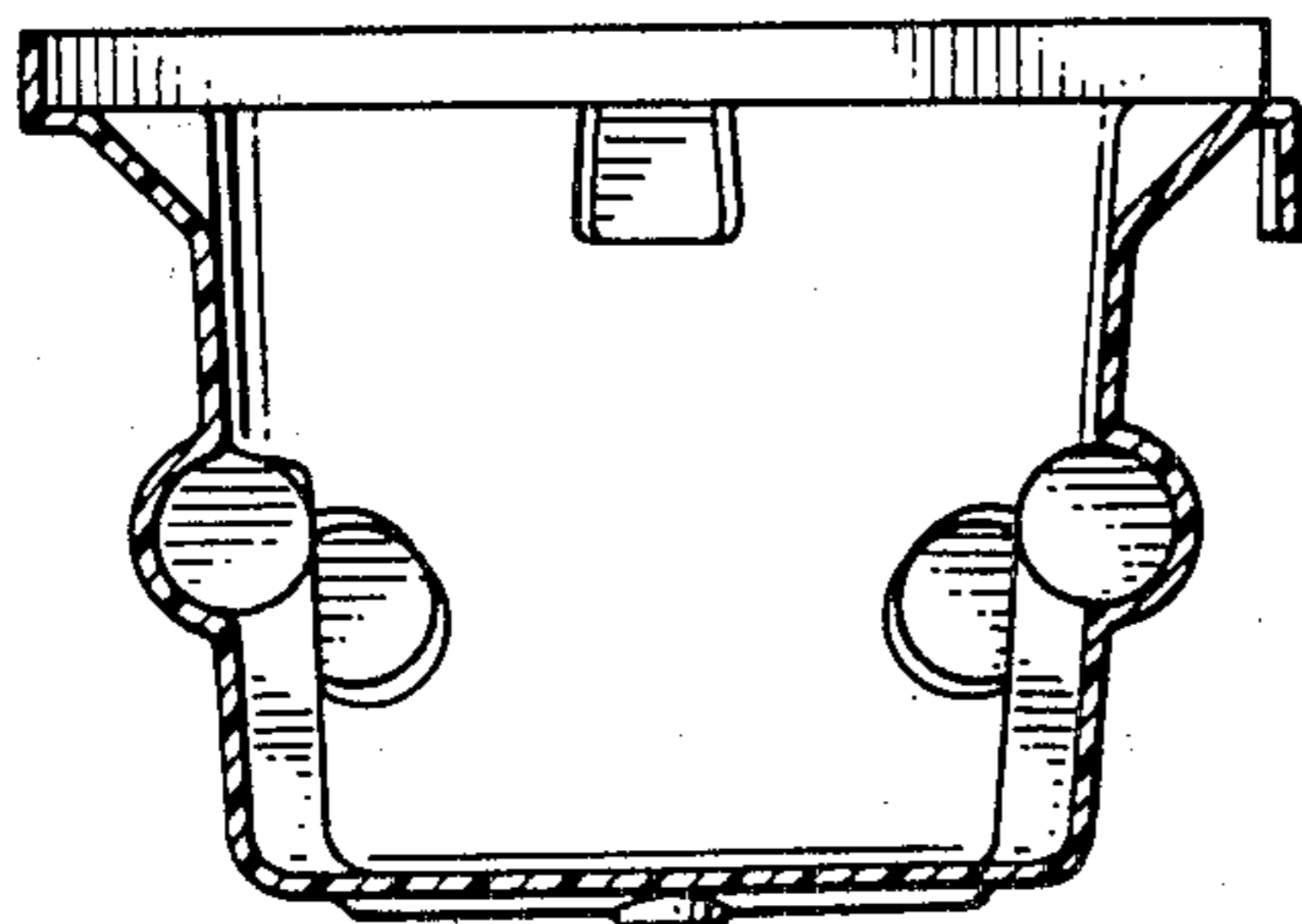

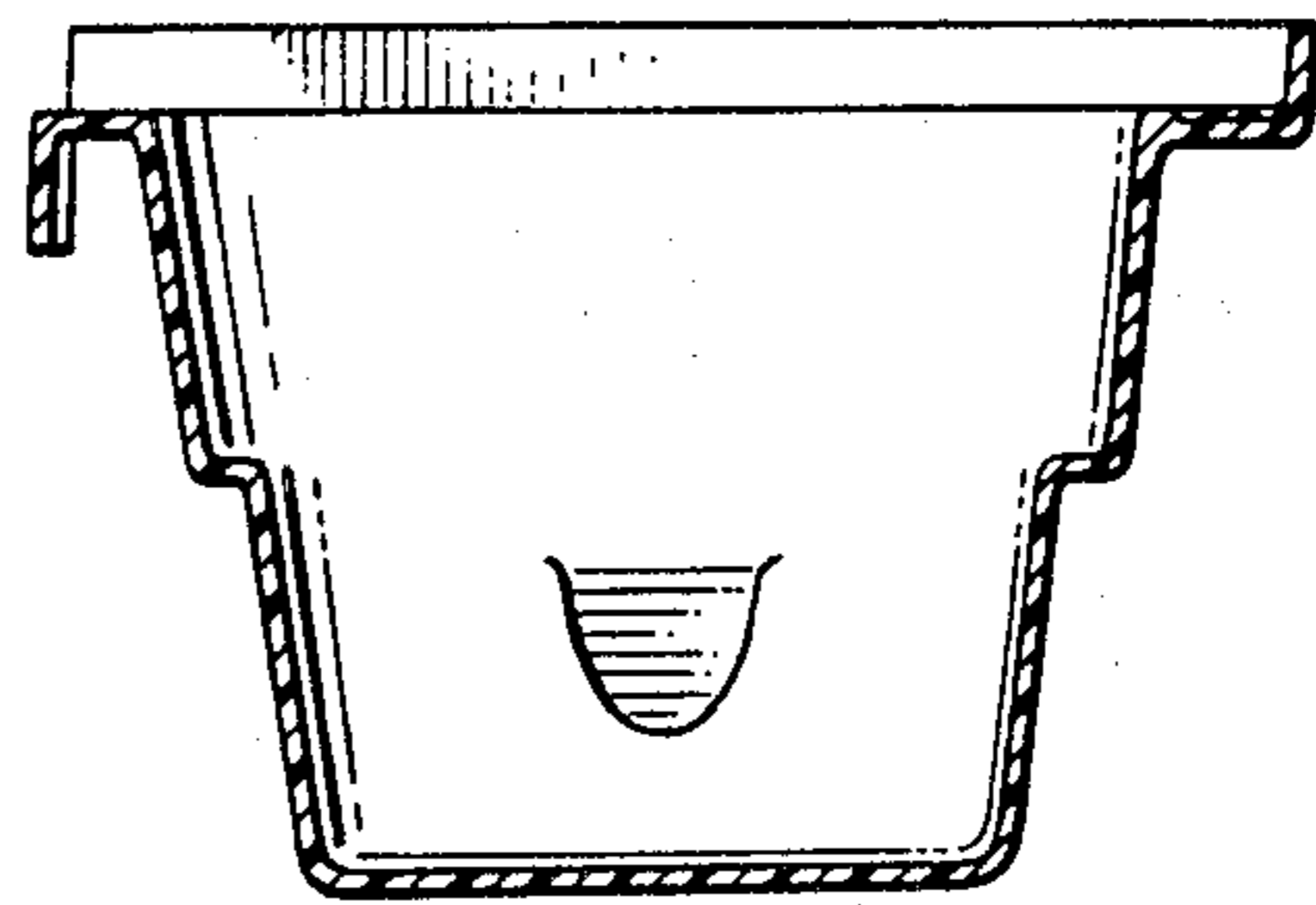
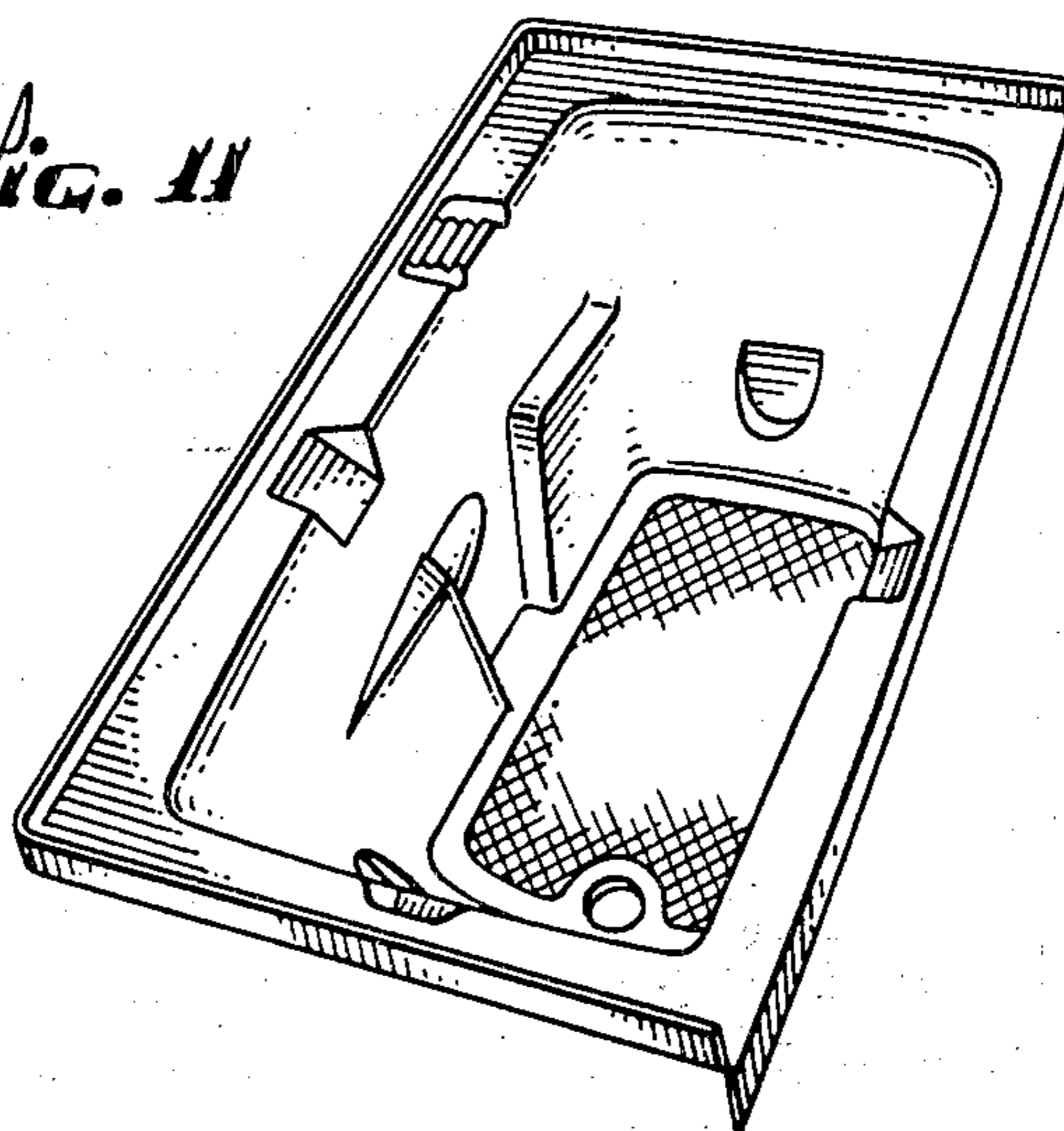

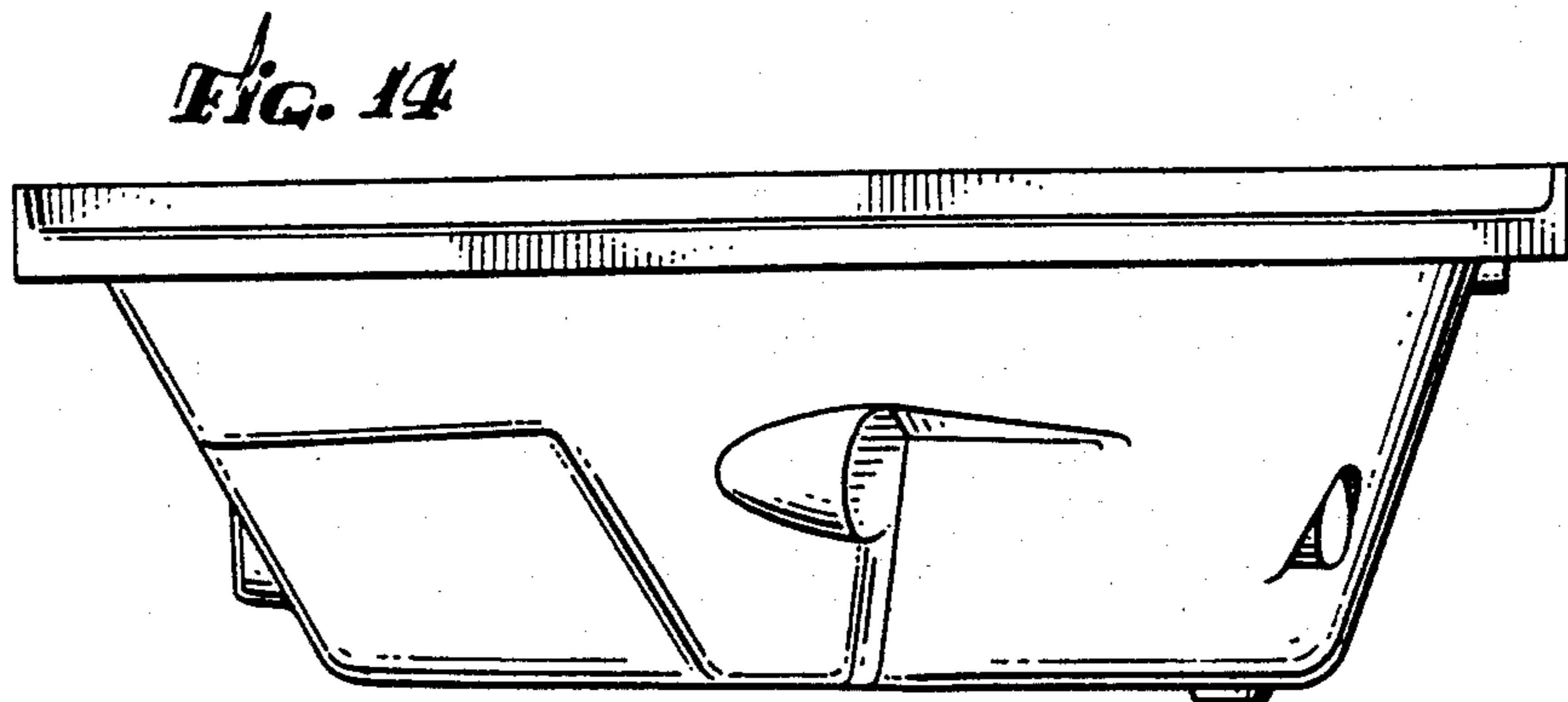
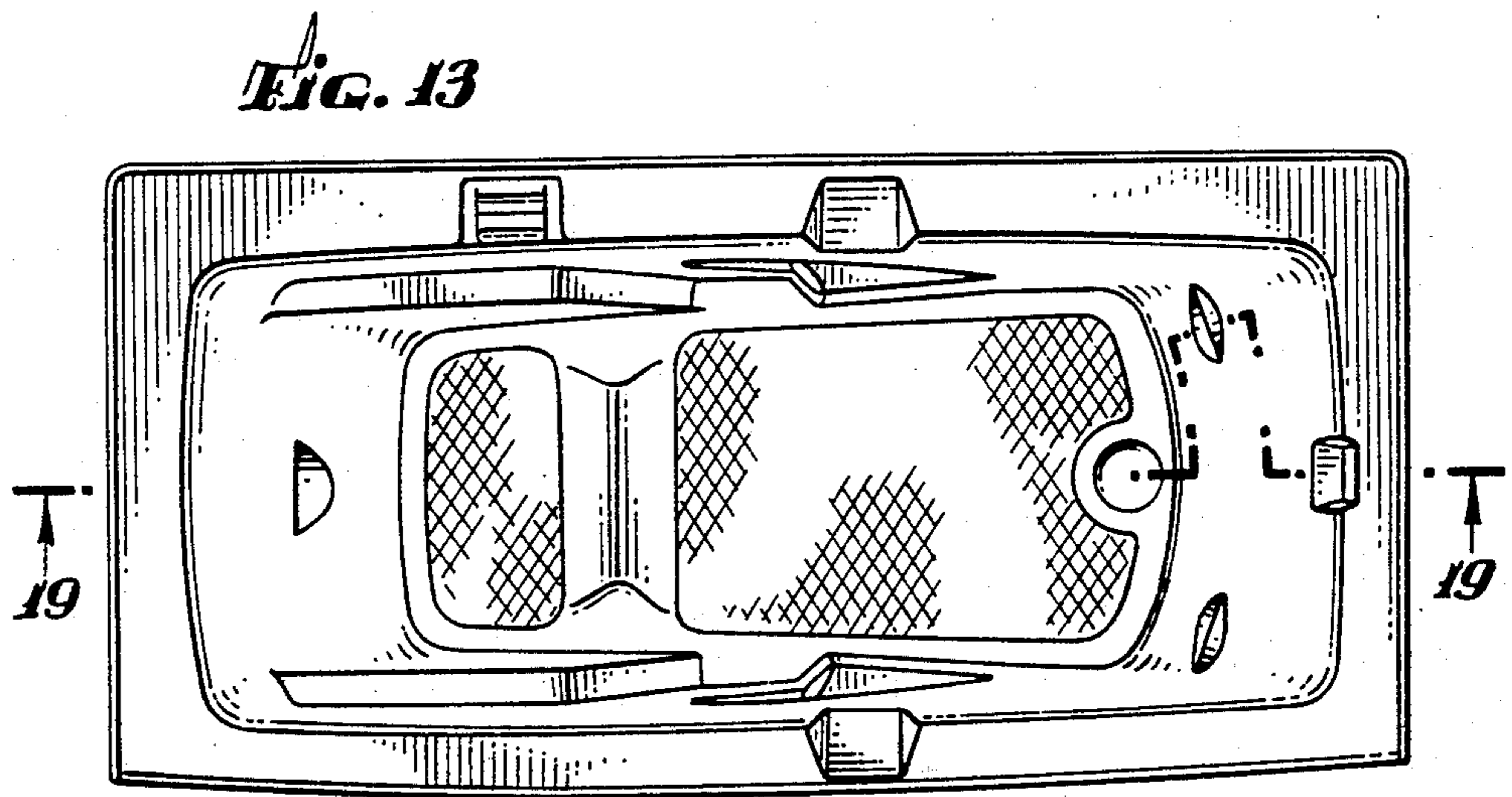
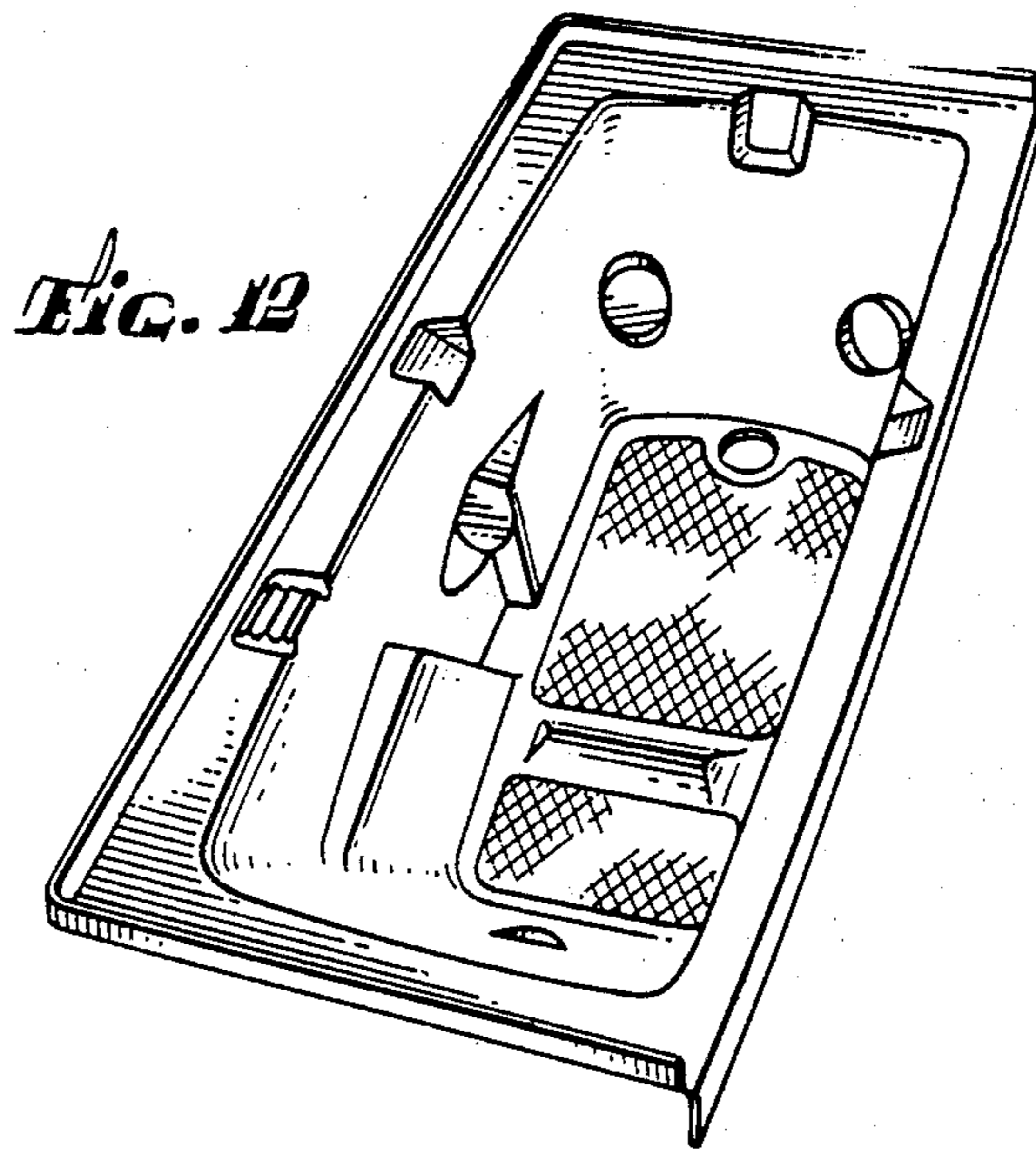

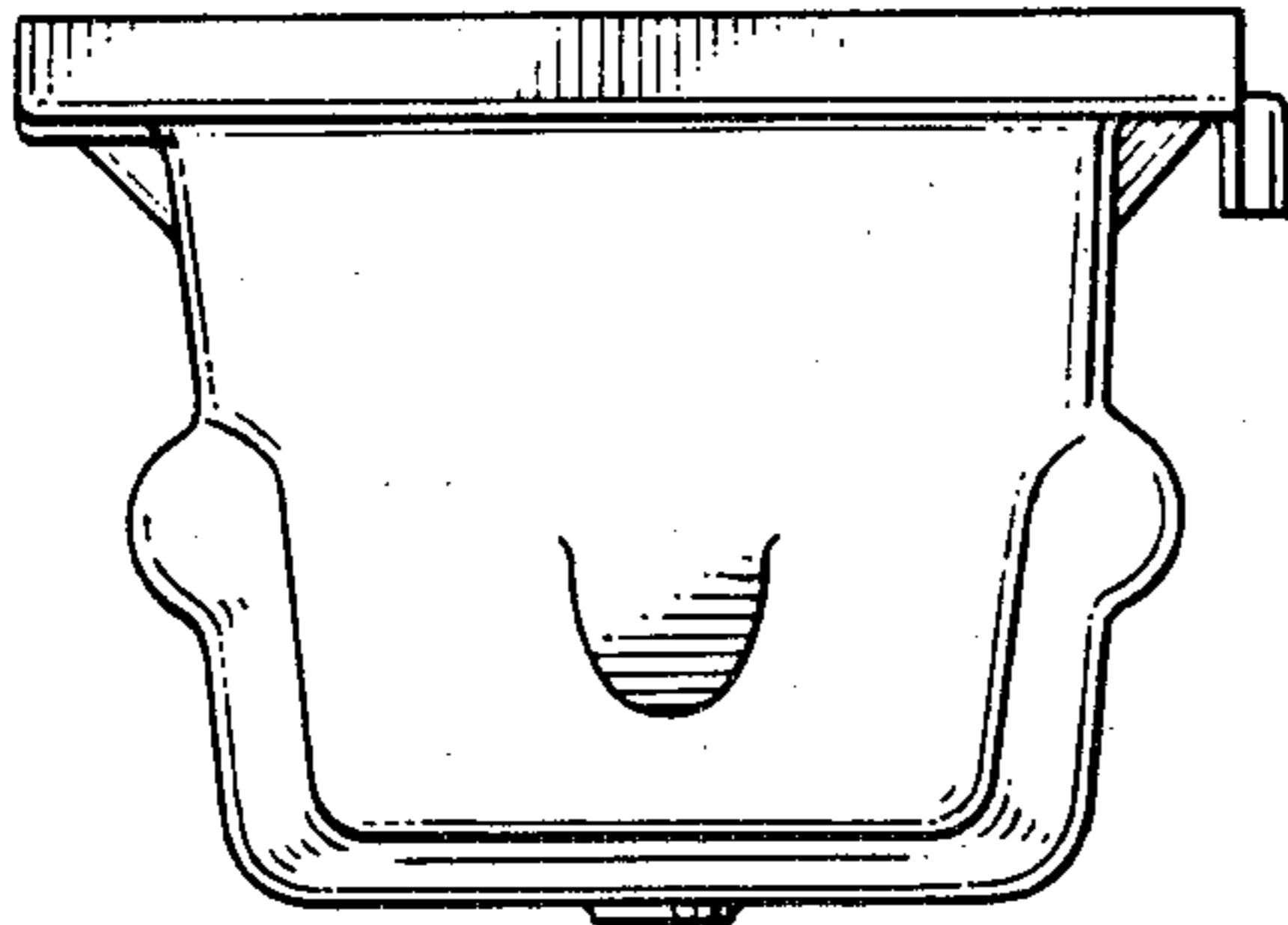

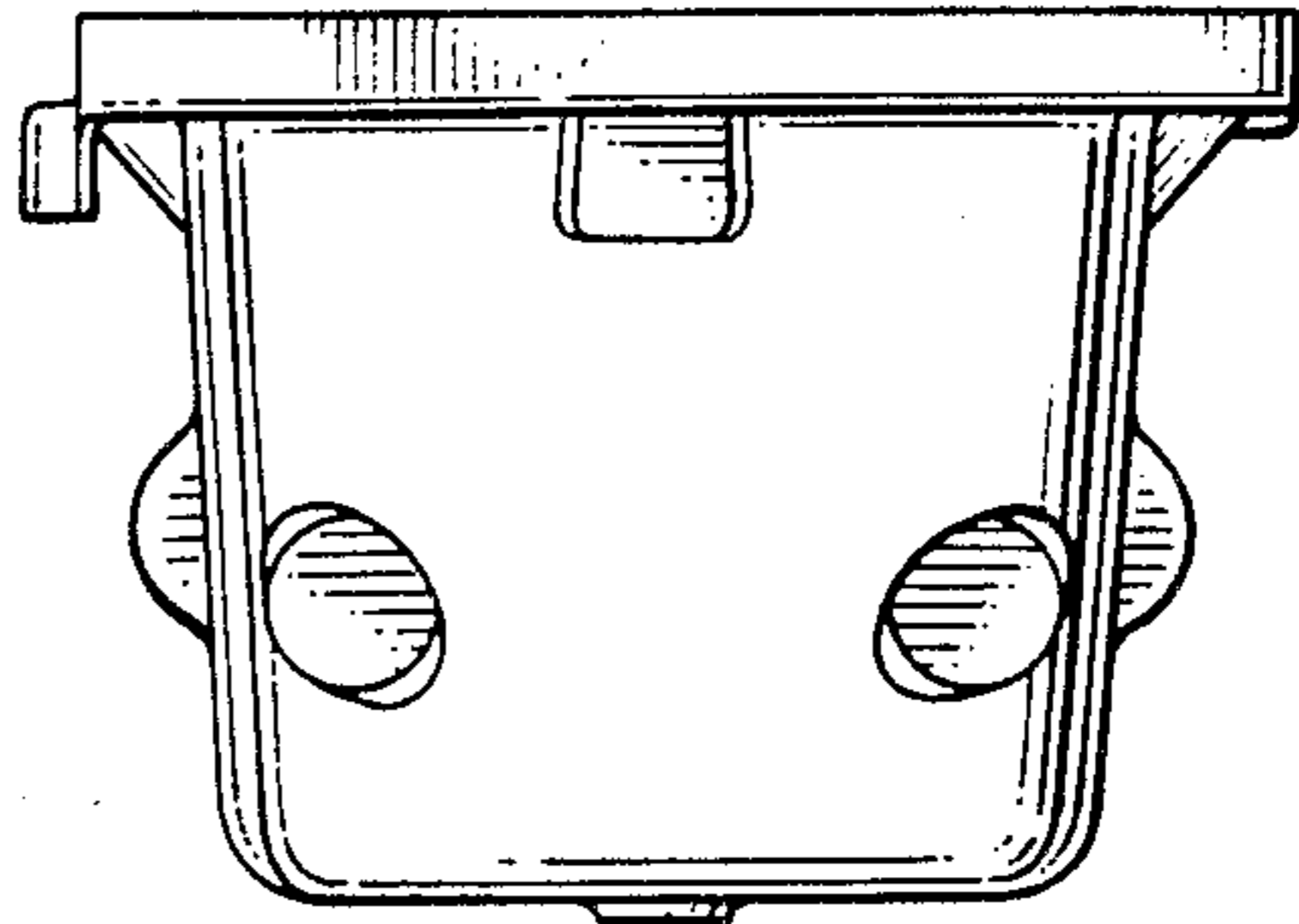

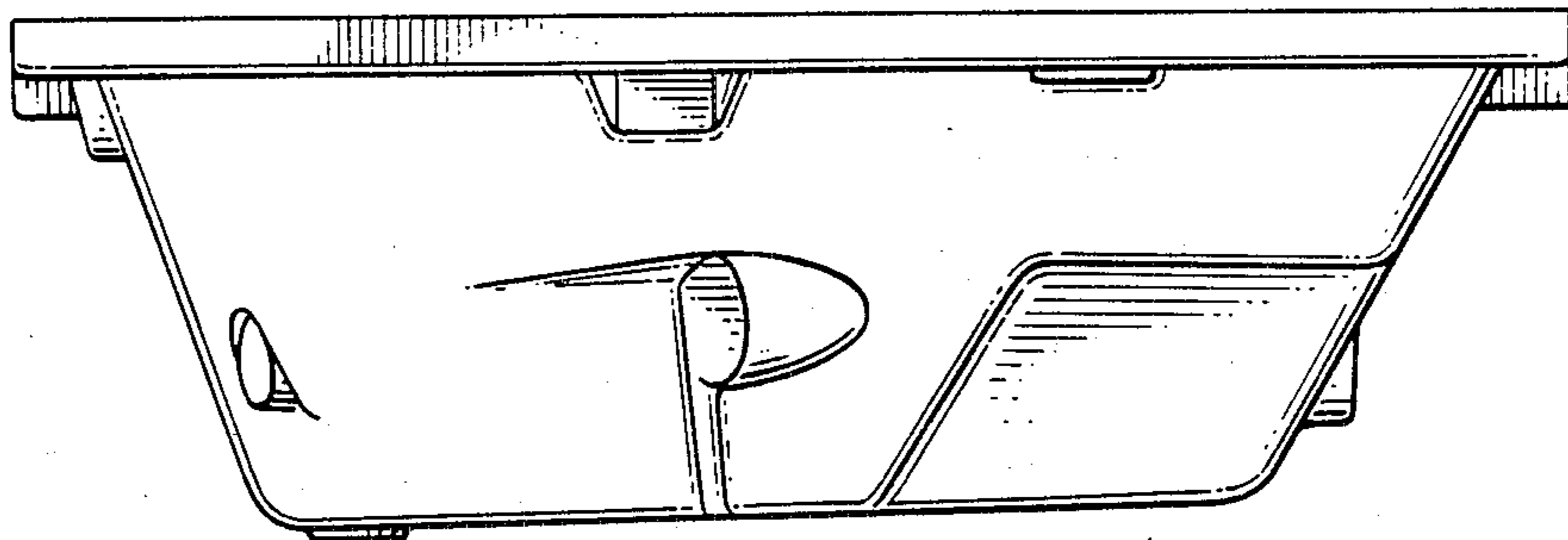
