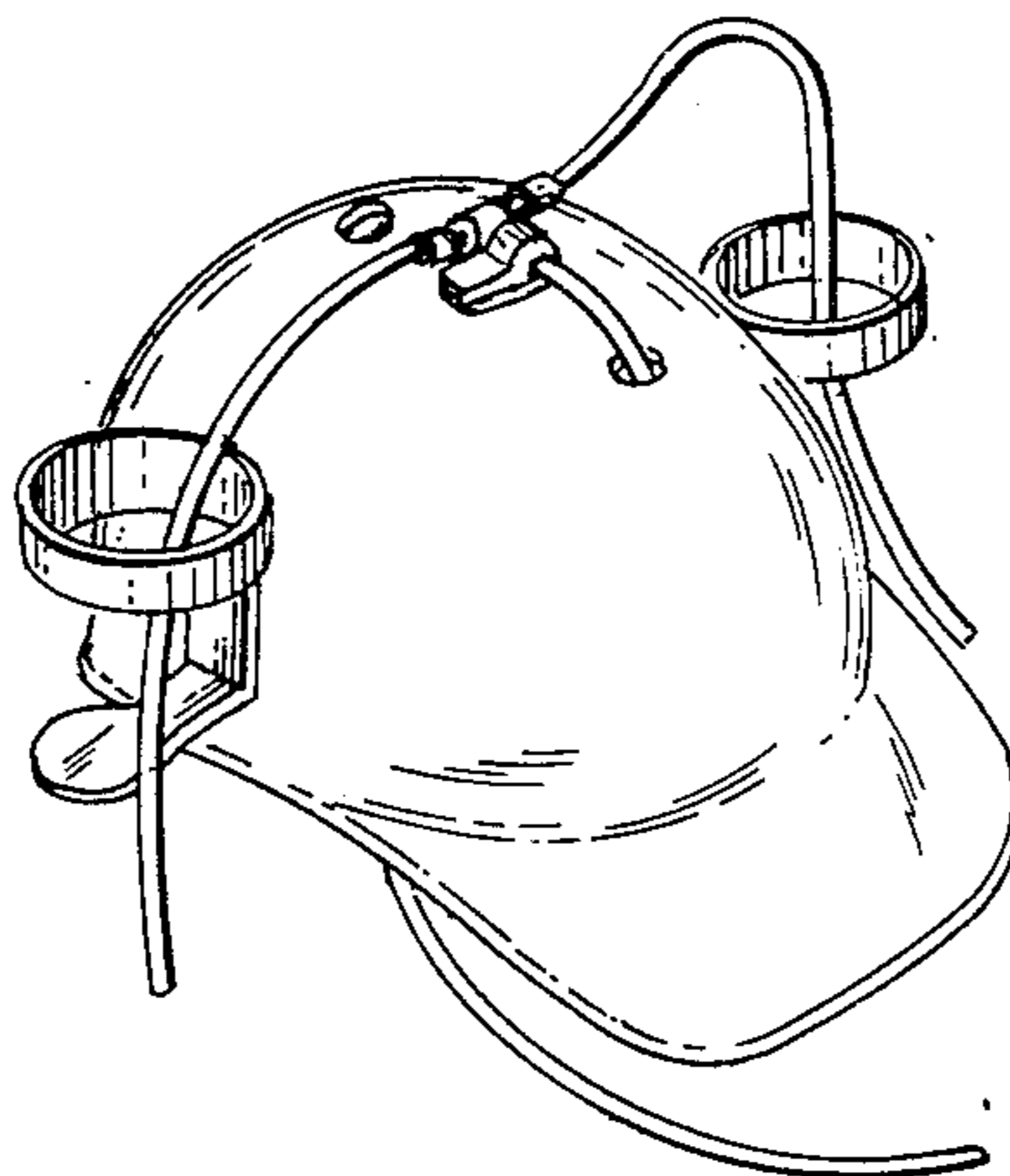

[57] CLAIM

The ornamental design for a combined helmet and beverage container supports, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a combined helmet and beverage container supports showing my new design; FIG. 2 is an enlarged top plan view thereof; FIG. 3 is a front elevational view thereof; and FIG. 4 is a left side elevational view as seen when worn; the right side being a mirror image thereof.



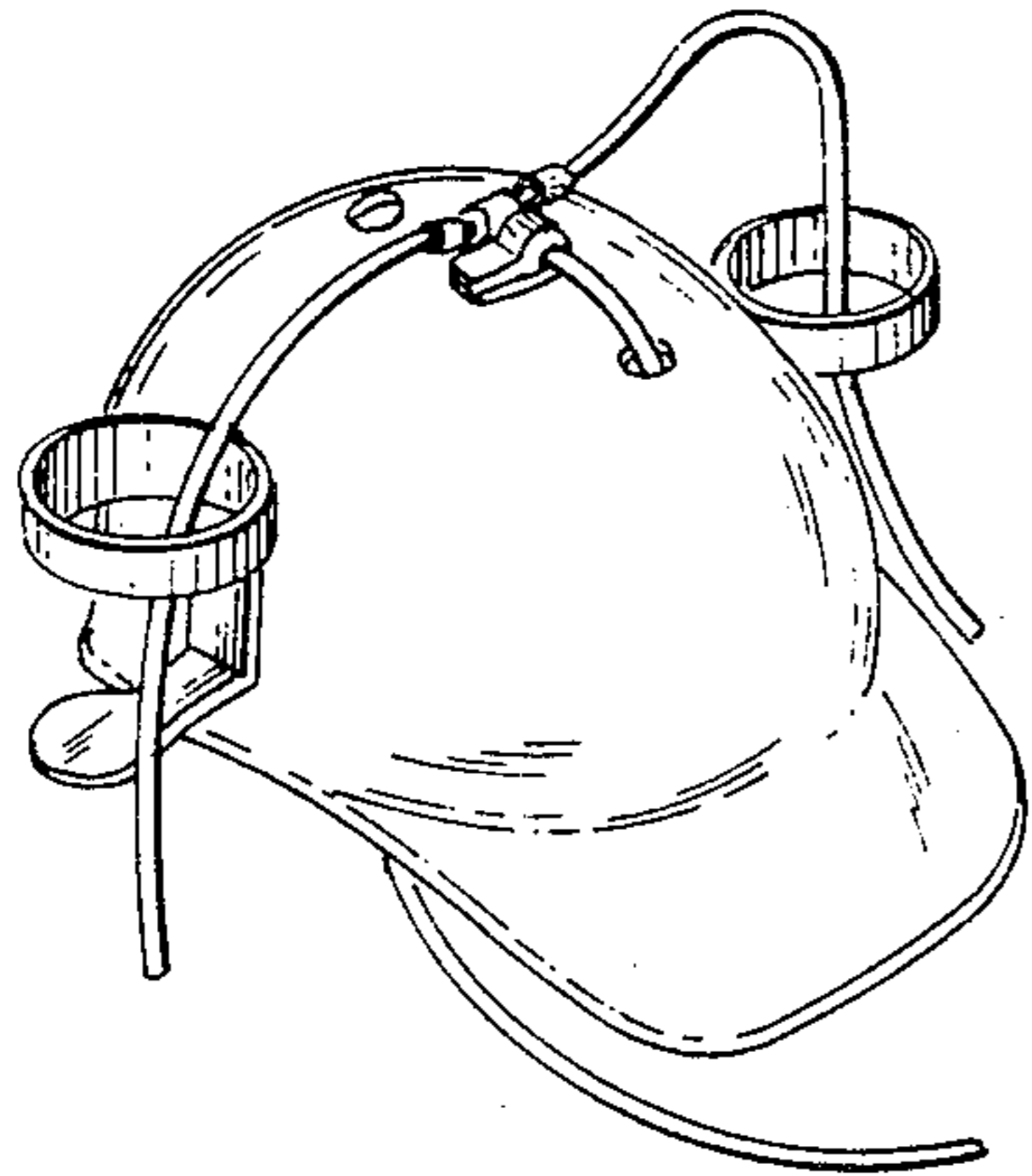

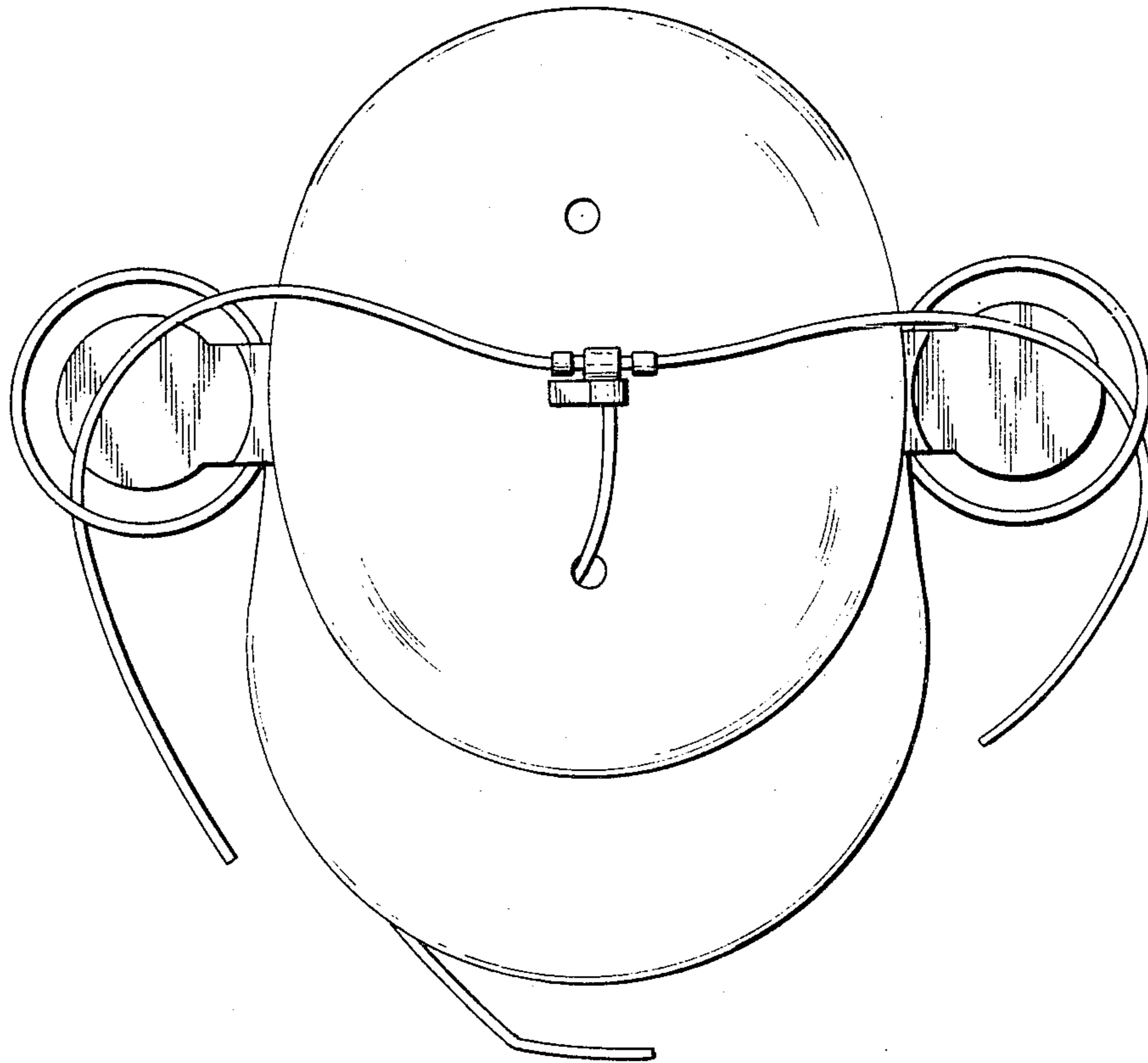

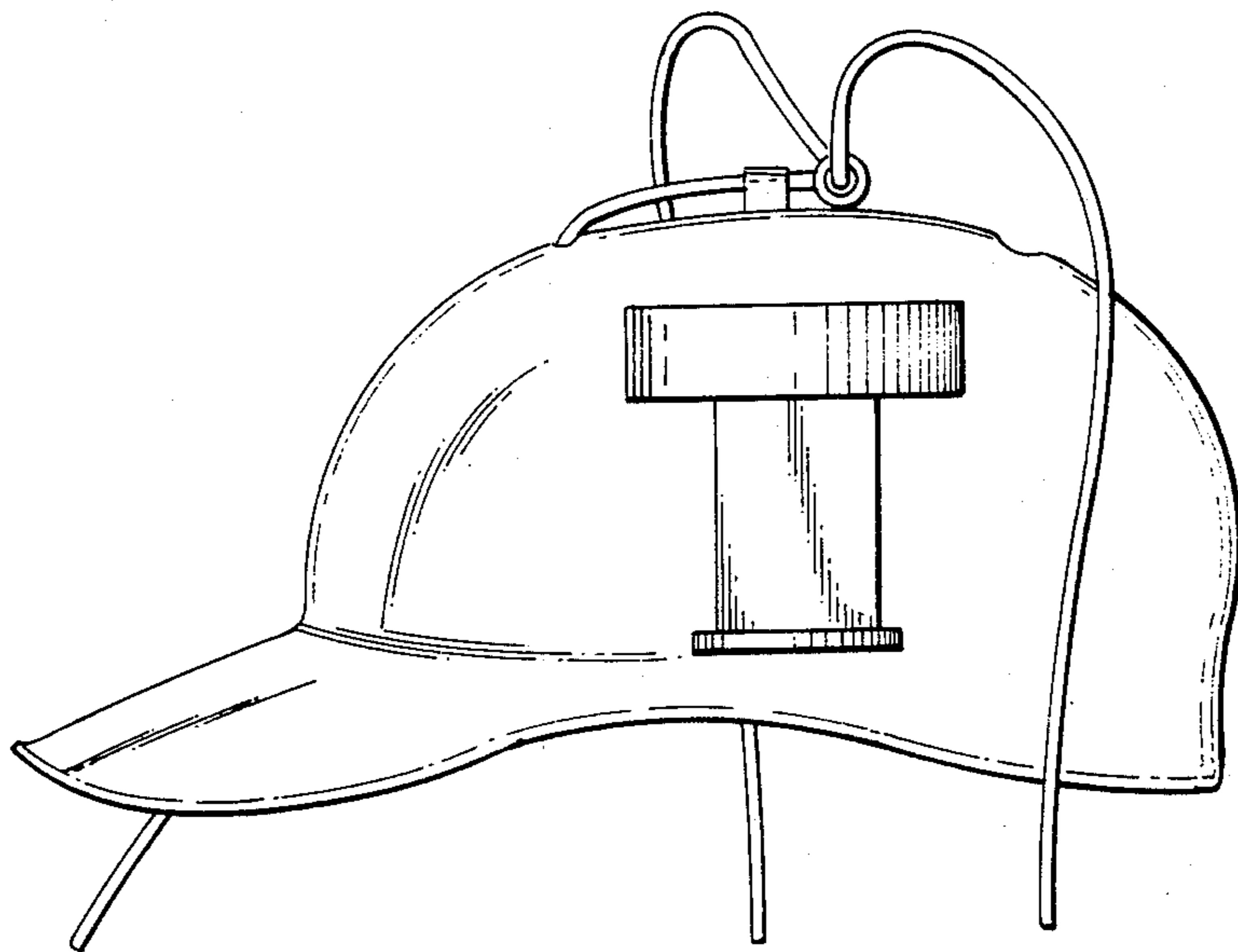
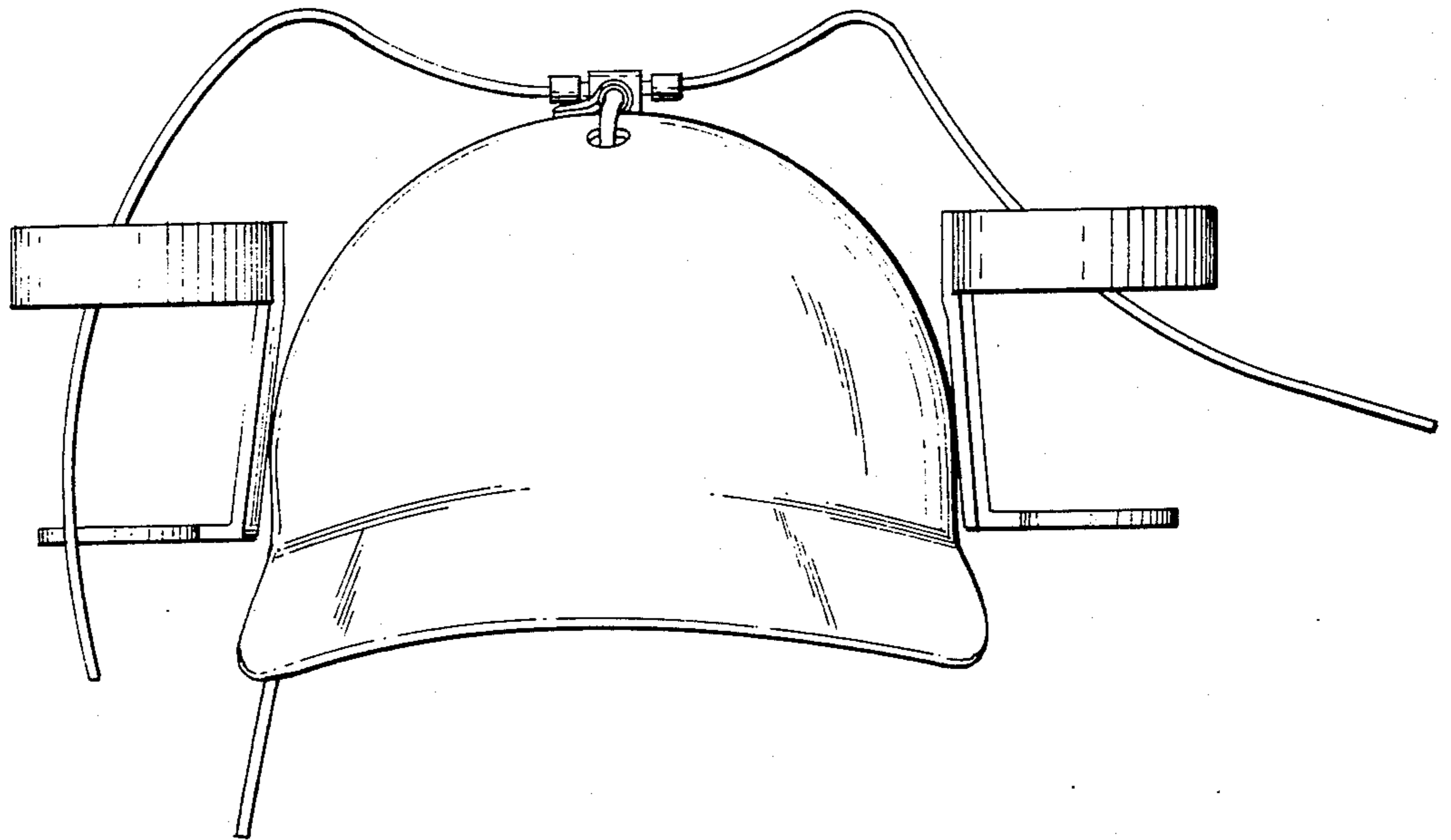
