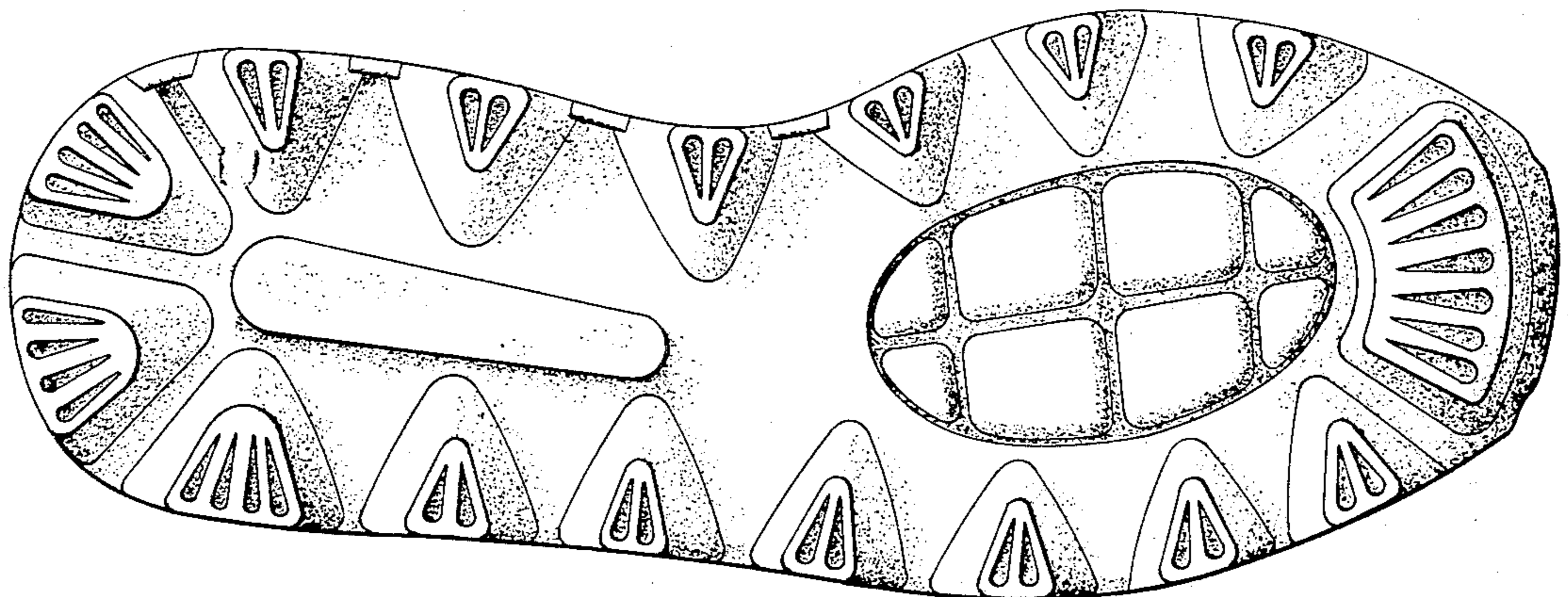

The ornamental design for a shoe sole, as shown and described.

DESCRIPTION

FIG. 1 is a left side elevational view of a shoe sole showing my new design;  
 FIG. 2 is a bottom plan view thereof;  
 FIG. 3 is a top plan view thereof;  
 FIG. 4 is a right side elevational view thereof;  
 FIG. 5 is a rear elevational view thereof;  
 FIG. 6 is a front elevational view thereof.  
 The broken line showing of a sports shoe is environmental only and form no part of the claimed design.



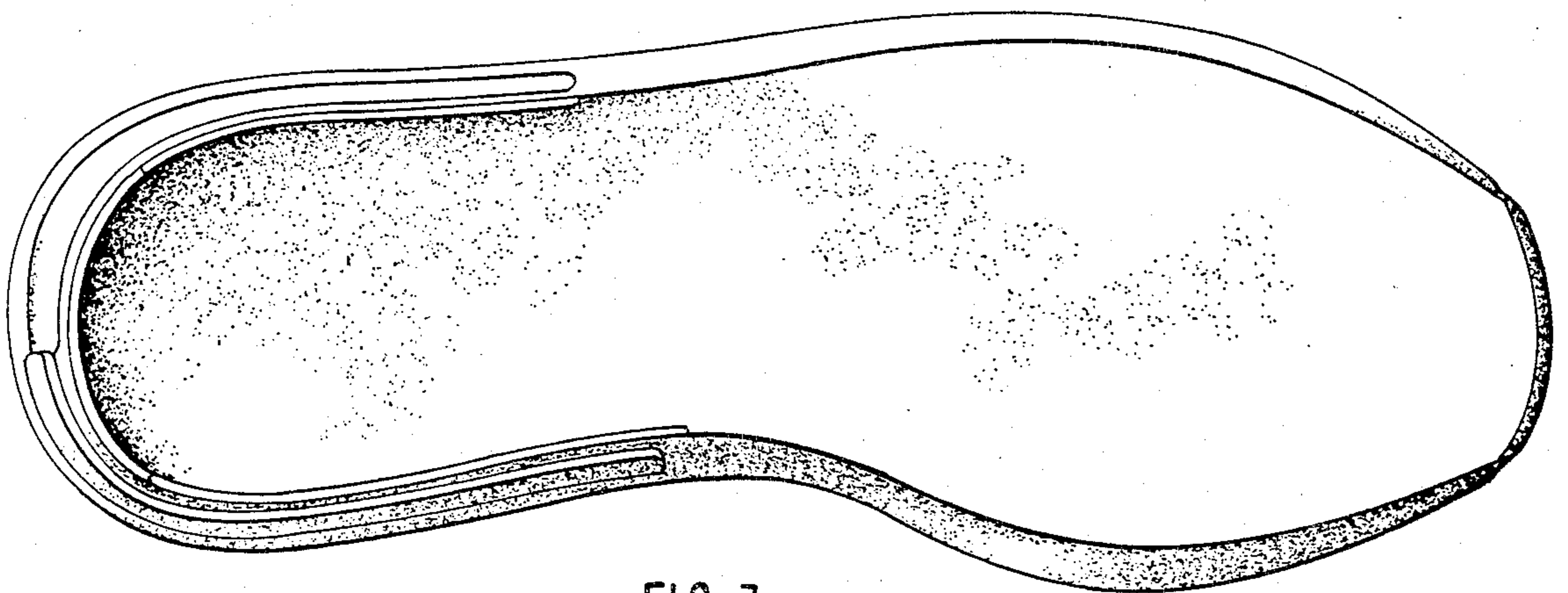
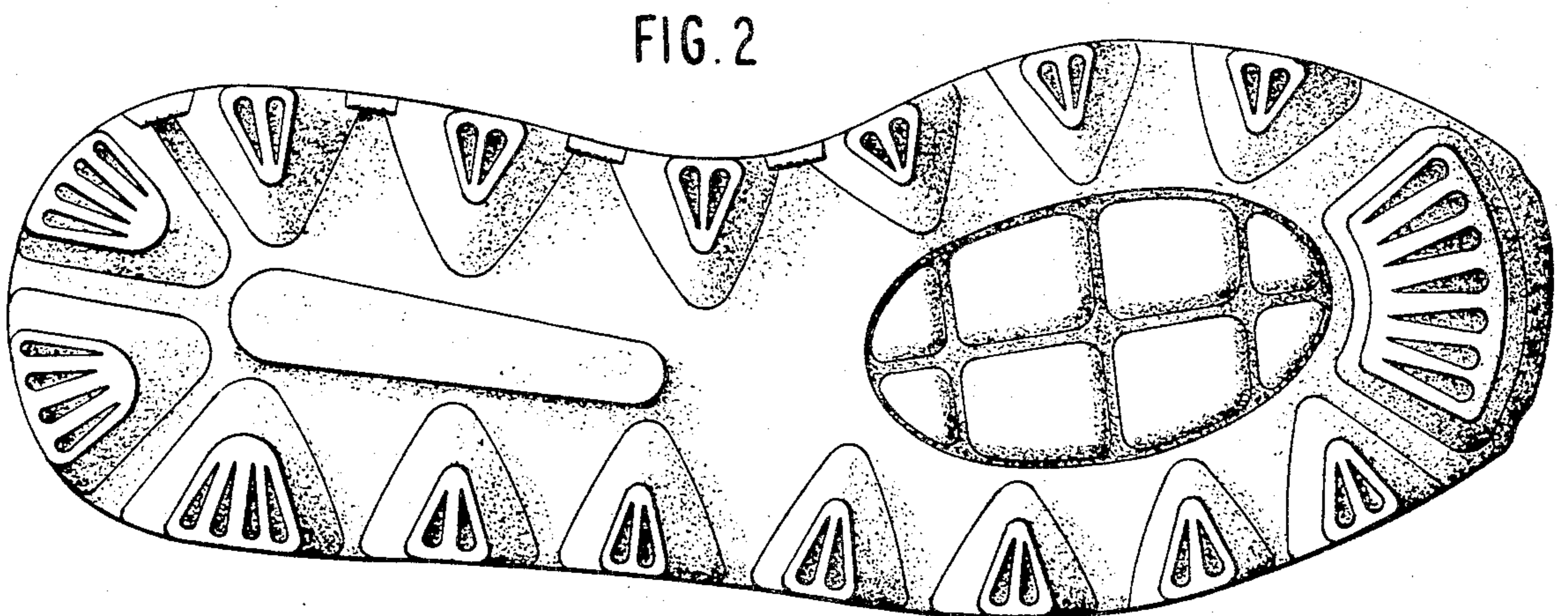
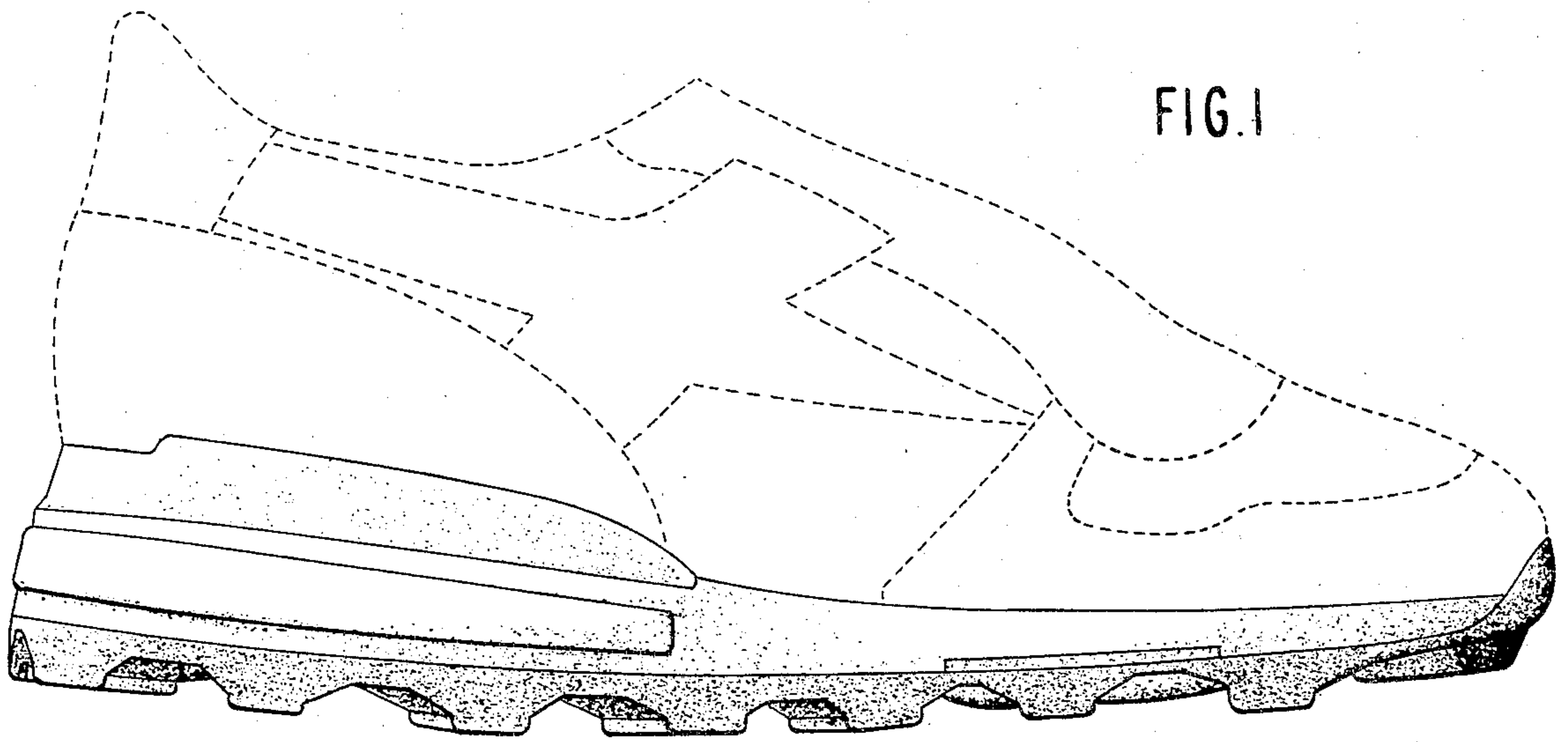

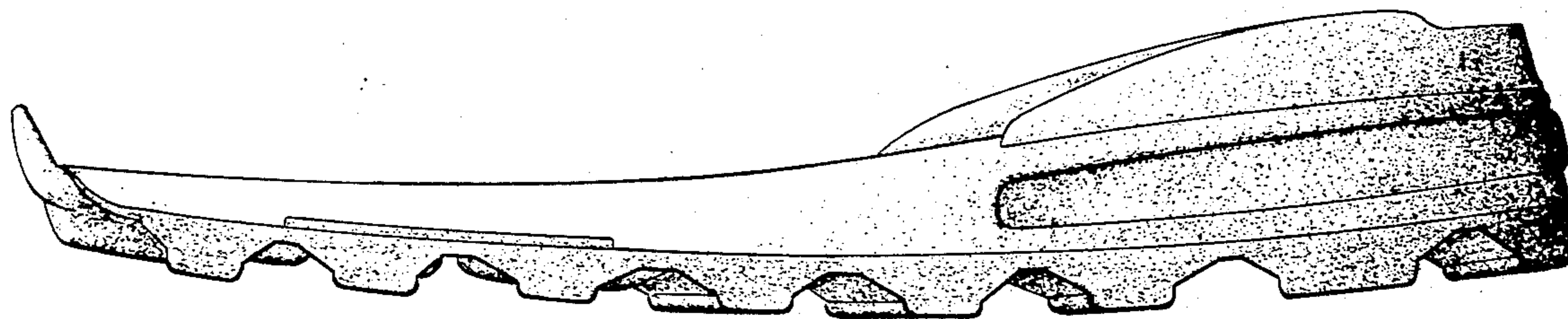

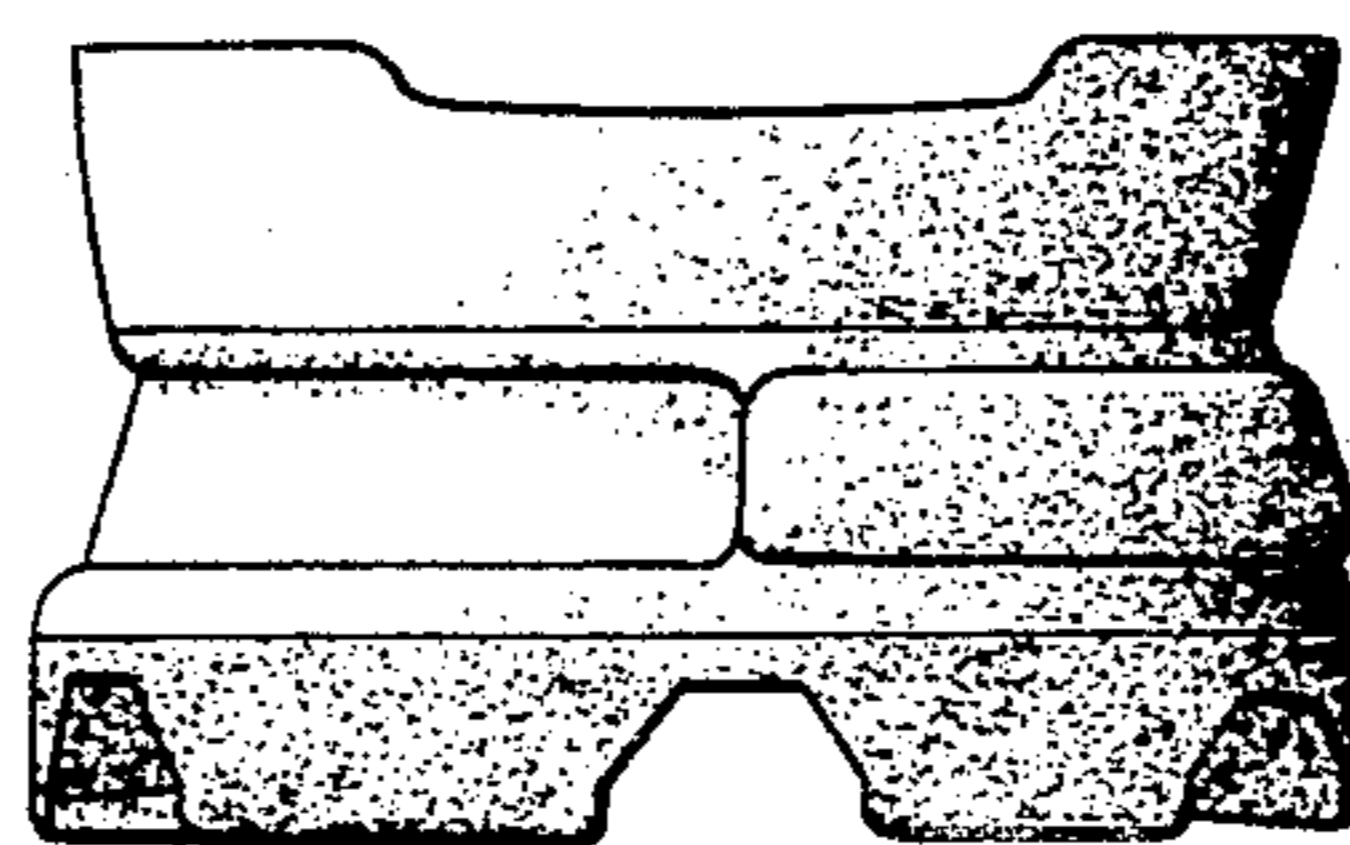
