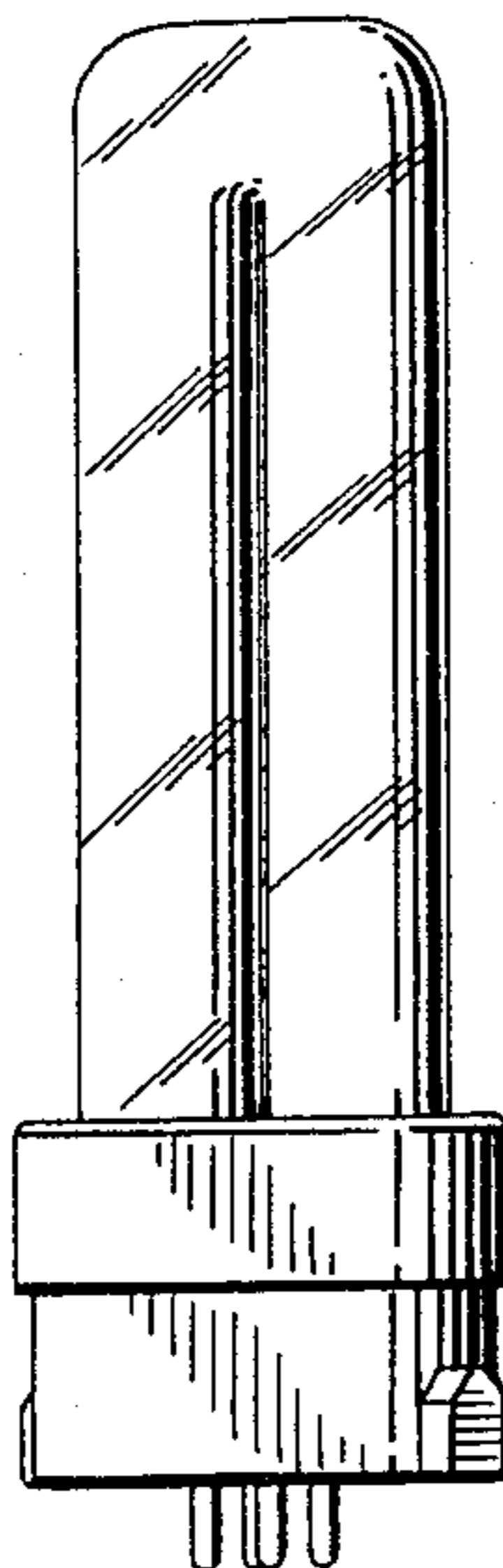

[57] CLAIM

The ornamental design for a fluorescent lamp, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a fluorescent lamp, showing our new design;  
 FIG. 2 is a bottom plan view thereof;  
 FIG. 3 is a top plan view thereof;  
 FIG. 4 is a left side elevational view thereof;  
 FIG. 5 is a right side elevational view thereof;  
 FIG. 6 is an enlarged cross-sectional view thereof taken along line 6—6 of FIG. 3;  
 FIG. 7 is a front elevational view of a second embodiment;  
 FIG. 8 is a left side elevational view thereof;  
 FIG. 9 is a right side elevational view thereof;  
 FIG. 10 is a bottom plan view thereof;  
 FIG. 11 is a top plan view thereof;  
 FIG. 12 is an enlarged cross-sectional view taken along line 12—12 of FIG. 11 thereof;  
 FIG. 13 is a front elevational view of a third embodiment;  
 FIG. 14 is a left side elevational view thereof;  
 FIG. 15 is a right side elevational view thereof;  
 FIG. 16 is a bottom plan view thereof;  
 FIG. 17 is a top plan view thereof;  
 FIG. 18 is an enlarged cross-sectional view taken along line 18—18 of FIG. 17, the lamp being broken away for convenience of illustration;  
 FIG. 19 is a front elevational view of a third embodiment;  
 FIG. 20 is a left elevational view thereof;  
 FIG. 21 is a top plan view thereof;  
 FIG. 22 is a bottom plan view thereof; and  
 FIG. 23 is an enlarged cross-sectional view taken along line 23—23 of FIG. 21.



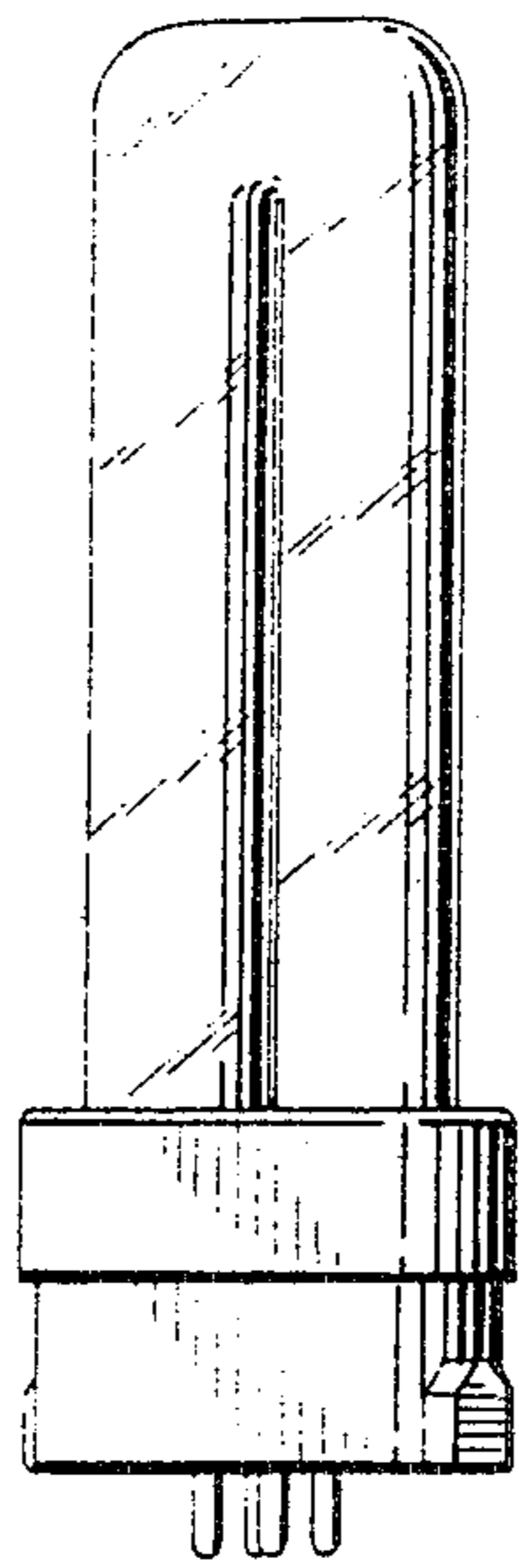

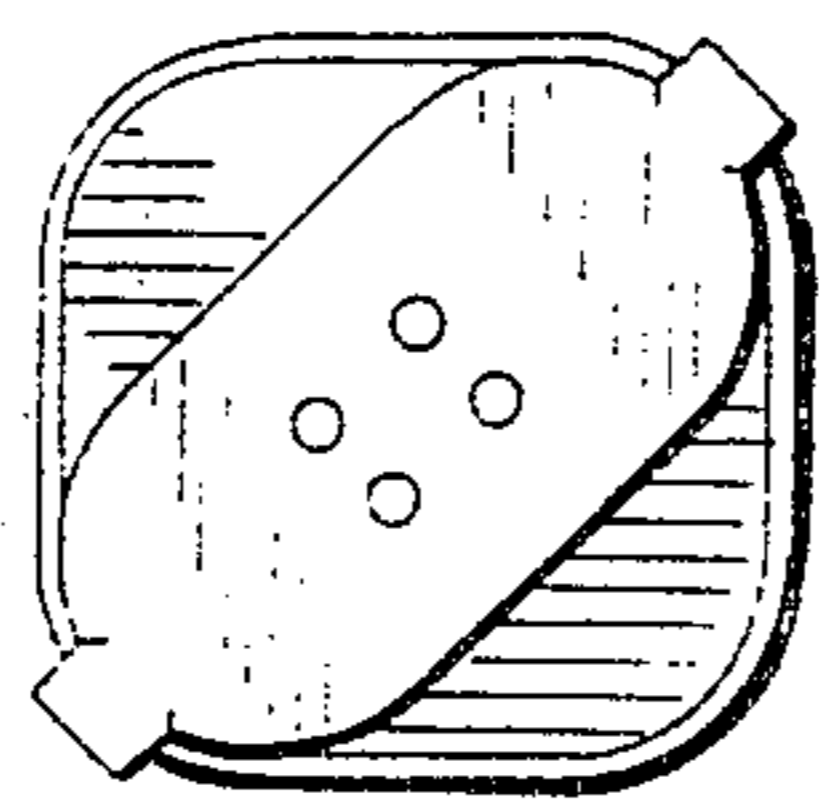

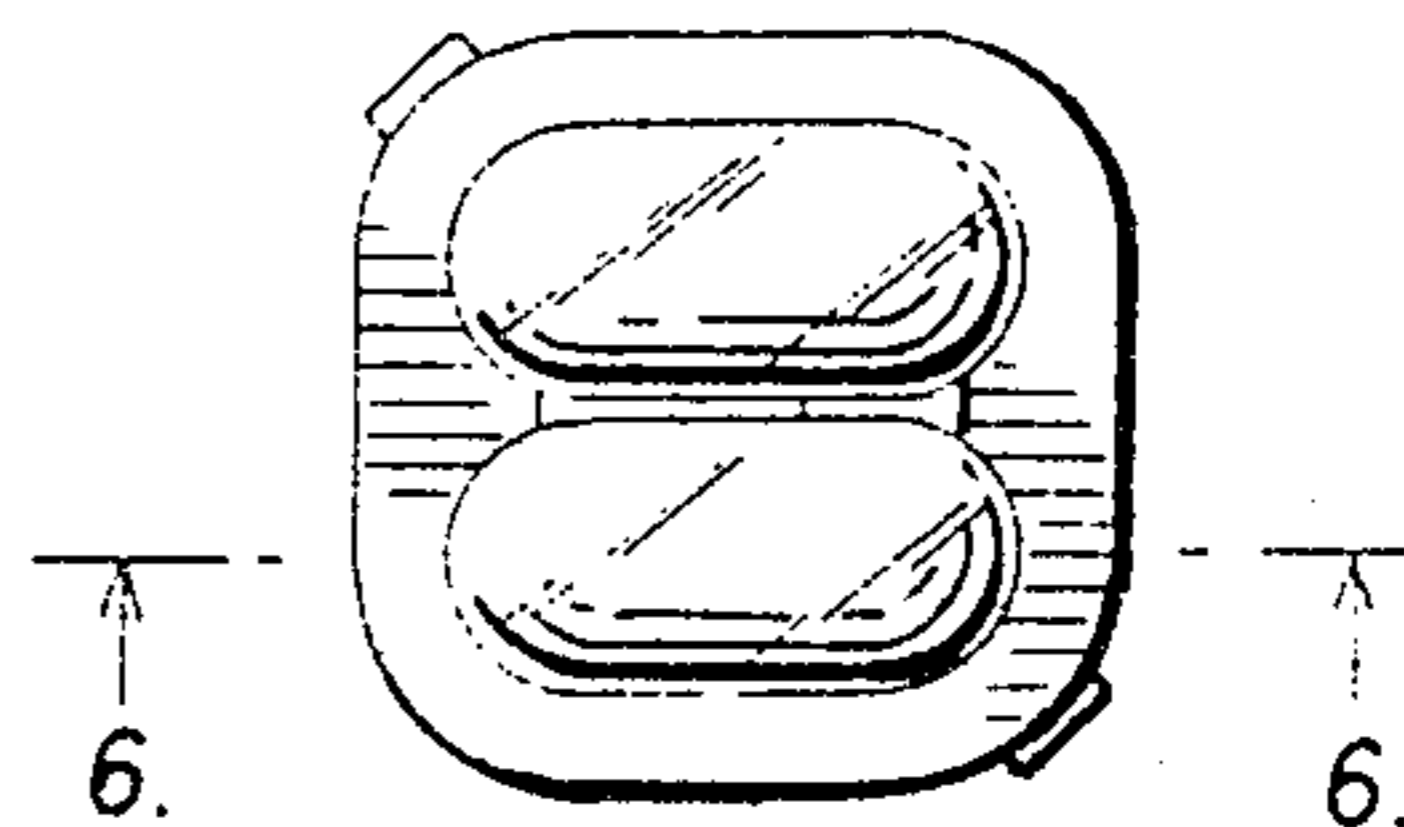
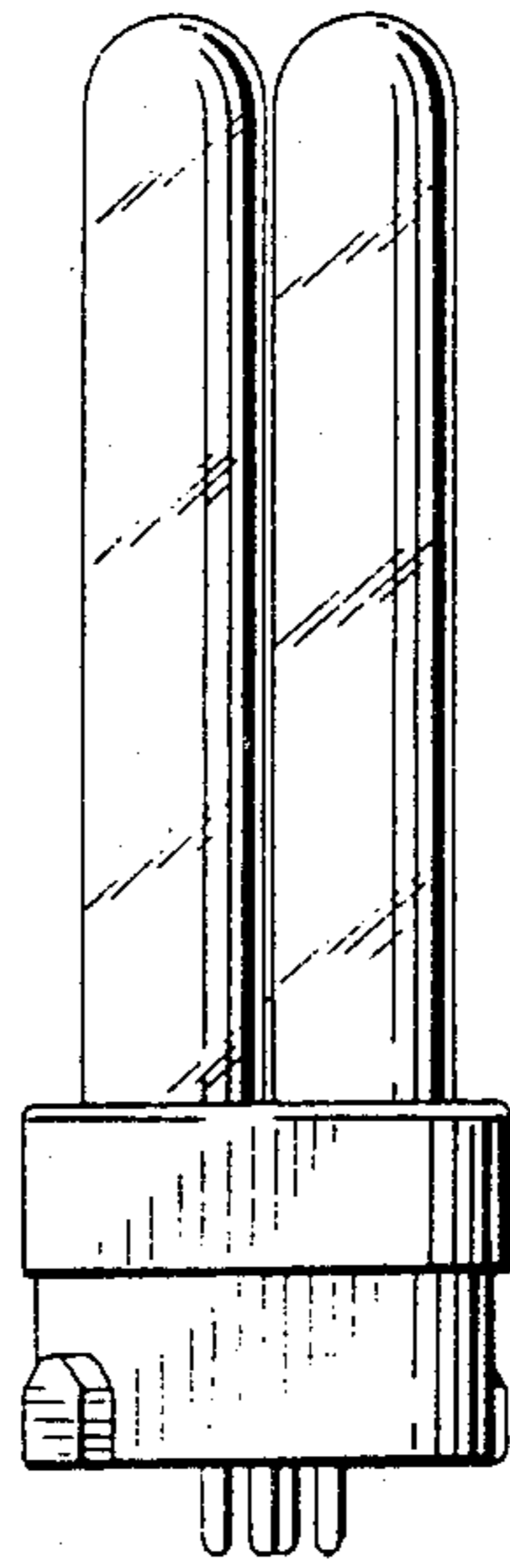
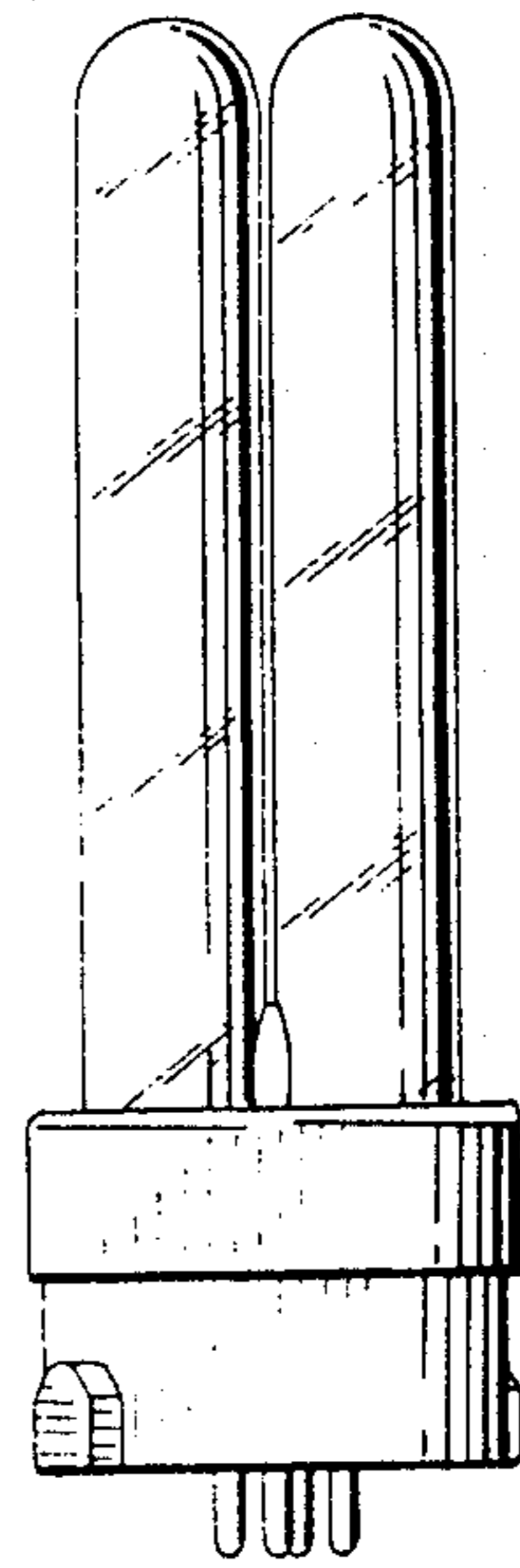

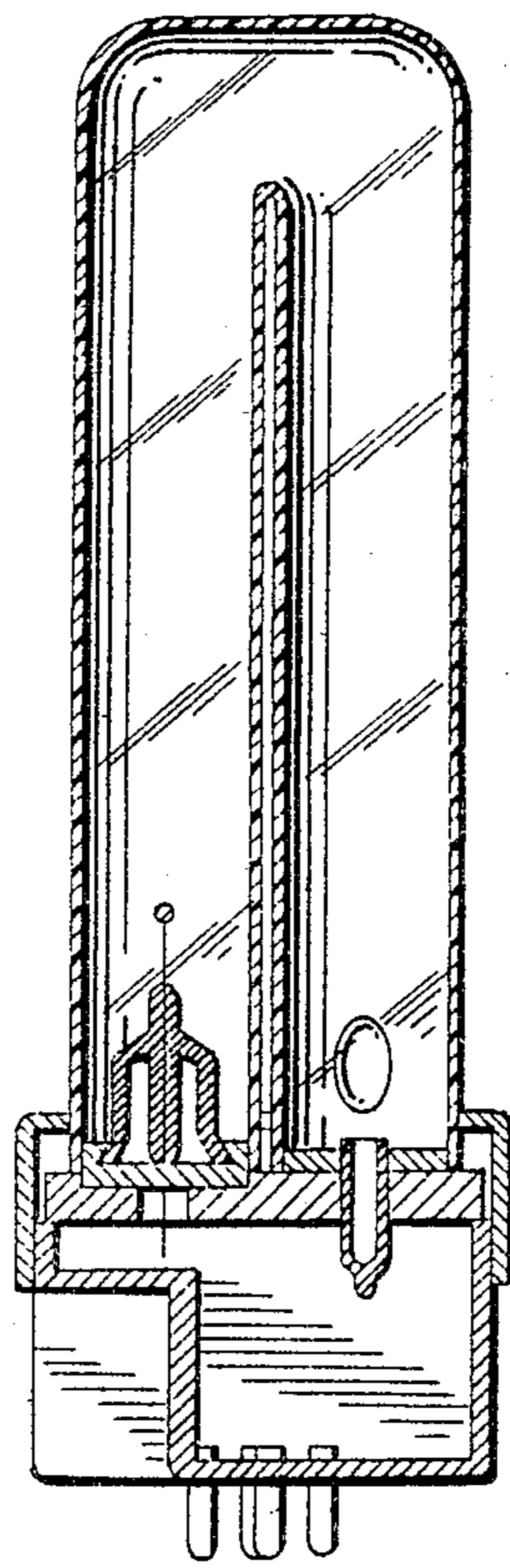
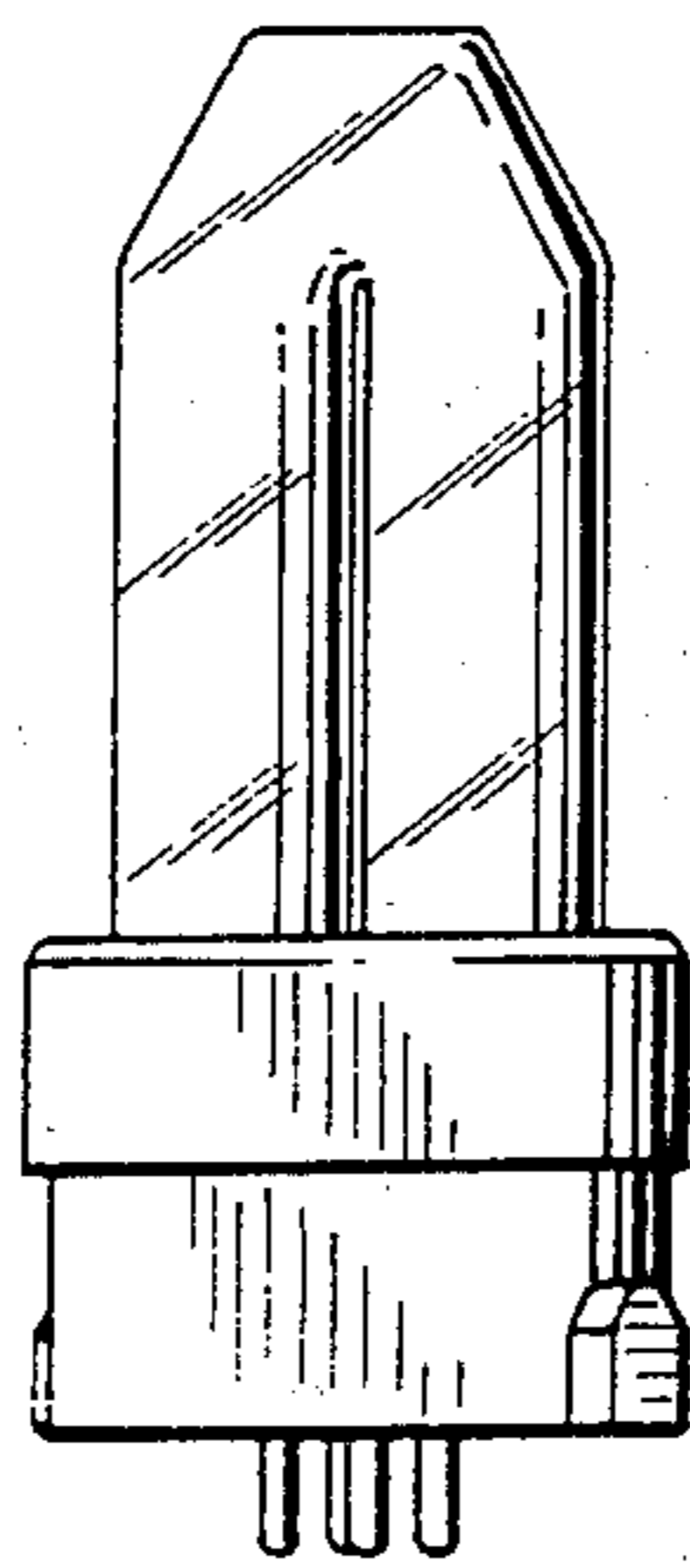
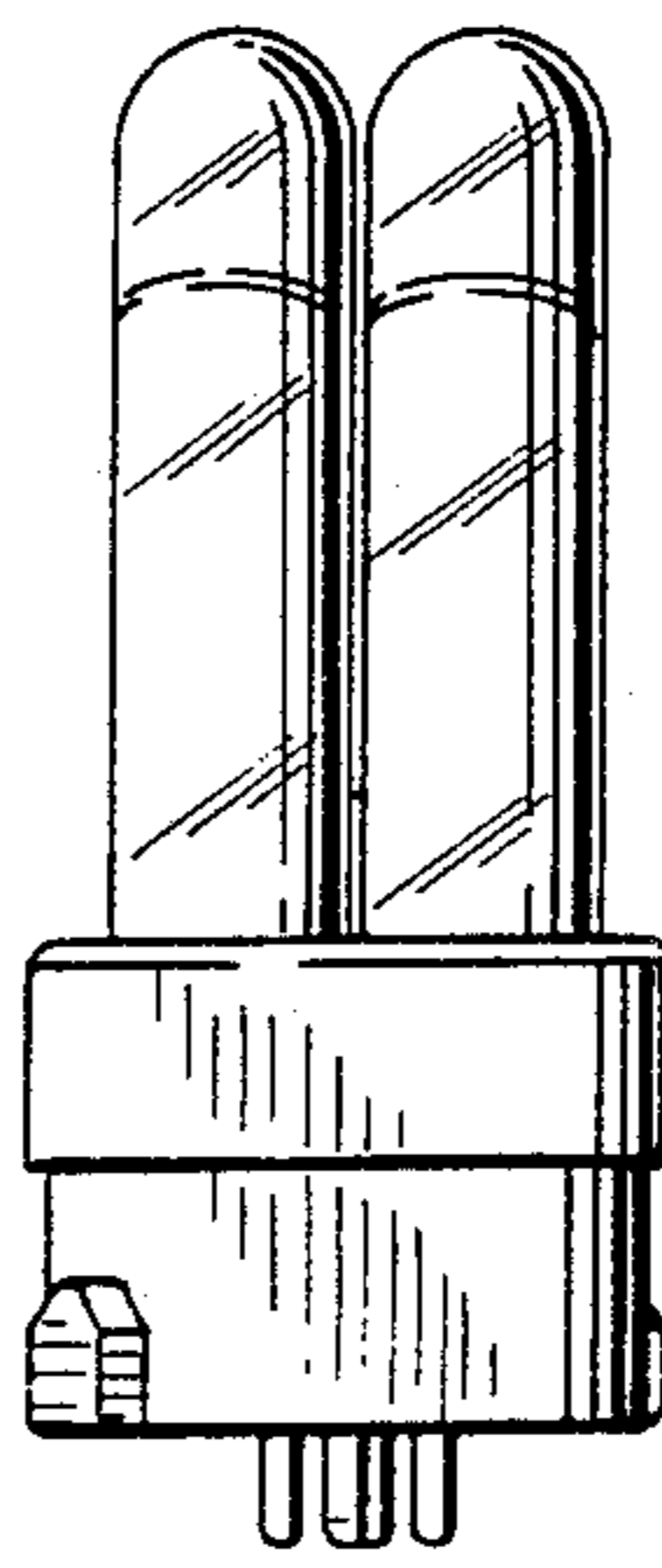


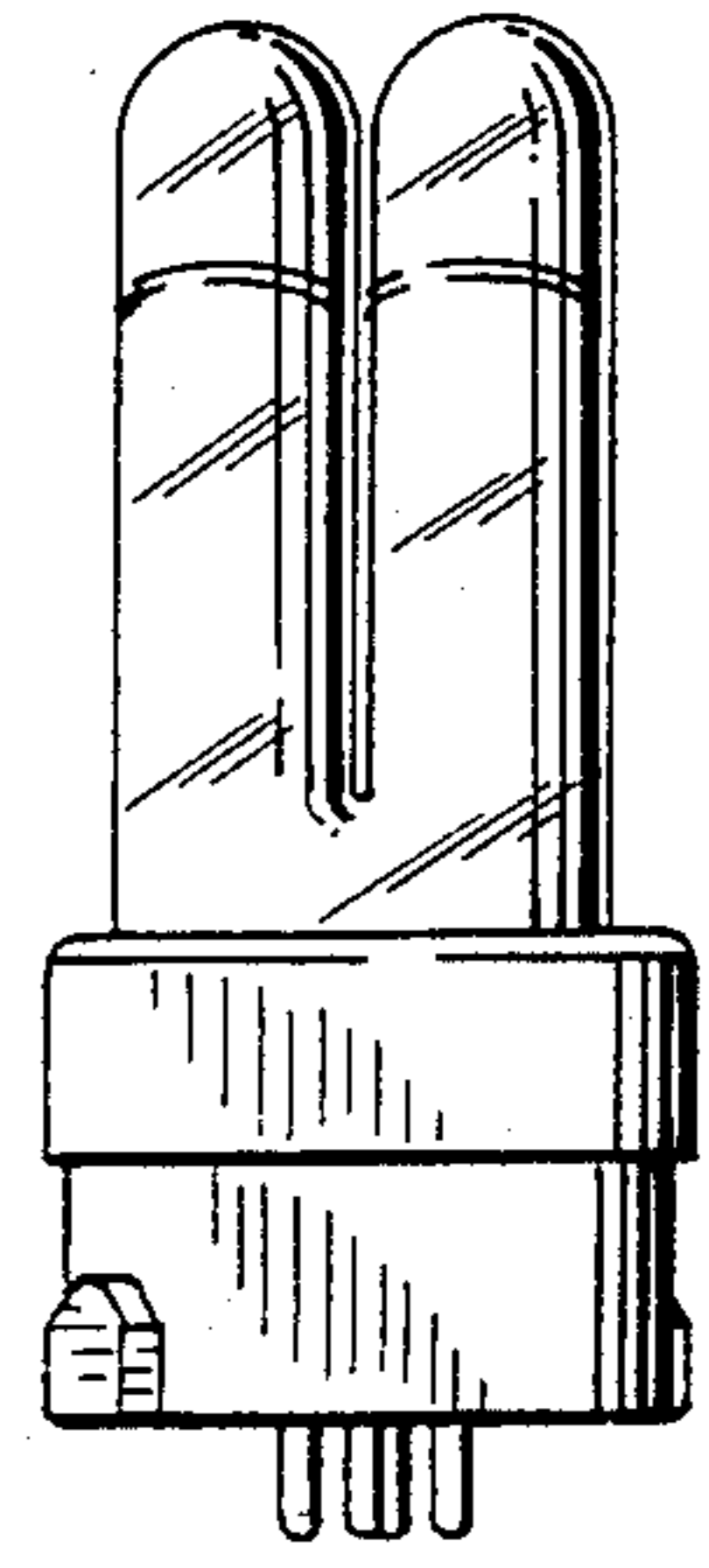

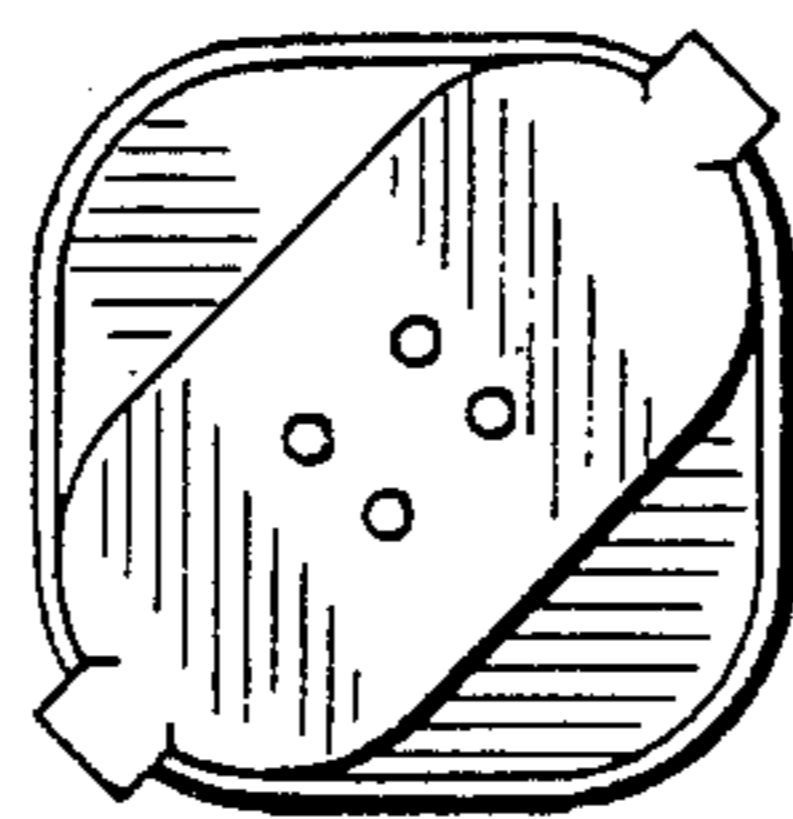

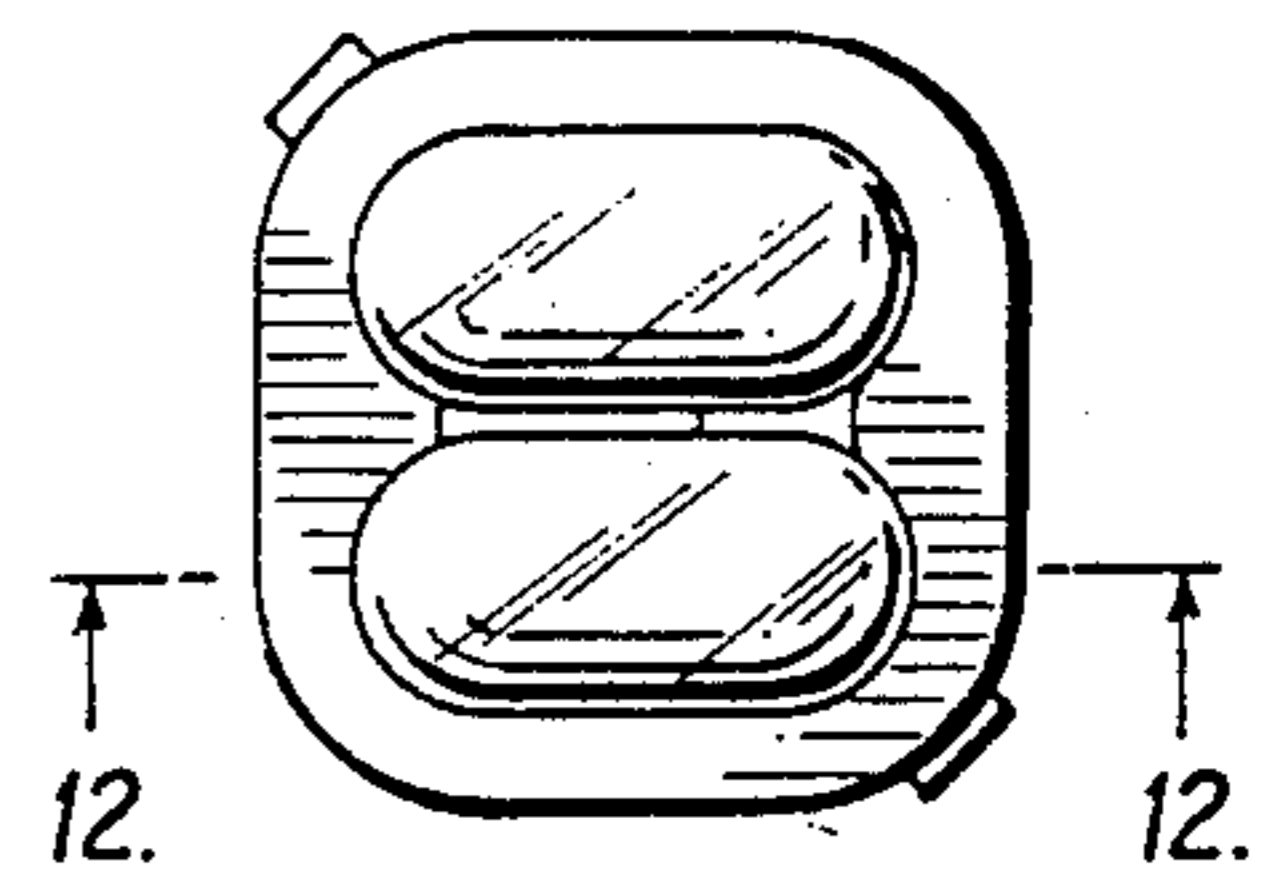

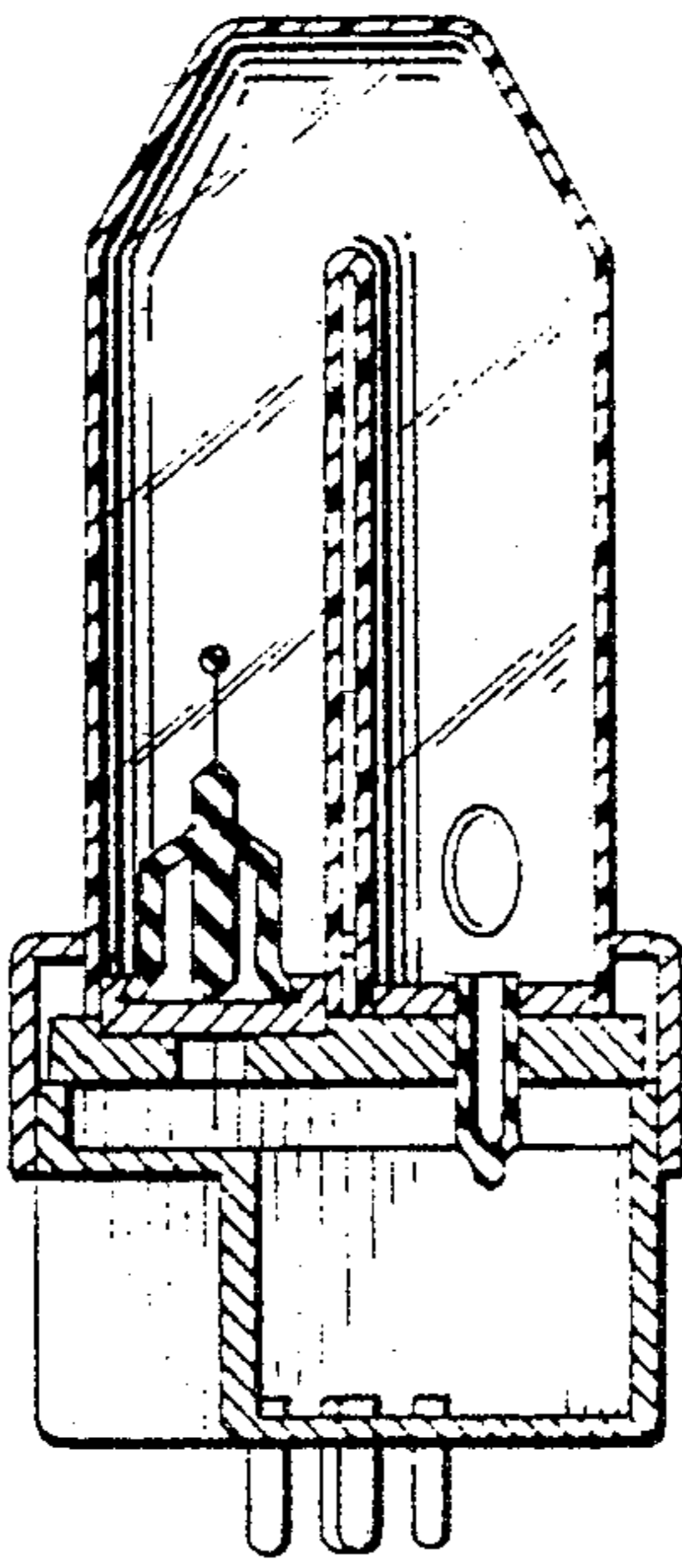
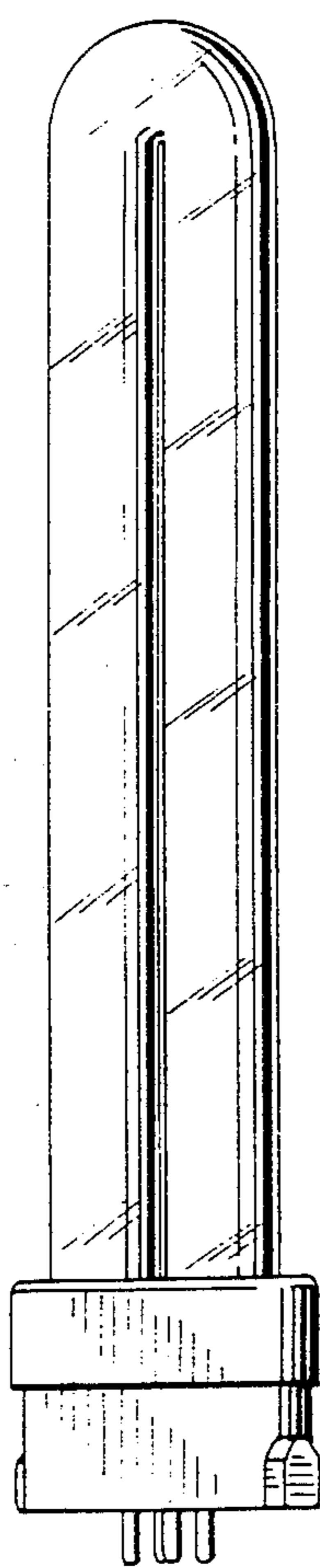
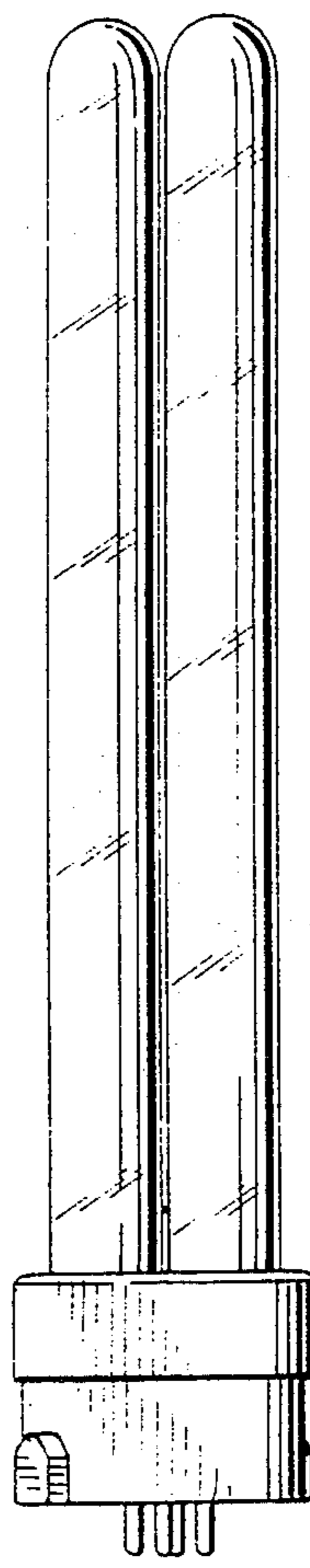


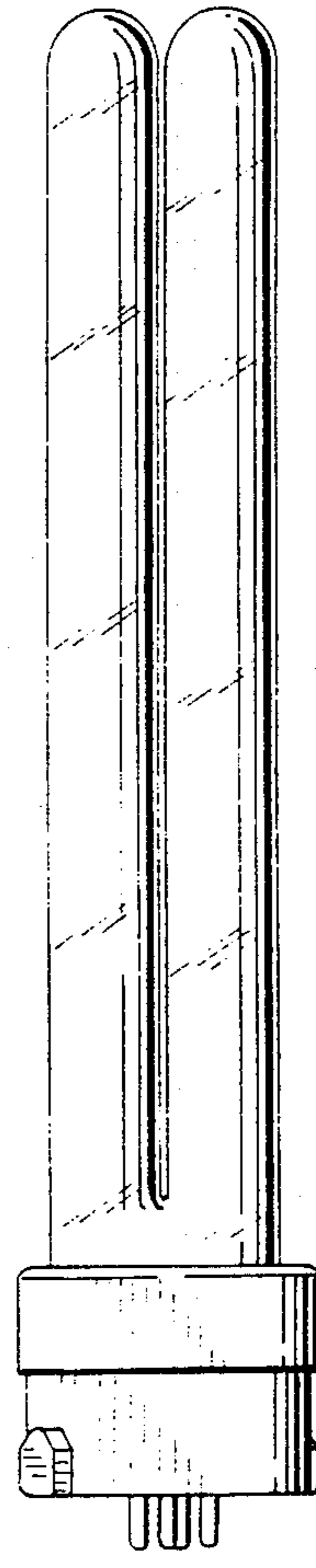

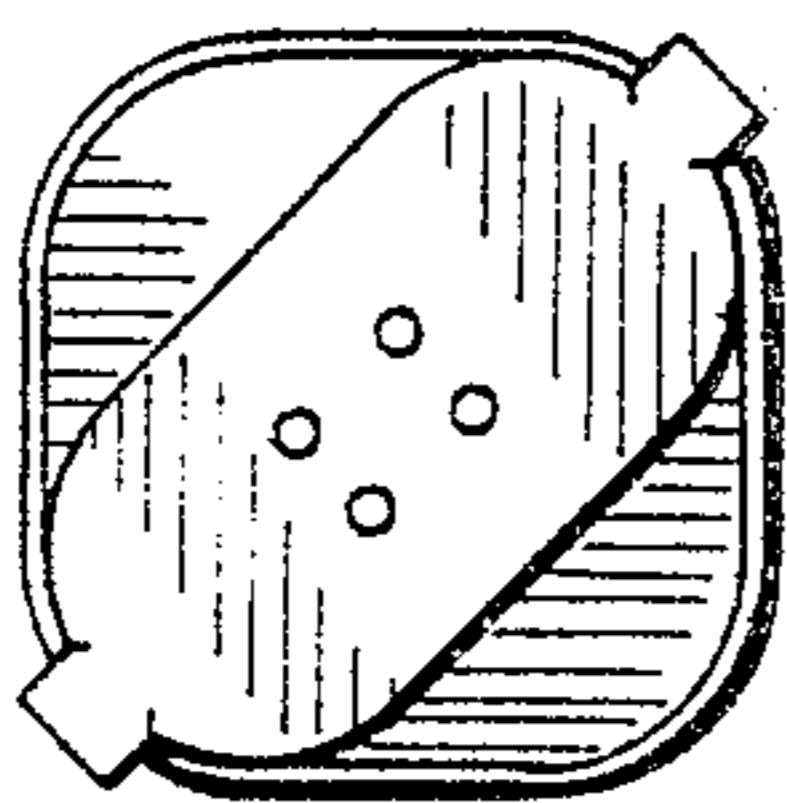

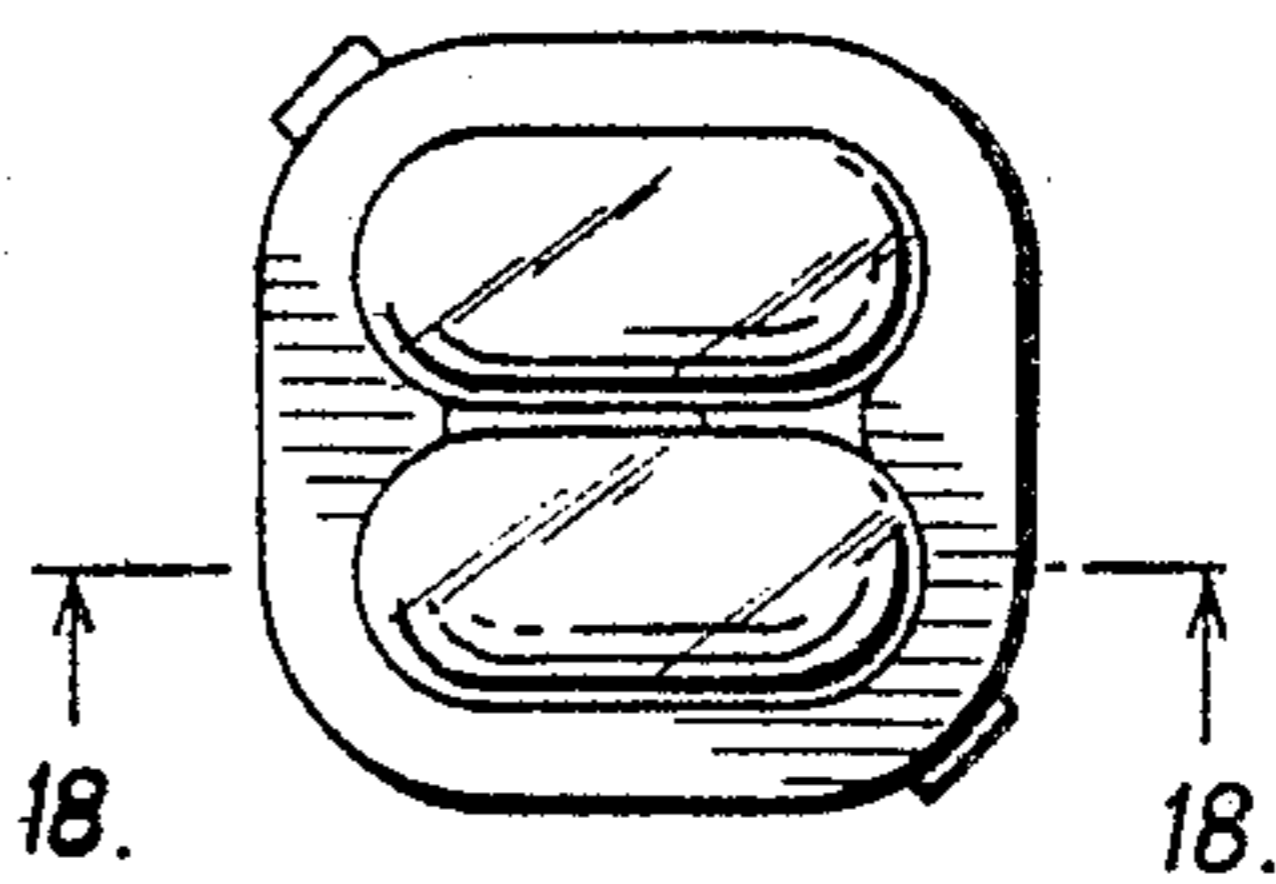

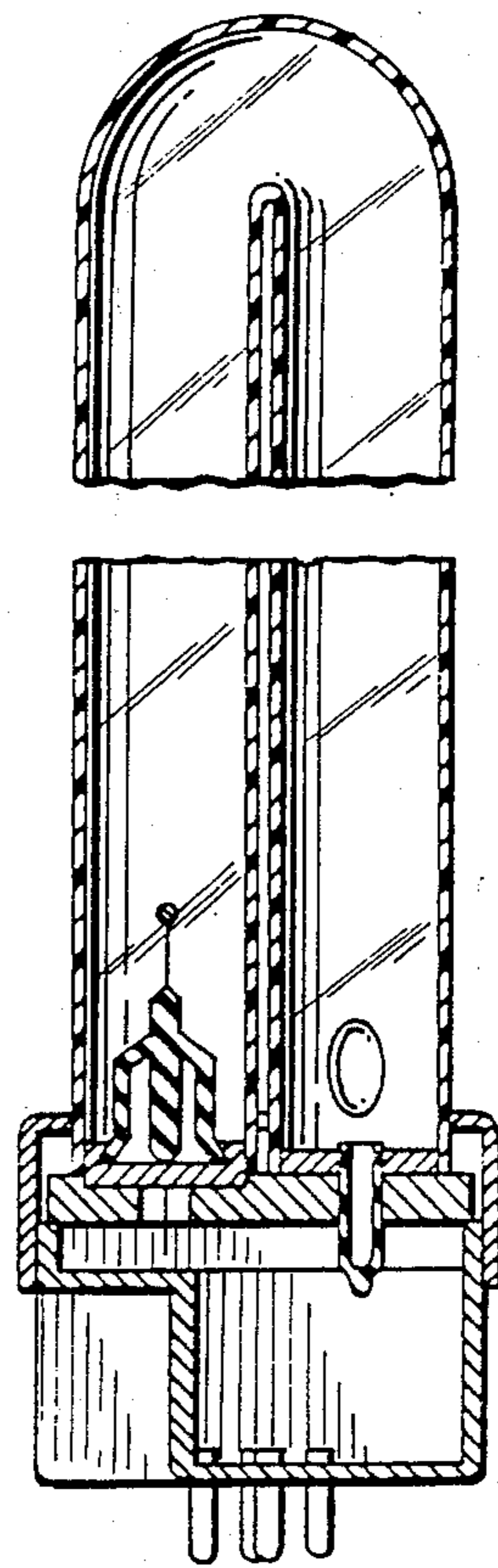

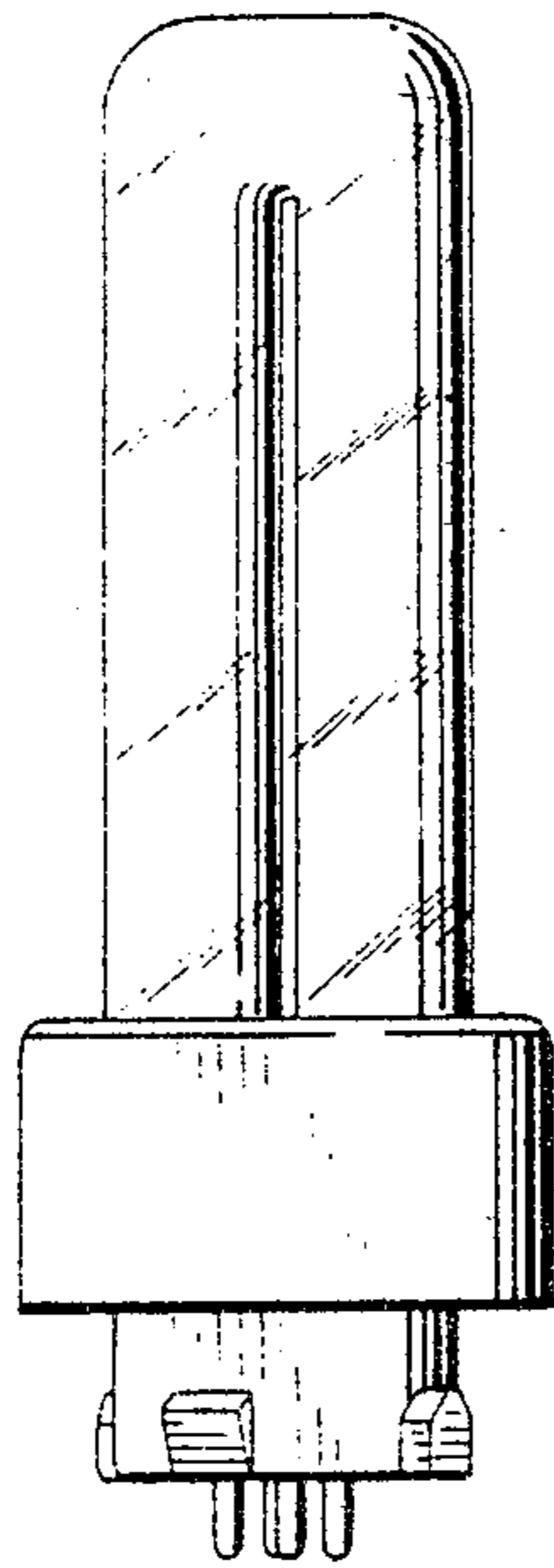

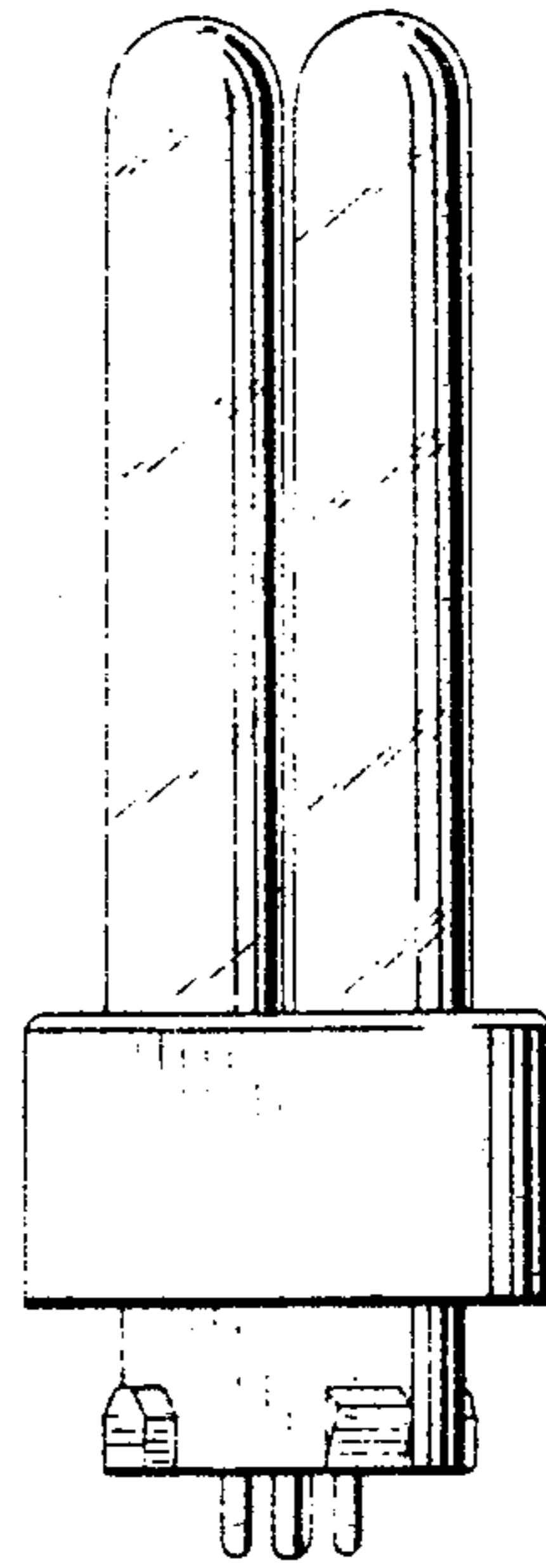

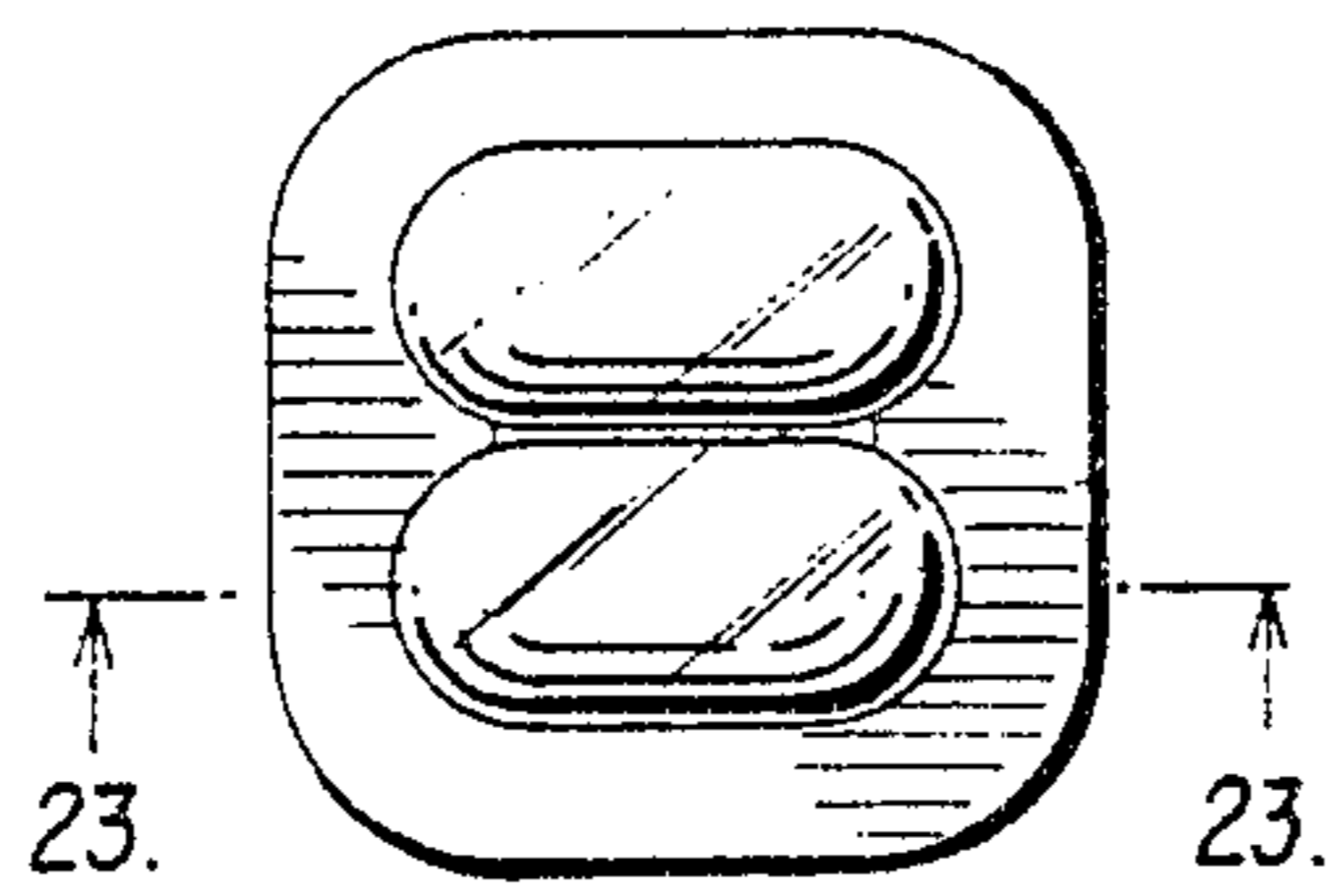

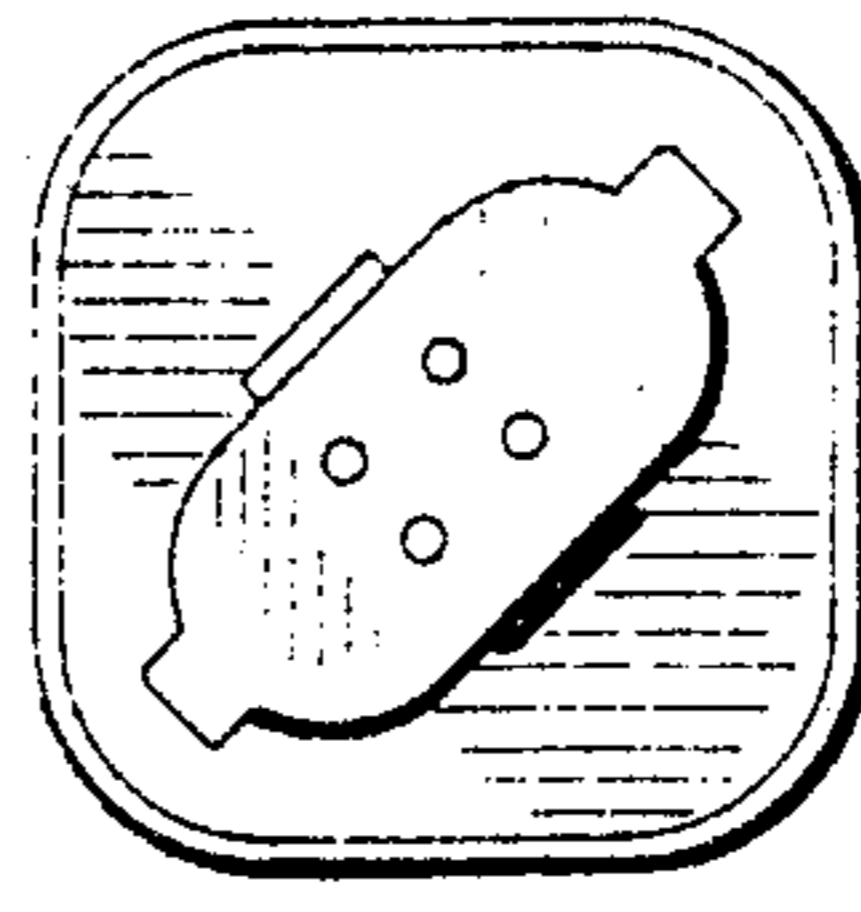

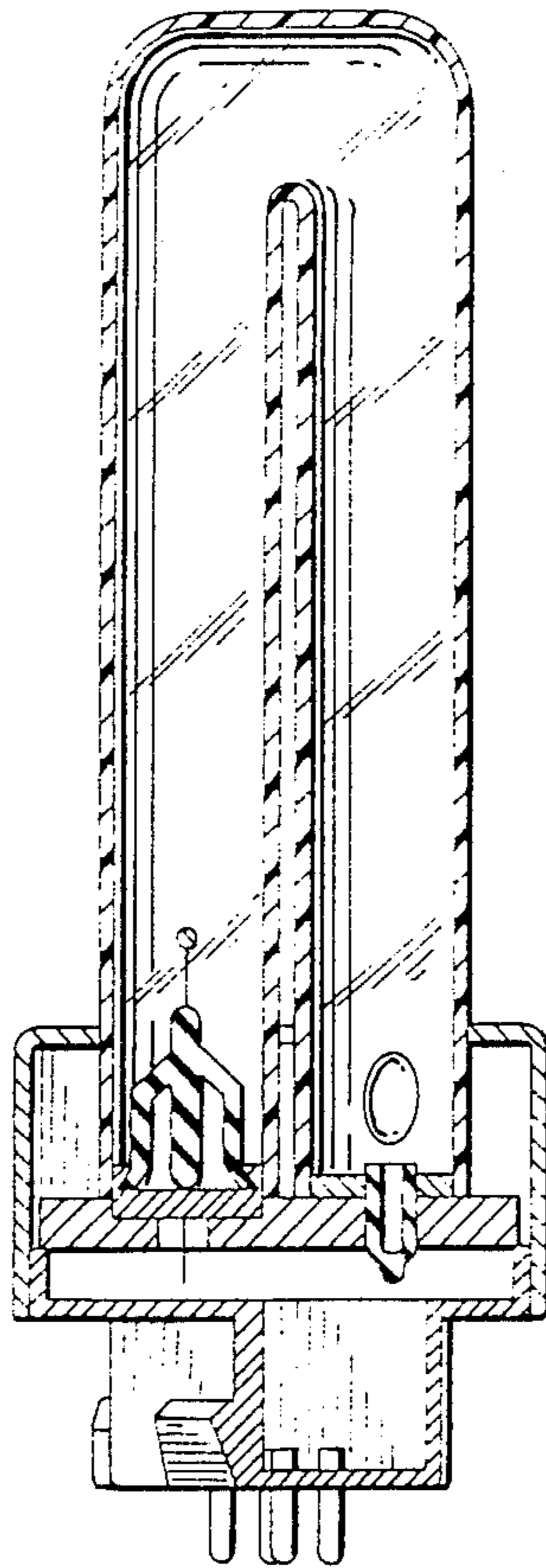
