The ornamental design for a facsimile, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a facsimile showing my new design;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a right side elevational view thereof;
FIG. 7 is a top, front and left side perspective view thereof;
FIG. 8 is a top, front and left side perspective view thereof, shown in a transmitting state;
FIG. 9 is a top, front and left side perspective view thereof, shown with a tray attached; and
FIG. 10 is a top, front and left side perspective view thereof, shown in a receiving state.
The broken line showing of the tray in FIGS. 8, 9 and 10 is for illustrative purposes only and forms no part of the claimed design.
The broken line showing of the sheets of paper in FIGS. 8 and 10 is for illustrative purposes only and forms no part of the claimed design.

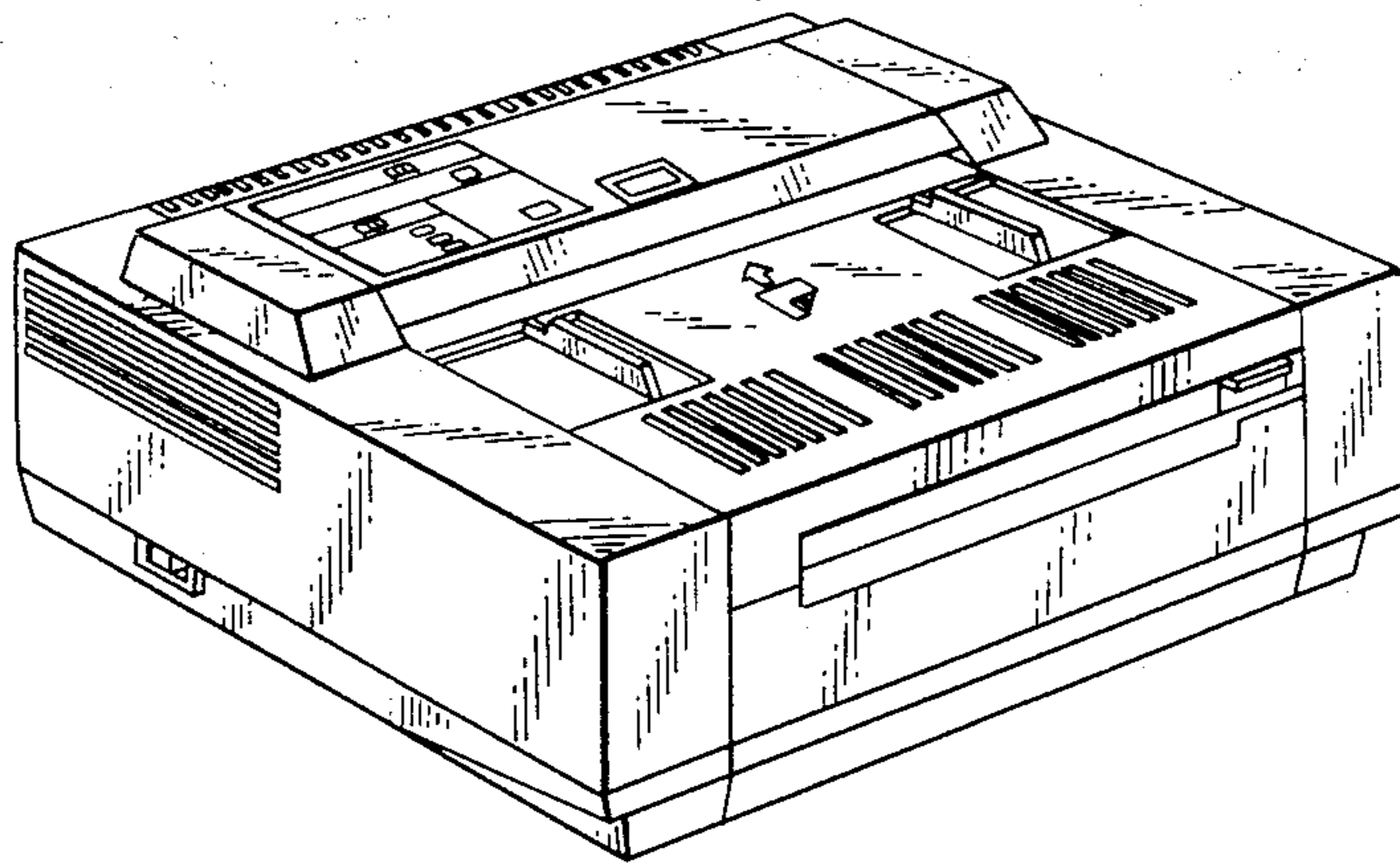

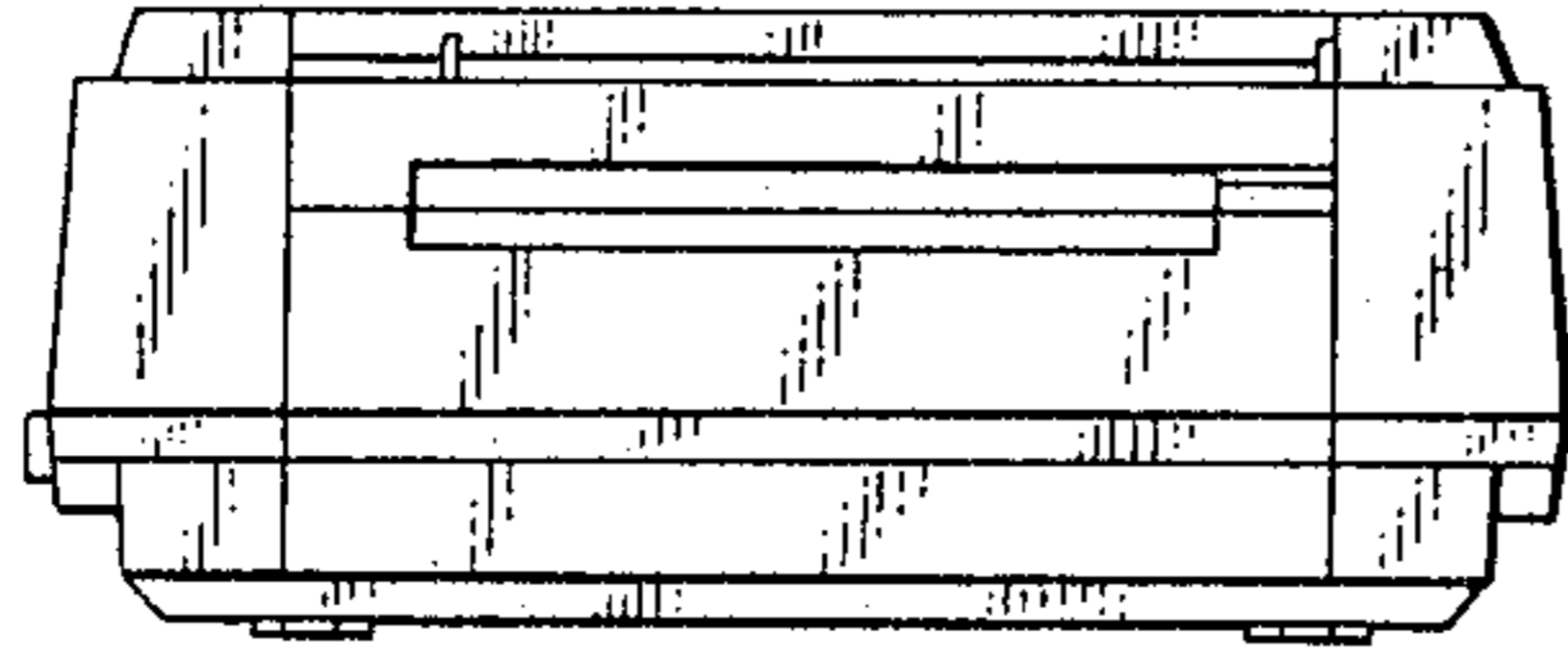

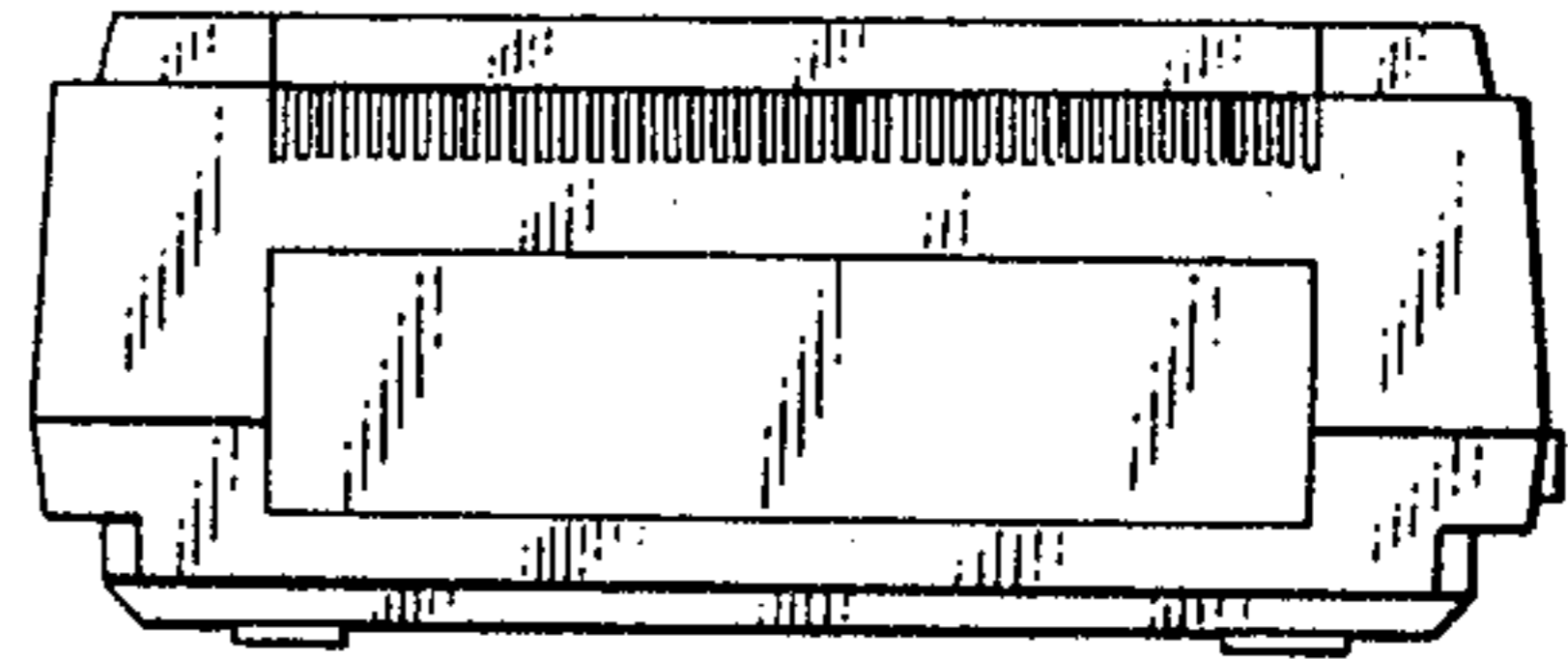

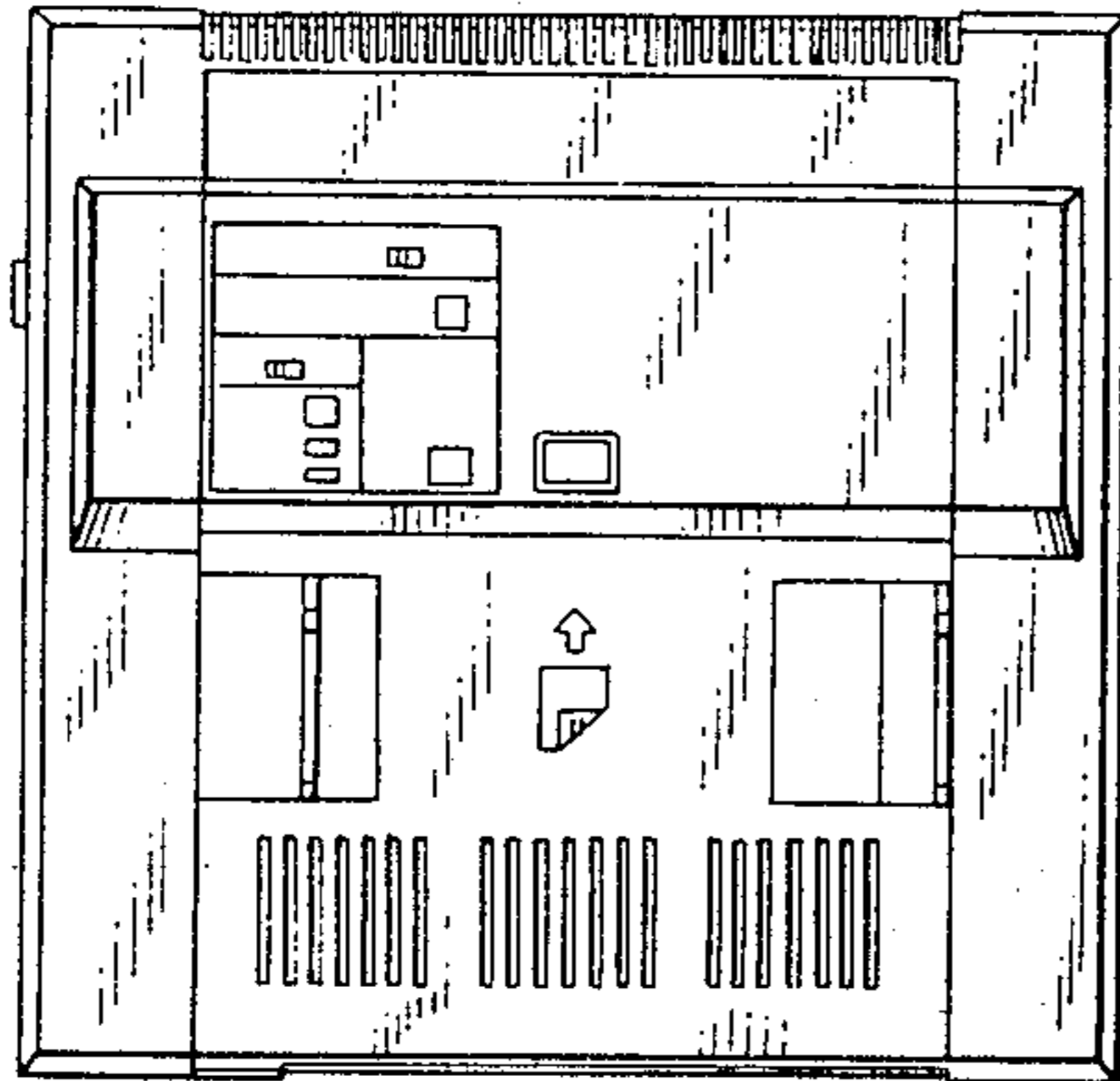

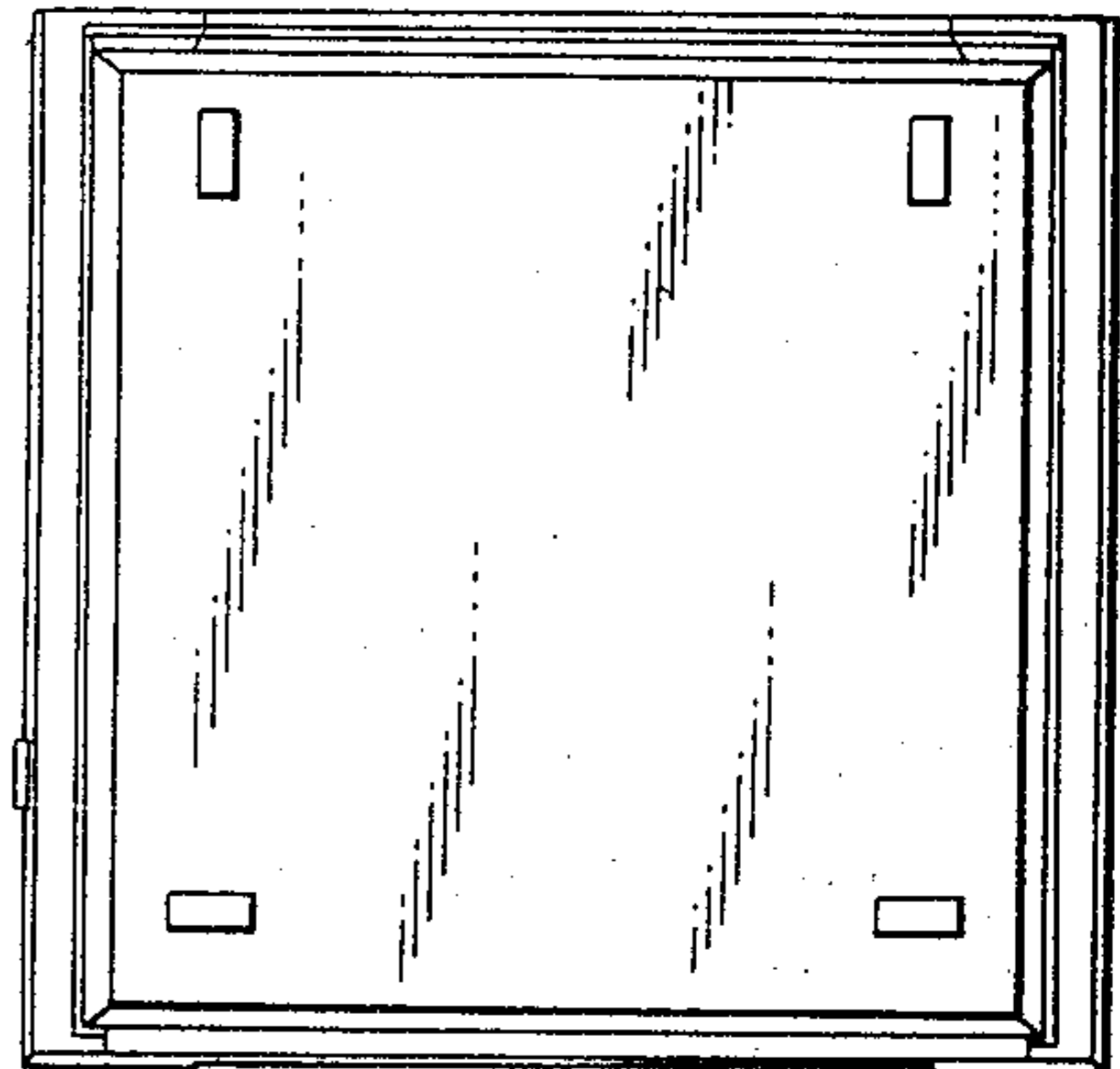

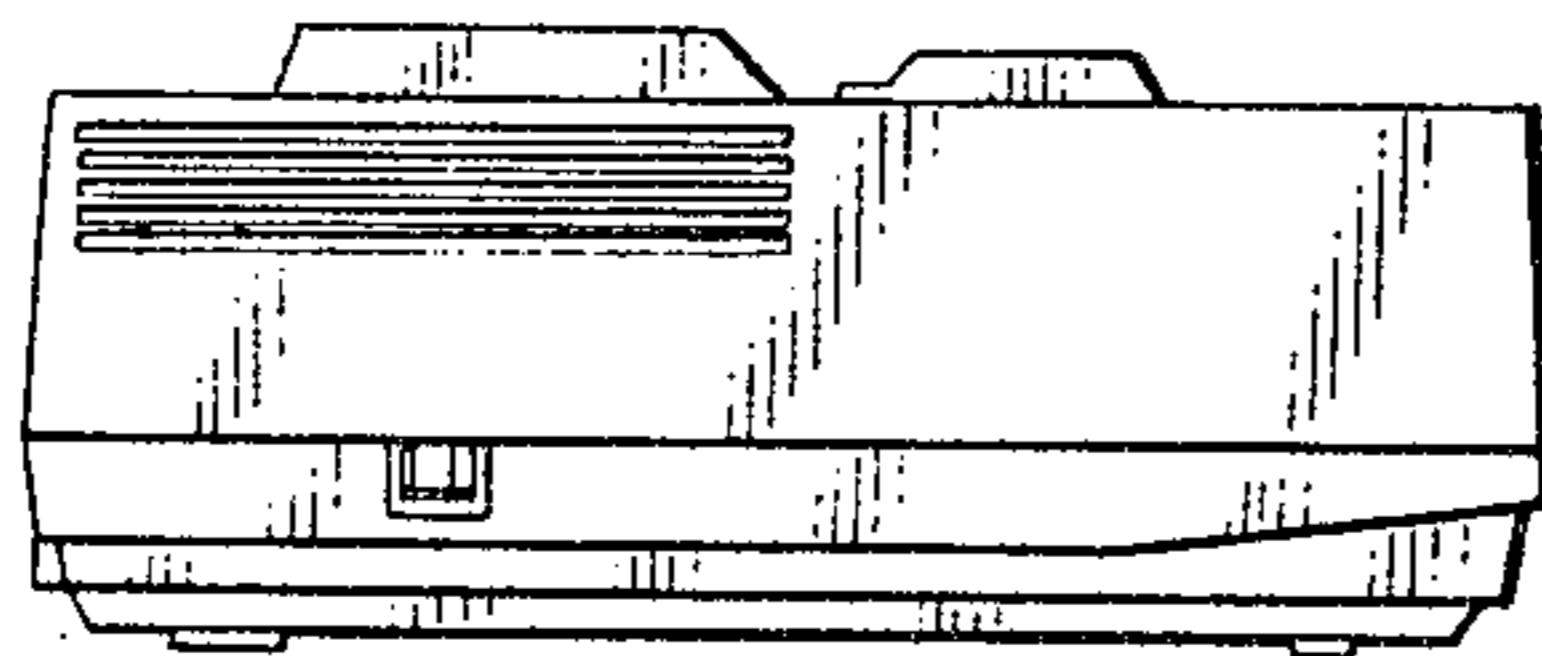
