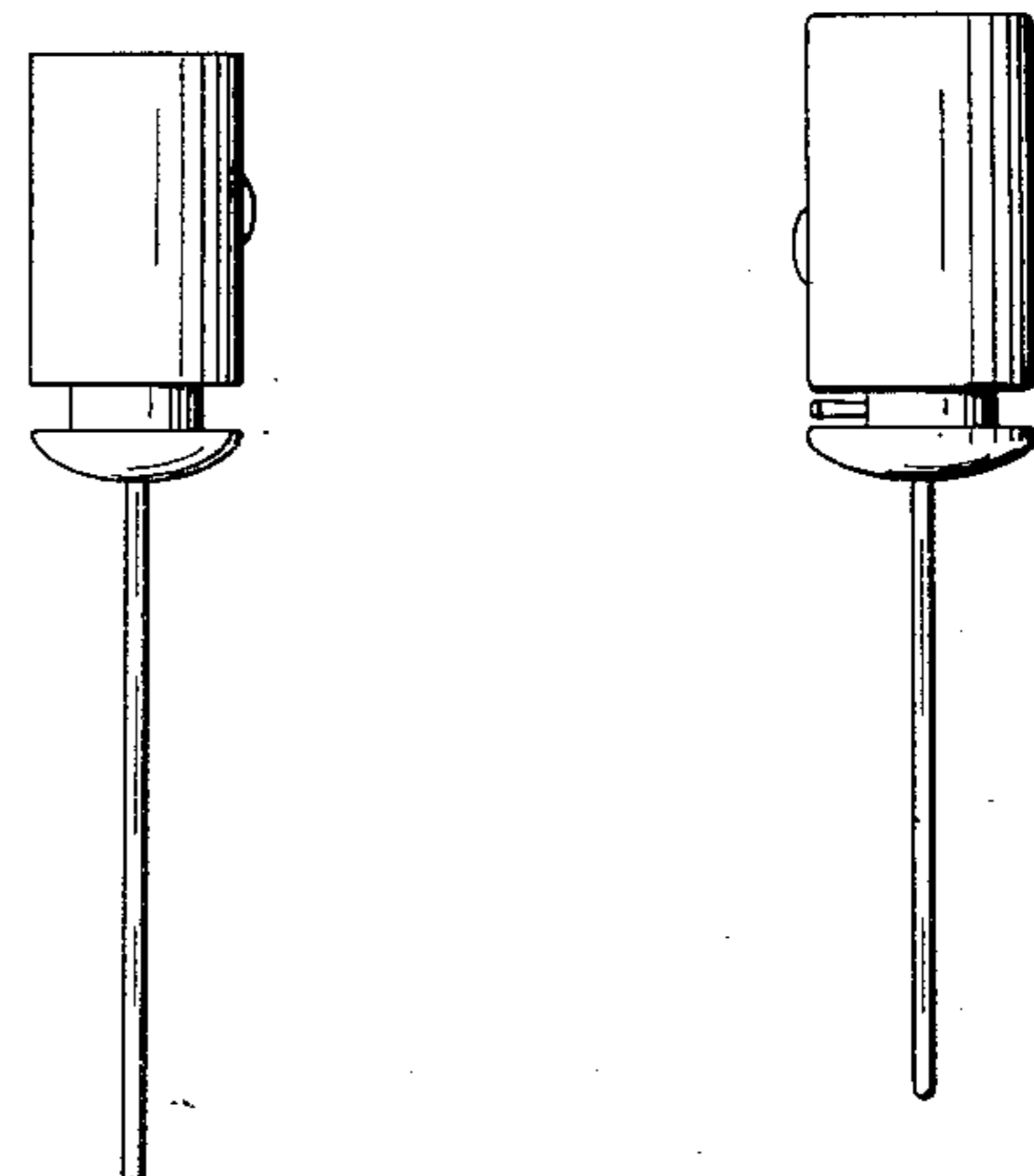
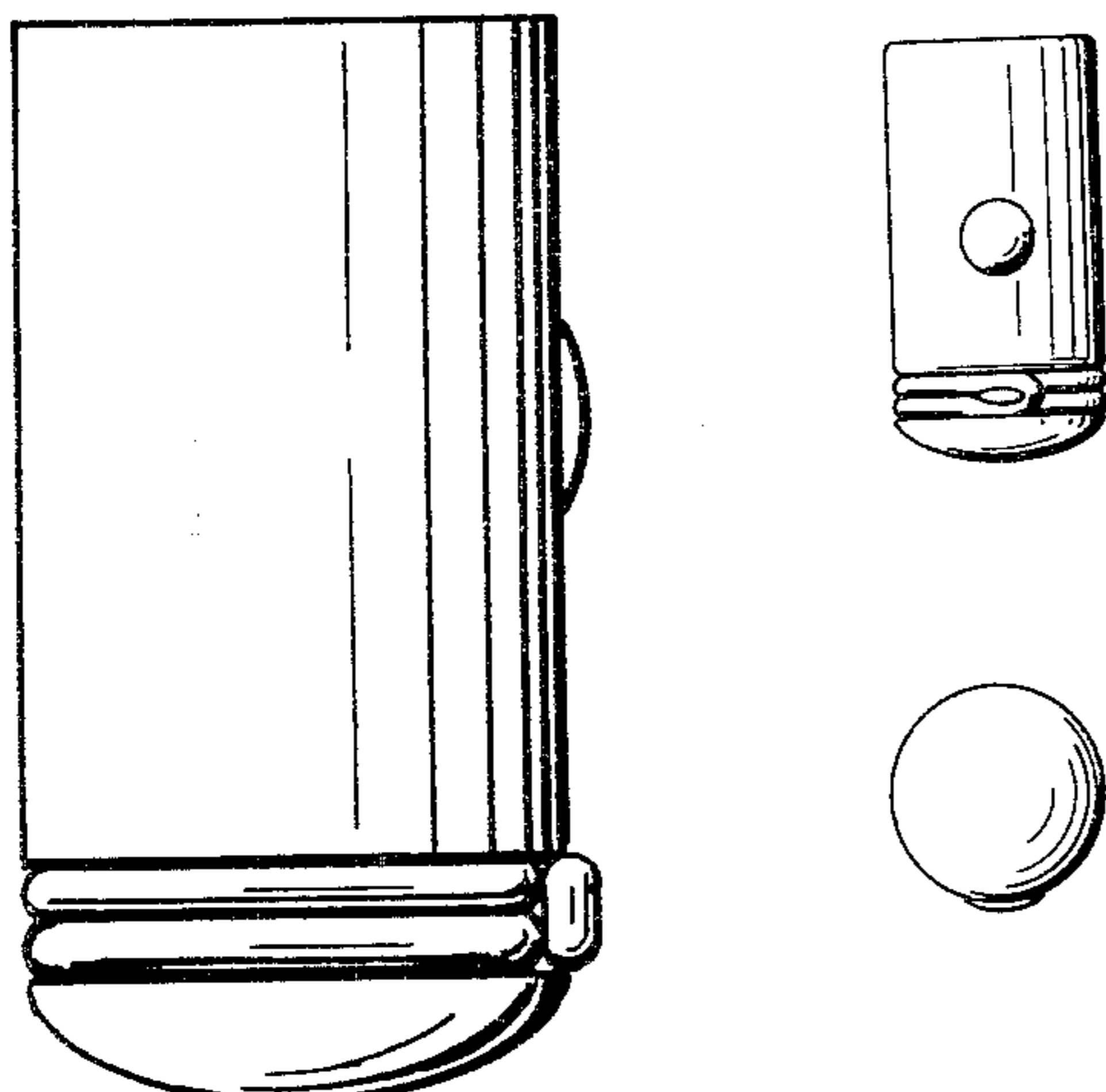

The ornamental design for an umbrella handle, substantially as shown and described.

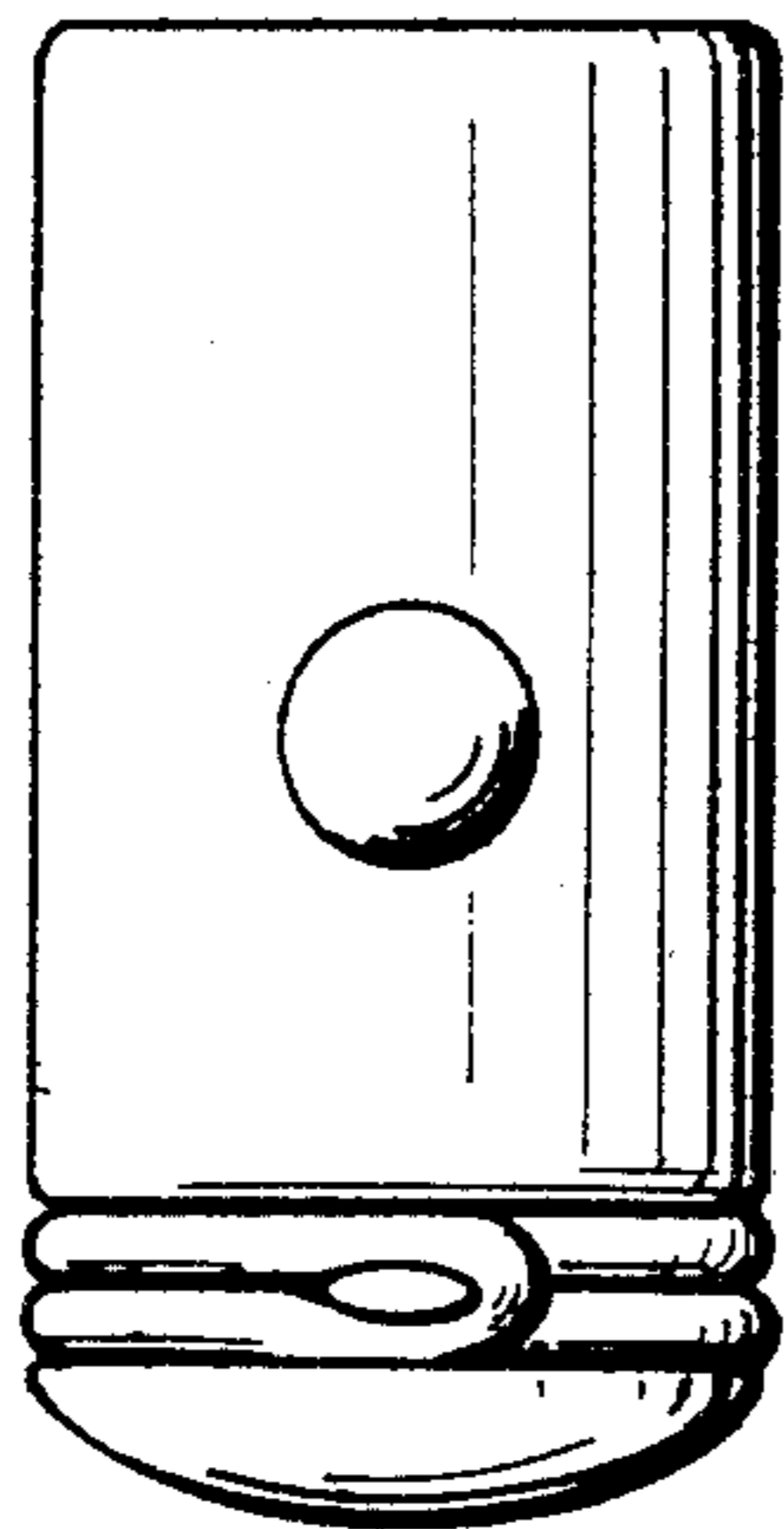
DESCRIPTION

FIG. 1 is a front elevation of an umbrella handle showing my new design, the carrying strap being shown in the stored position;  
 FIG. 2 is a rear elevation thereof;  
 FIG. 3 is a left side elevation thereof;  
 FIG. 4 is a right side elevation thereof;  
 FIG. 5 is a bottom plan view thereof;  
 FIG. 6 is a top plan view thereof;  
 FIG. 7 is a front elevation thereof with the carrying strap being shown in a use position;  
 FIG. 8 is a left side elevation thereof;  
 FIG. 9 is a right side elevation thereof;  
 FIG. 10 is a rear elevation thereof;  
 FIG. 11 is a bottom plan view thereof;  
 FIG. 12 is a top plan view thereof;  
 FIG. 13 is a front elevation of a second embodiment of that shown in FIG. 1, the carrying strap being shown in the stored position;  
 FIG. 14 is a right side elevation thereof;

 FIG. 24 is a top plan view thereof.

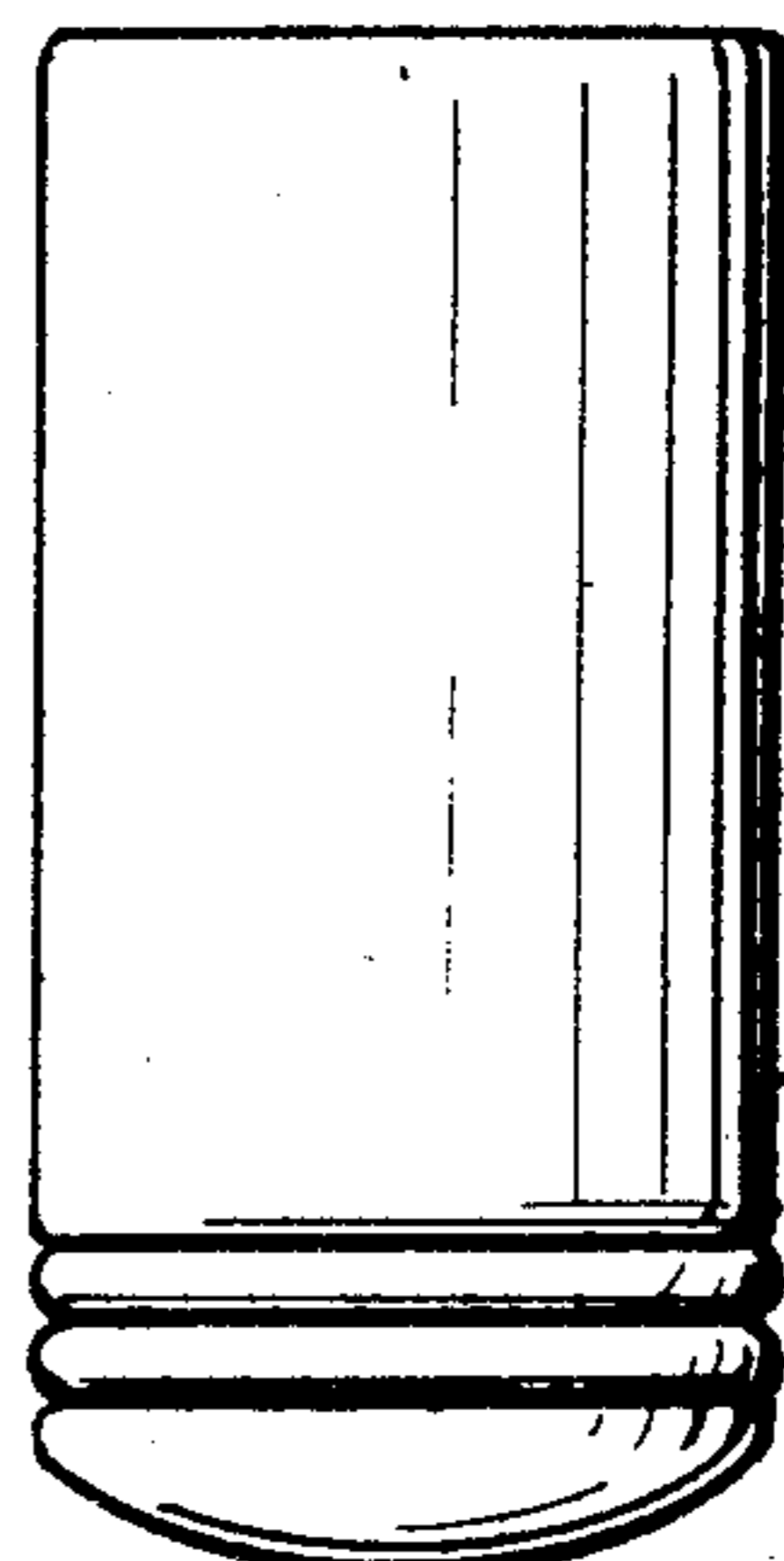

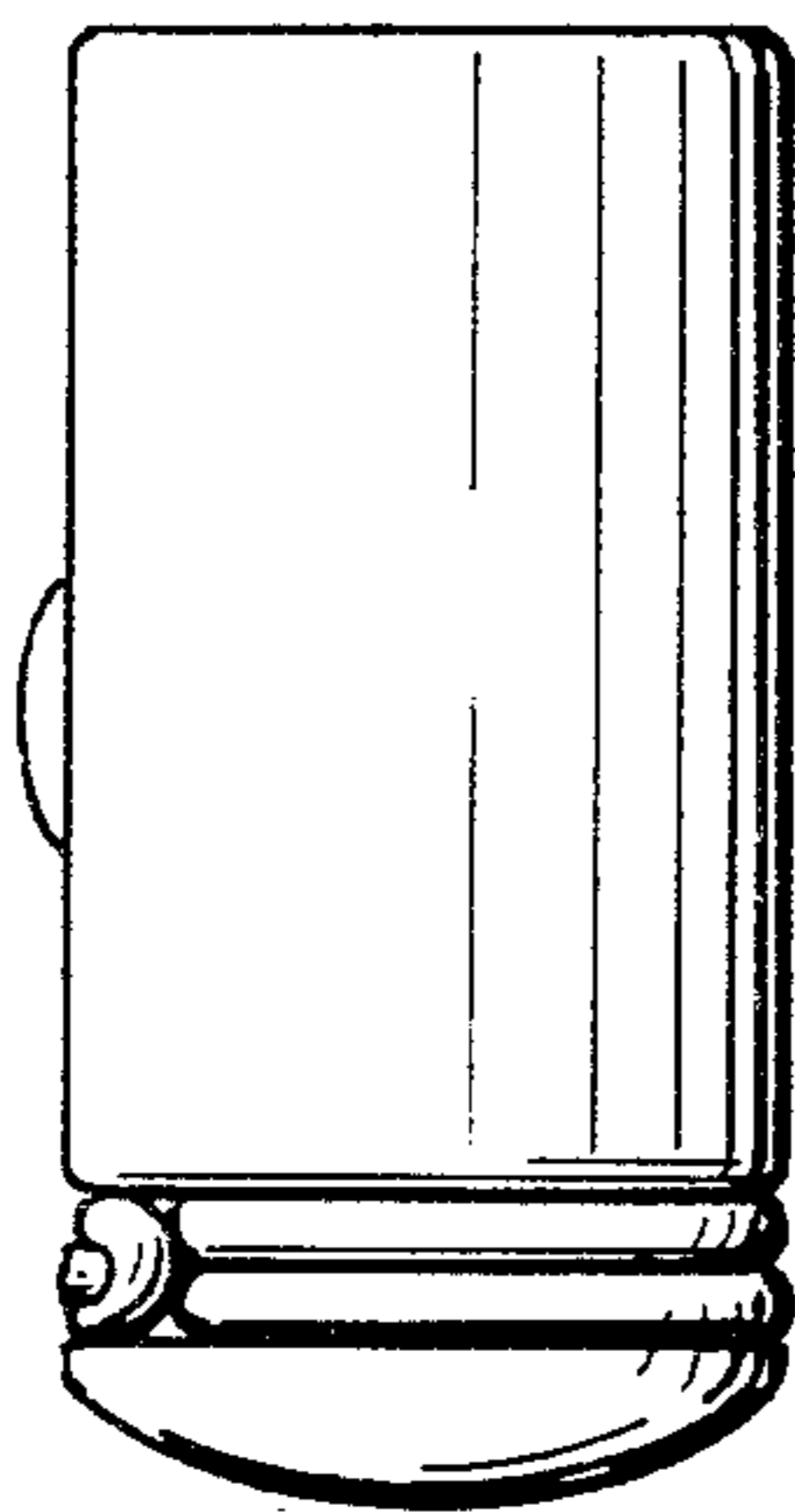

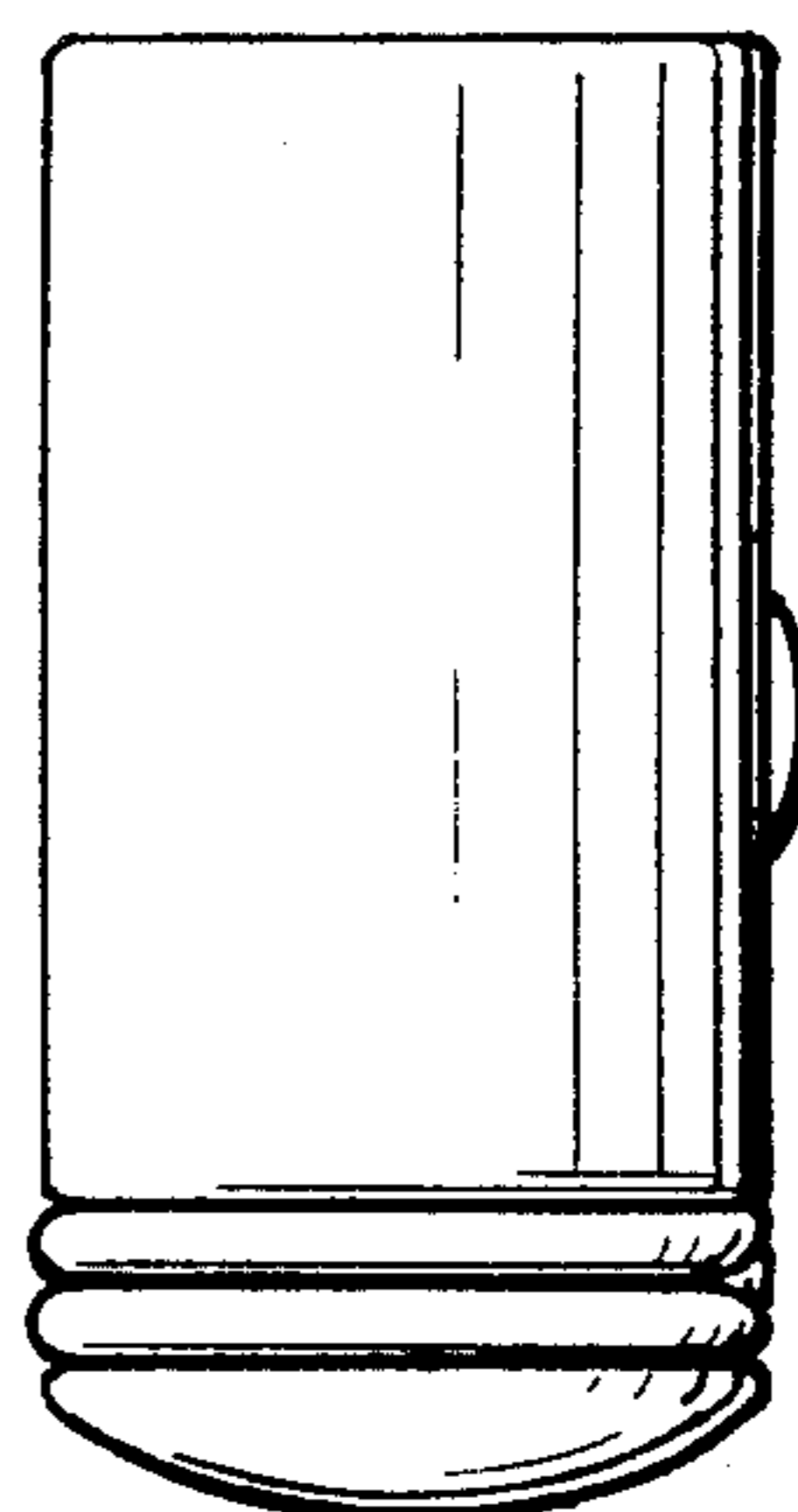

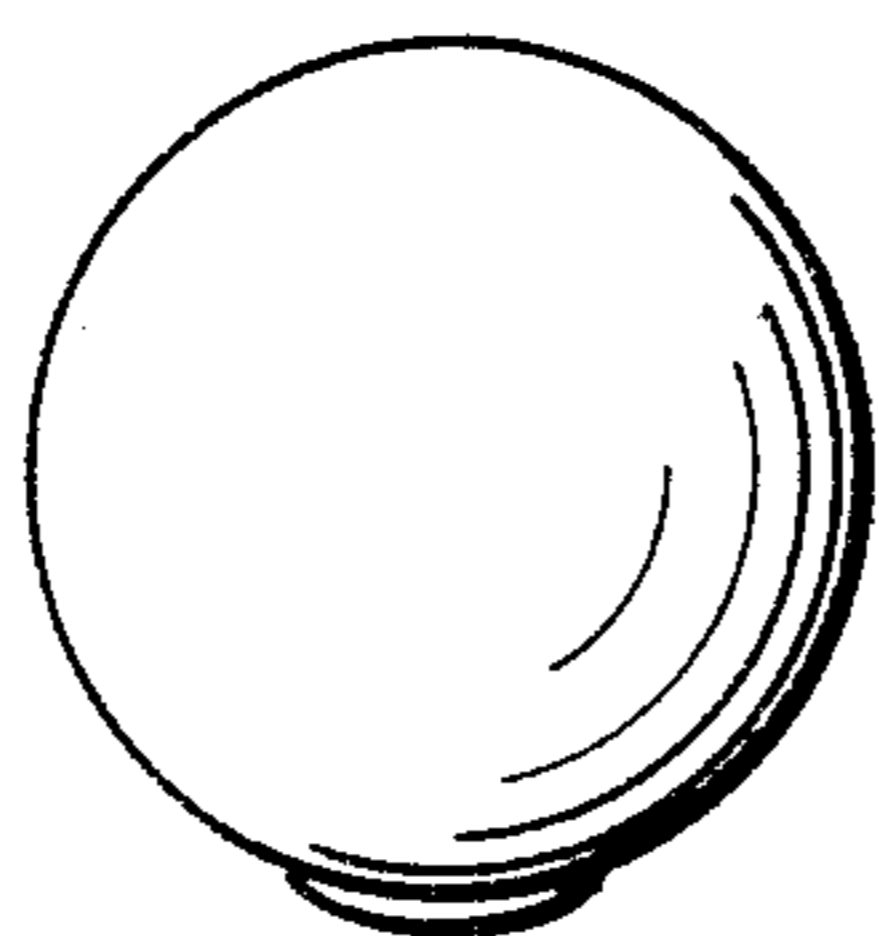

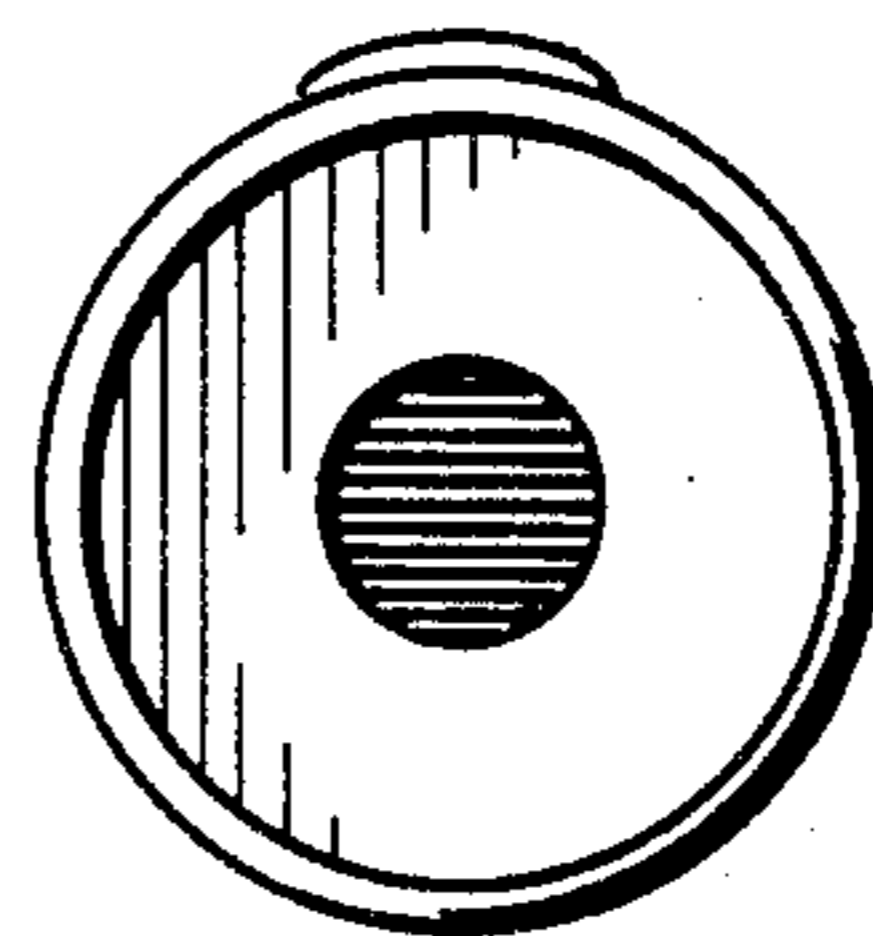

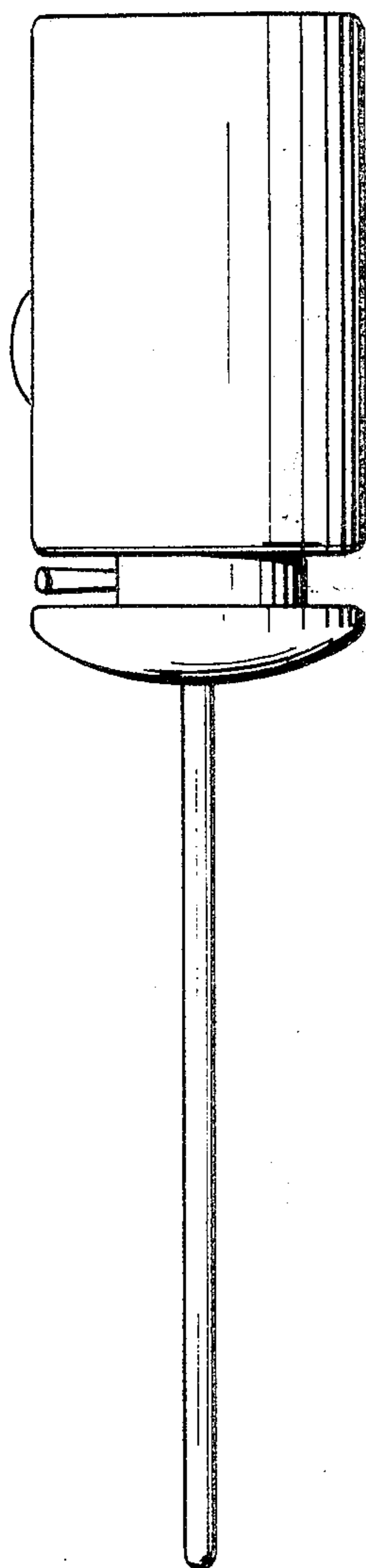

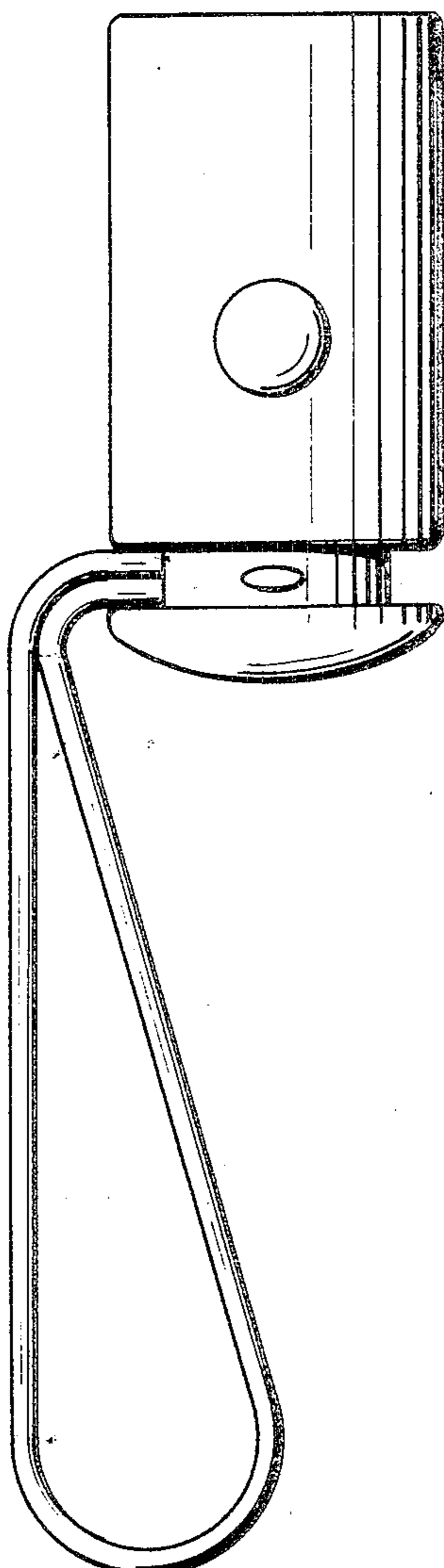

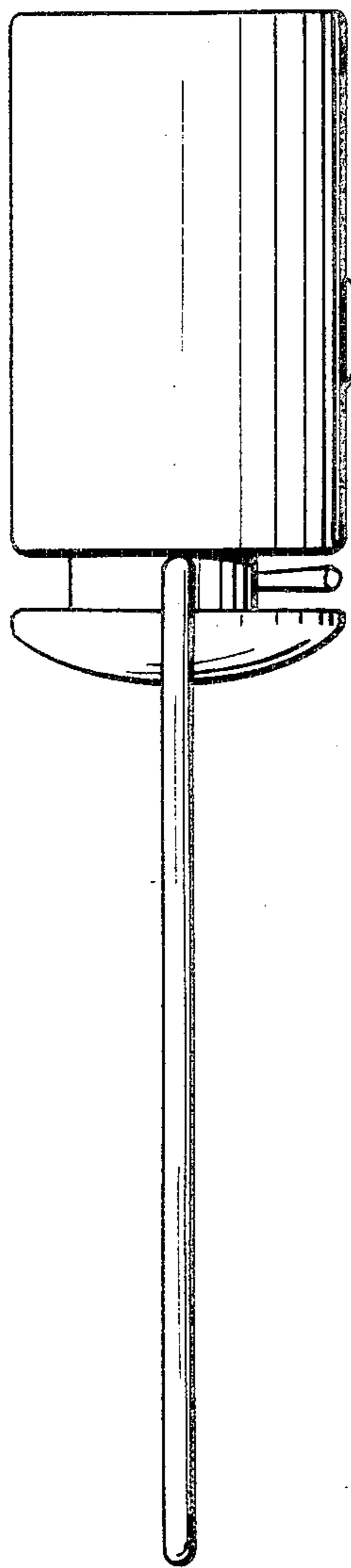

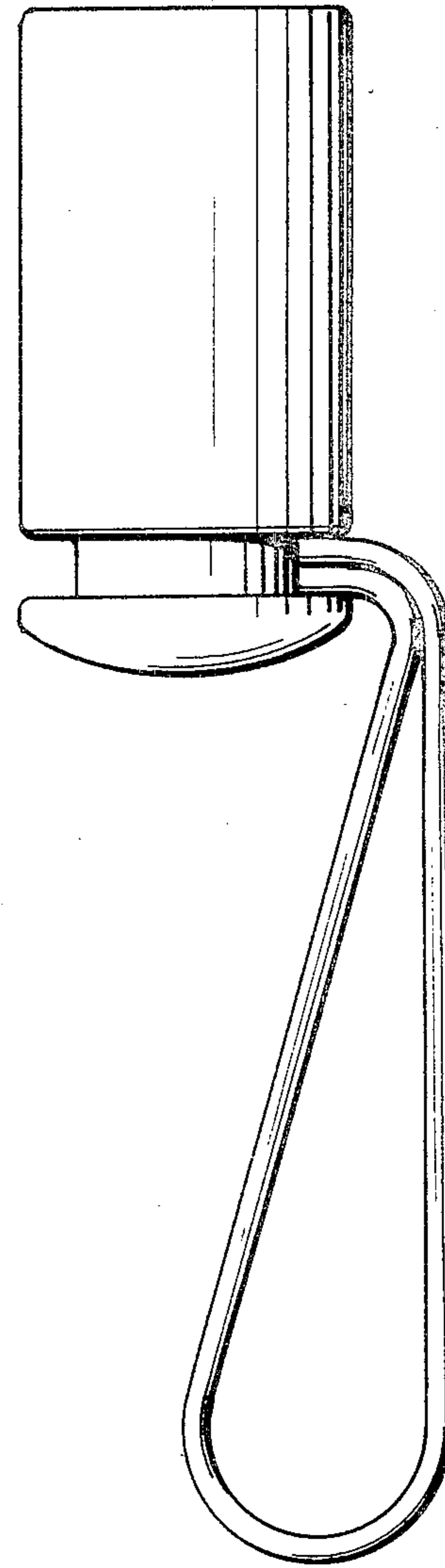

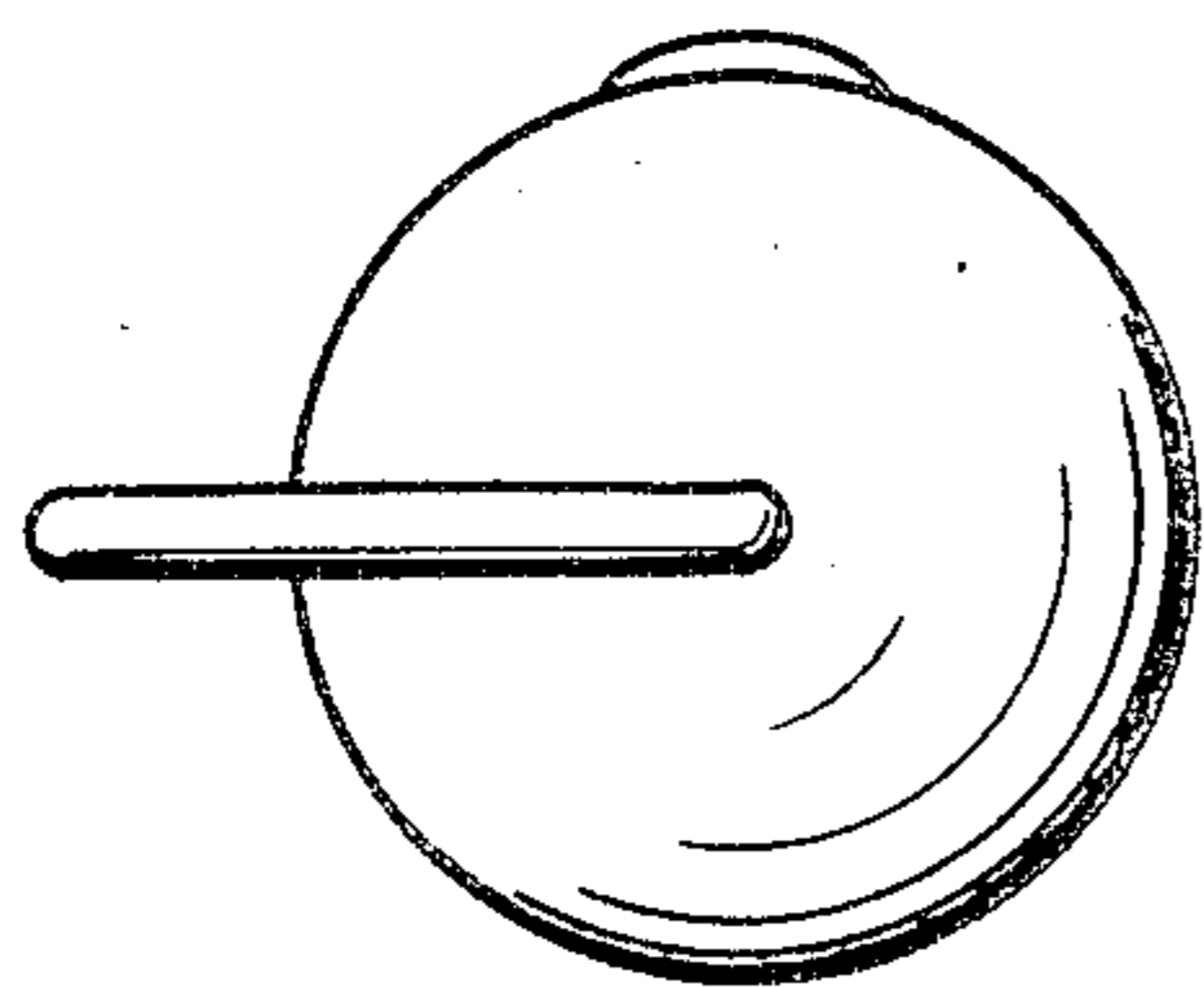

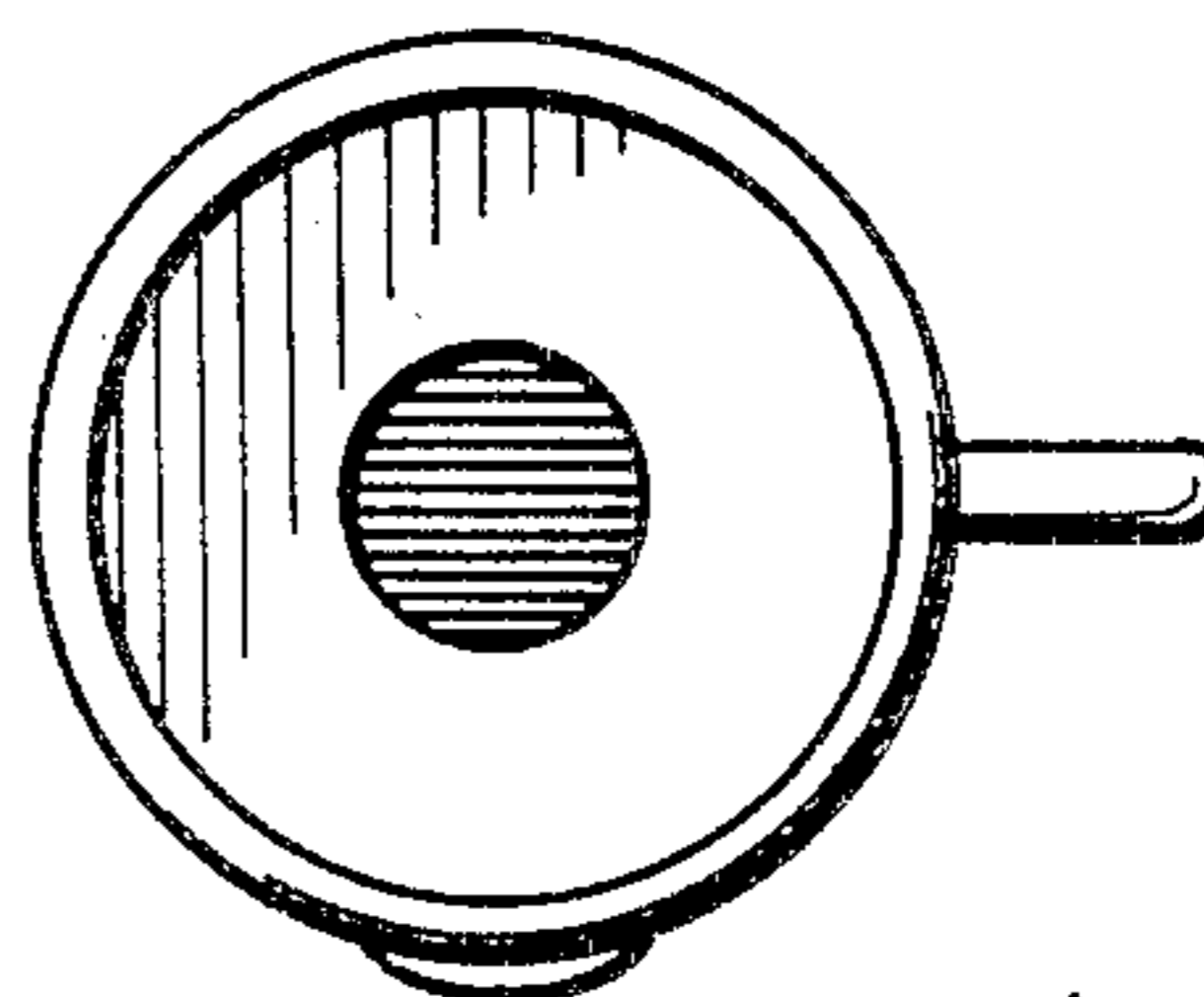

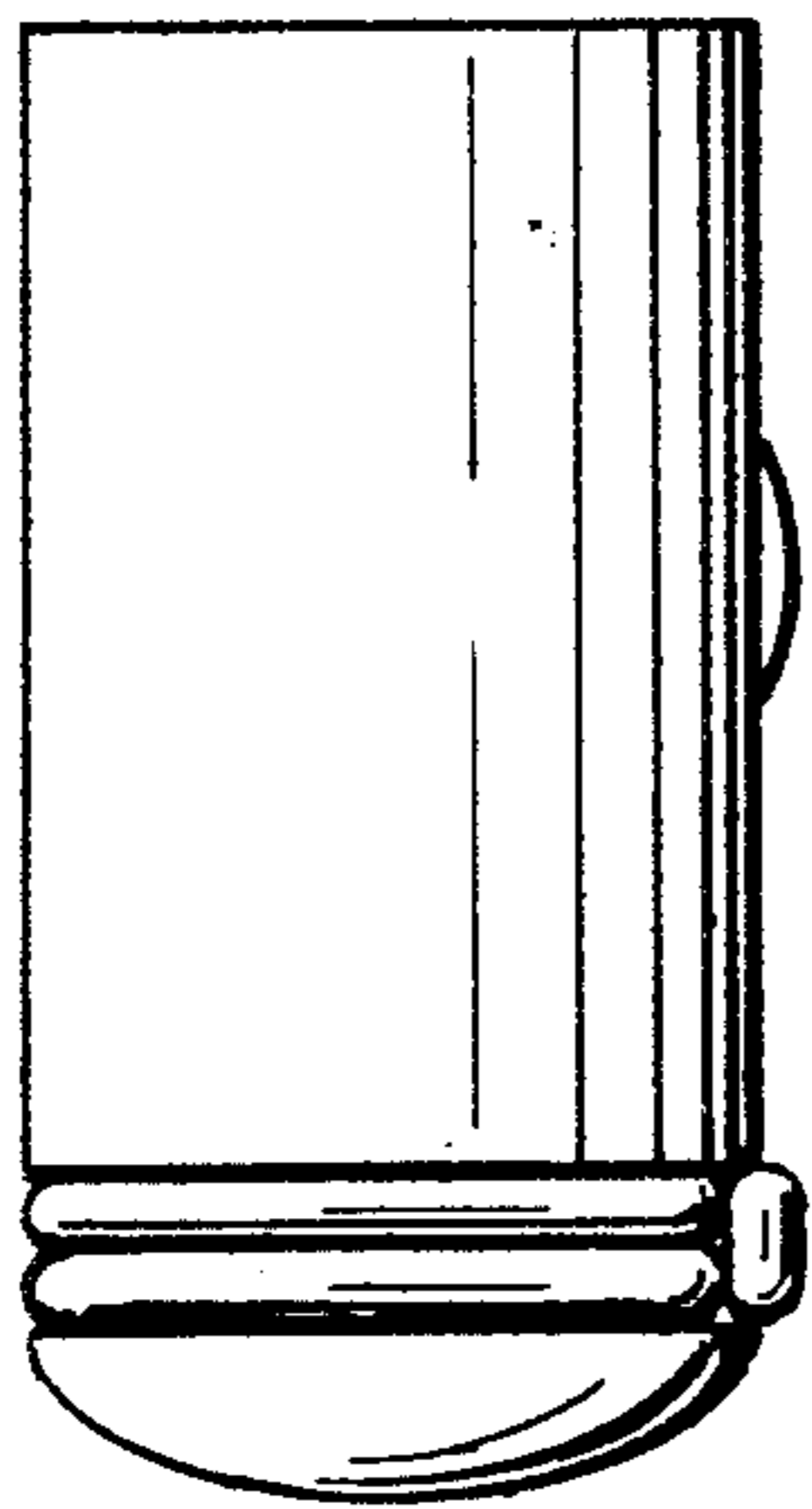

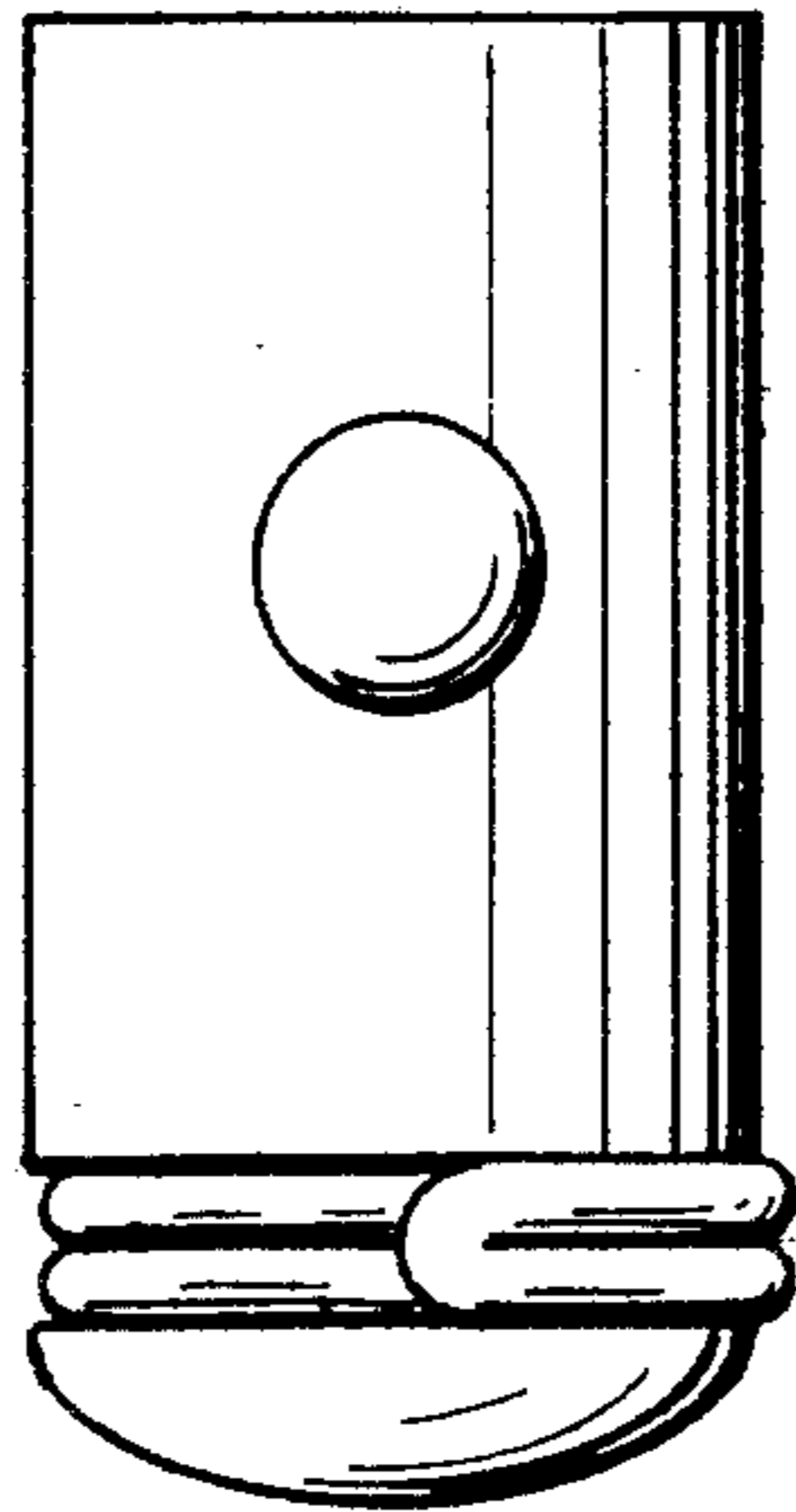

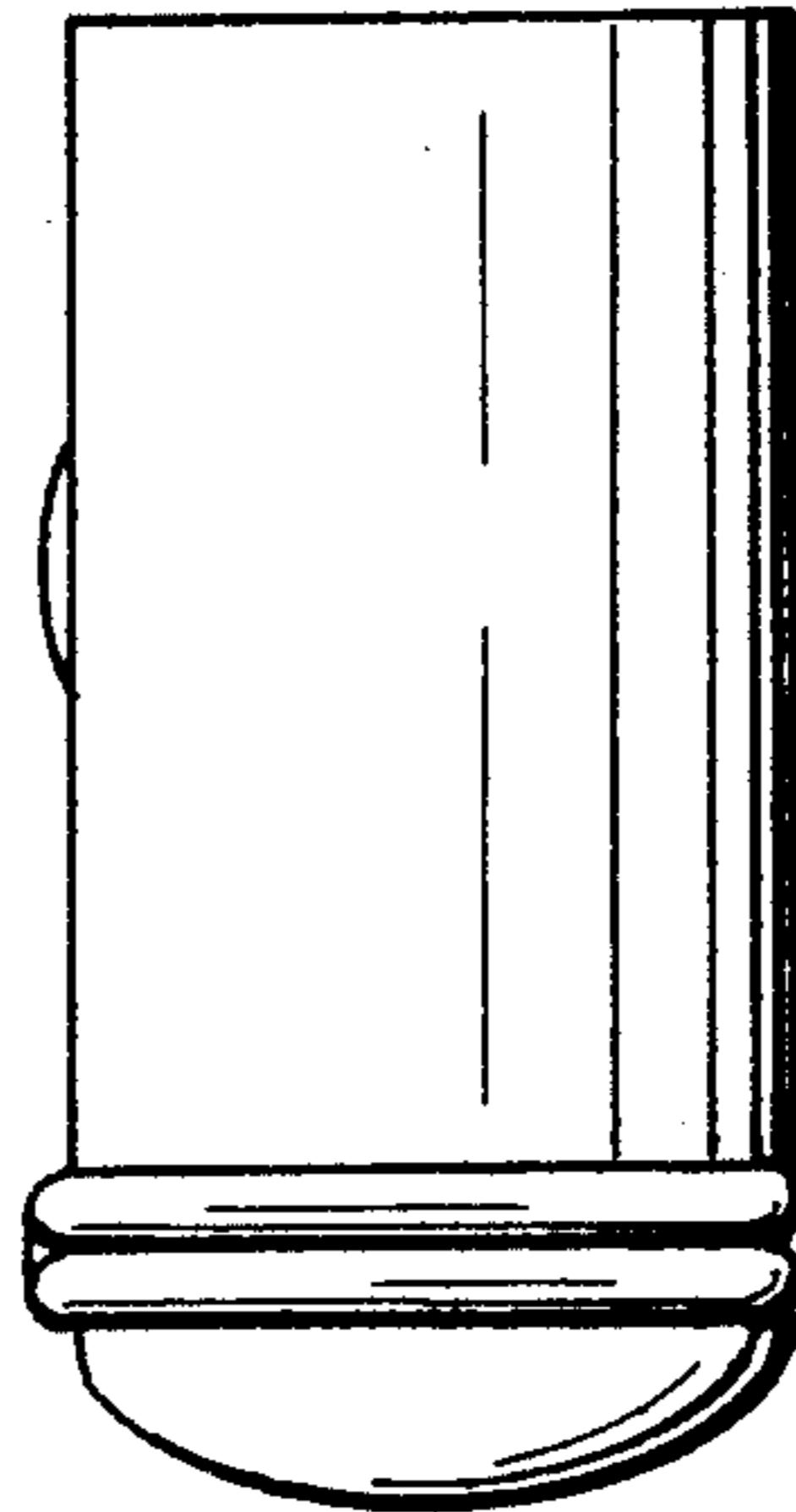

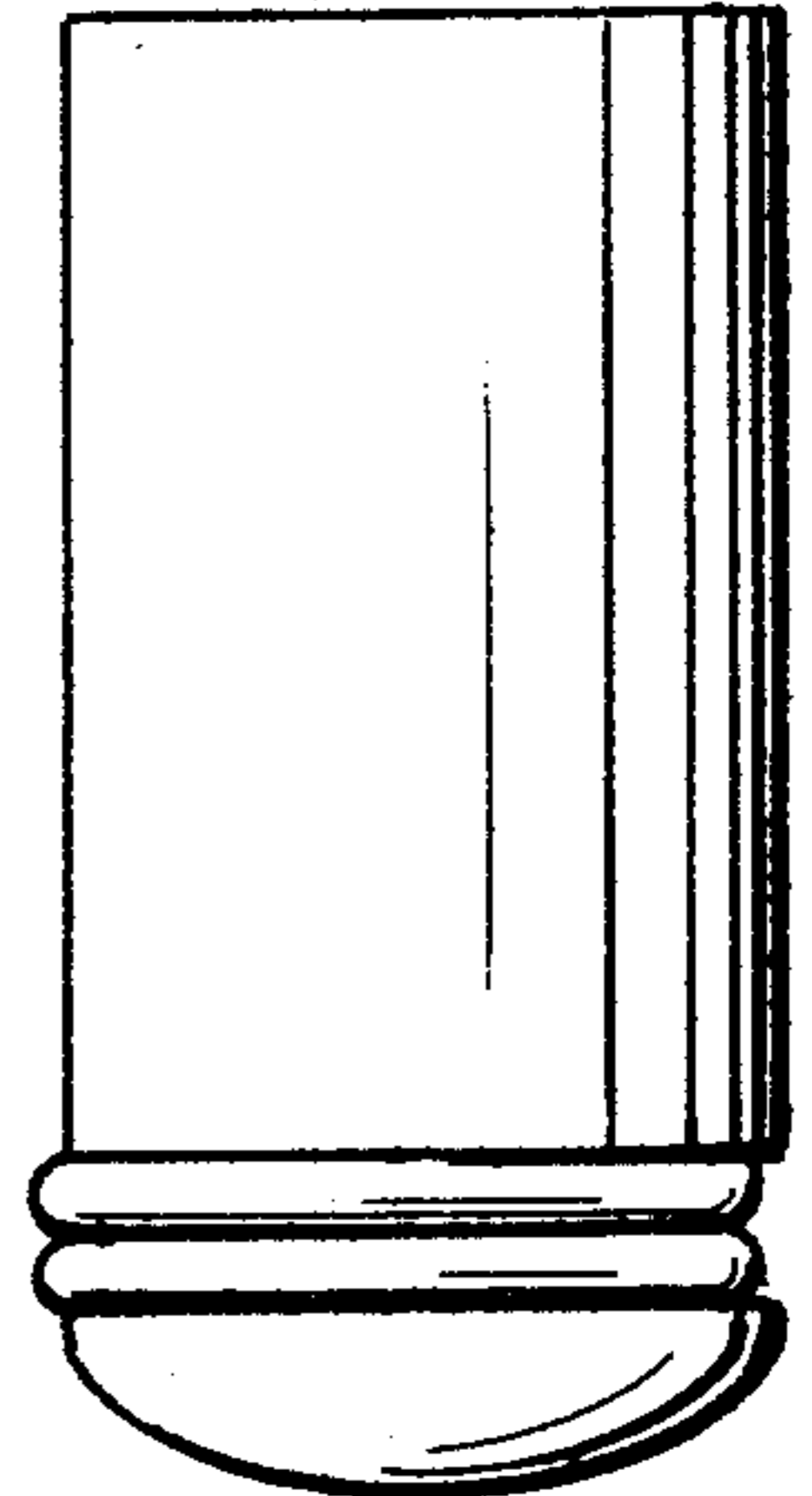

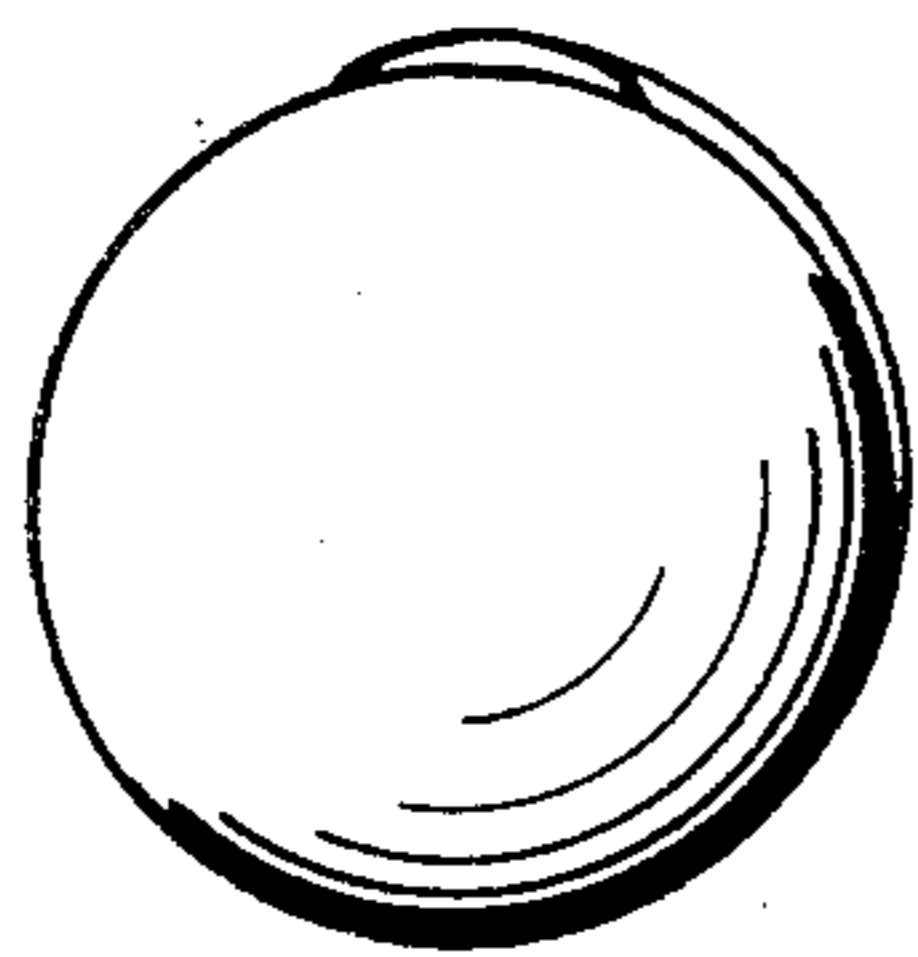

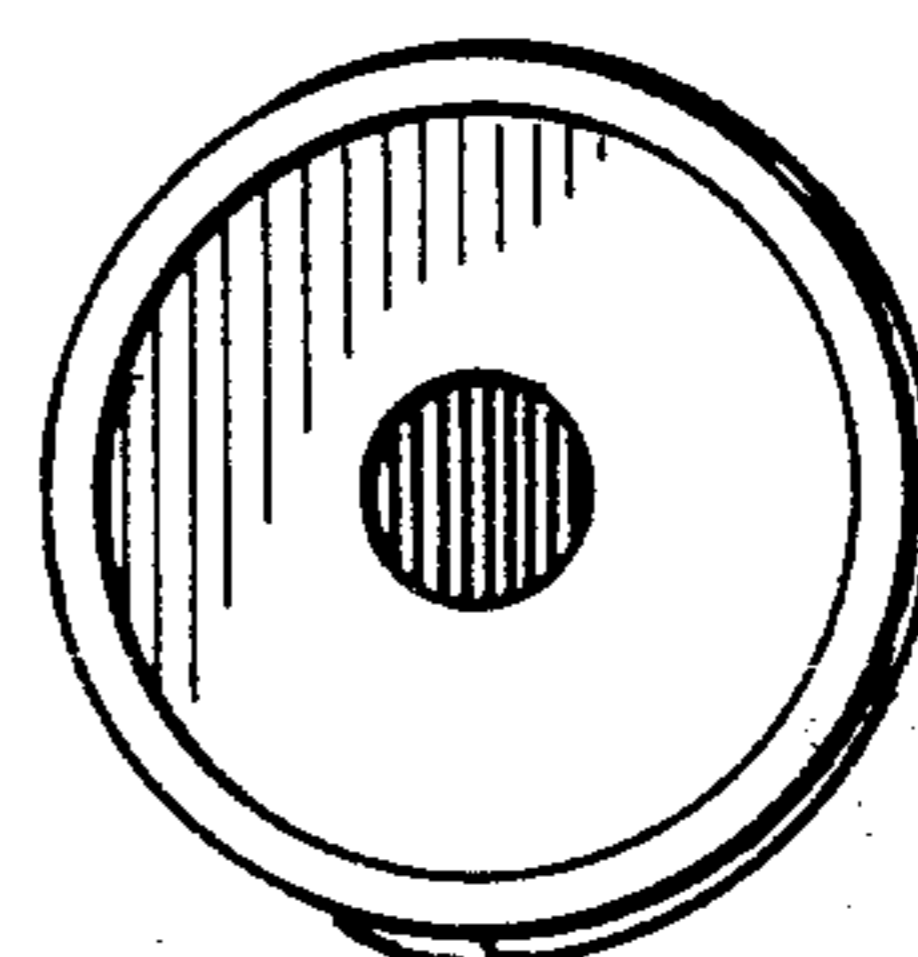

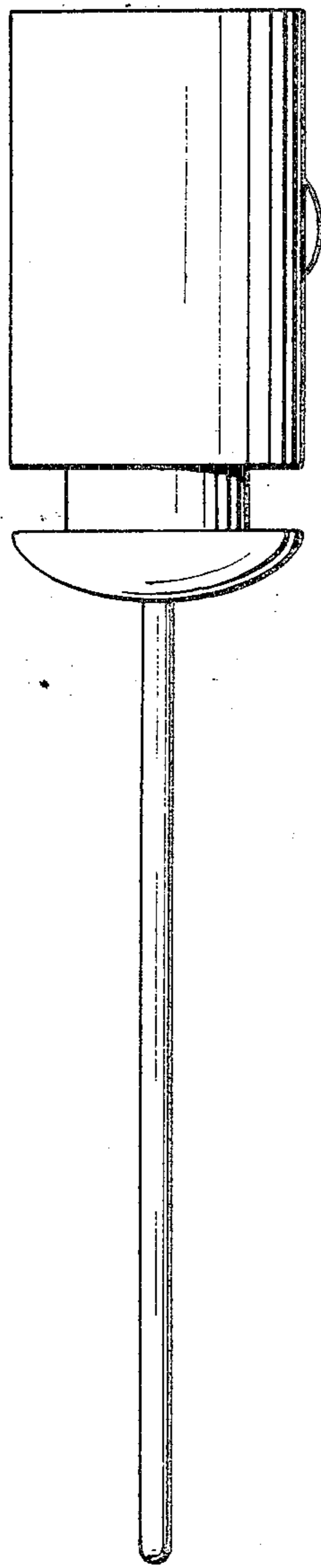

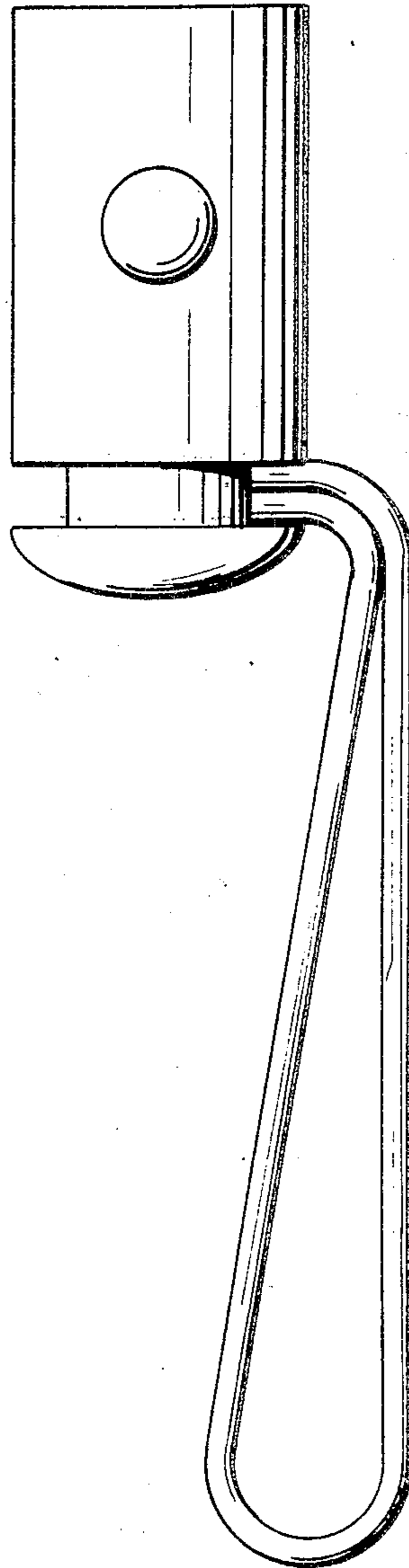

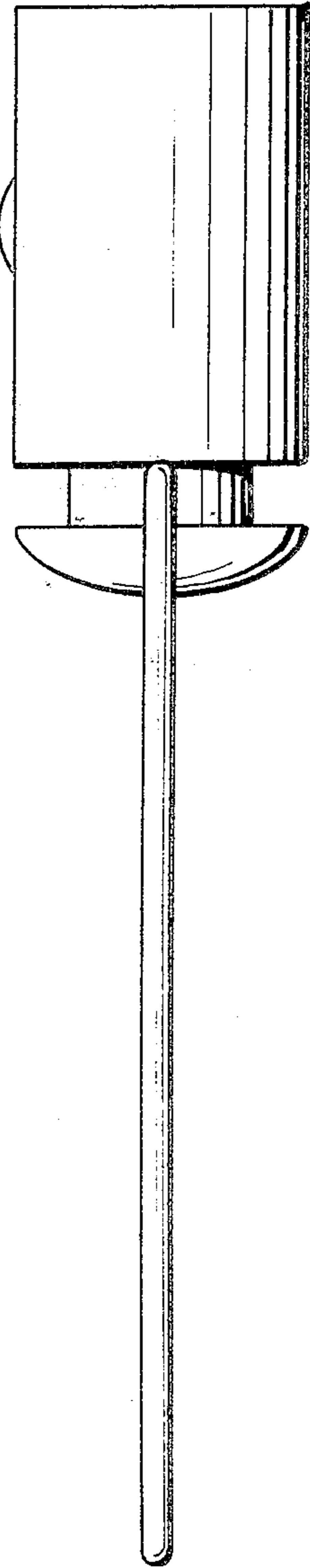

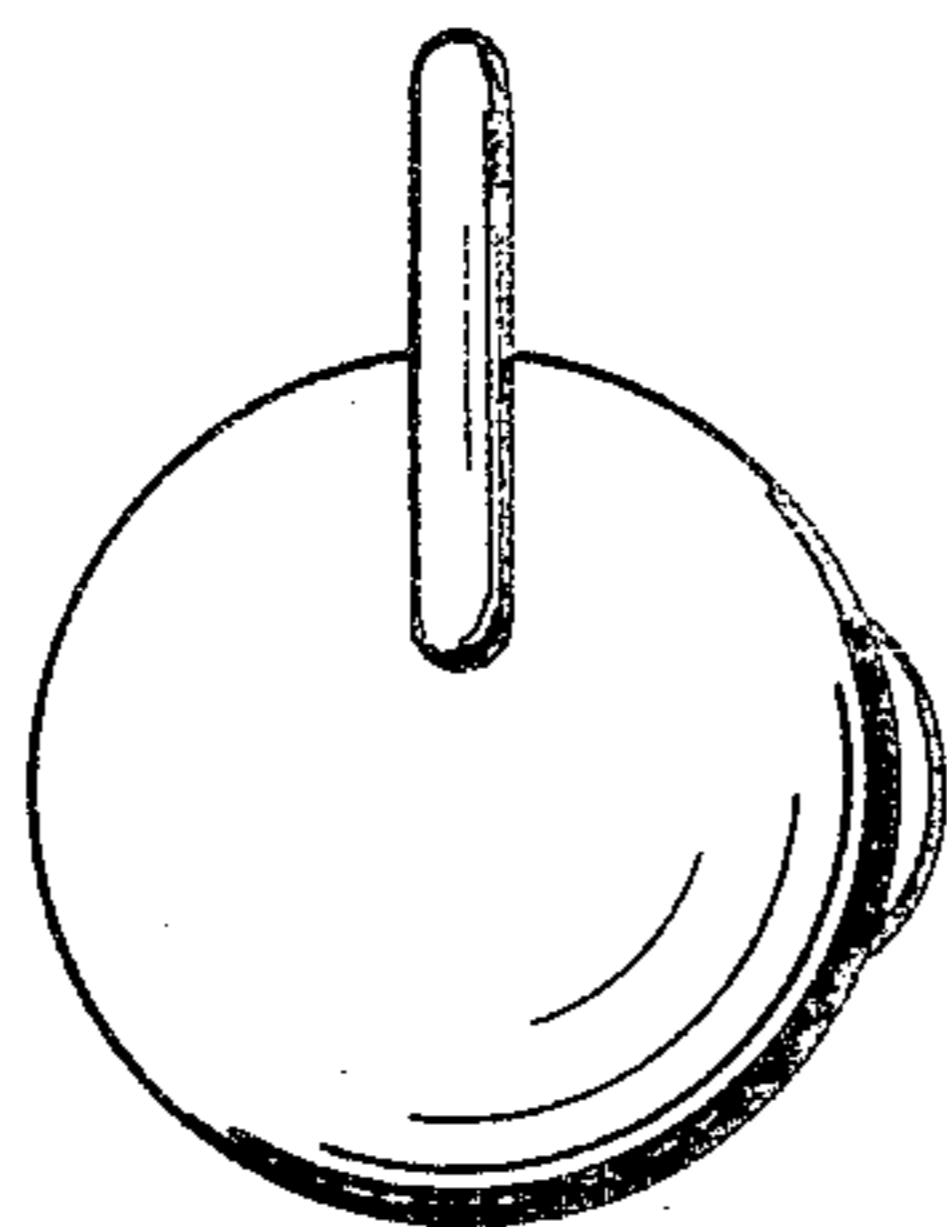

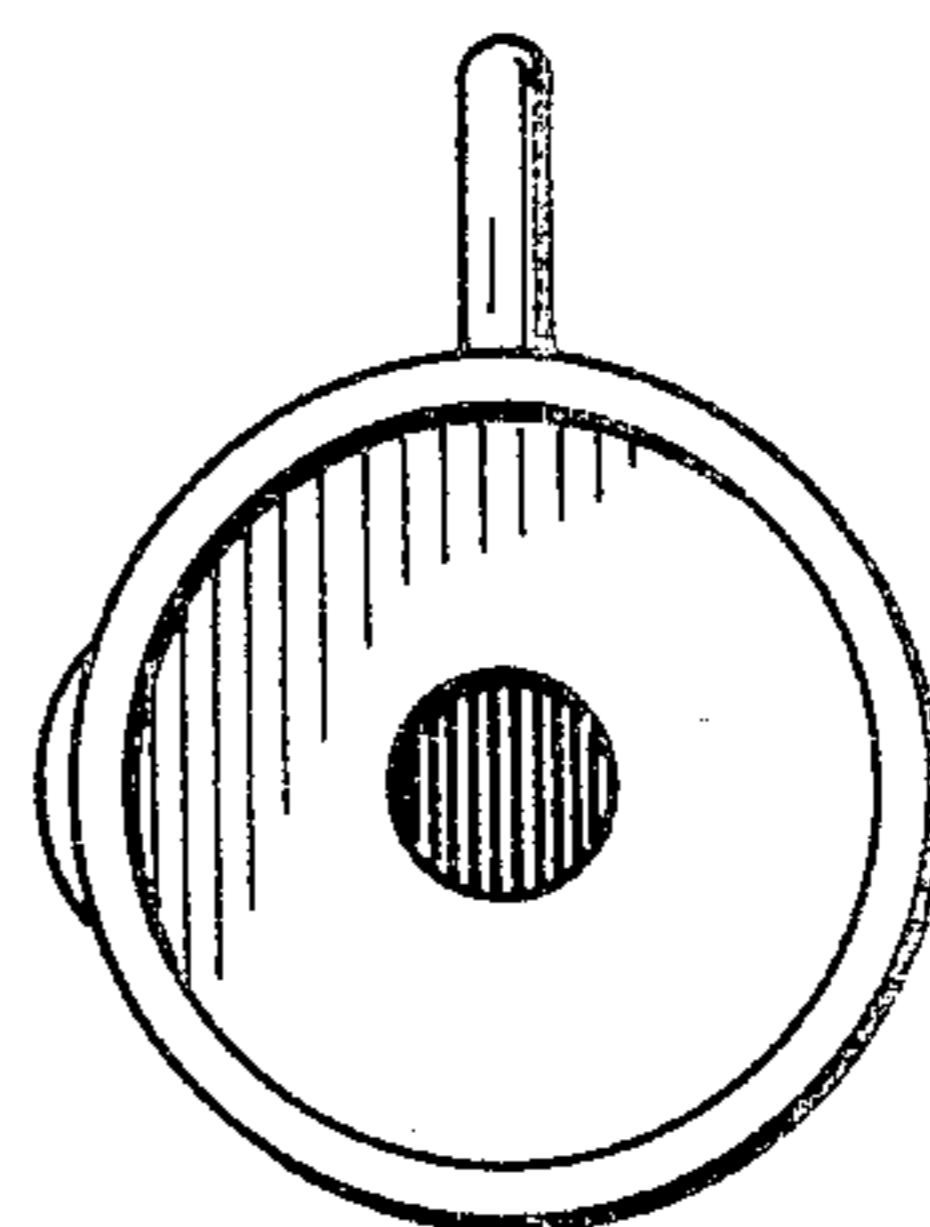
