CLAIM

[57] The ornamental design for a cassette storage cabinet, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a cassette storage cabinet showing my new design;  
 FIG. 2 is a top plan view thereof;  
 FIG. 3 is a right side elevational view thereof, the left side elevational view thereof being a mirror image;  
 FIG. 4 is a rear elevational view thereof;  
 FIG. 5 is a bottom plan view thereof;  
 FIG. 6 is a fragmentary perspective view of the right-hand corner of the cabinet;  
 FIG. 7 is a front elevational view of a modified form of the cassette storage cabinet shown in FIG. 1;  
 FIG. 8 is a top plan view thereof;  
 FIG. 9 is a right side elevational view thereof, the left side elevational view thereof being a mirror image;  
 FIG. 10 is a rear elevational view thereof; and  
 FIG. 11 is a bottom plan view thereof.

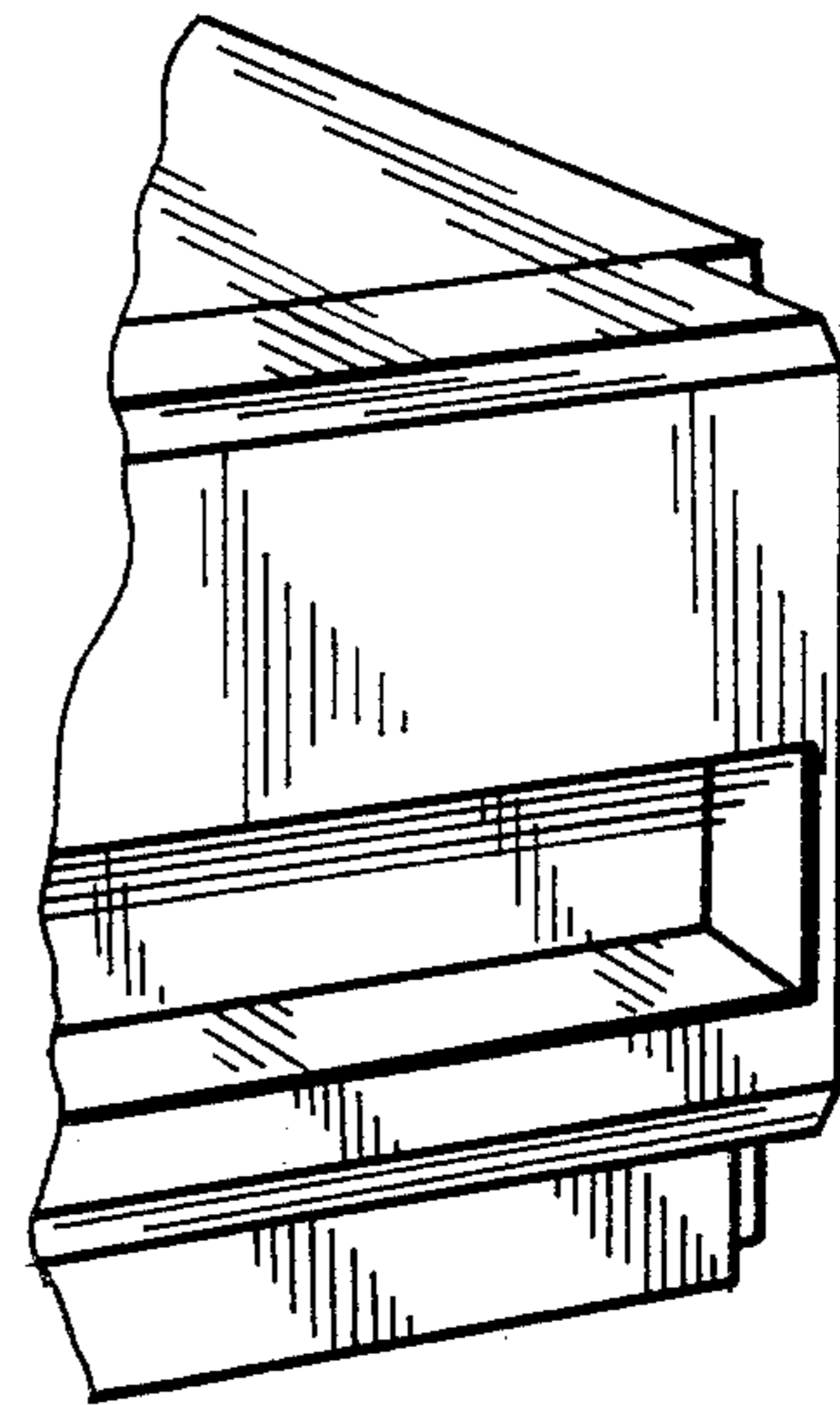
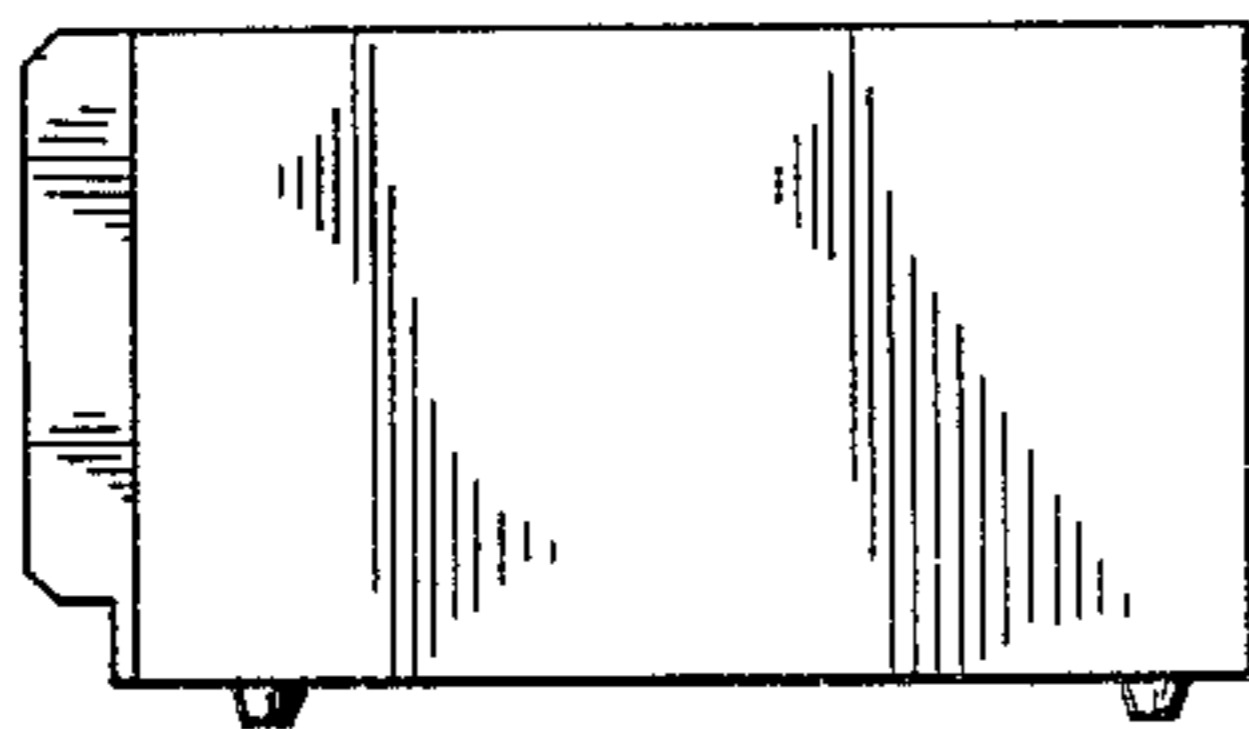
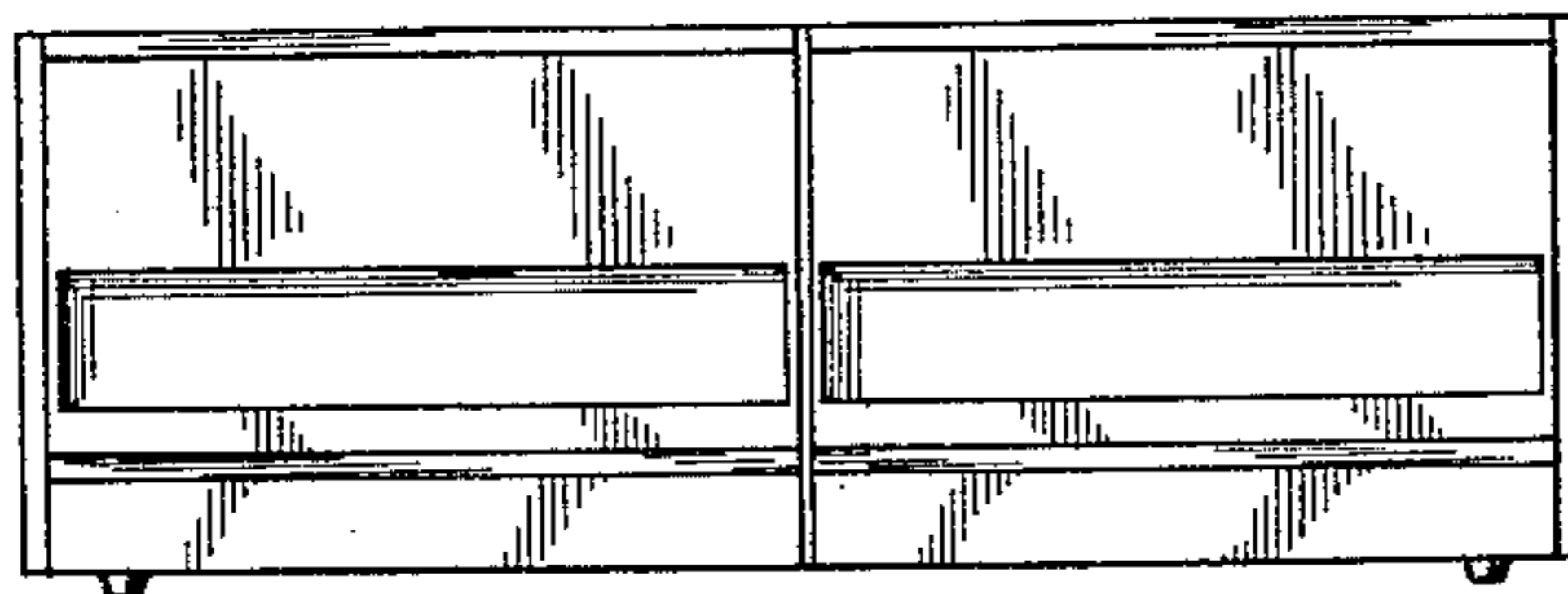

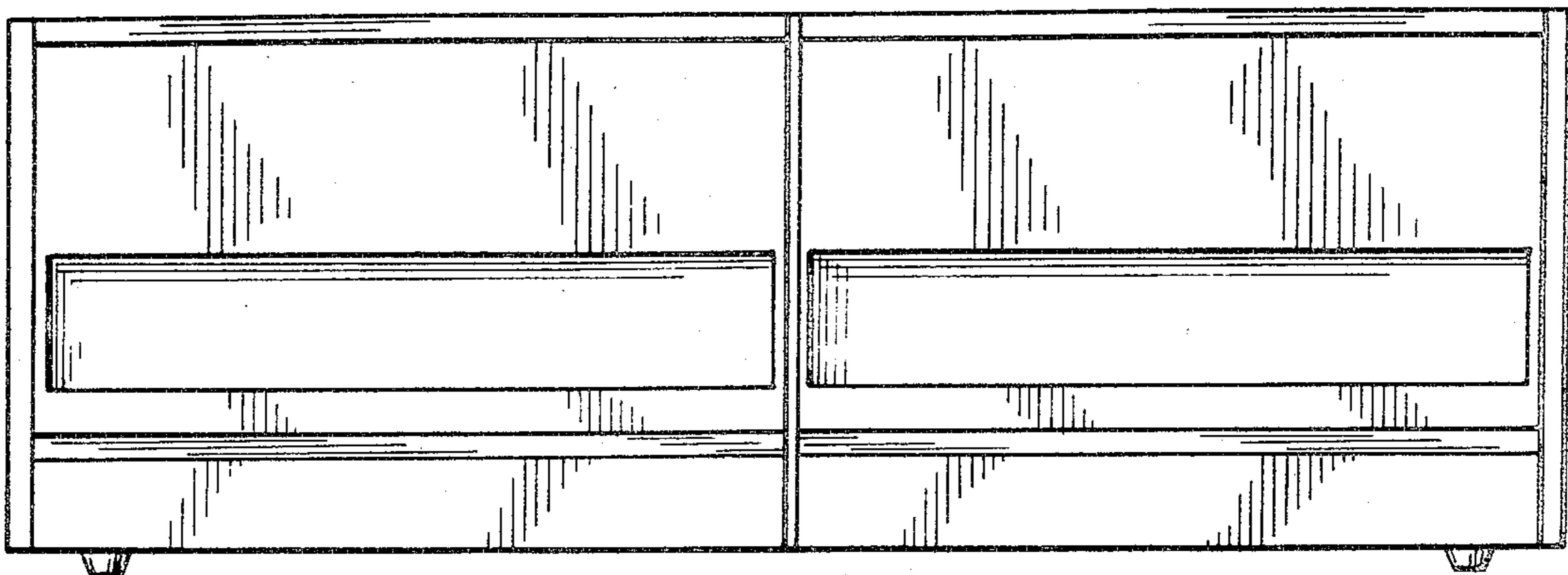

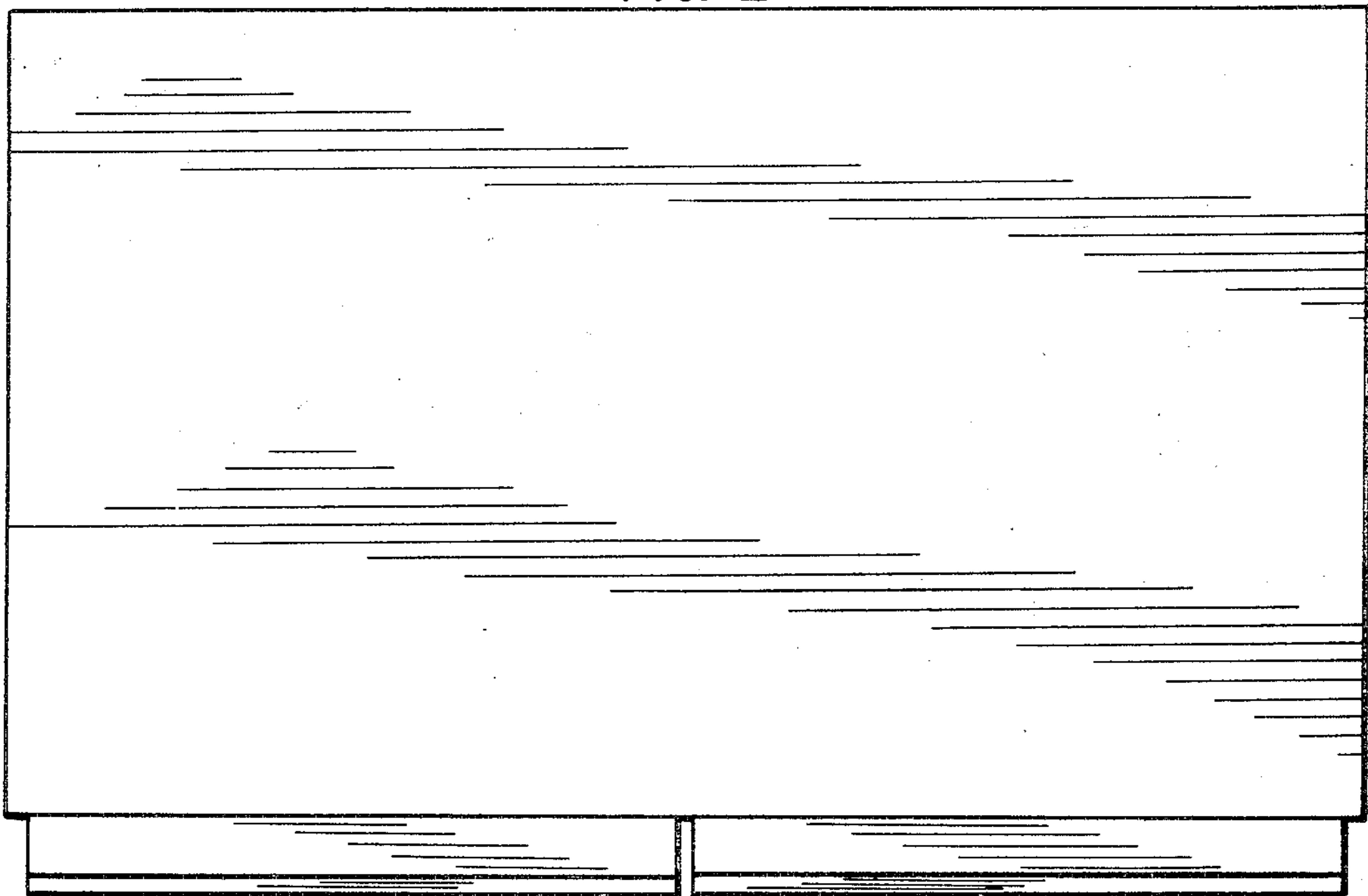

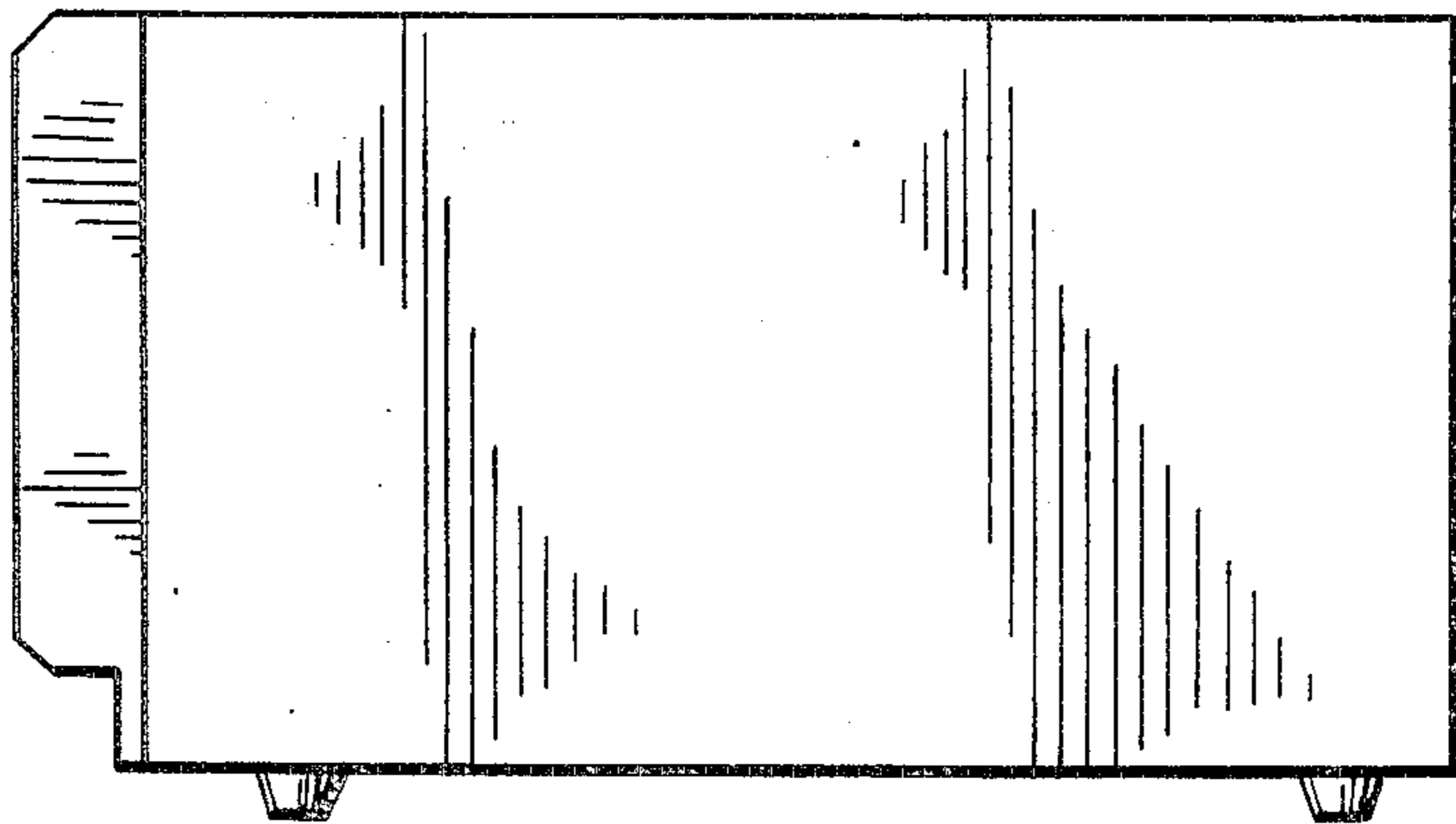

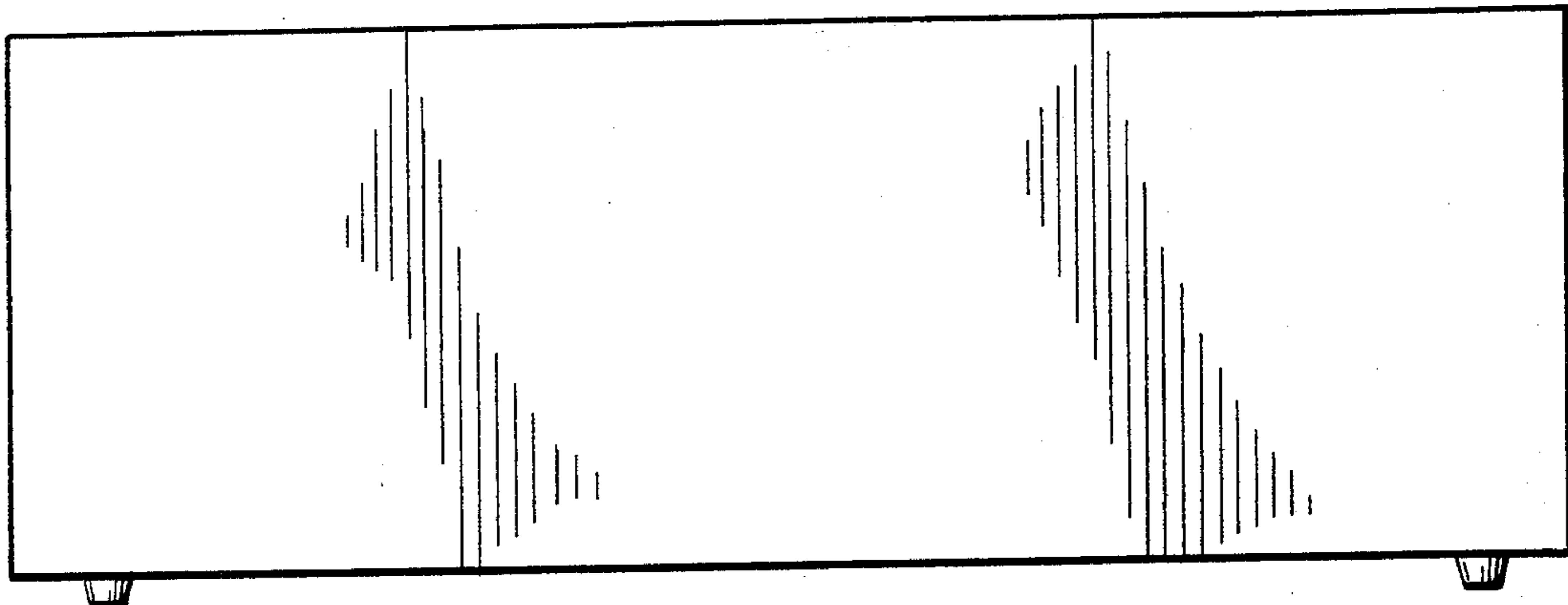

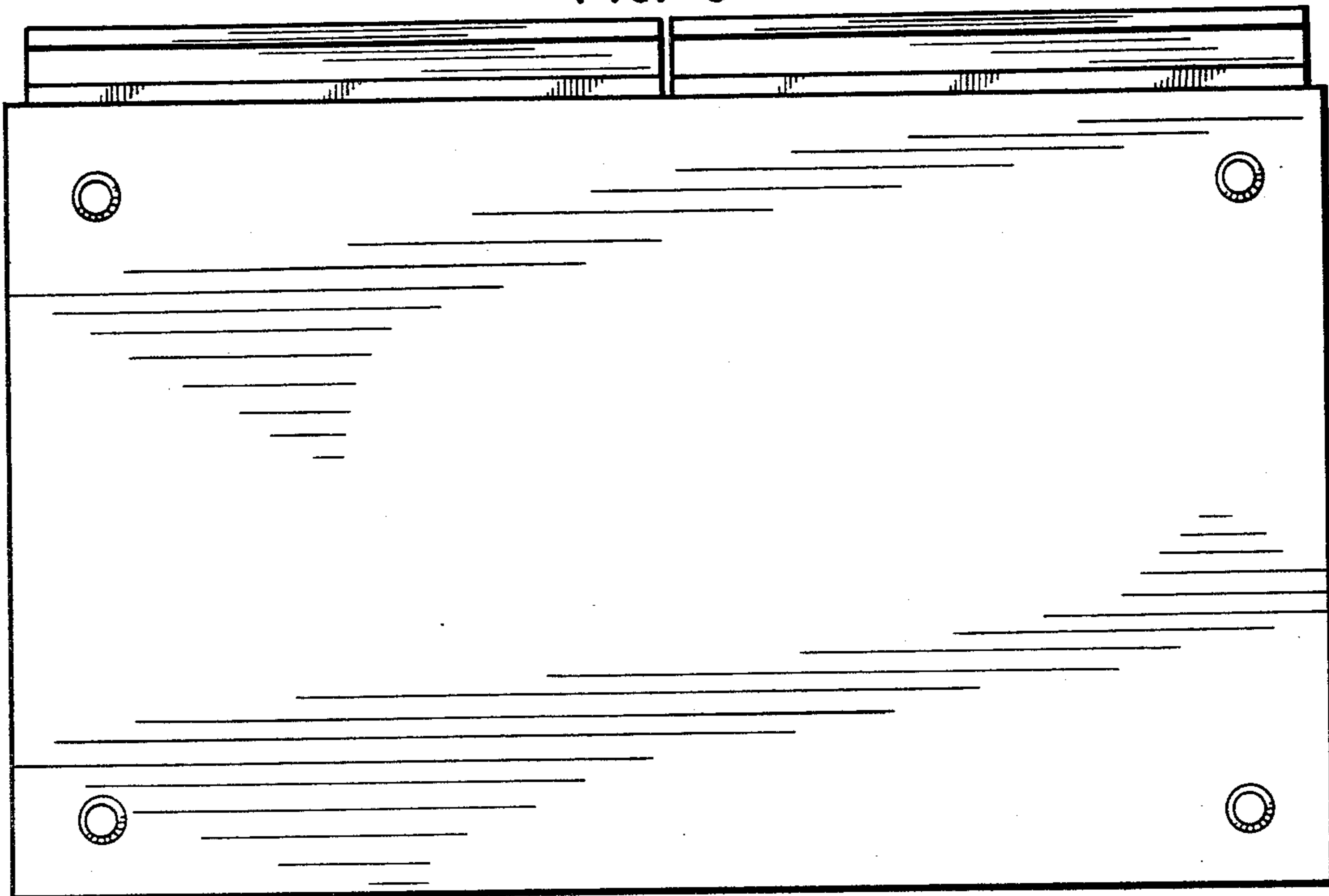

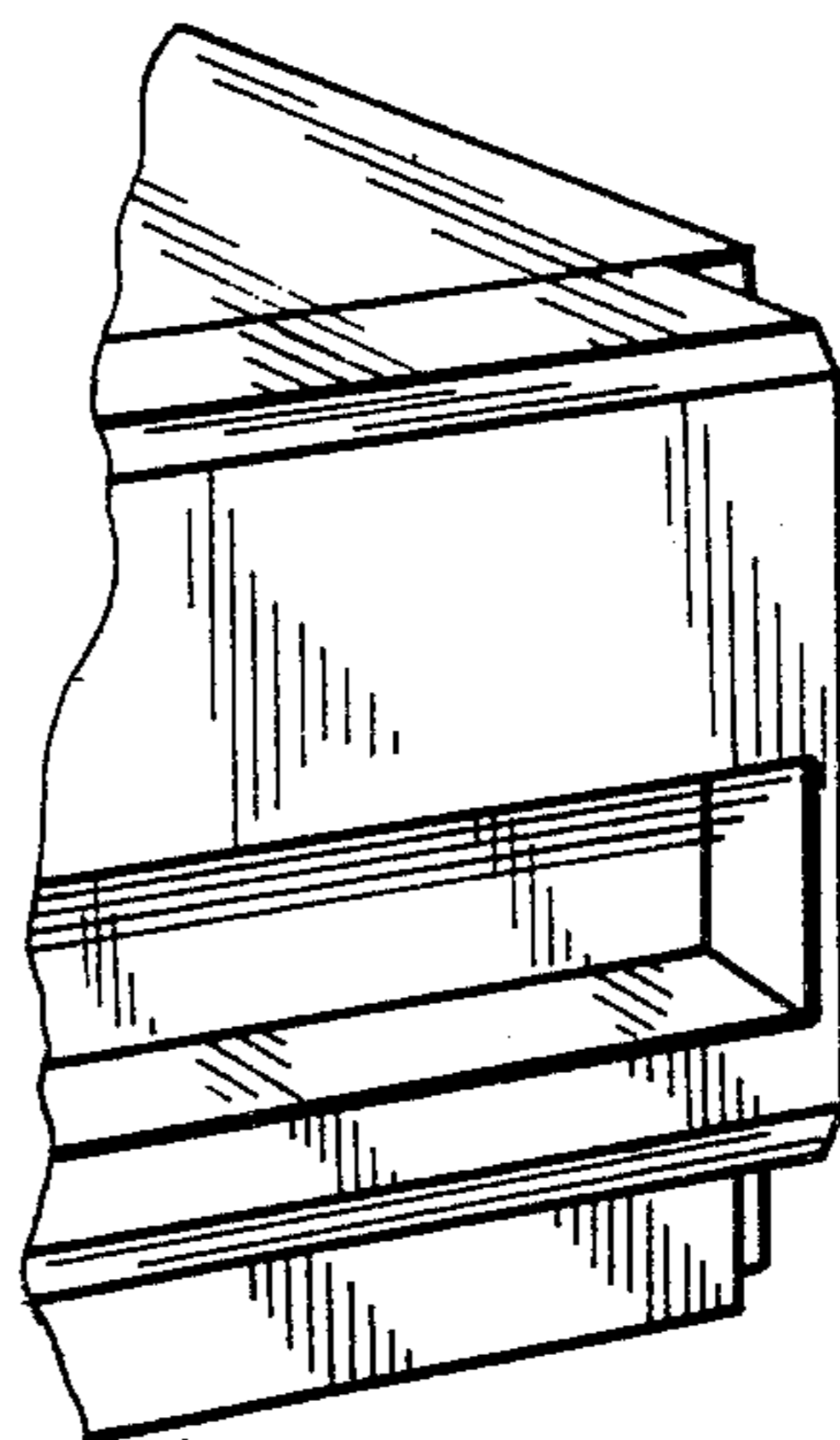

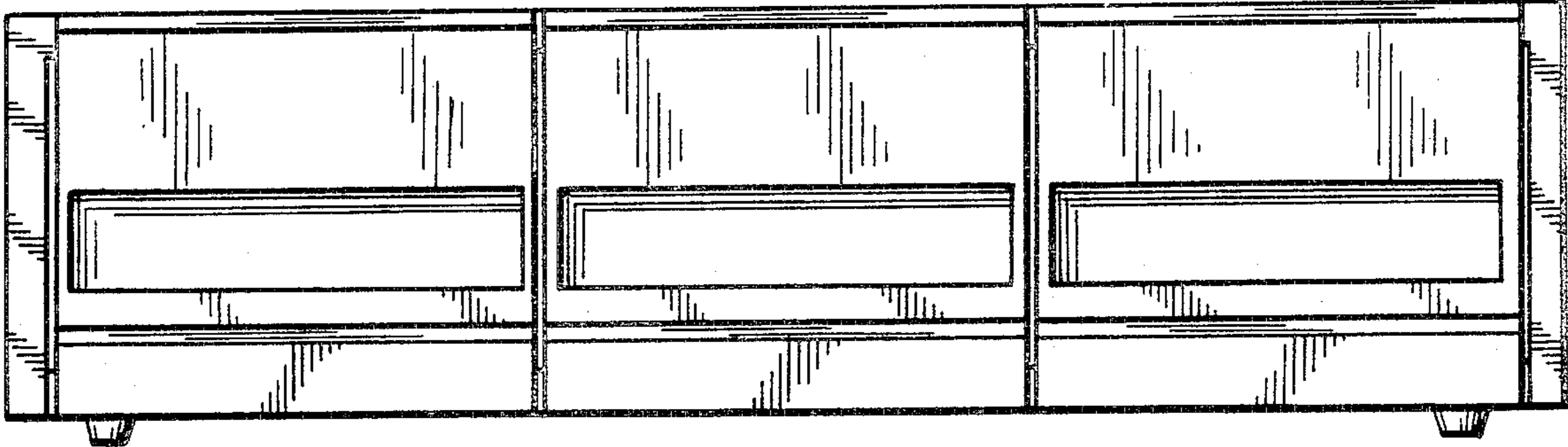

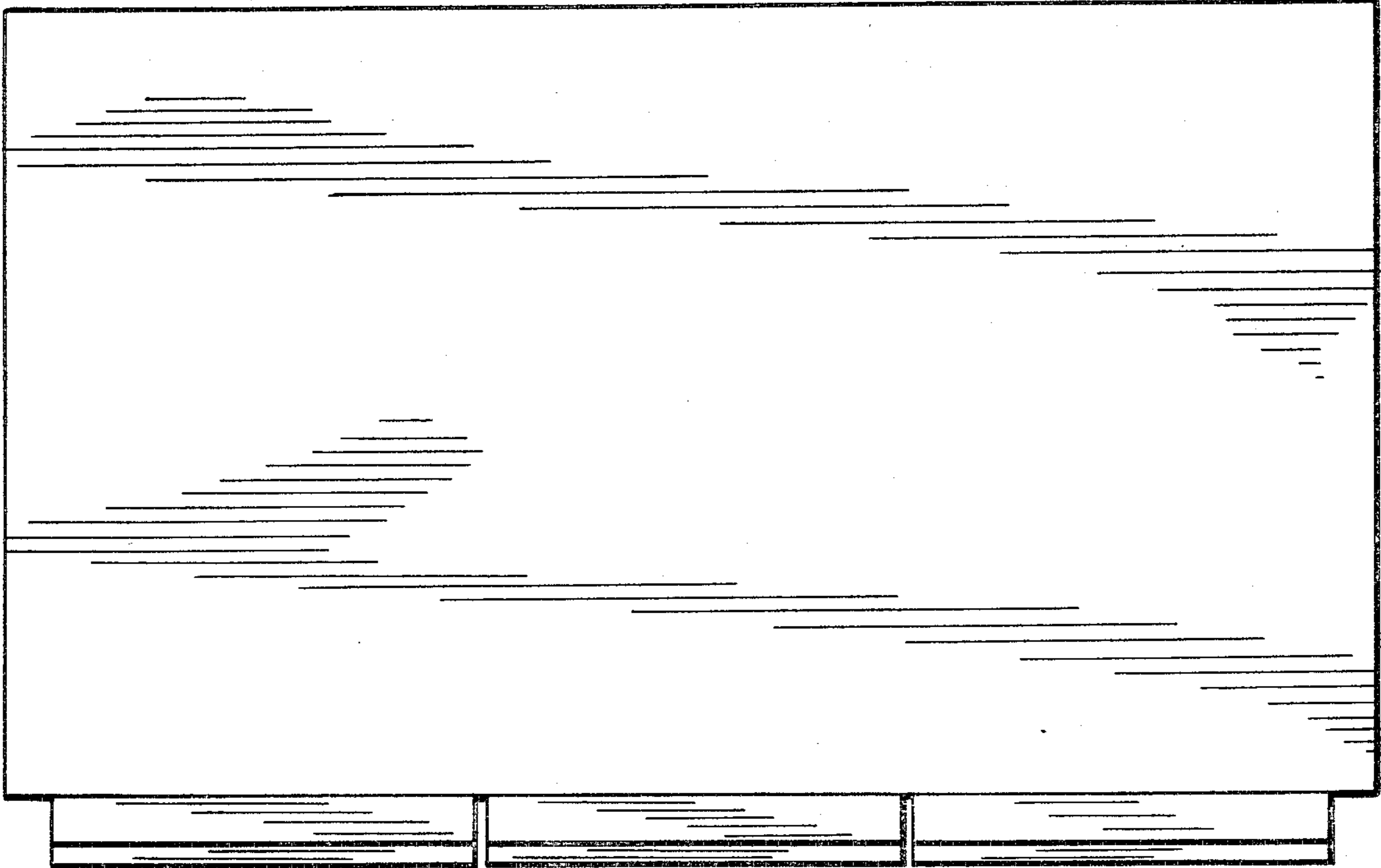
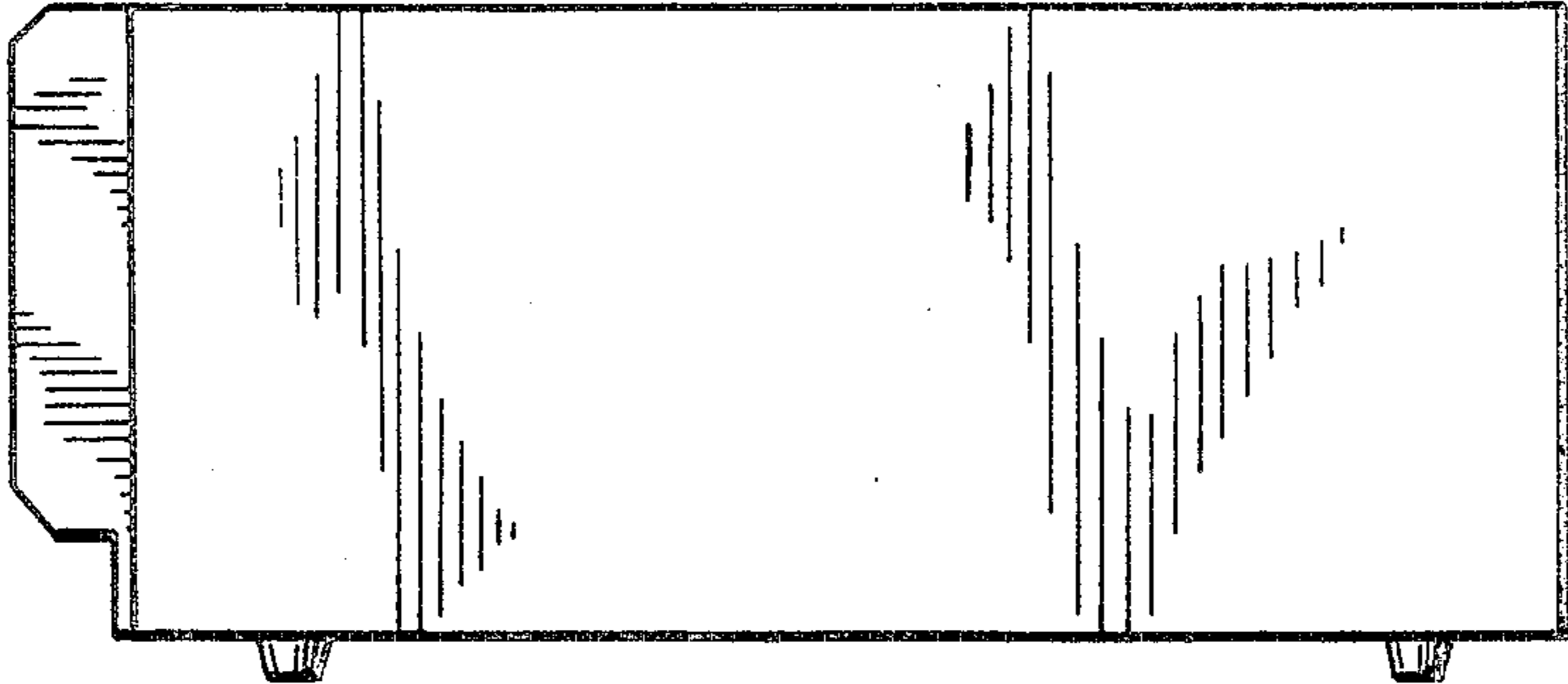

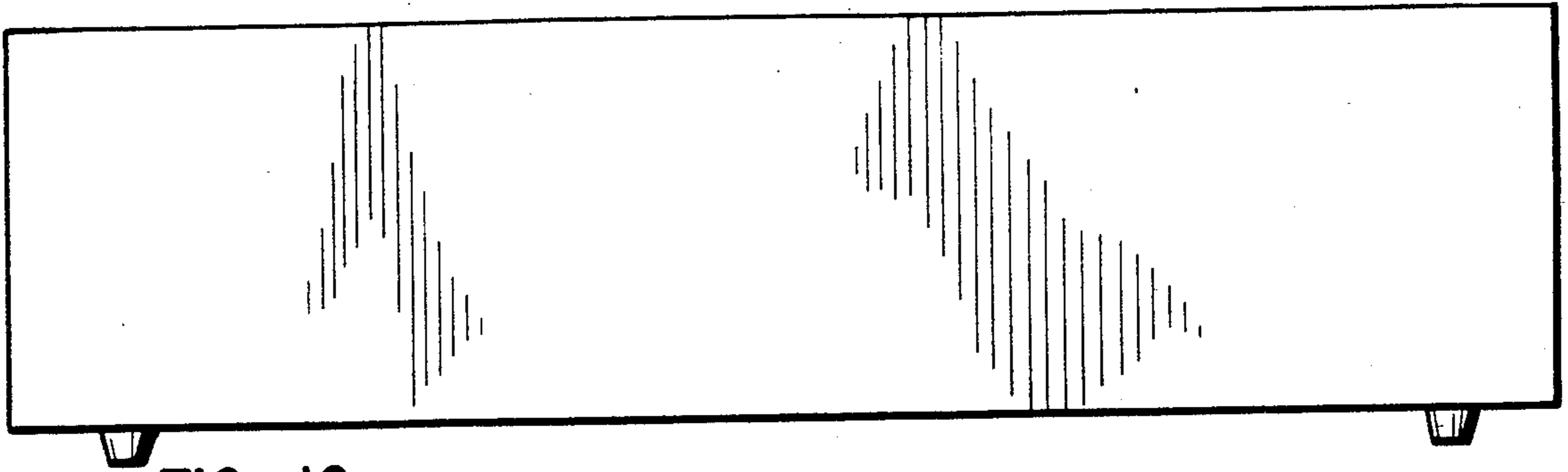

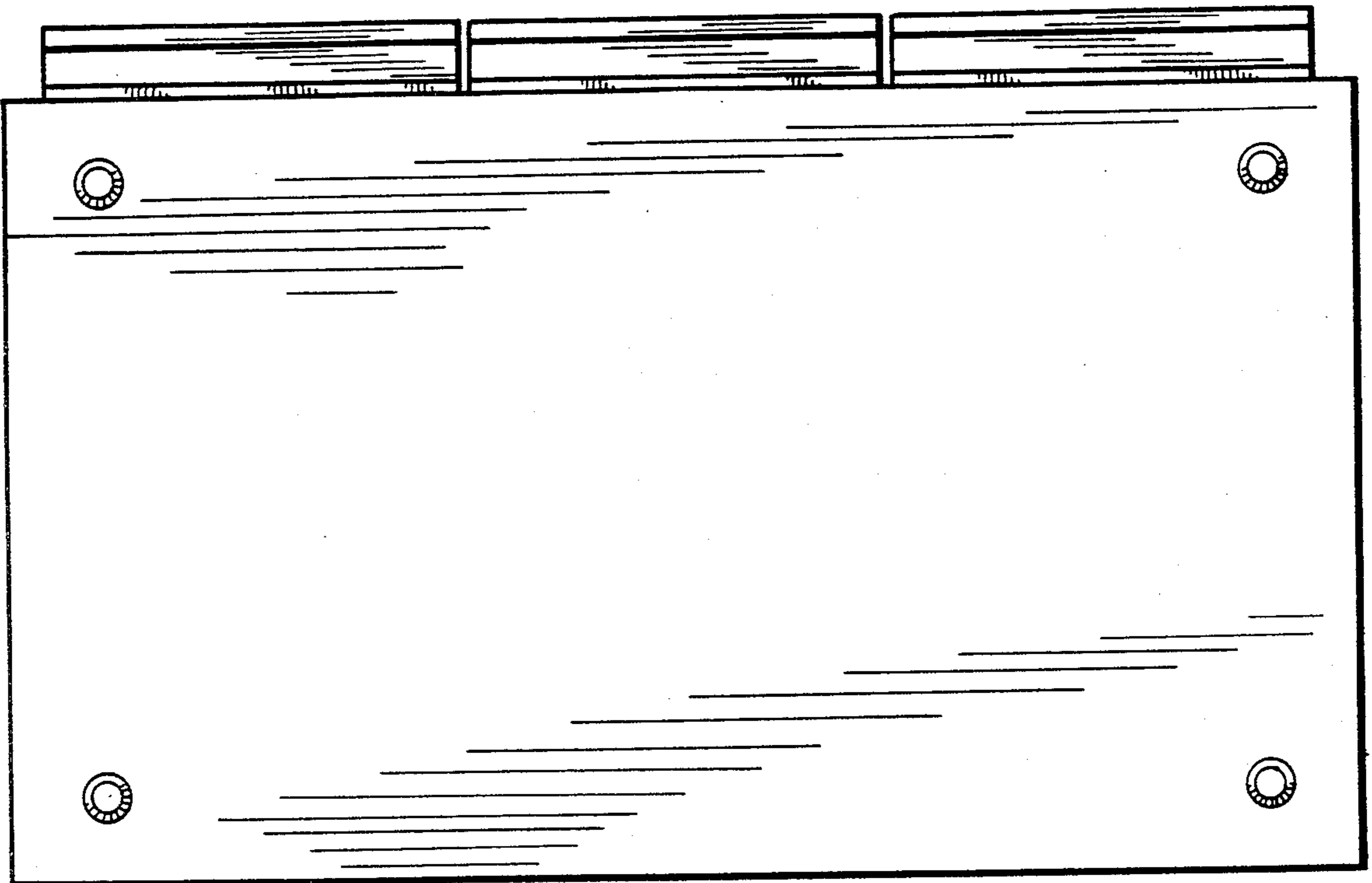
