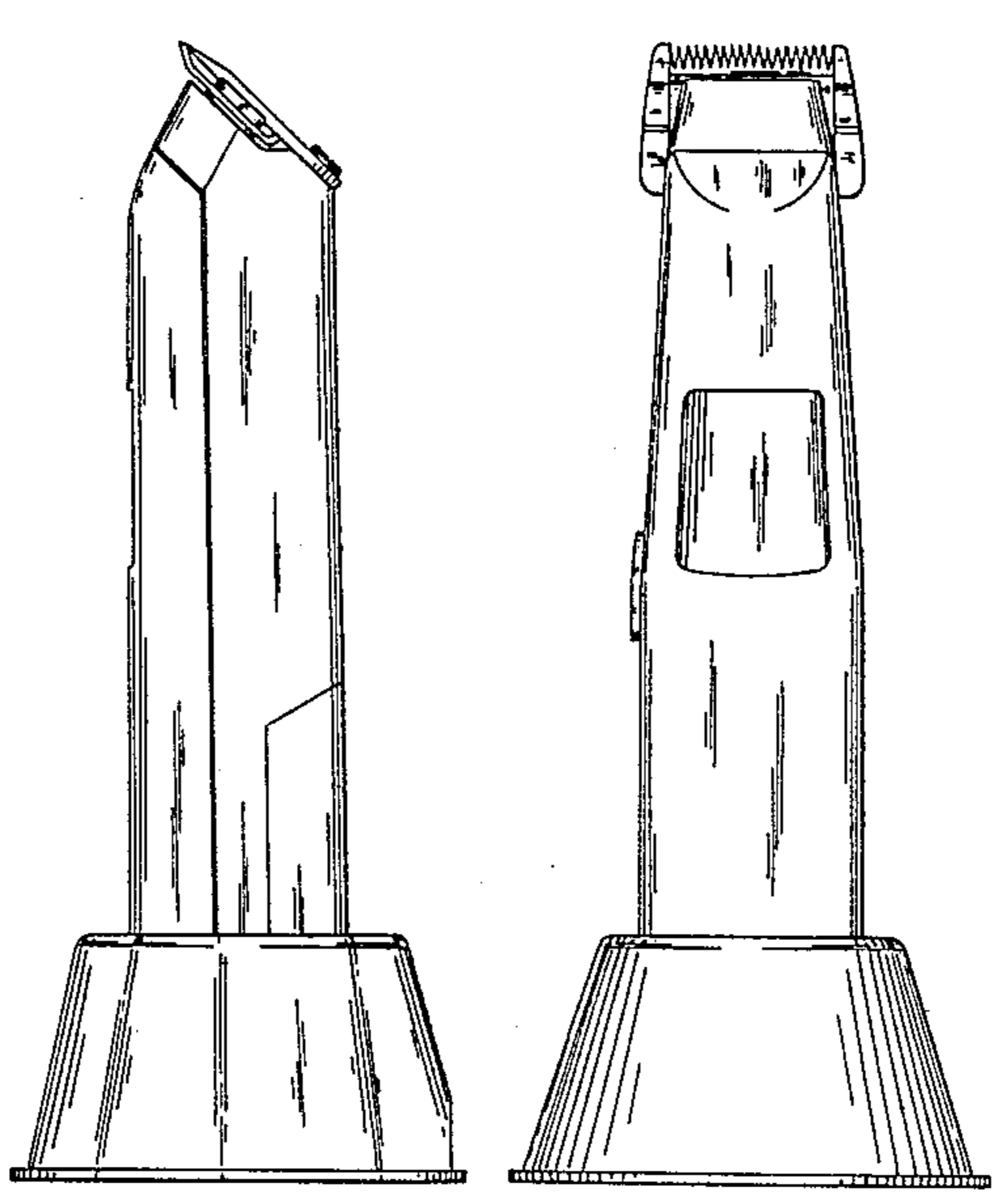

[57] CLAIM

The ornamental design for a combined electric hair trimmer and stand therefore, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a combined electric hair trimmer and stand therefor showing my new design;
FIG. 2 is a left side elevational view thereof;
FIG. 3 is a right side elevational view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a top plan view of the stand with trimmer removed for clarity of illustration;
FIG. 7 is a left side elevational view of the stand alone;
FIG. 8 is a right side elevational view of the stand alone;
FIG. 9 is a rear elevational view of the stand alone;
FIG. 10 is a front elevational view of the trimmer with stand removed for clarity of illustration;
FIG. 11 is a left side elevational view of the trimmer alone;
FIG. 12 is a right side elevational view of the trimmer alone;
FIG. 13 is a top plan view of the trimmer alone; and
FIG. 14 is a bottom plan view of the trimmer alone.



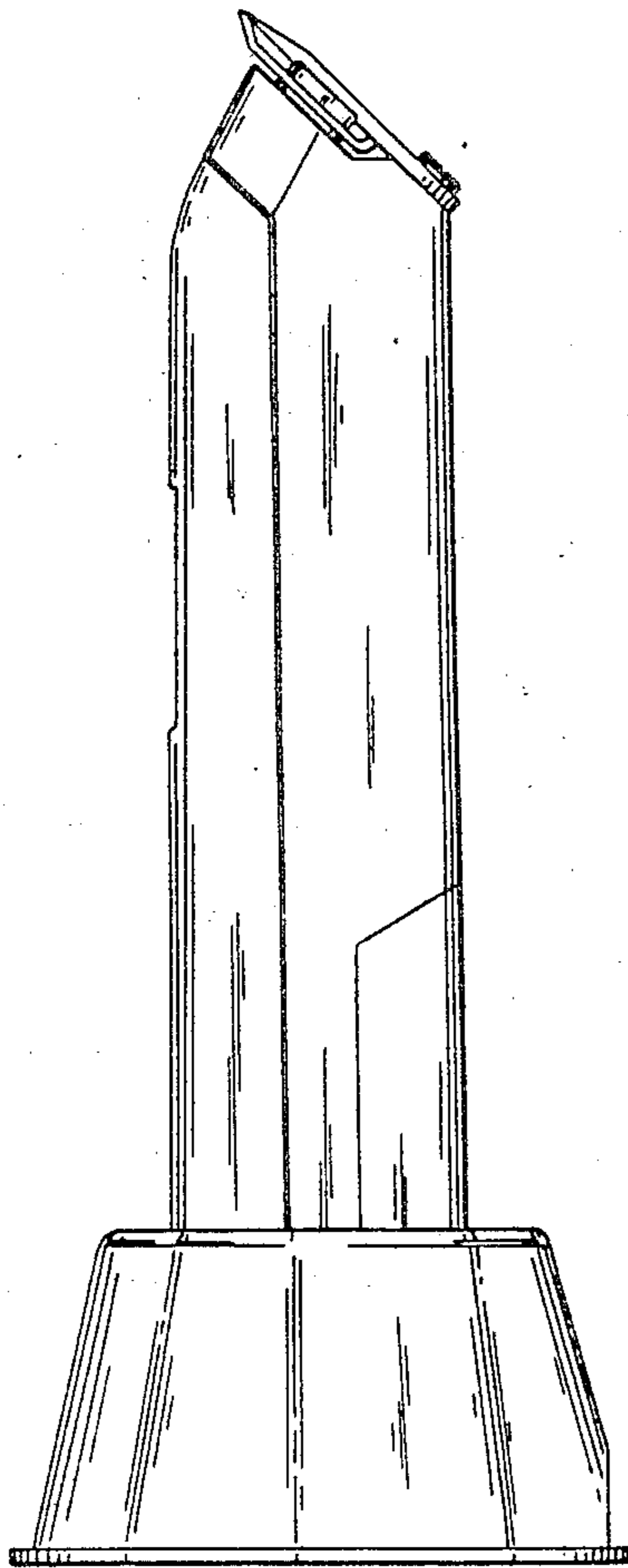

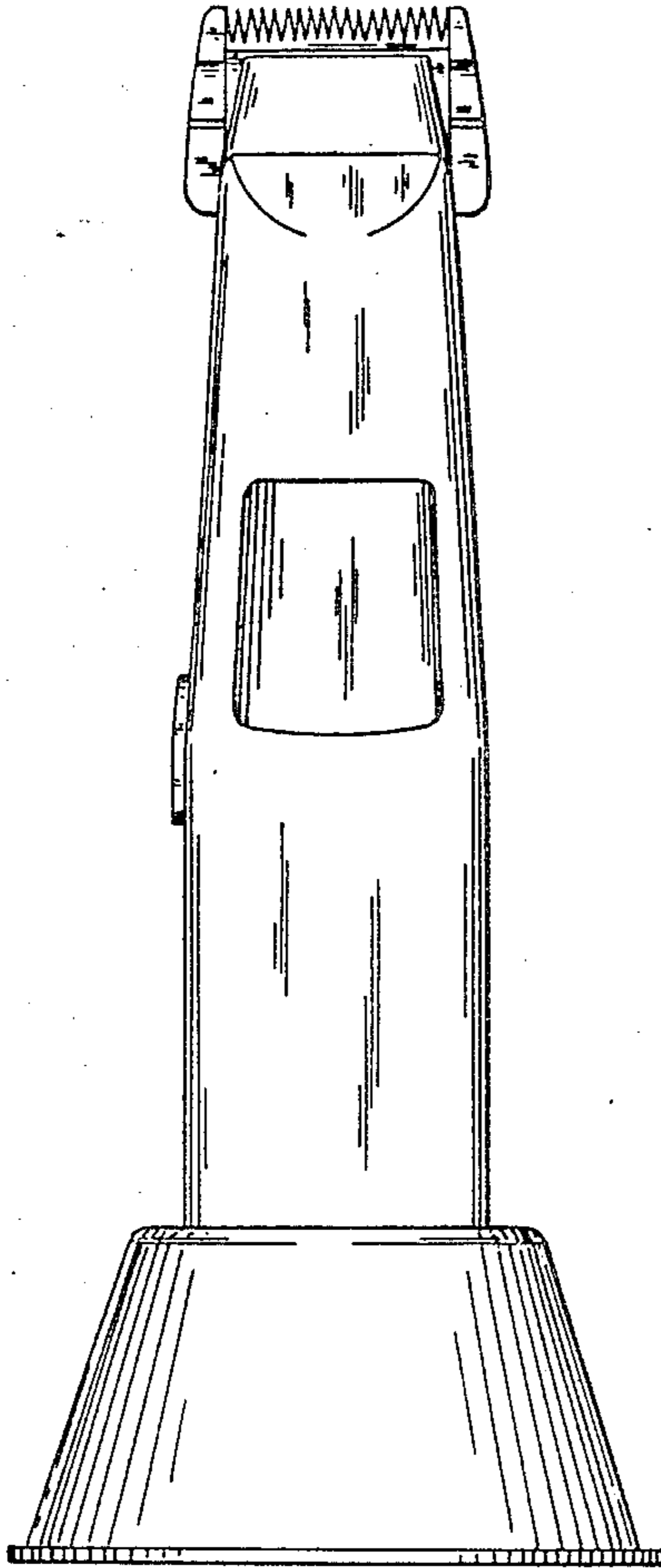

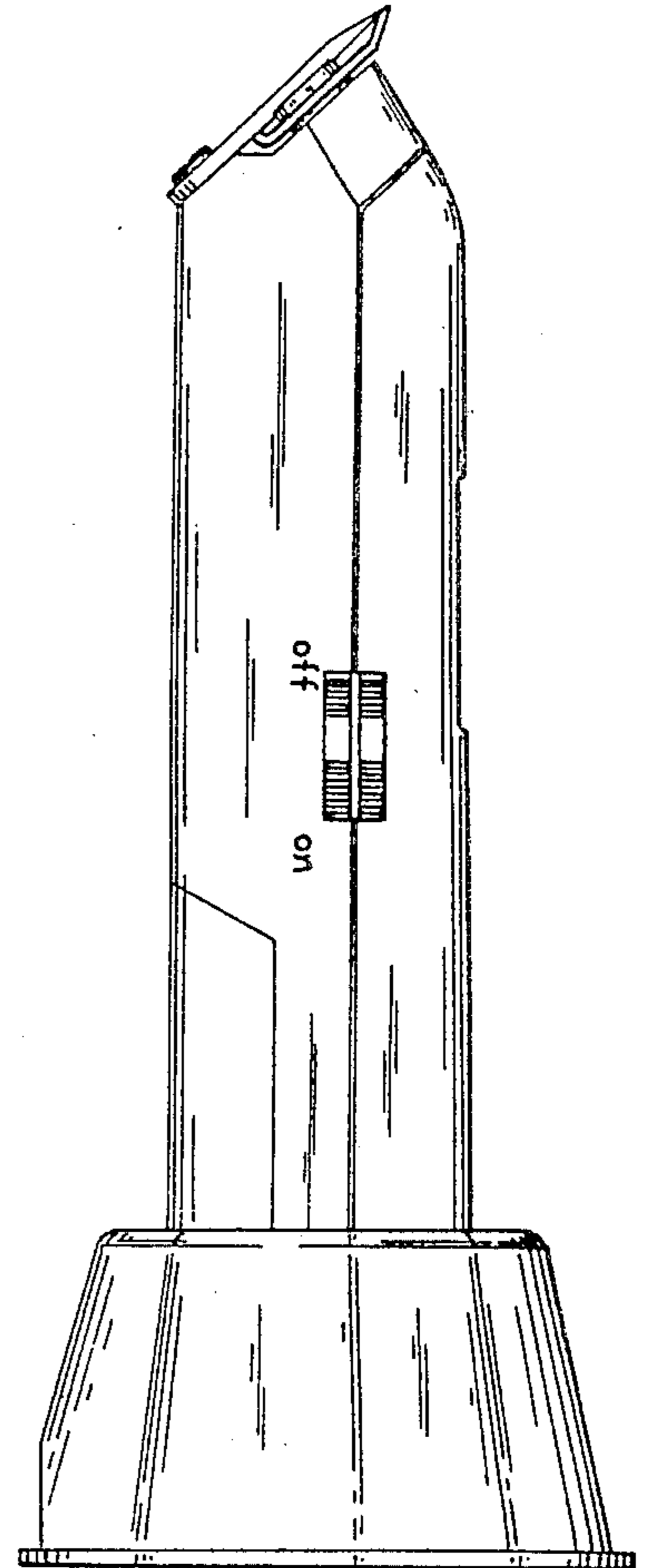

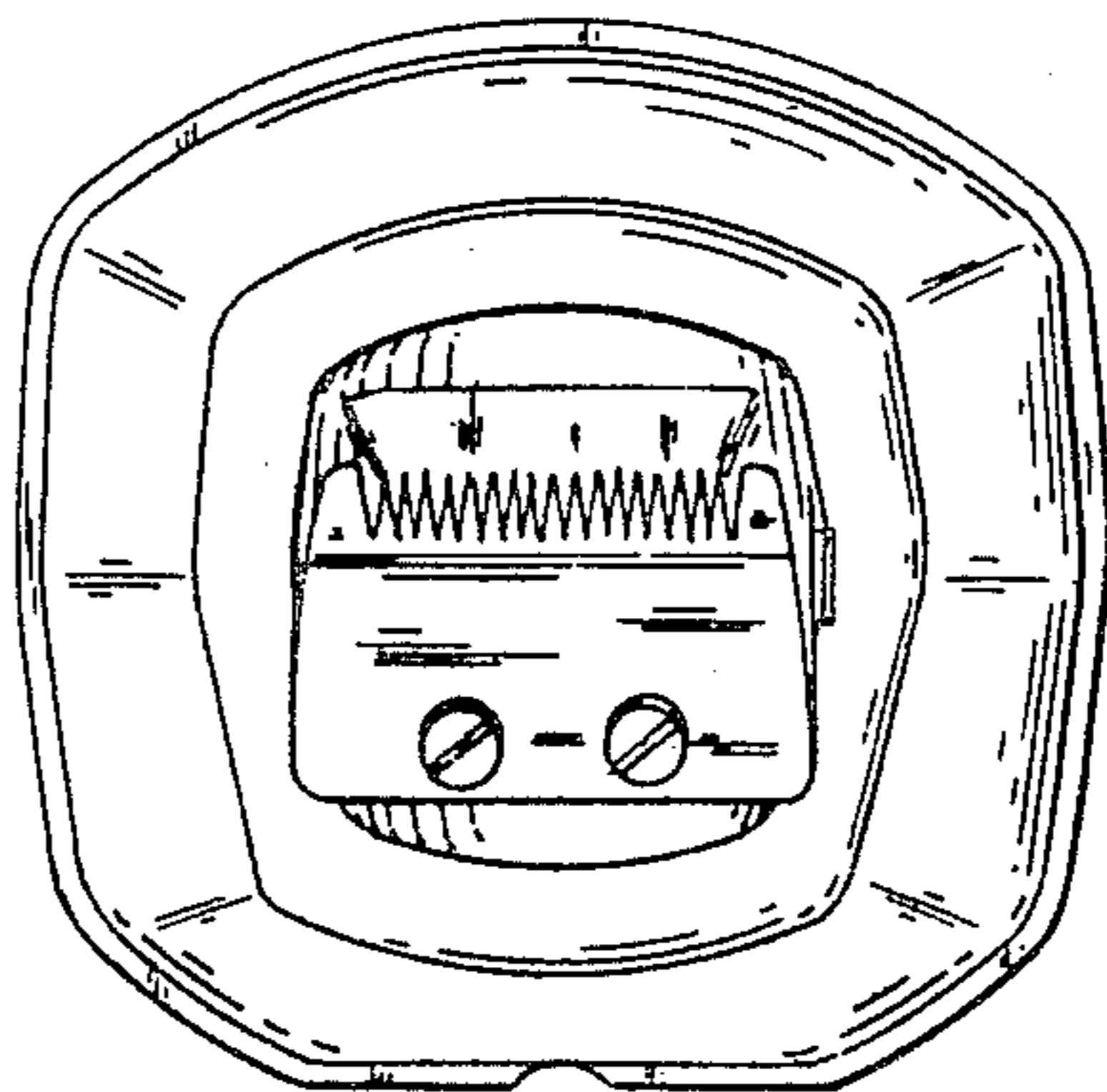

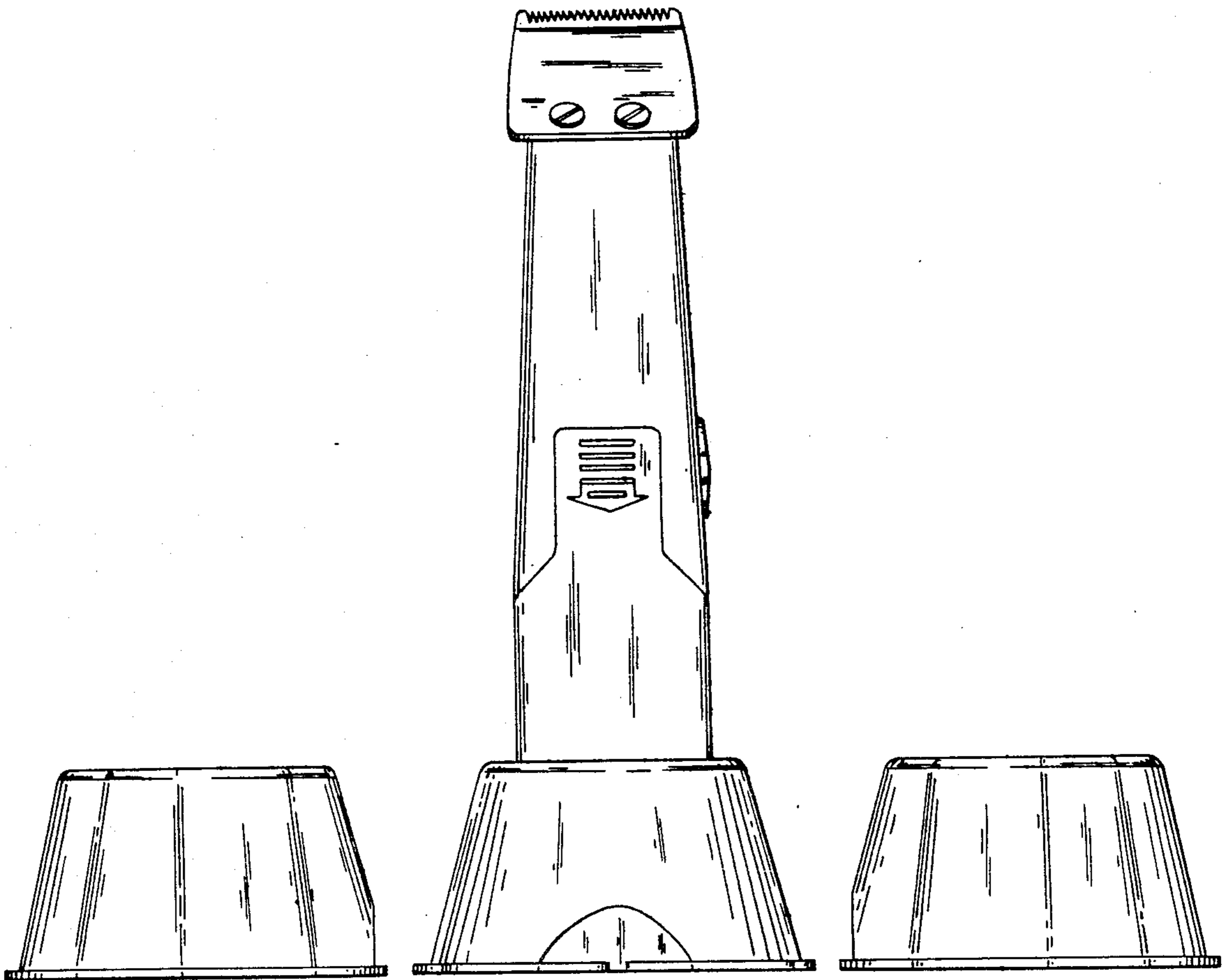

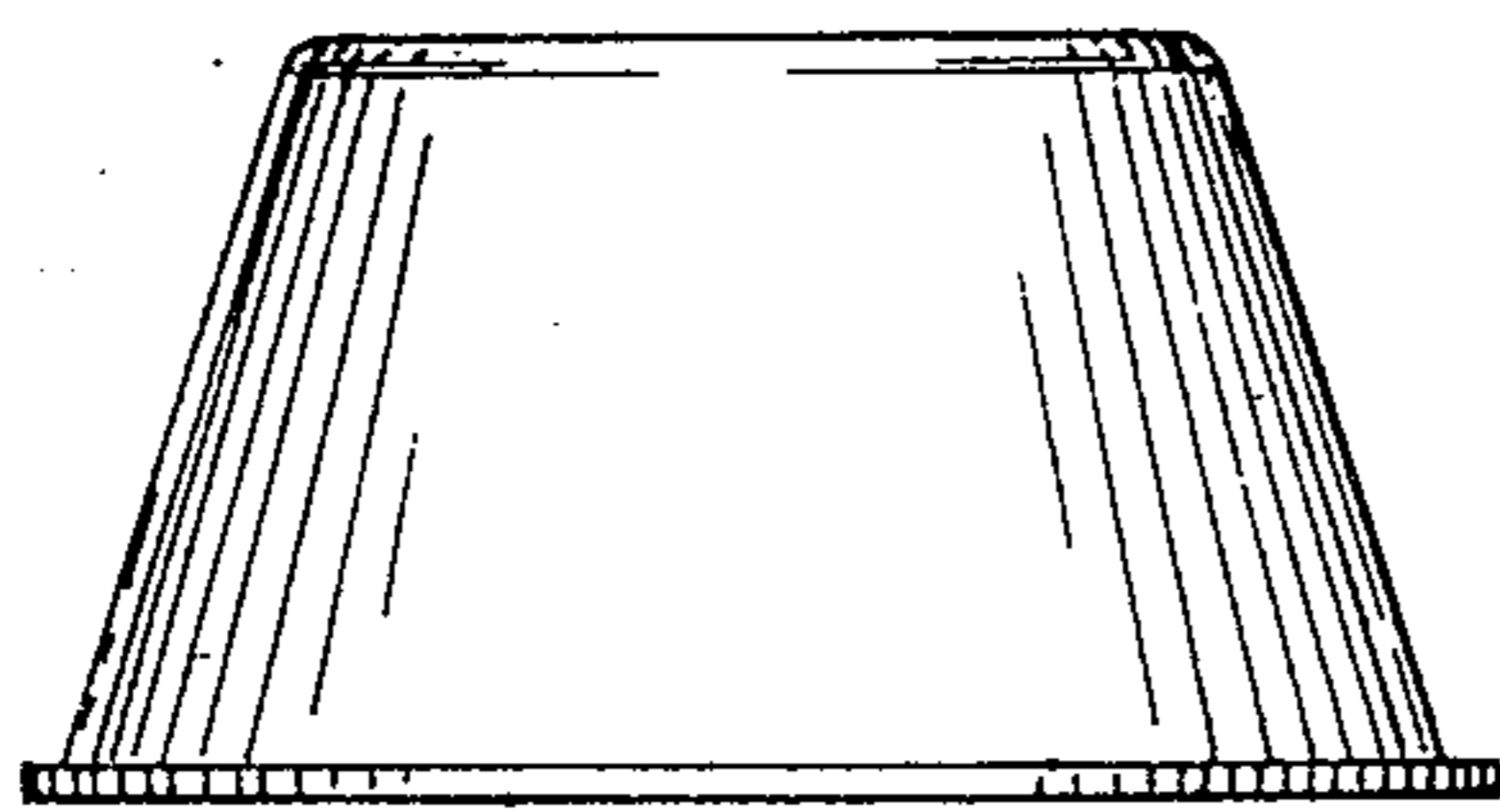

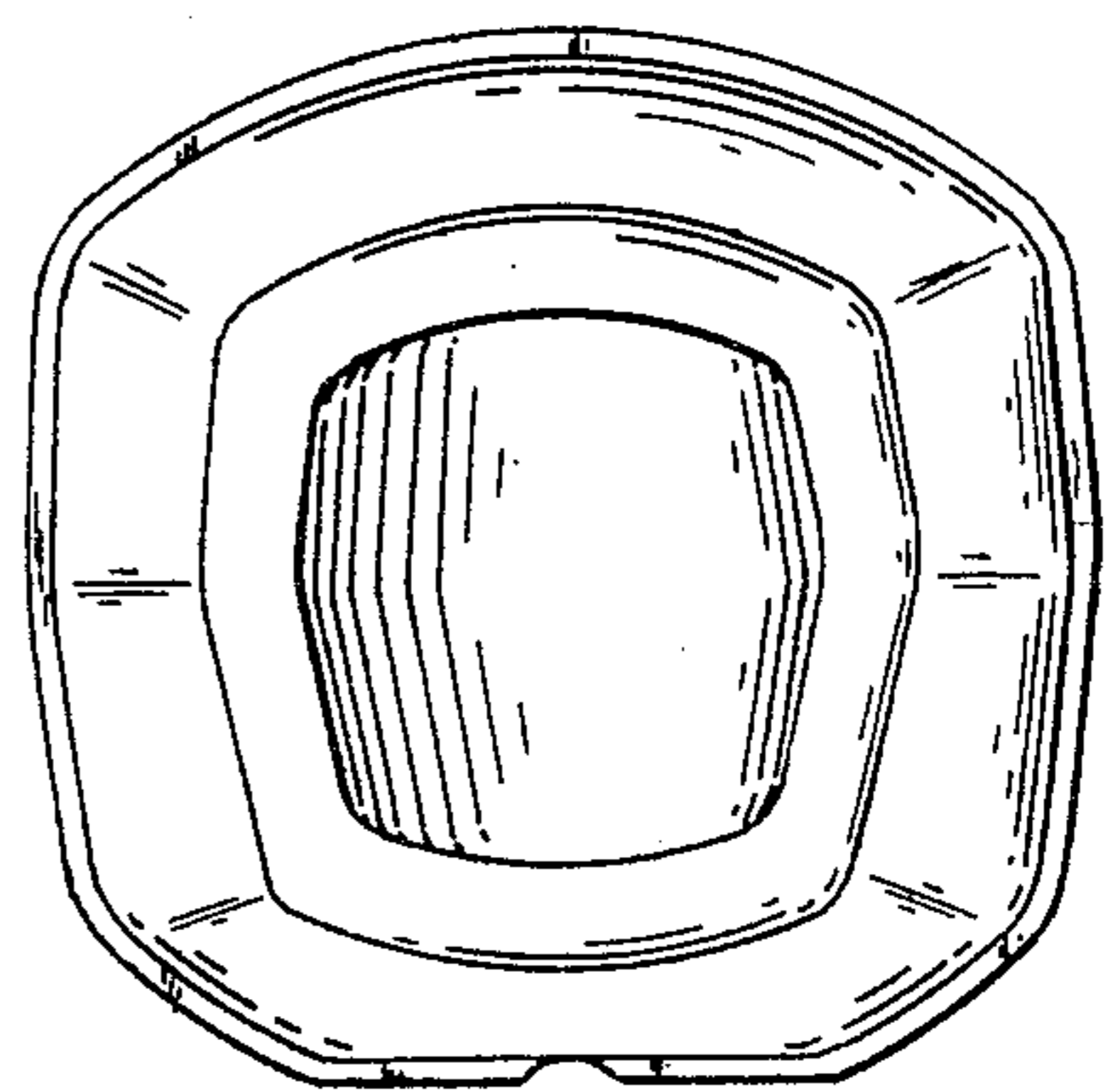

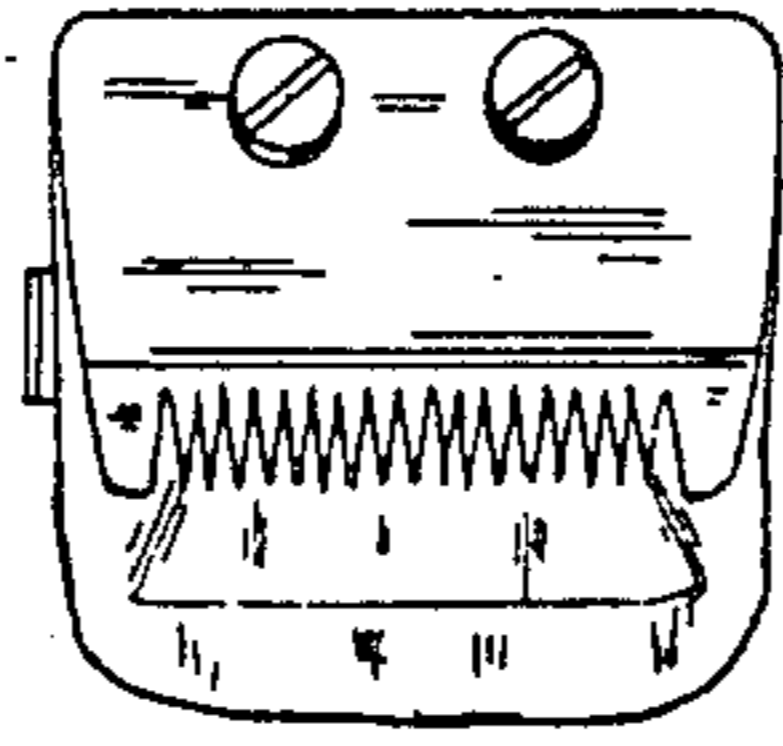

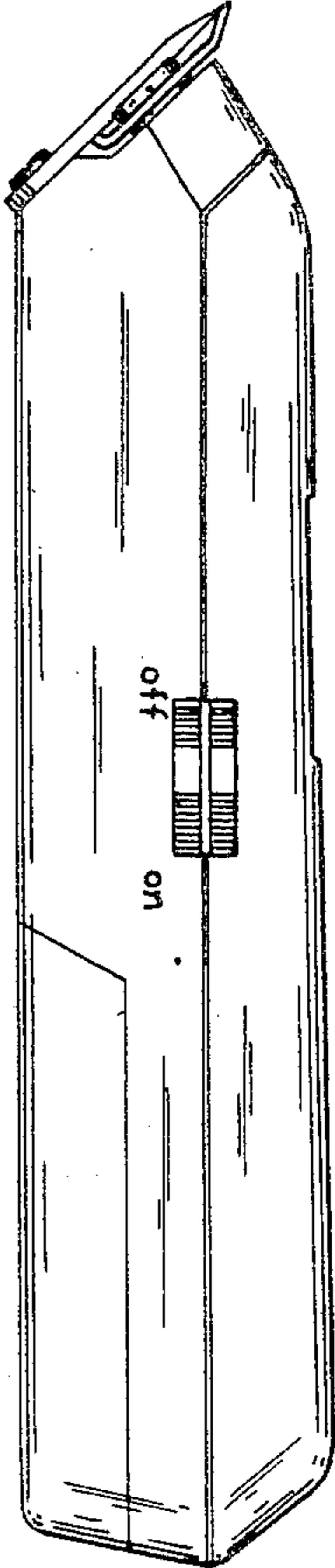

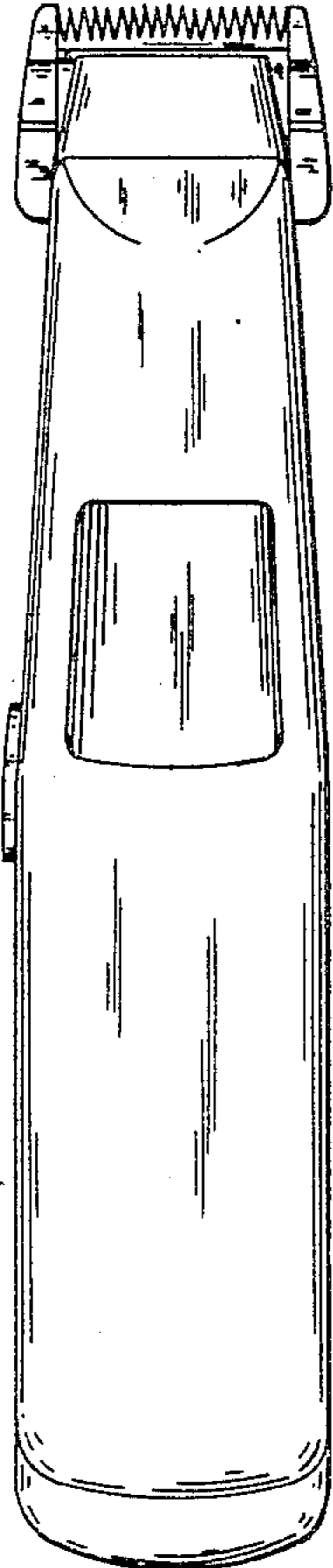

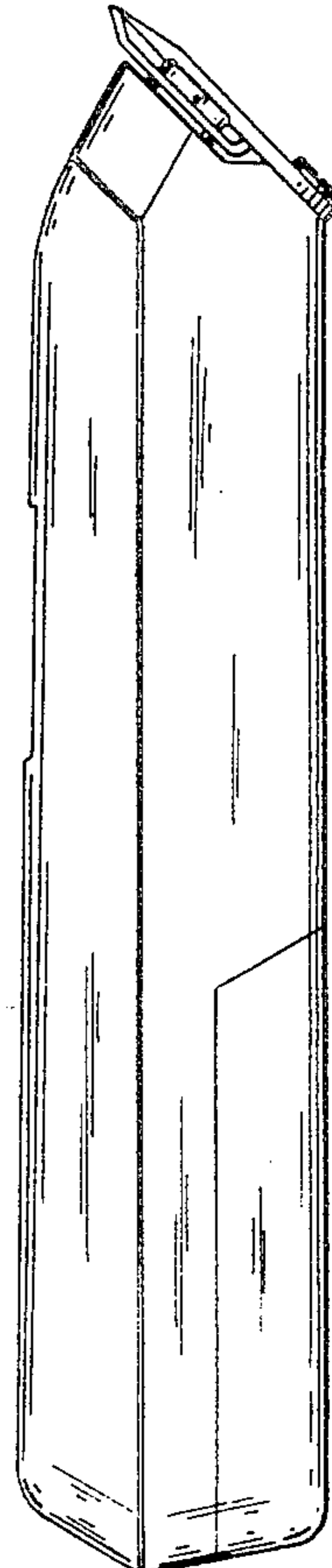

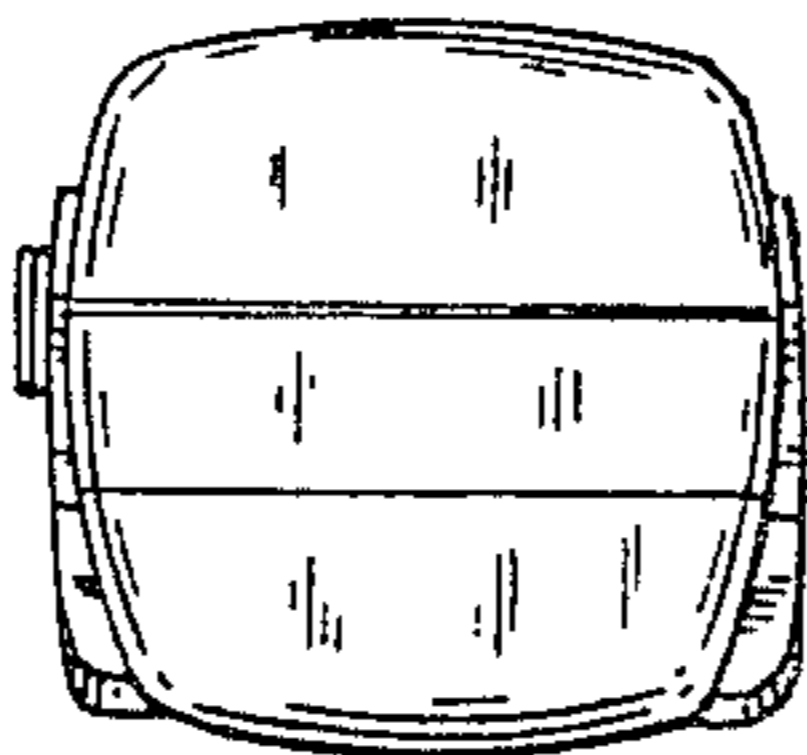
