[57] CLAIM

The ornamental design for a telephone stand, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and right side perspective view of a telephone stand showing my new design, with a handset and cord being represented in this and subsequent figures for illustrative, environmental association purposes only;

FIG. 2 is a top plan view thereof;

FIGS. 3 and 4 are respectively front and rear elevational views thereof;

FIGS. 5 and 6 are respectively right and left side elevational views thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a front, top and right side perspective view of a second embodiment thereof;

FIG. 9 is a top plan view thereof;

FIG. 10 is a front, top and right side perspective view of a third embodiment thereof;

FIG. 11 is a top plan view thereof;

FIG. 12 is a front, top and right side perspective view of a fourth embodiment thereof;

FIG. 13 is a top plan view thereof;

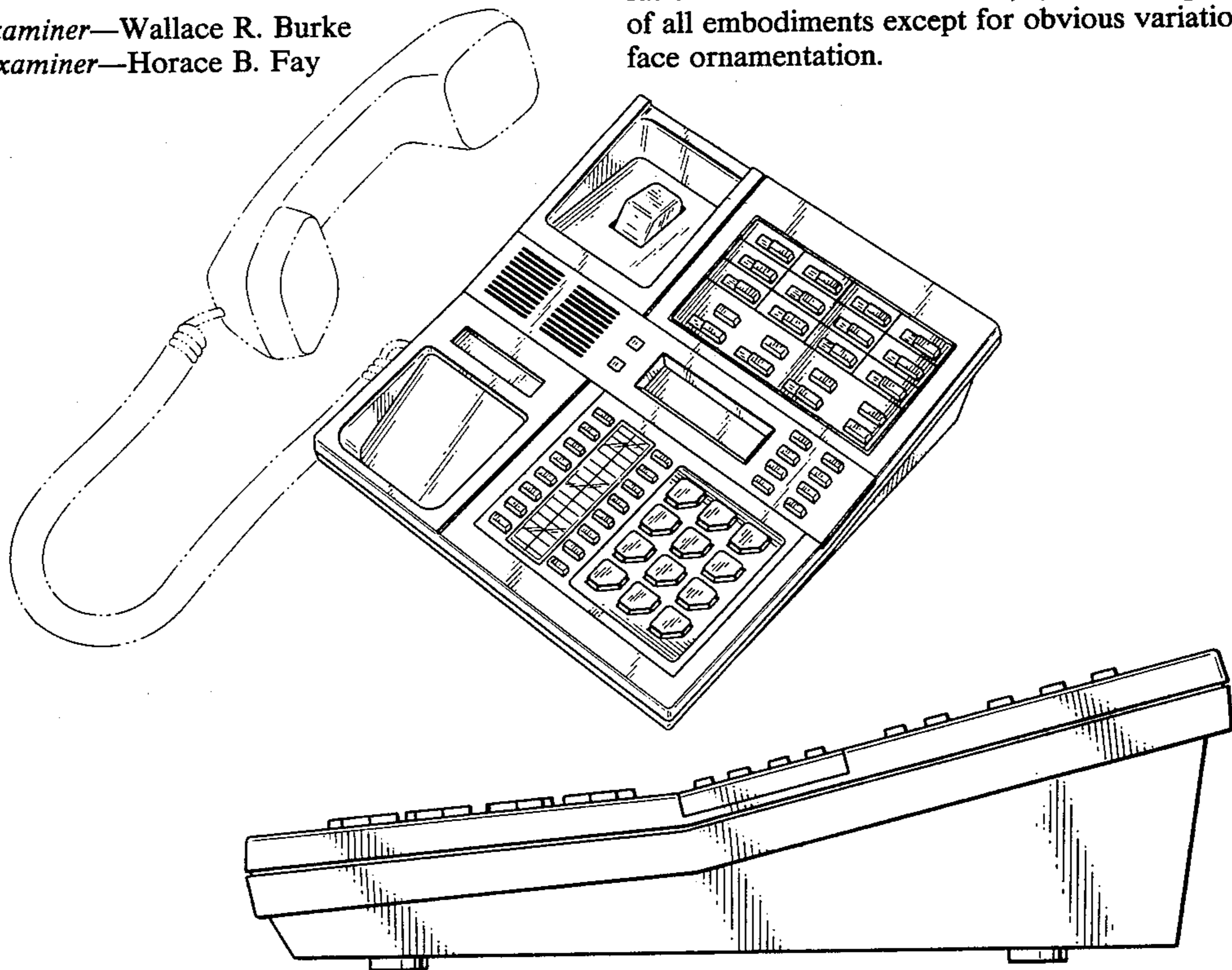
FIG. 14 is a front, top and right side perspective view of a fifth embodiment thereof;

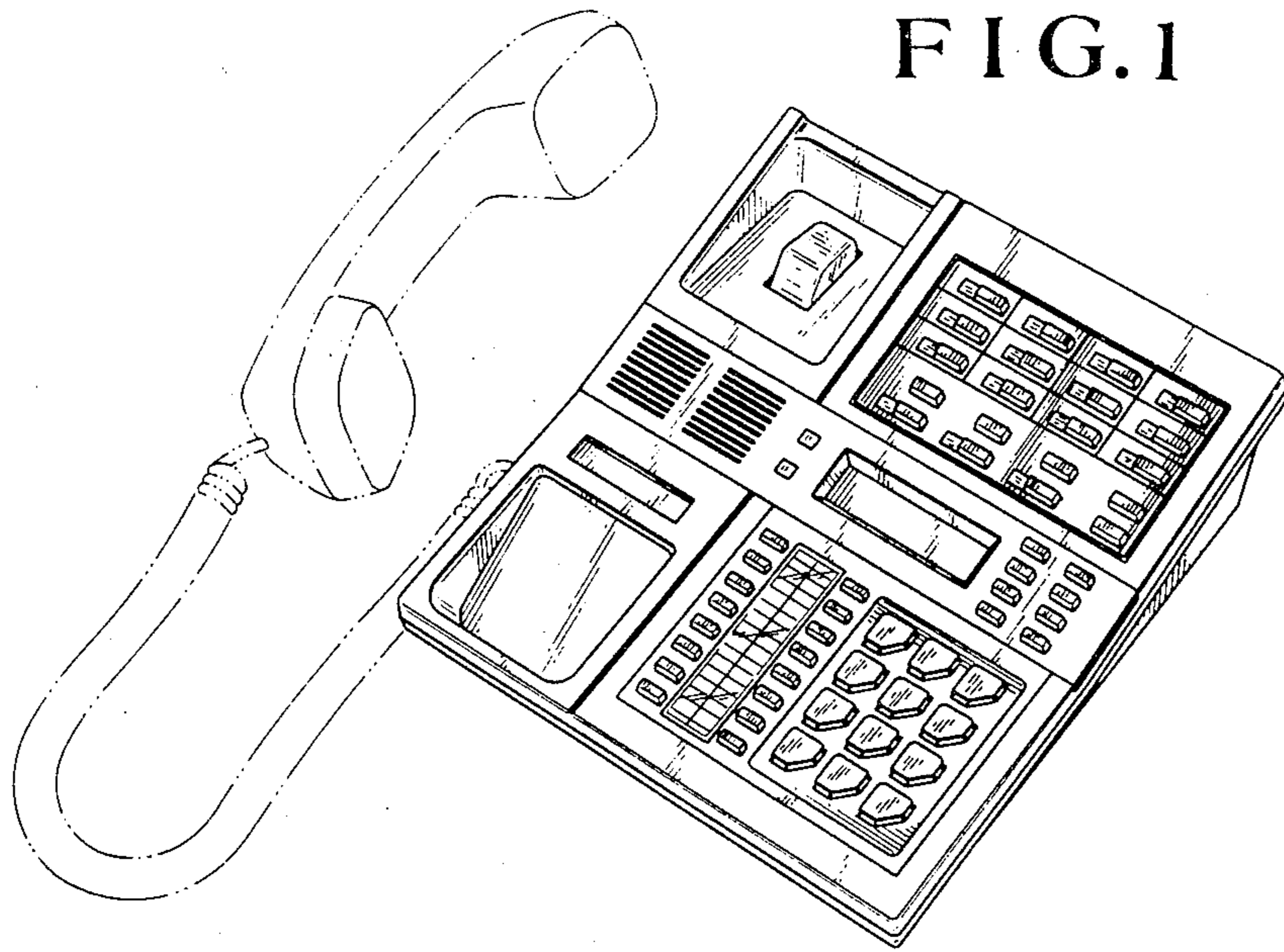

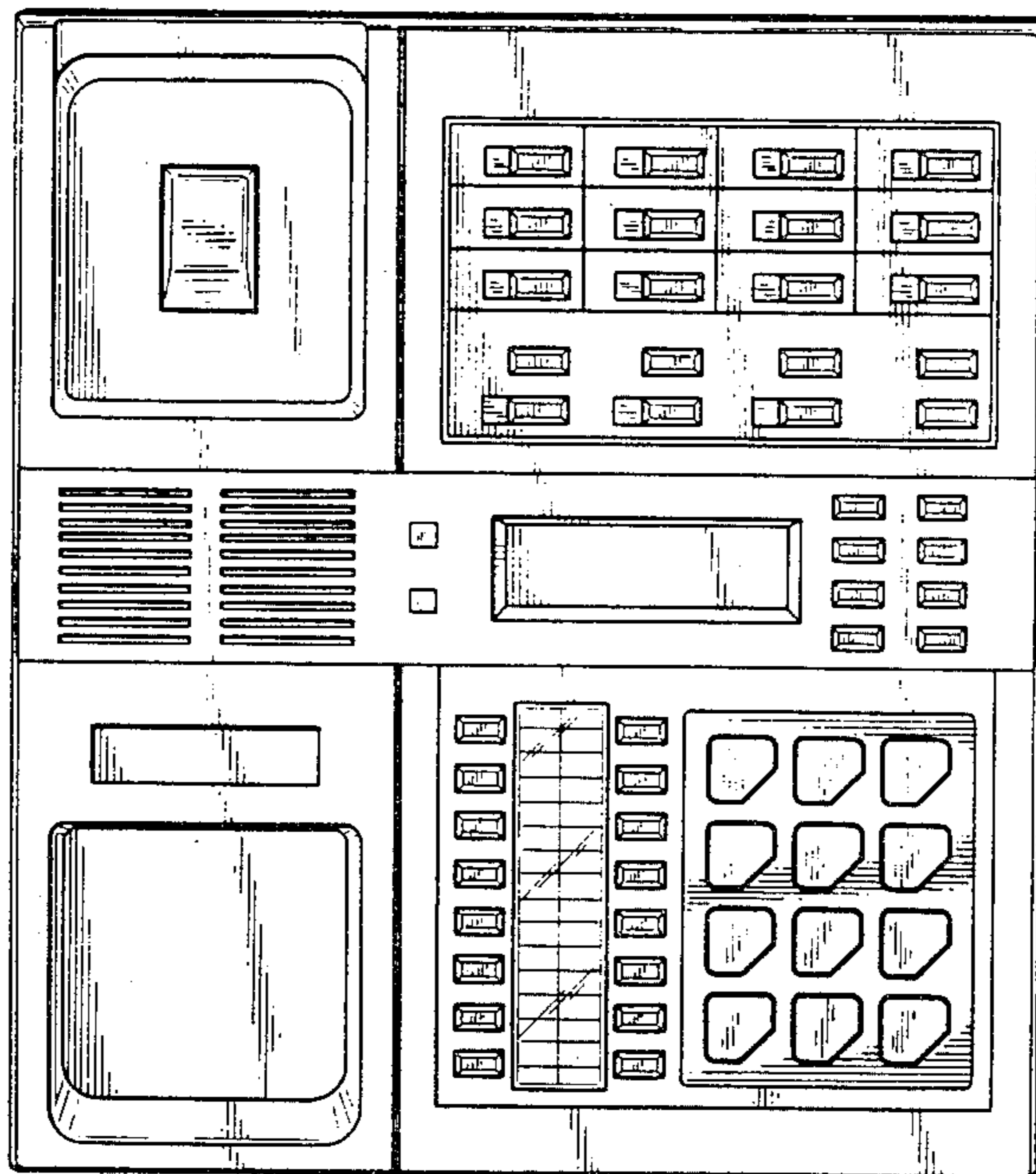

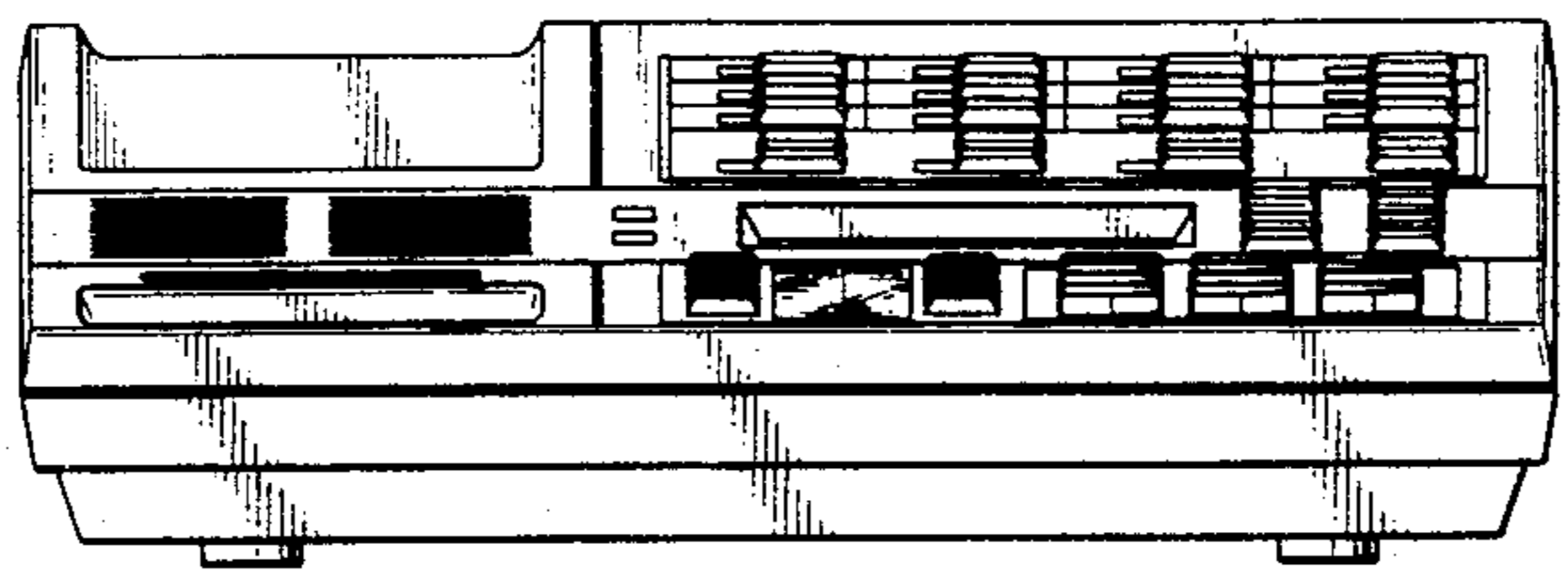

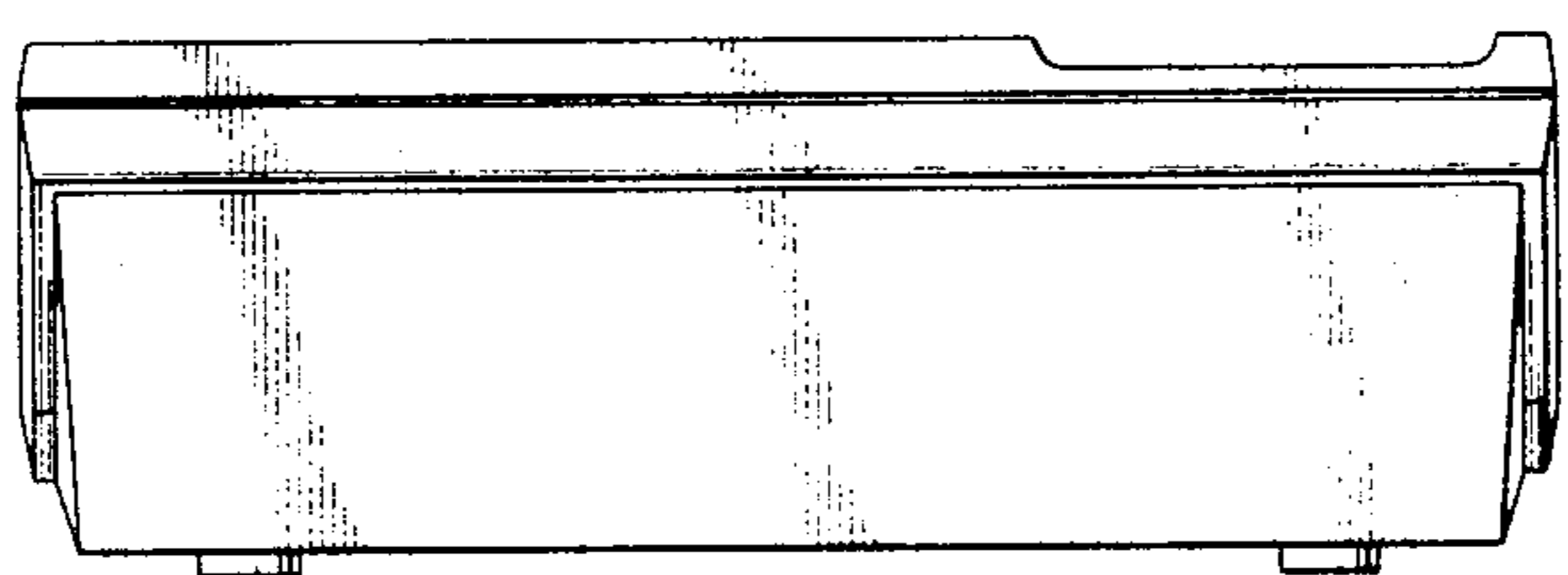

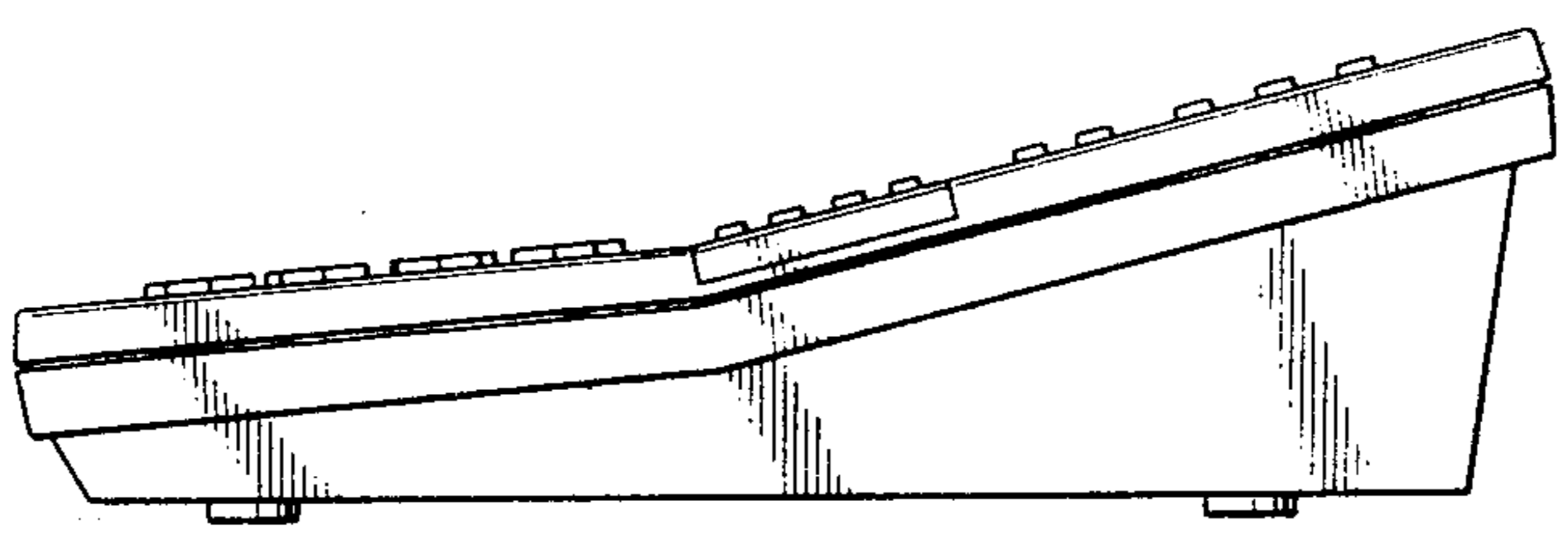

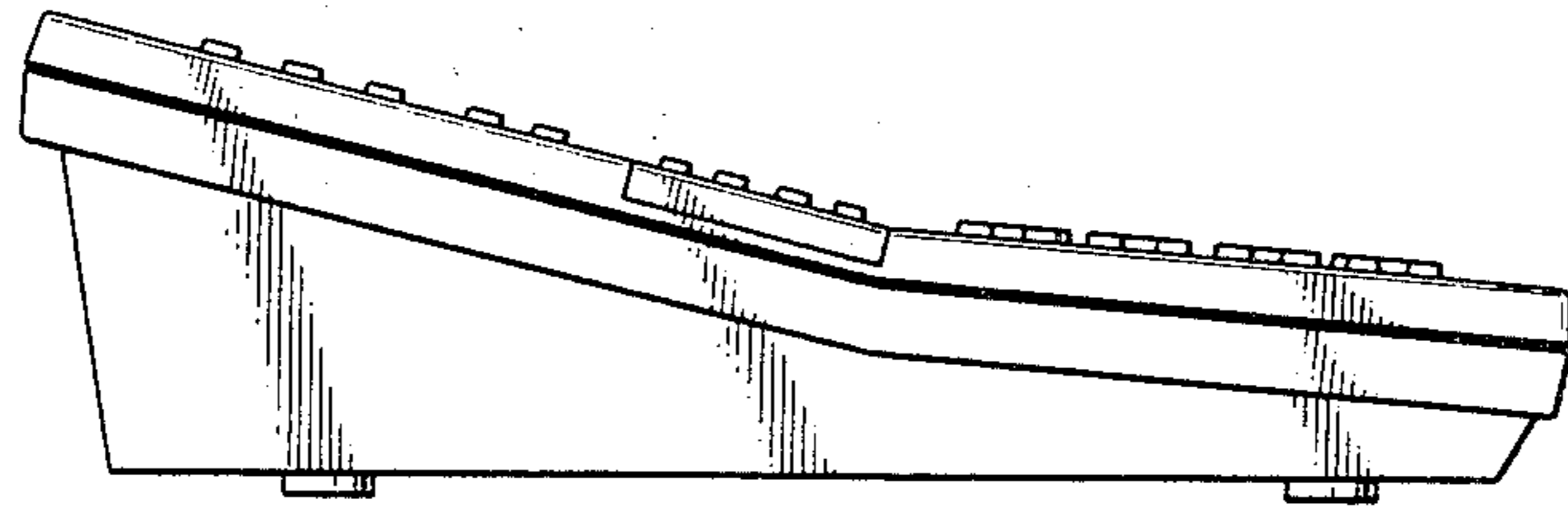

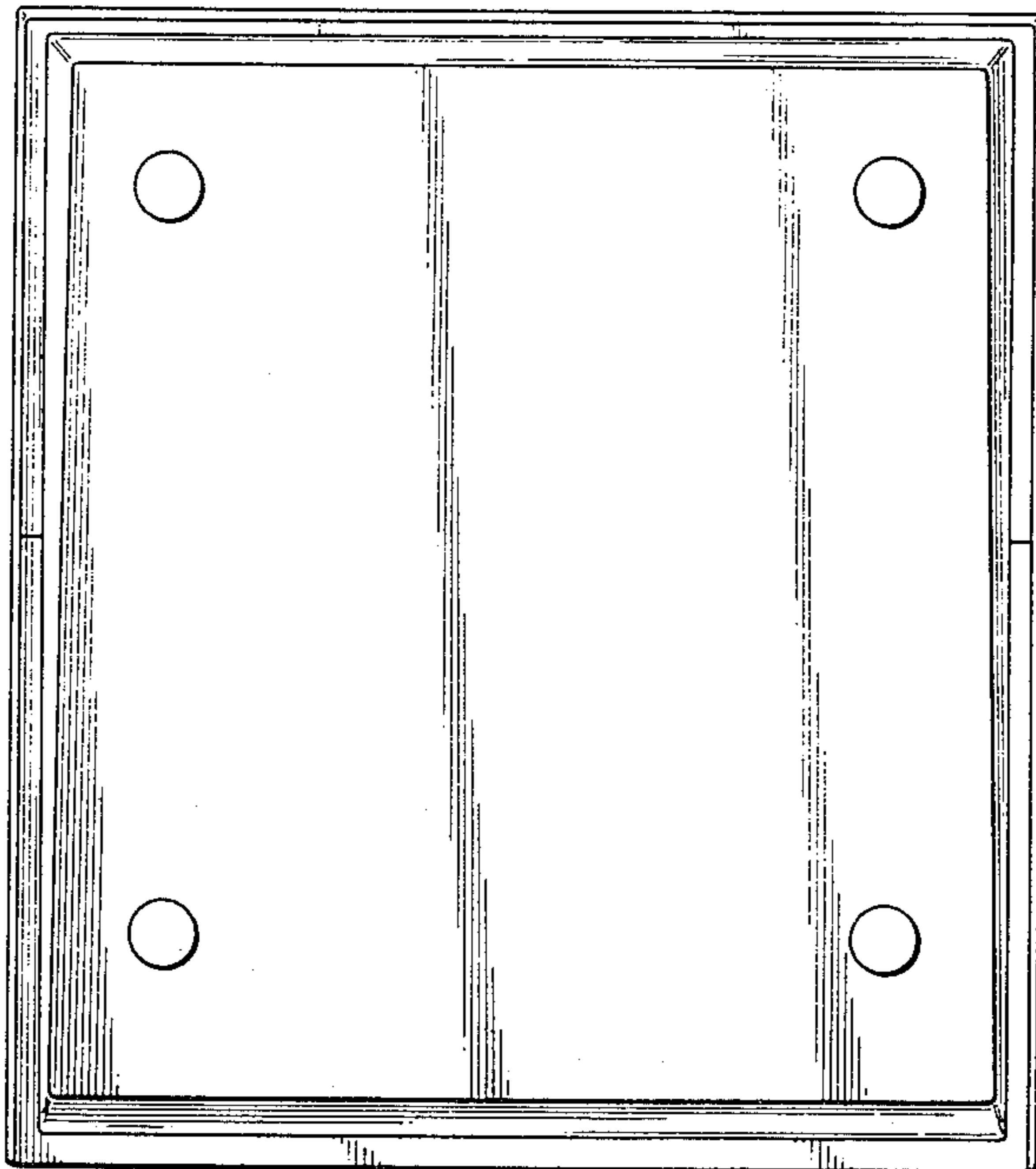

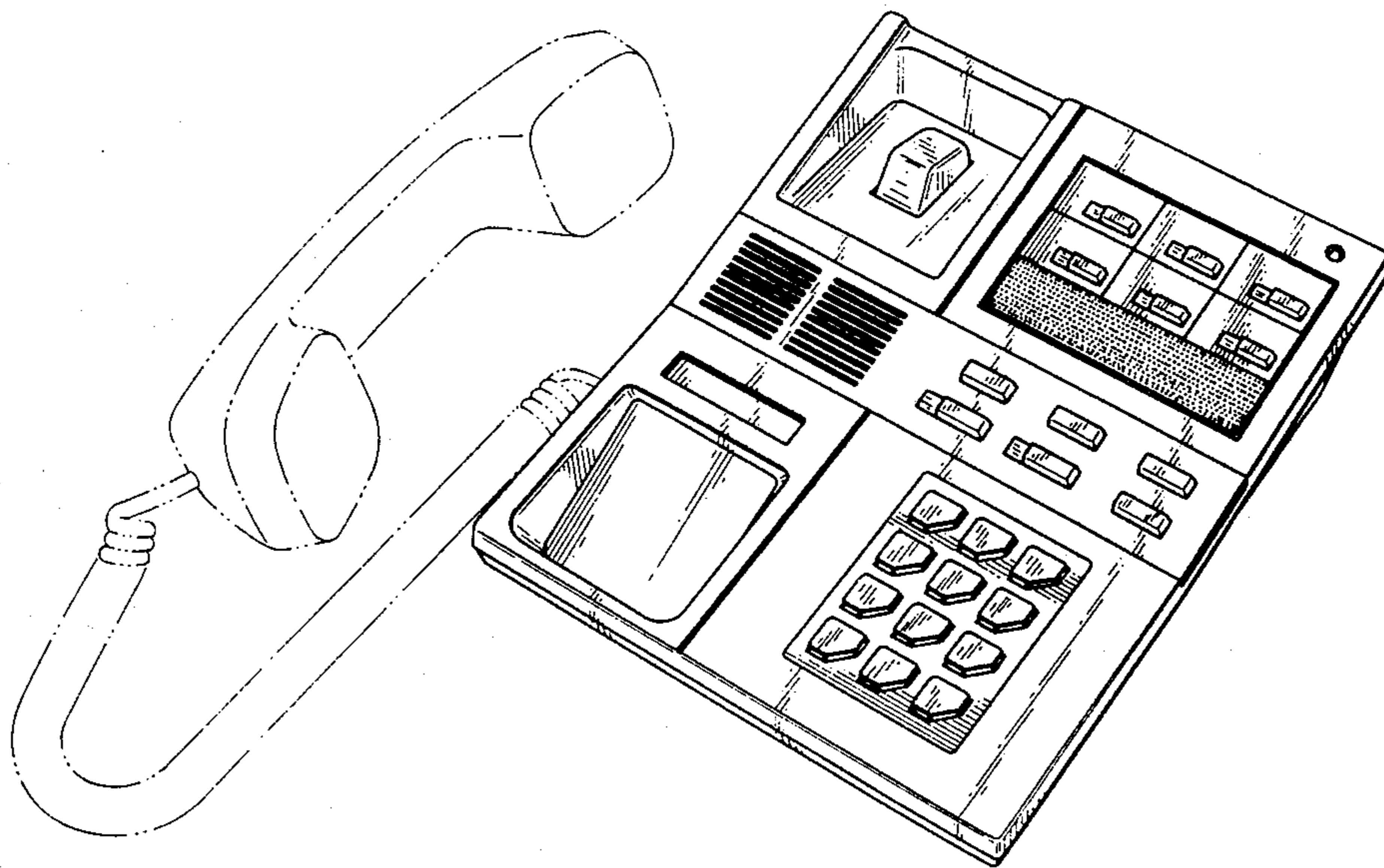

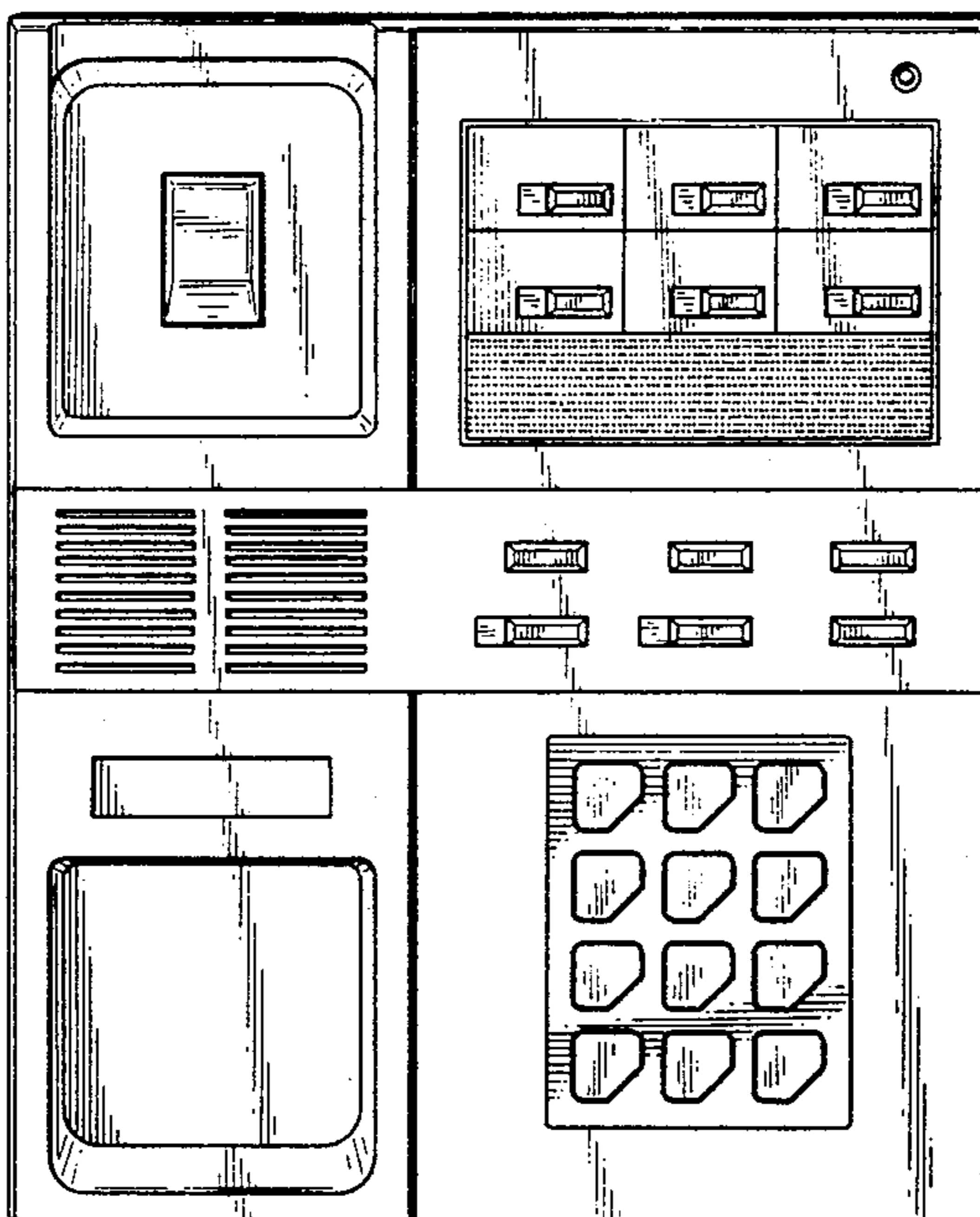

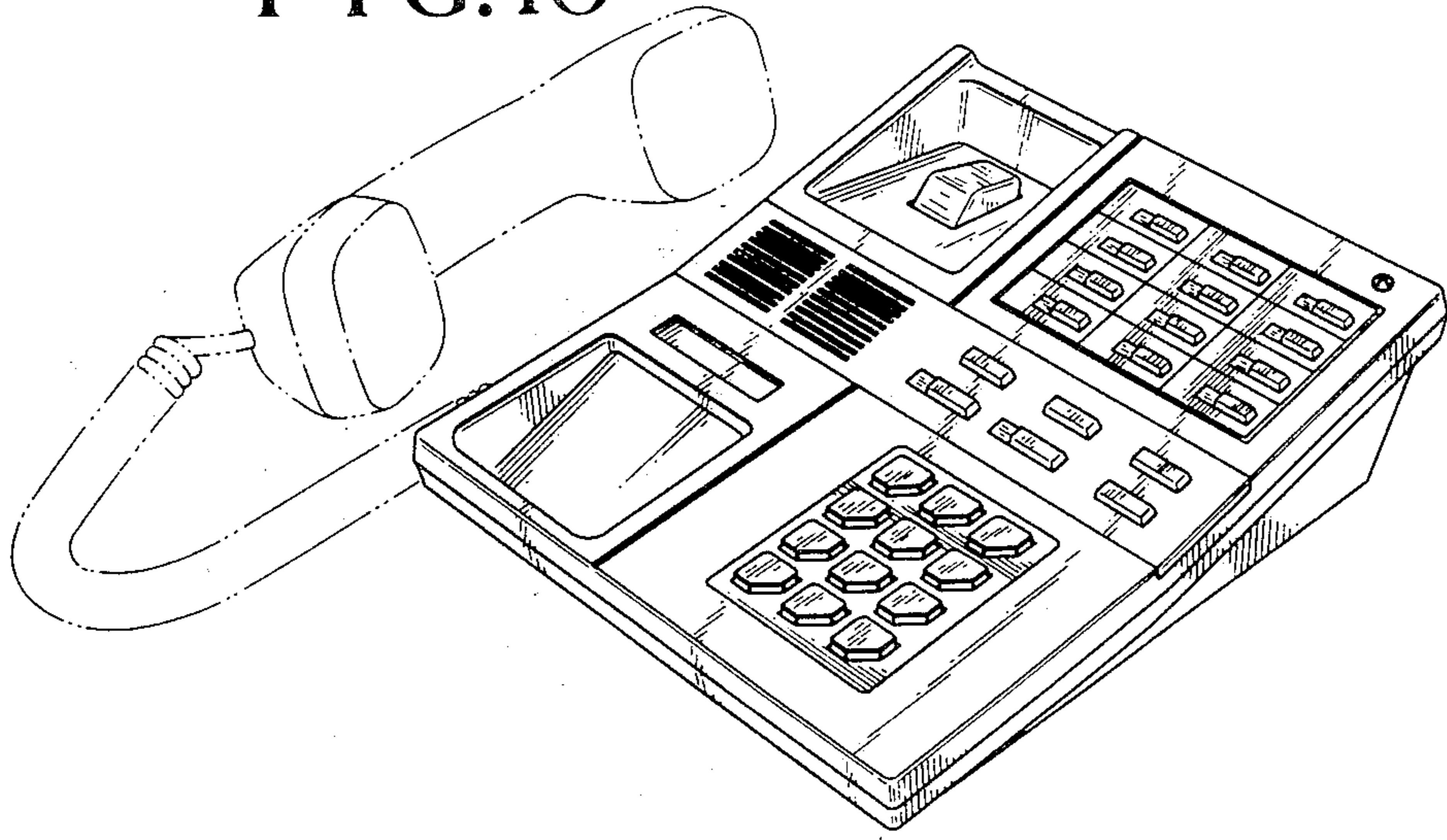

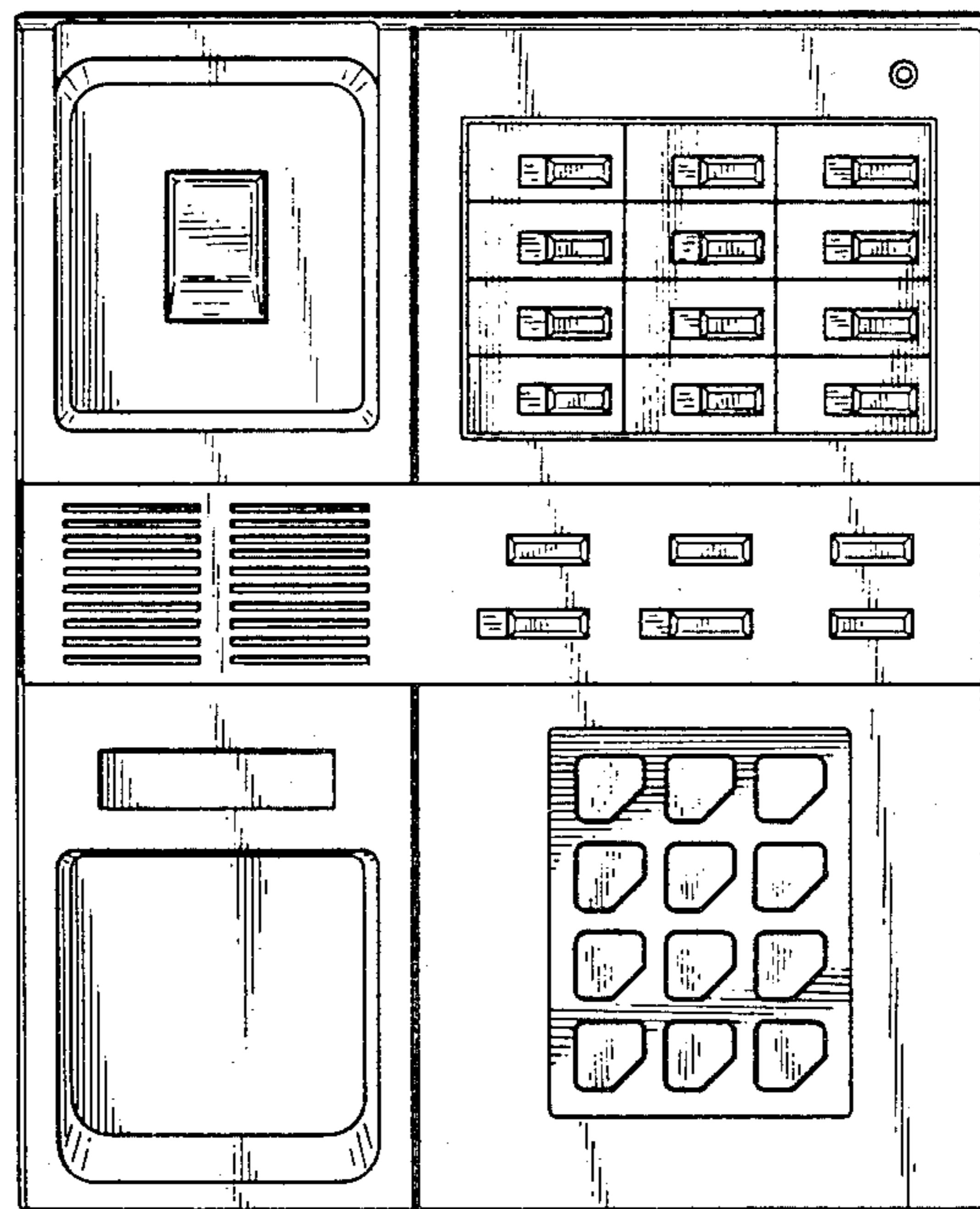

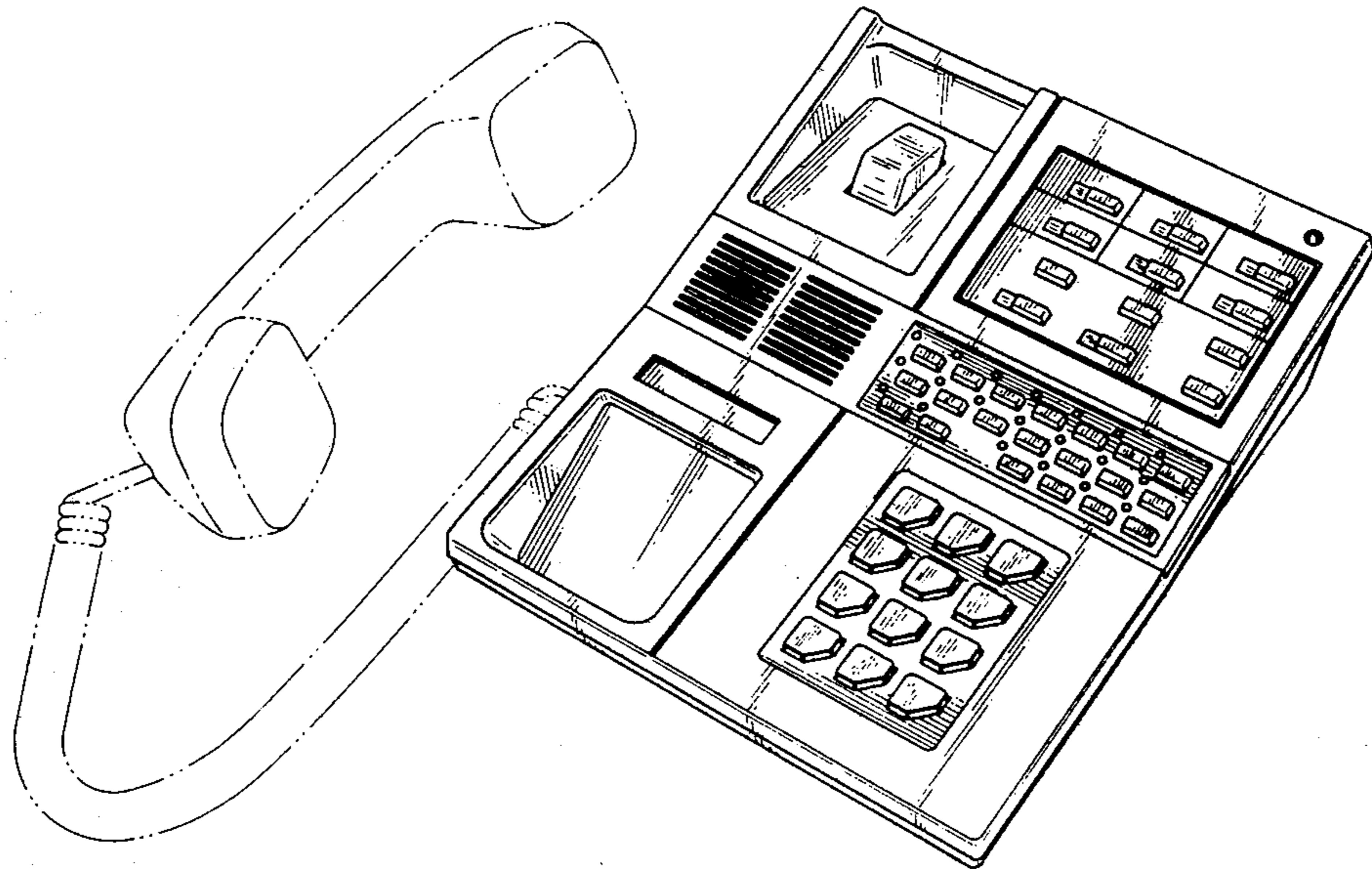

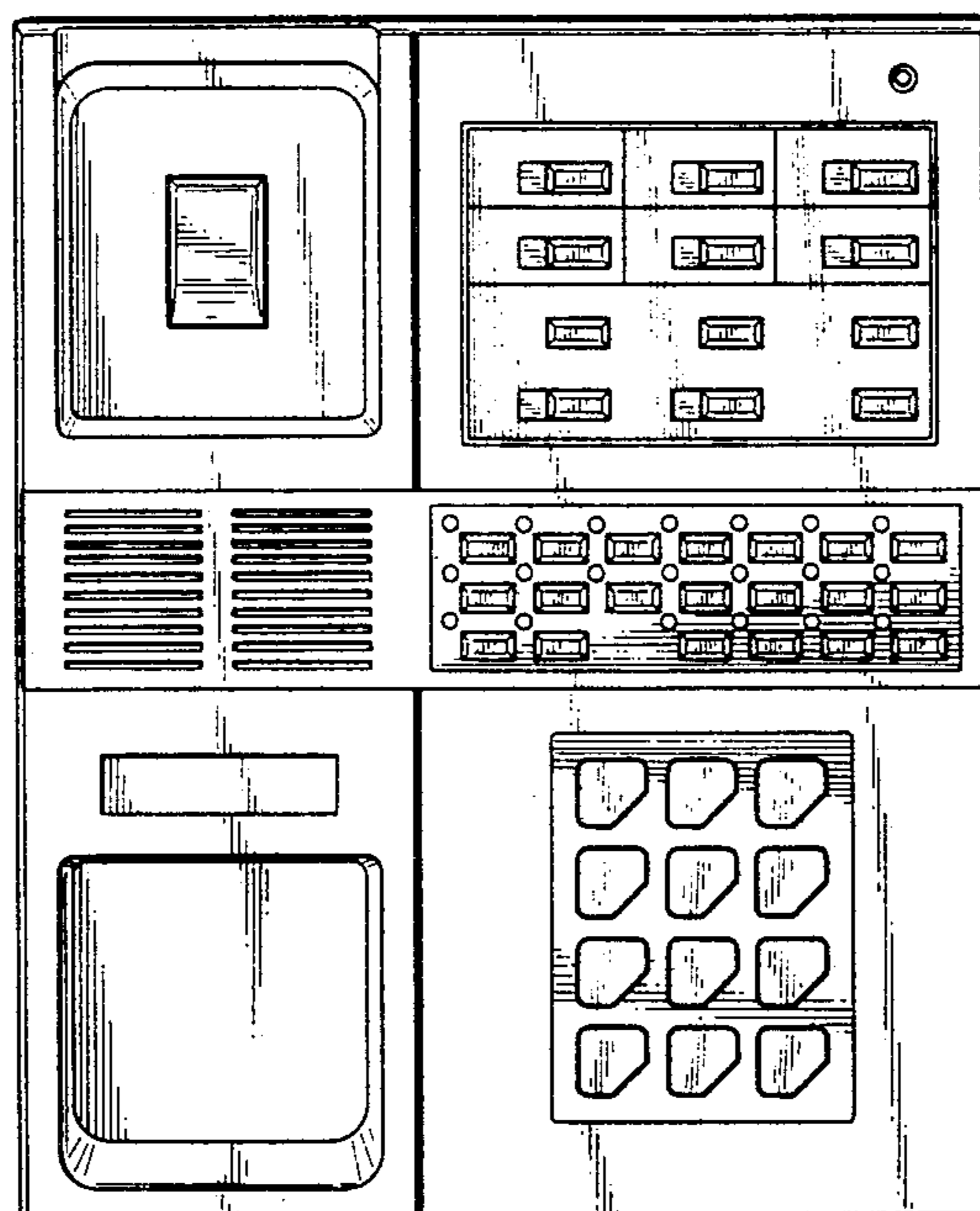

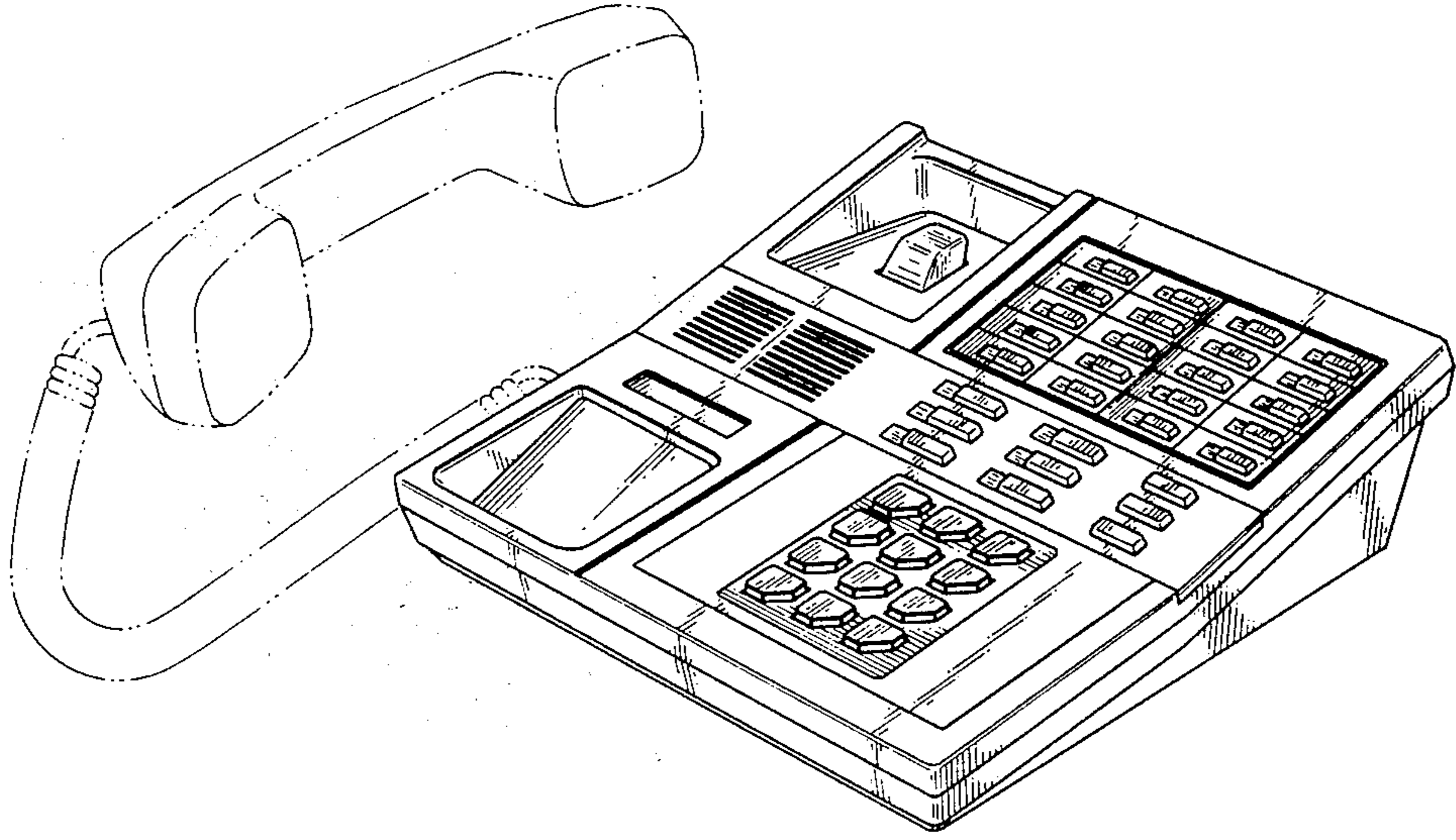

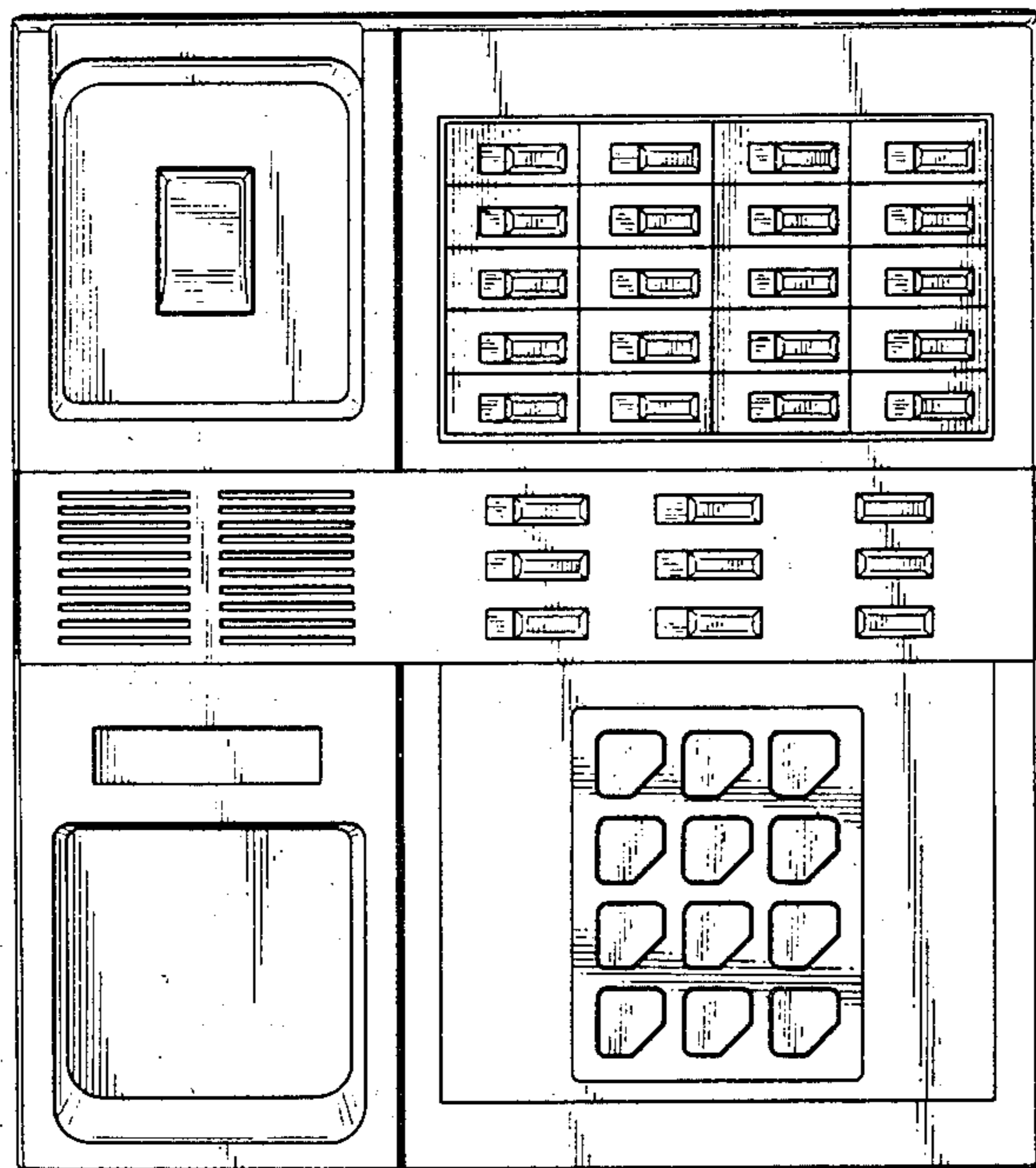

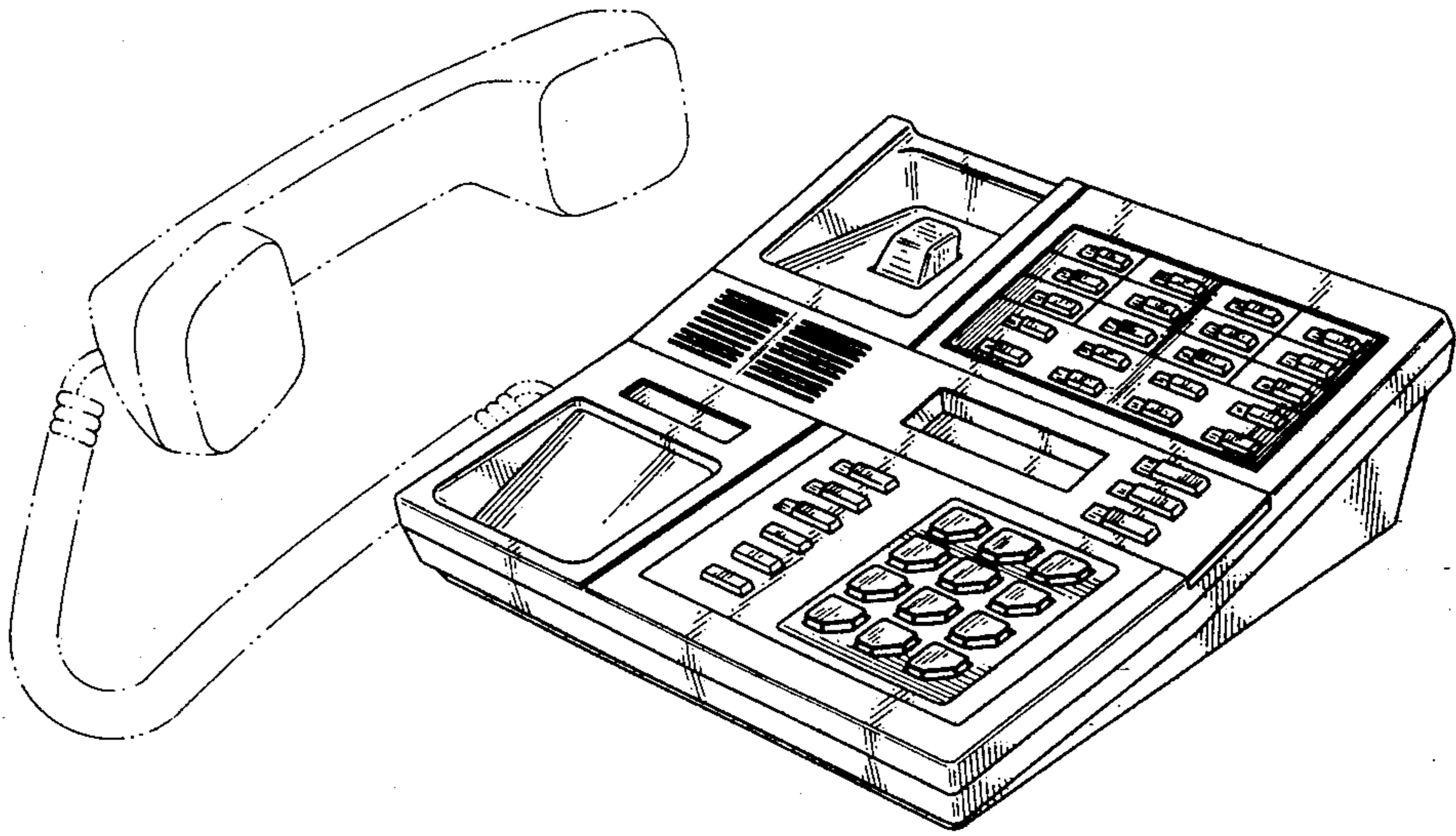
