[57] CLAIM

The ornamental design for a paving stone, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a paving stone showing a first embodiment of my new design;

FIG. 2 is a bottom plan view of the paving stone showing the first embodiment of my new design;

FIG. 3 is a side elevational view of the bottom of the paving stone of FIG. 1 according to first embodiment of my new design;

FIG. 4 is an elevational view from the left of FIG. 1 of the first embodiment of my new design;

FIG. 5 is a perspective view of the paving stone showing the first embodiment of my new design;

FIG. 6 is a top plan view of a paving stone showing a second embodiment of my new design;

FIG. 7 is a bottom plan view of the paving stone showing the second embodiment of my new design;

FIG. 8 is a side elevational view of the bottom of the paving stone showing the second embodiment of my new design;

FIG. 9 is an elevational view from the left of FIG. 6 of the paving stone showing the second embodiment of my new design;

FIG. 10 is a perspective view of the paving stone showing the second embodiment of my new design;

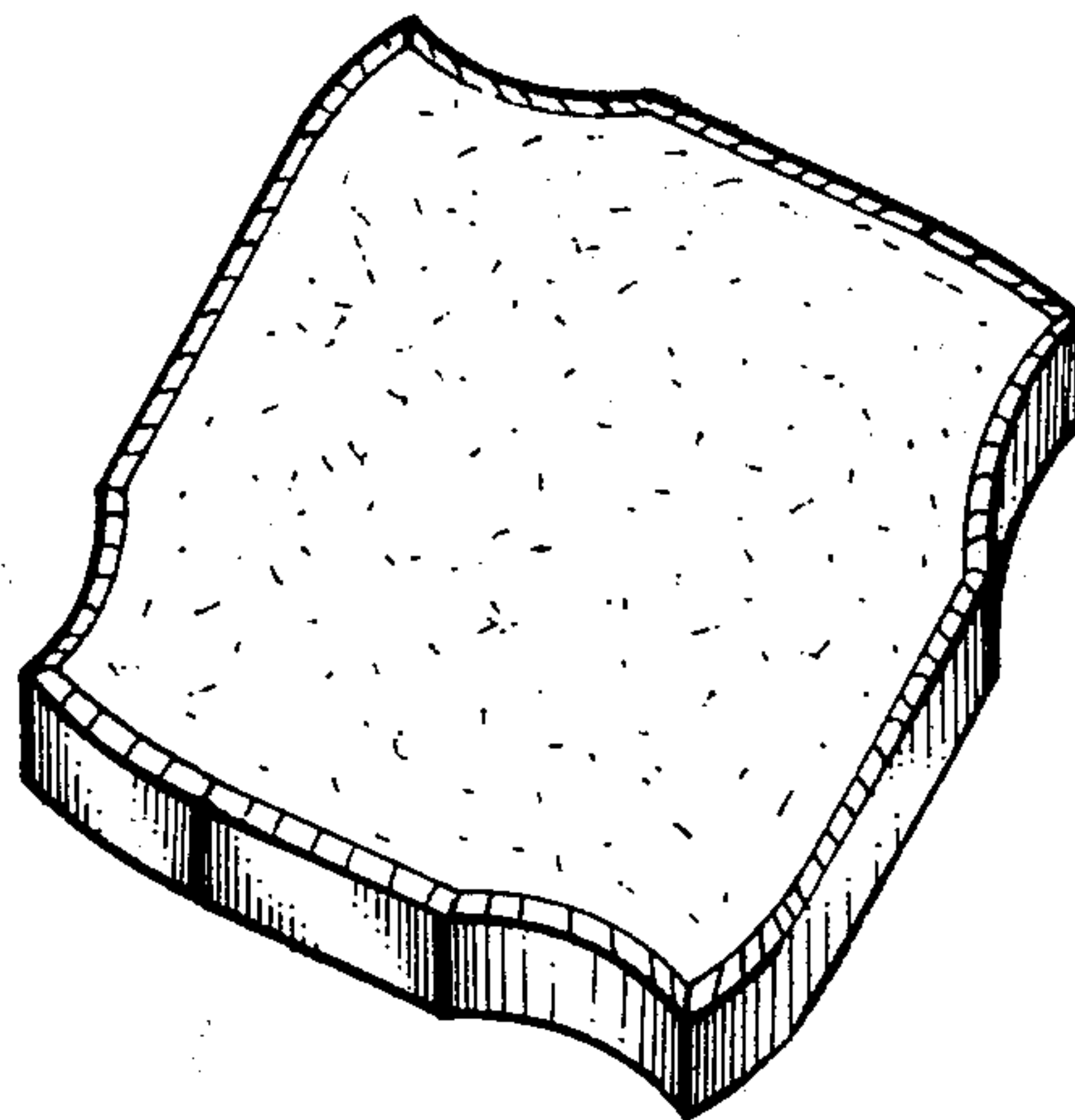
FIG. 11 is a top plan view of a paving stone showing a third embodiment of my new design;

FIG. 15 is a perspective view of the paving stone showing the third embodiment of my new design.



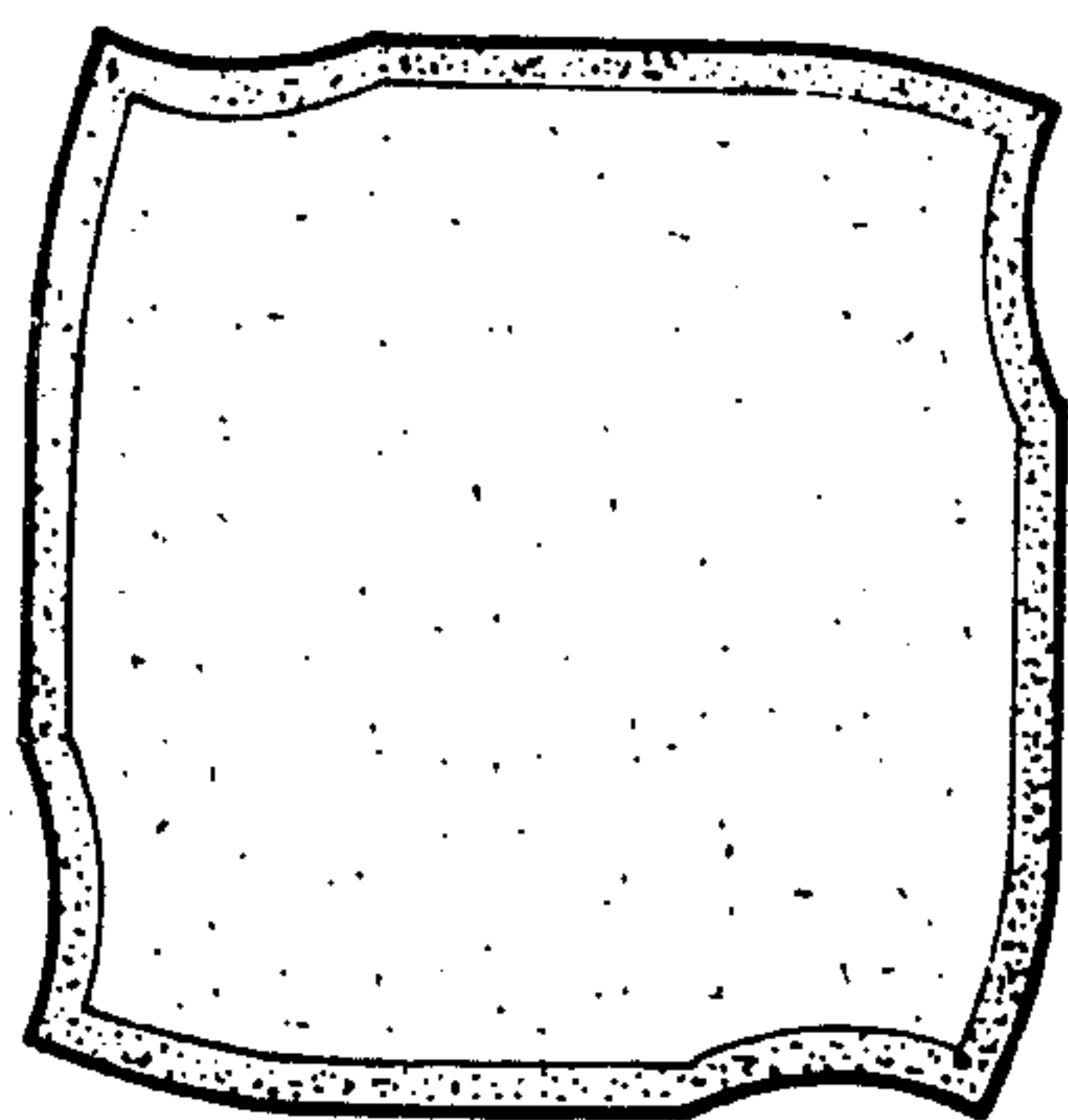

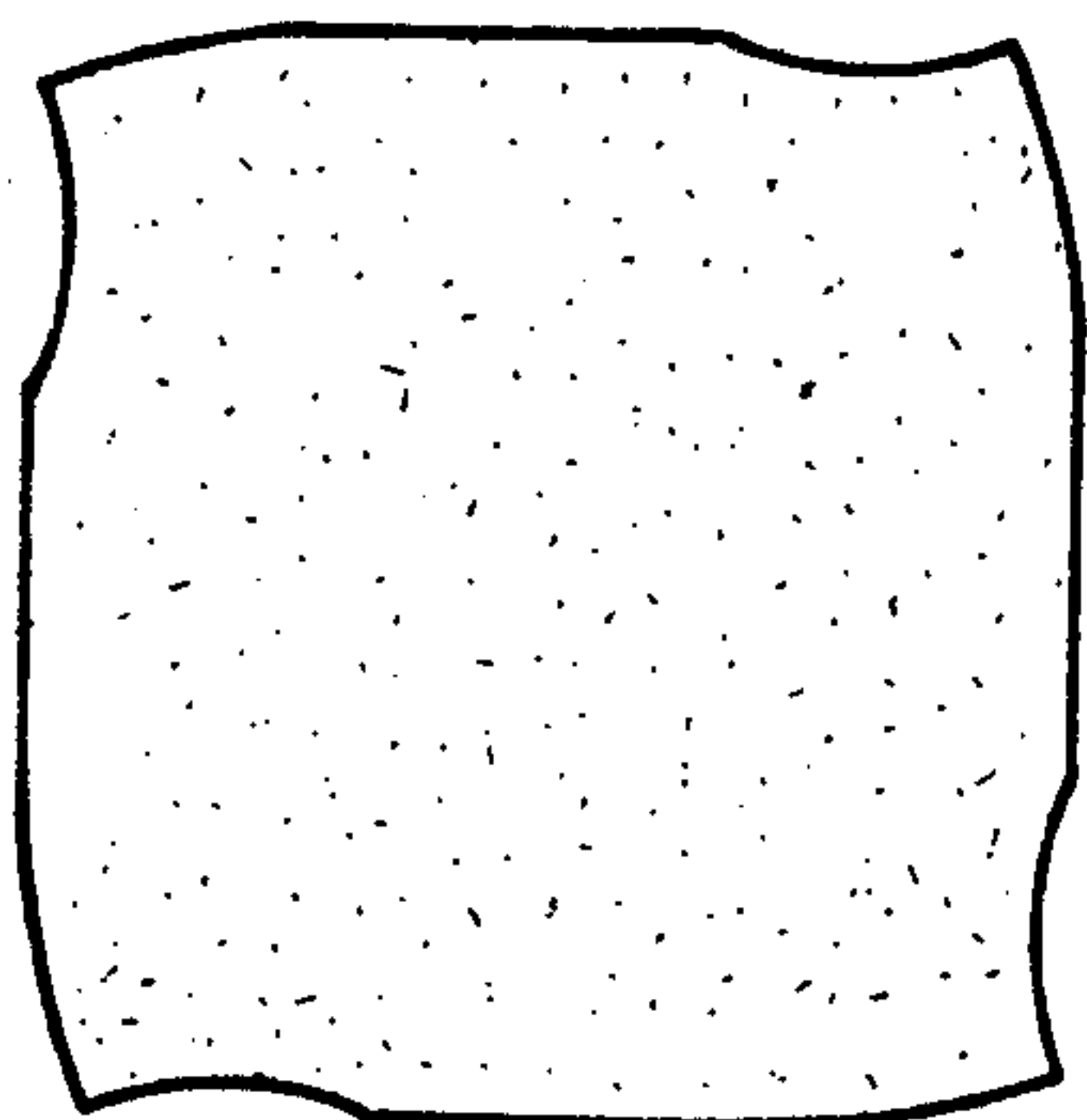
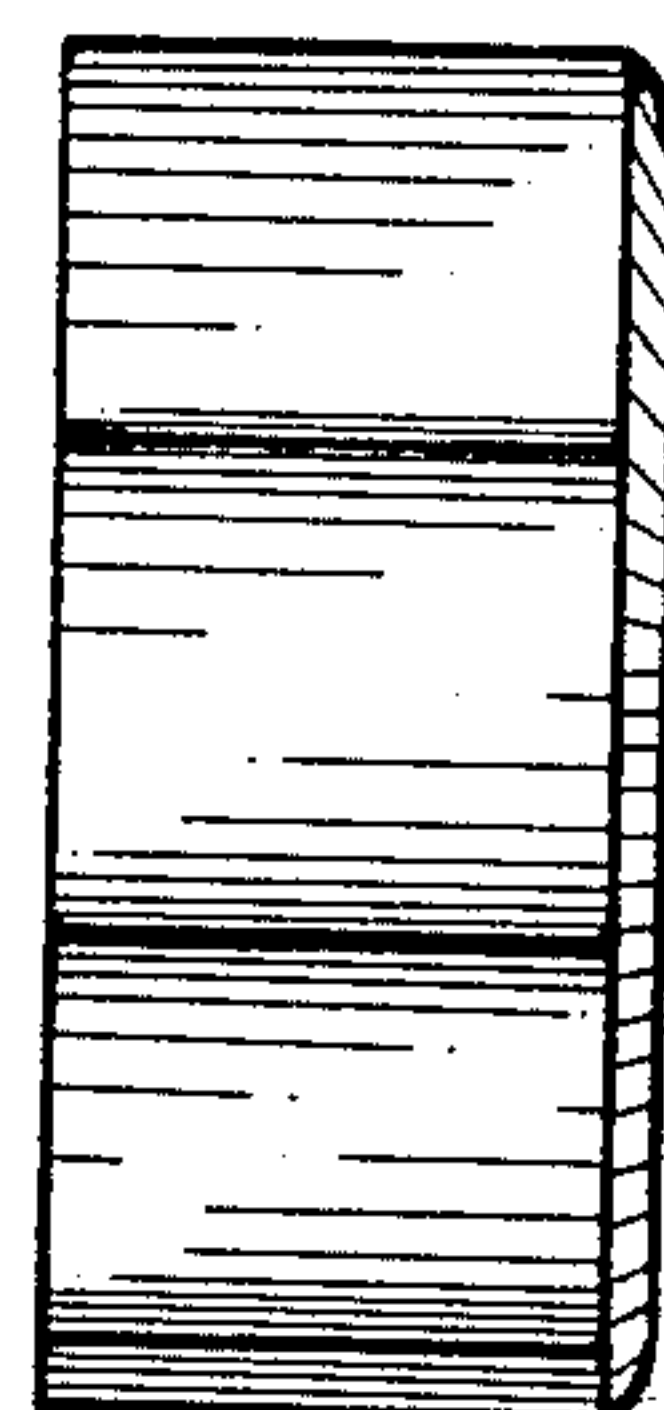

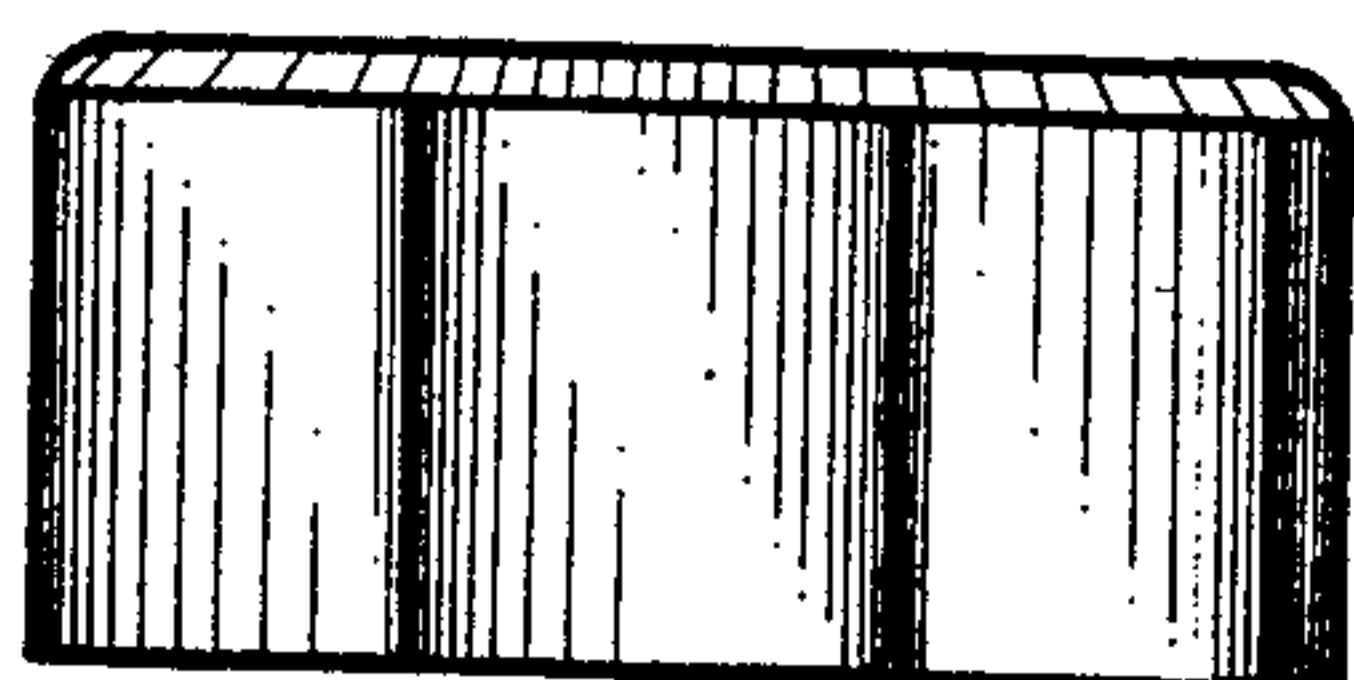
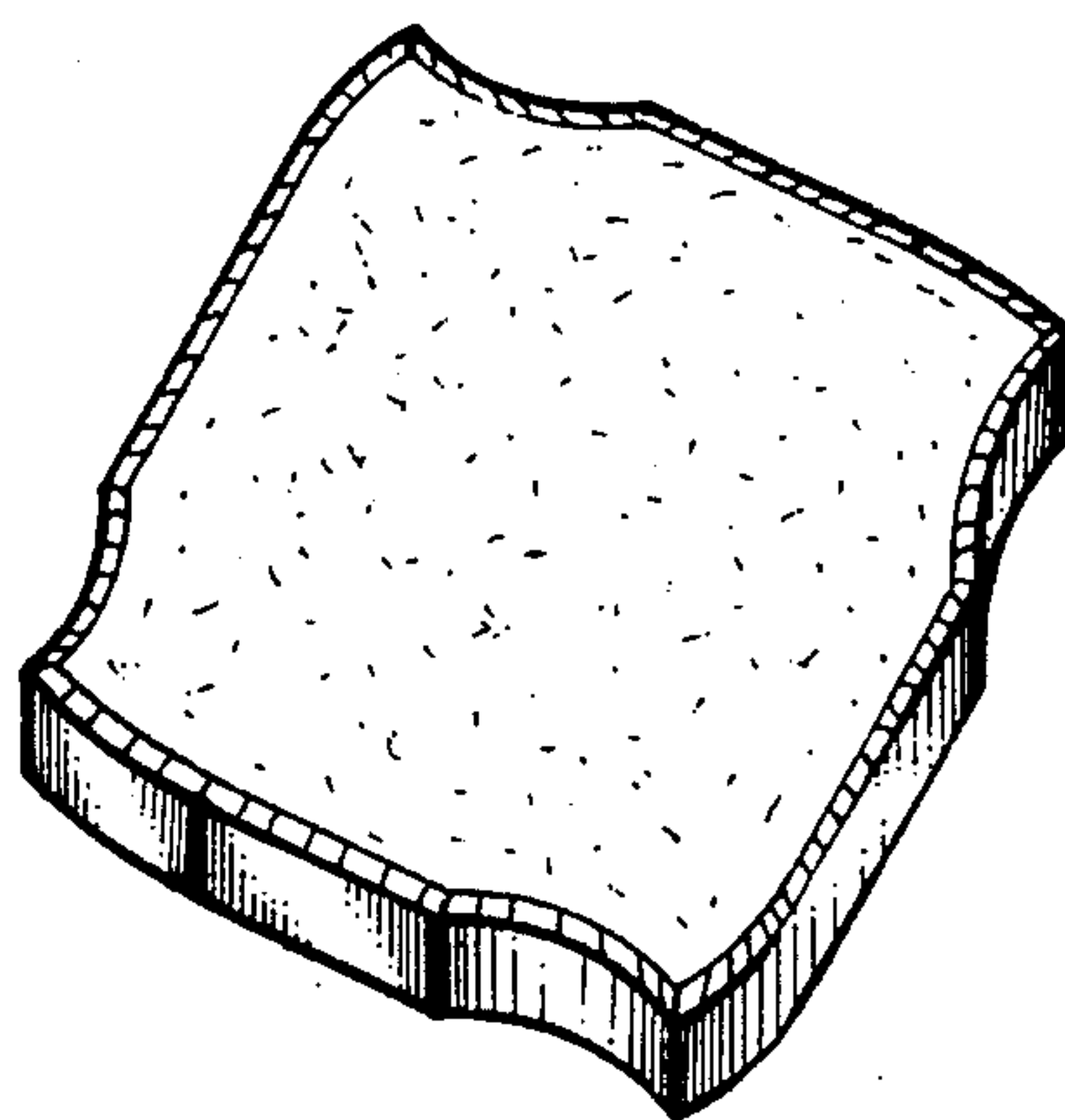

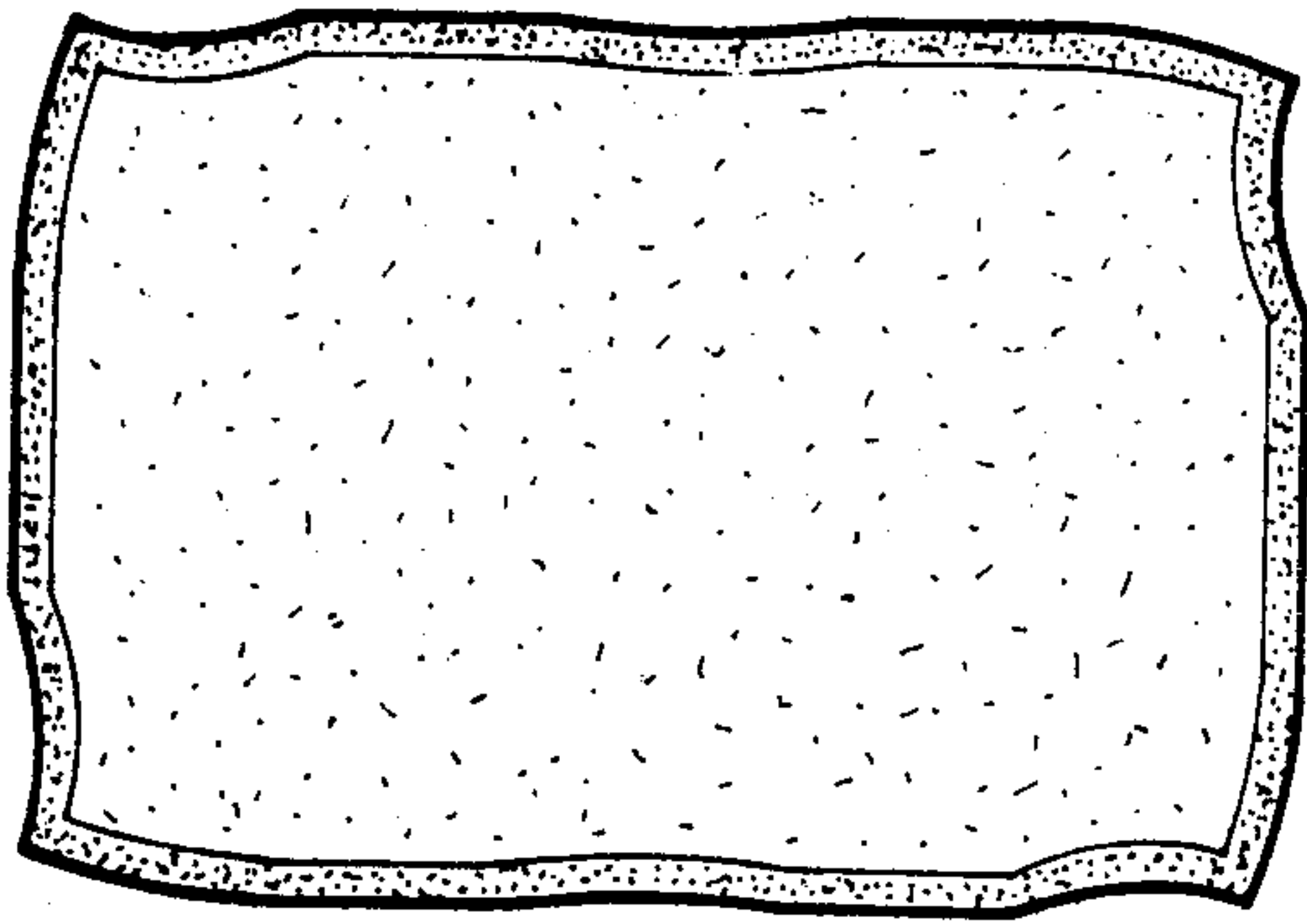

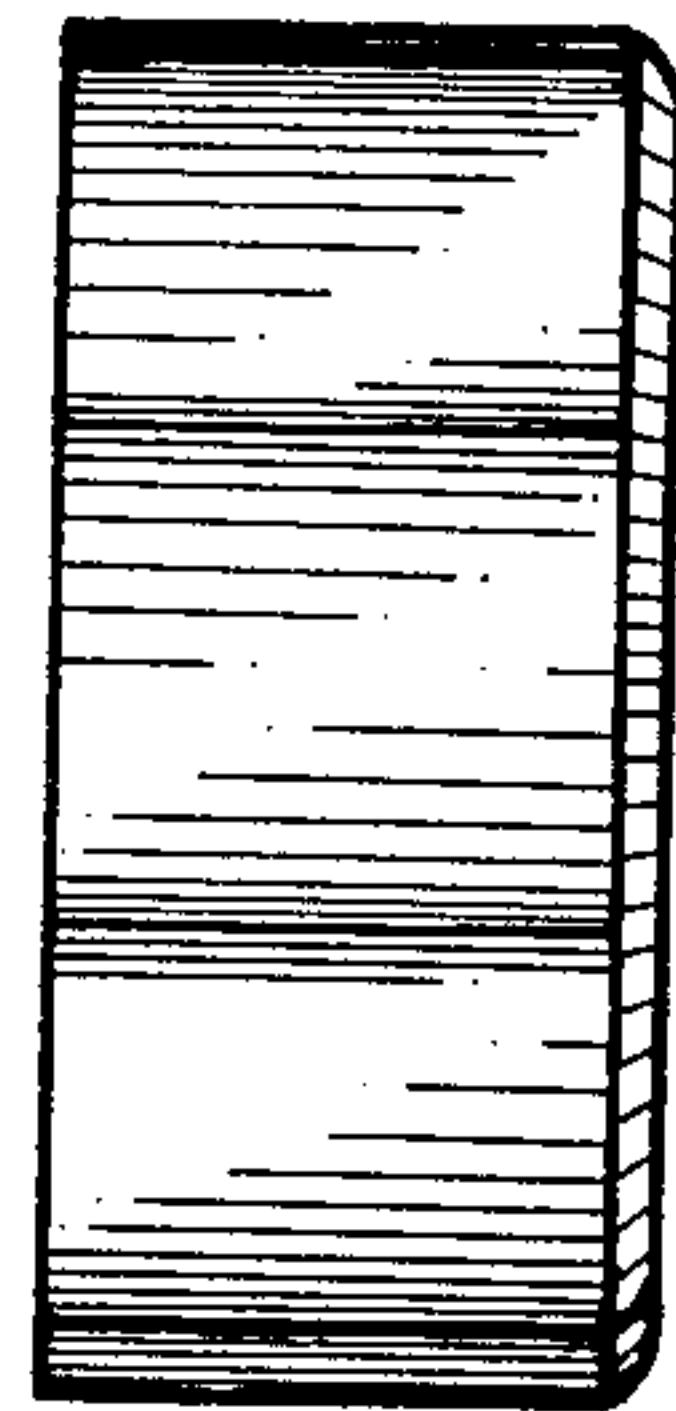

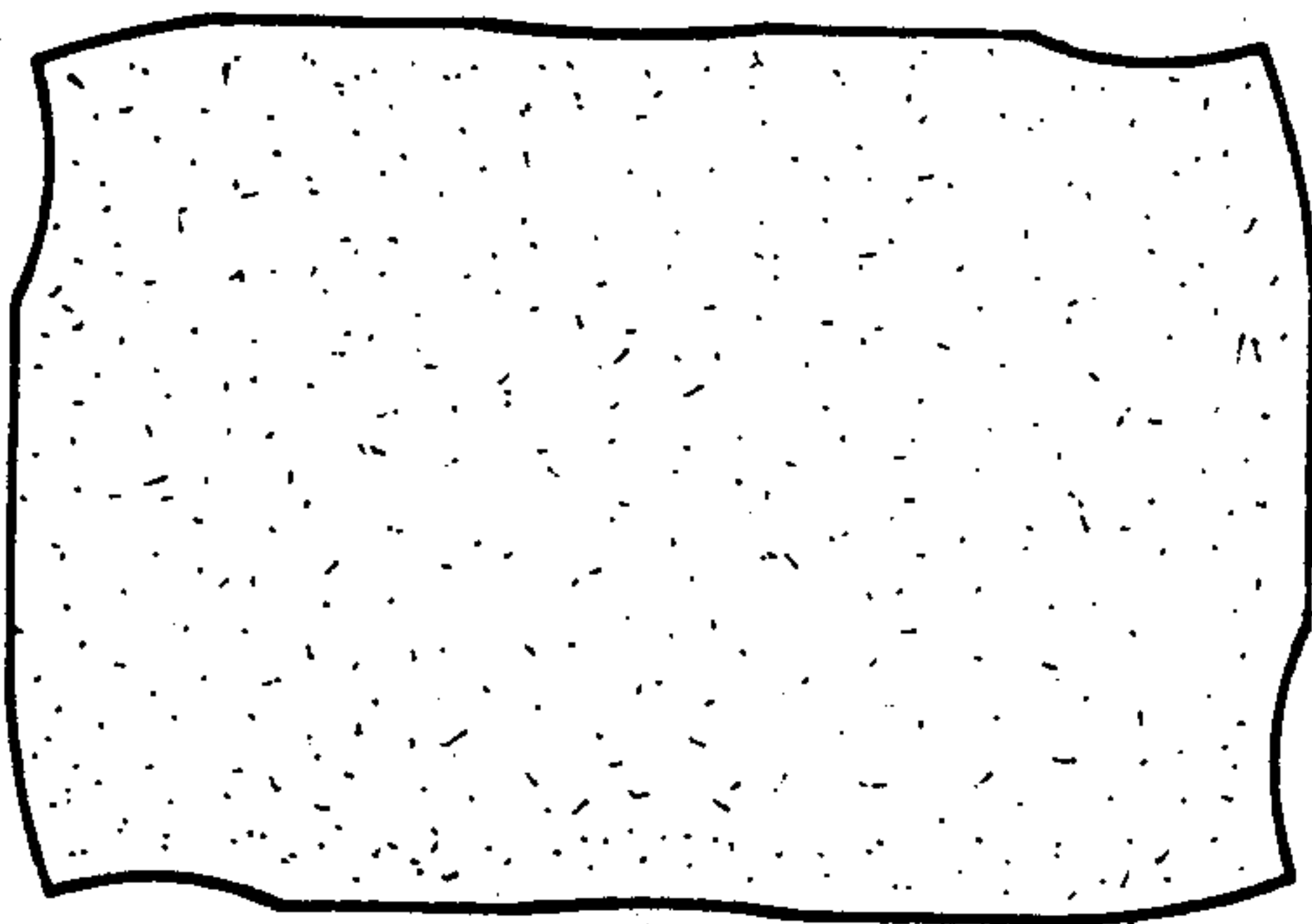

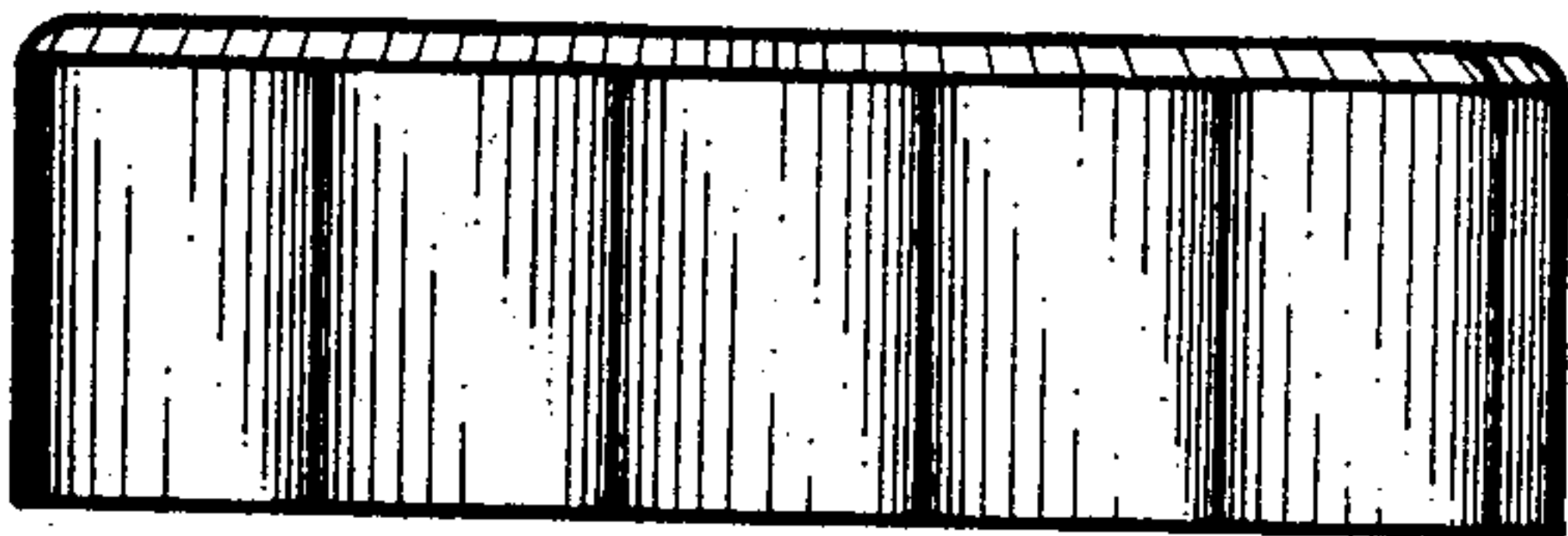

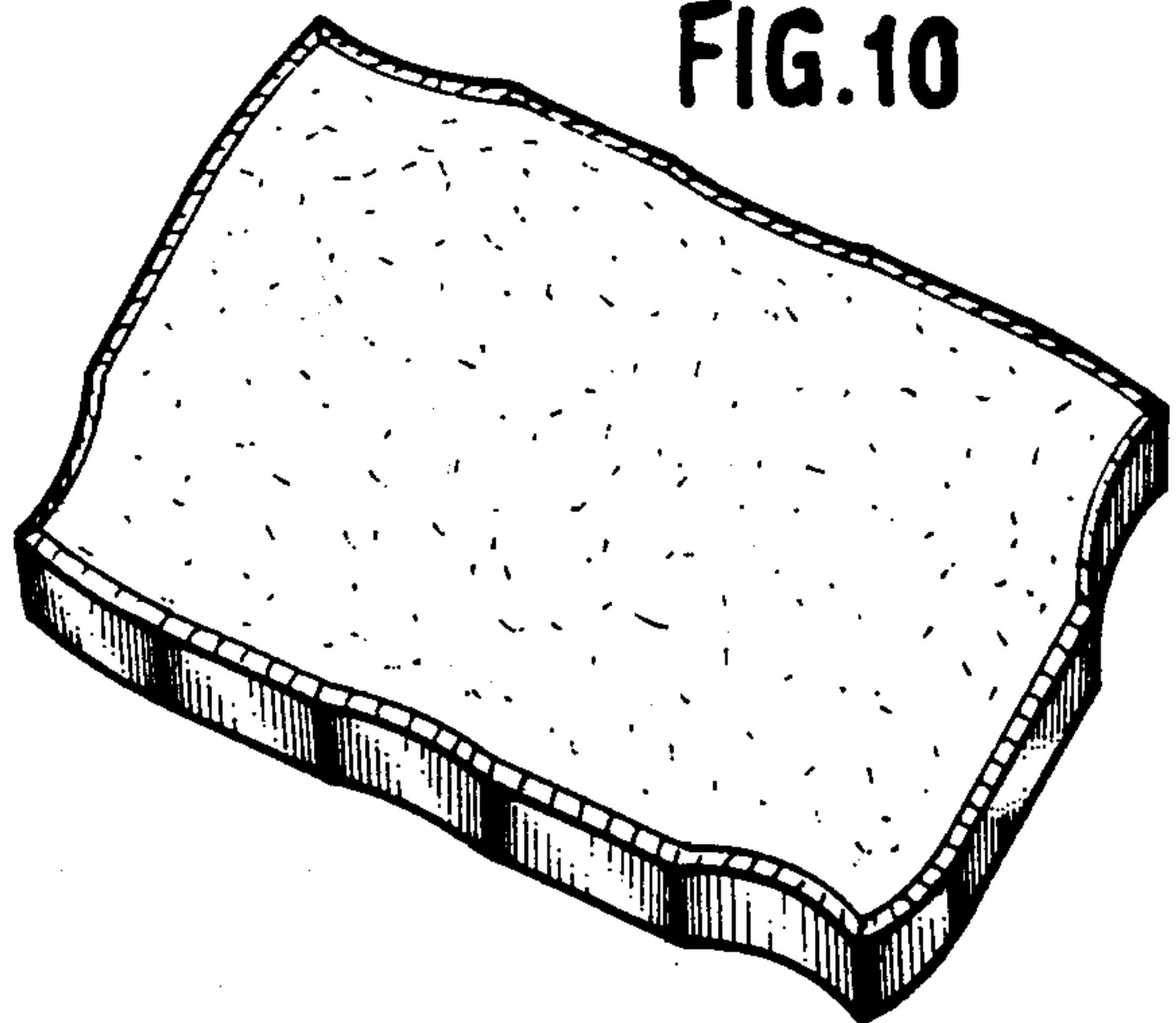

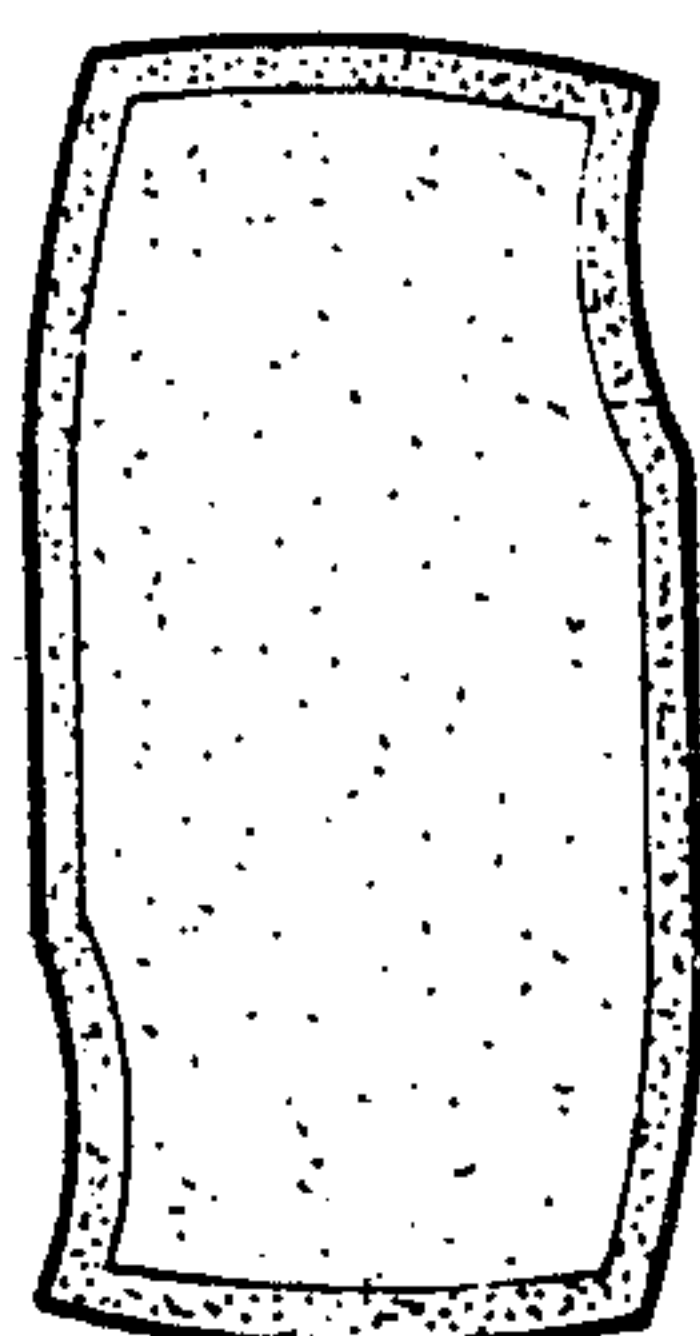

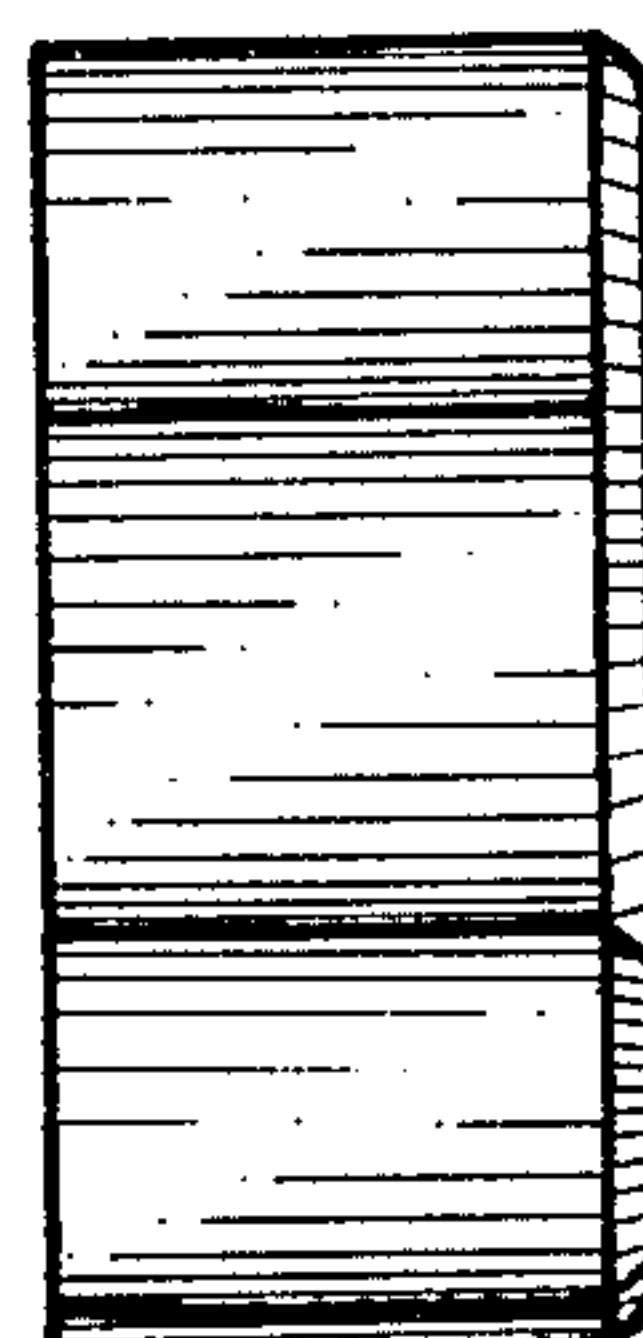

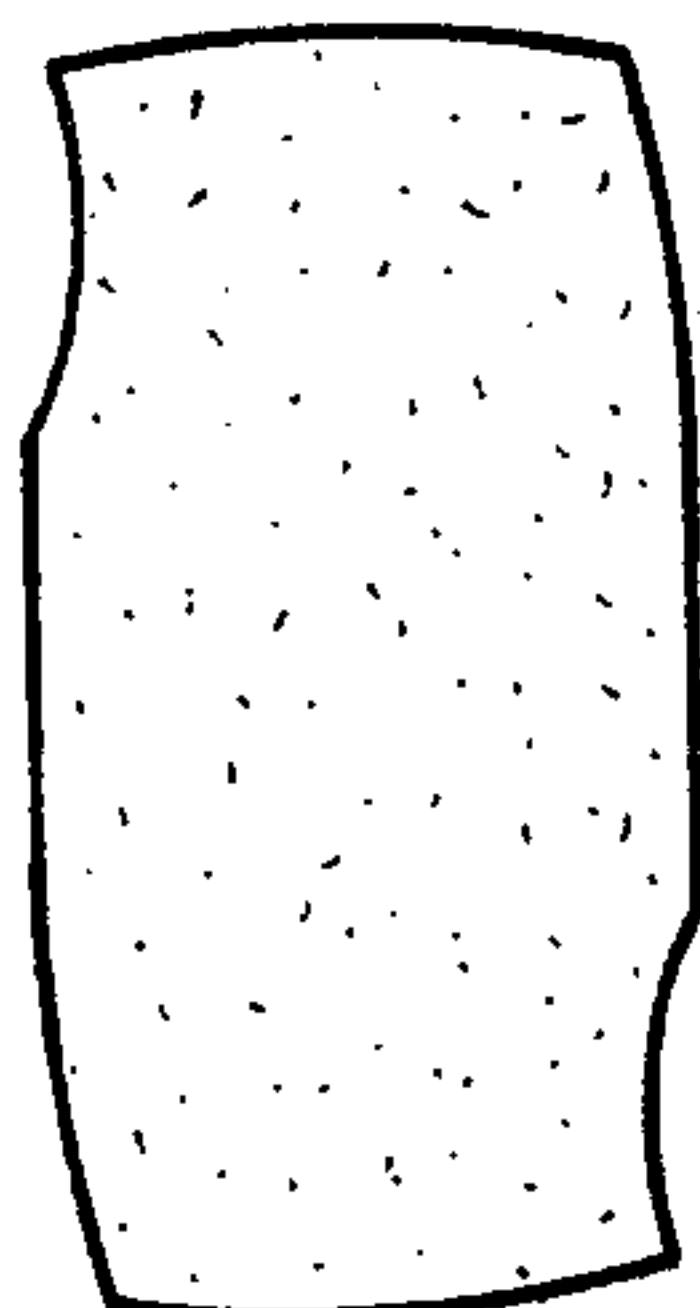

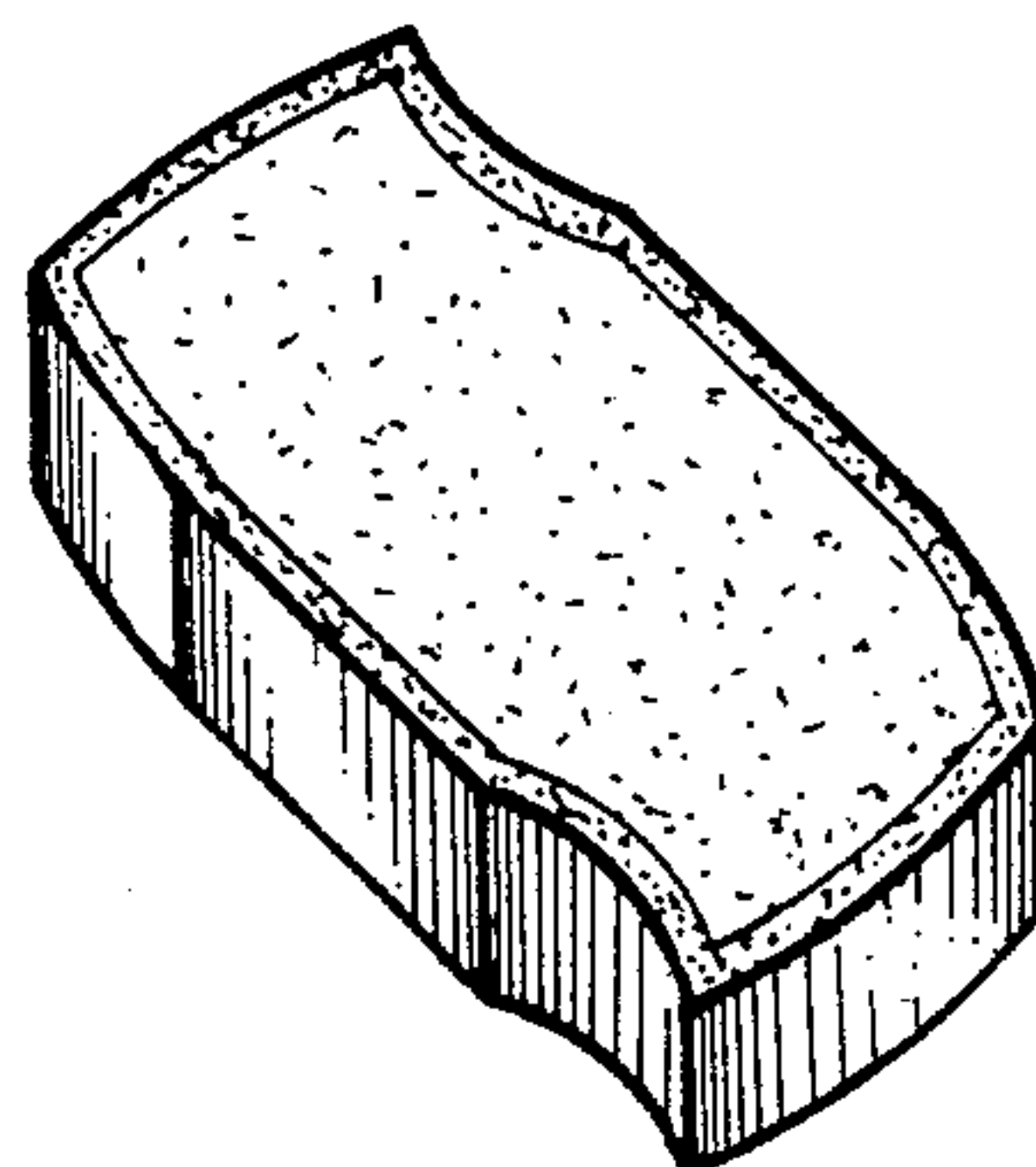

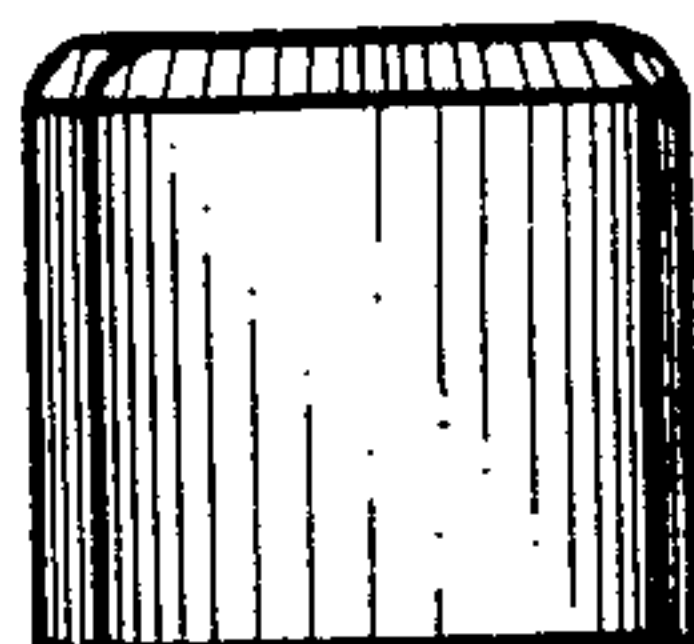
