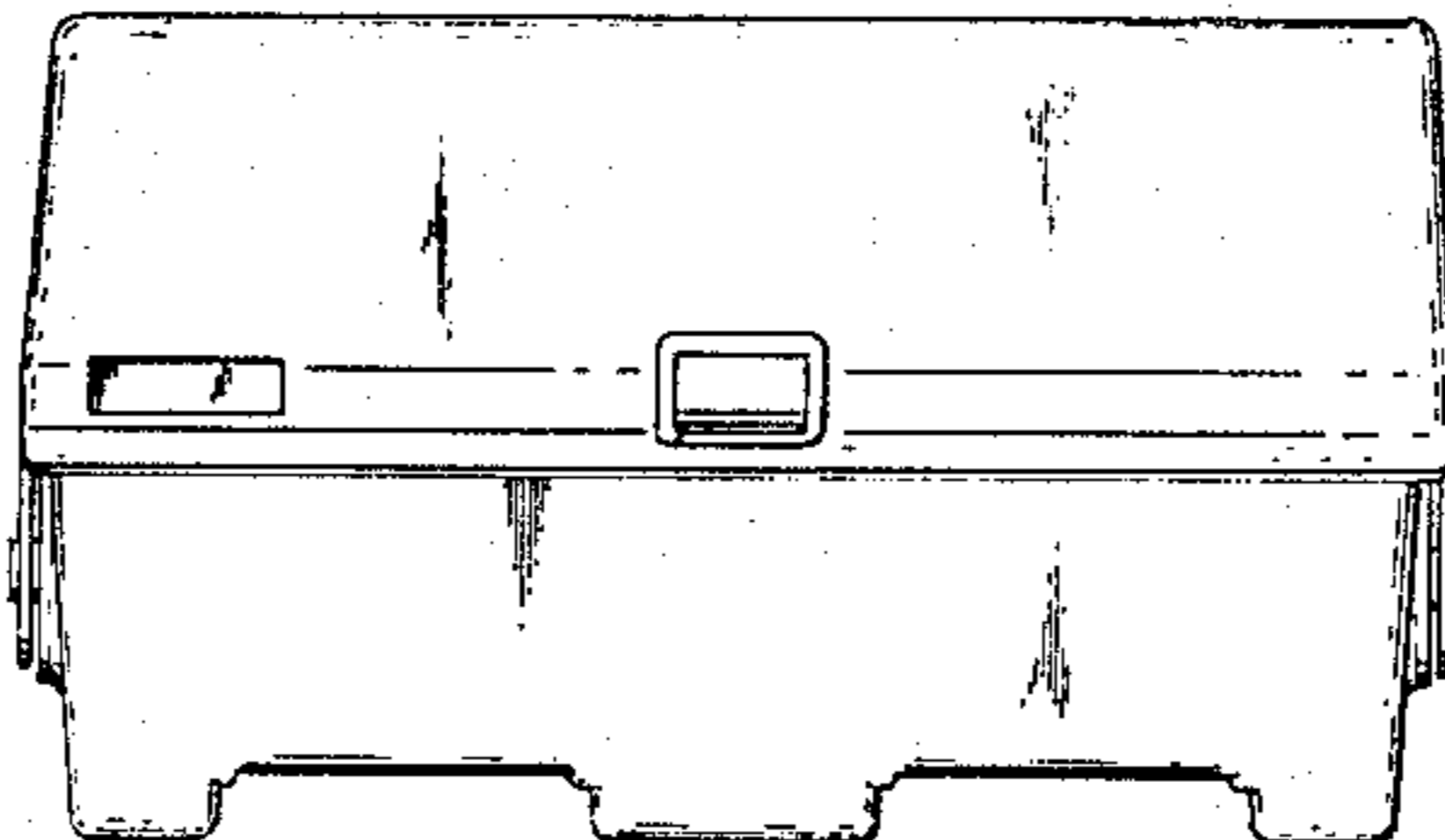
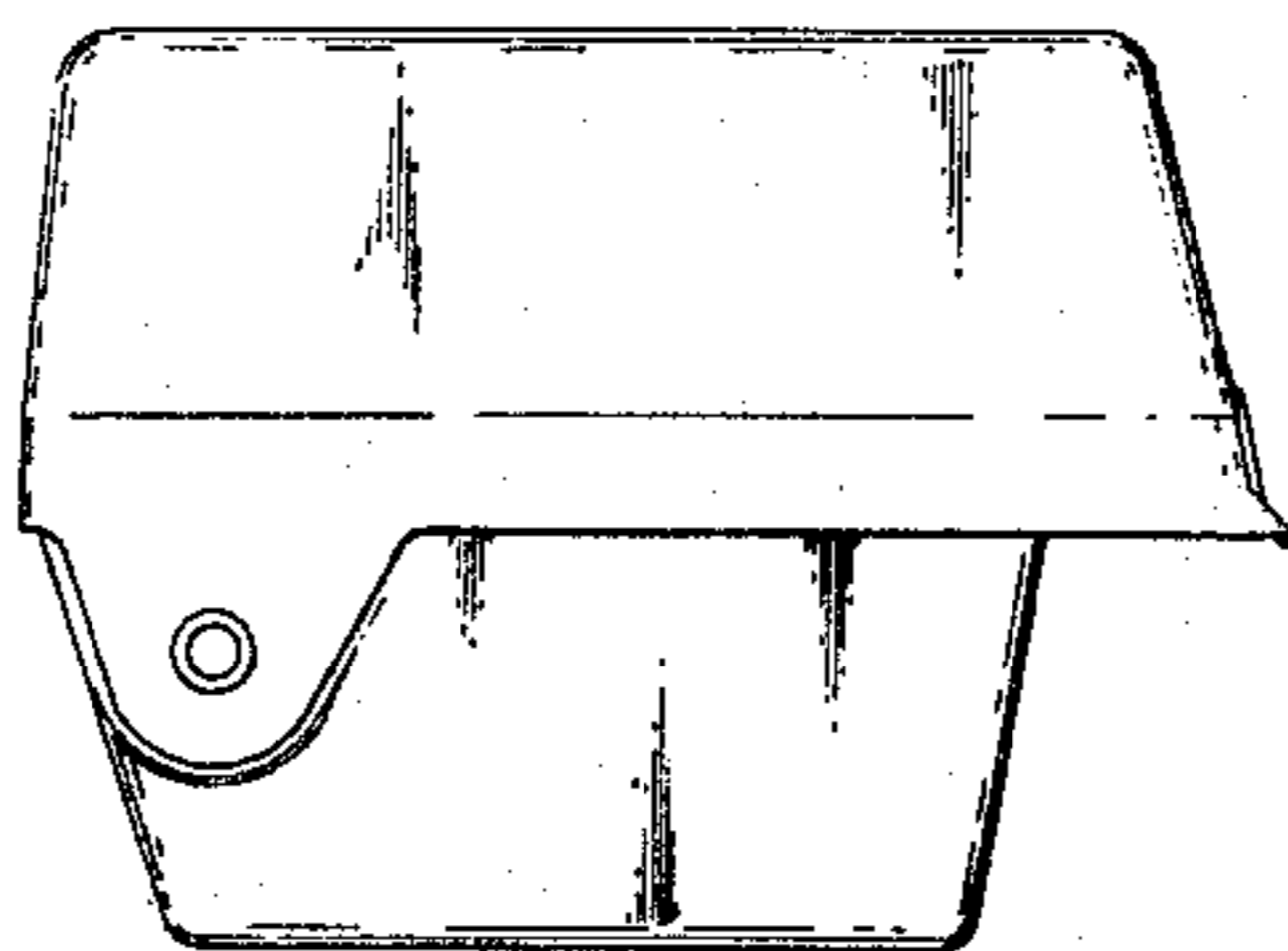

[57] CLAIM

The ornamental design for a disk storage and carrying case, substantially as shown and described.

DESCRIPTION

FIG. 1 is a left side elevational view of a disk storage and carrying case showing our new design, the right side being a mirror image thereof;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a left side elevational view of a second embodiment of the disk storage and carrying case, the right side elevational view being a mirror image thereof;
FIG. 7 is a front elevational view thereof;
FIG. 8 is a rear elevational view thereof;
FIG. 9 is a top plan view thereof; and
FIG. 10 is a bottom plan view thereof.



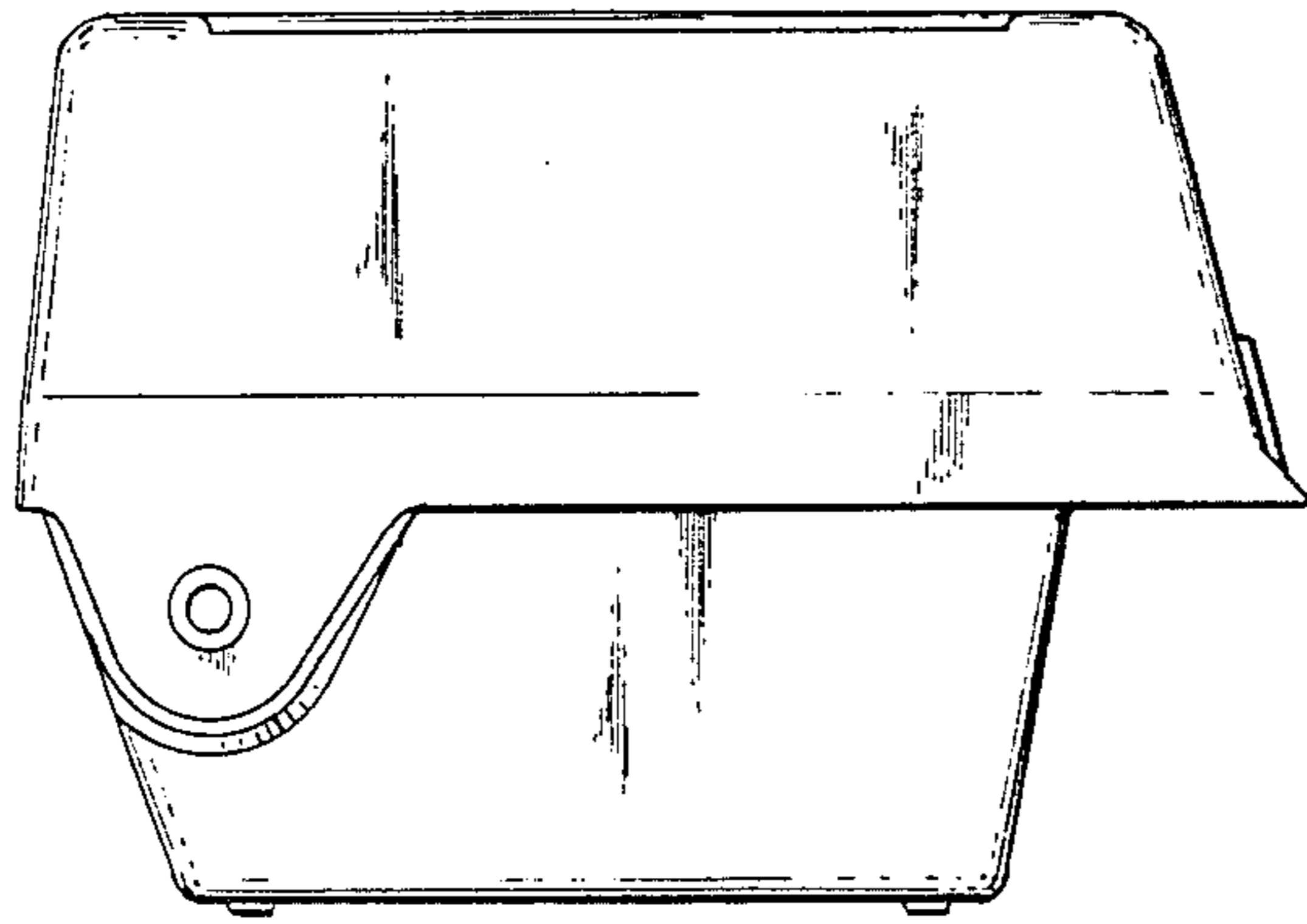

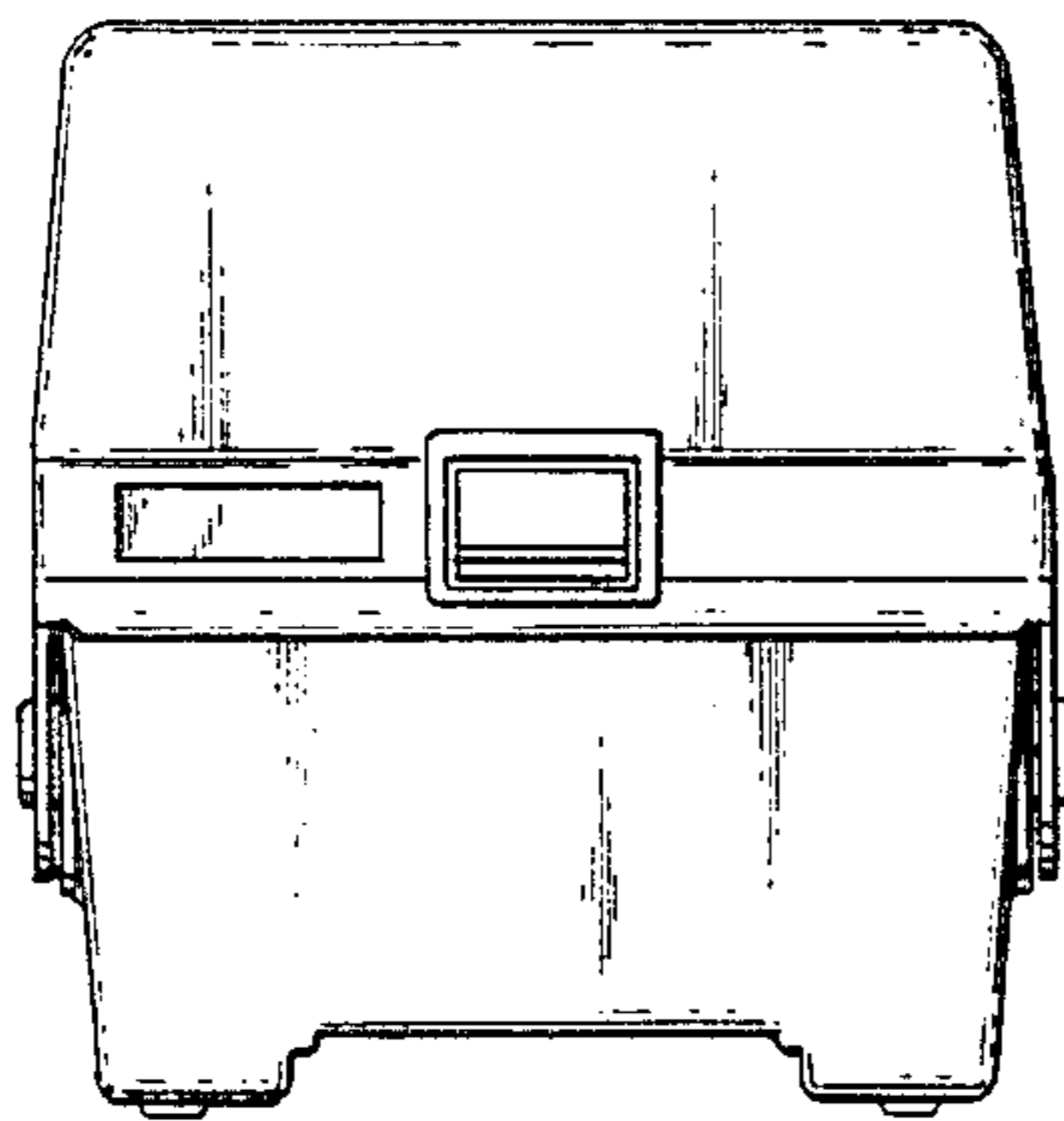

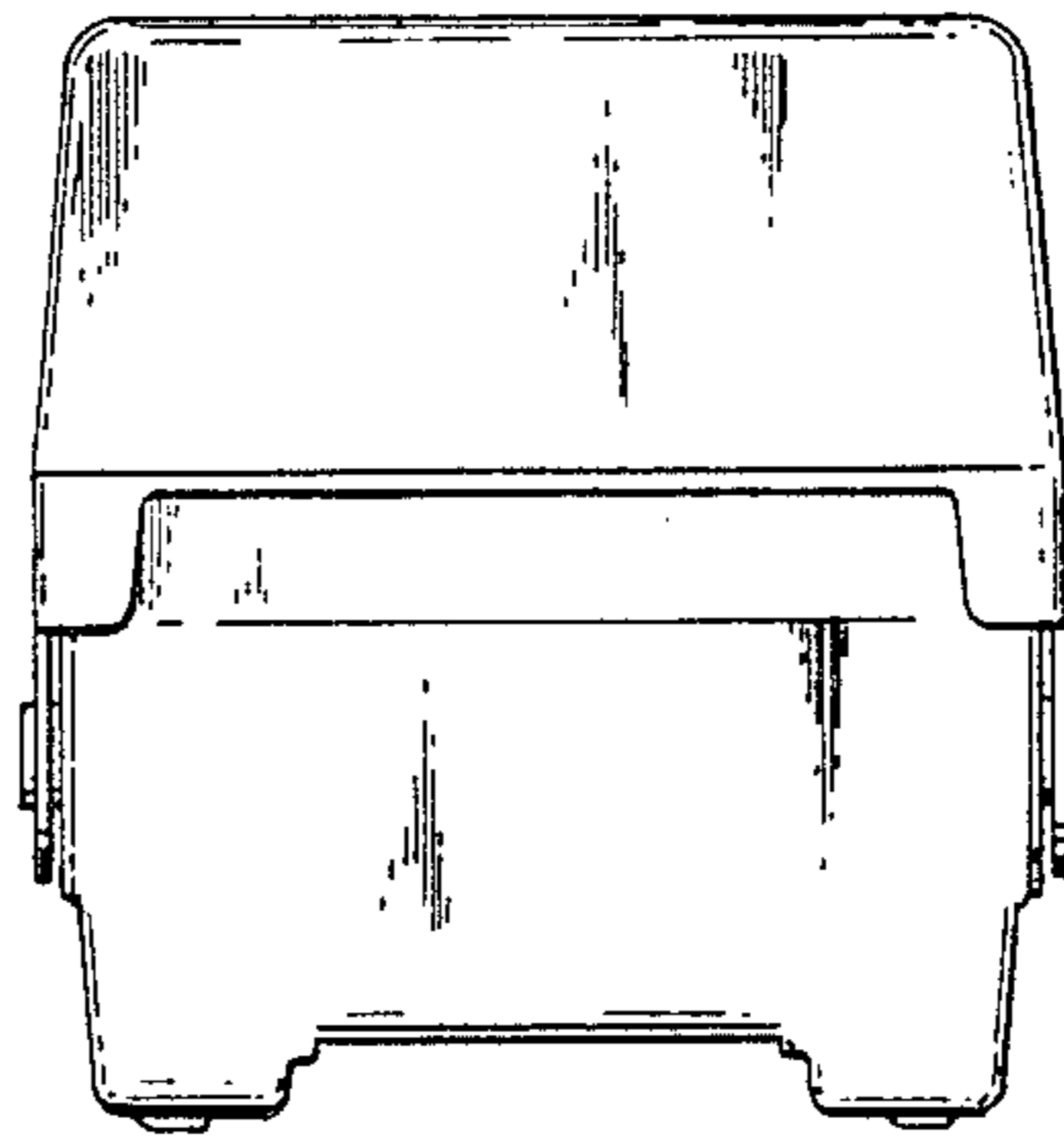

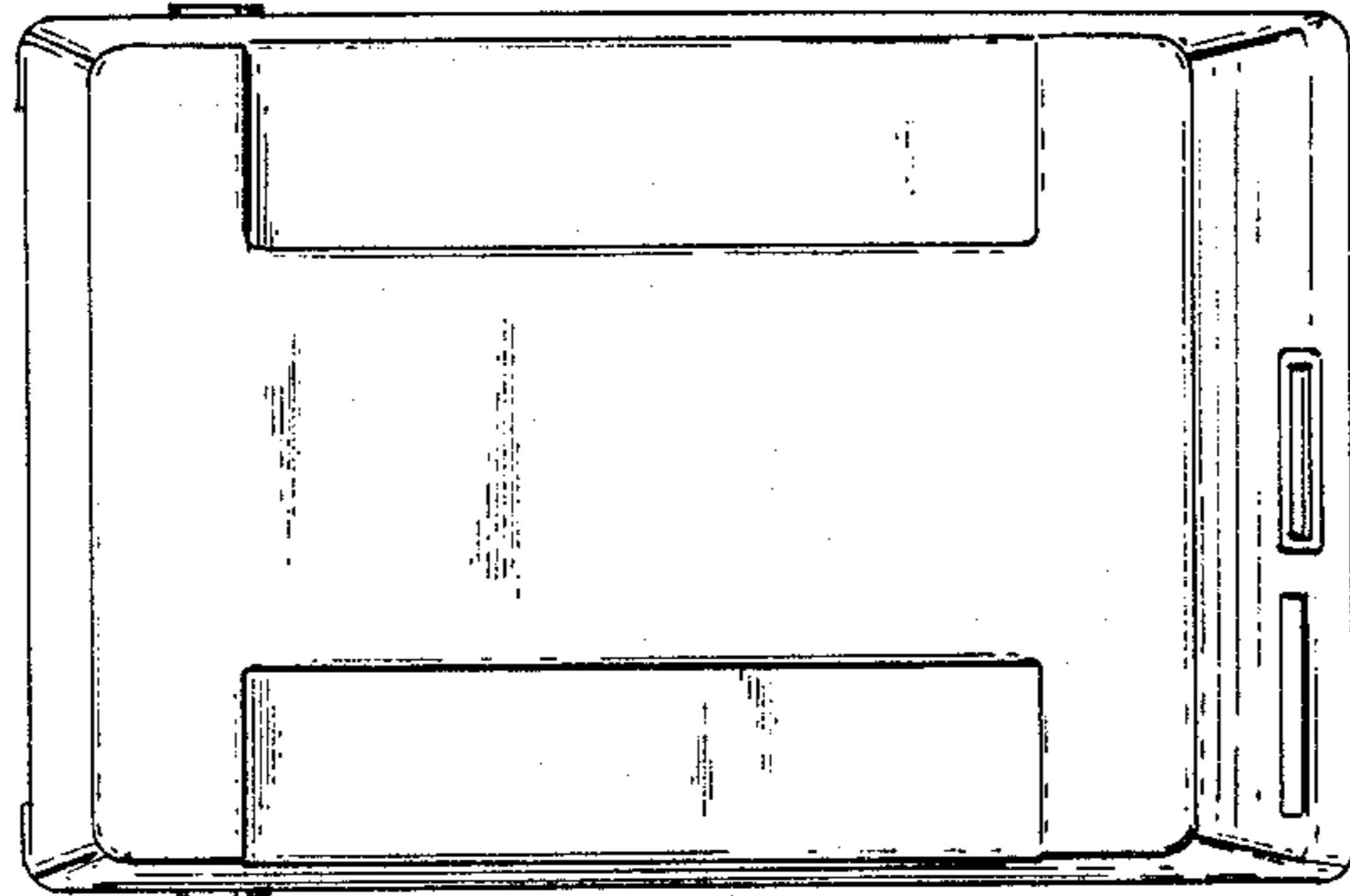
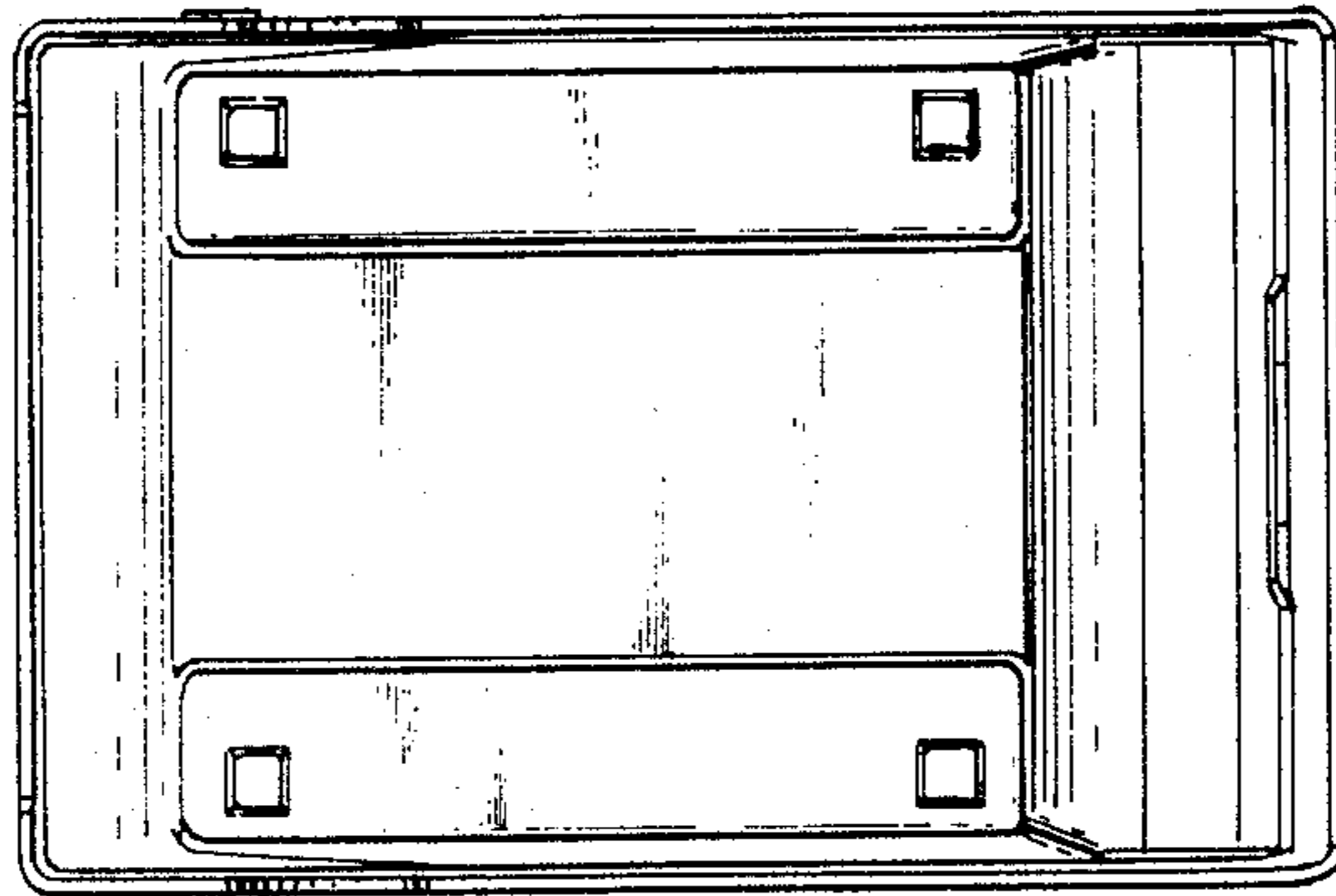

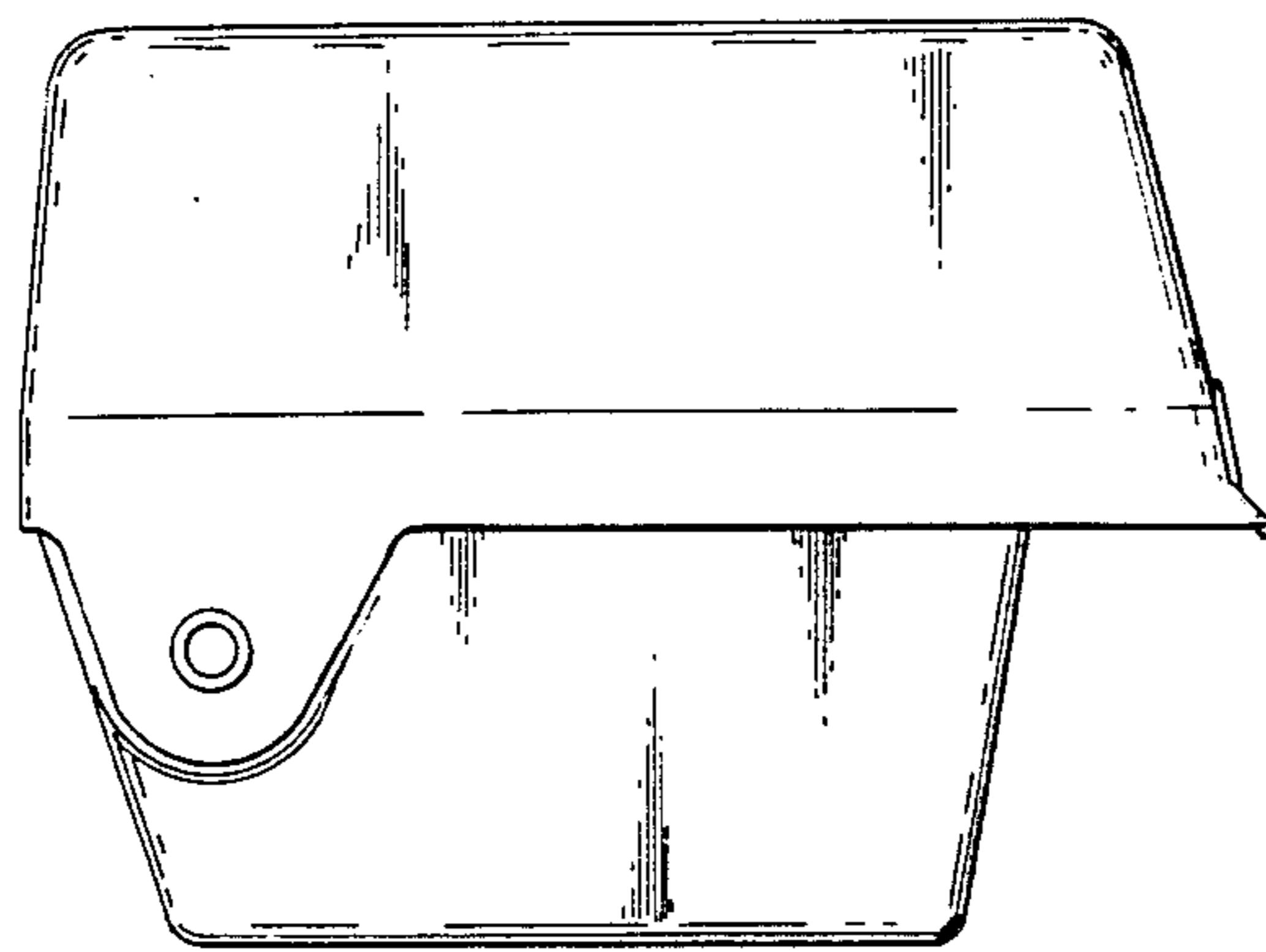

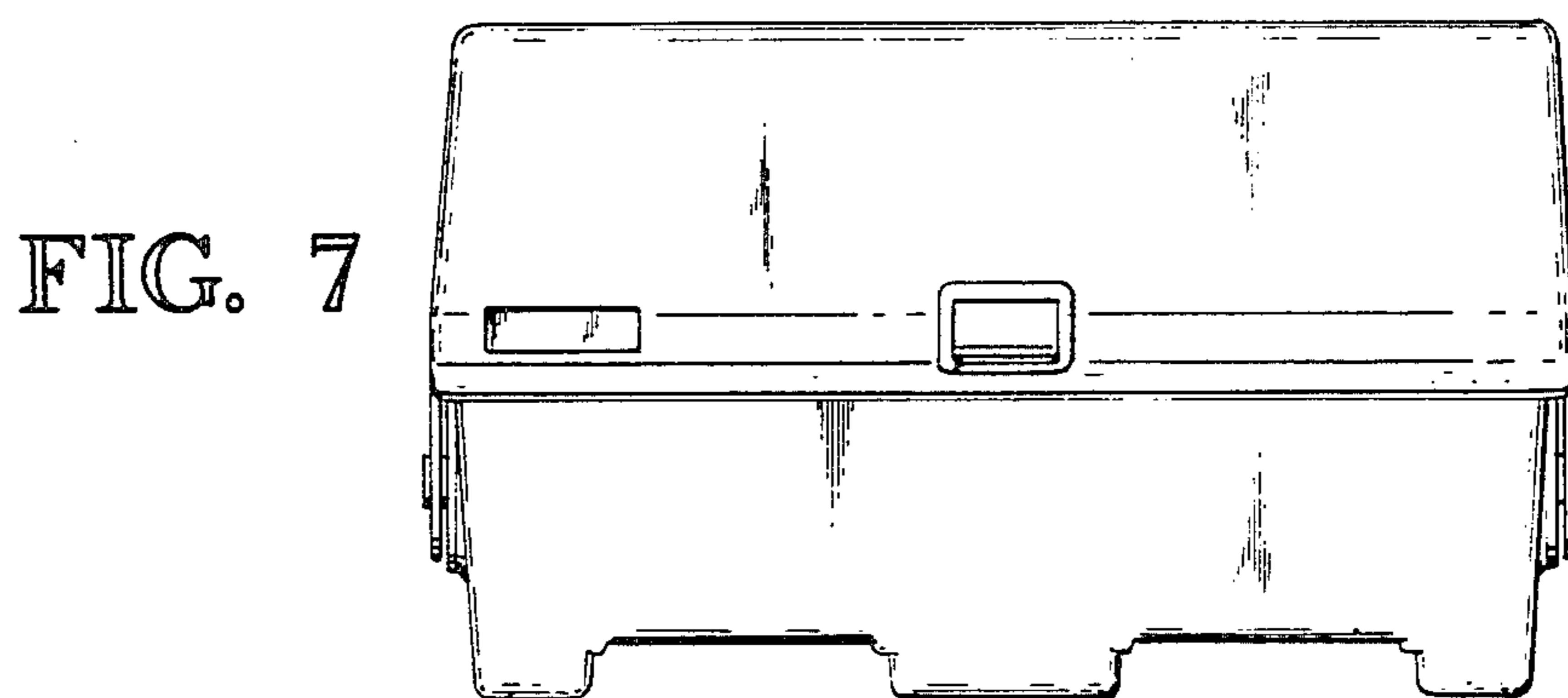

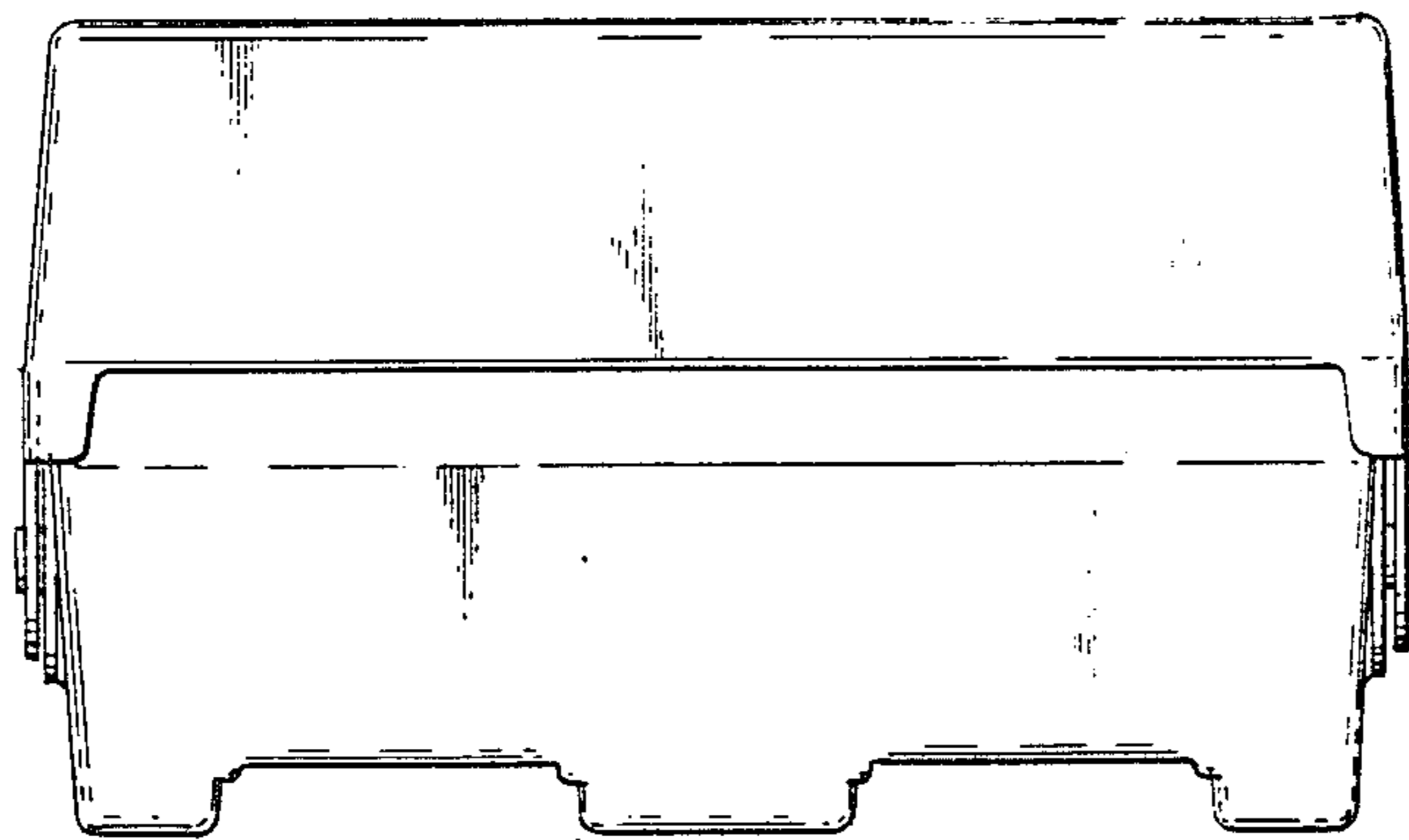

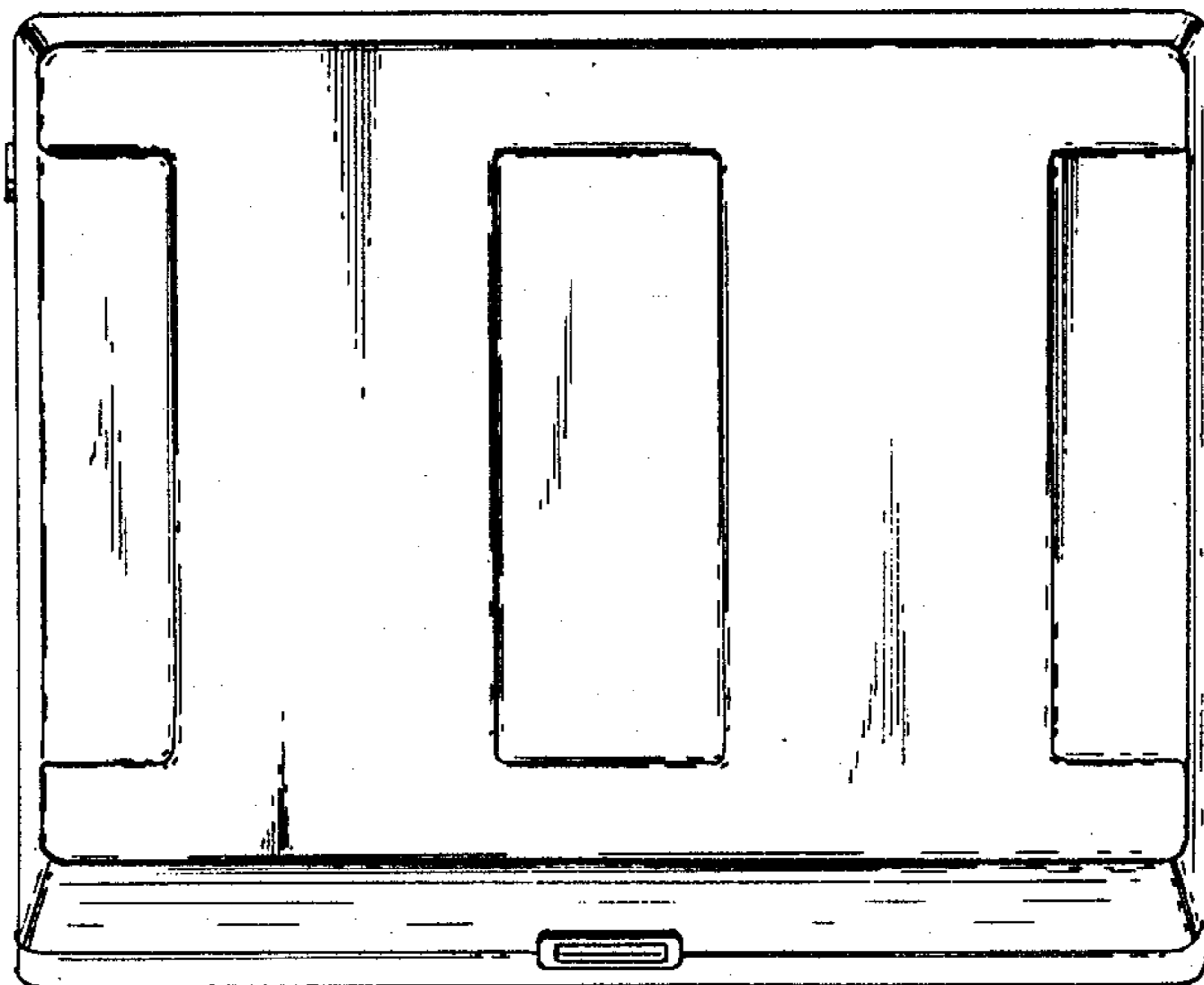
