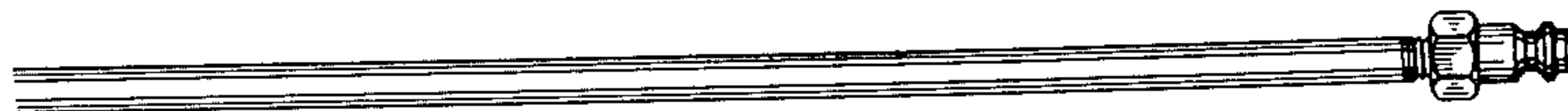

[57] **CLAIM**

The ornamental design for a spraying wand, as shown and described.

**DESCRIPTION**

FIG. 1 is a side elevational view of a spray wand showing my new design;  
 FIG. 2 is a top plan view thereof;  
 FIG. 3 is a bottom plan view thereof;  
 FIG. 4 is an enlarged forshortened side elevational view taken from plane 4—4 of FIG. 2;  
 FIG. 5 is an enlarged forshortened side elevational view taken from plane 5—5 on FIG. 2;  
 FIG. 6 is an enlarged forshortened side elevational view taken from plane 6—6 on FIG. 2;  
 FIG. 7 is an enlarged forshortened side elevational view taken from plane 7—7 on FIG. 2;  
 FIG. 8 is a cross sectional view taken on line 8—8 of FIG. 4;  
 FIG. 9 is a cross sectional view taken on line 9—9 of FIG. 4;  
 FIG. 10 is a cross sectional view taken on line 10—10 of FIG. 4;  
 FIG. 11 is a side elevational view of a modified form of the spray wand shown in FIG. 1;  
 FIG. 12 is an enlarged forshortened perspective view of FIG. 11;  
 FIG. 13 is a plan view taken from plane 13—13 on FIG. 11;  
 FIG. 14 is a plan view taken from plane 14—14 on FIG. 11;  
 FIG. 15 is an enlarged forshortened side elevational view taken from plane 15—15 on FIG. 13;  
 FIG. 16 is an enlarged forshortened side elevational view taken from plane 16—16 on FIG. 11;  
 FIG. 17 is an enlarged forshortened side elevational view taken from plane 17—17 on FIG. 13;  
 FIG. 18 is an enlarged forshortened side elevational view taken from plane 18—18 on FIG. 13;  
 FIG. 19 is a cross sectional view taken on line 19—19 of FIG. 15;  
 FIG. 20 is a cross sectional view taken on line 20—20 of FIG. 15;  
 FIG. 21 is a cross sectional view taken on line 21—21 of FIG. 15.  
 It is to be understood that the connecting tube has been broken away in FIGS. 4 through 7, 11 and 15 through 18 for convenience of illustration.



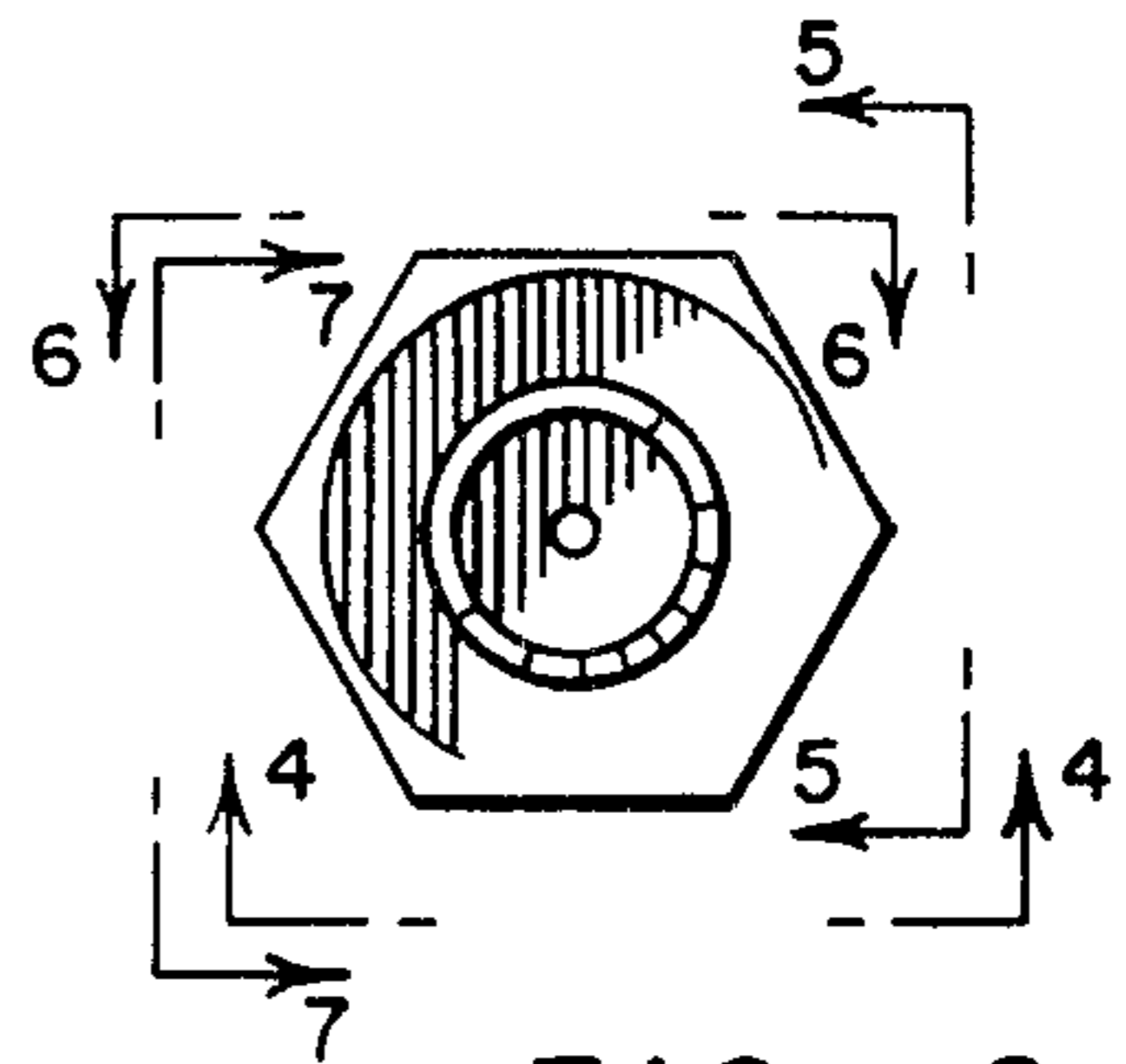
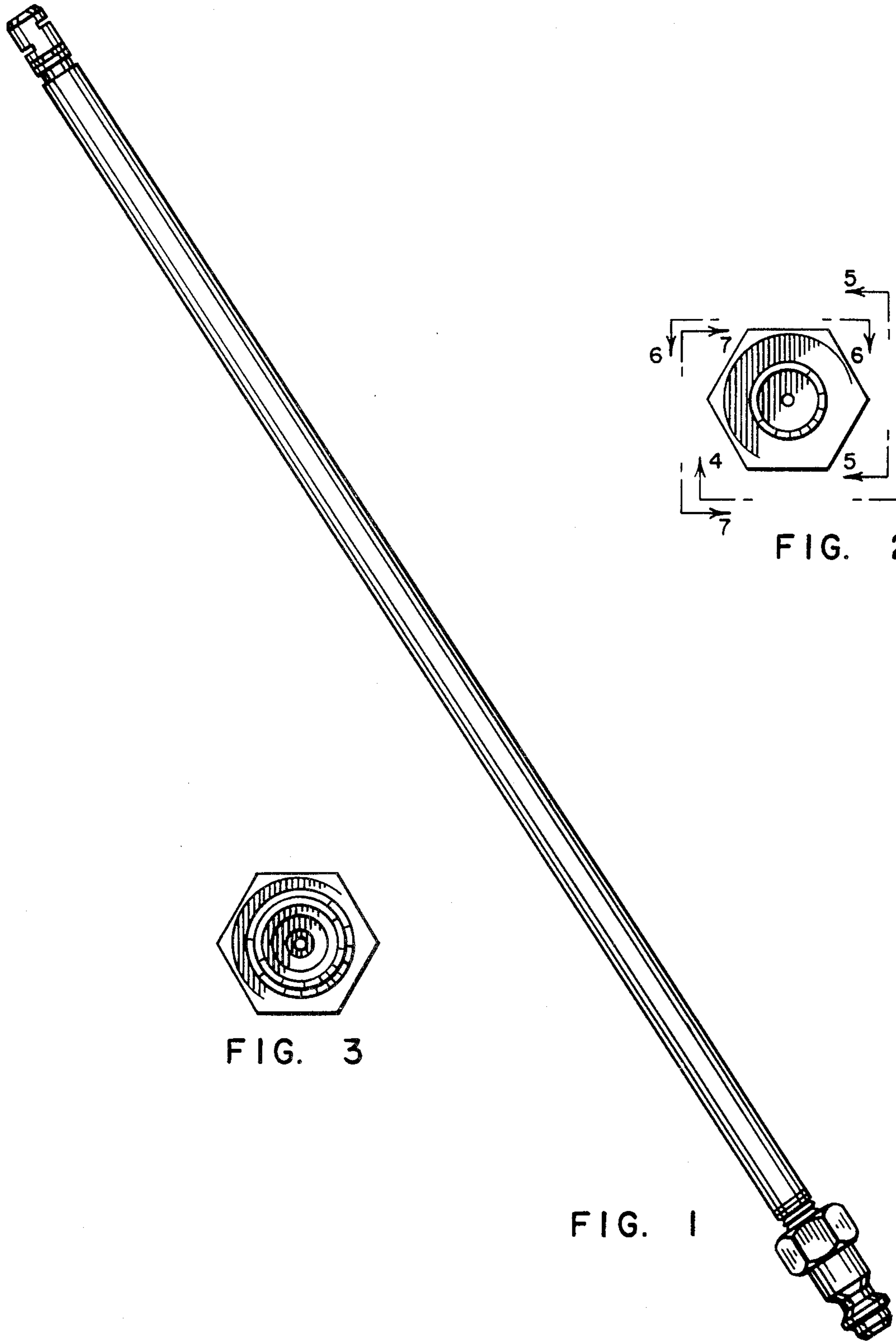

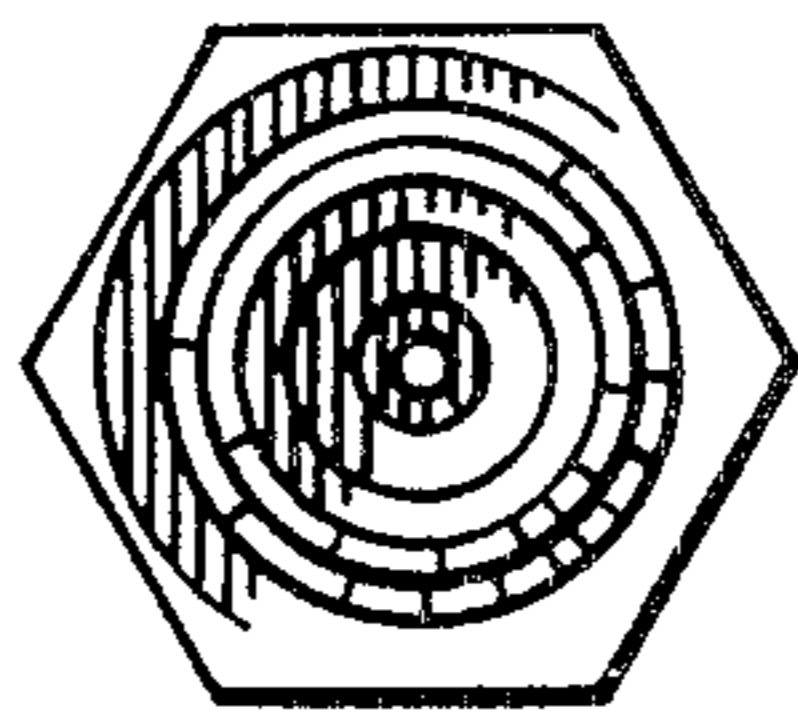

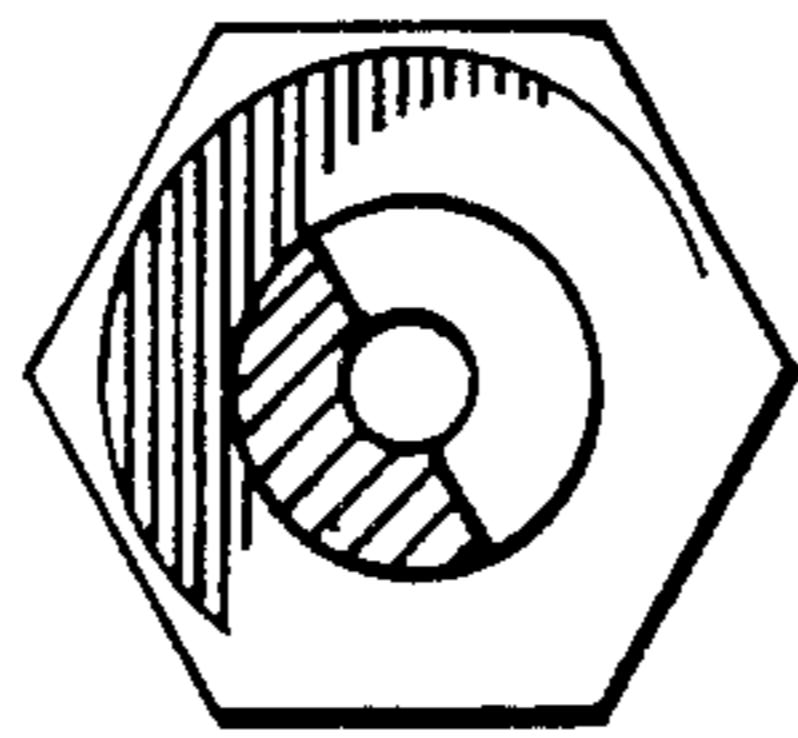

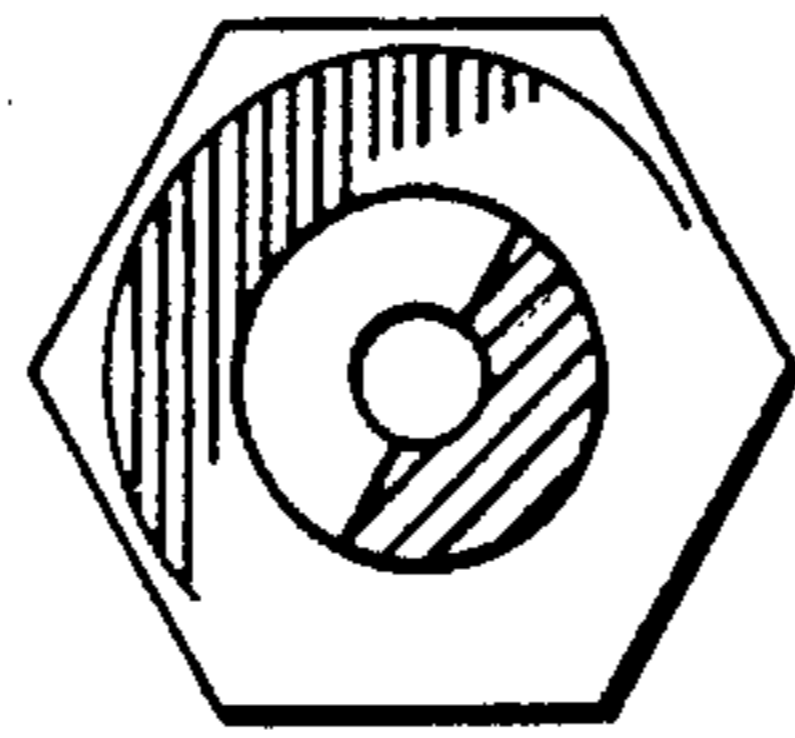

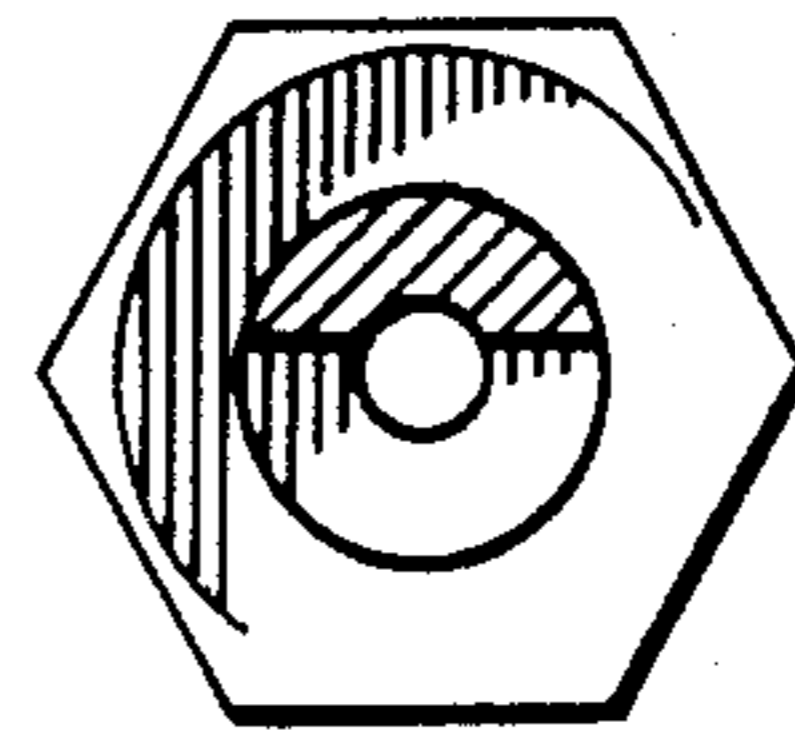

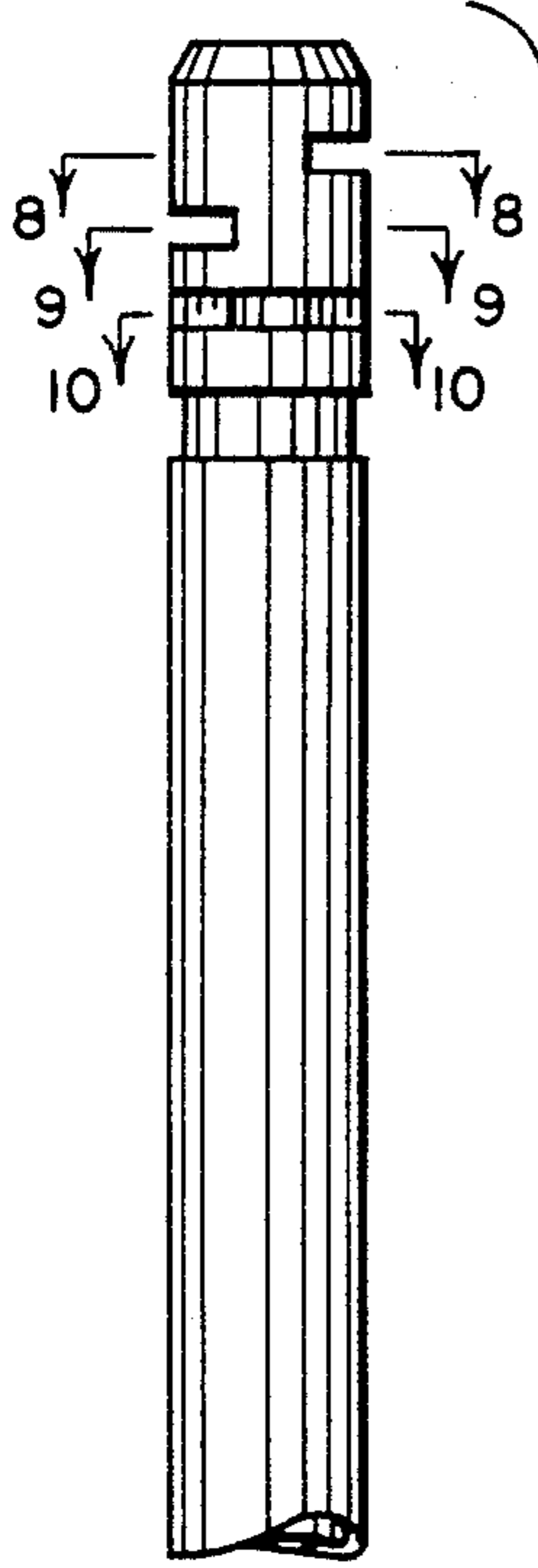

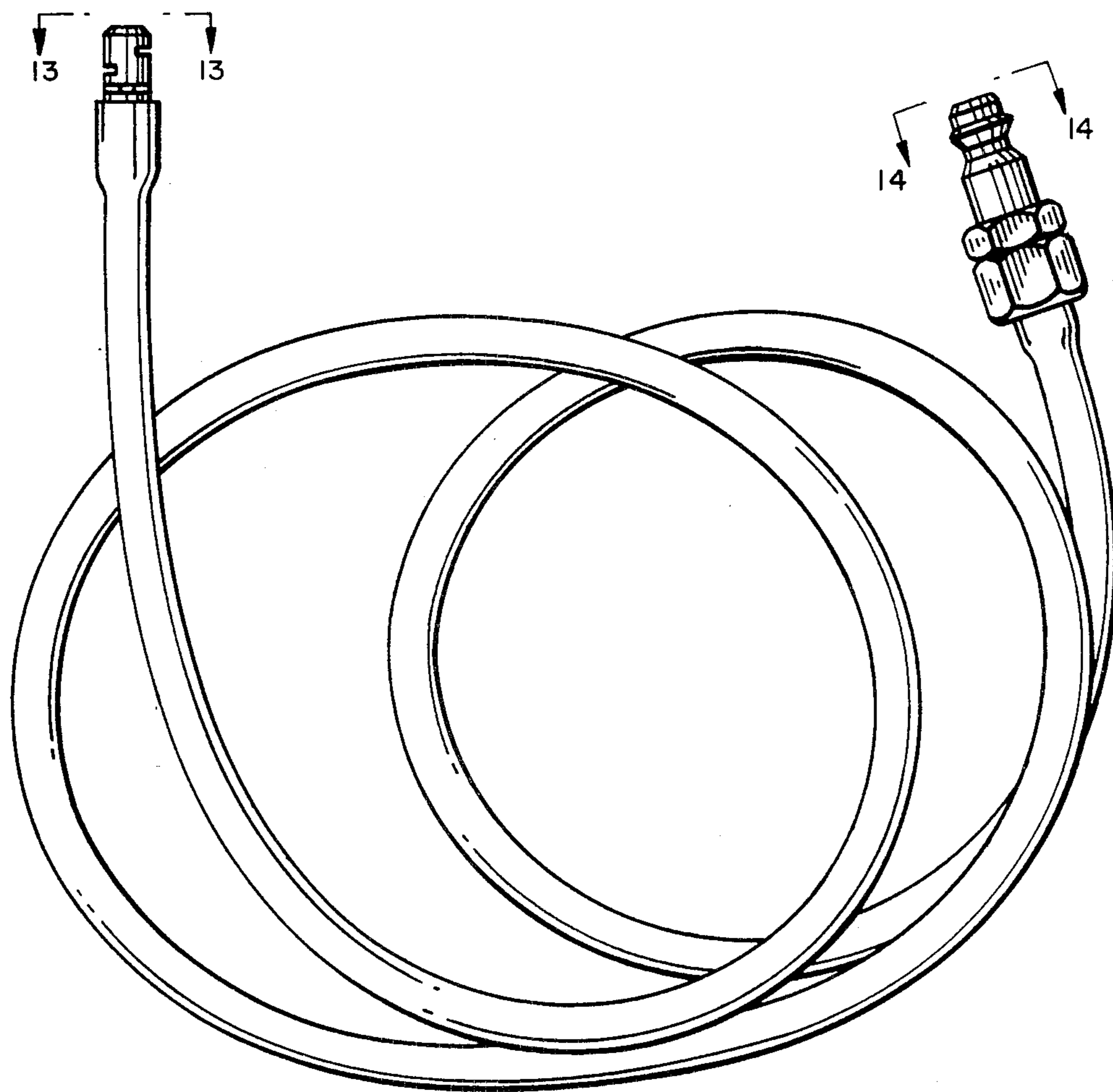

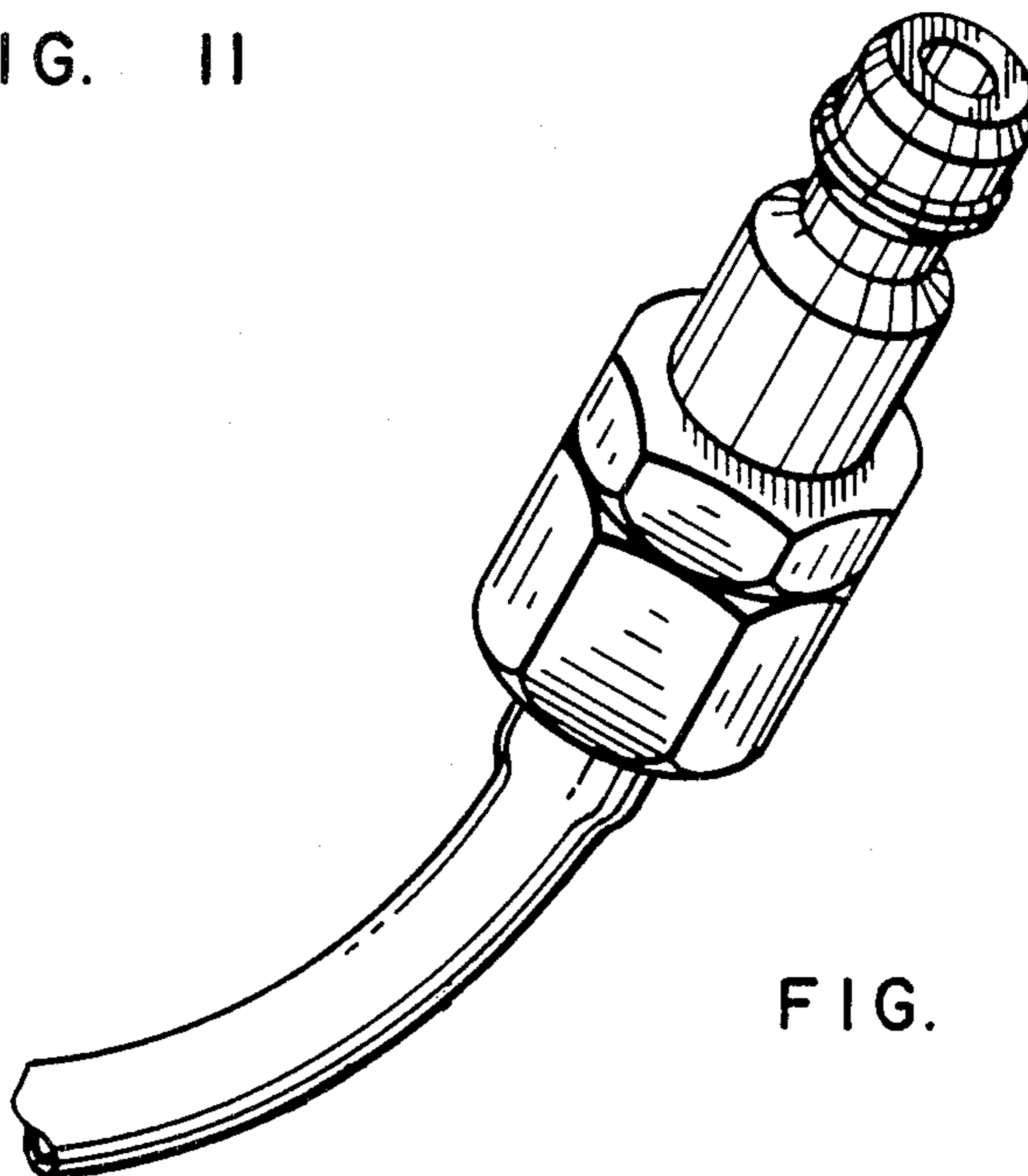
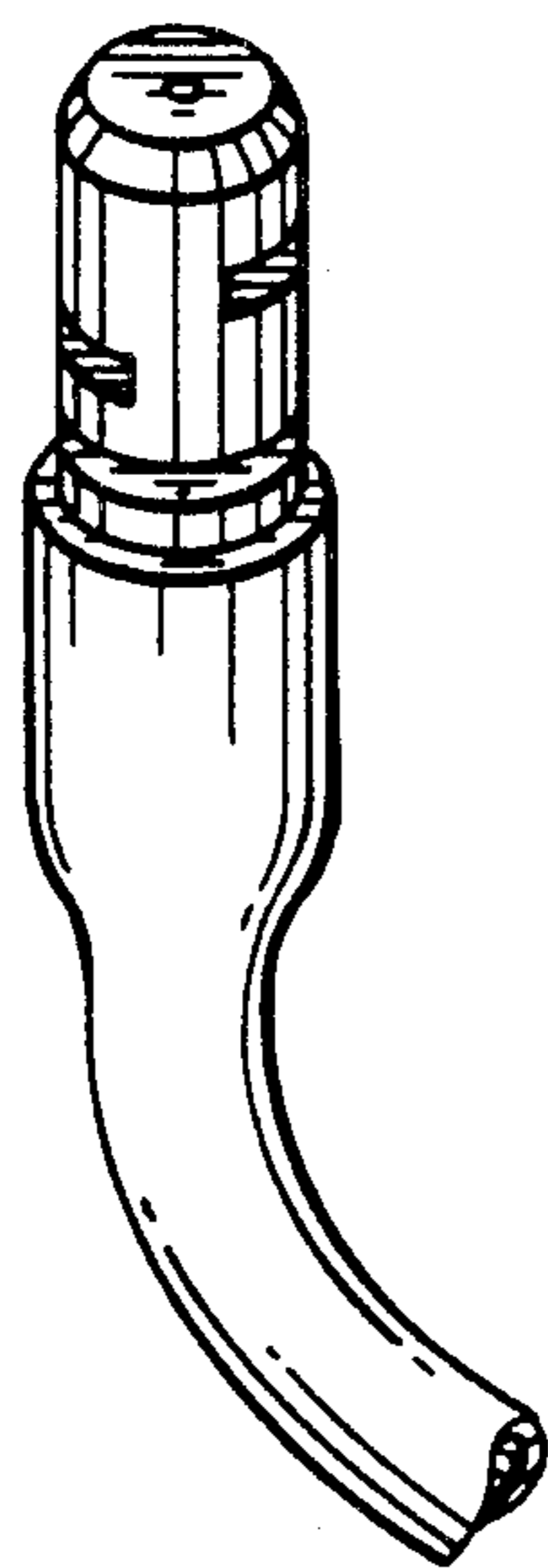

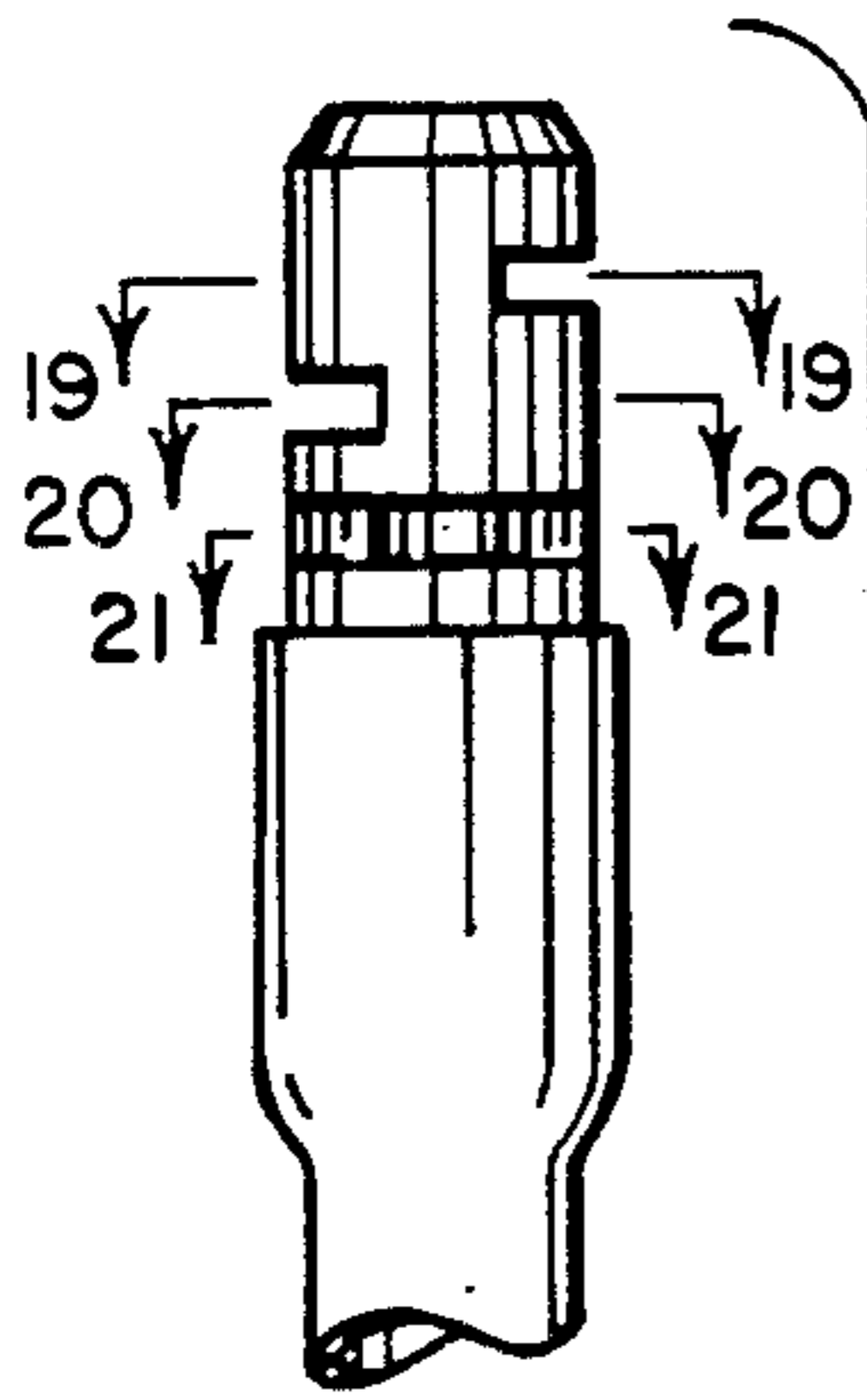

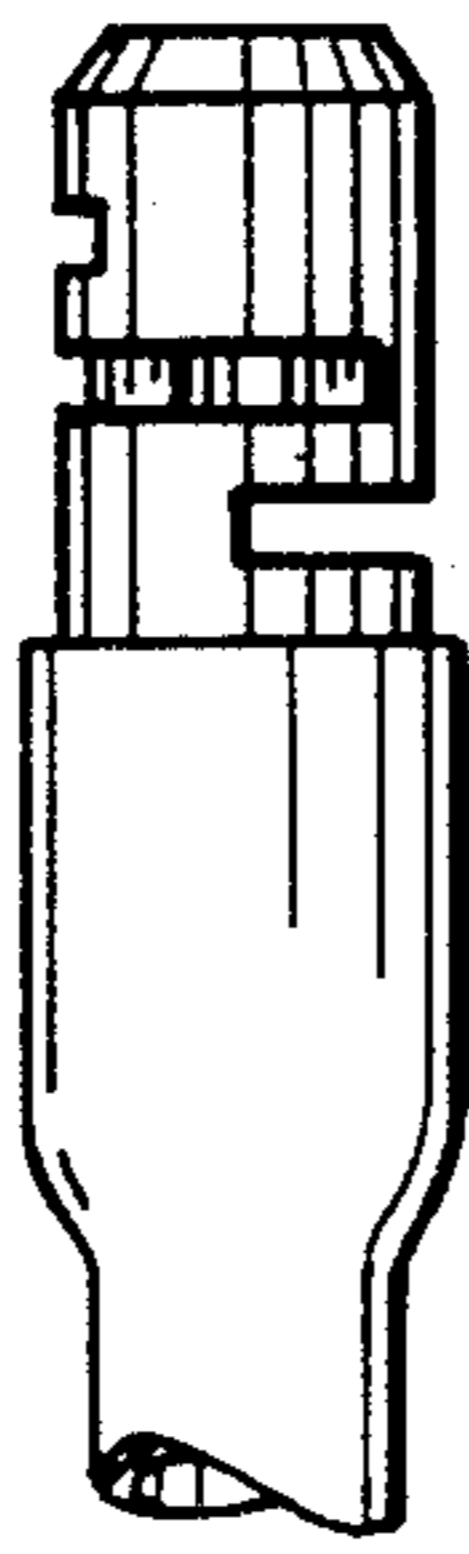

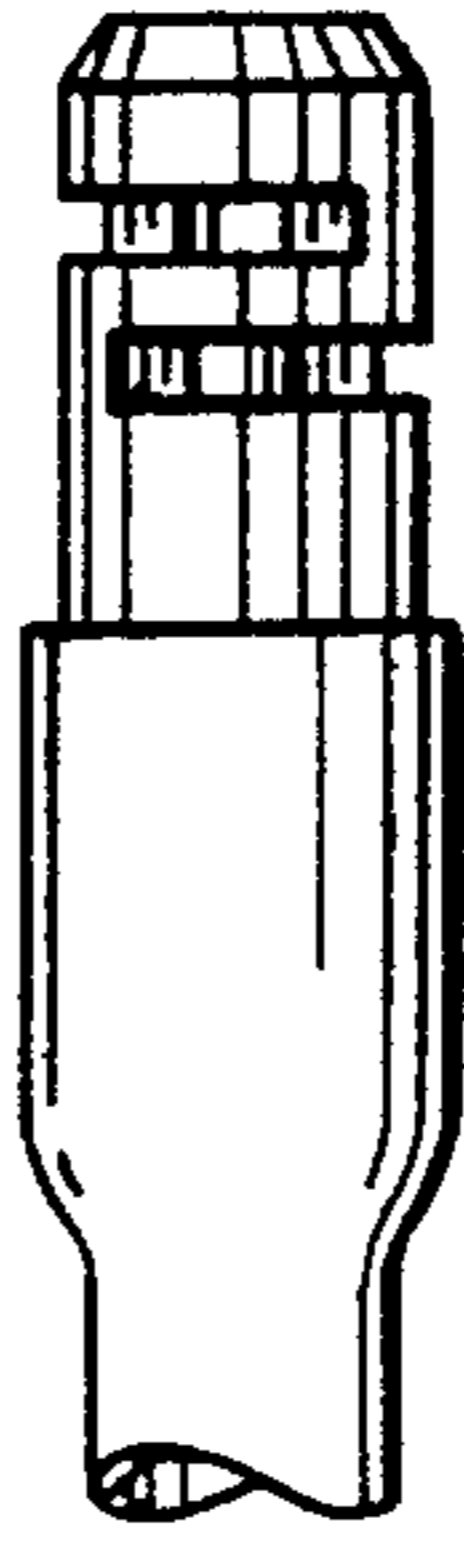

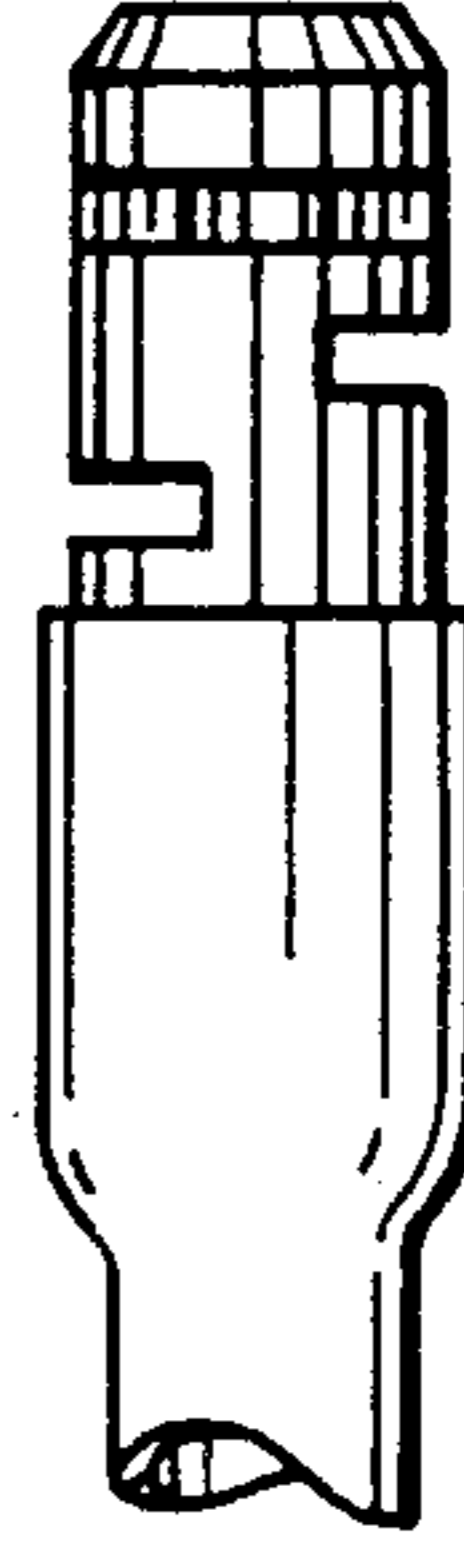

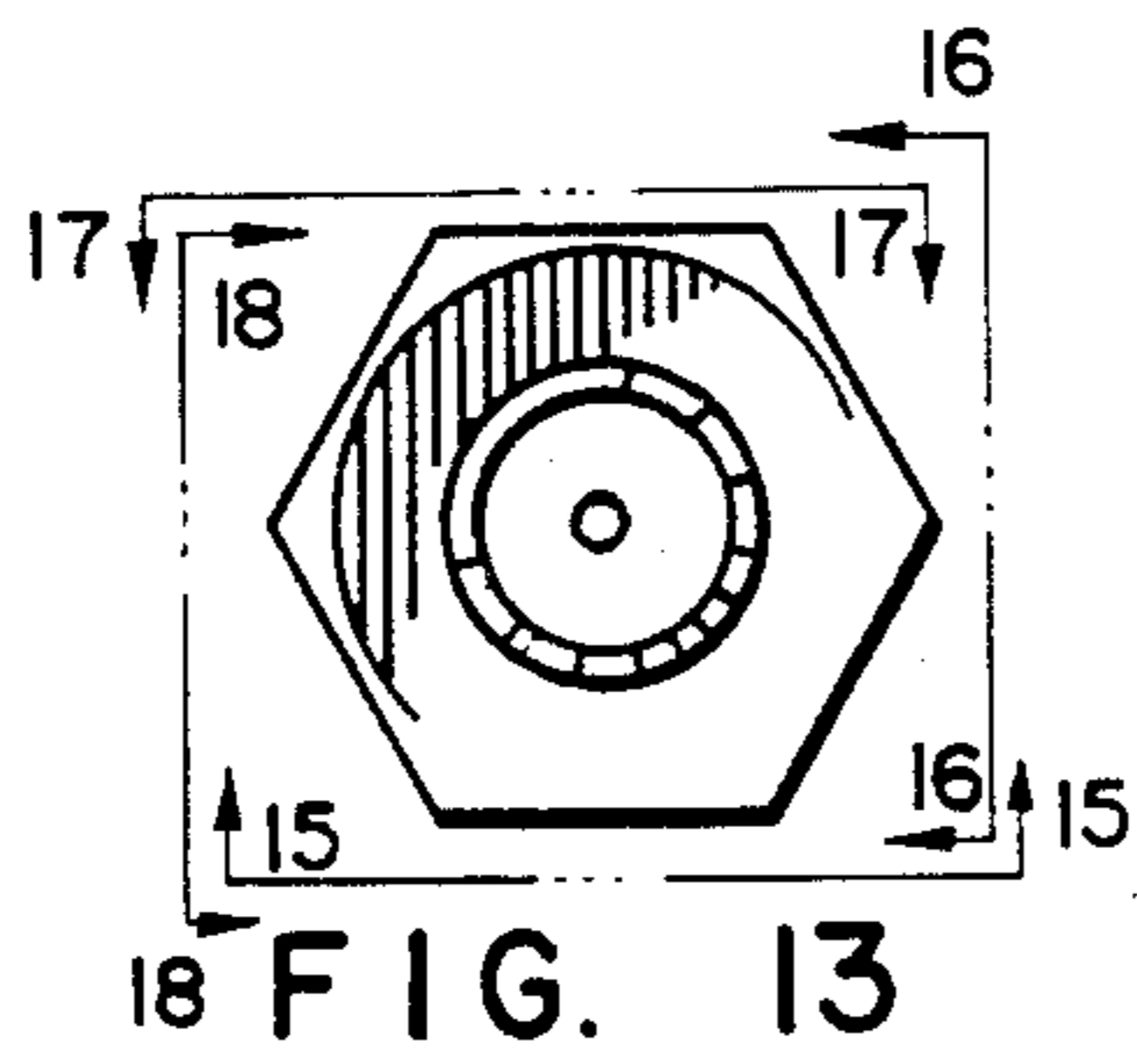
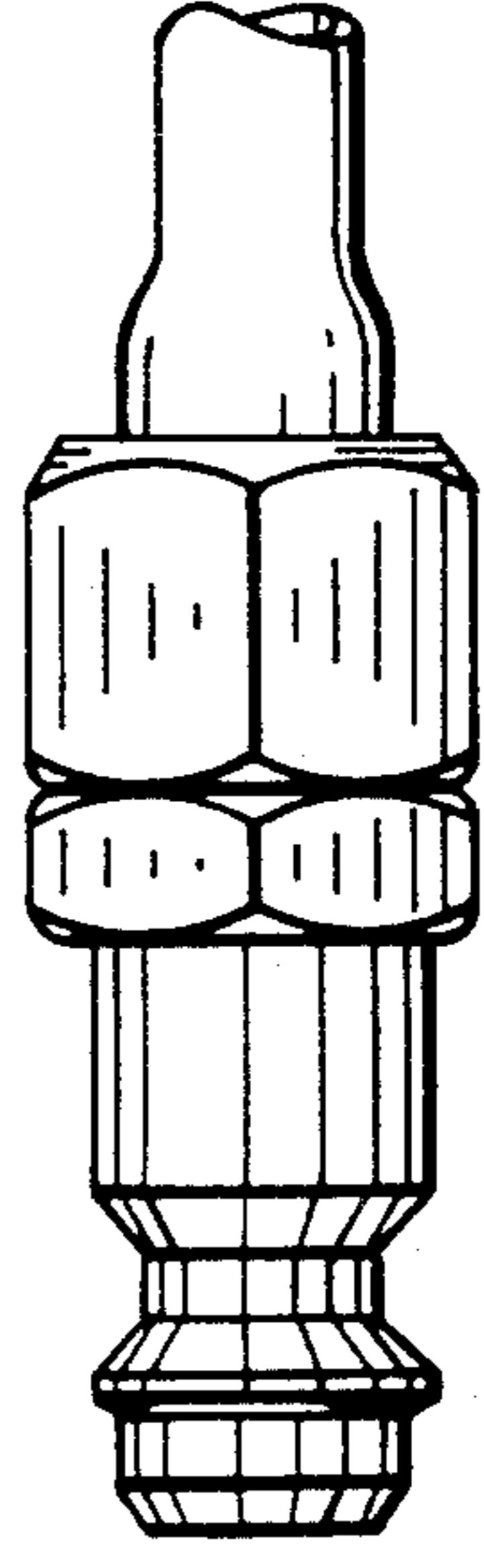
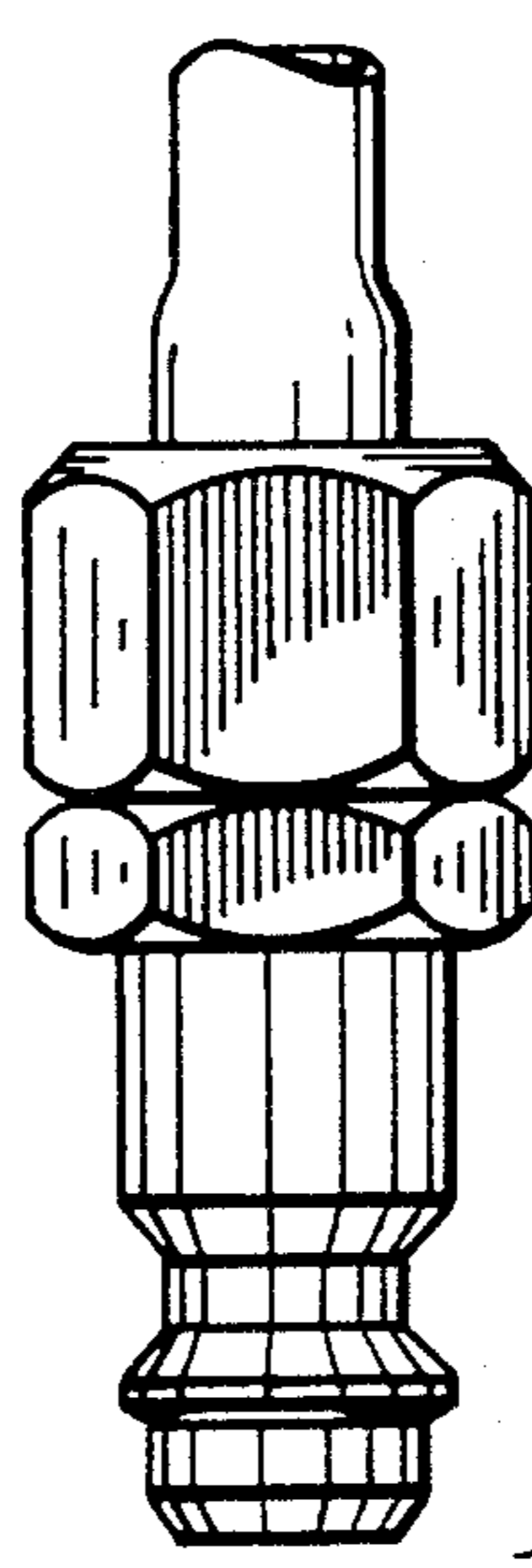
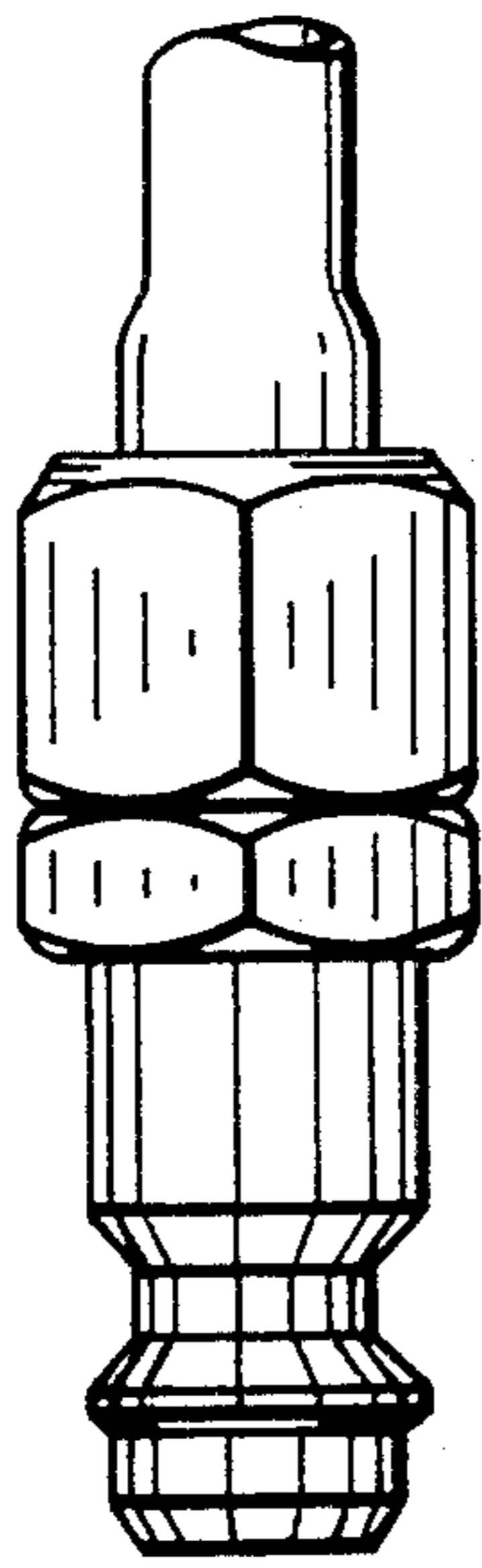
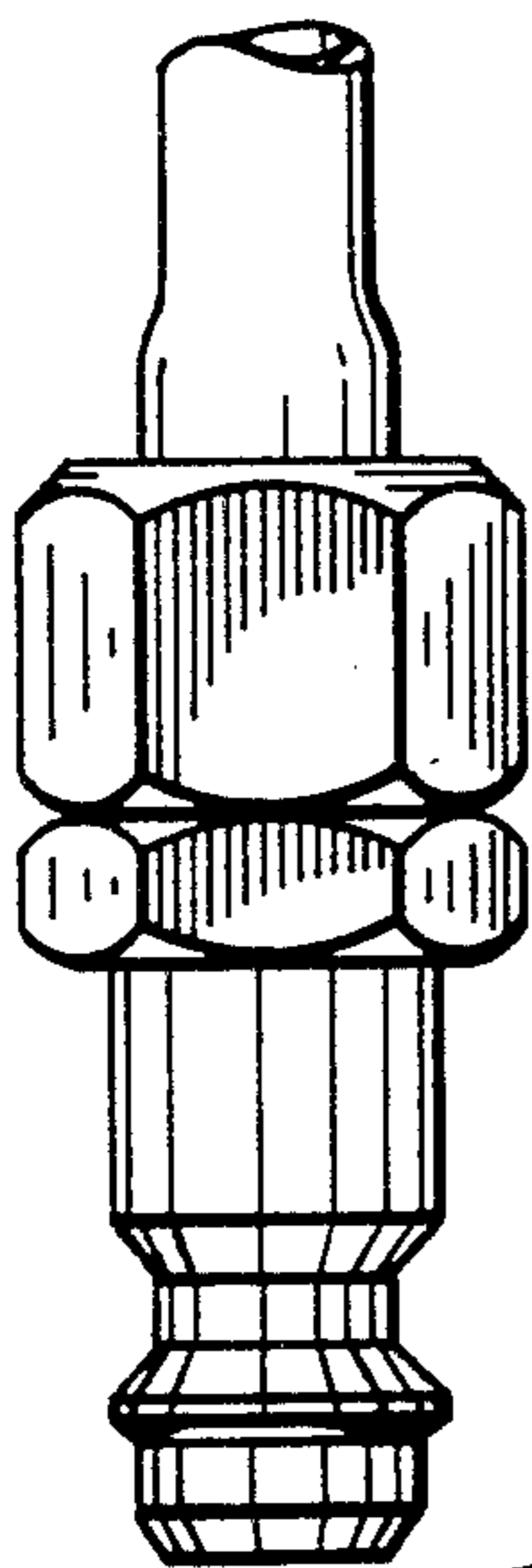

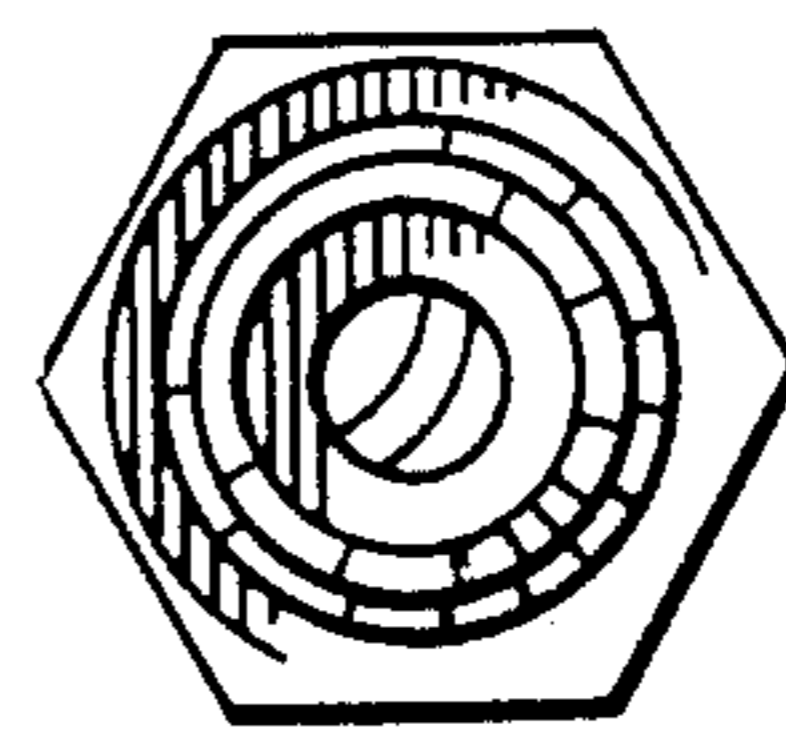

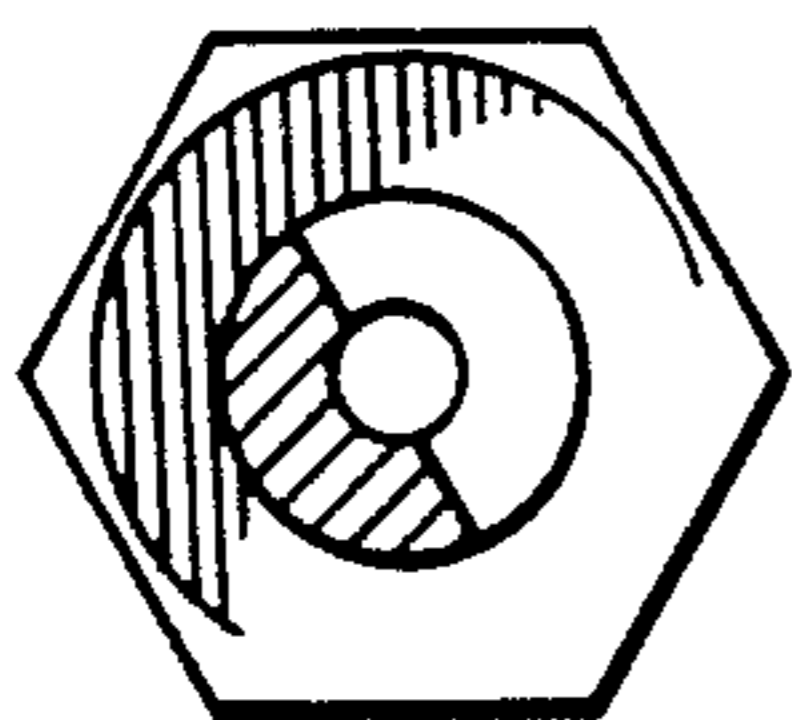

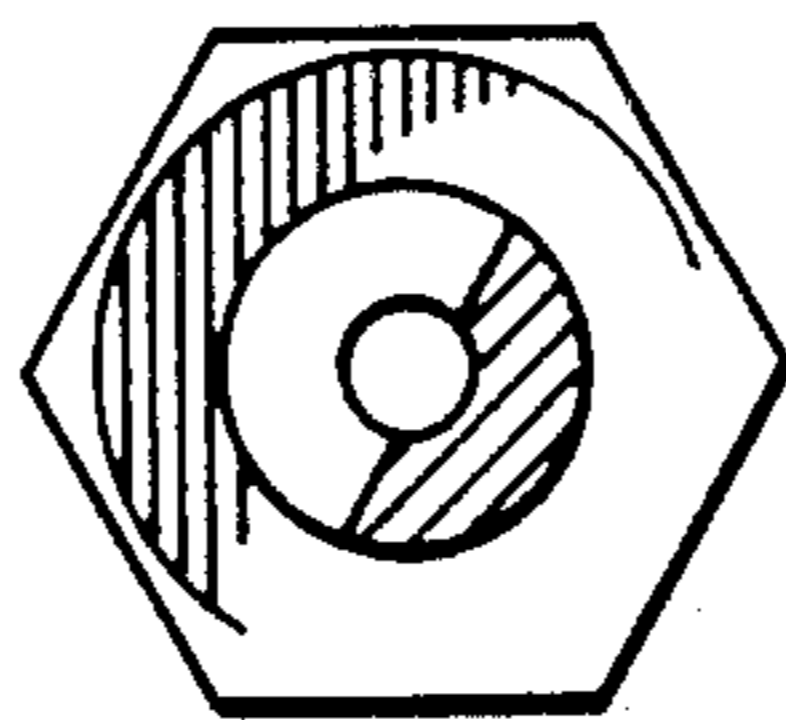

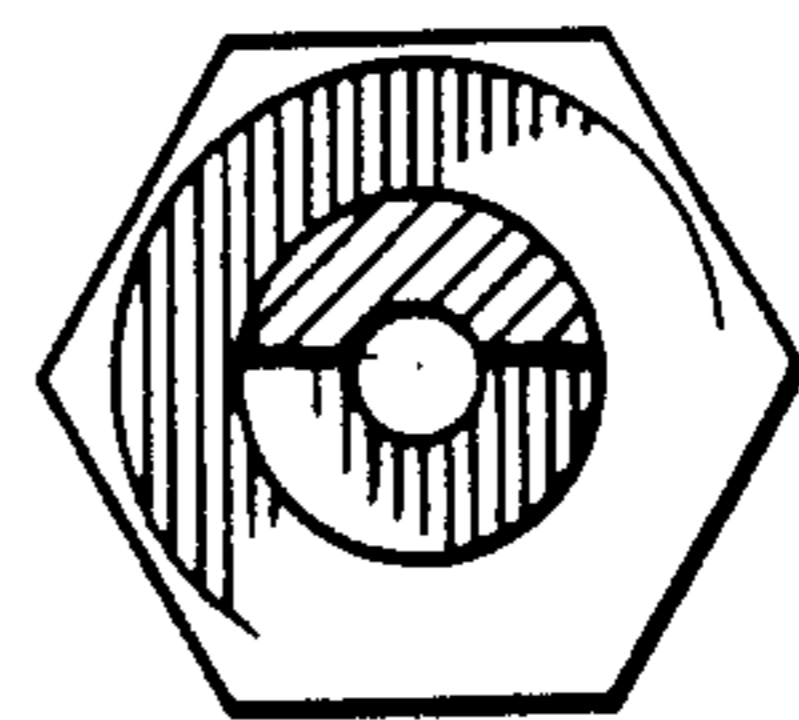
