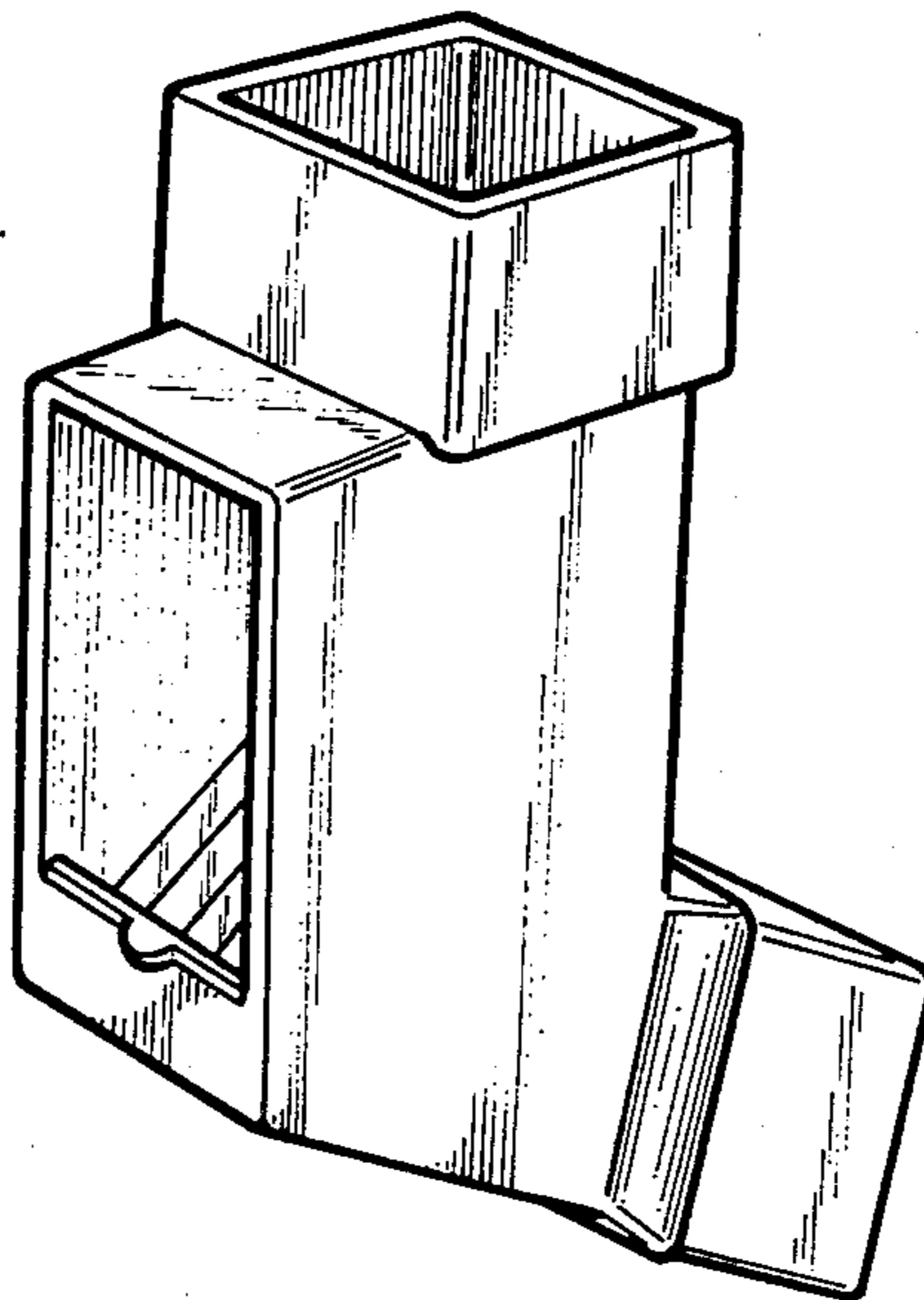

[57] CLAIM

The ornamental design for a debris separator downspout, as shown and described.

DESCRIPTION

FIG. 1 is a right side elevational view of a debris separator downspout showing my new design;  
 FIG. 2 is a perspective view taken from the top, front and right side thereof;  
 FIG. 3 is a left side elevational view thereof;  
 FIG. 4 is a top plan view thereof;  
 FIG. 5 is a front elevational view thereof;  
 FIG. 6 is a rear elevational view thereof;  
 FIG. 7 is a bottom plan view thereof;  
 FIG. 8 is a perspective view taken from the top, front and right side of a modified form of the debris separator downspout shown in FIG. 1;  
 FIG. 9 is a right side elevational view of FIG. 8;  
 FIG. 10 is a left side elevational view of FIG. 8;  
 FIG. 11 is a top plan view of FIG. 8;  
 FIG. 12 is a front elevational view of FIG. 8;  
 FIG. 13 is a rear elevational view of FIG. 8; and  
 FIG. 14 is a bottom plan view of FIG. 8.



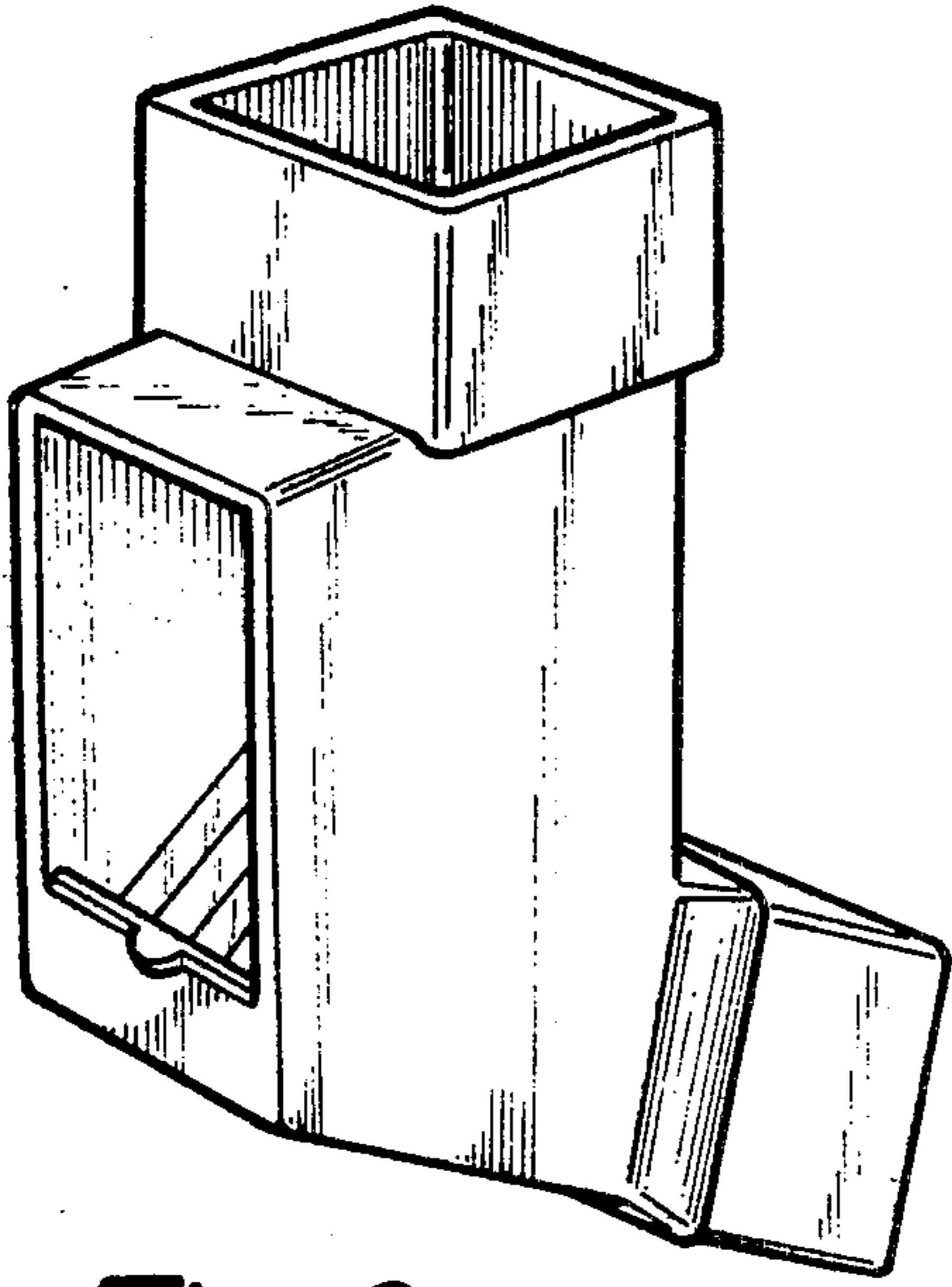

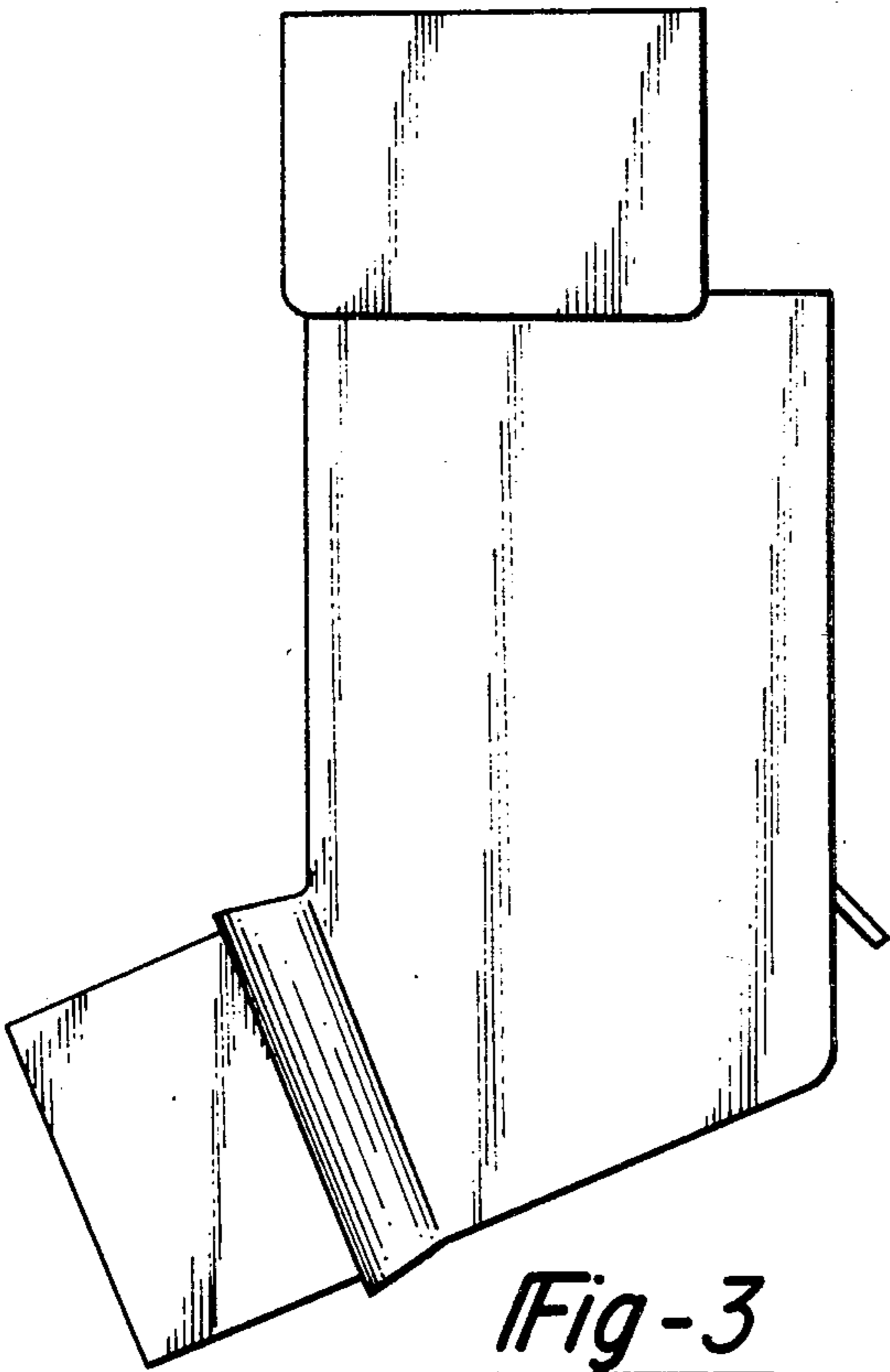
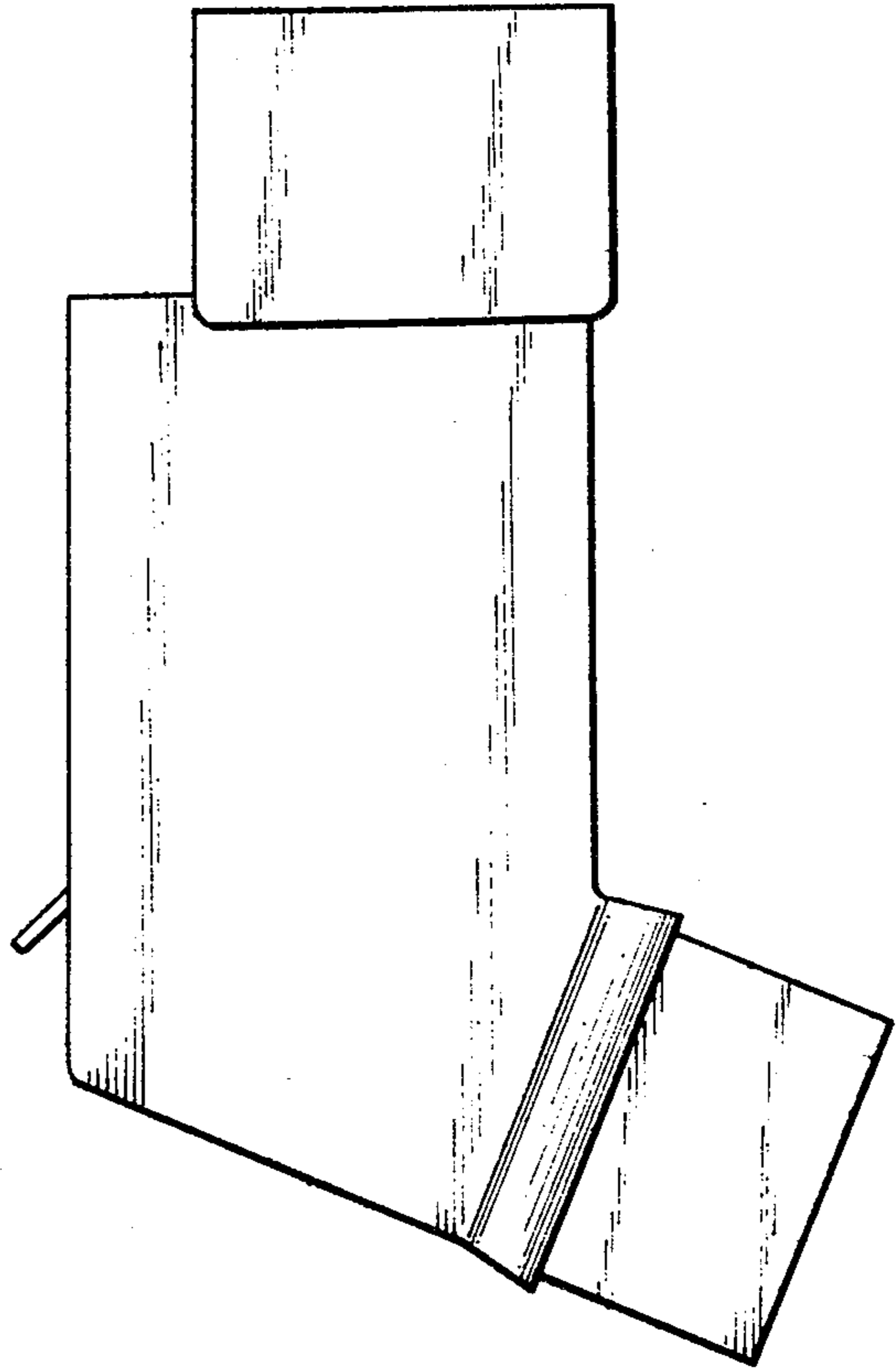

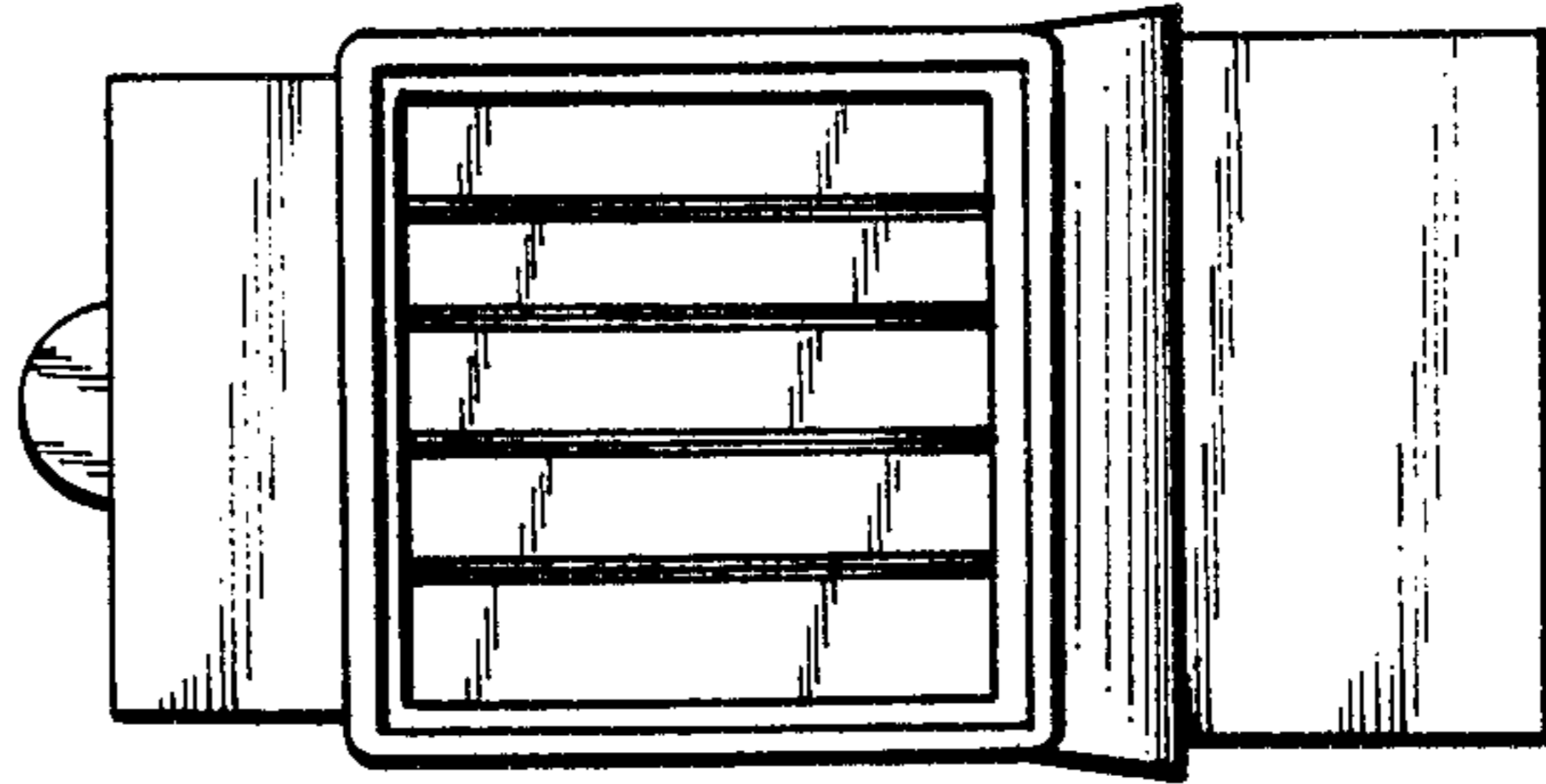

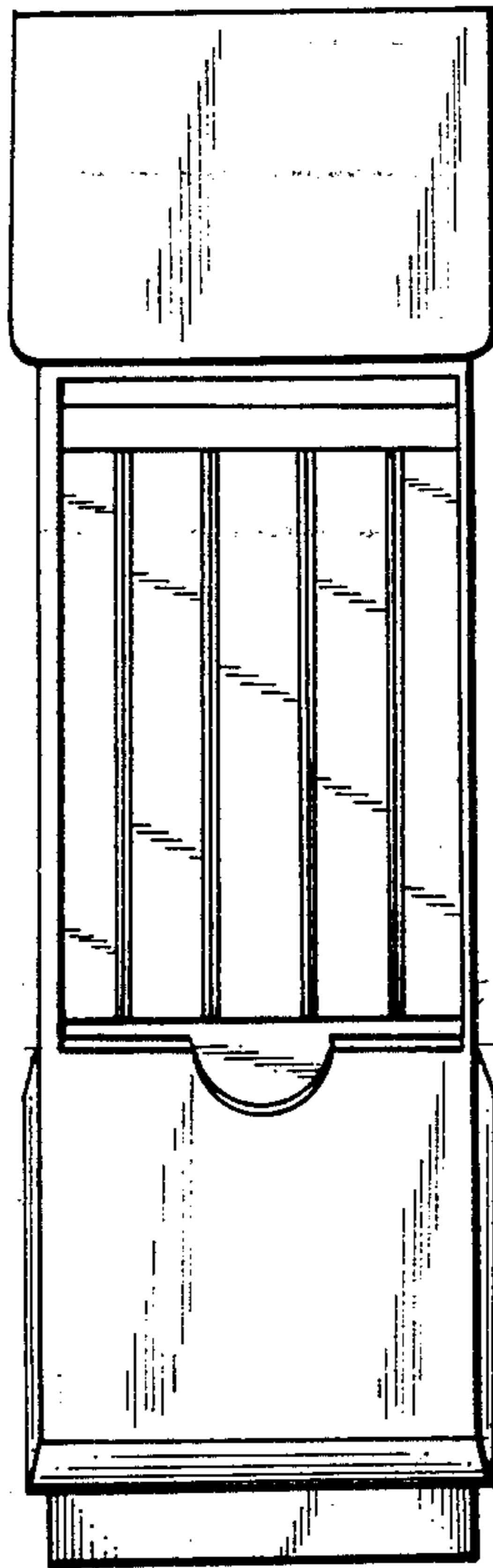

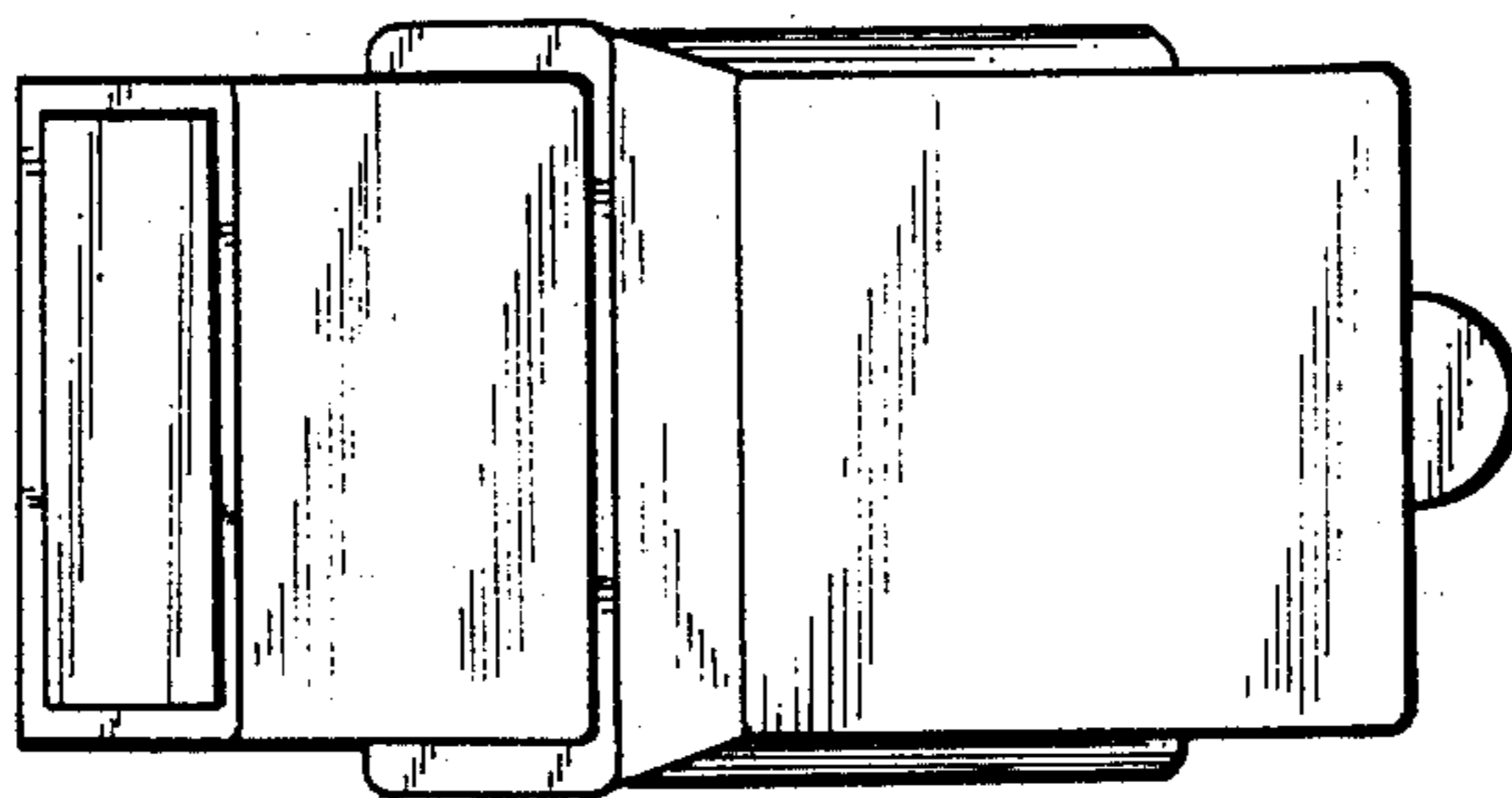
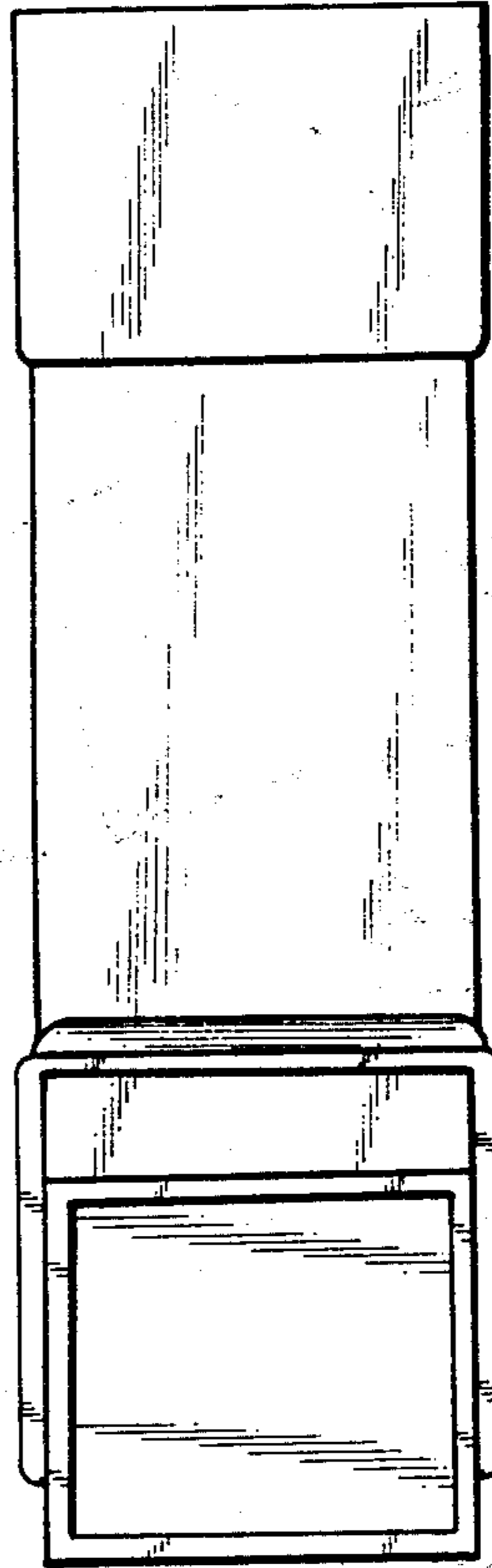

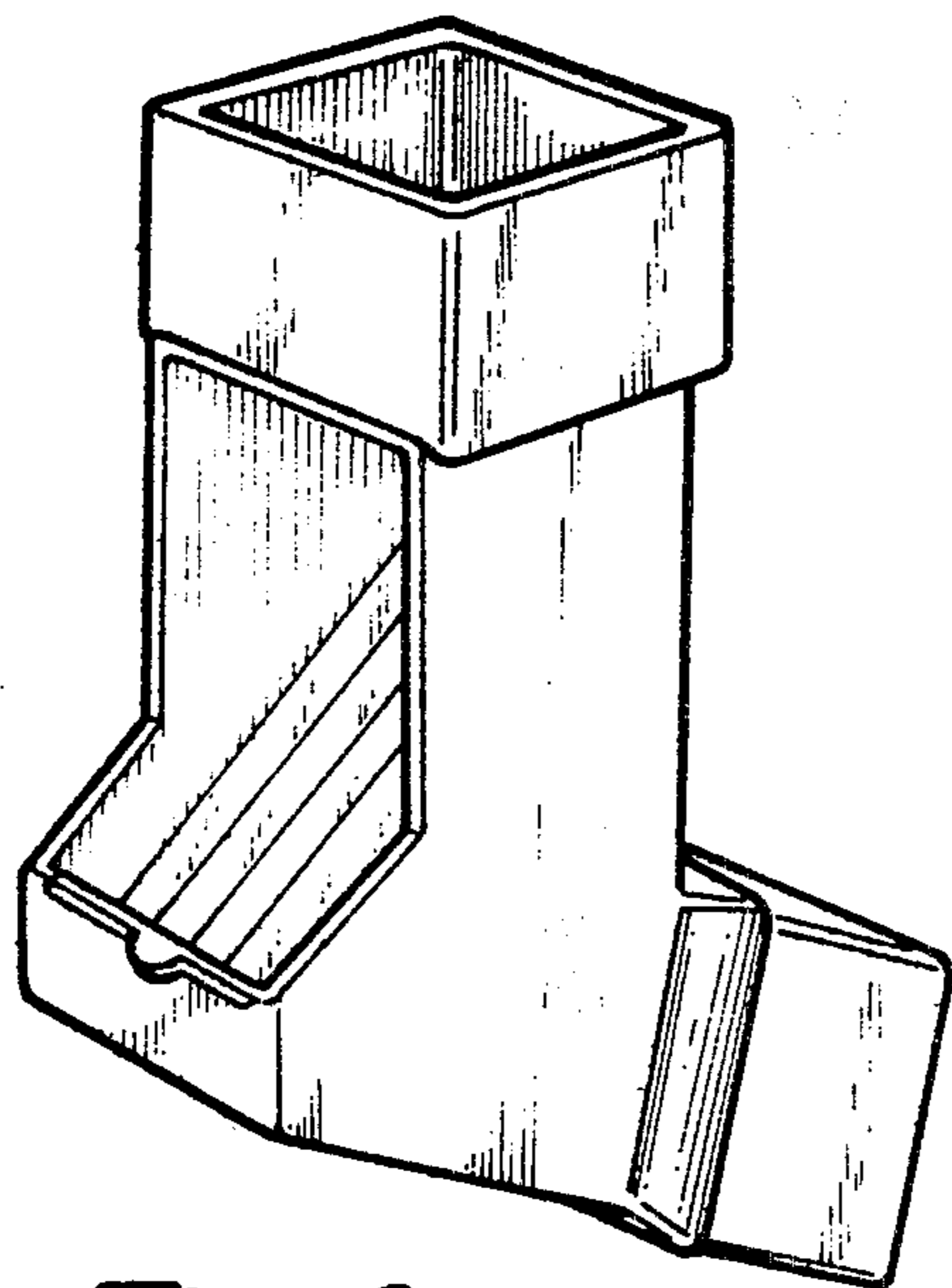

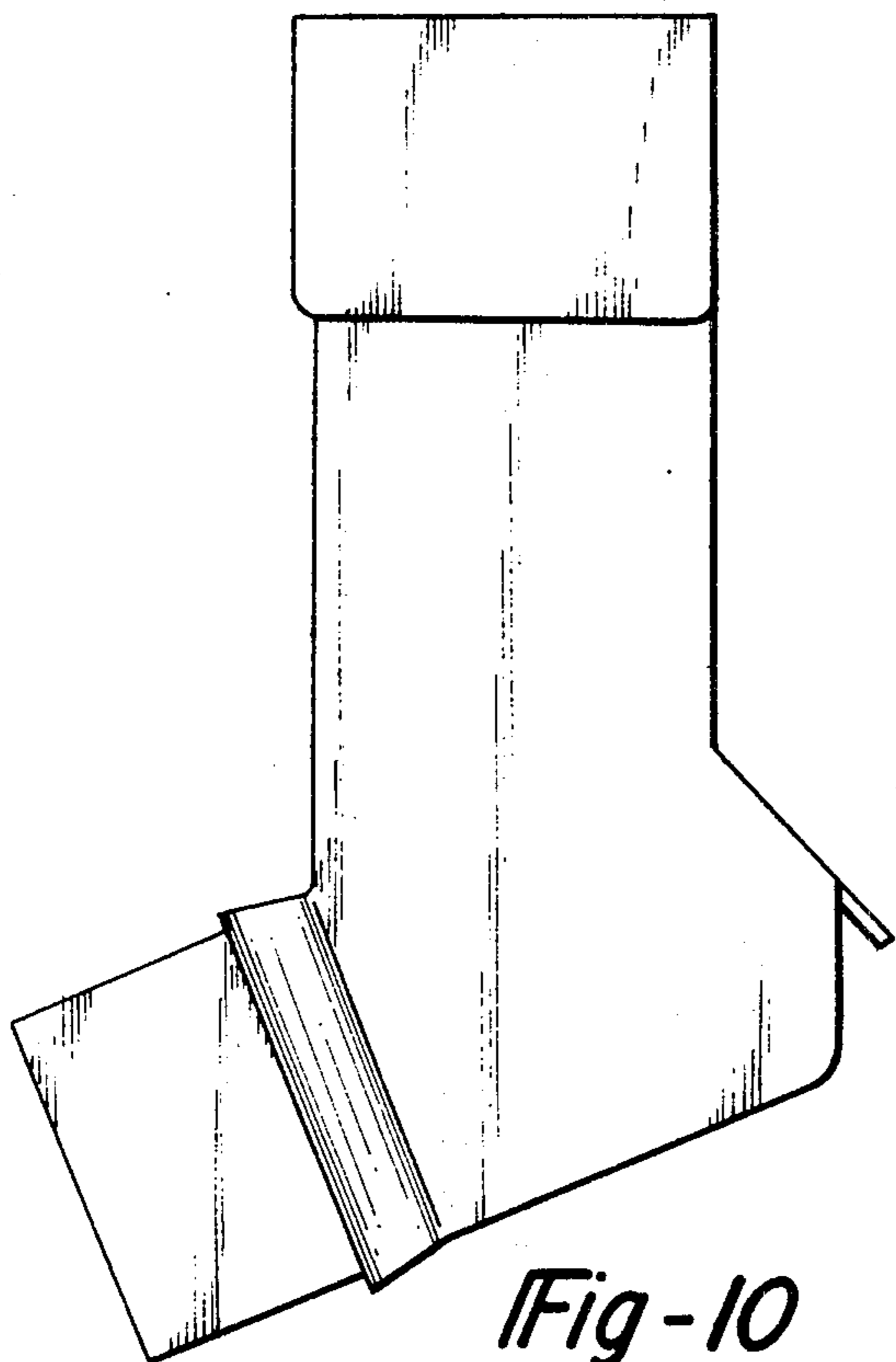
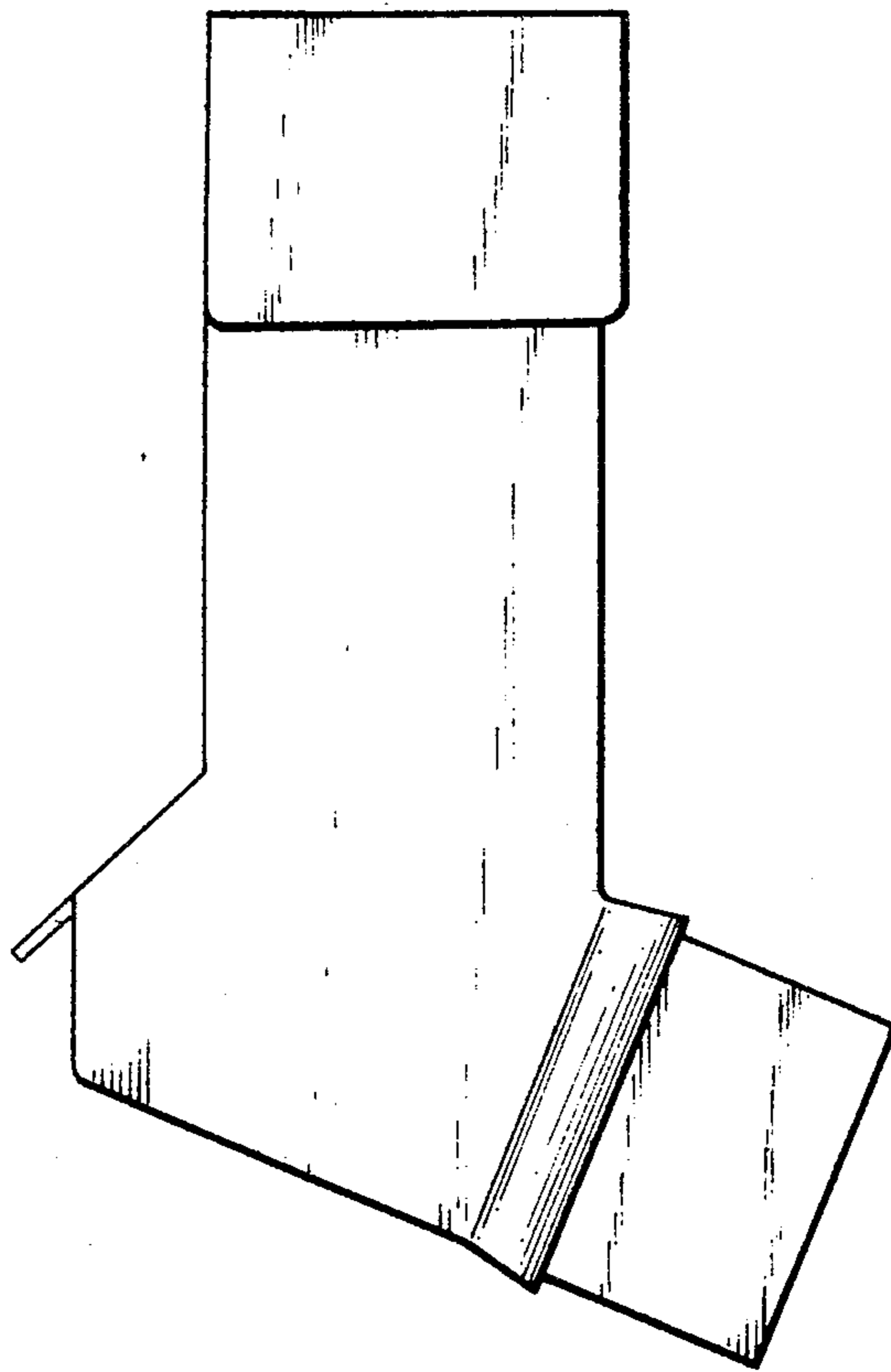

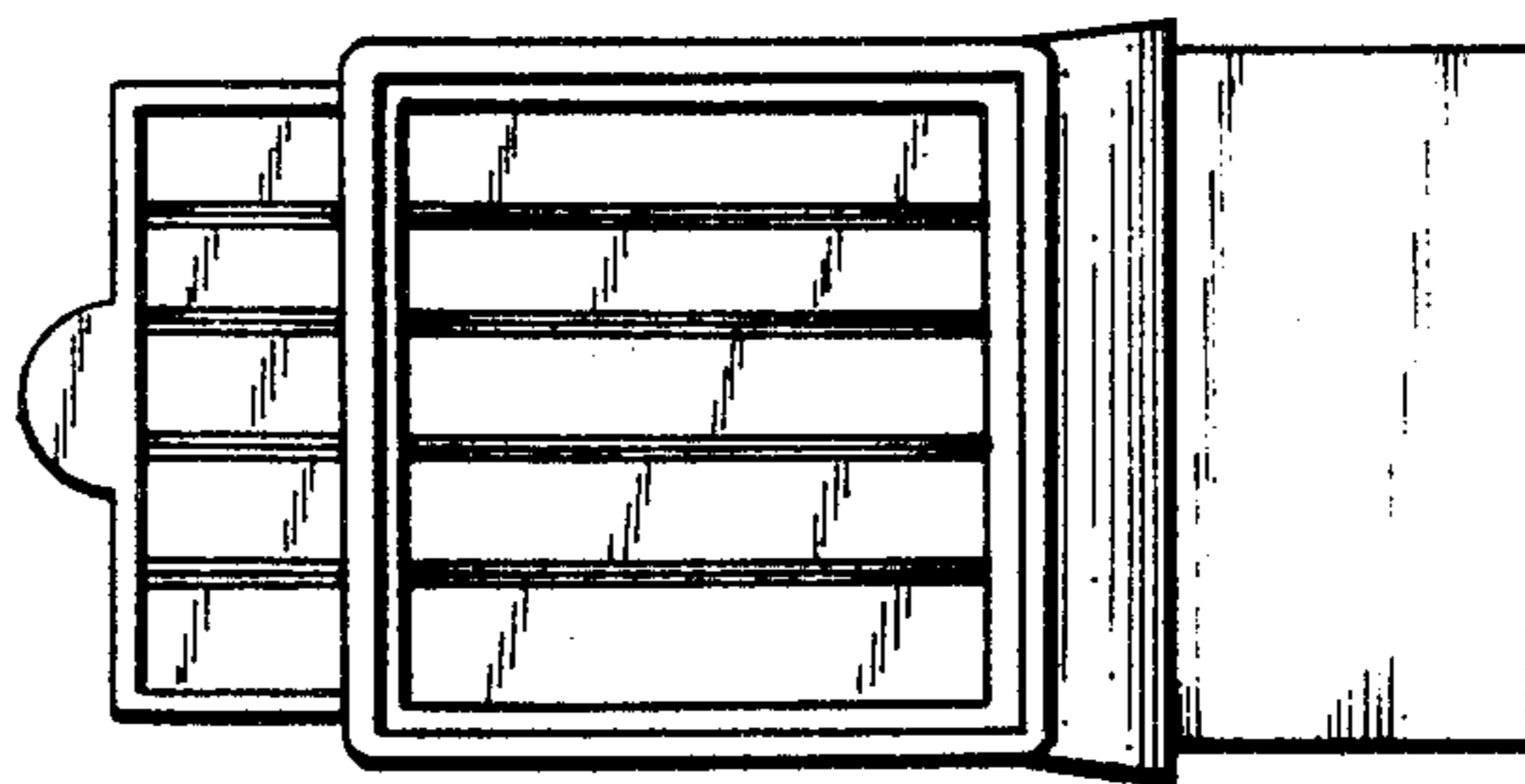

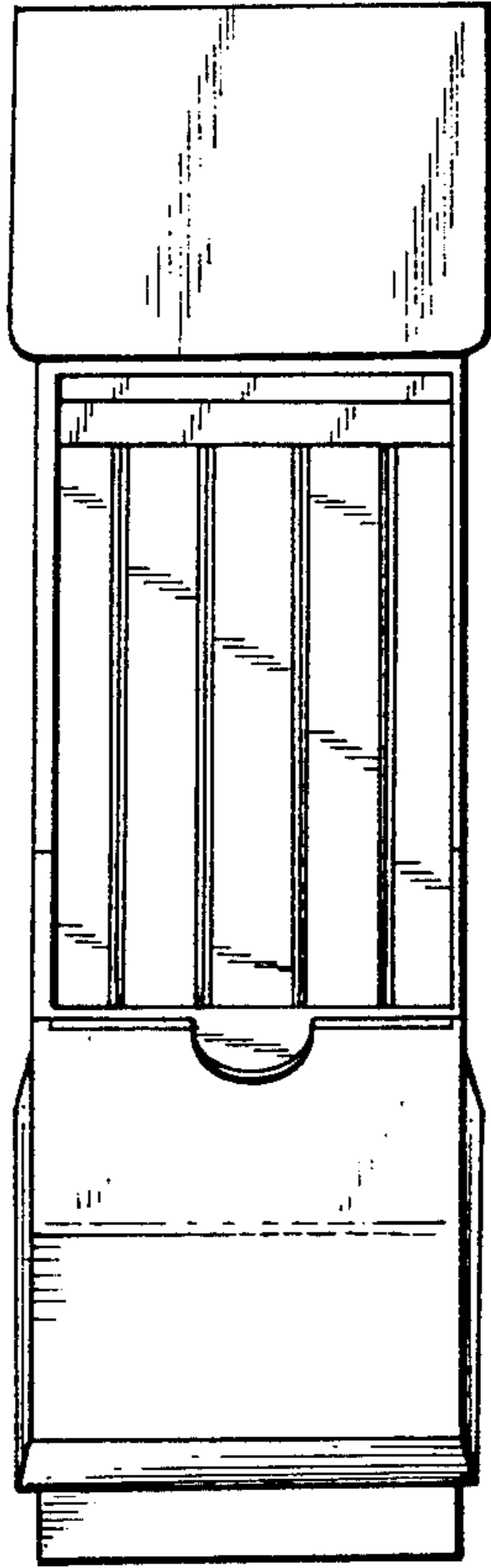

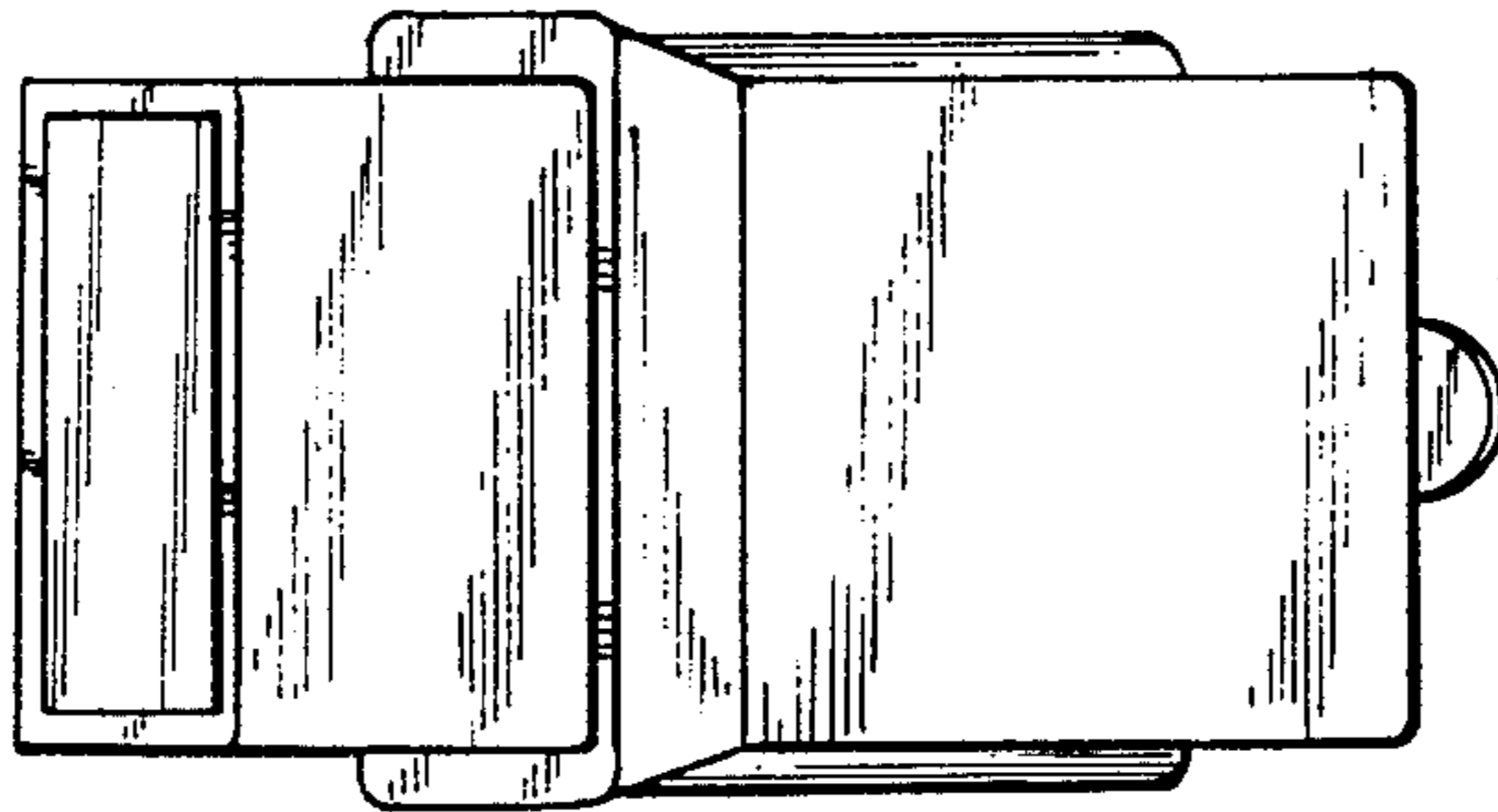
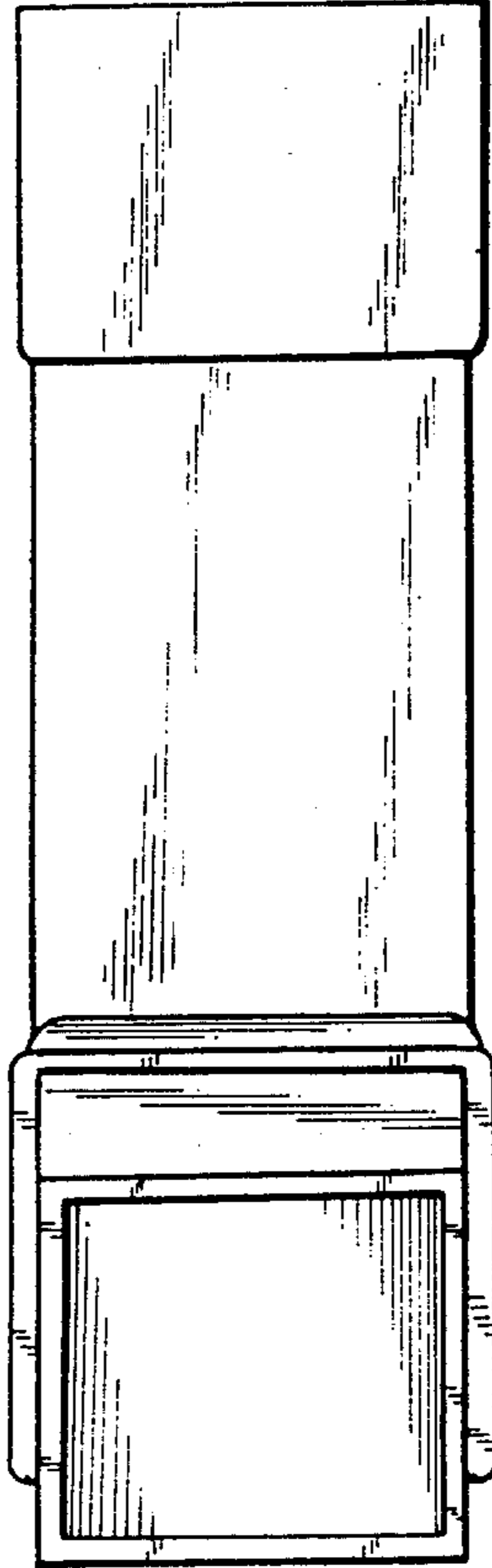
