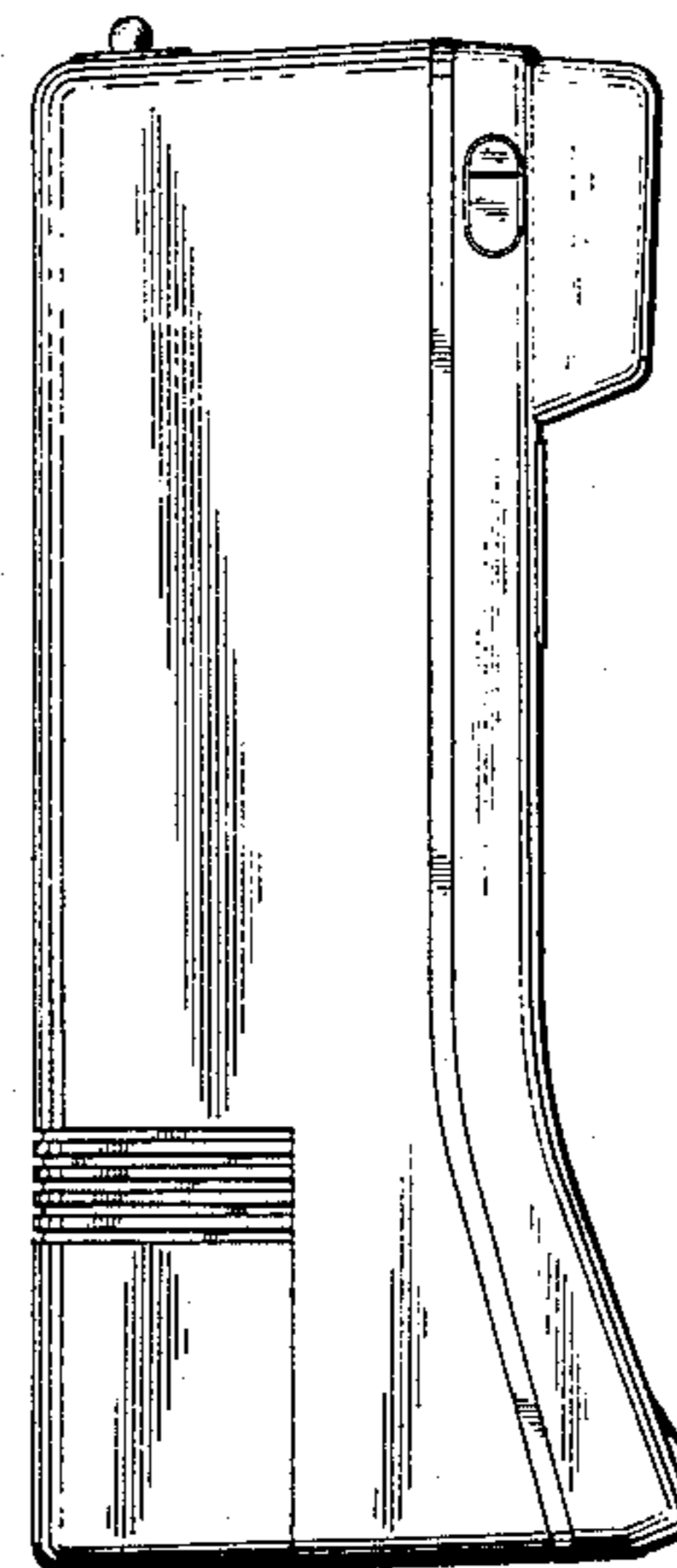
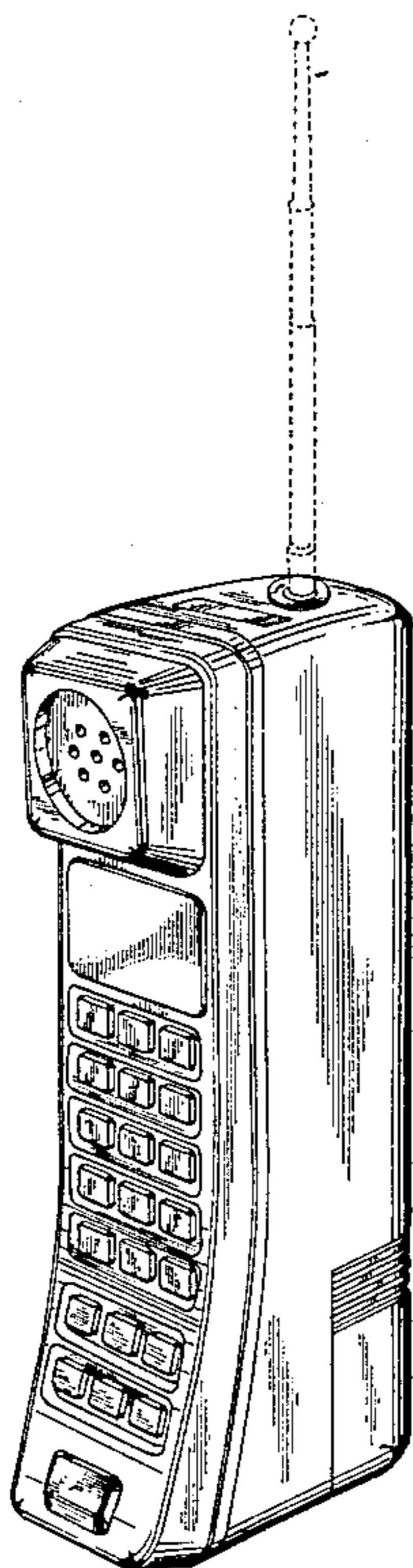

The ornamental design for a portable handset radio telephone, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a portable handset radio telephone showing my new design;  
 FIG. 2 is a rear elevational view thereof;  
 FIG. 3 is a front and right side perspective view thereof, and the showing of an antenna in broken lines is for environmental association purposes only;  
 FIG. 4 is a right side elevational view thereof;  
 FIG. 5 is a left side elevational view thereof;  
 FIG. 6 is a top plan view thereof; and  
 FIG. 7 is a bottom plan view thereof.



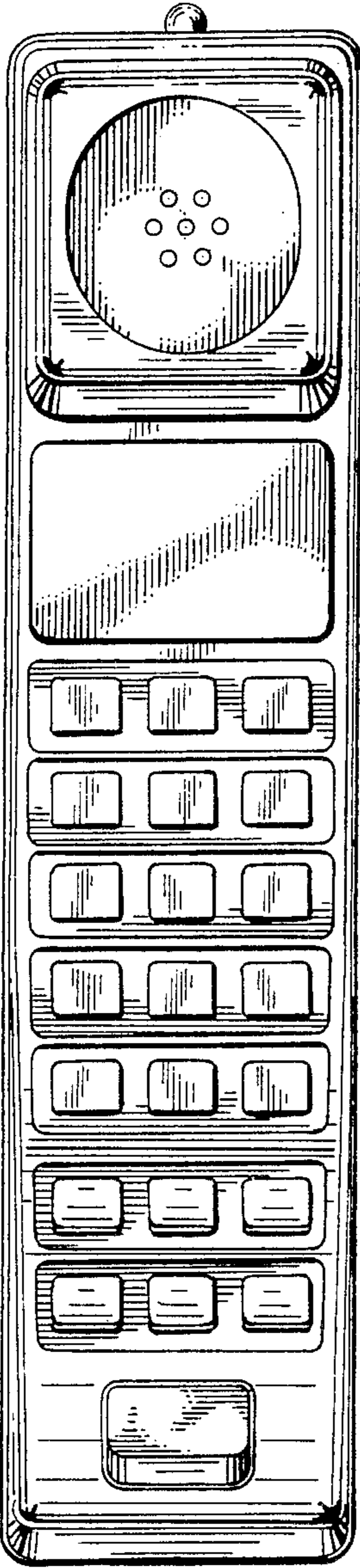

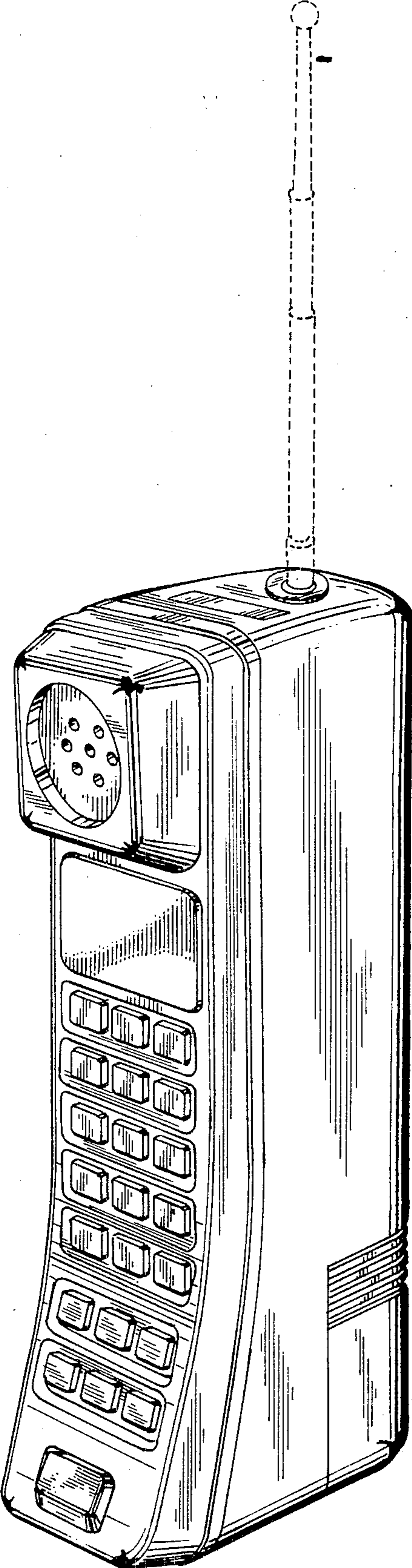

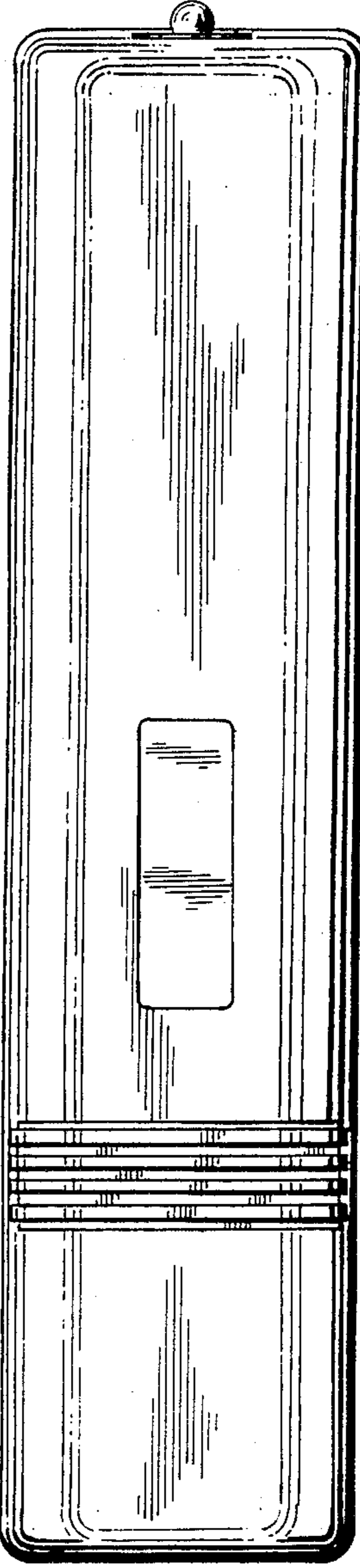

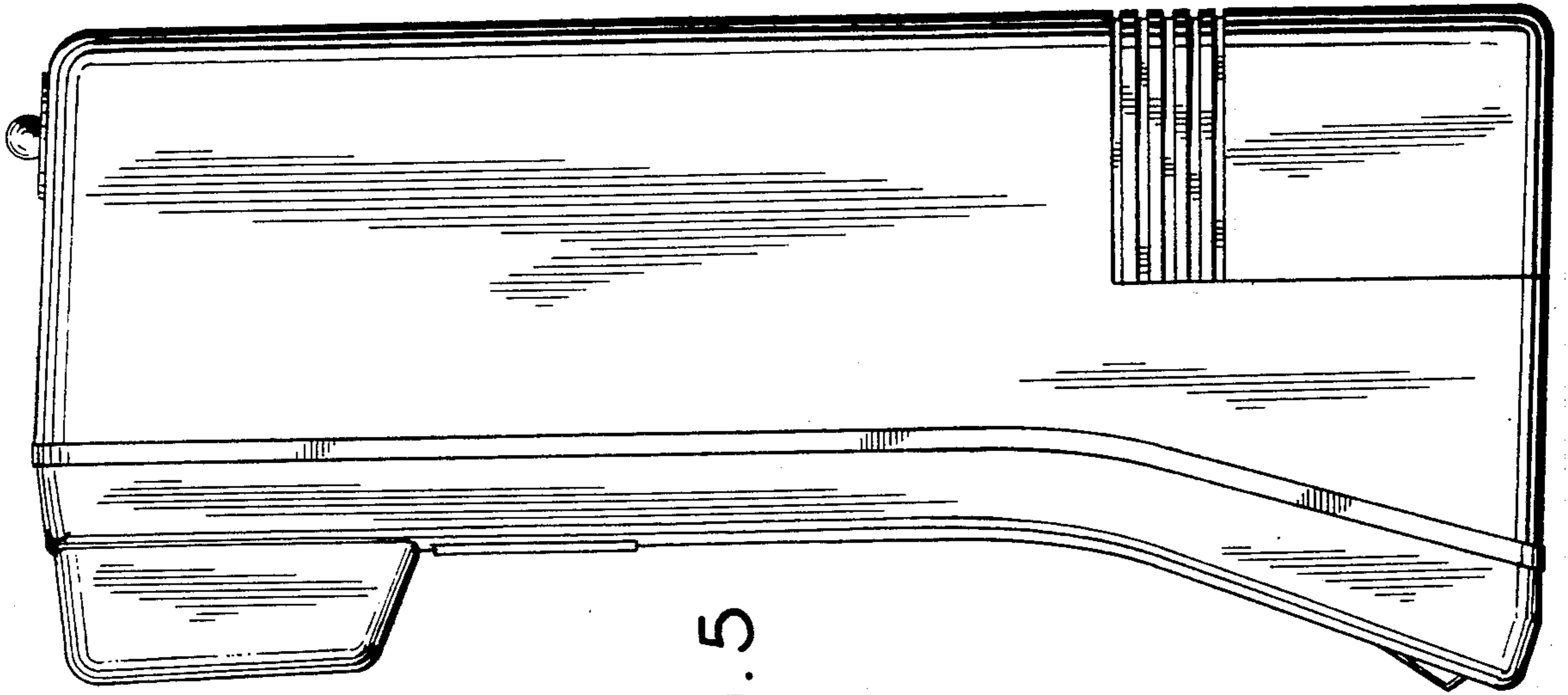

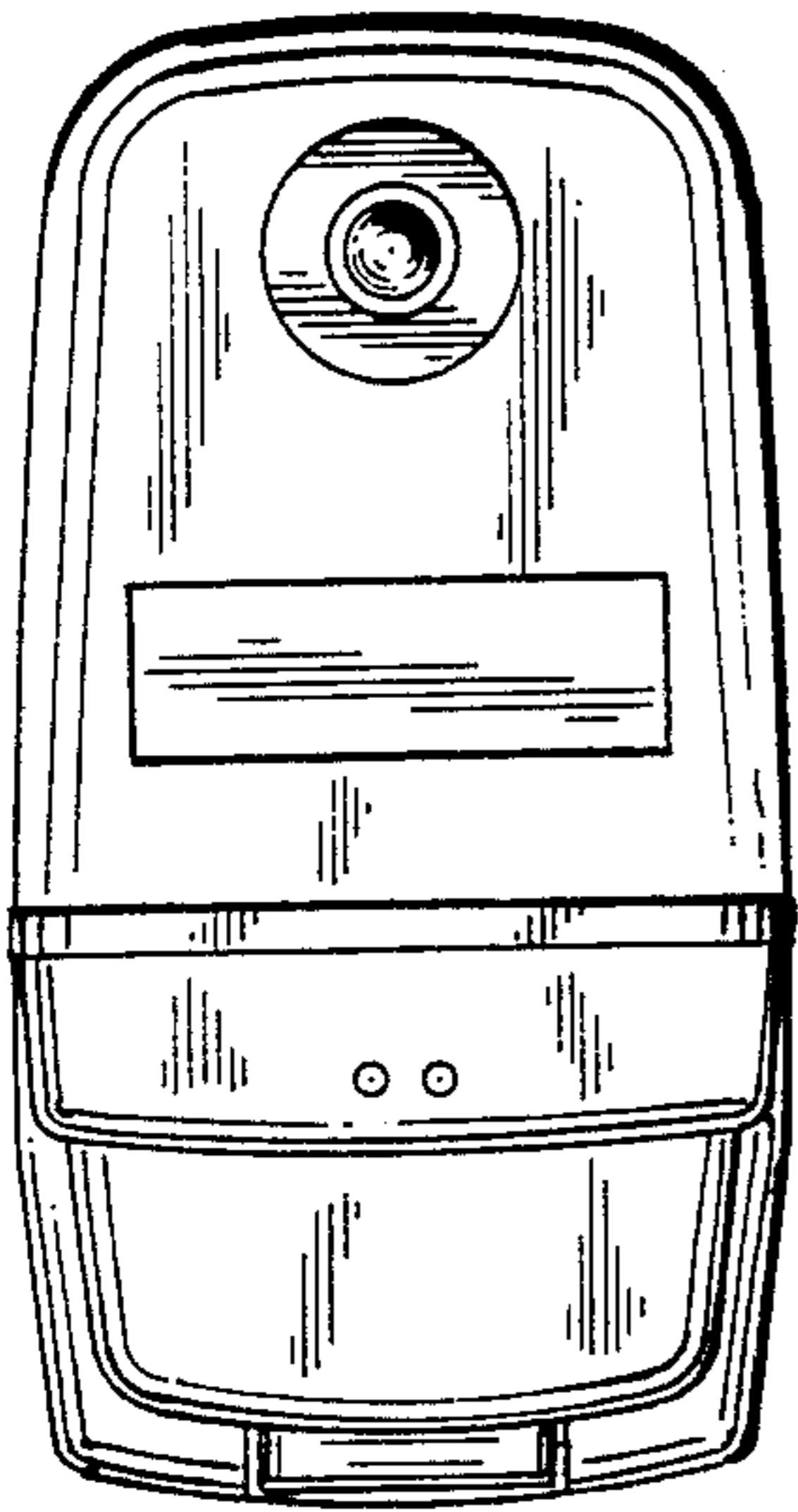

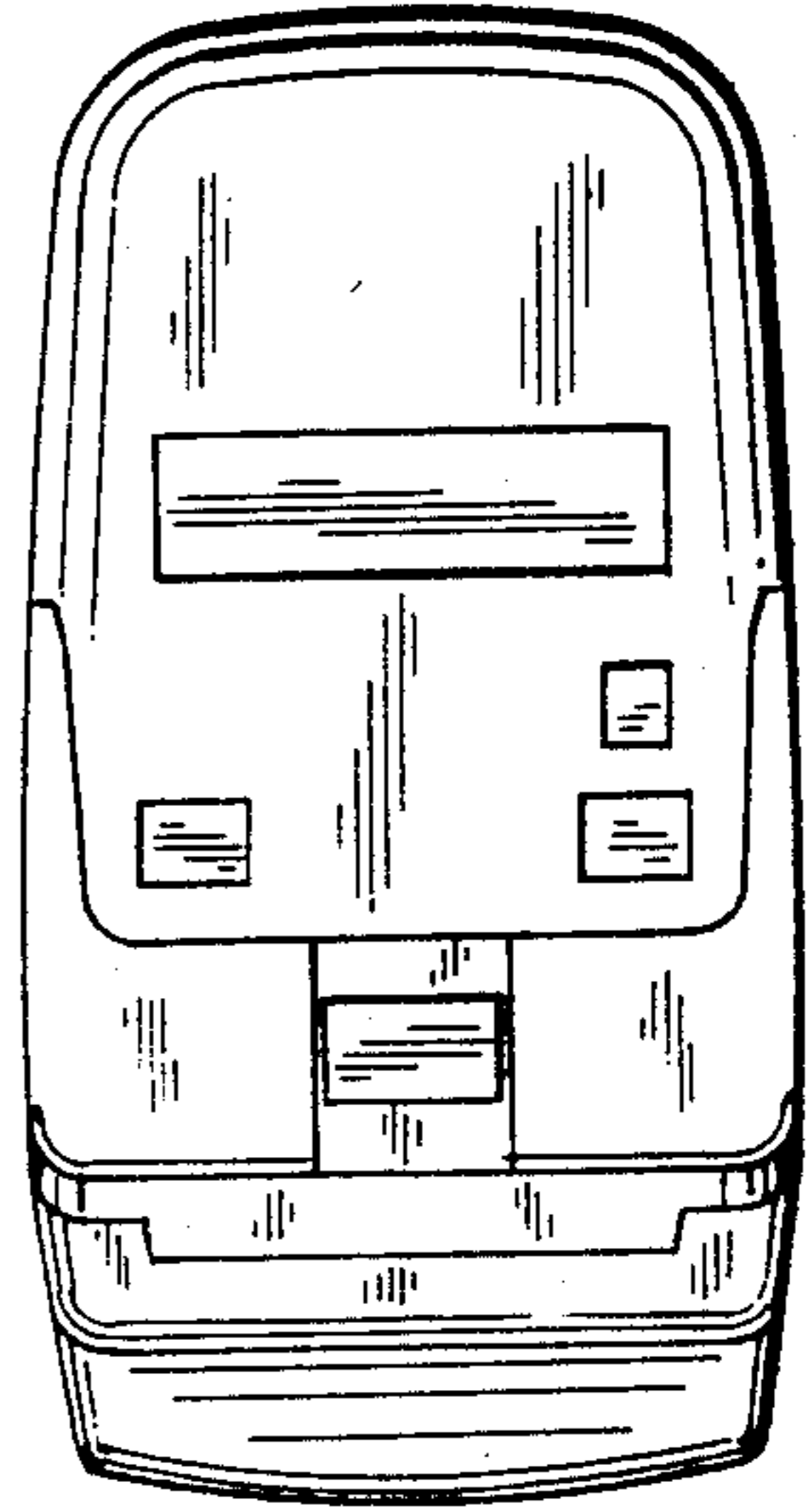

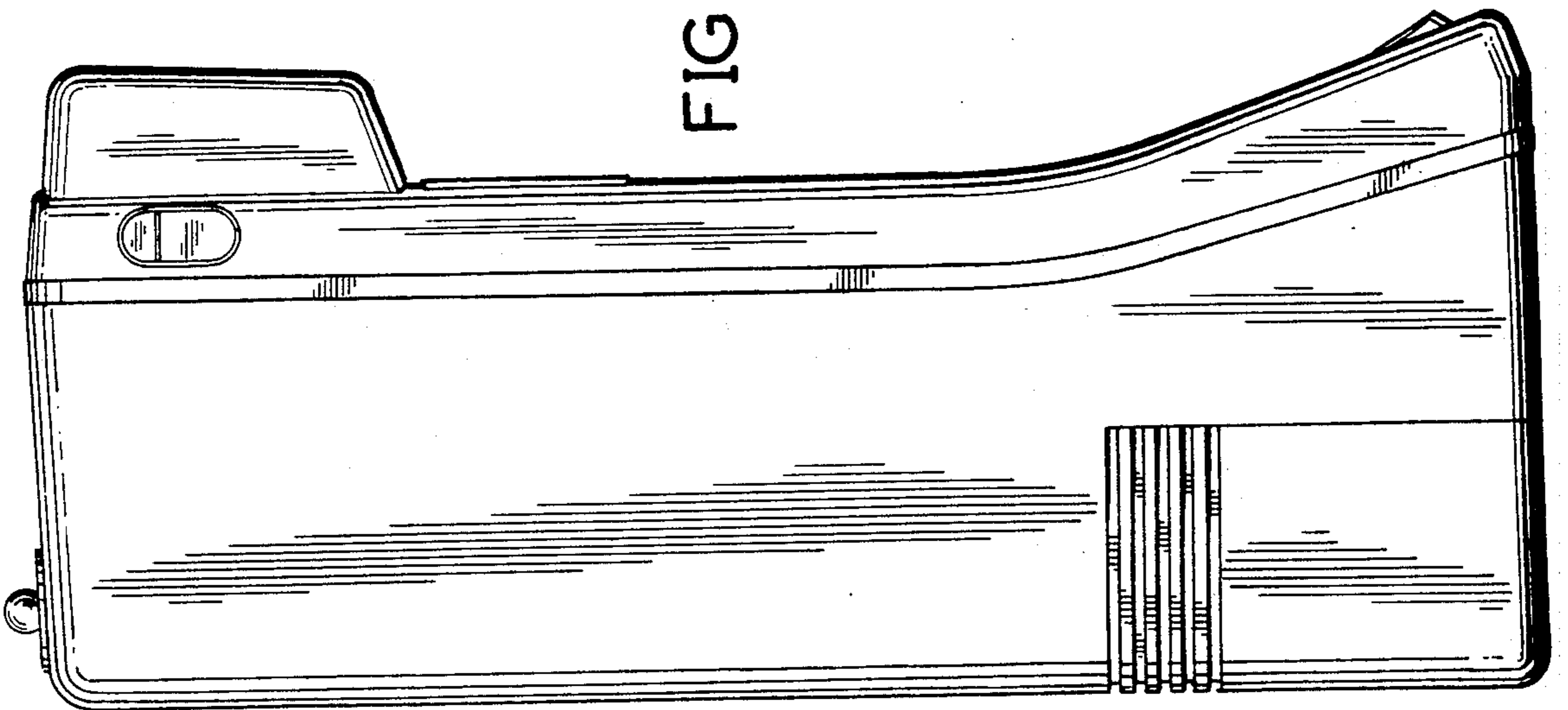
