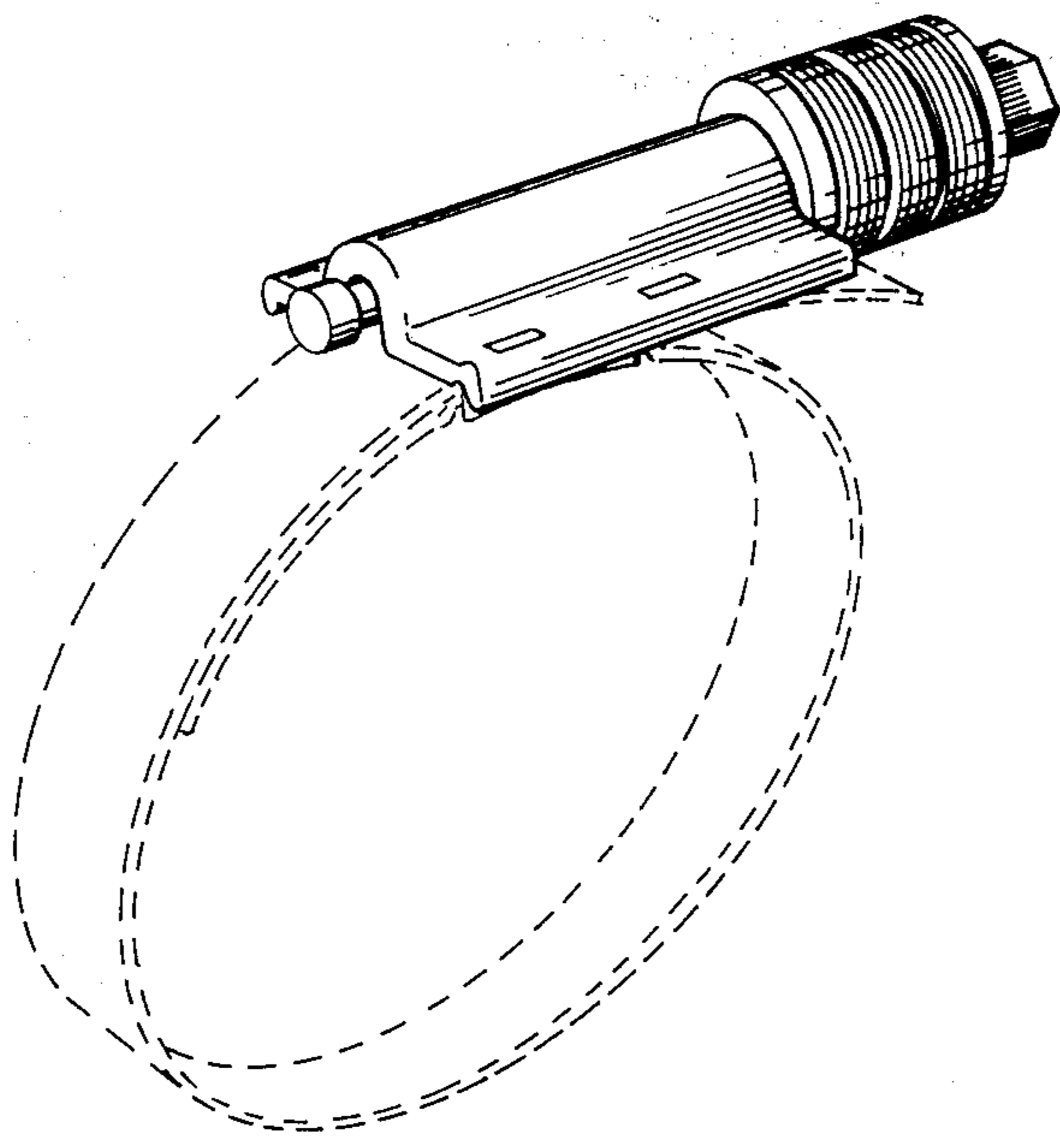

[57] CLAIM

The ornamental design for the clamping body, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a clamping body showing my new design, the hand being shown in broken lines for illustrative purposes only;  
FIG. 2 is a right side elevational view thereof, the left side being a mirror image;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a top plan view thereof, the bottom being unornamented.



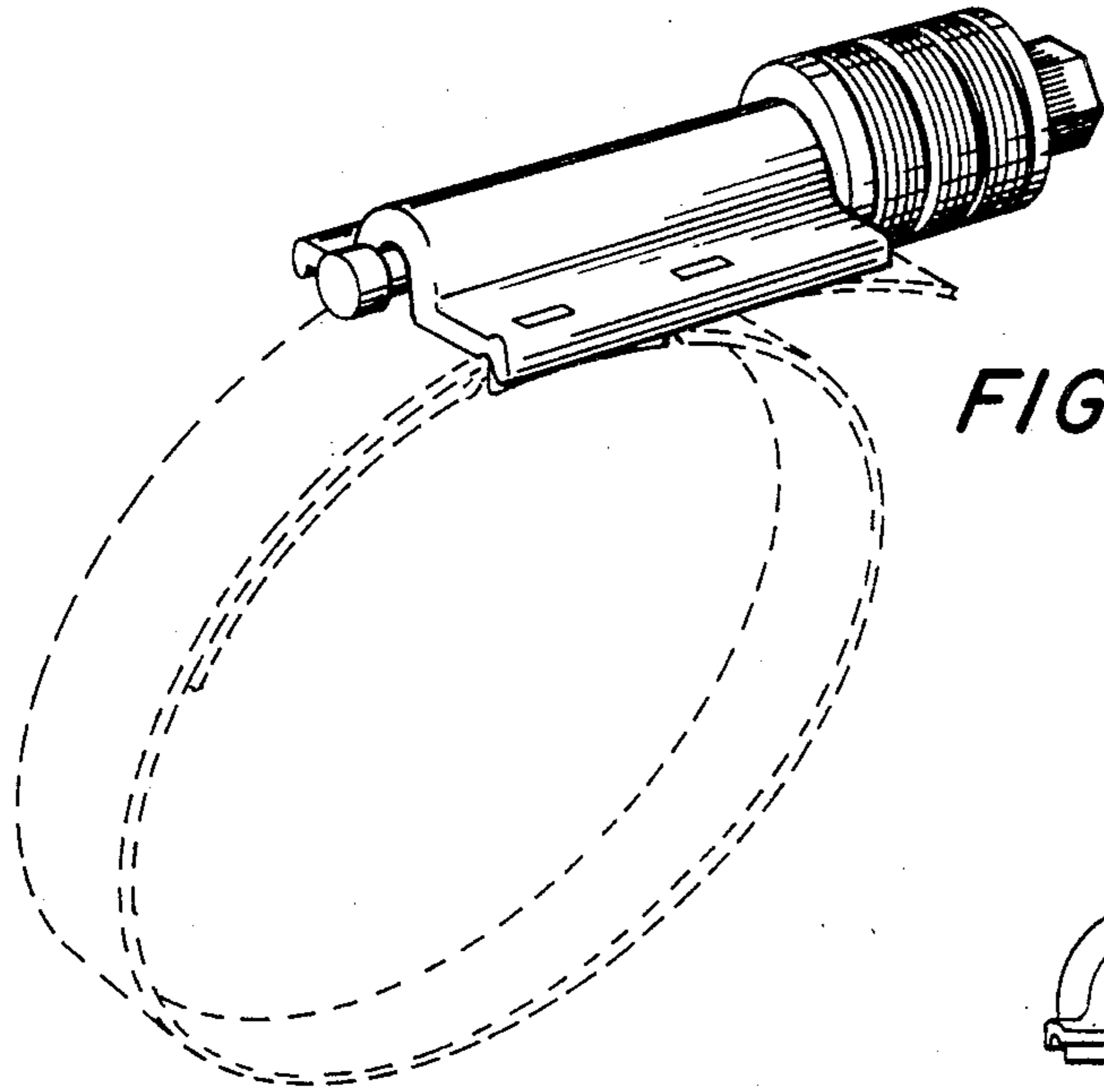

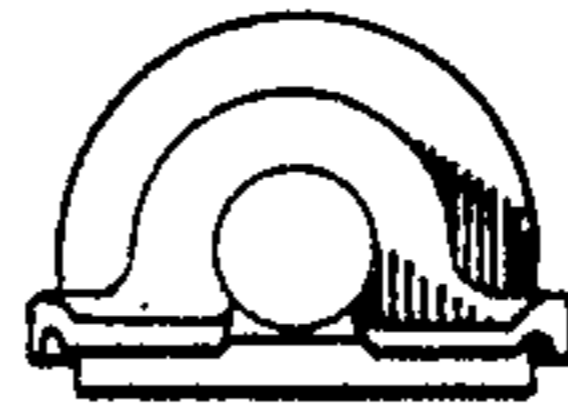

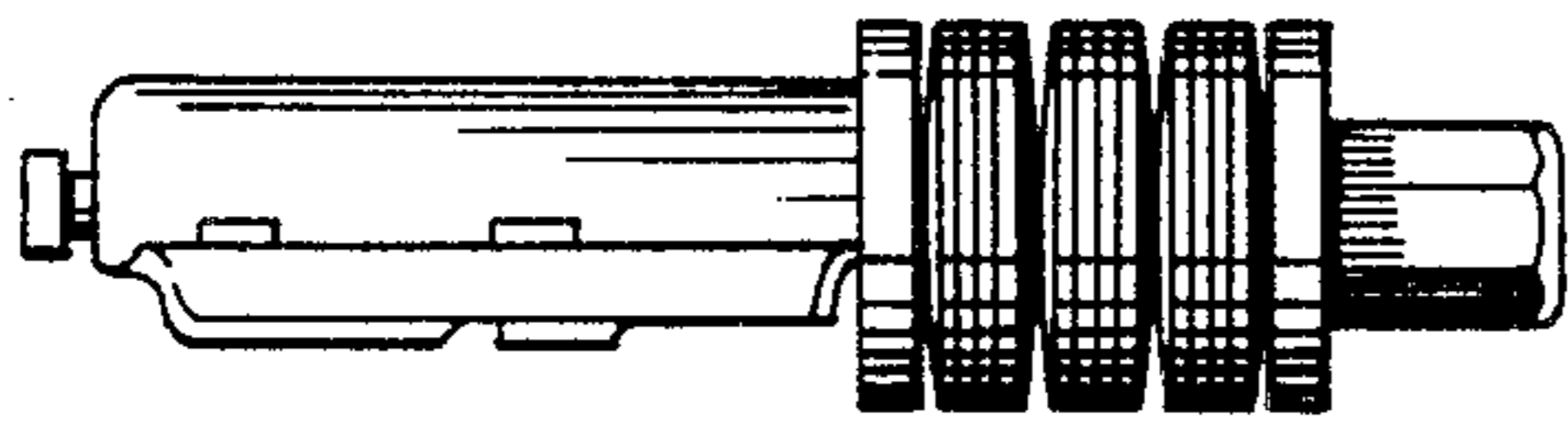

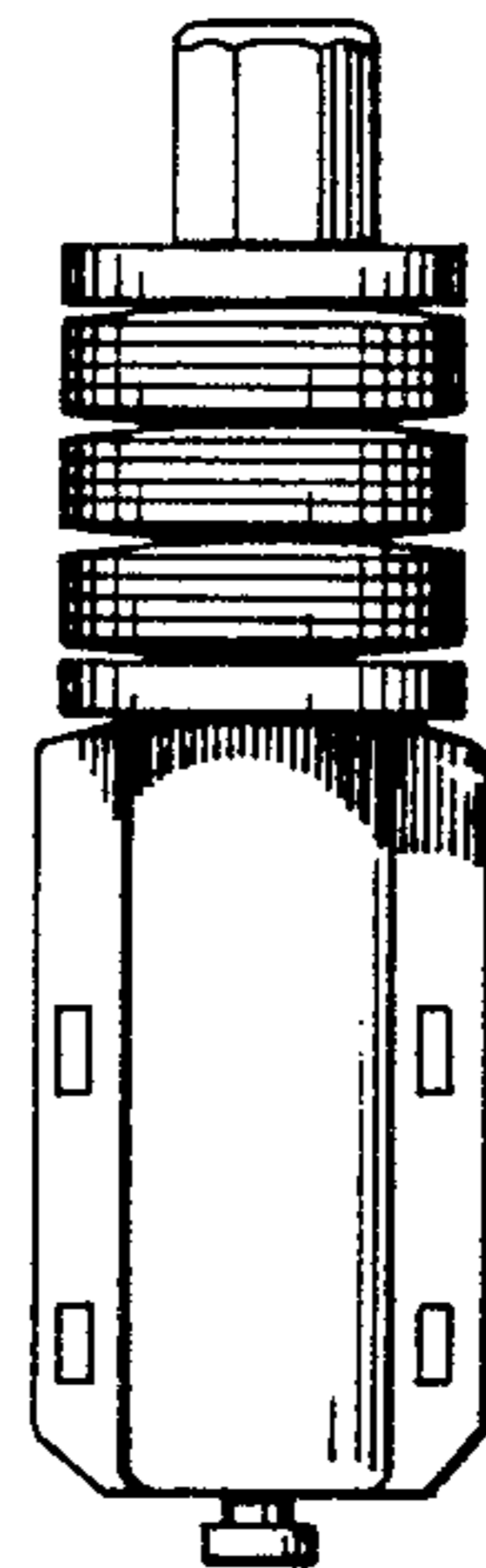
