[57] CLAIM

The ornamental design for a telephone apparatus housing, as shown and described.

DESCRIPTION

FIG. 1 is a side elevational view of a telephone apparatus housing showing our new design, the side opposite being a mirror image of the side shown; FIG. 2 is a top plan view thereof; FIGS. 3 and 4 are respectively front and rear elevational views thereof; FIG. 5 is a bottom plan view thereof; and FIG. 6 is a perspective view thereof.

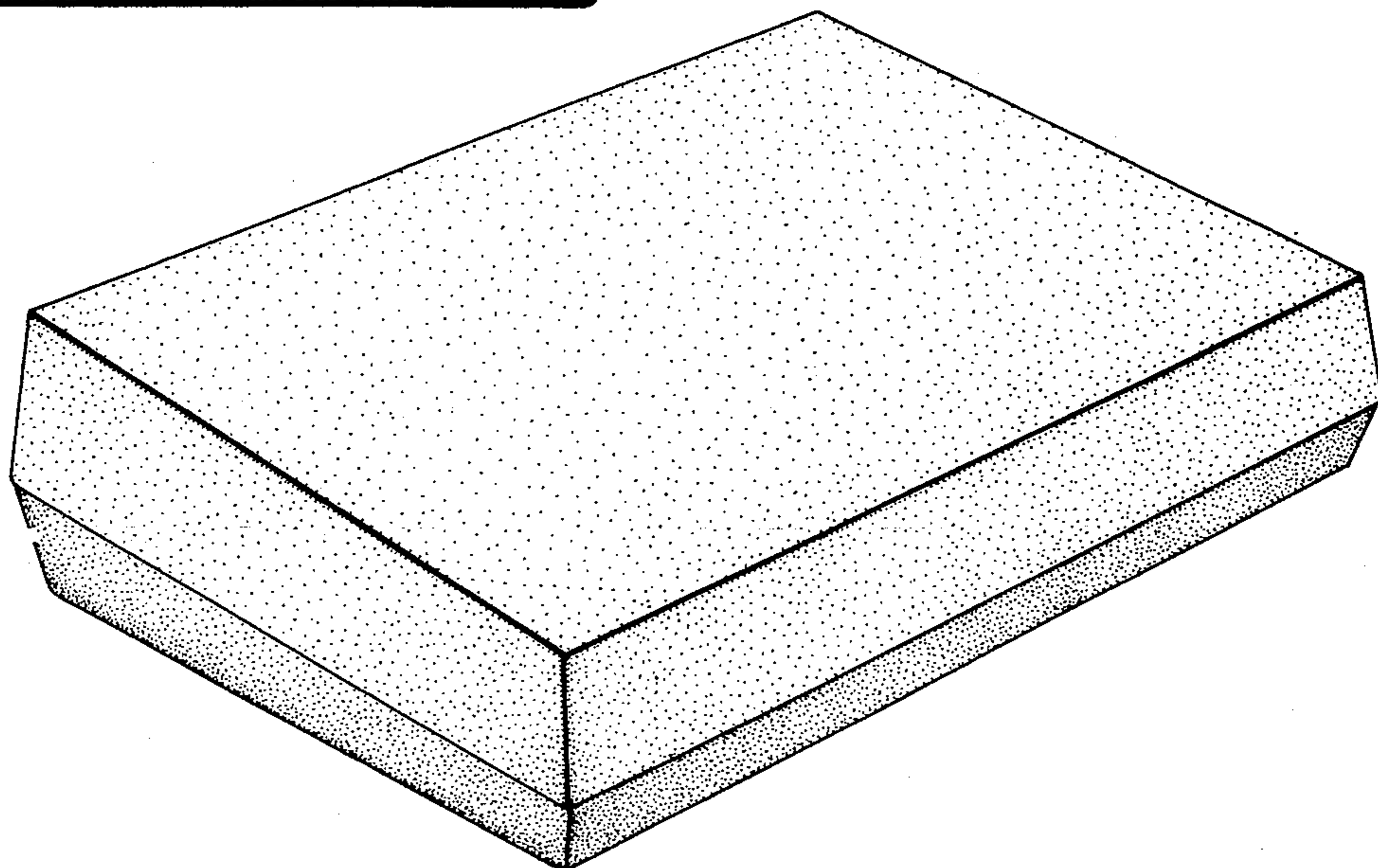
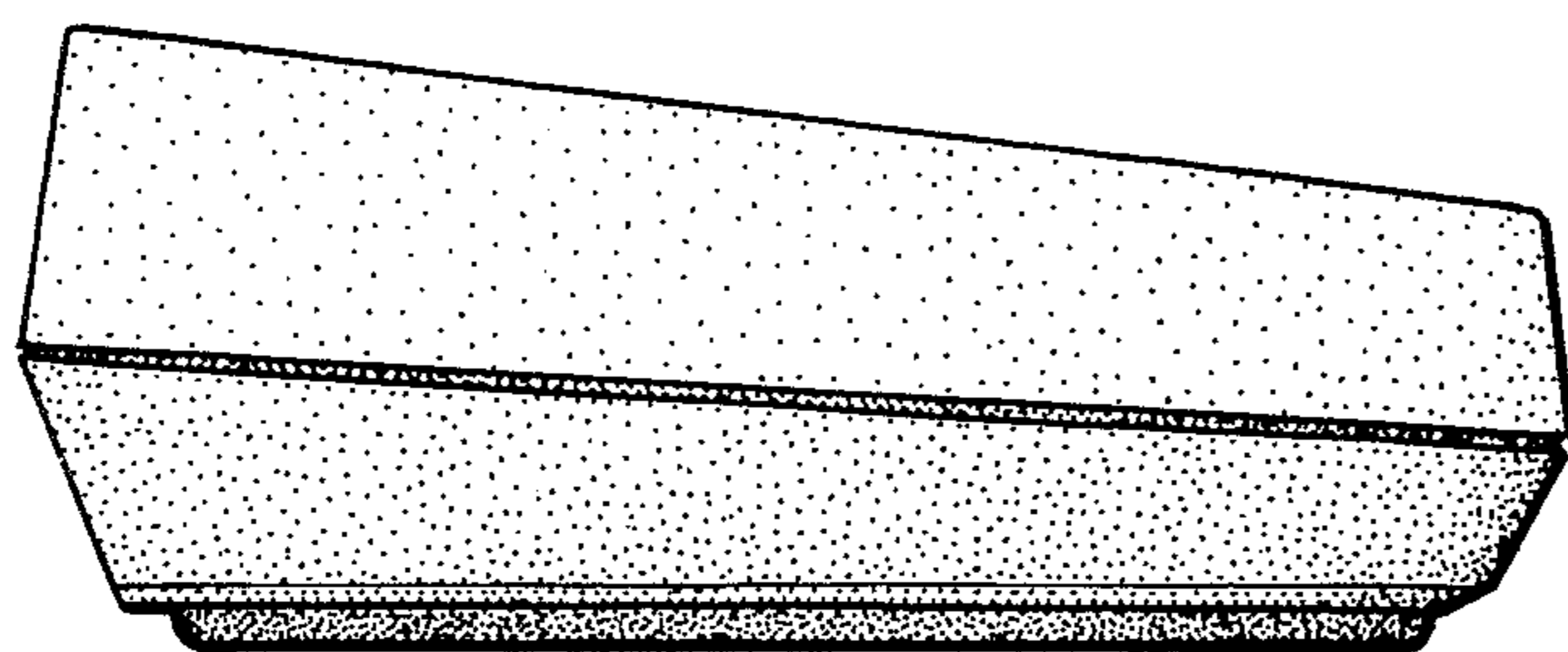

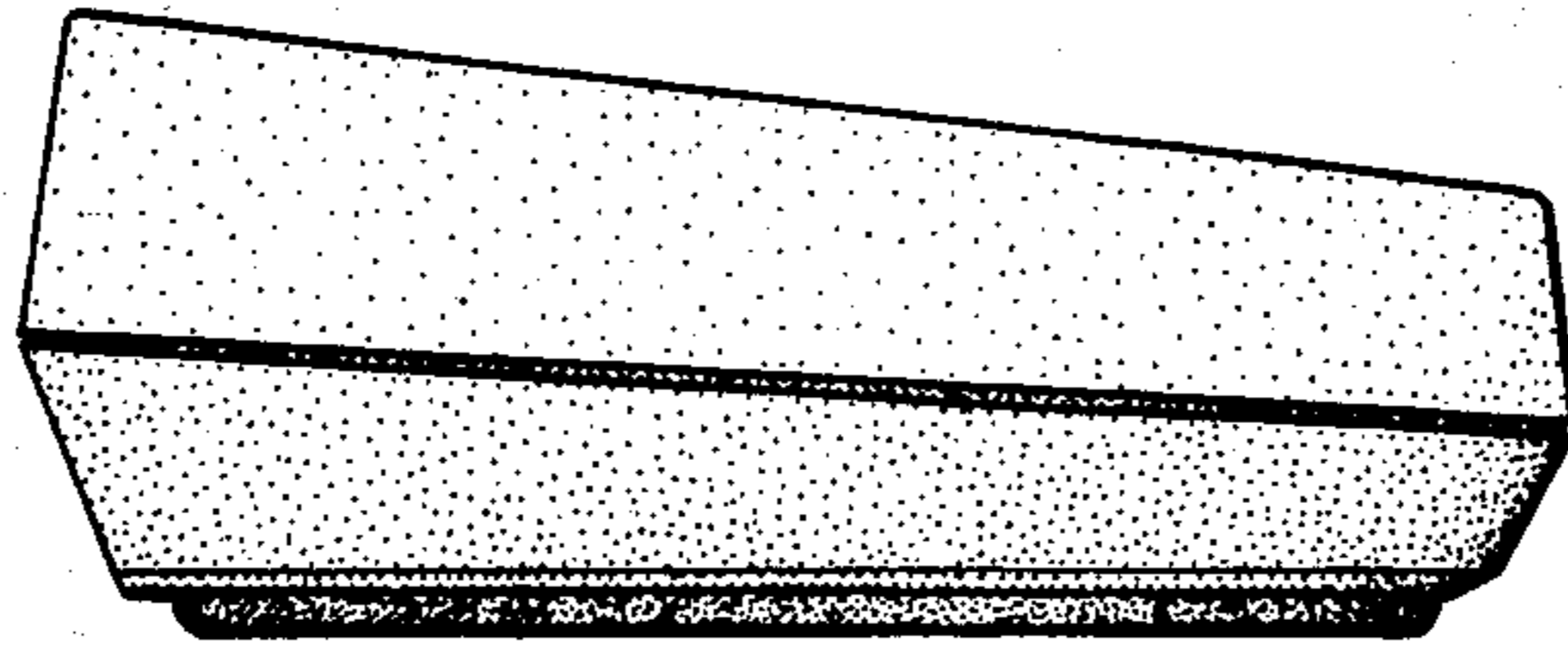

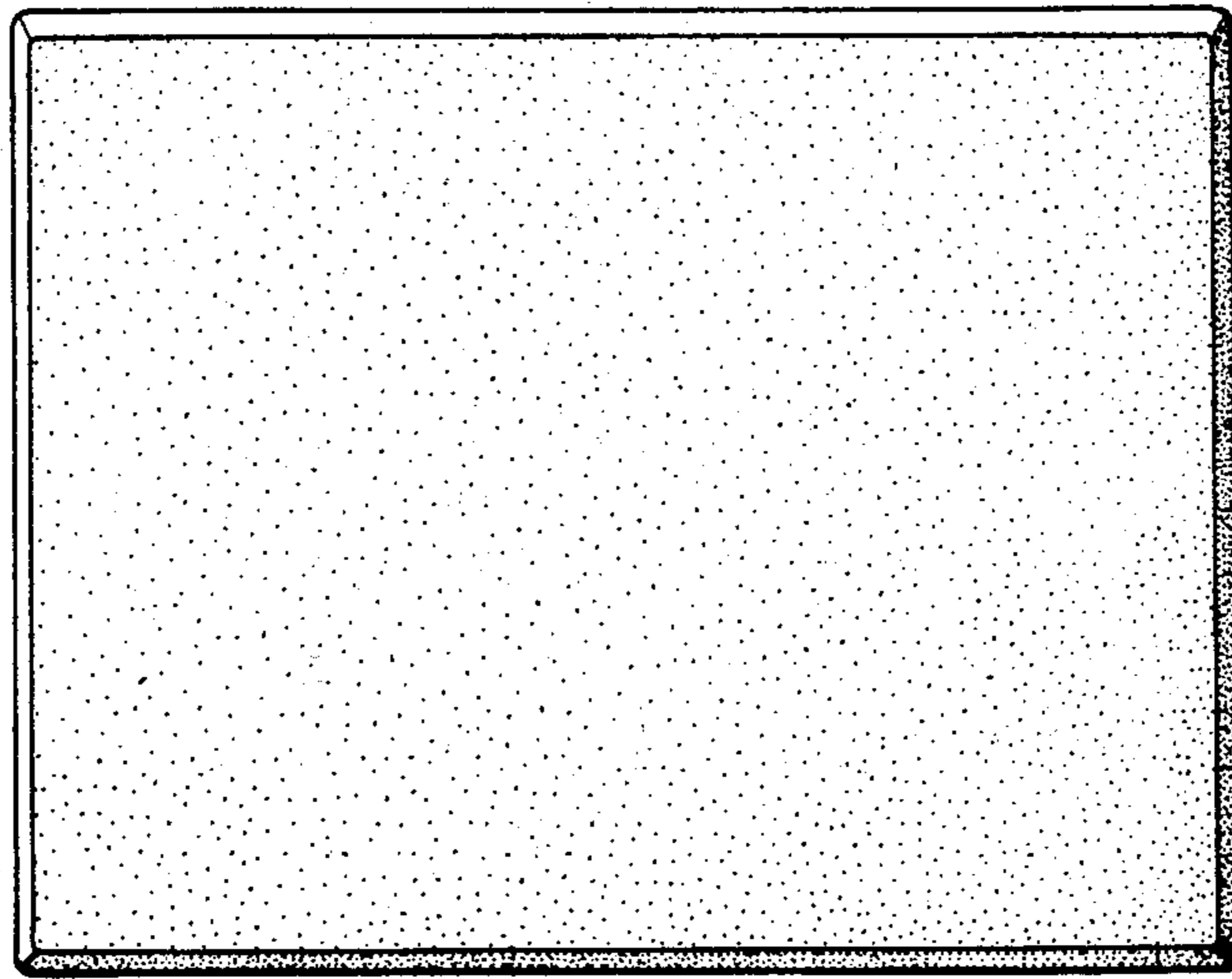

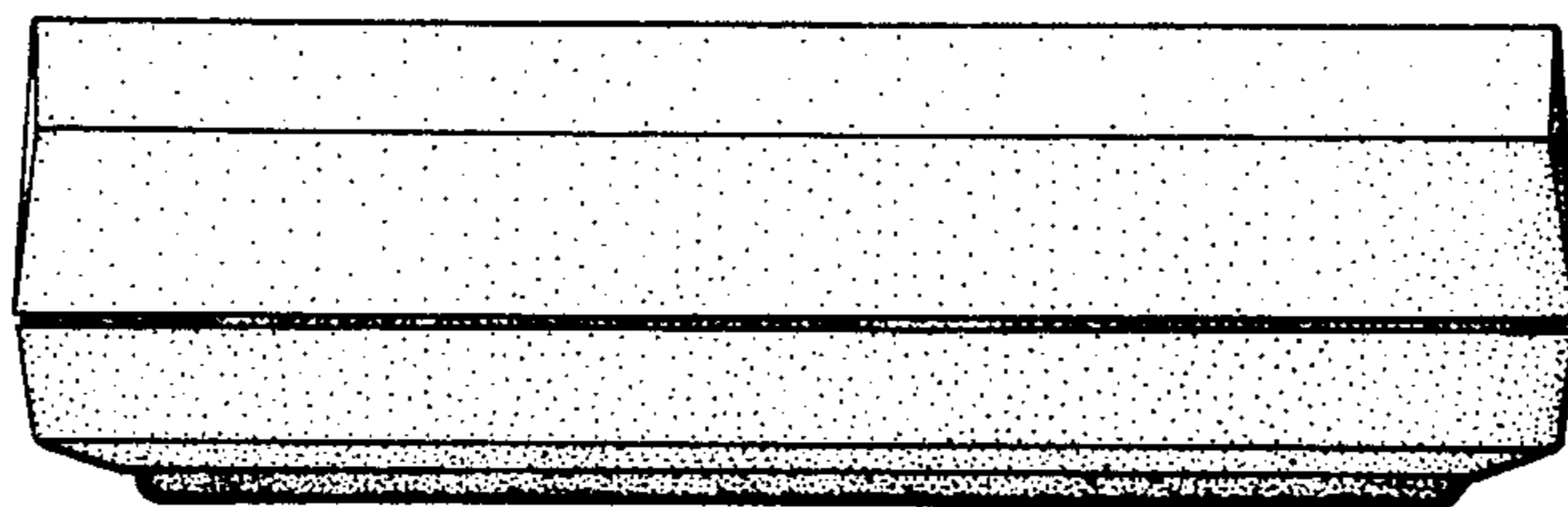

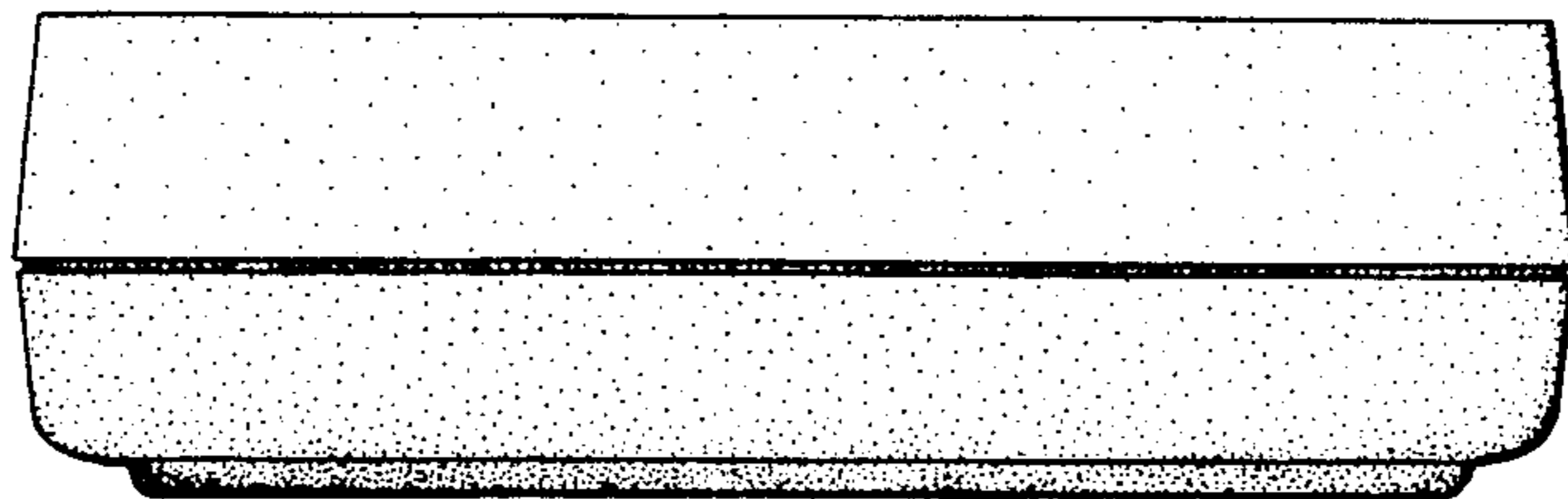

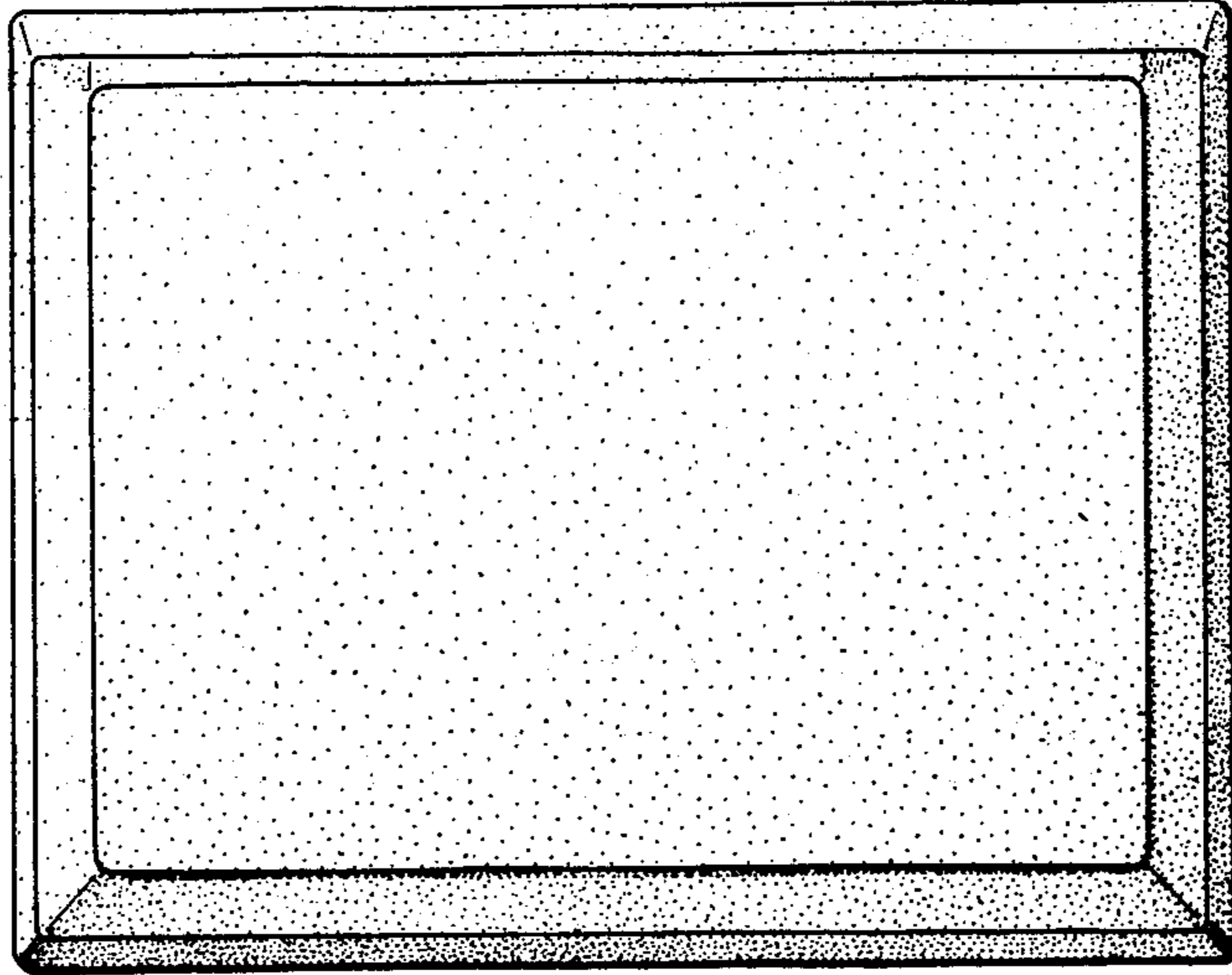
