[57] CLAIM

The ornamental design for a combined seat and table unit, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a combined seat and table unit showing my new design;

FIG. 2 is a front elevation view of the seat and table combination of FIG. 1.

FIG. 3 is a left side elevation view of the seat and table combination of FIG. 1.

FIG. 4 is a right side elevation view of the seat and table combination of FIG. 1.

FIG. 13 is a front perspective view of a combined seat and table unit showing a third embodiment of my design;


FIG. 14 is a front elevation view of the seat and table combination of FIG. 13.




FIG. 15 is a left side elevation view of the seat and table combination of FIG. 13.

FIG. 18 is a top elevation view of the seat and table combination of FIG. 13.
































