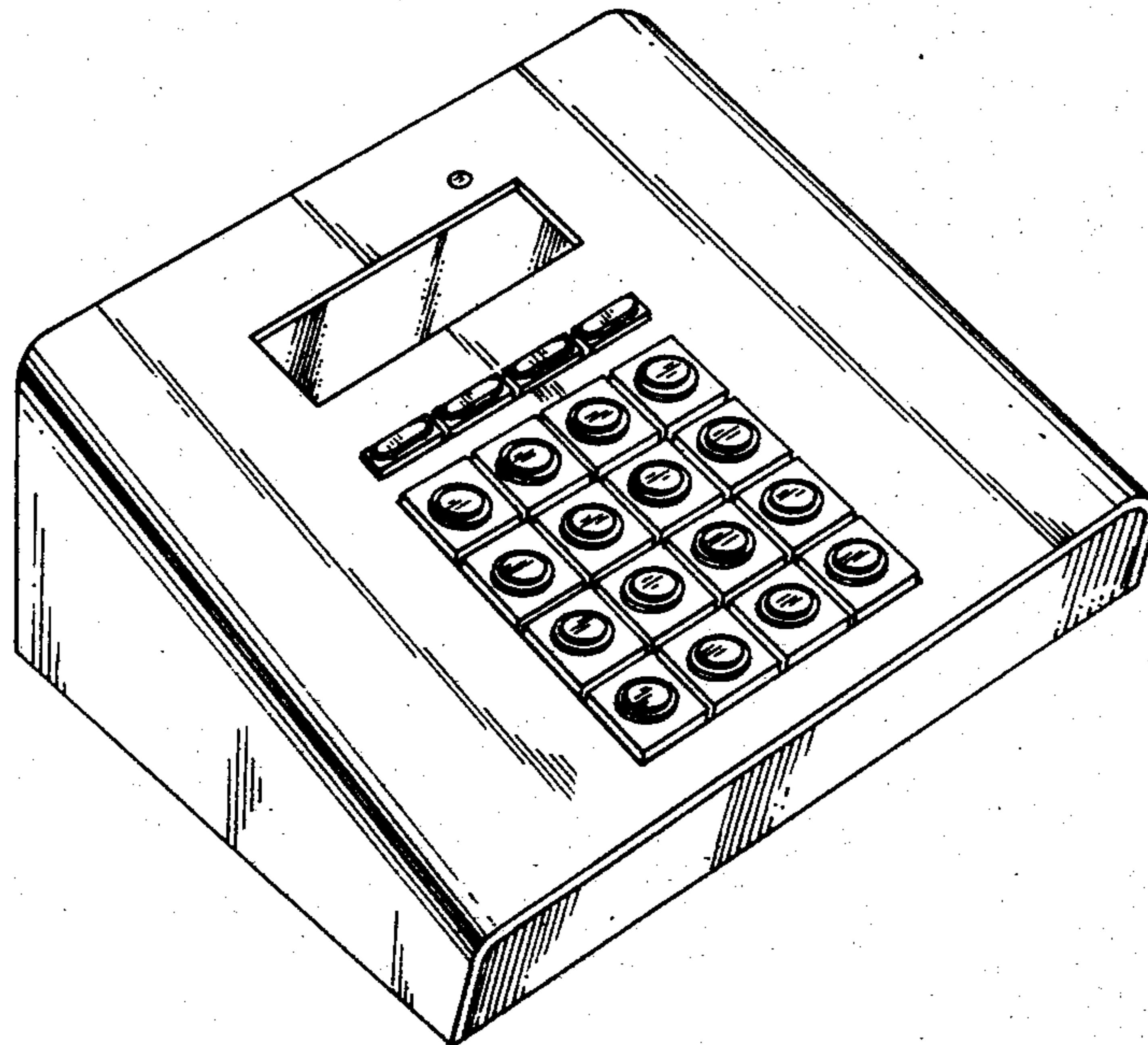

[57] CLAIM

The ornamental design for a microprocessor controller for automated document retrieval systems, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a microprocessor controller for automated document retrieval systems showing my new design;  
FIG. 2 is a top plan view thereof on an enlarged scale;  
FIG. 3 is a bottom plan view thereof;  
FIG. 4 is a left side elevational view thereof on an enlarged scale;  
FIG. 5 is a right side elevational view thereof on an enlarged scale;  
FIG. 6 is a front elevational view thereof on an enlarged scale;  
FIG. 7 is a rear elevational view thereof on an enlarged scale.



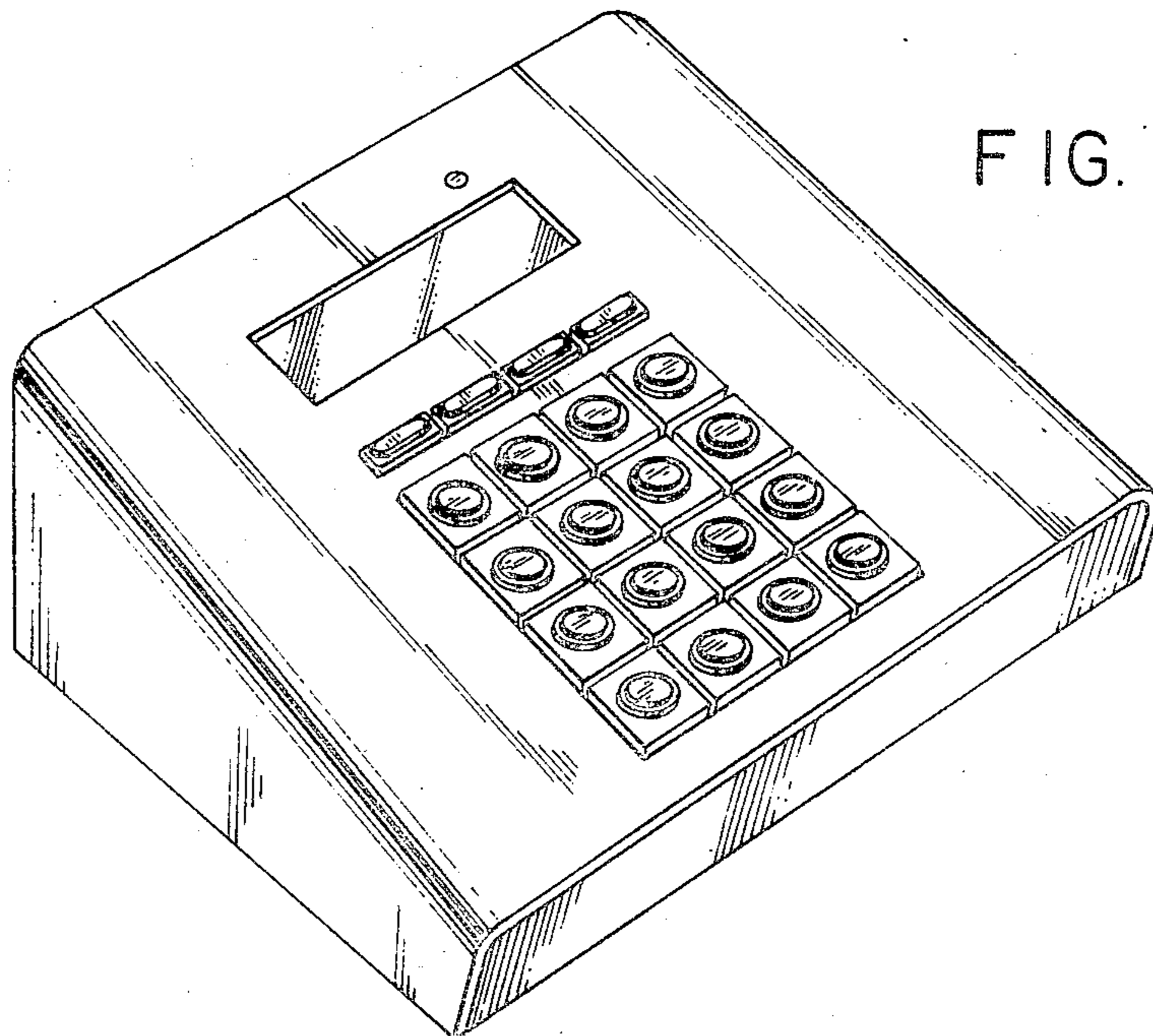

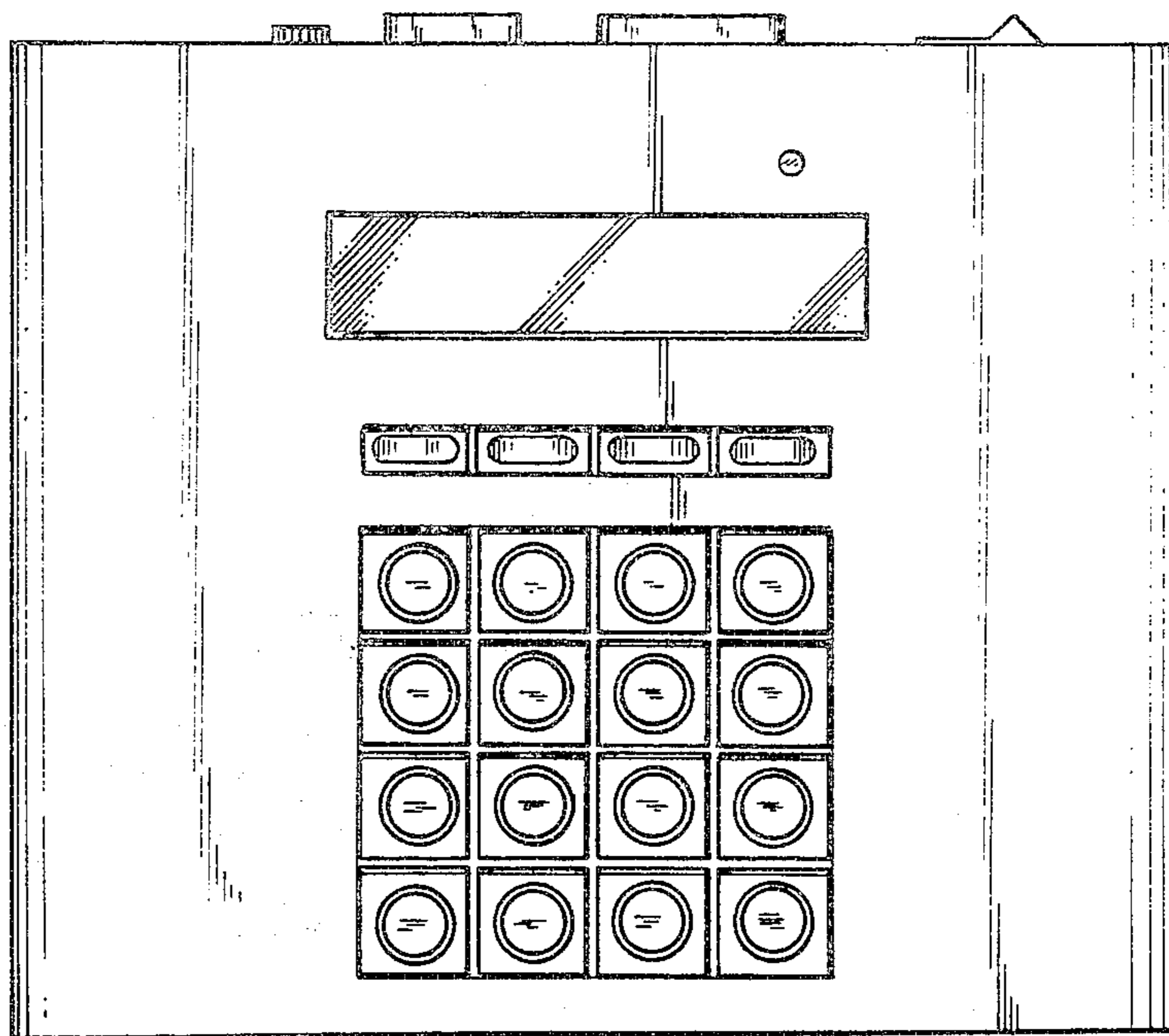

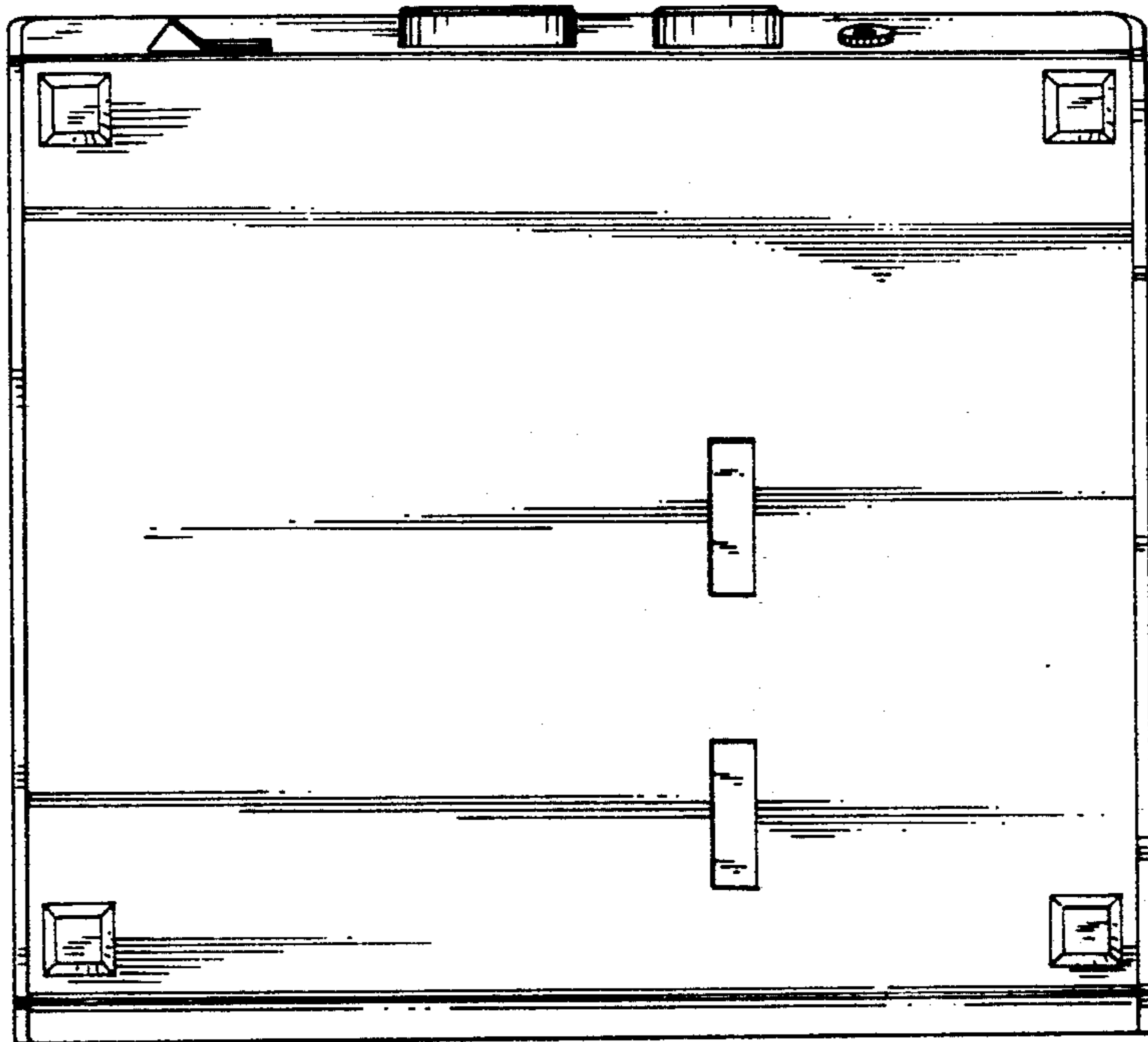

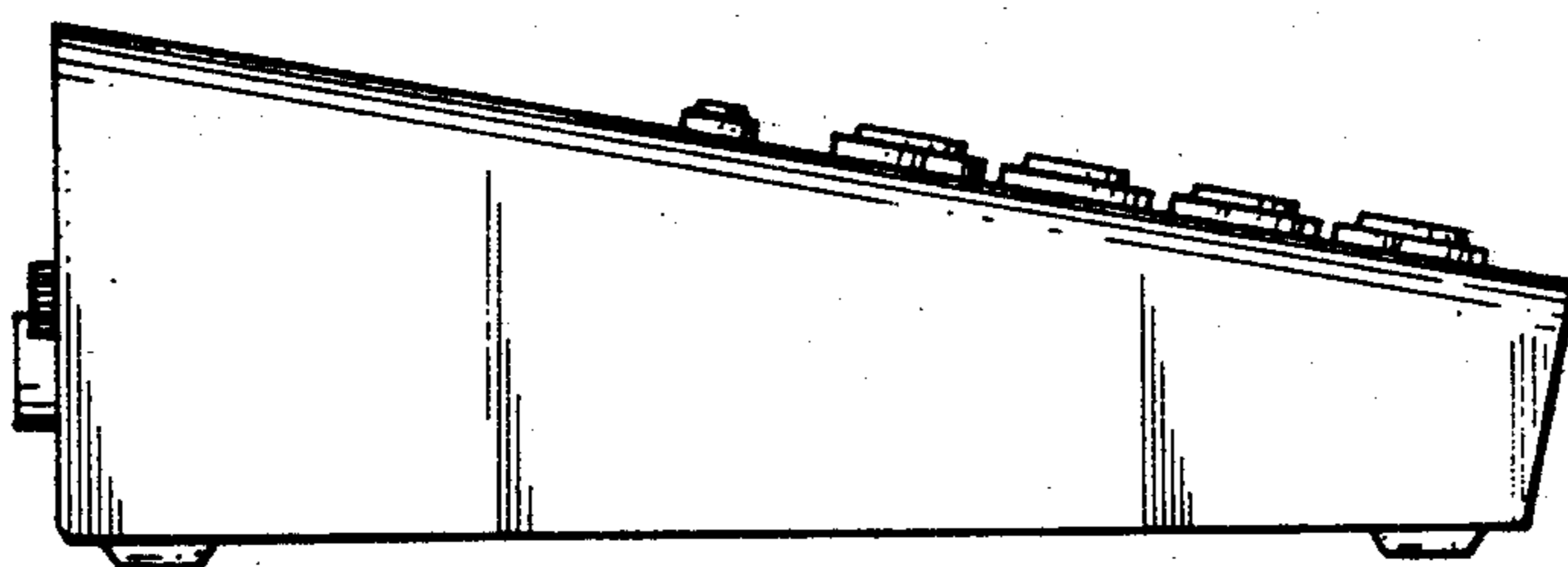

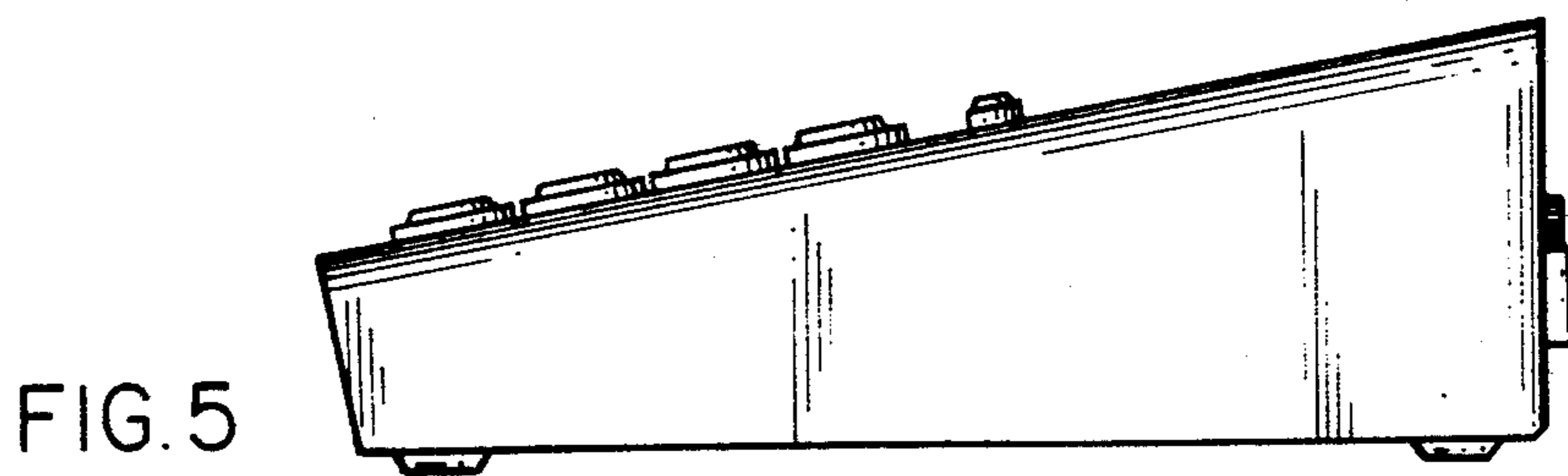

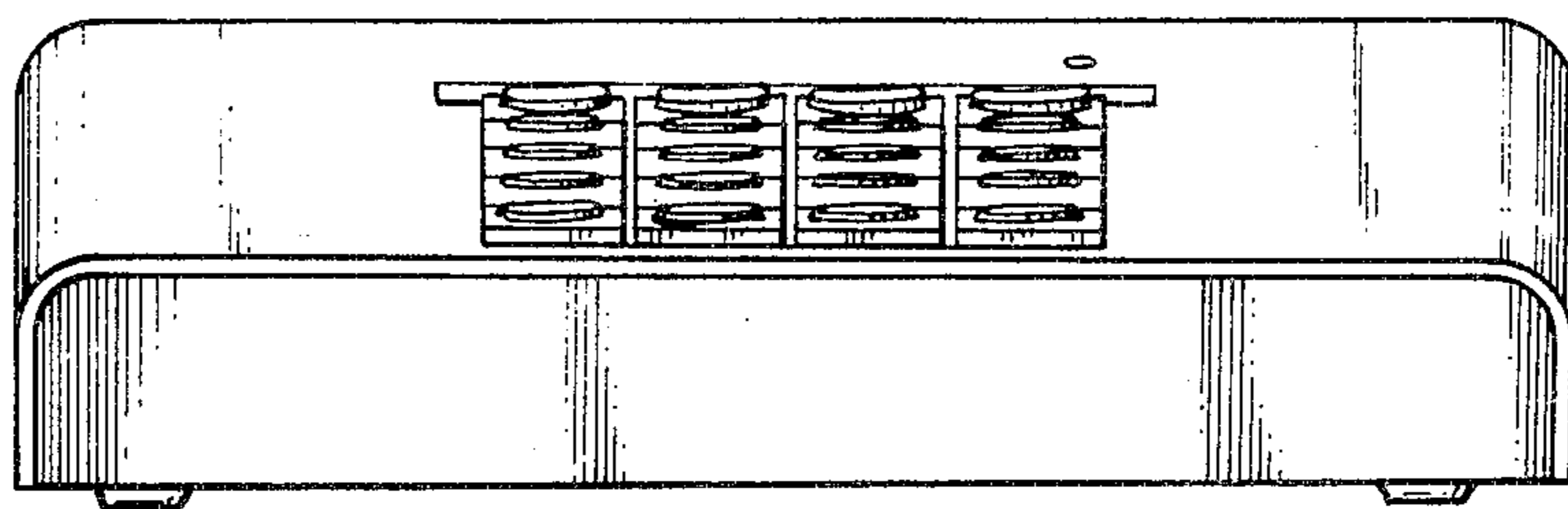

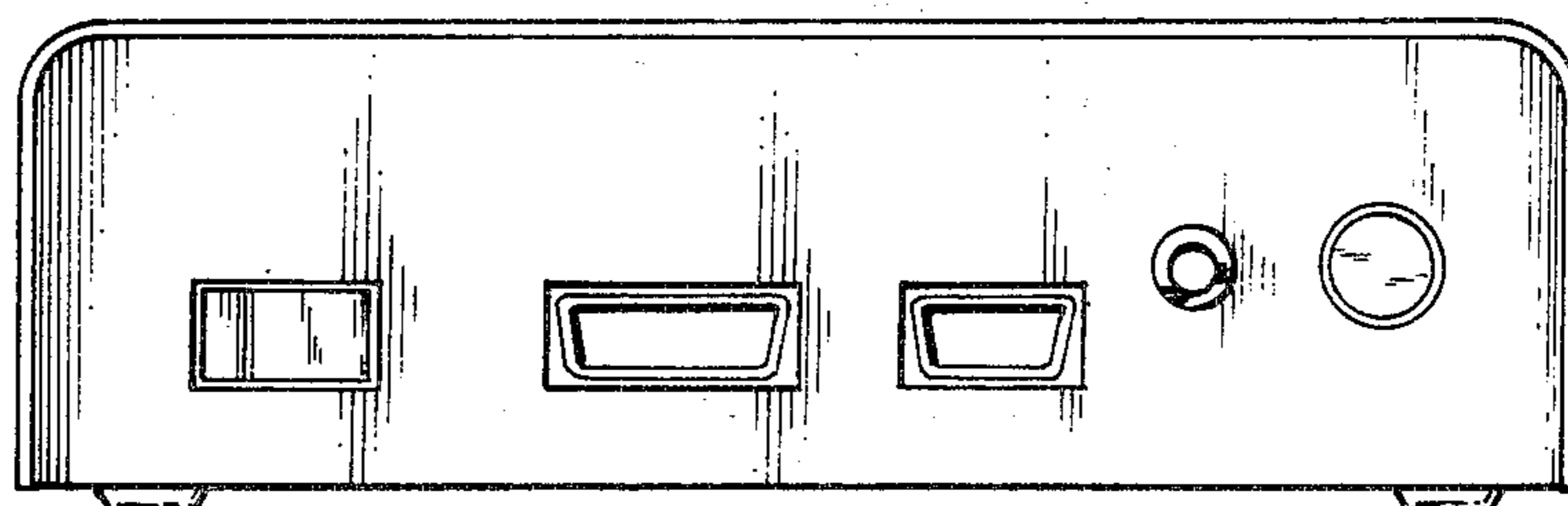
