a third embodiment of my design;

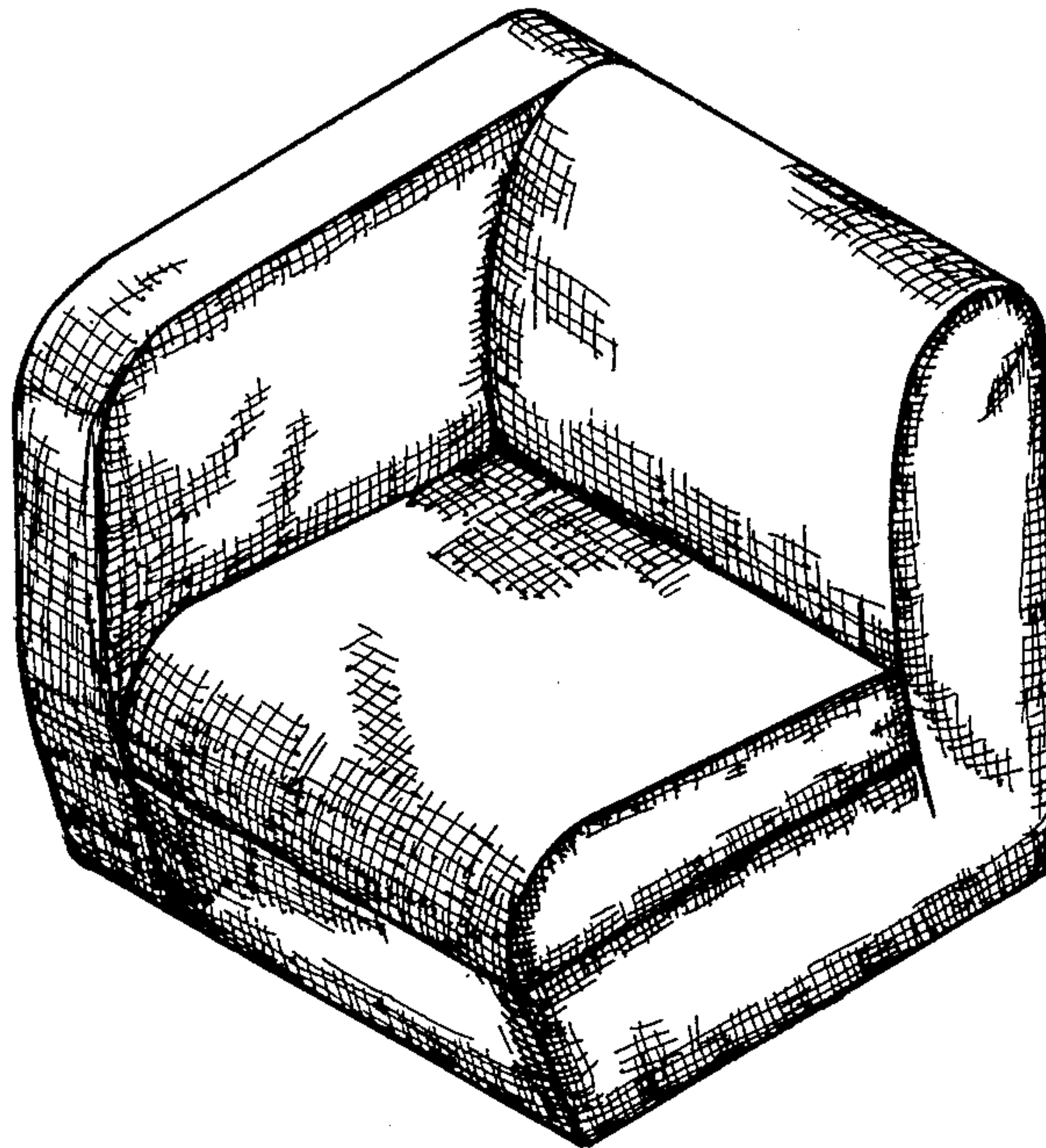
FIG. 13 is a front elevation view of the seat of FIG. 12;

FIG. 17 is a top elevation view of the seat of FIG. 12.



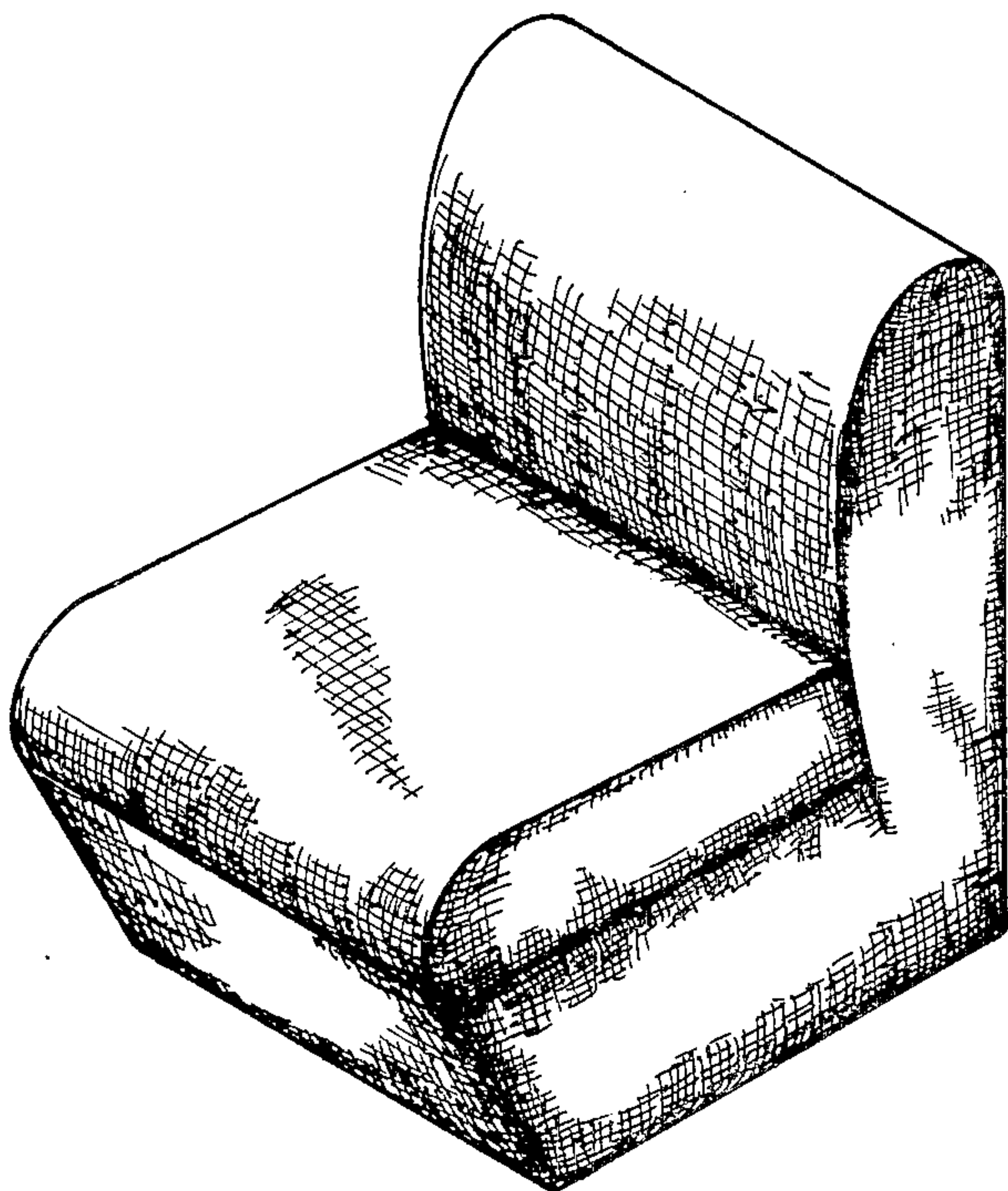

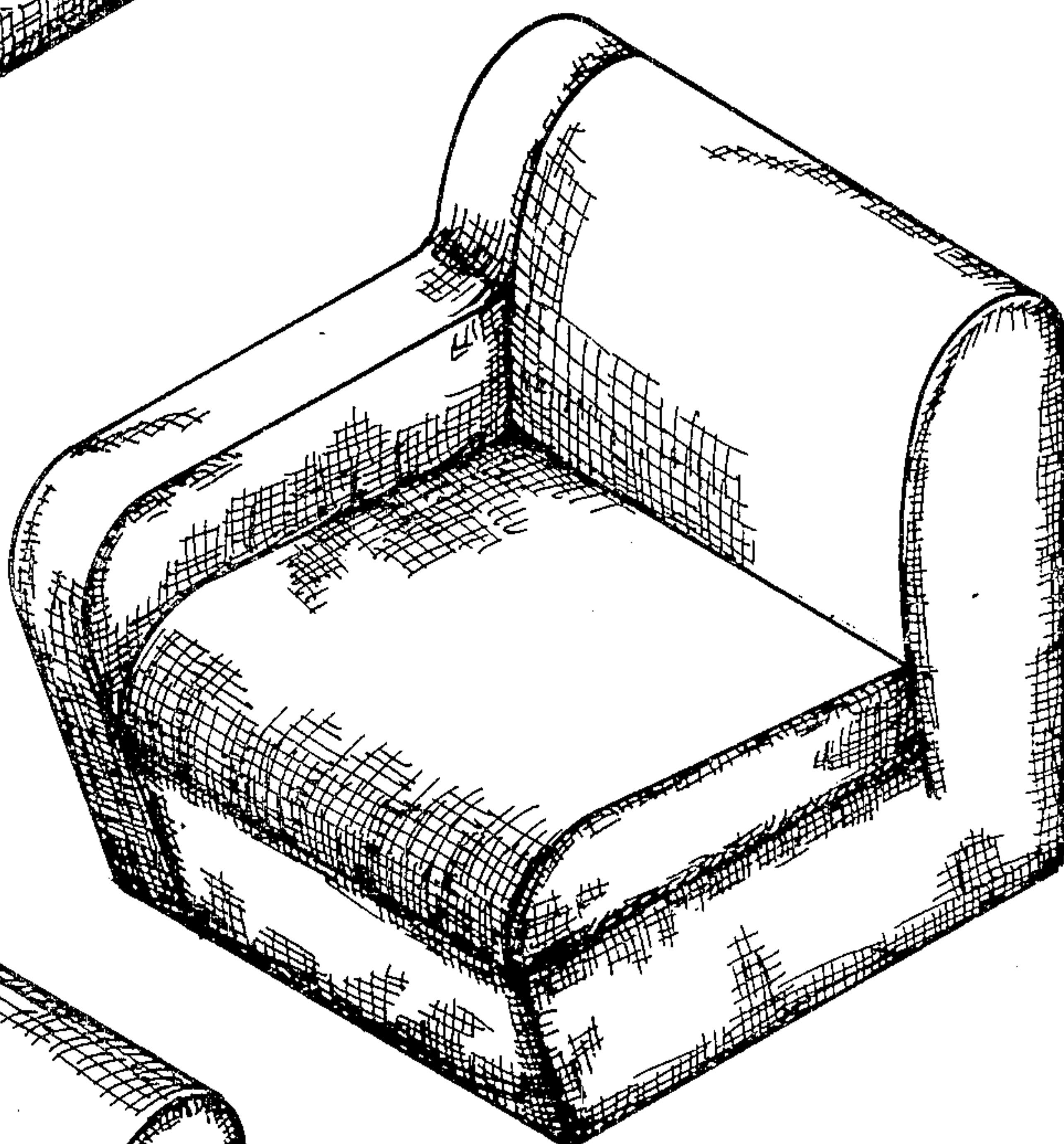

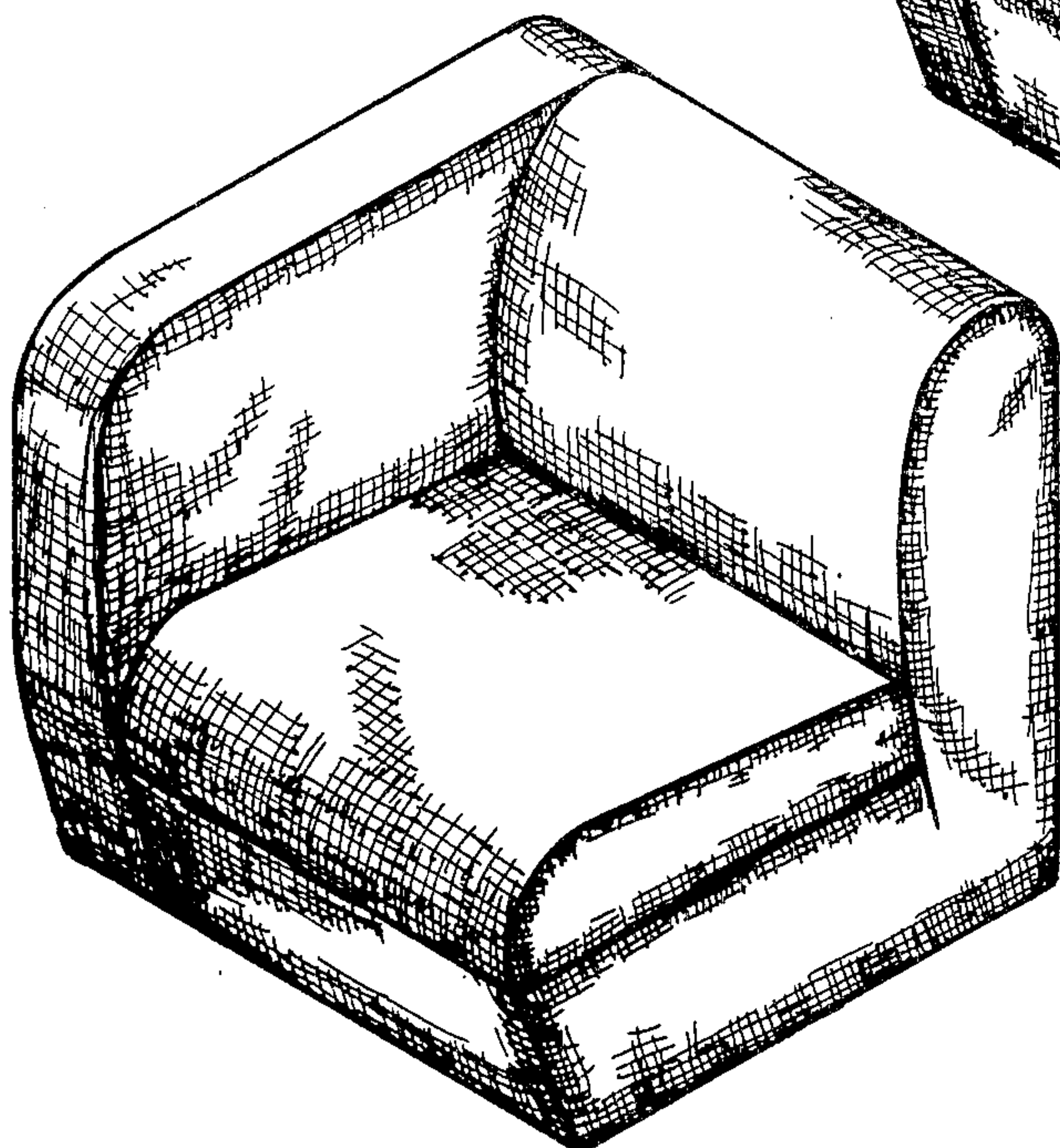

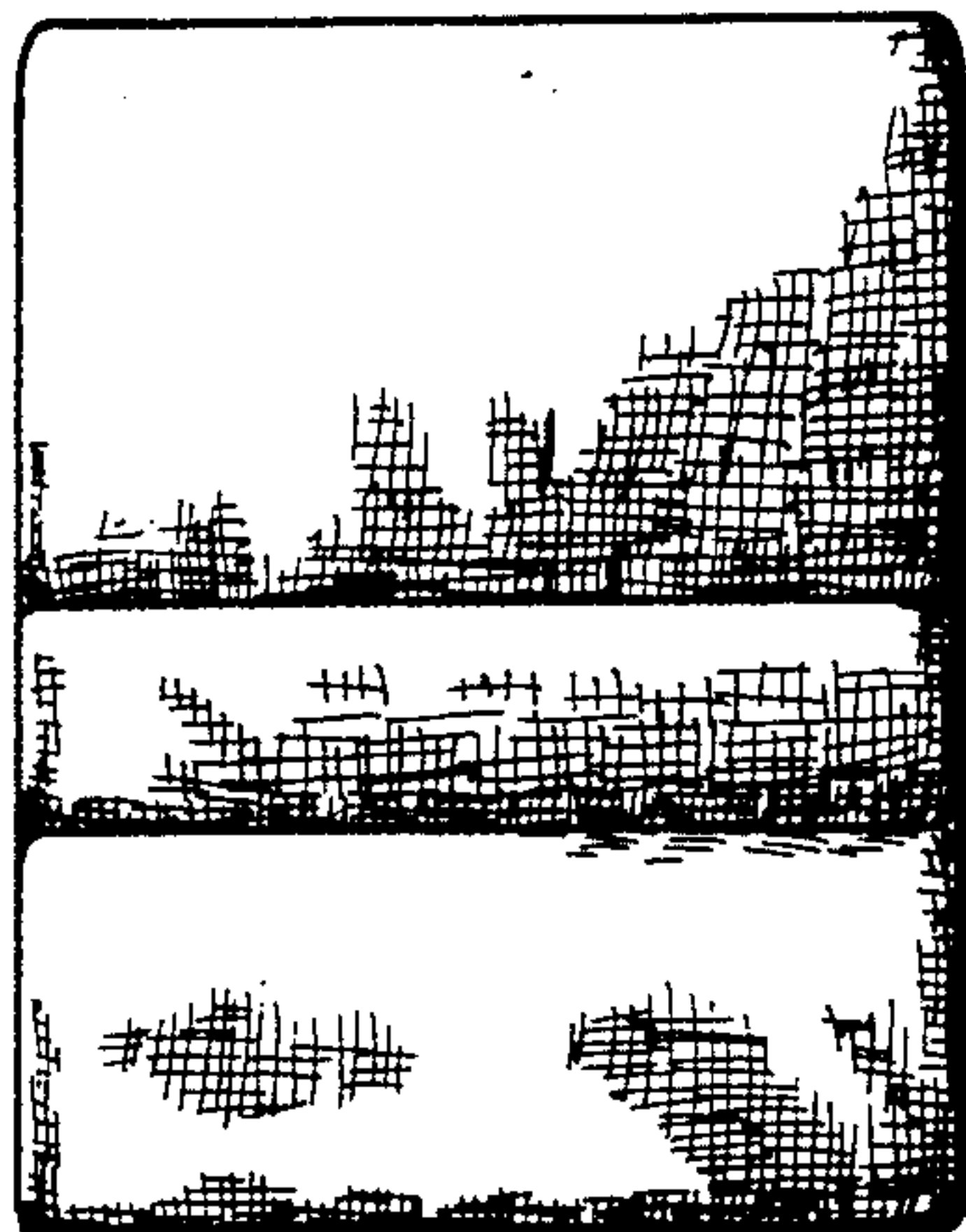

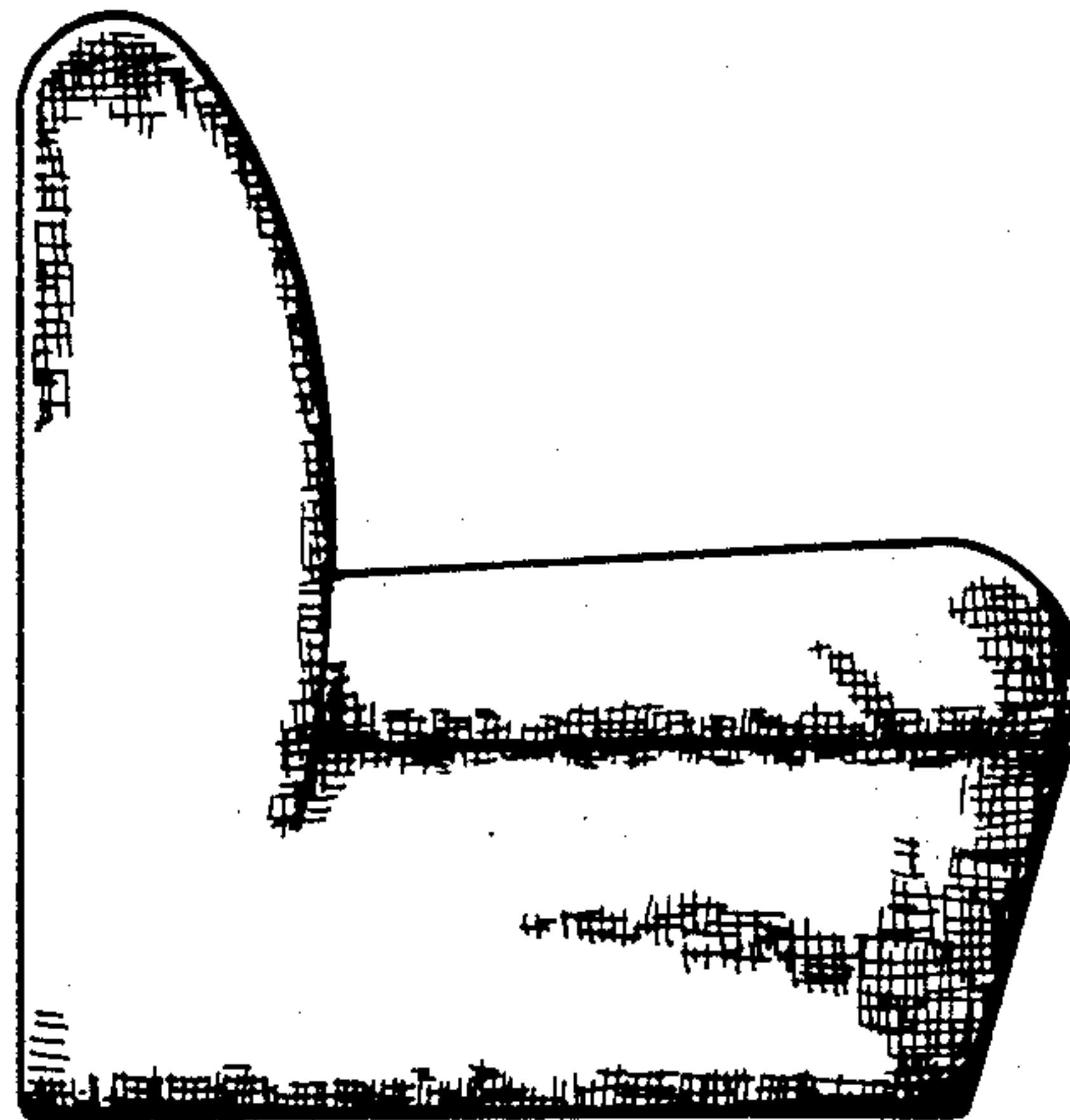

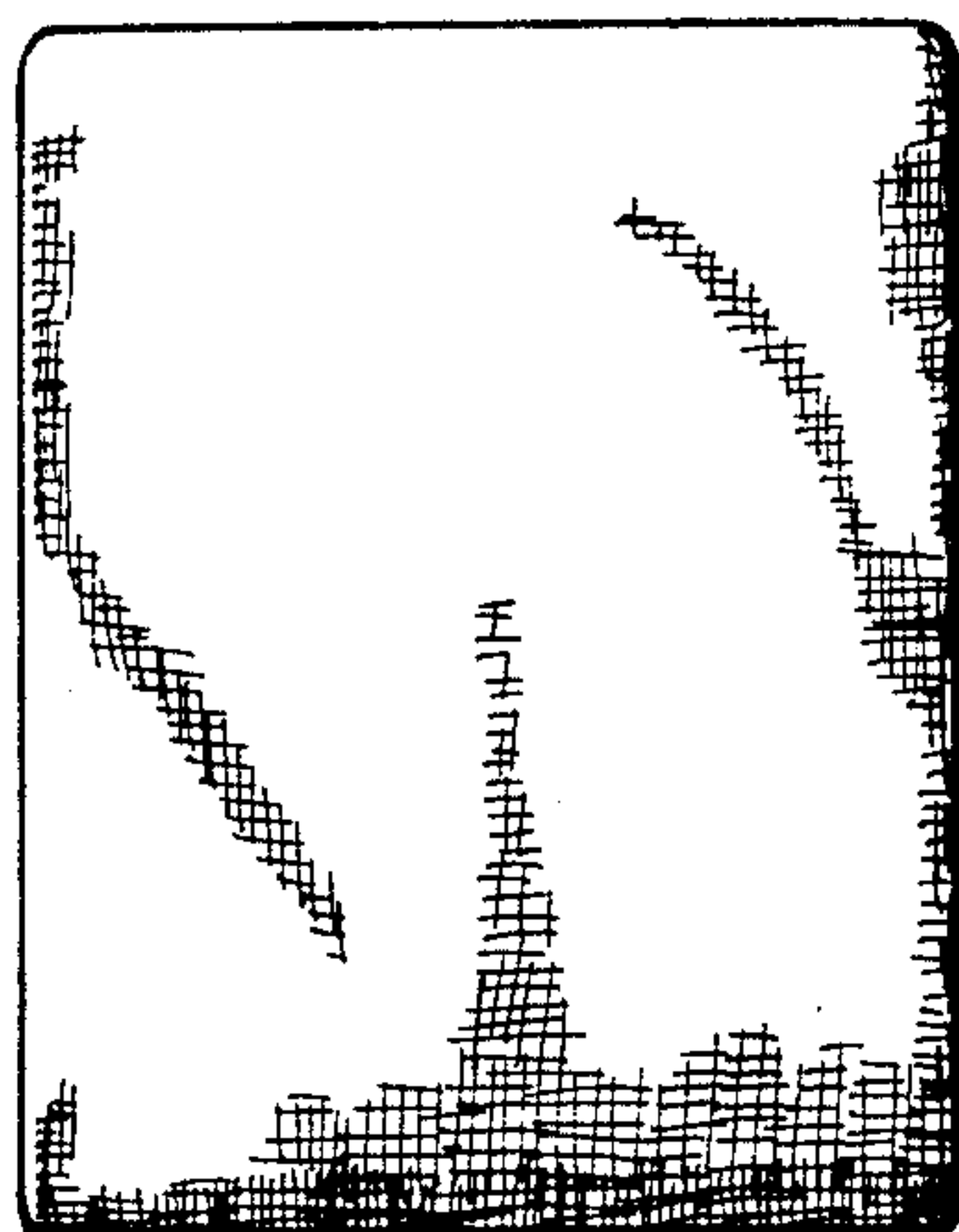

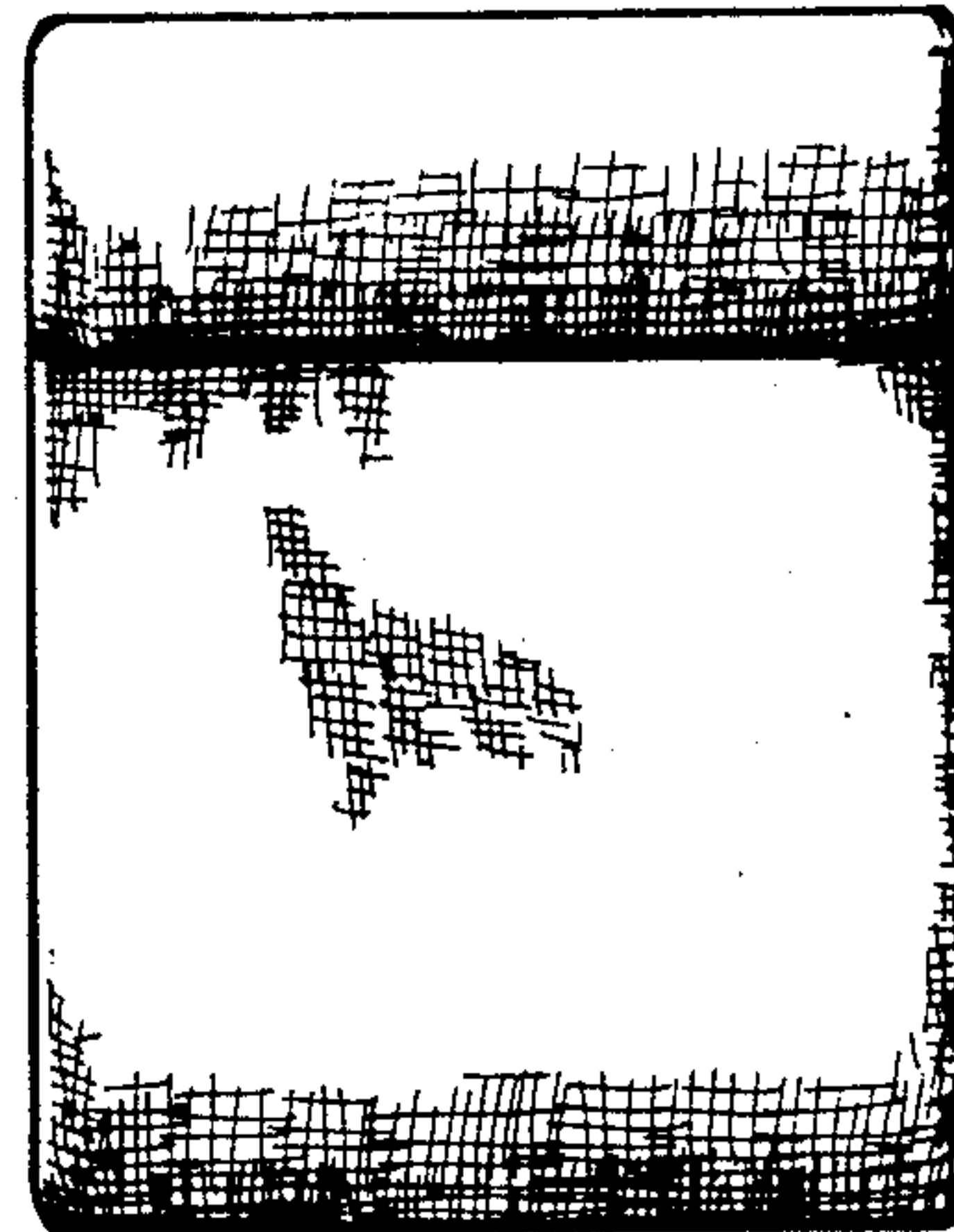

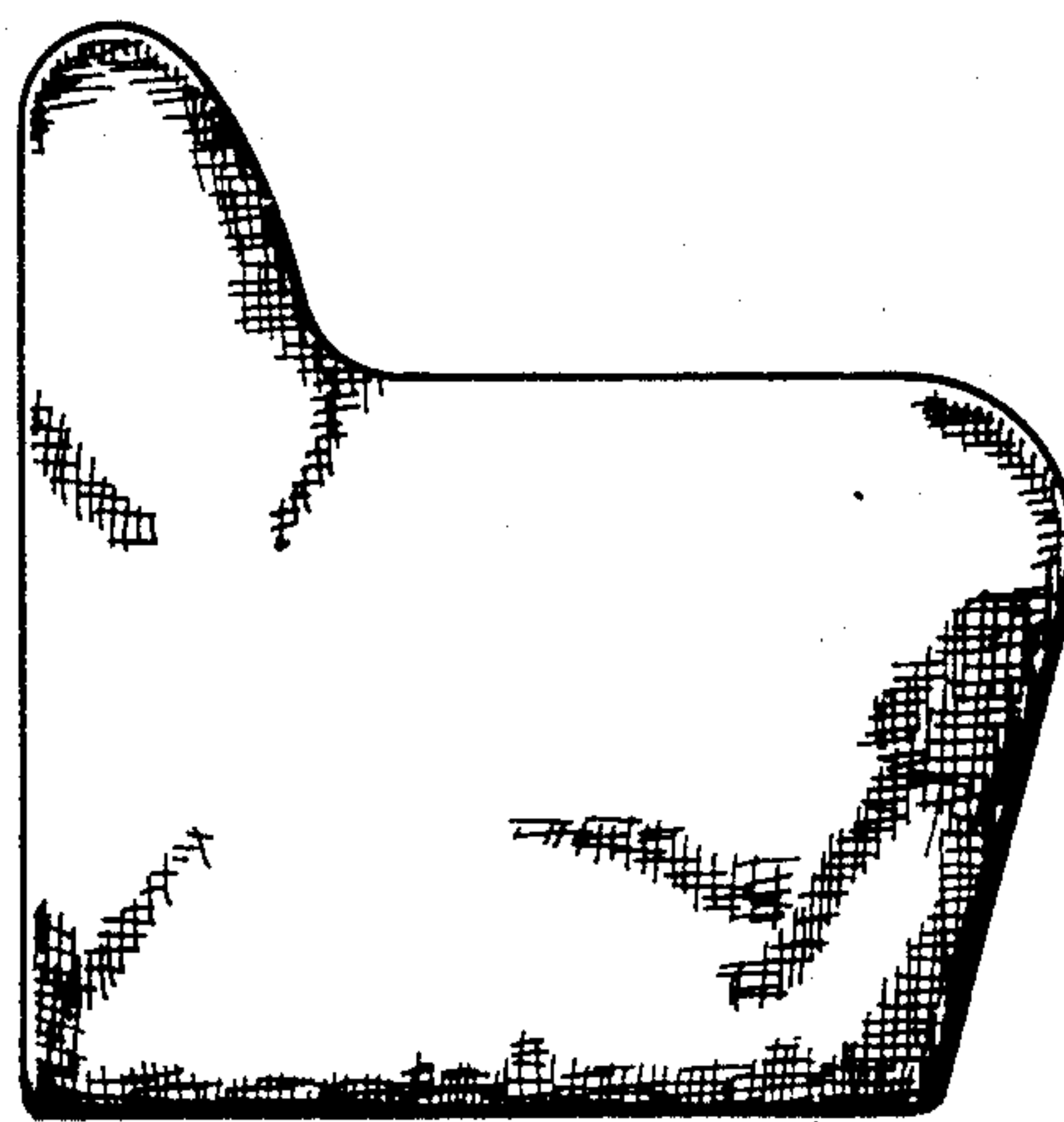

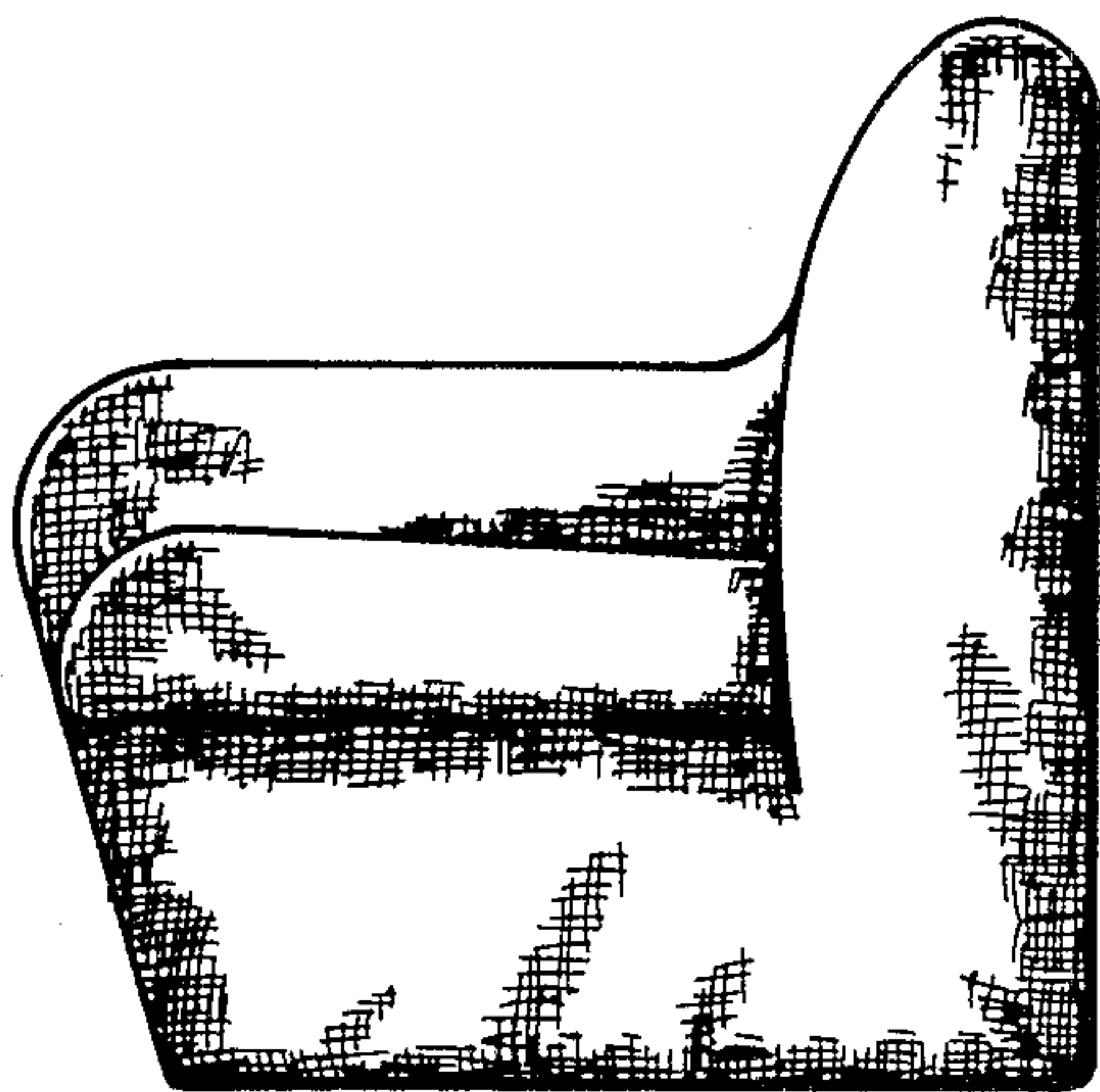

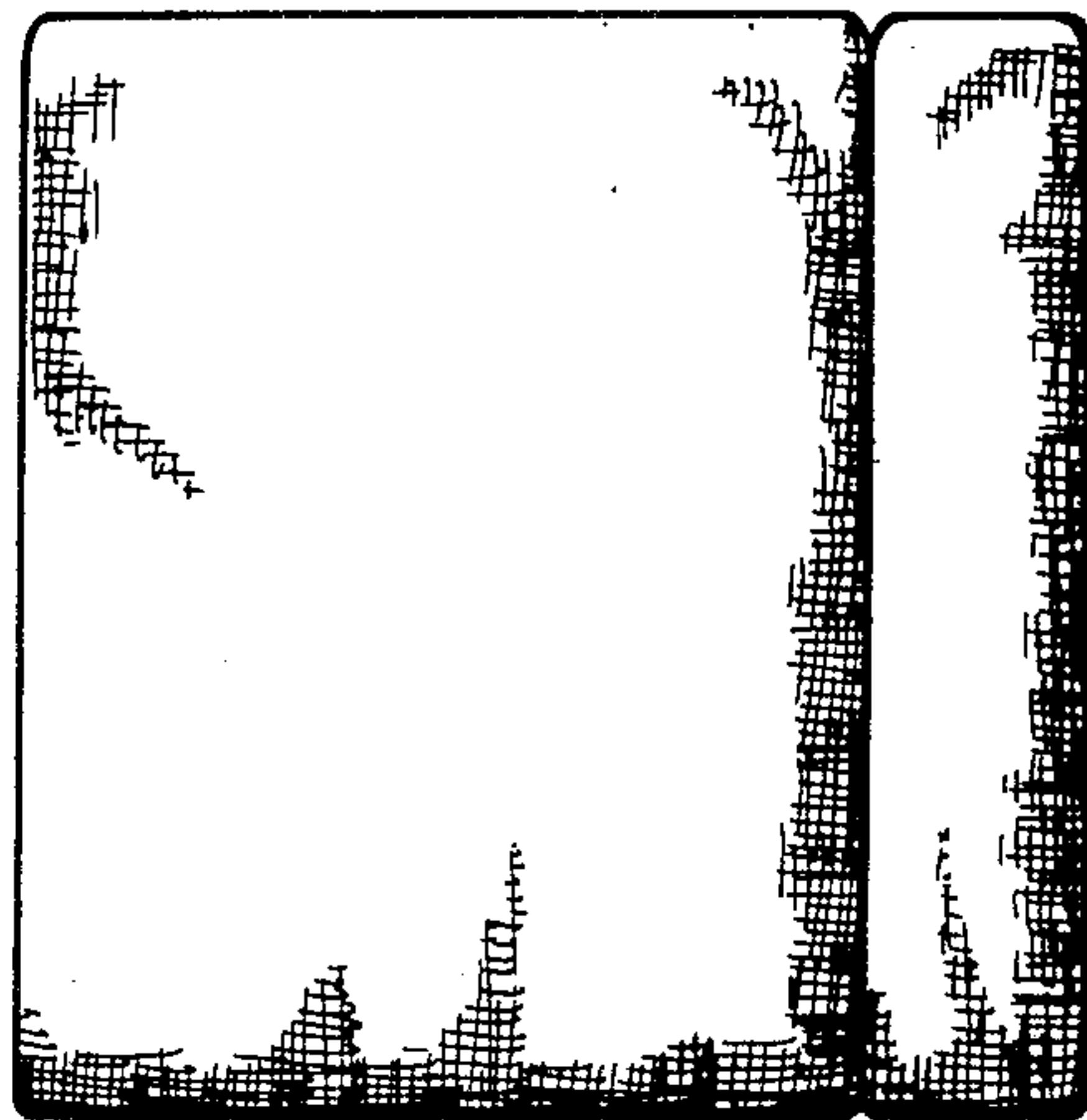

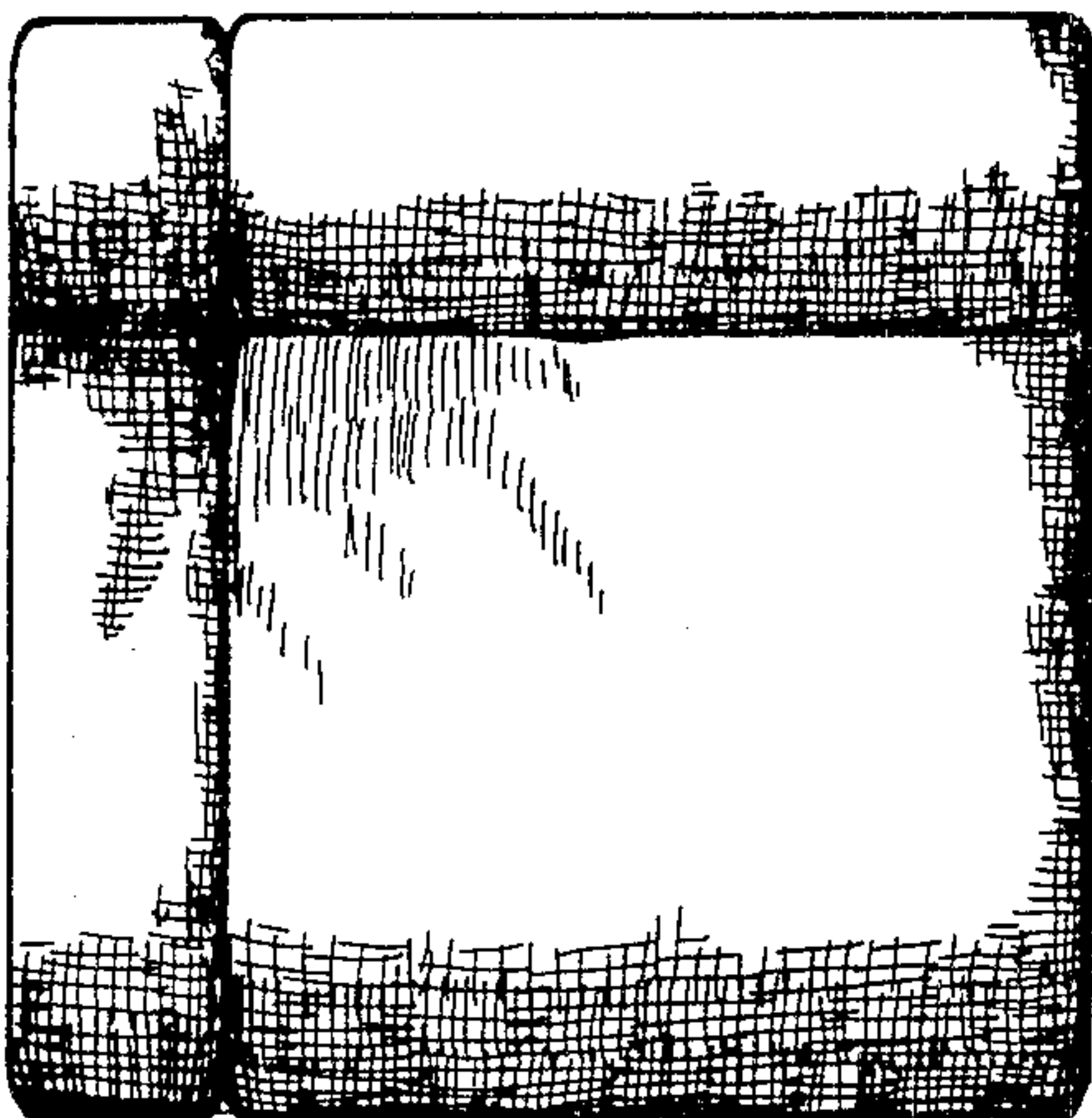

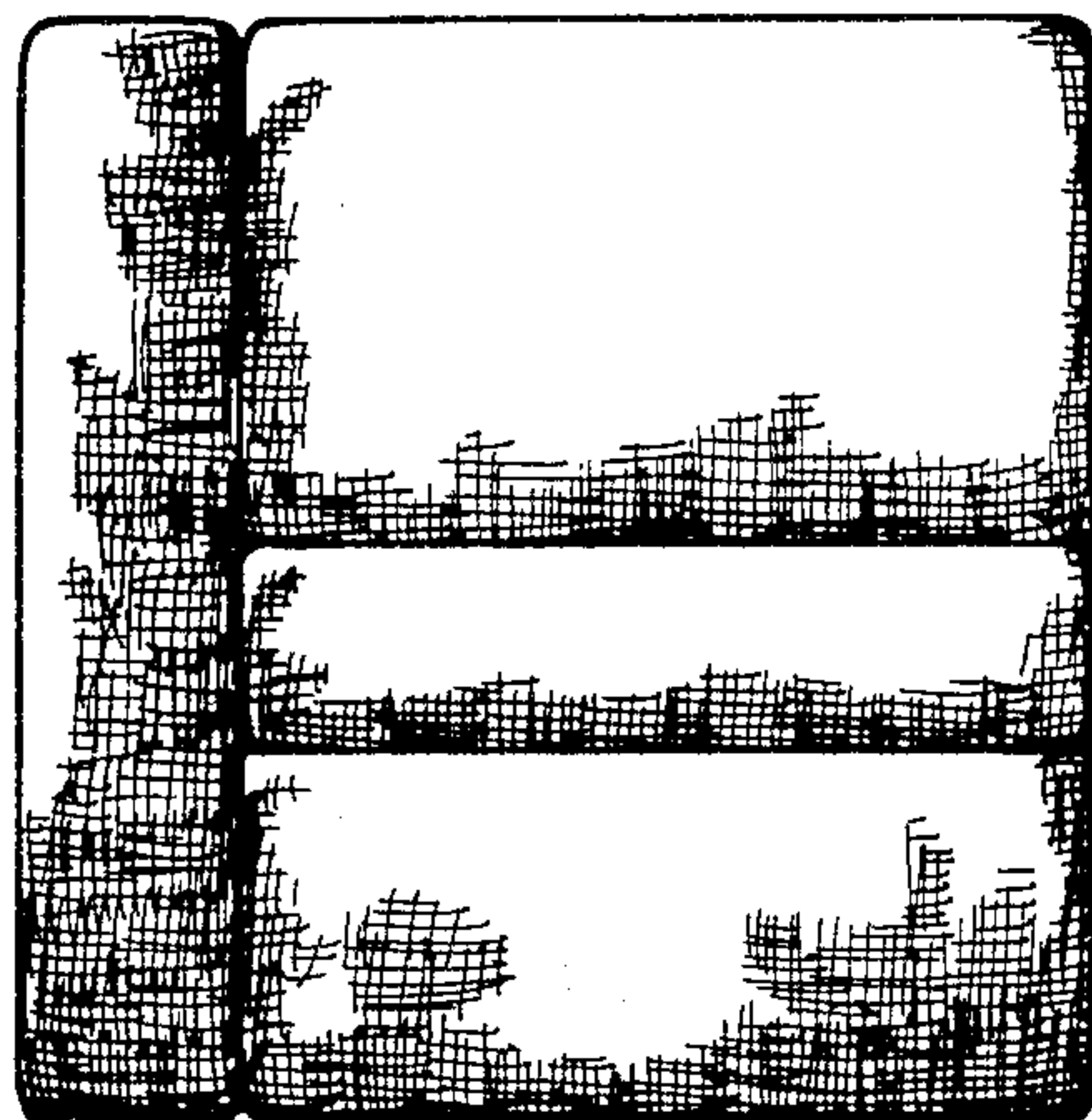

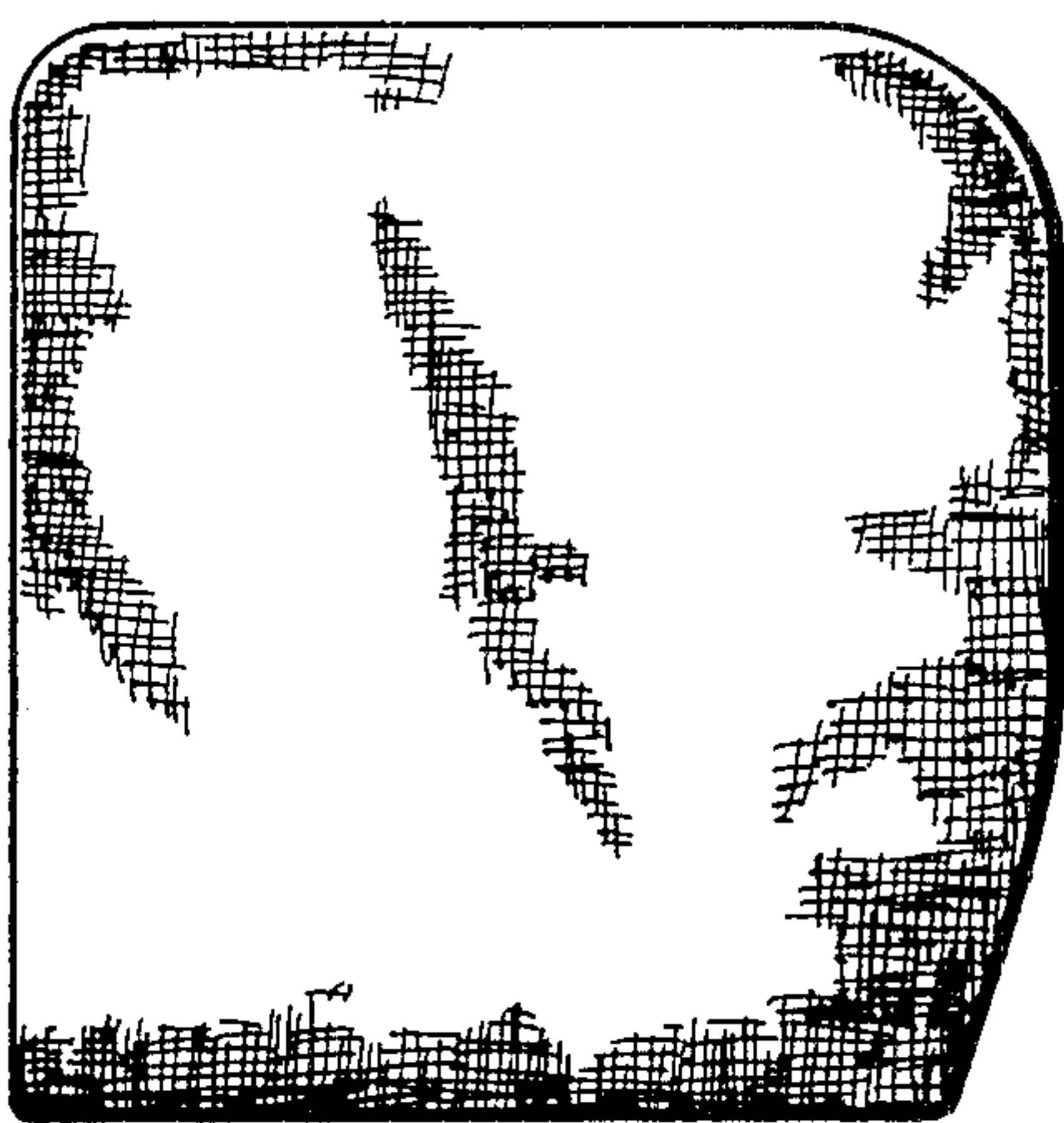

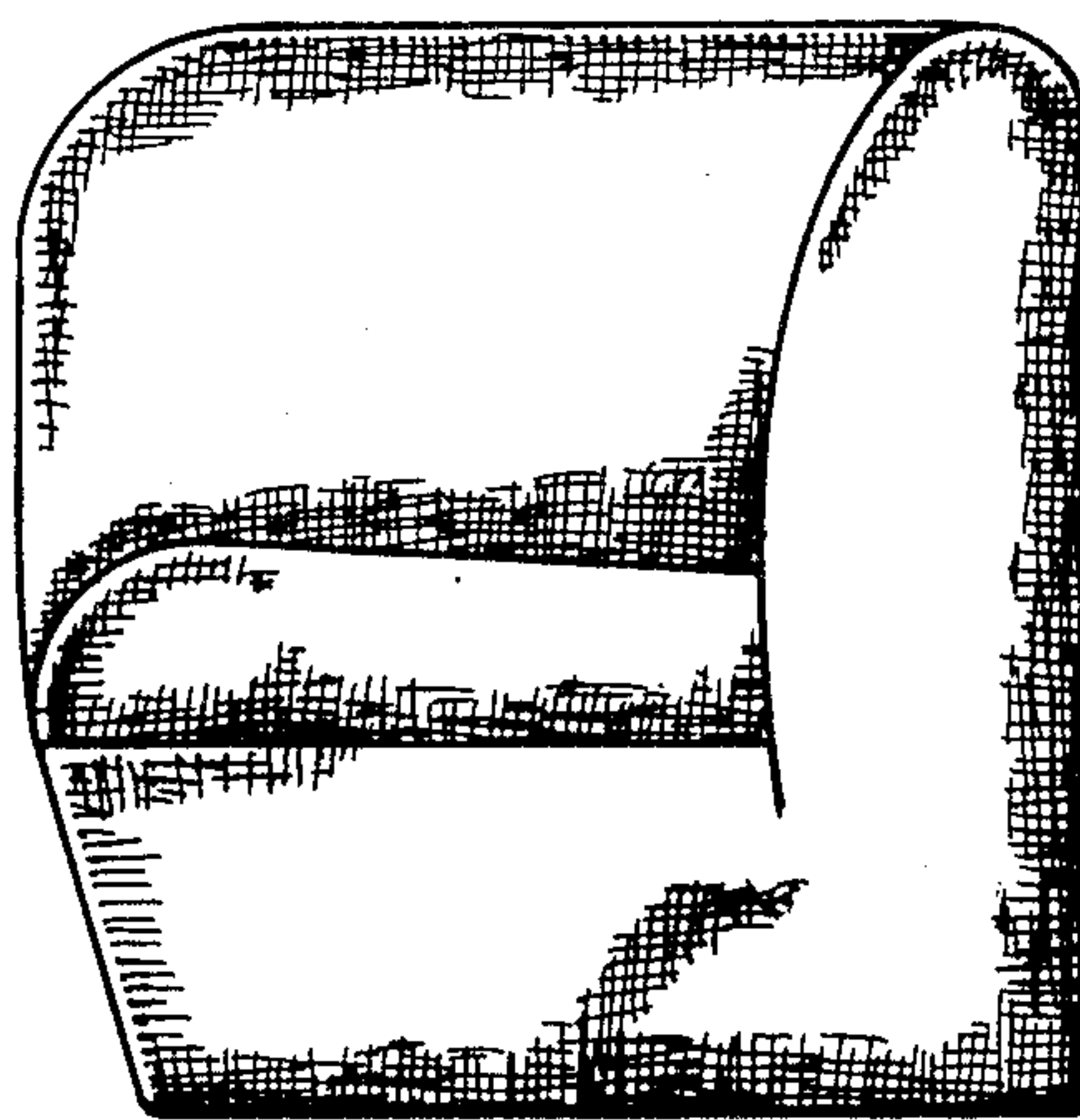

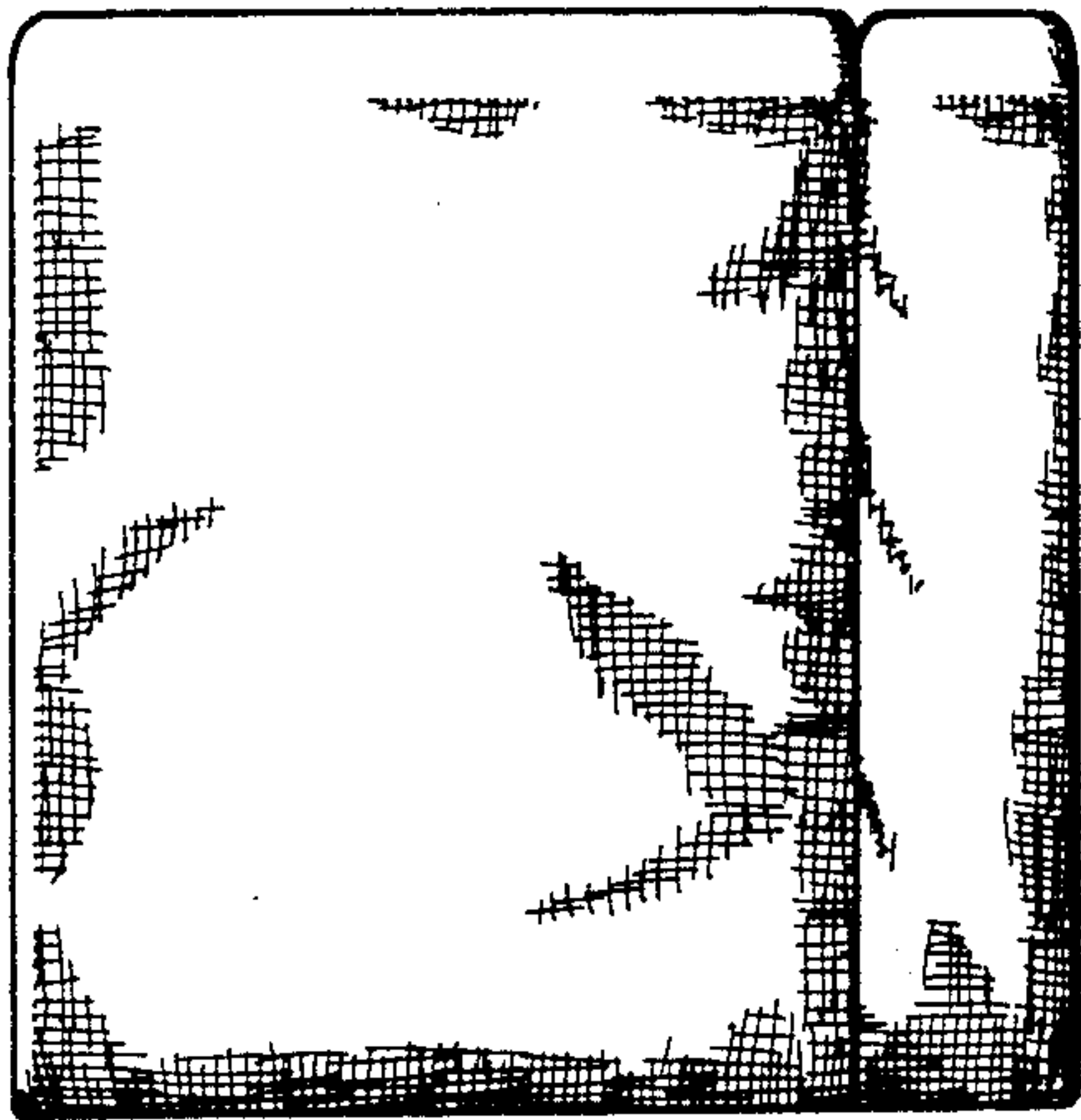

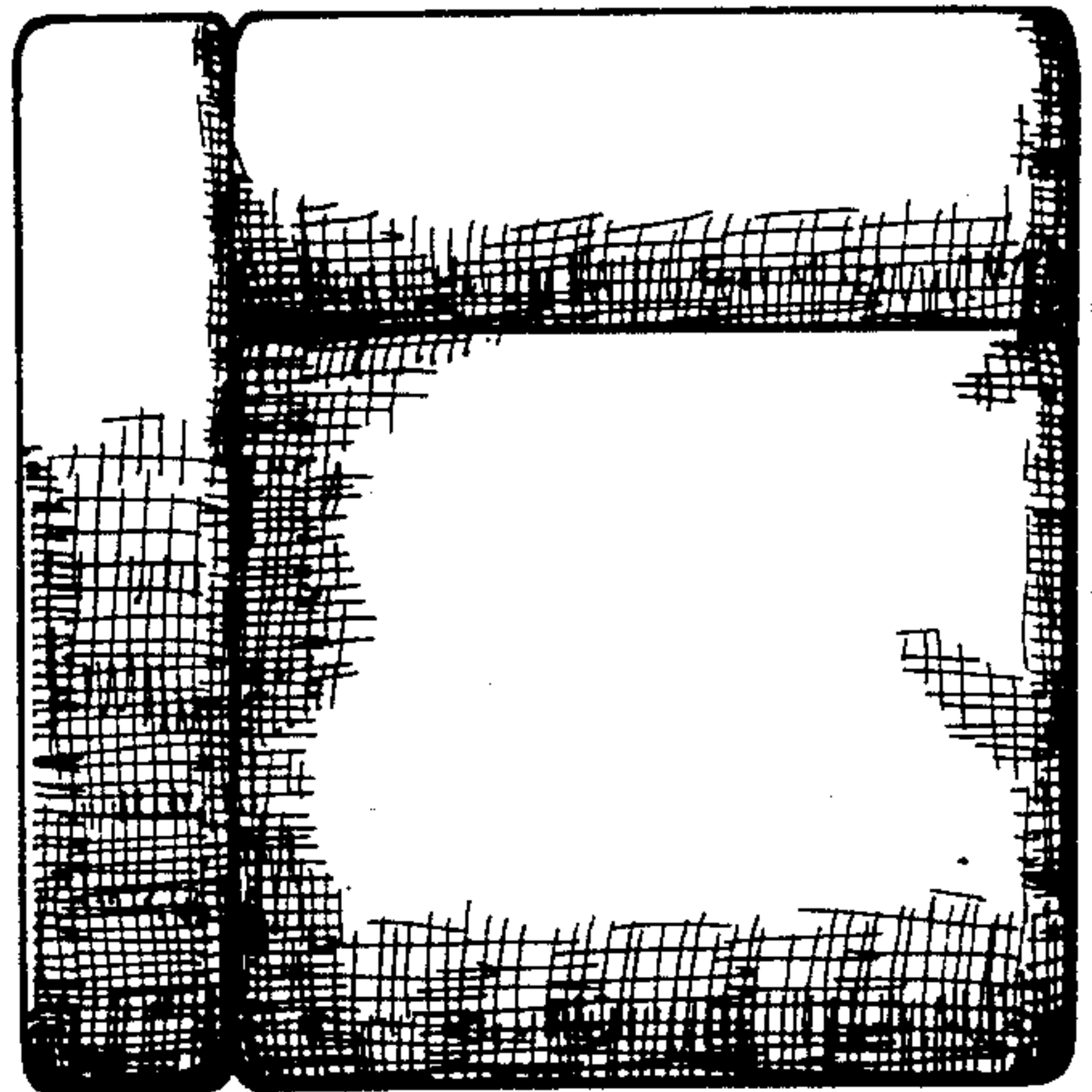
