DESCRIPTION

FIG. 10 is a left side elevational view thereof.

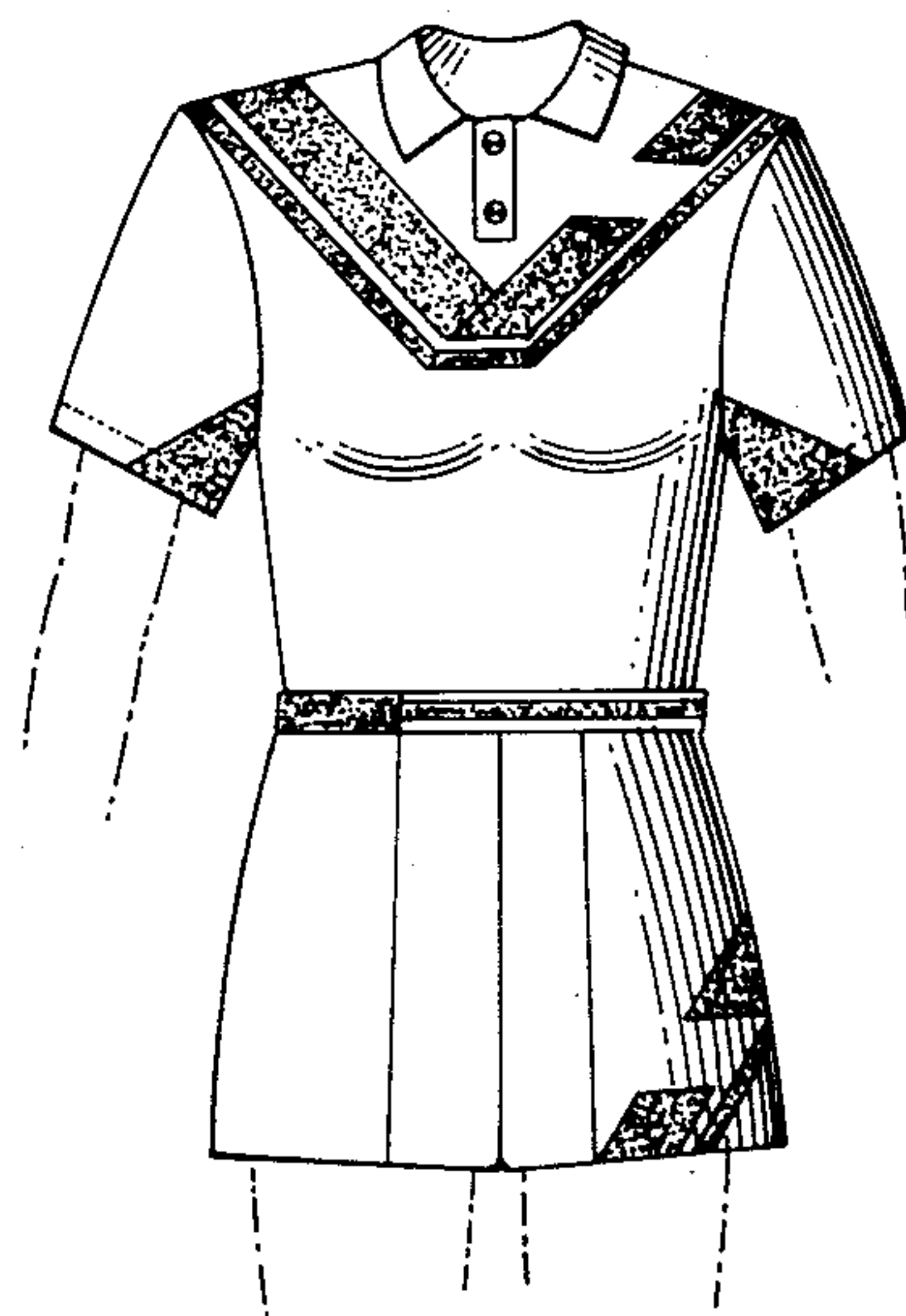
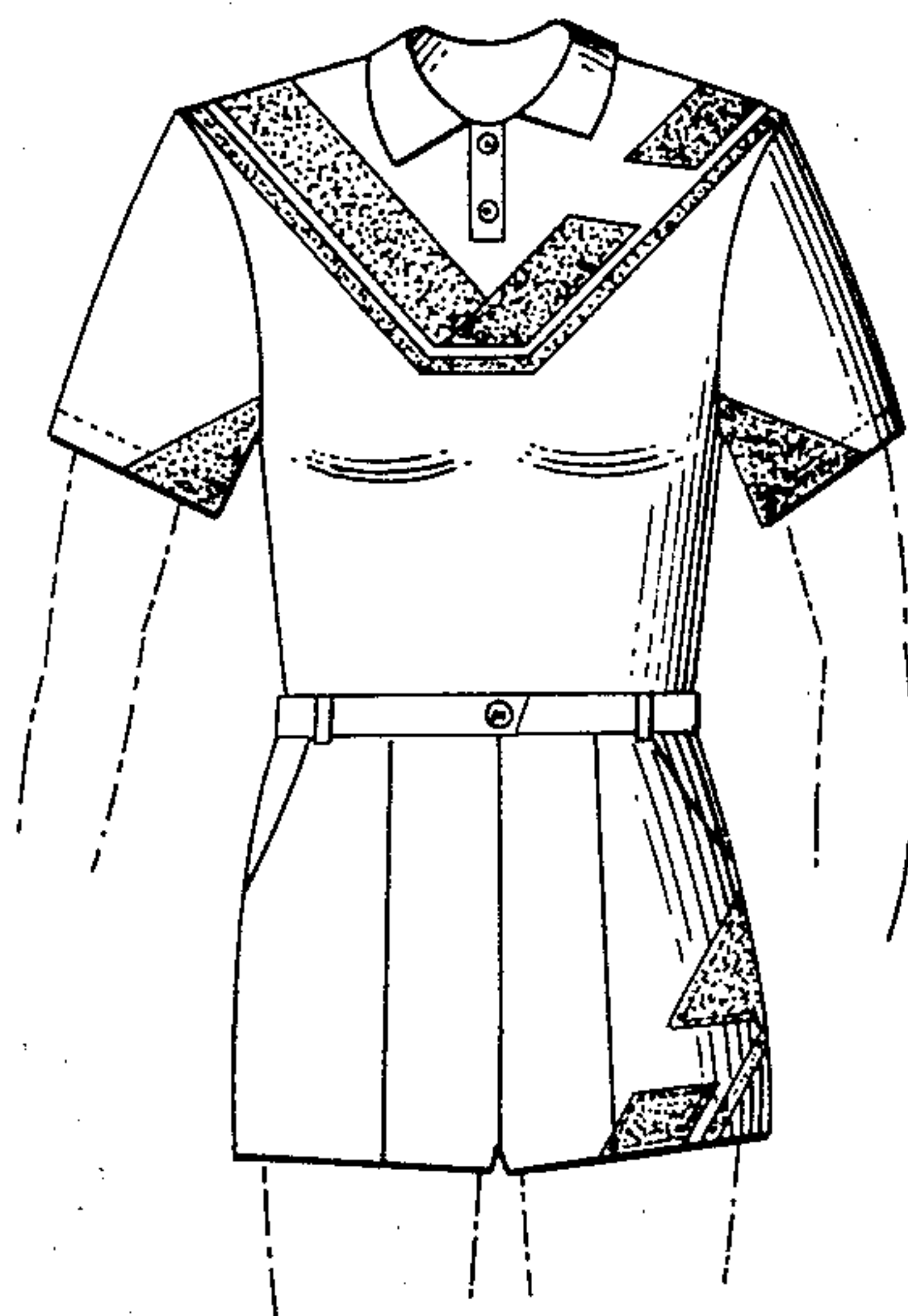

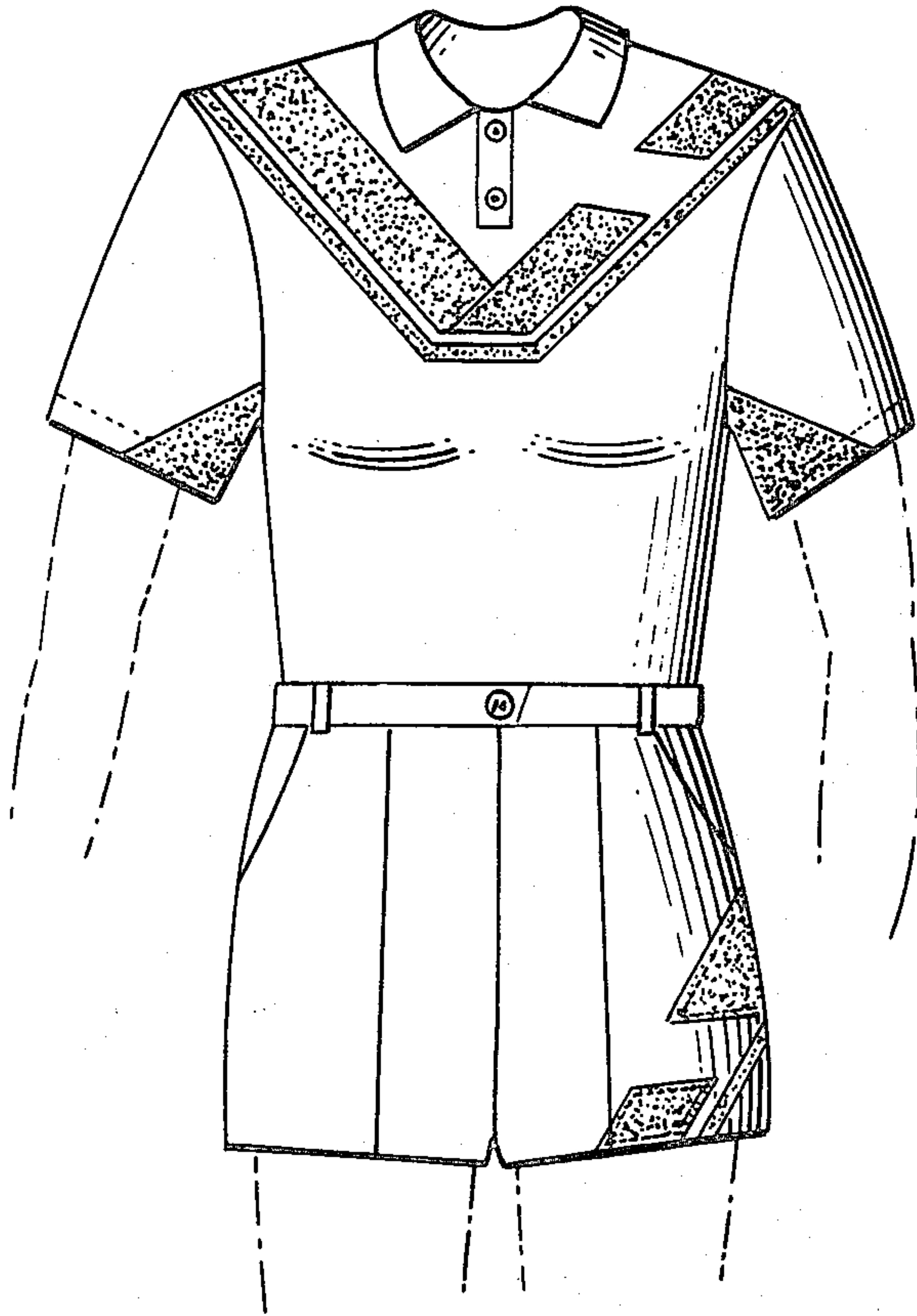

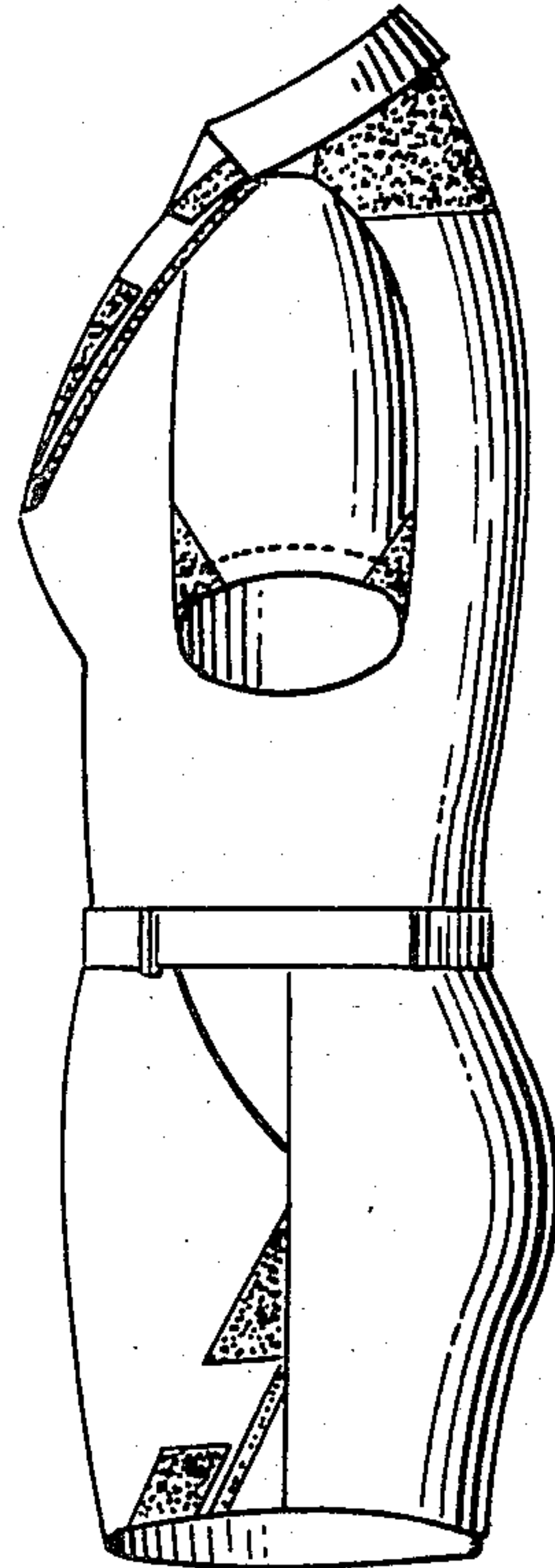

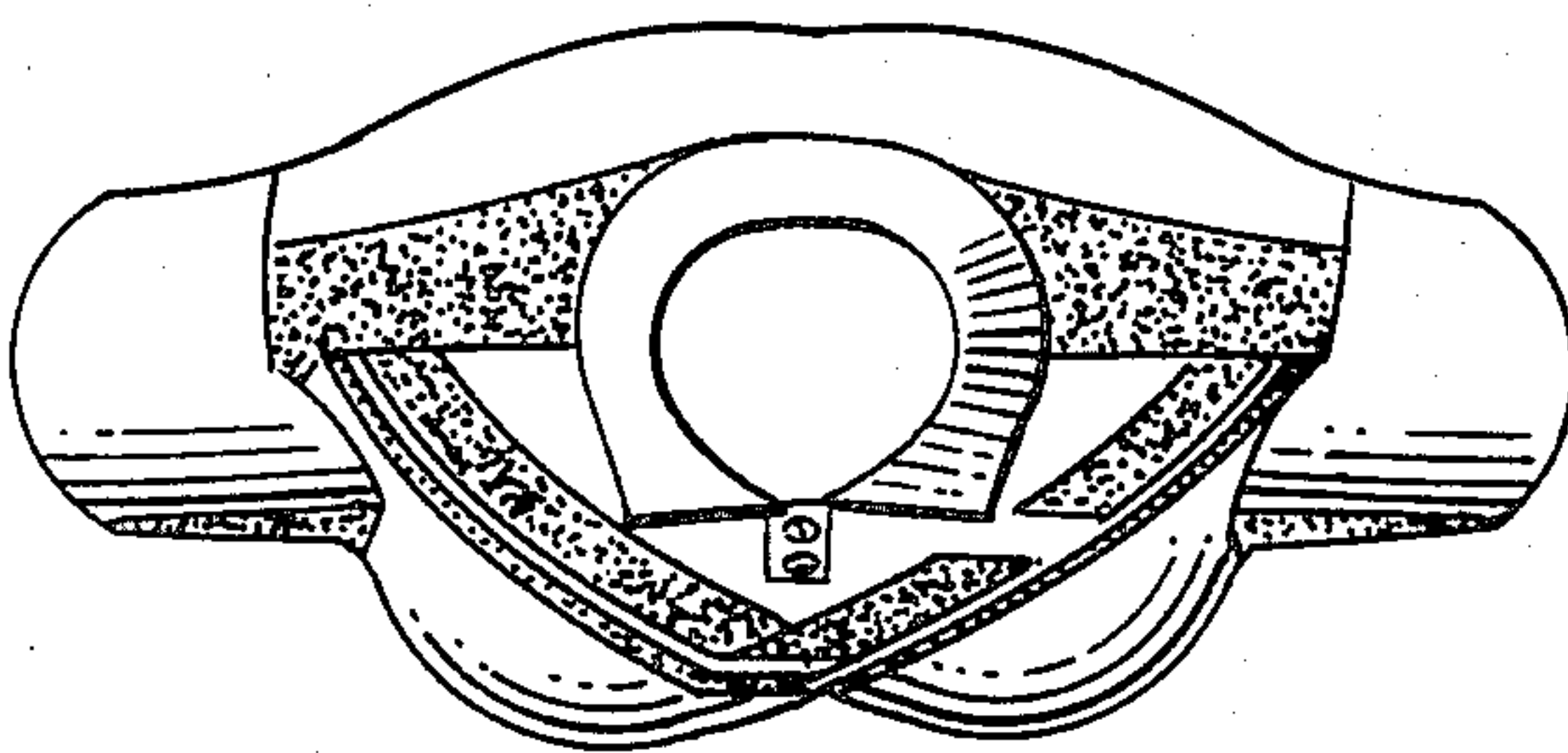

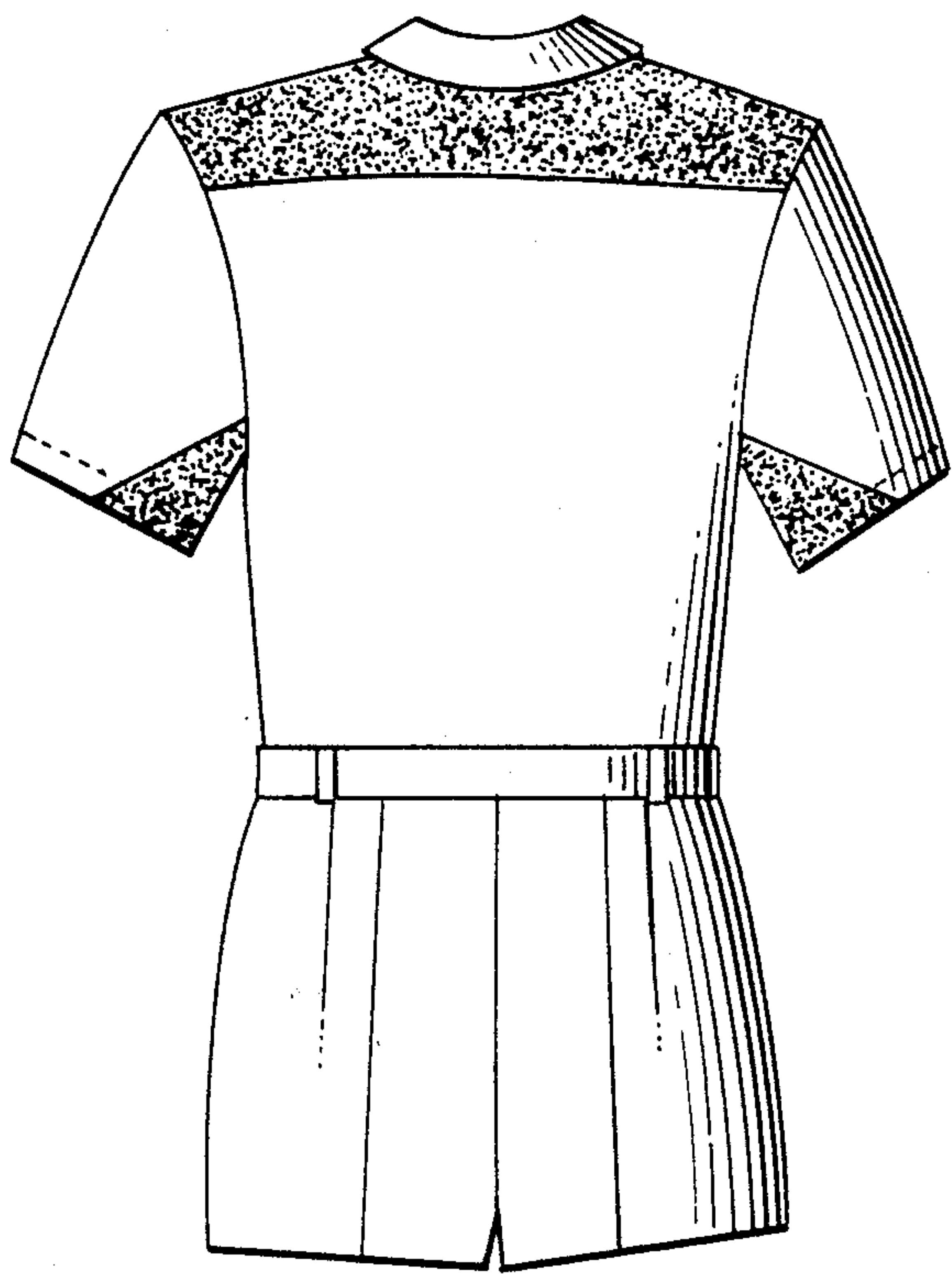

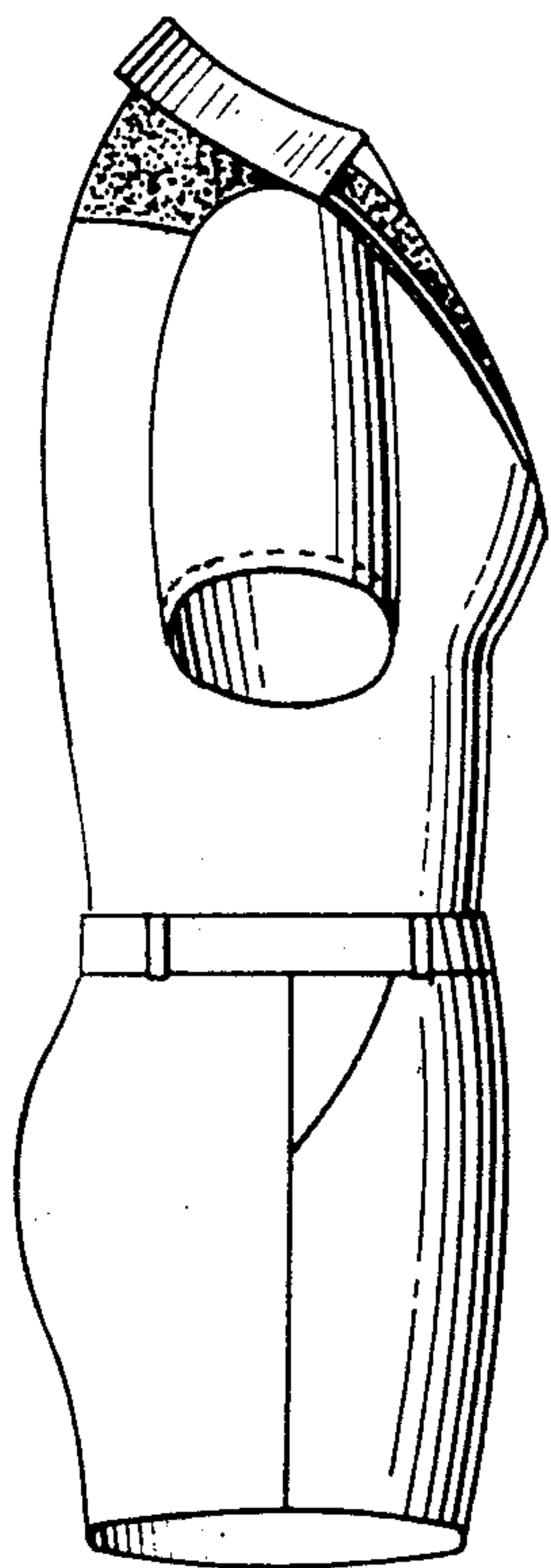

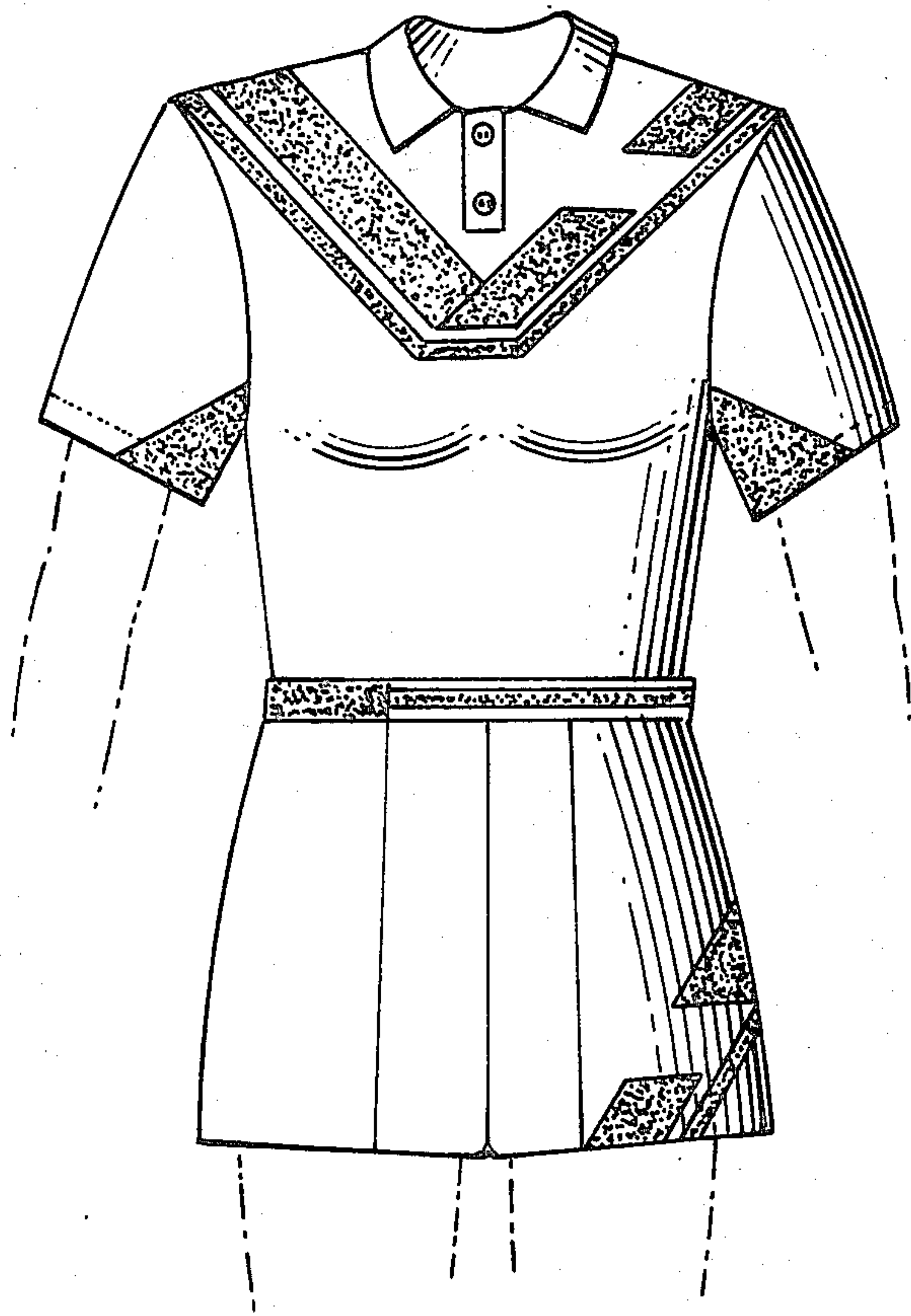

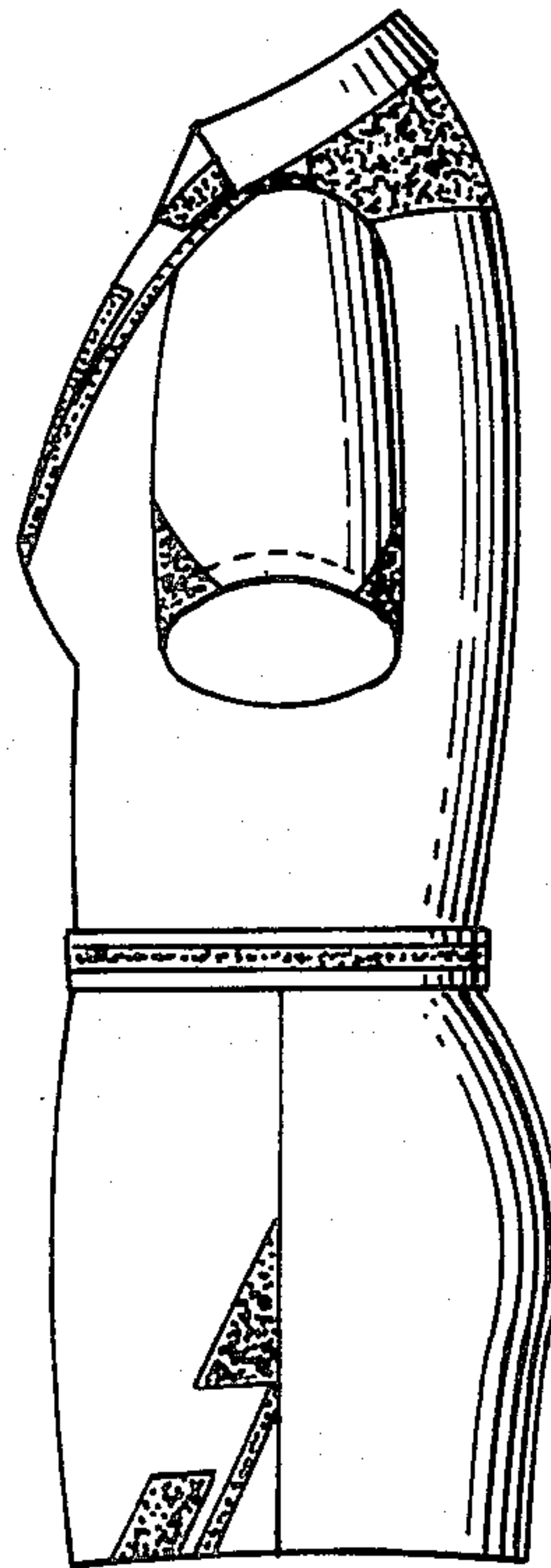

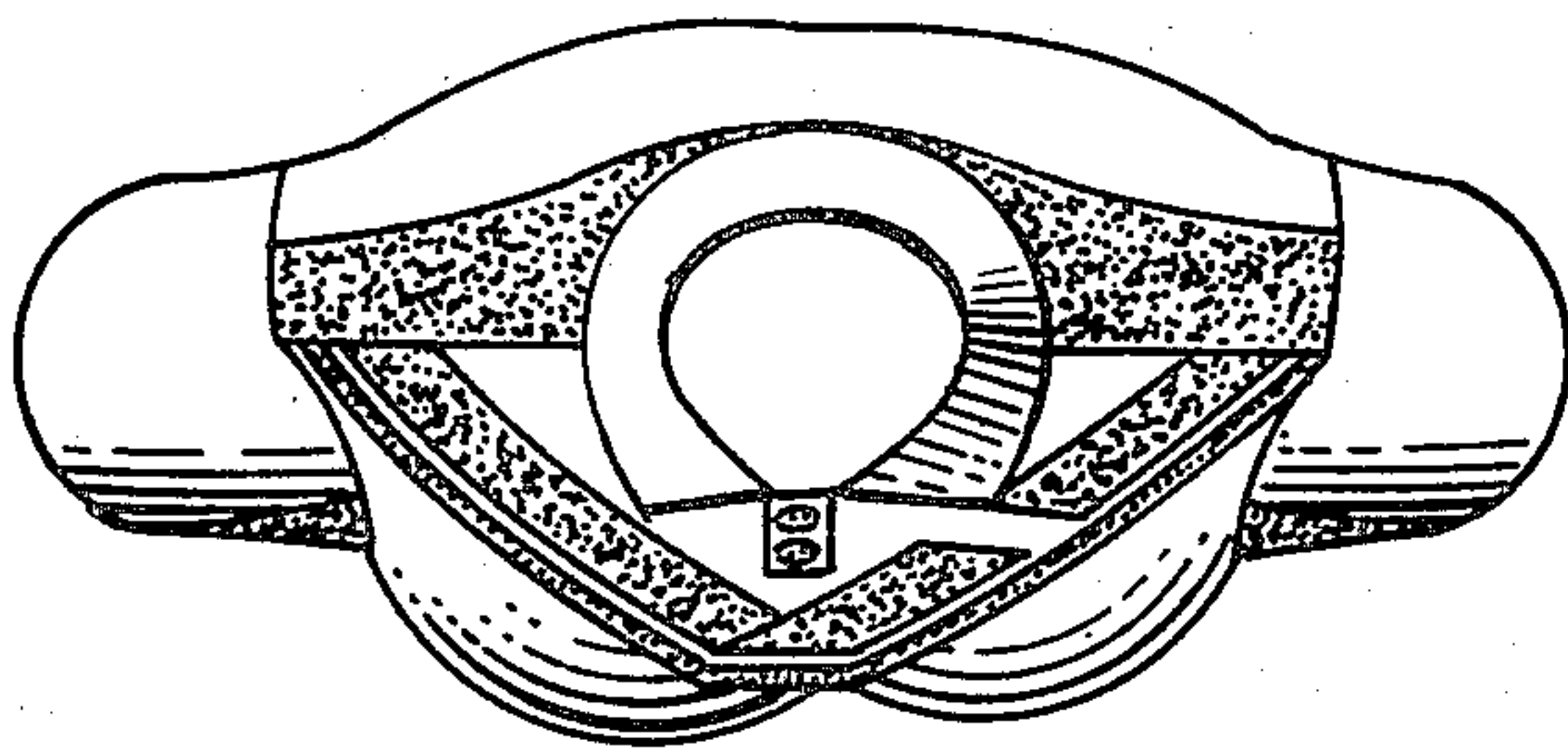

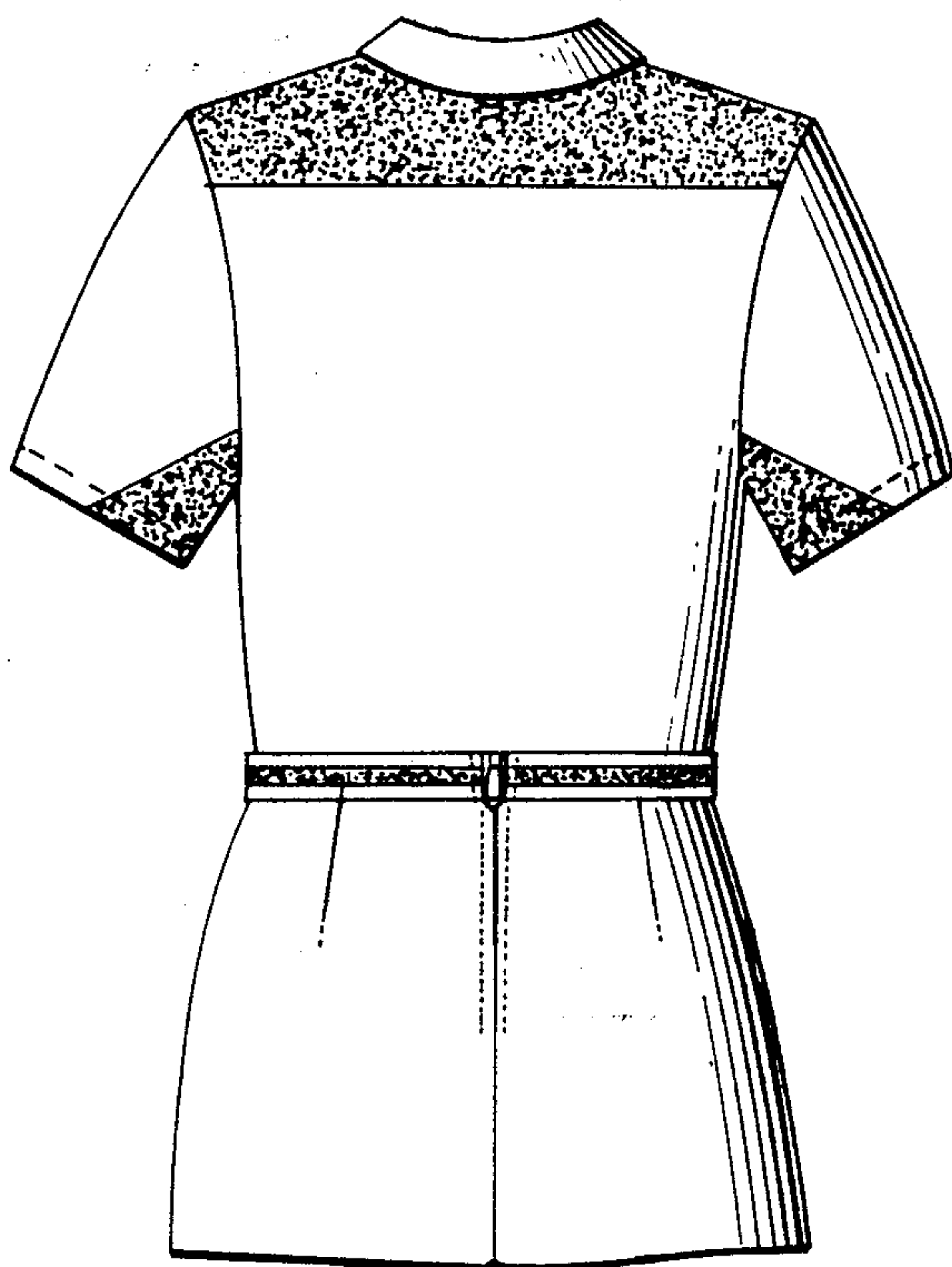
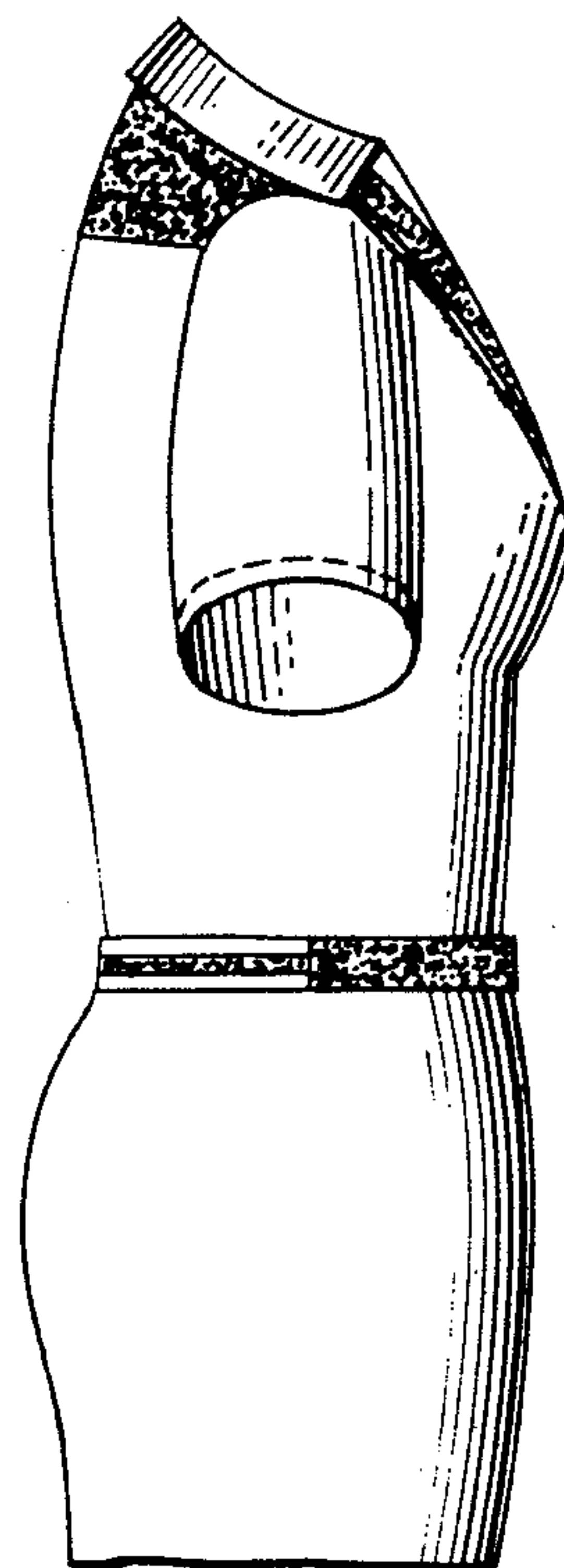
