[57] CLAIM

The ornamental design for a storage cabinet, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a storage cabinet showing our new design;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a top plan view thereof;
 FIG. 4 is a left side elevational view thereof, the right side elevational view thereof being a mirror image;
 FIG. 5 is a rear elevational view thereof;
 FIG. 6 is a perspective view similar to FIG. 1 but showing a cover panel slid to an open position;
 FIG. 7 is a perspective view of an alternate embodiment of the storage cabinet showing our new design;
 FIG. 8 is a front elevational view thereof;
 FIG. 9 is a top plan view thereof;
 FIG. 10 is a left side elevational view thereof, the right side elevational view thereof being a mirror image;
 FIG. 11 is a rear elevational view thereof; and
 FIG. 12 is a perspective view similar to FIG. 7 but showing a cover panel slid to an open position.

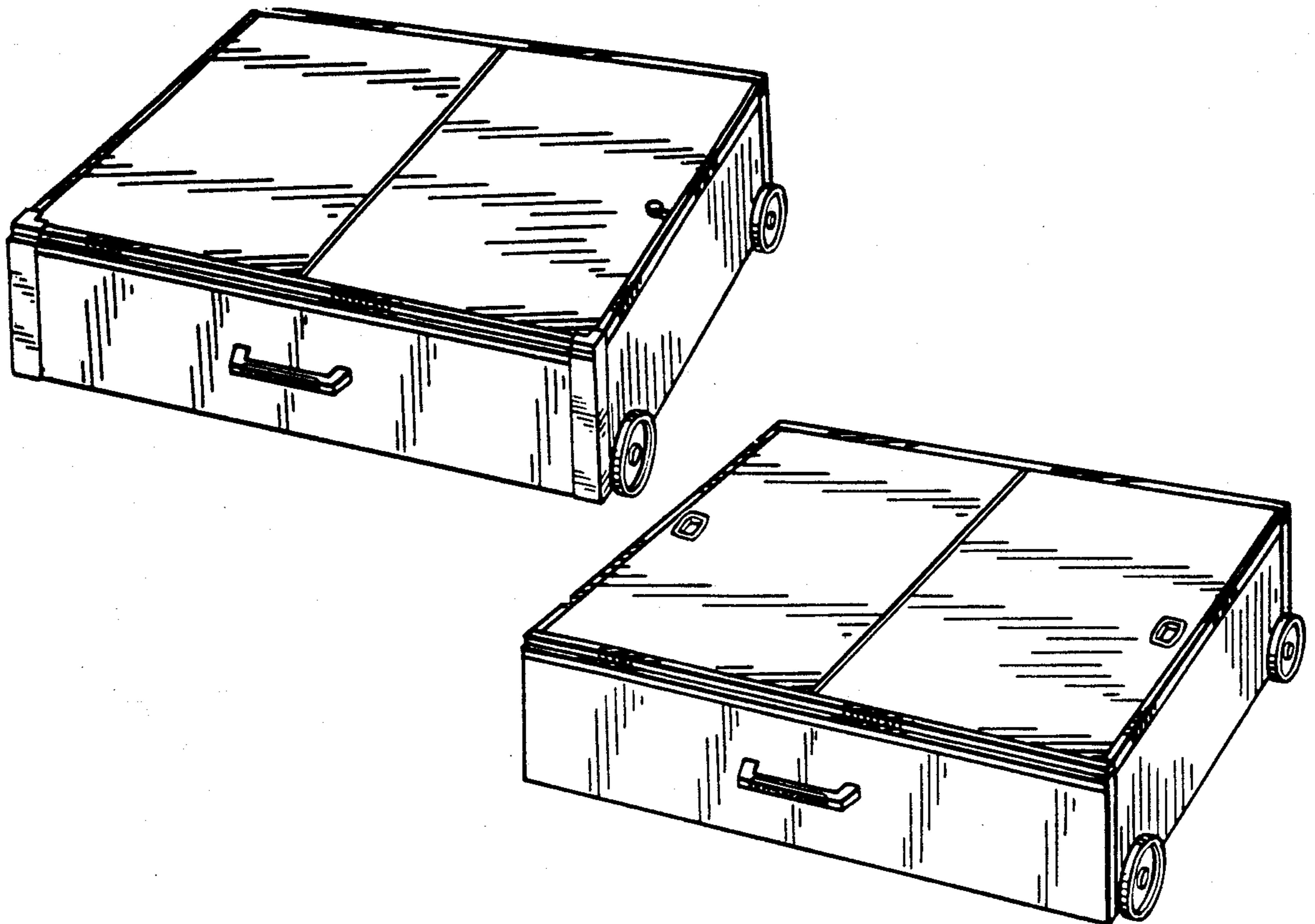

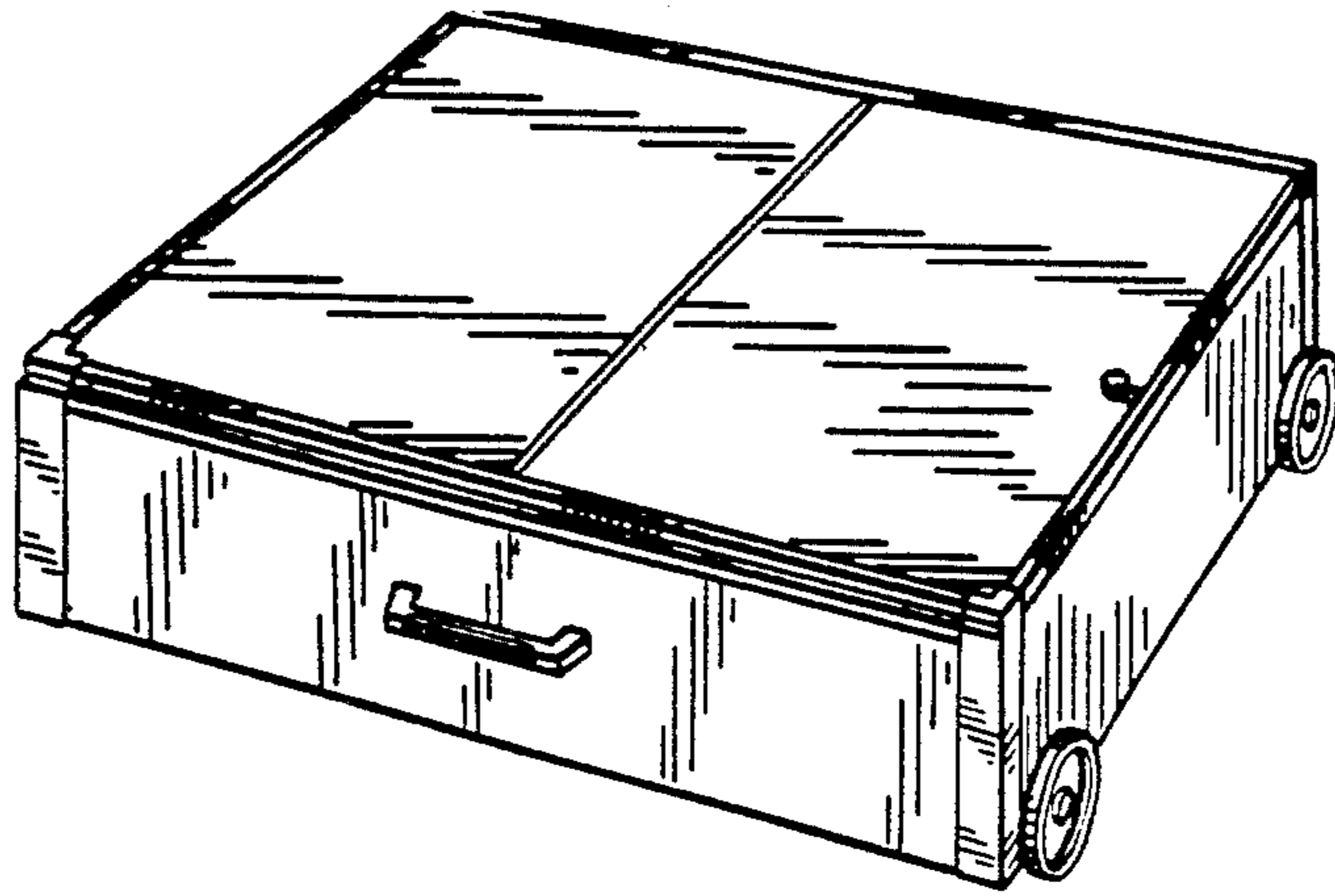

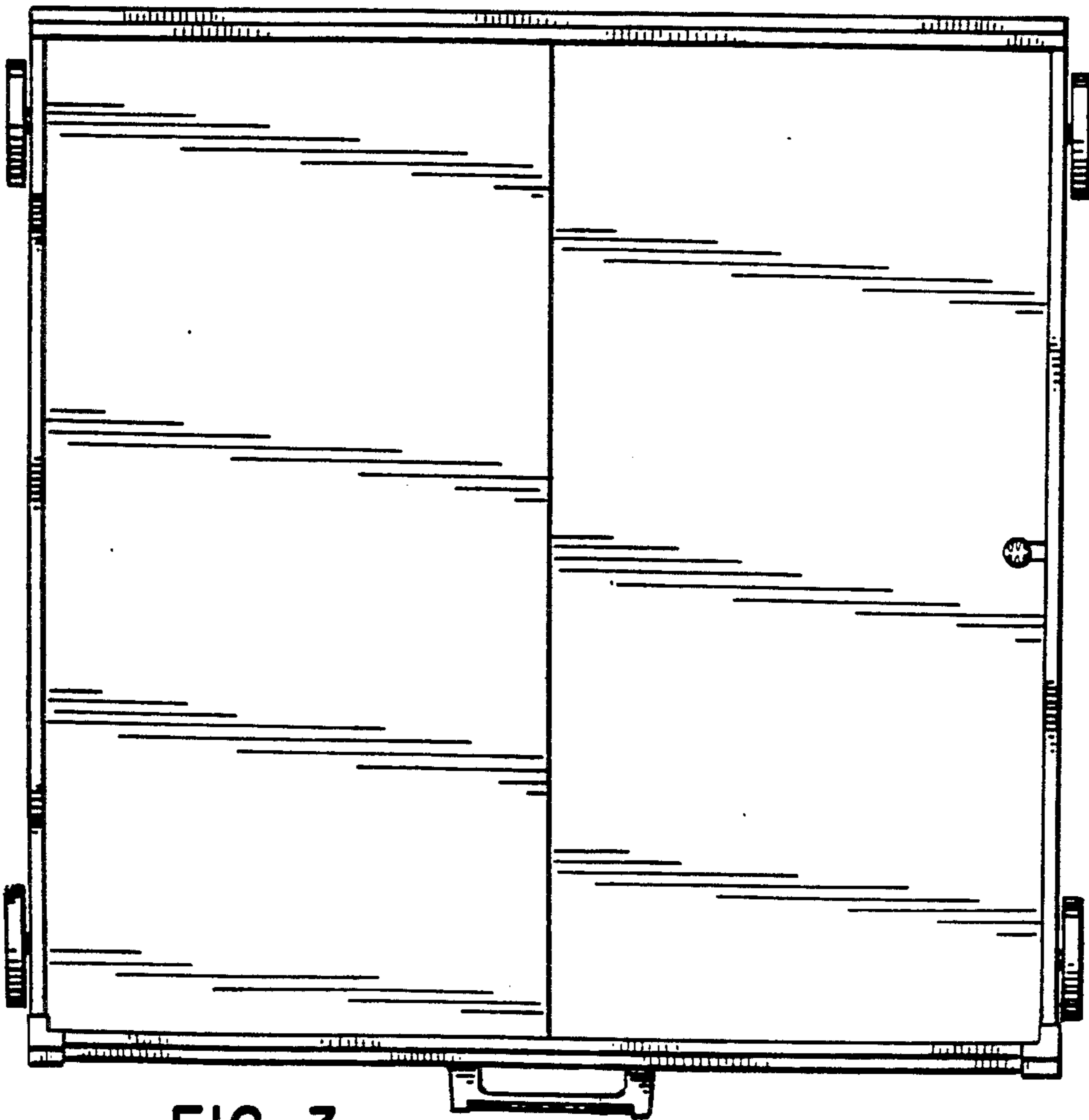
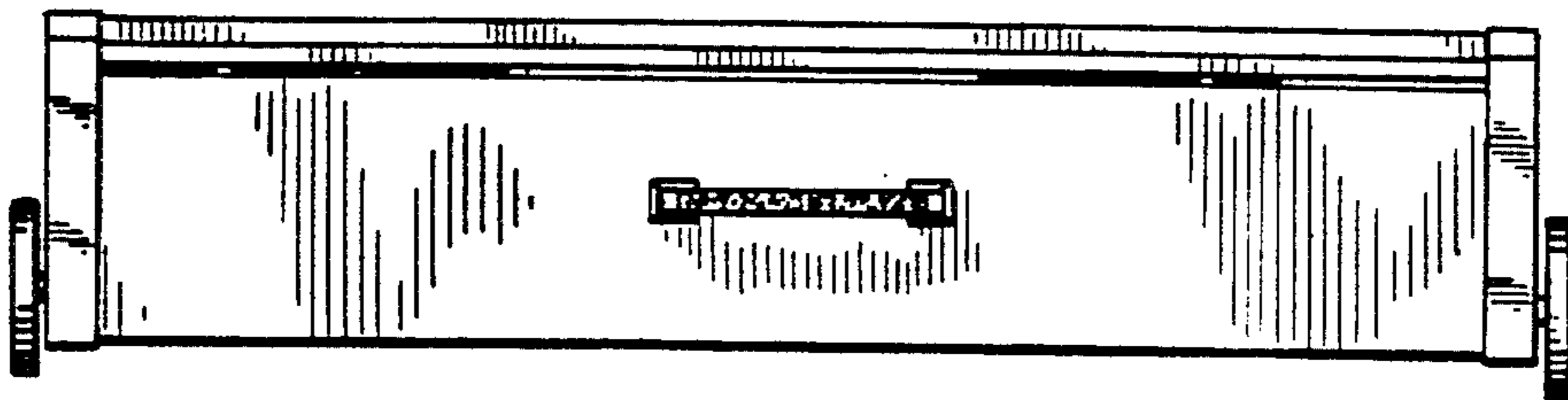

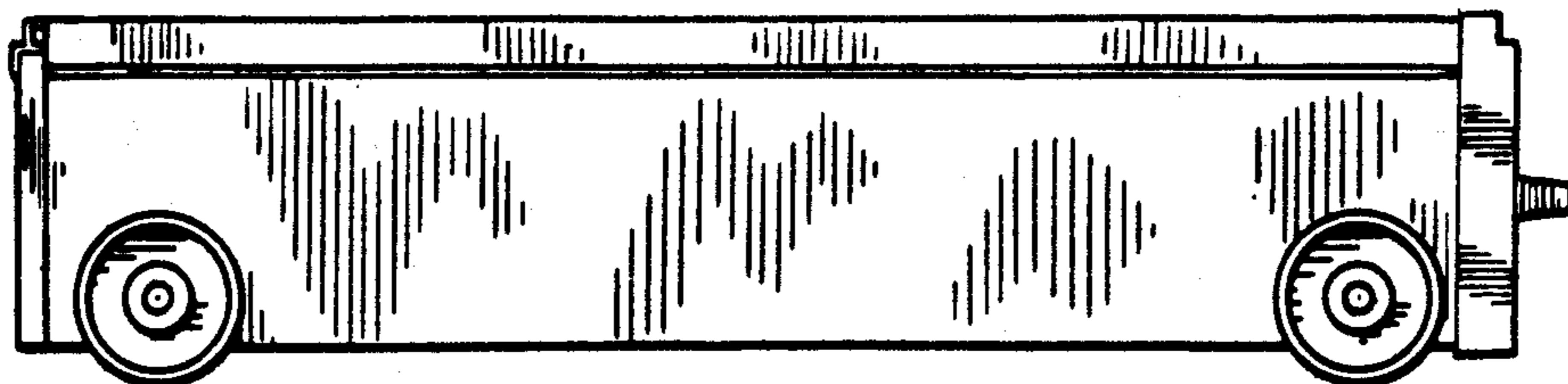

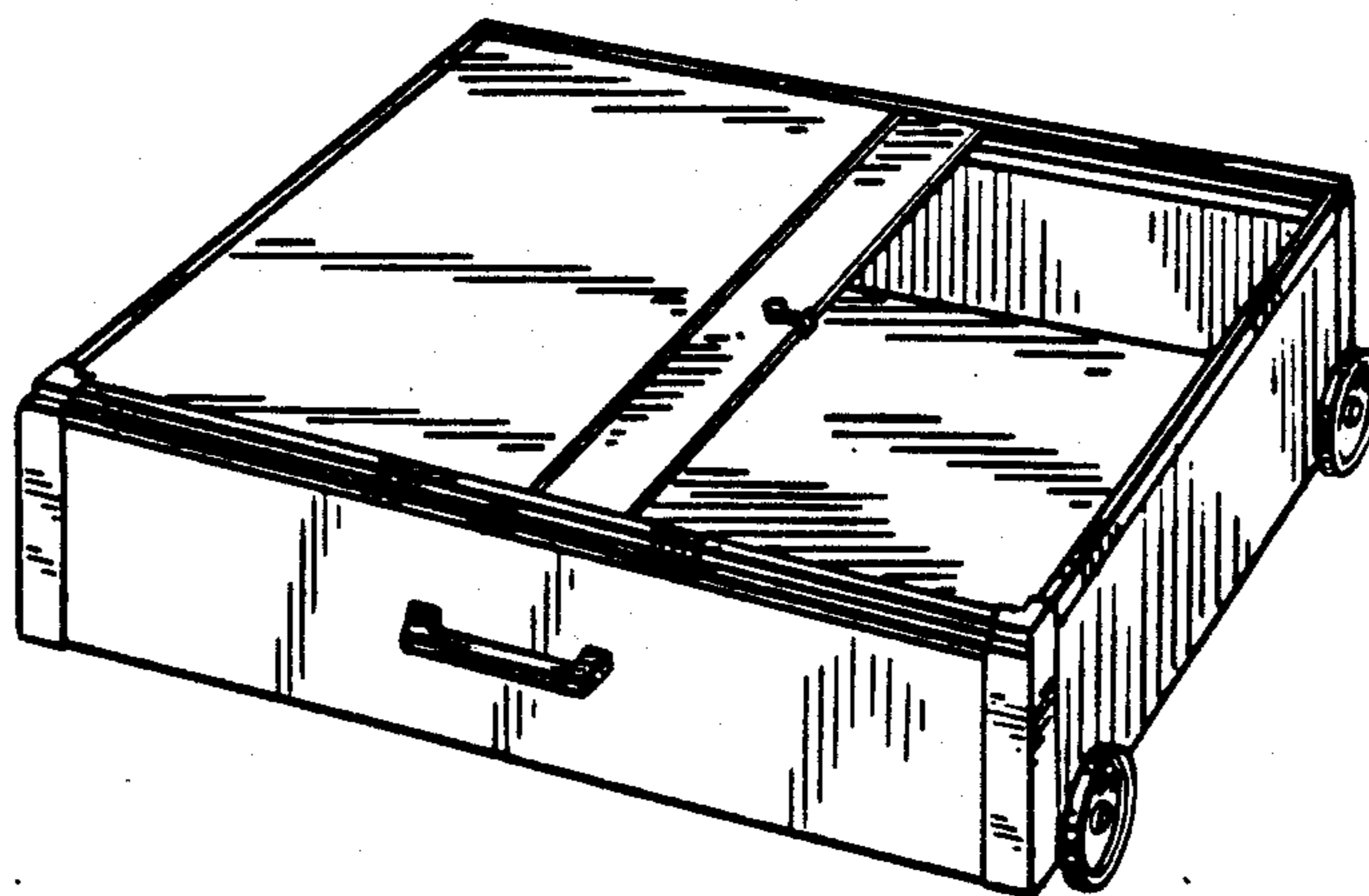
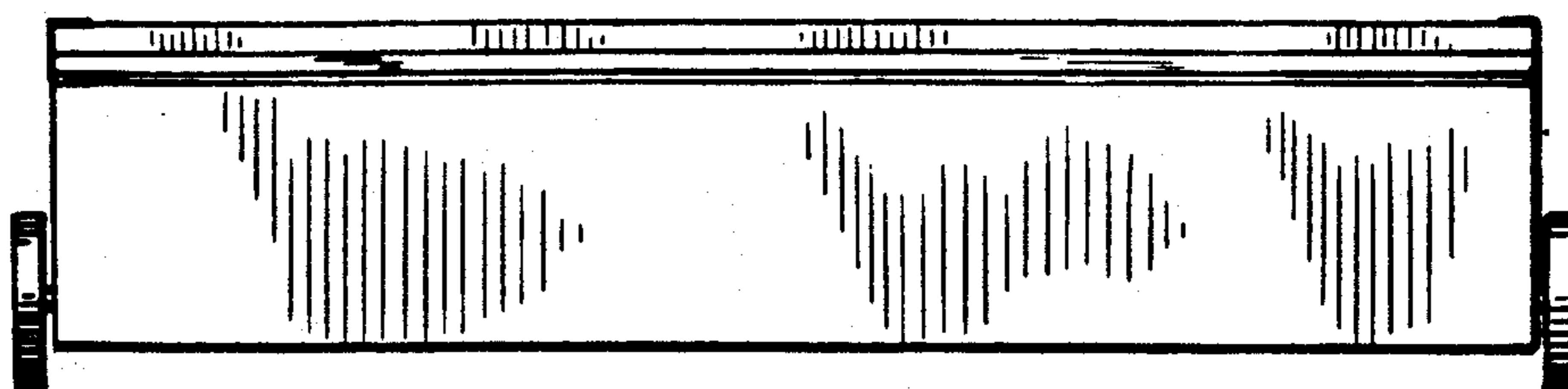

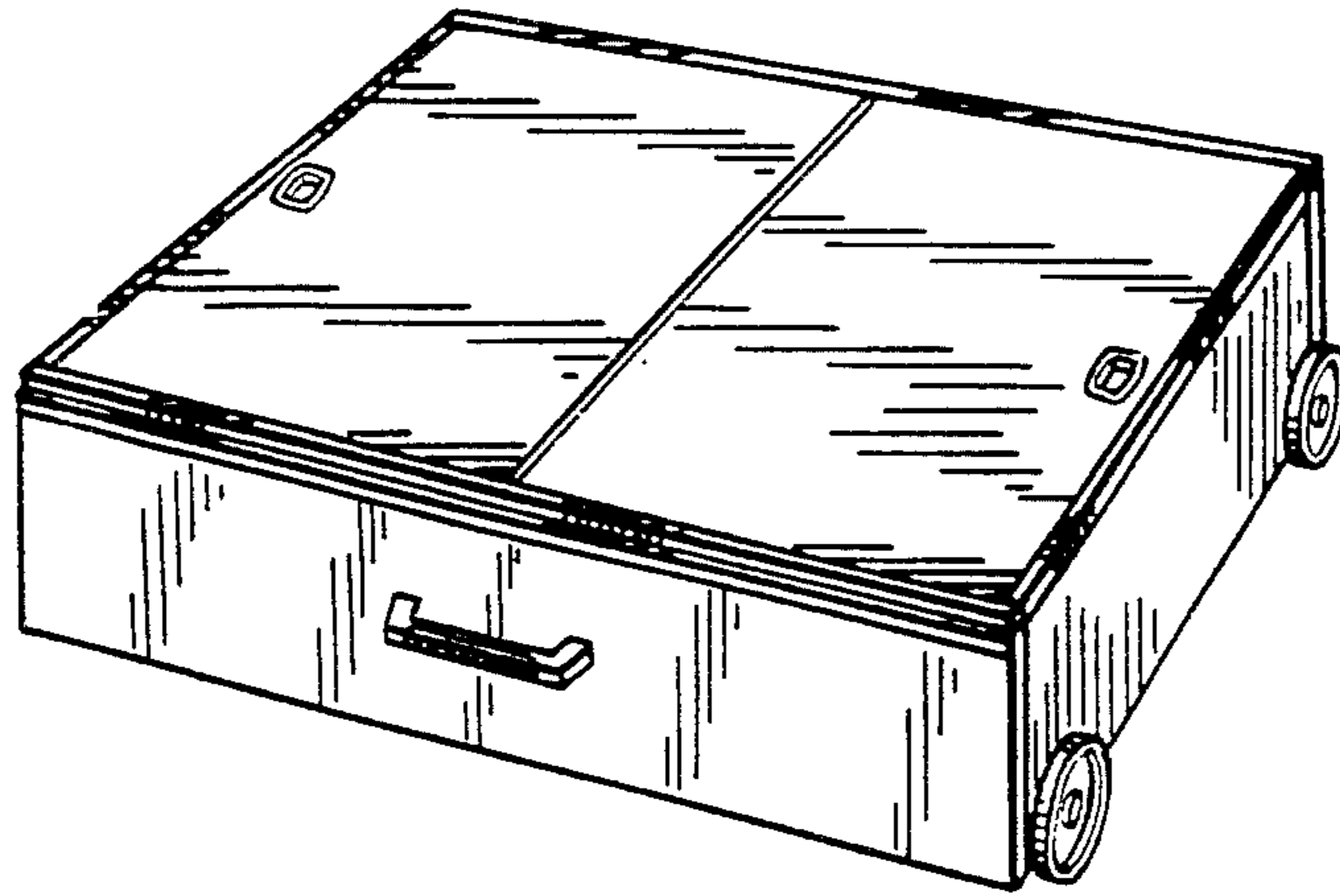

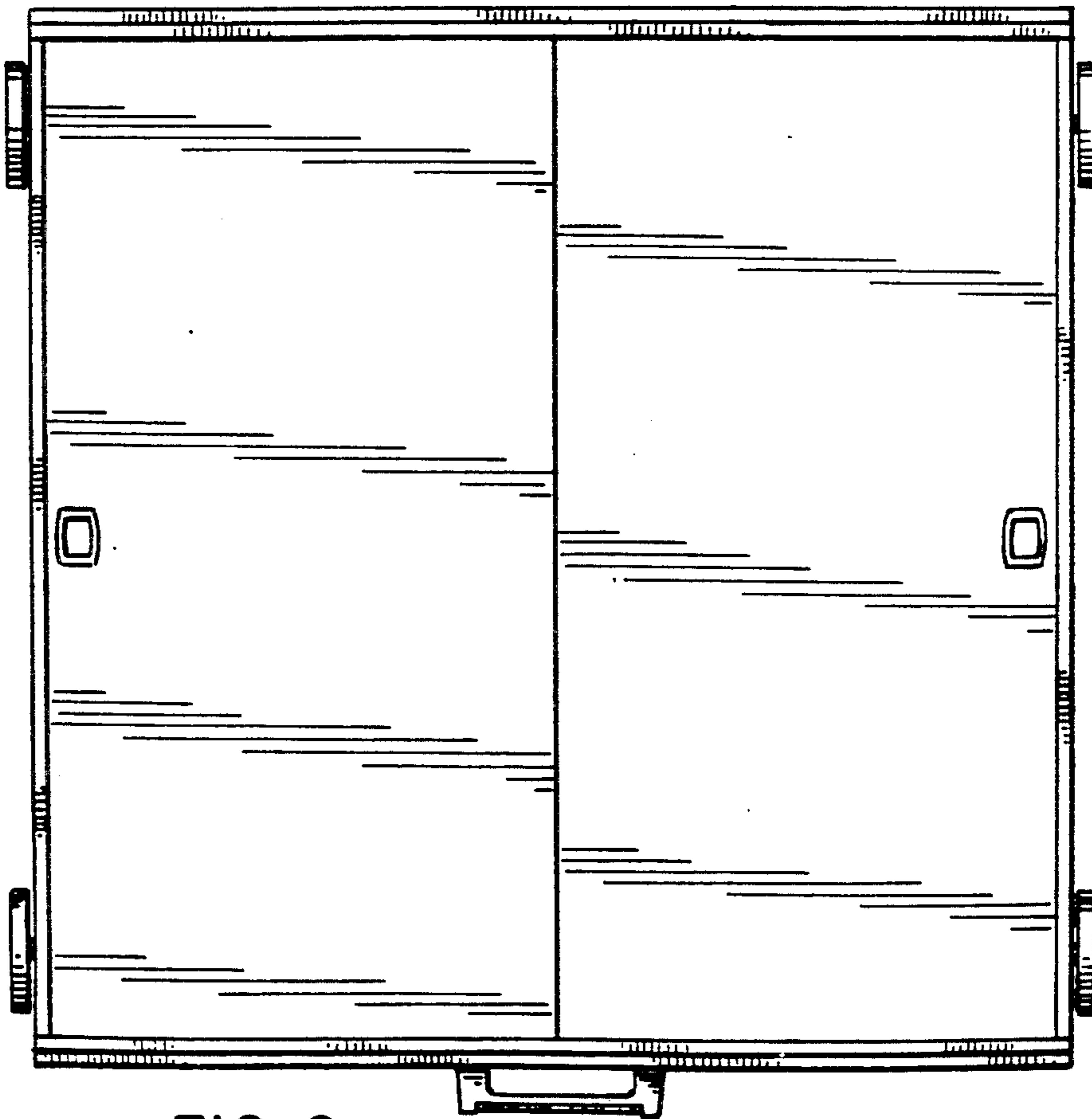
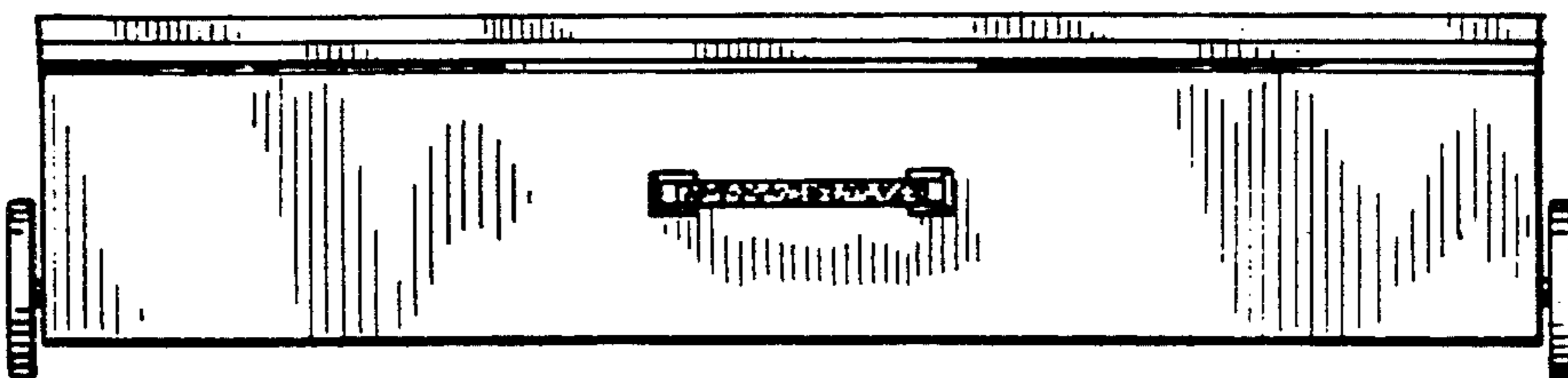

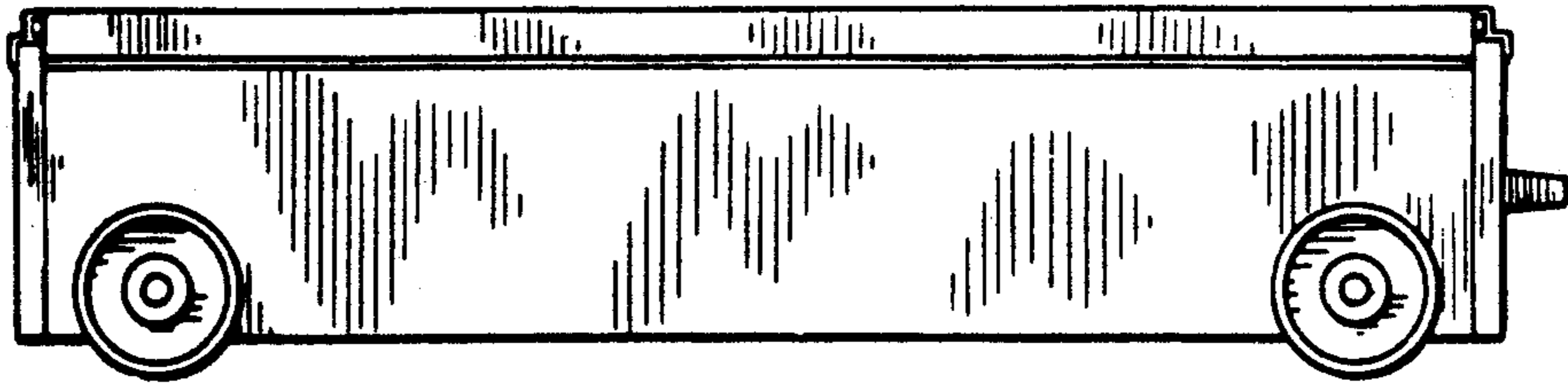

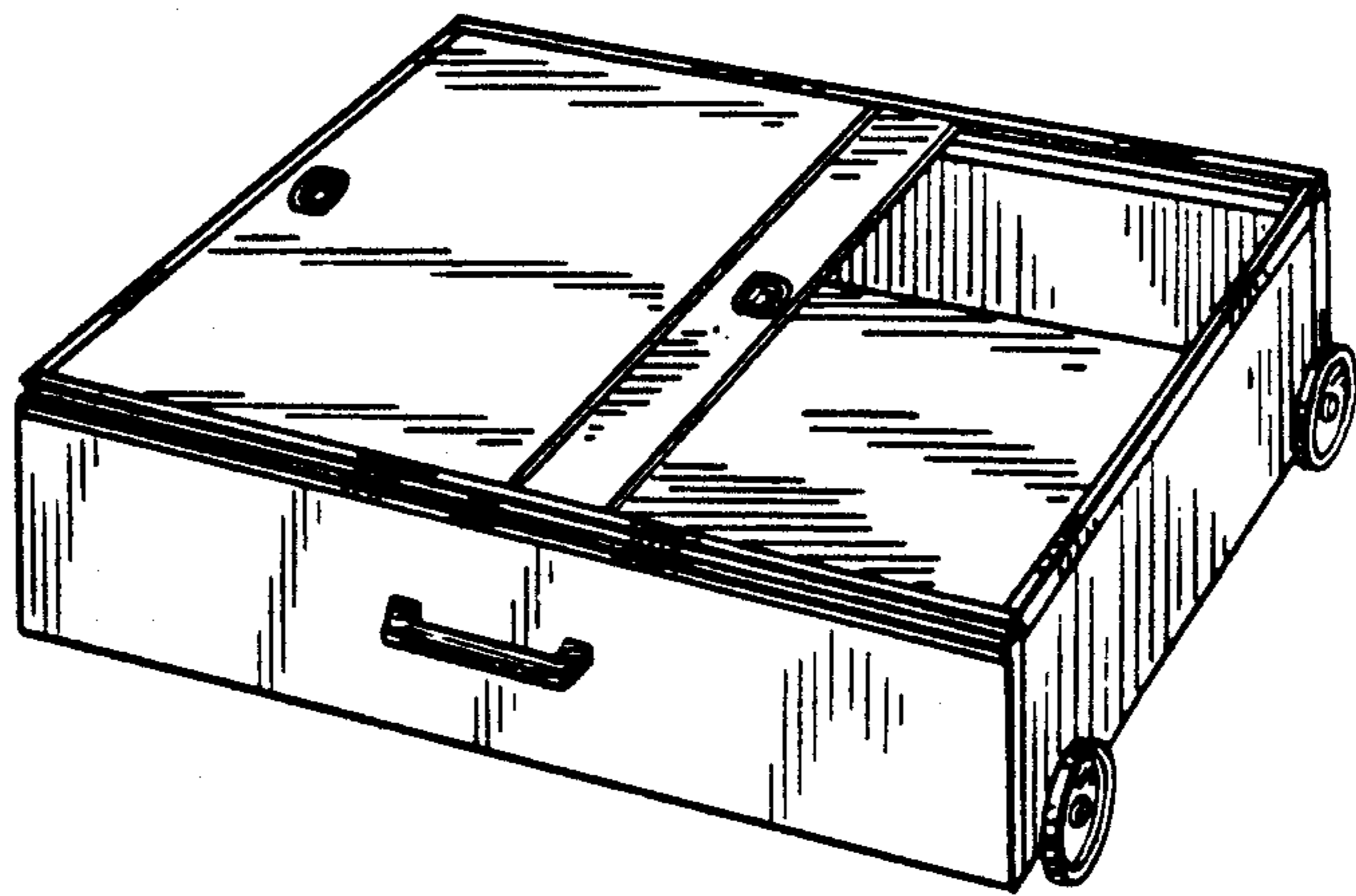
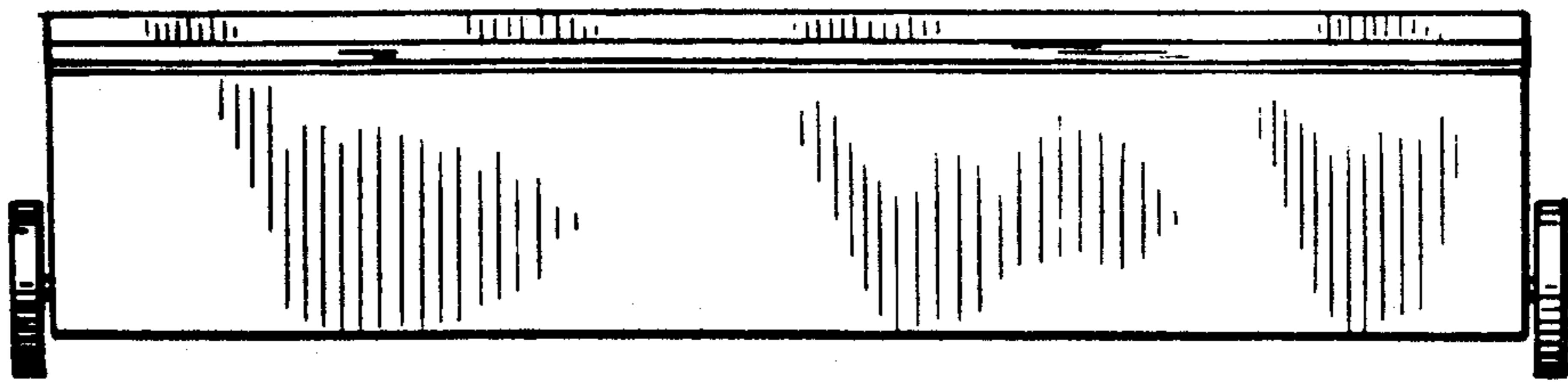
