## DESCRIPTION

FIG. 24 is a left side elevational view thereof;

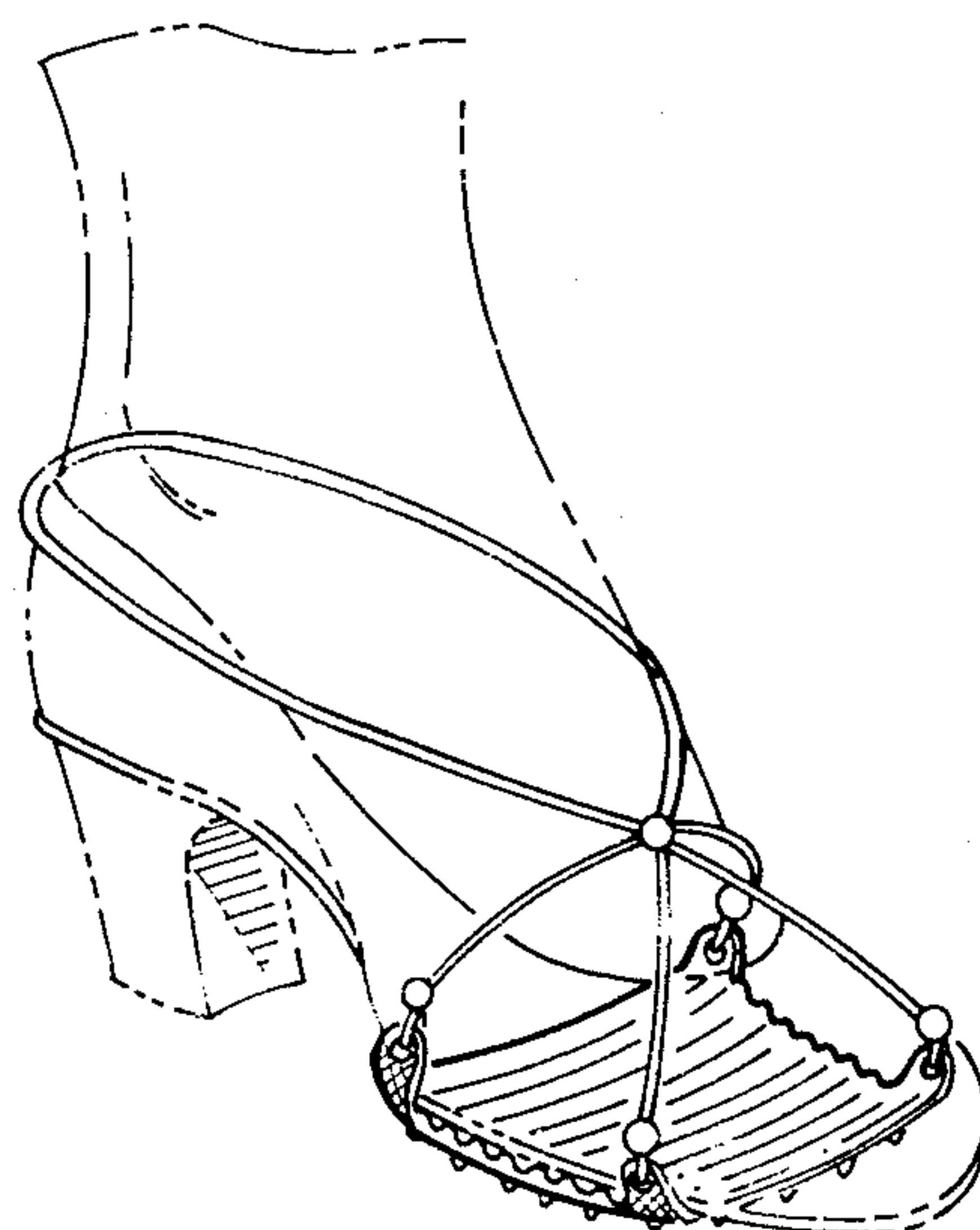
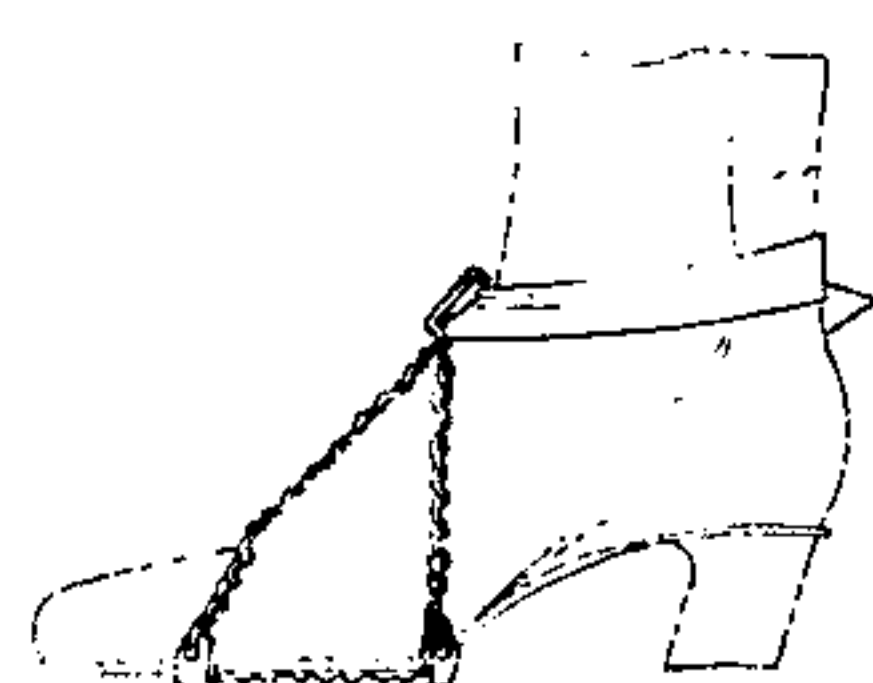
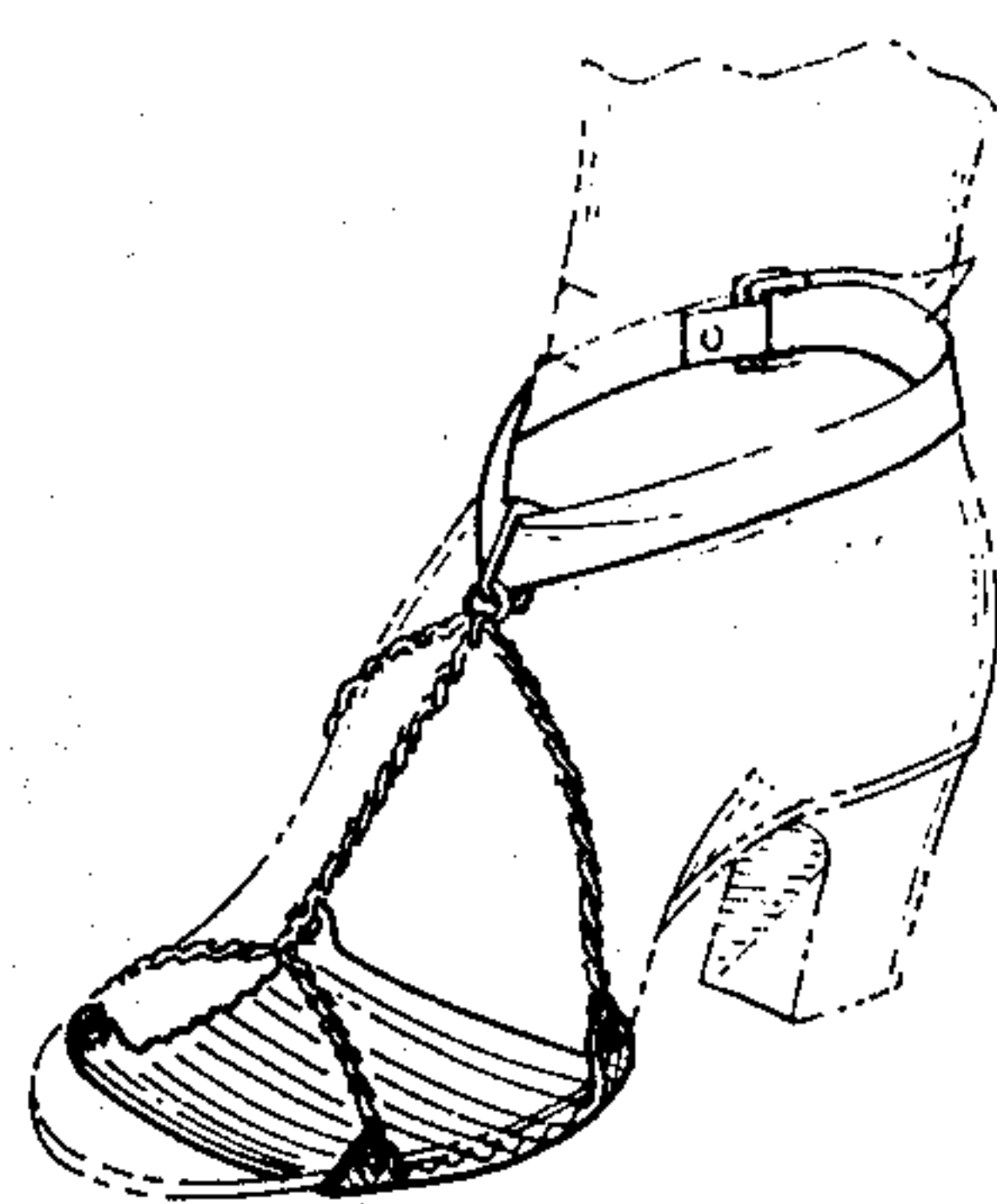
FIG. 25 is a front elevational view thereof;

The broken line showing of the foot and shoe of a wearer is for illustrative purposes only and forms no part of the claimed design.



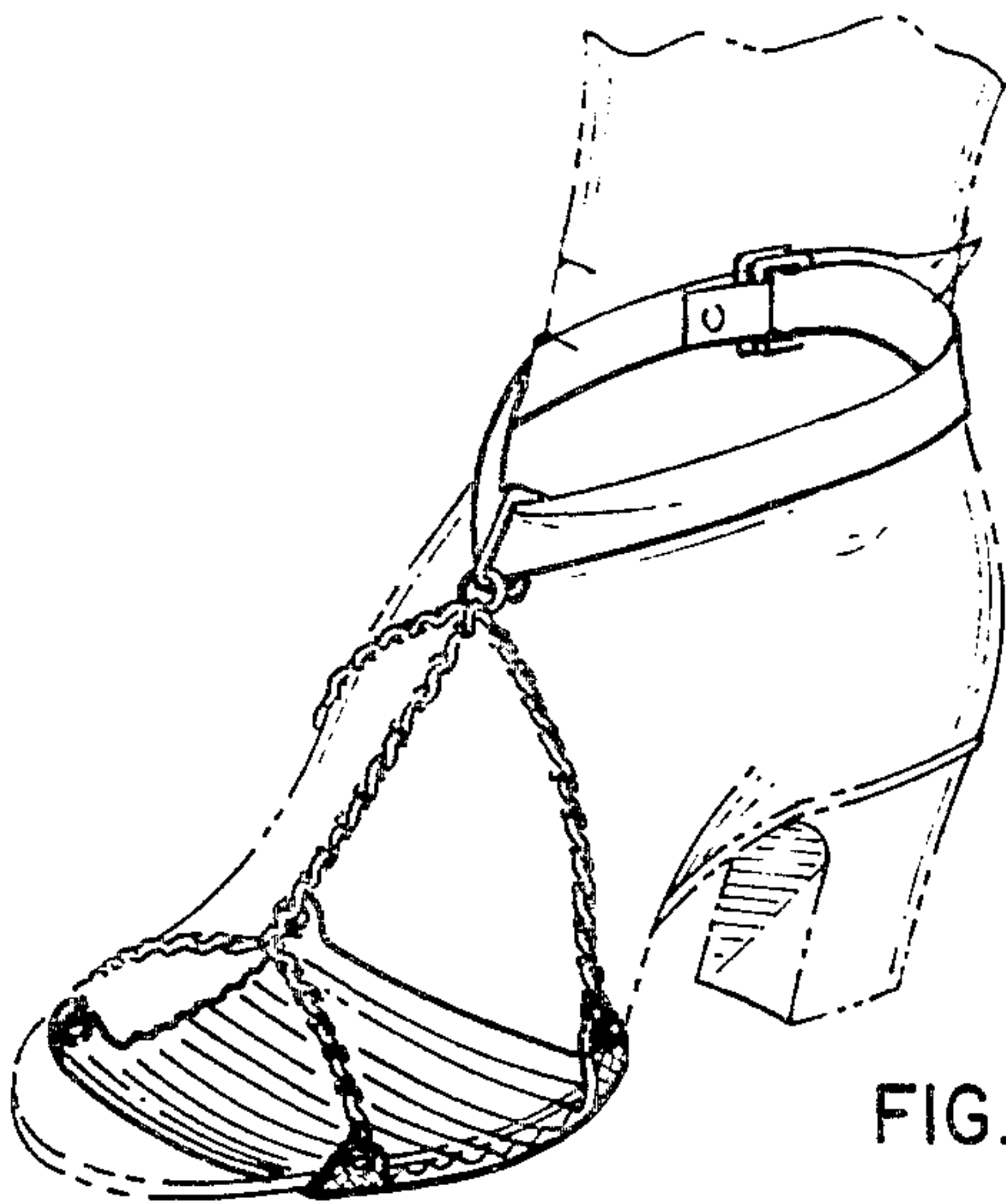

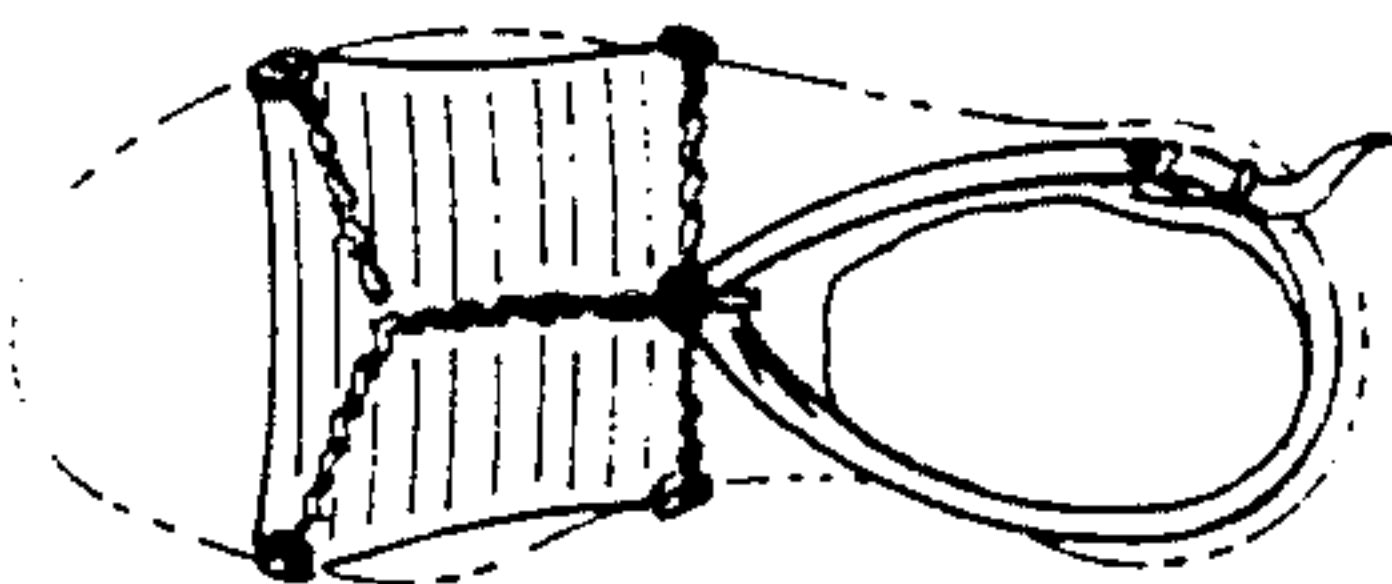

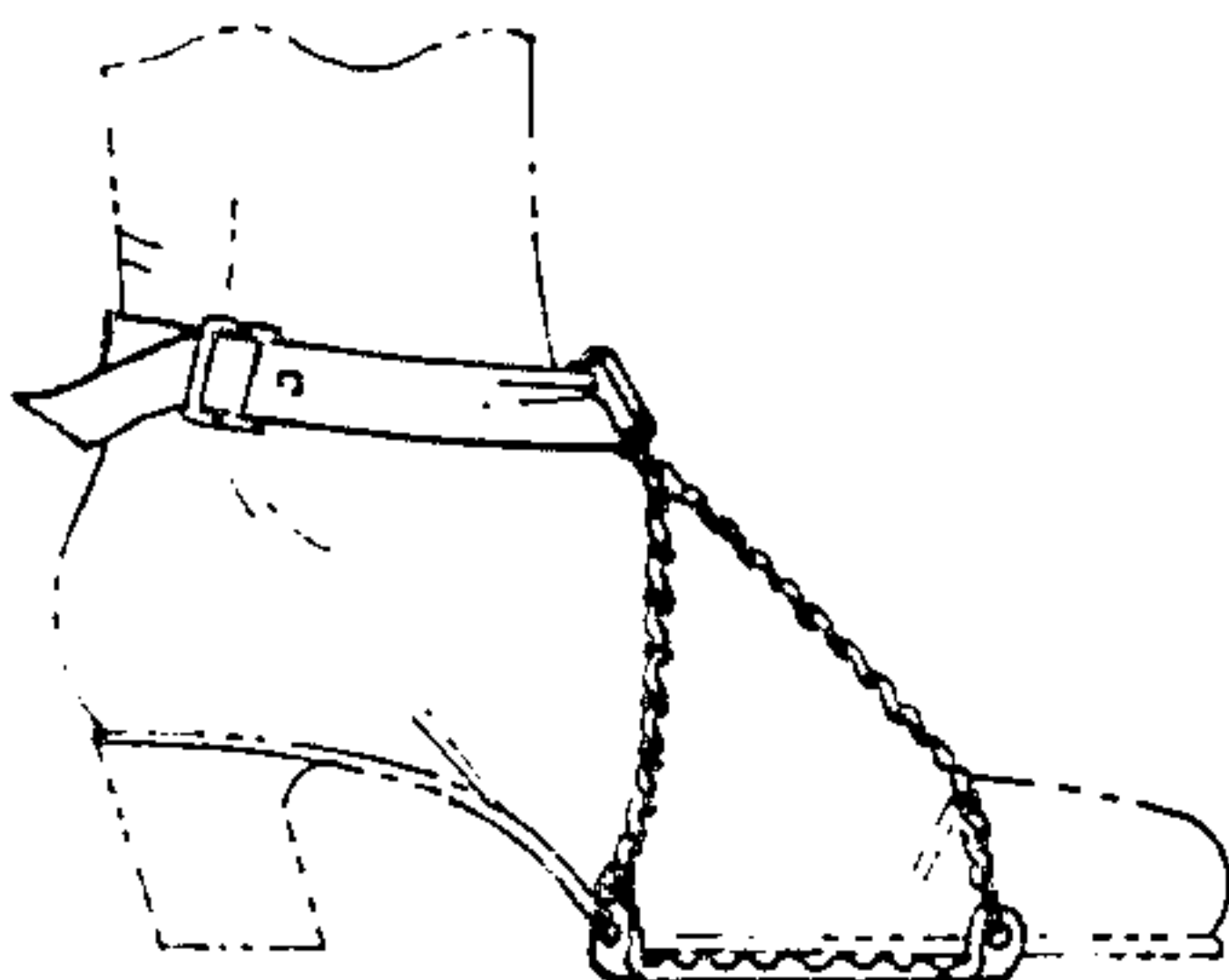

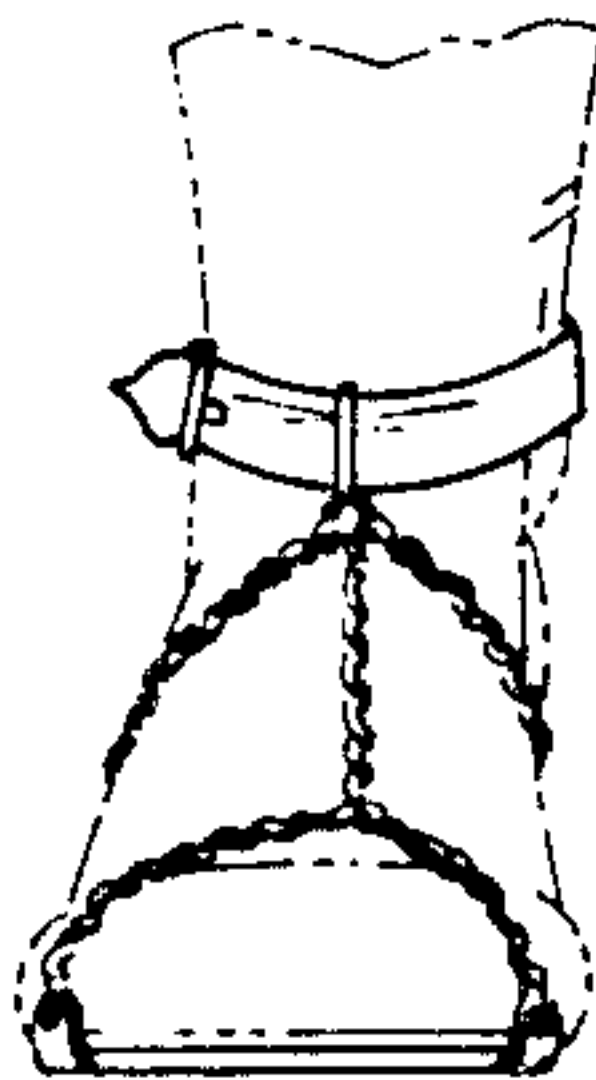

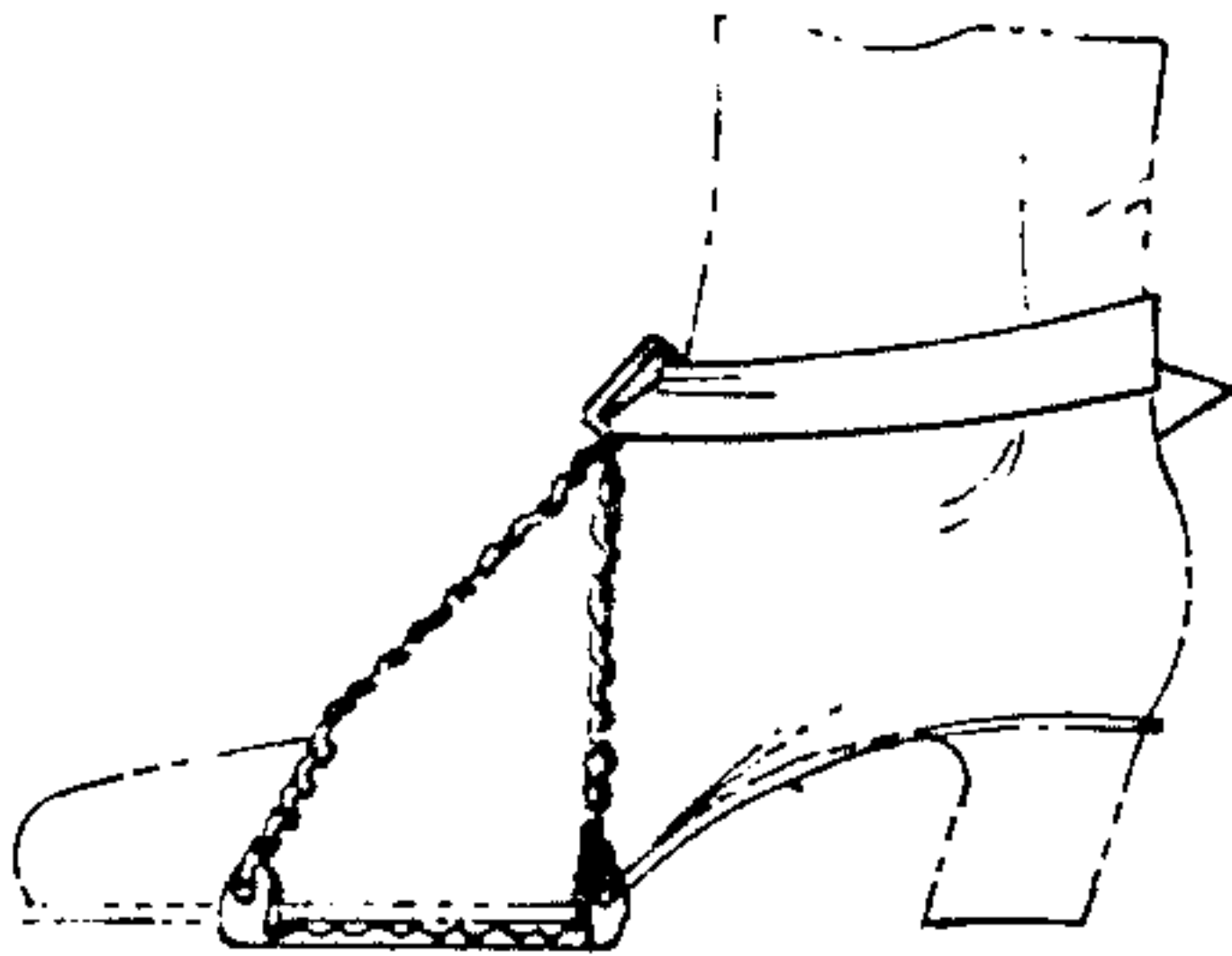

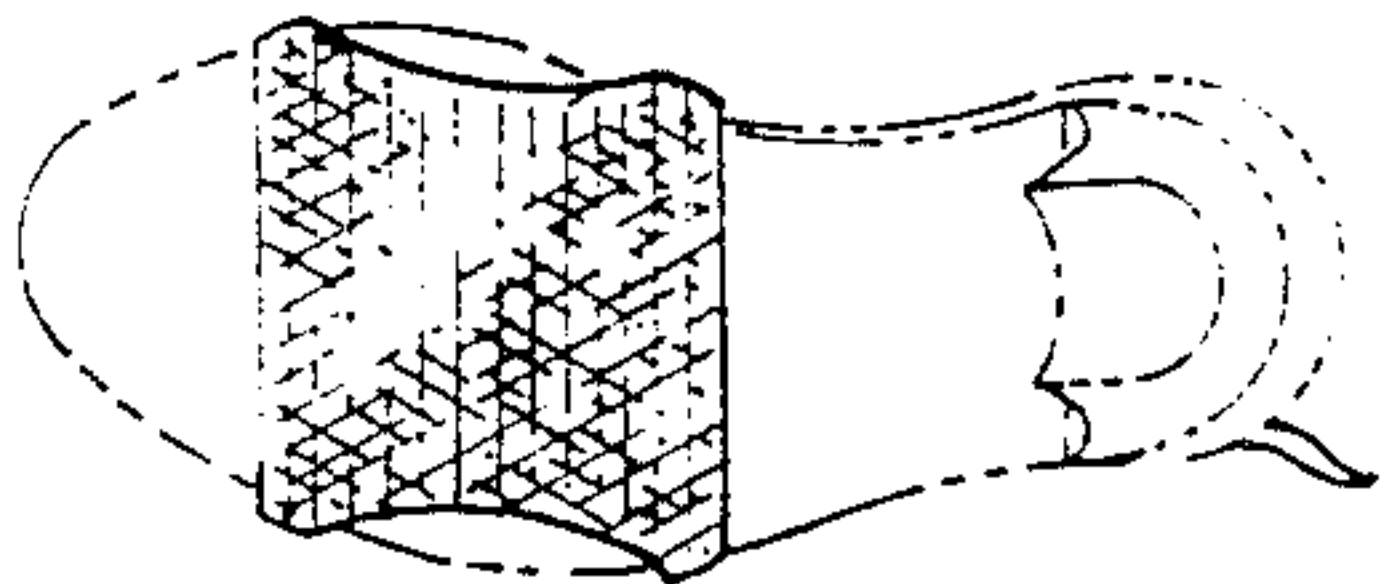

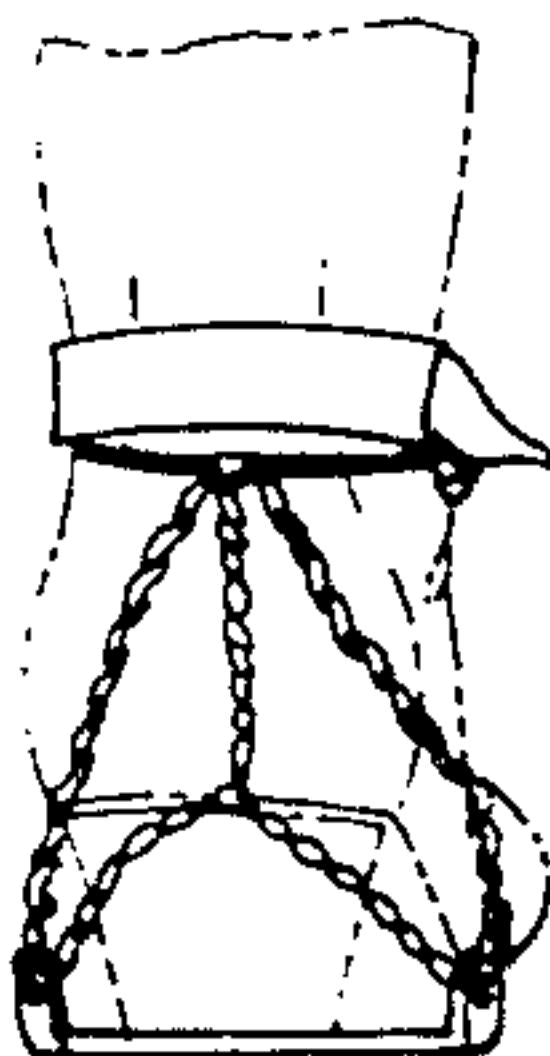

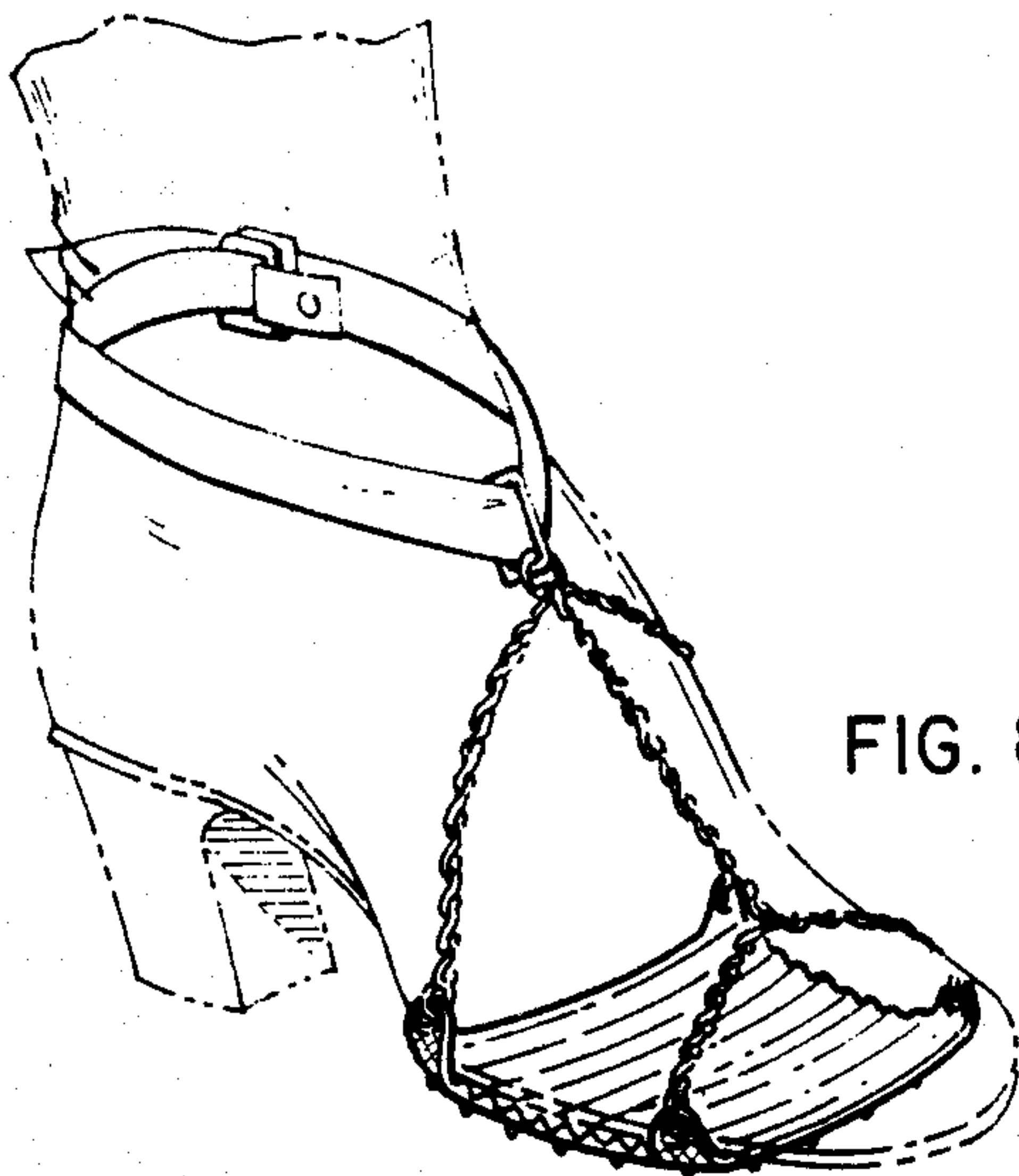

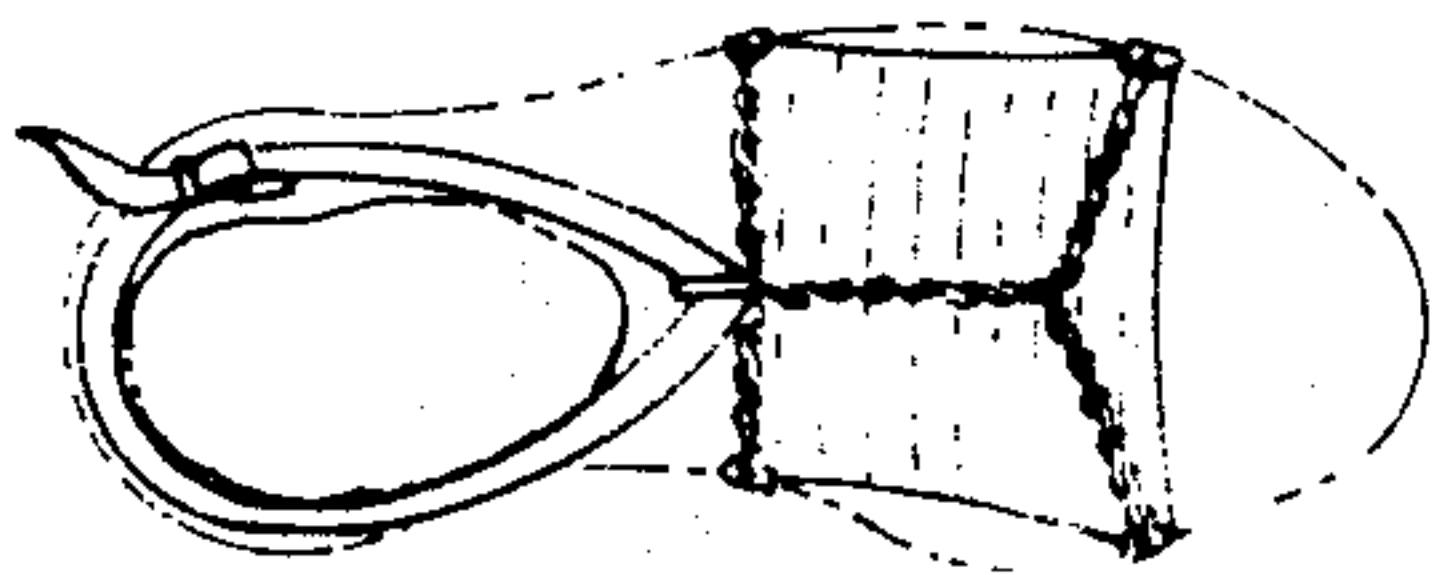

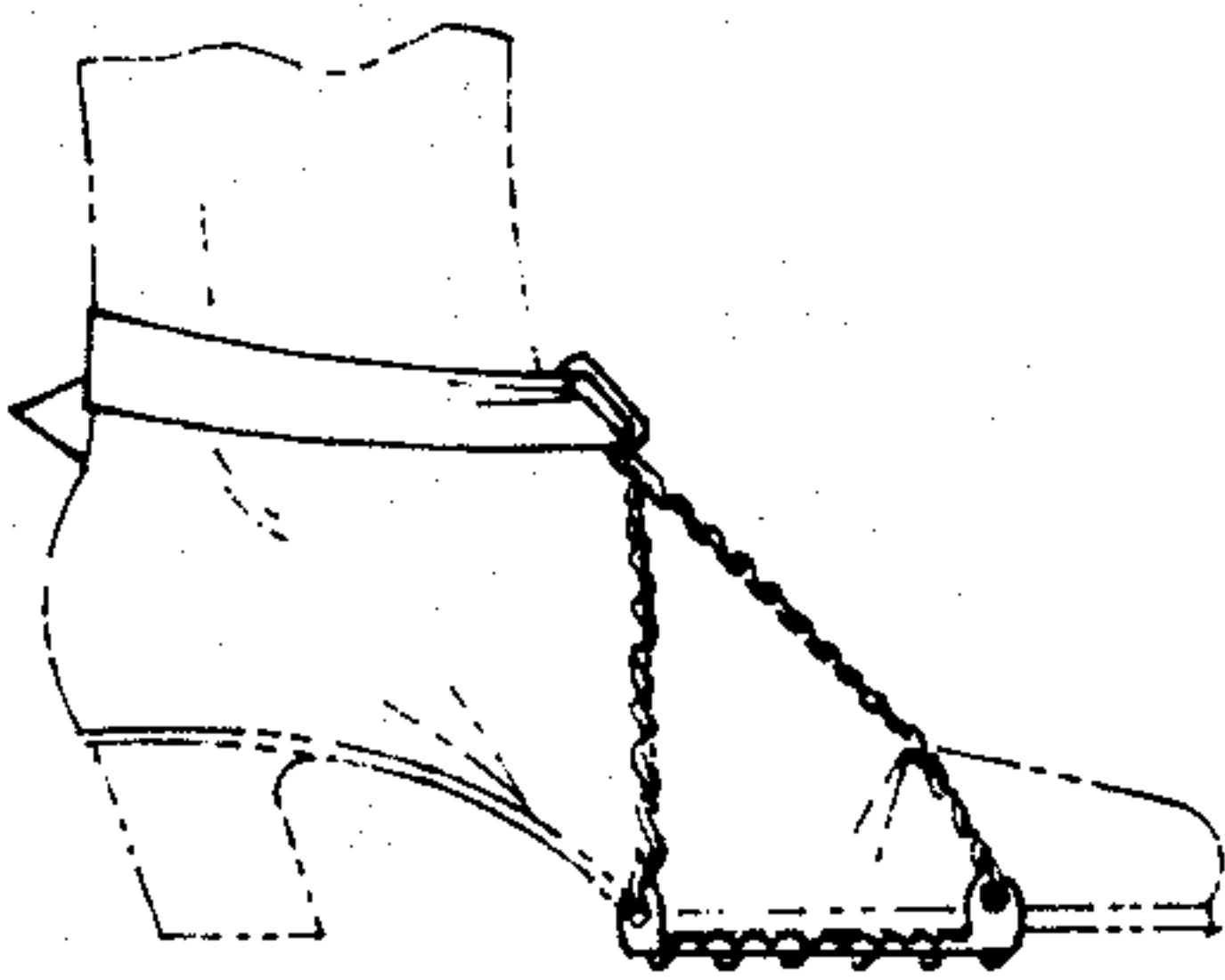

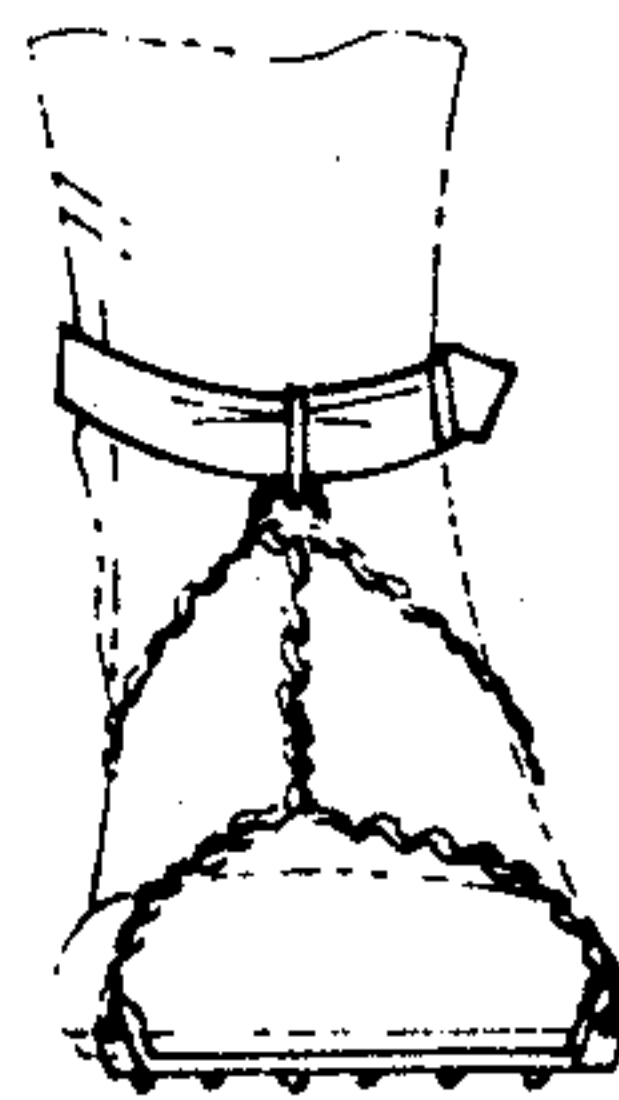

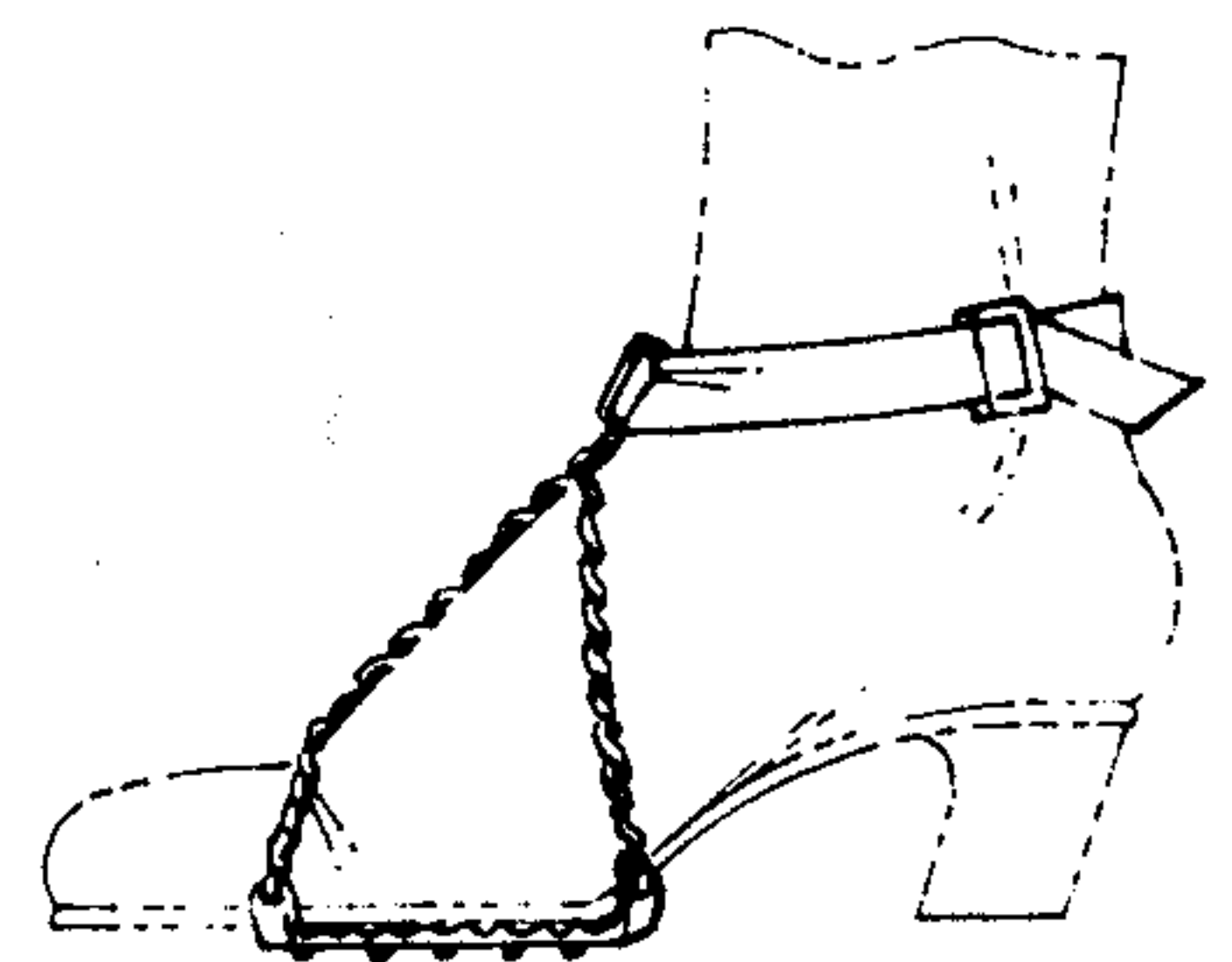

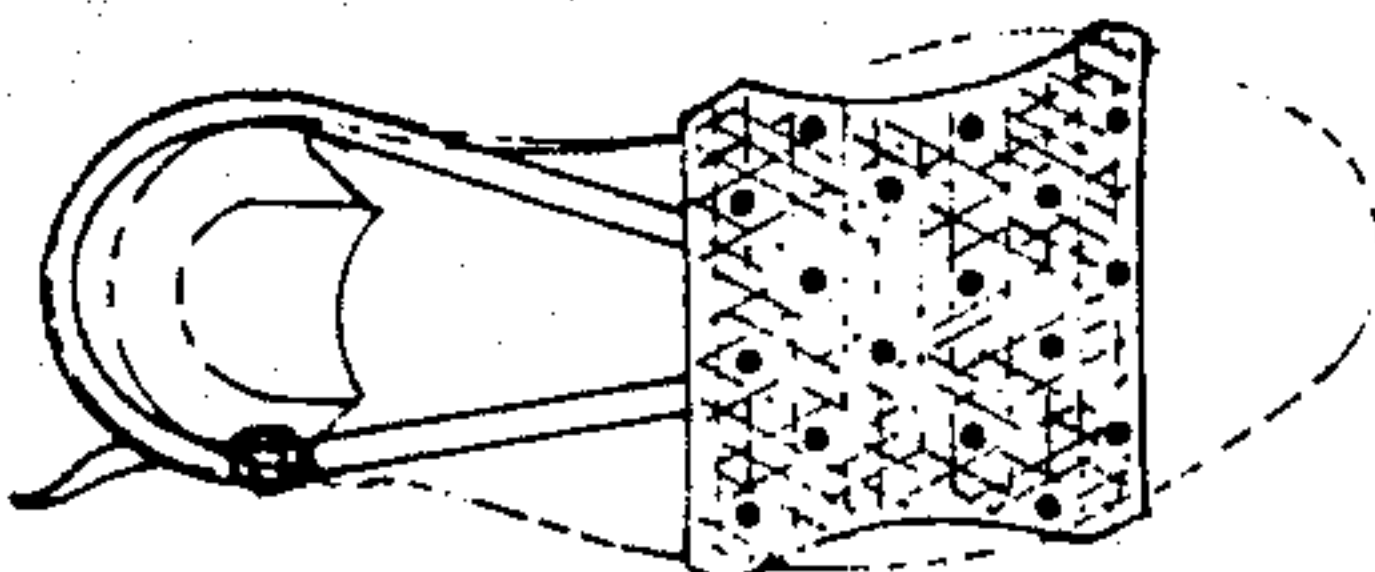

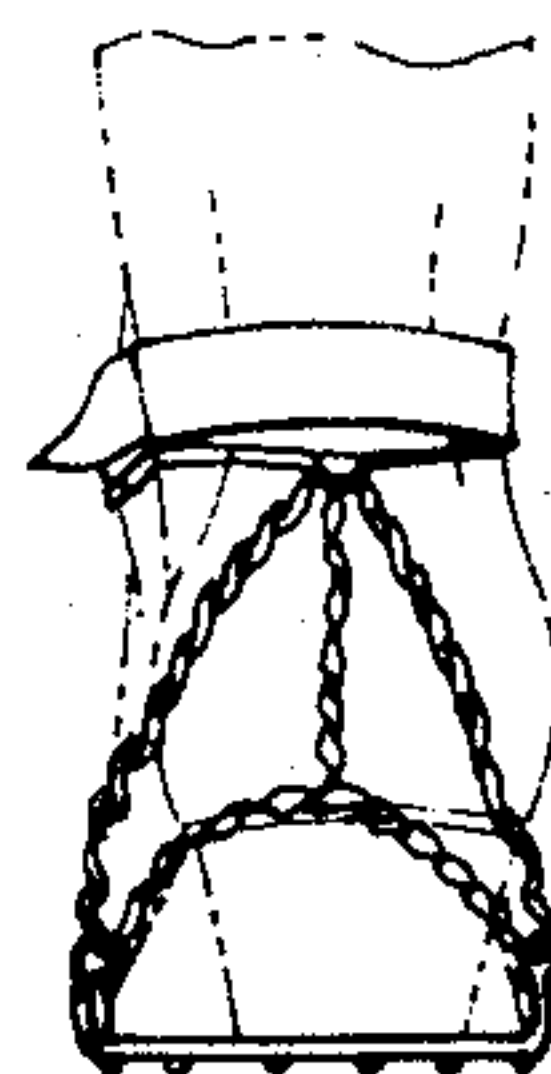

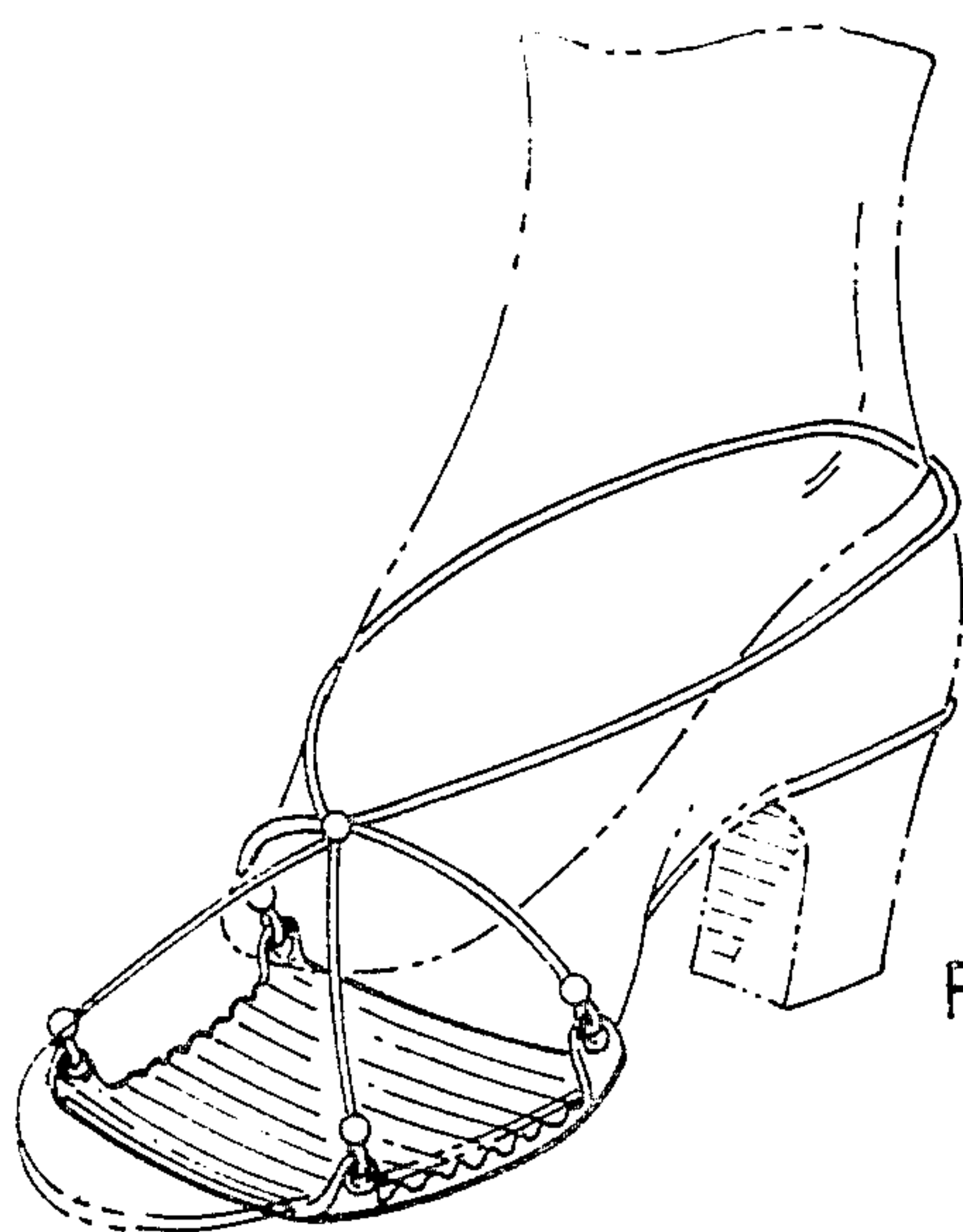

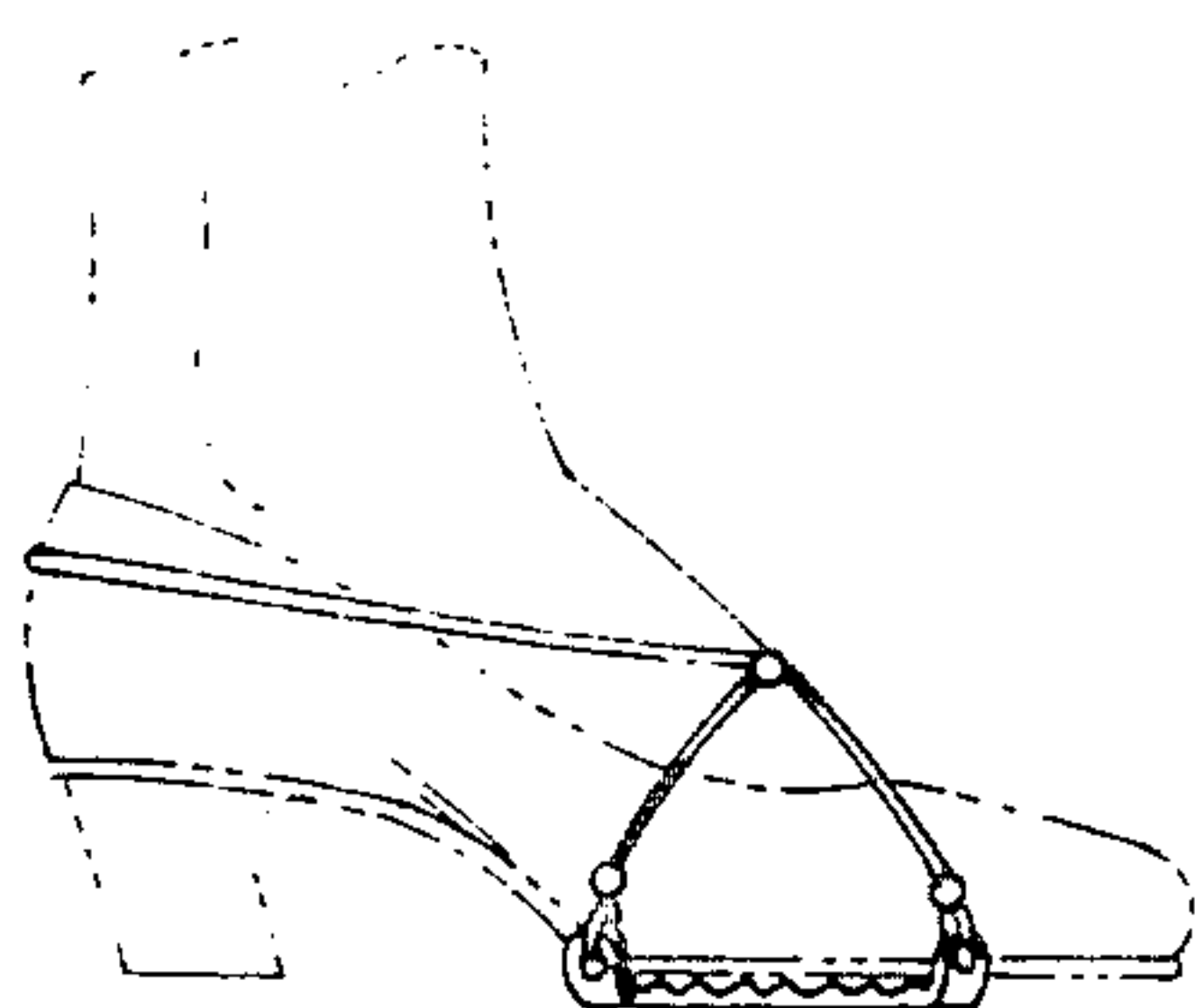
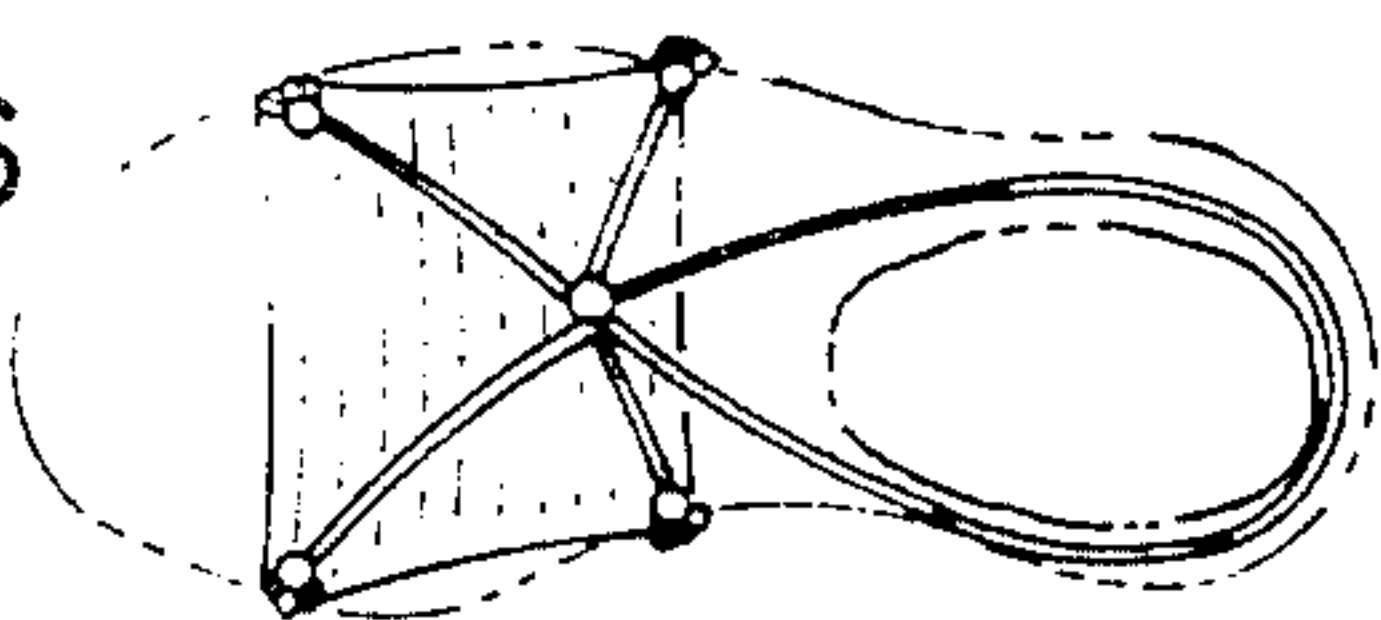

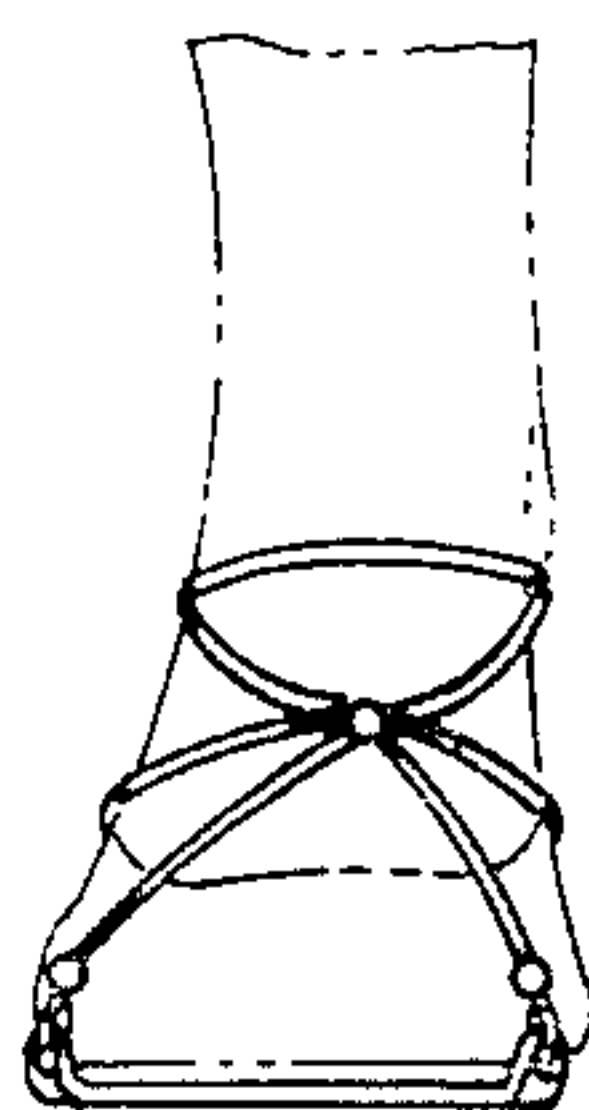

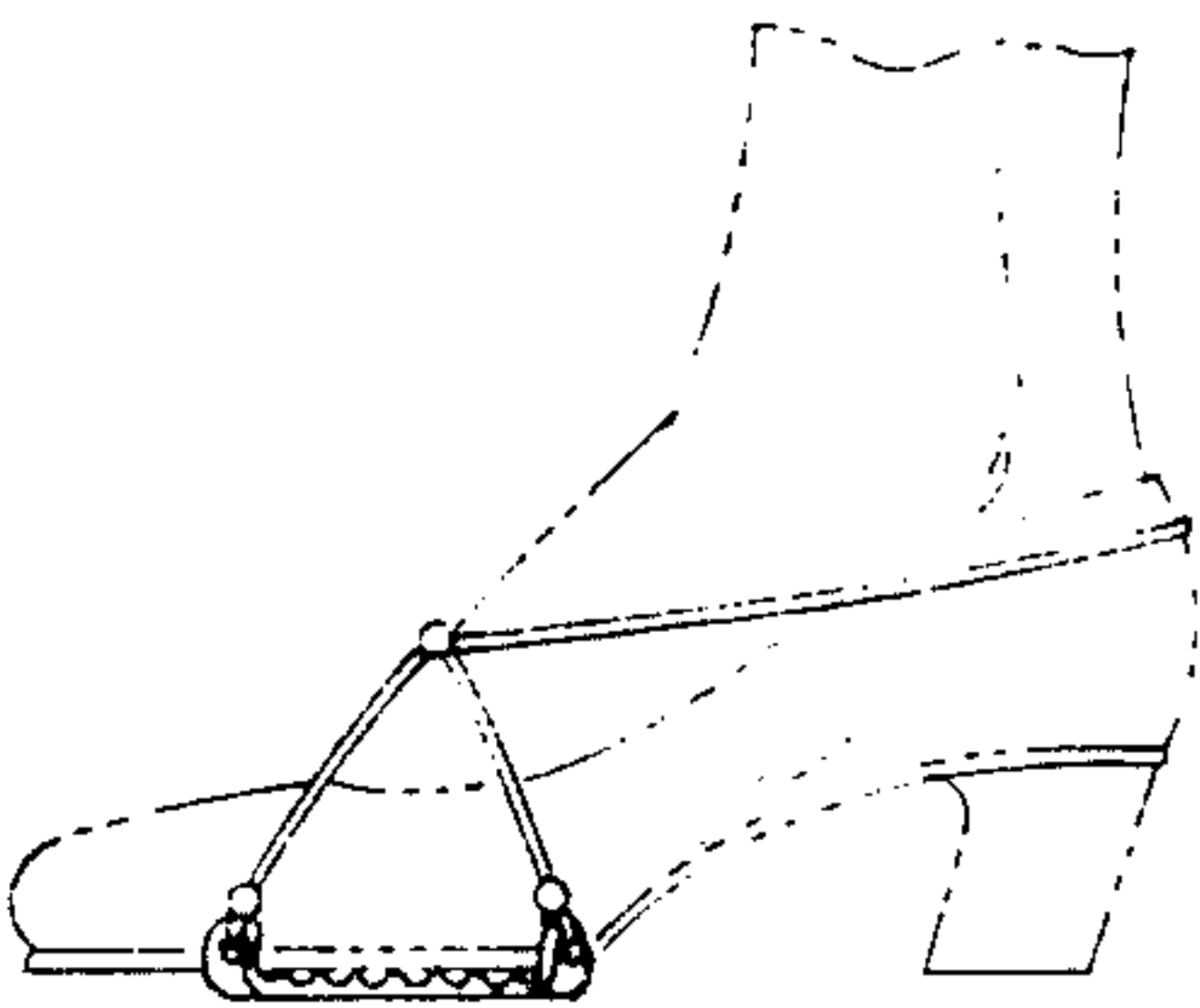

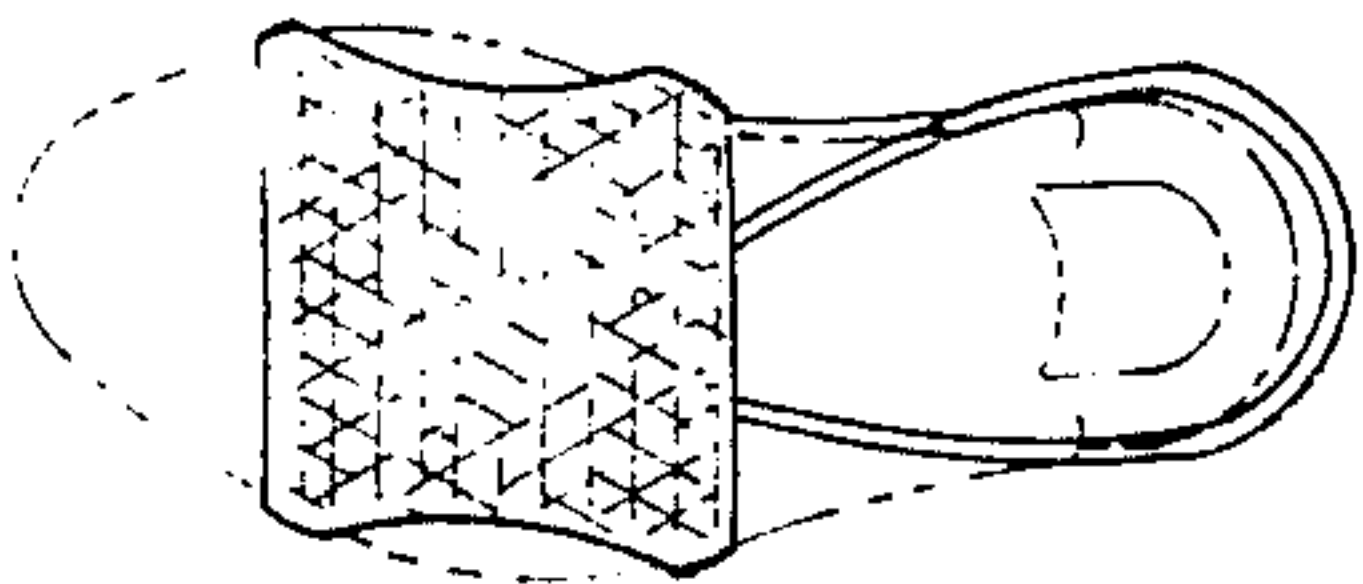

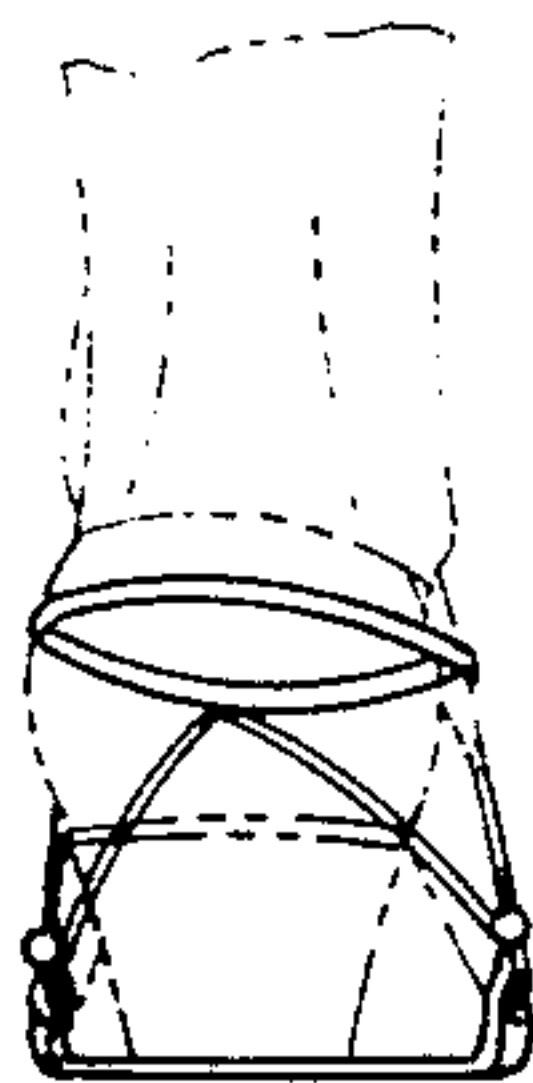
