[57] **CLAIM**

The ornamental design for a telephone set, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front, top and right side isometric view of a telephone set showing our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a front elevational view thereof; FIGS. 4 and 5 are respectively left and right side elevational views thereof; FIG. 6 is a rear elevational view thereof; and FIG. 7 is a bottom plan view thereof.

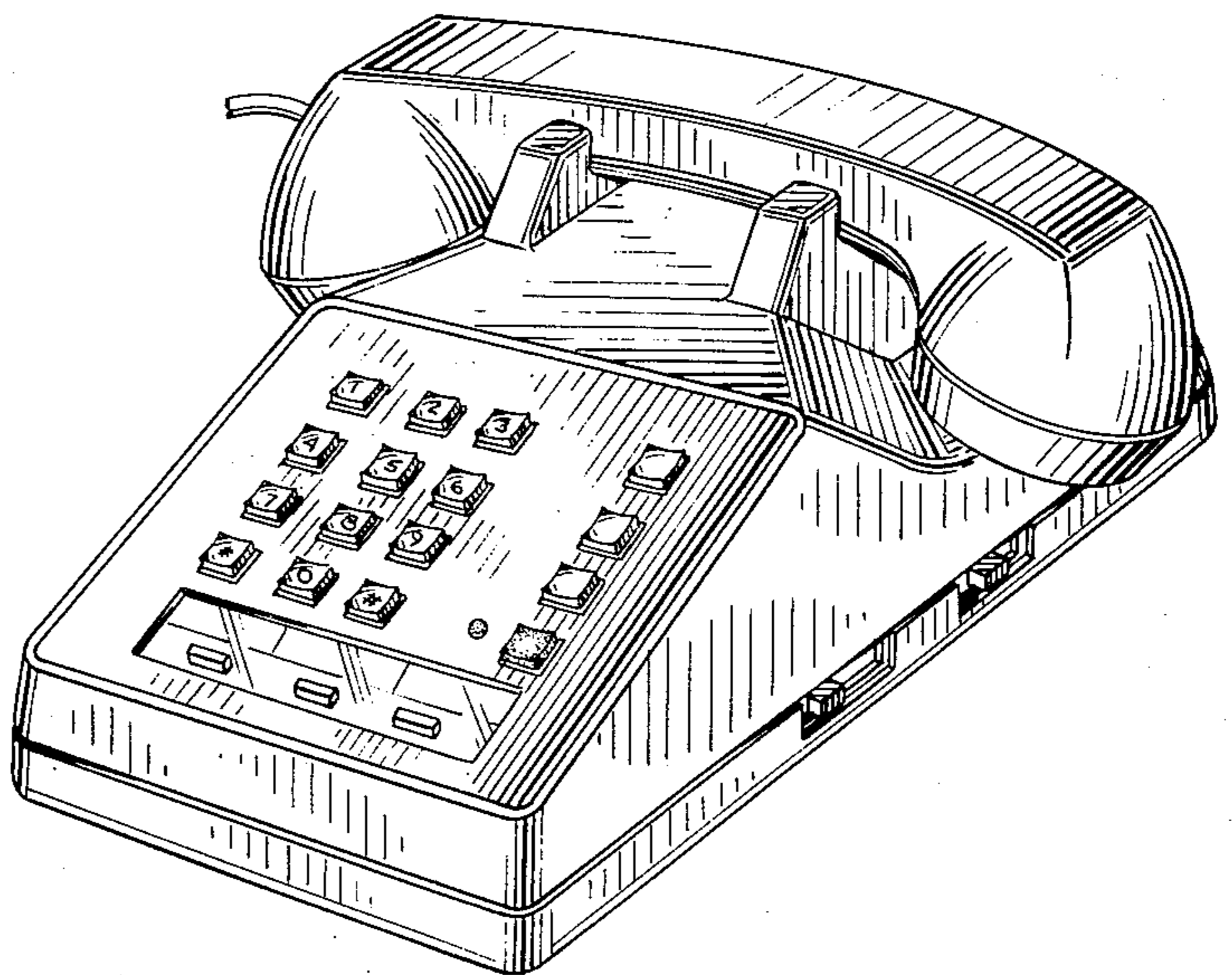
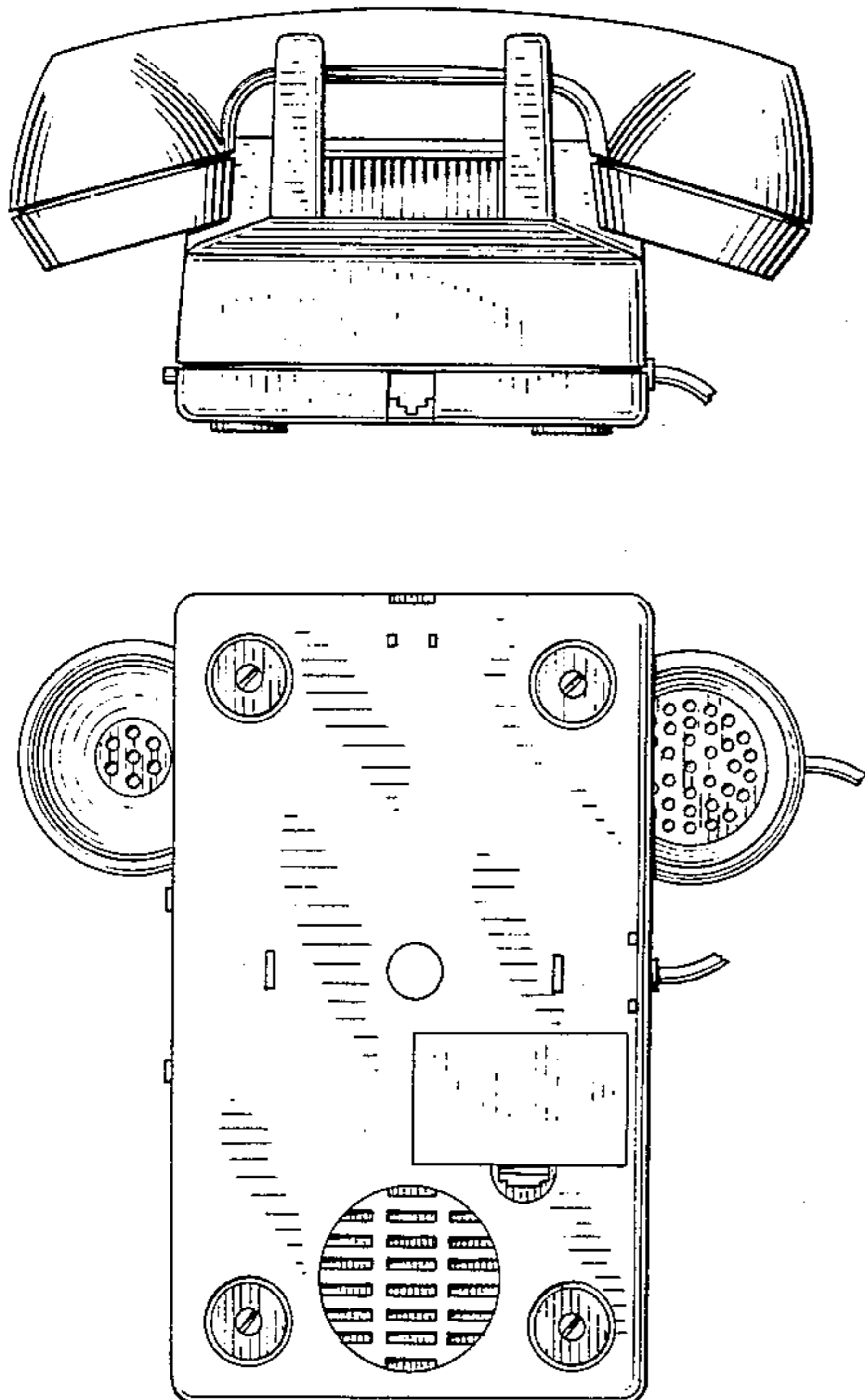

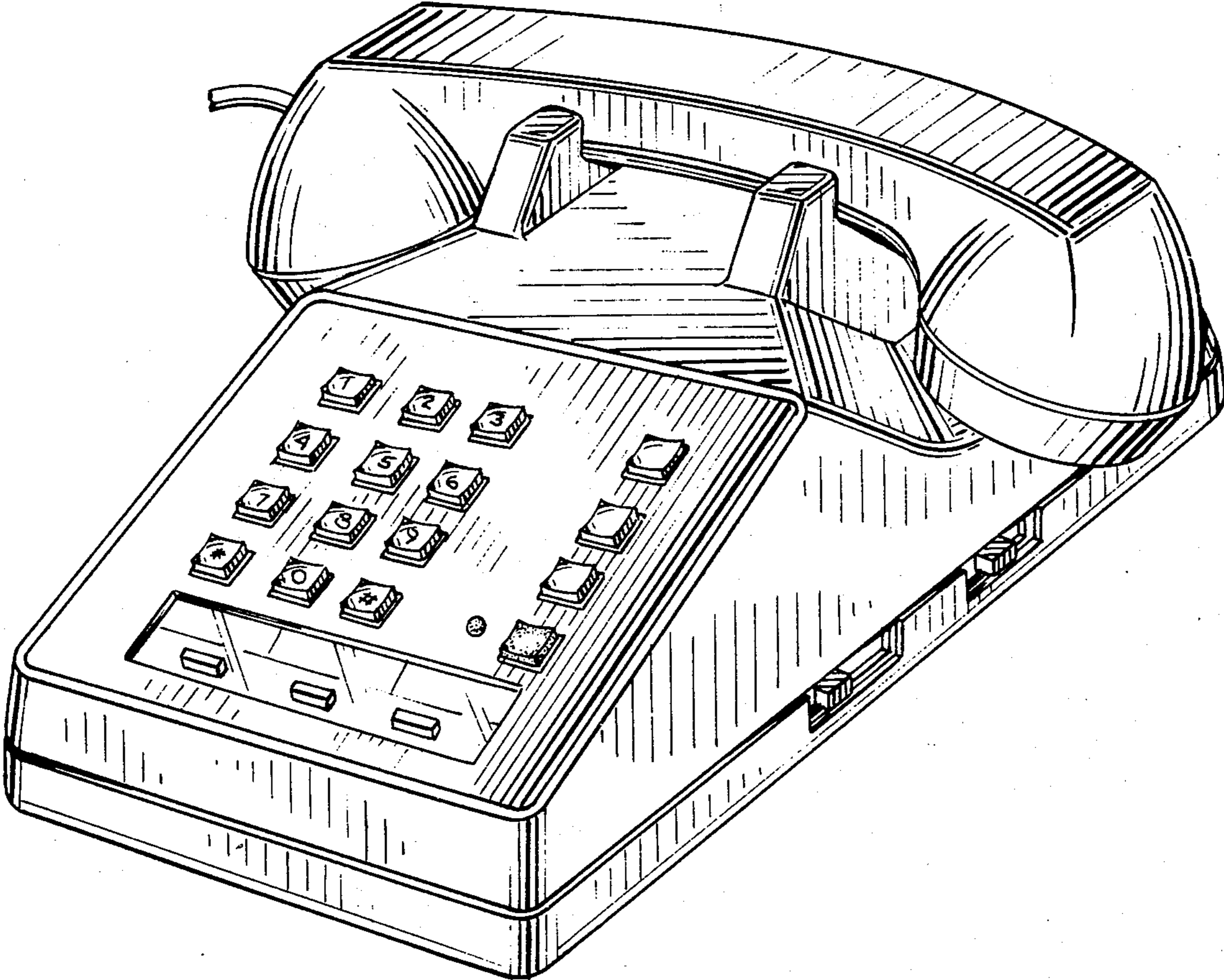

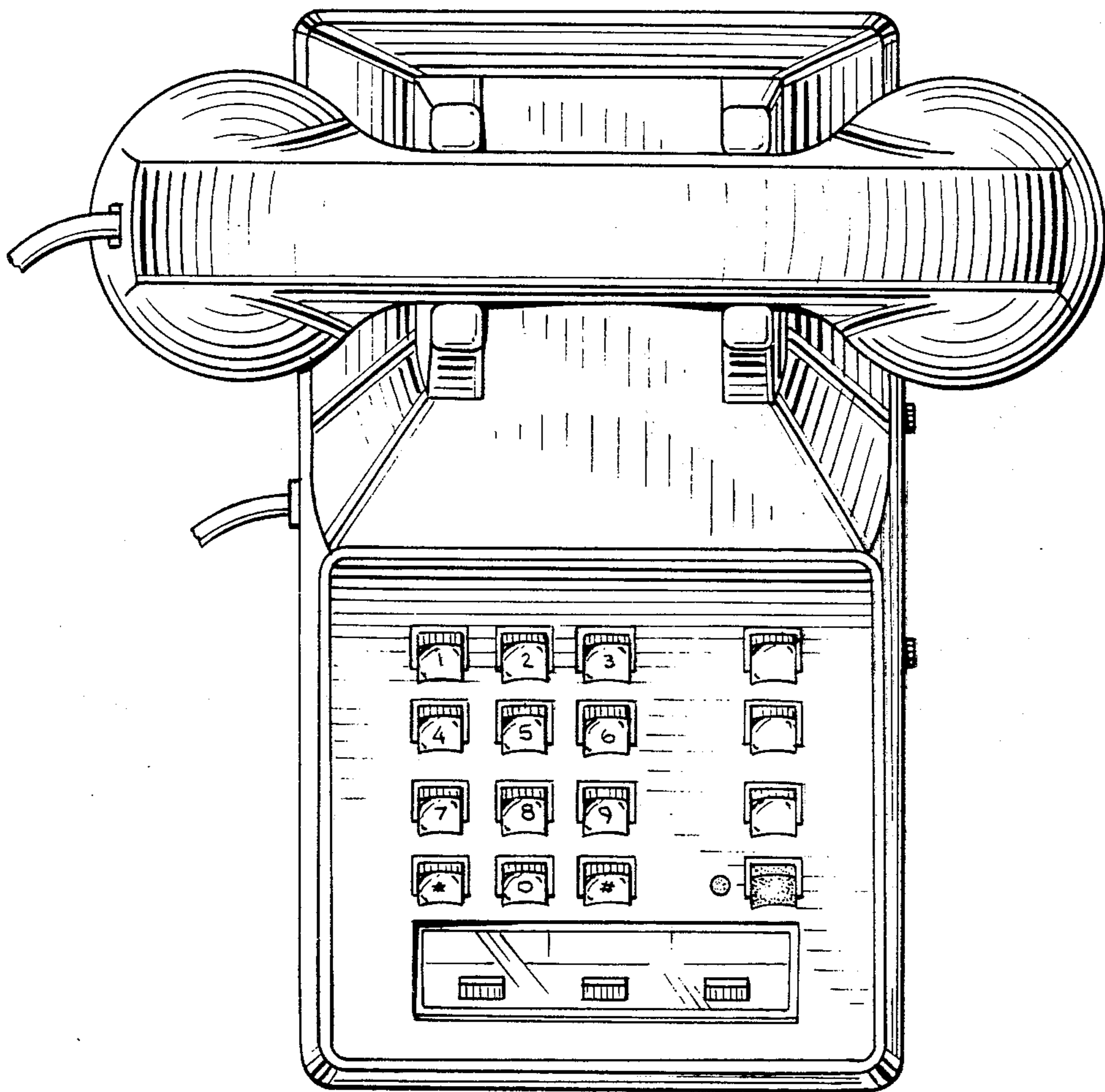

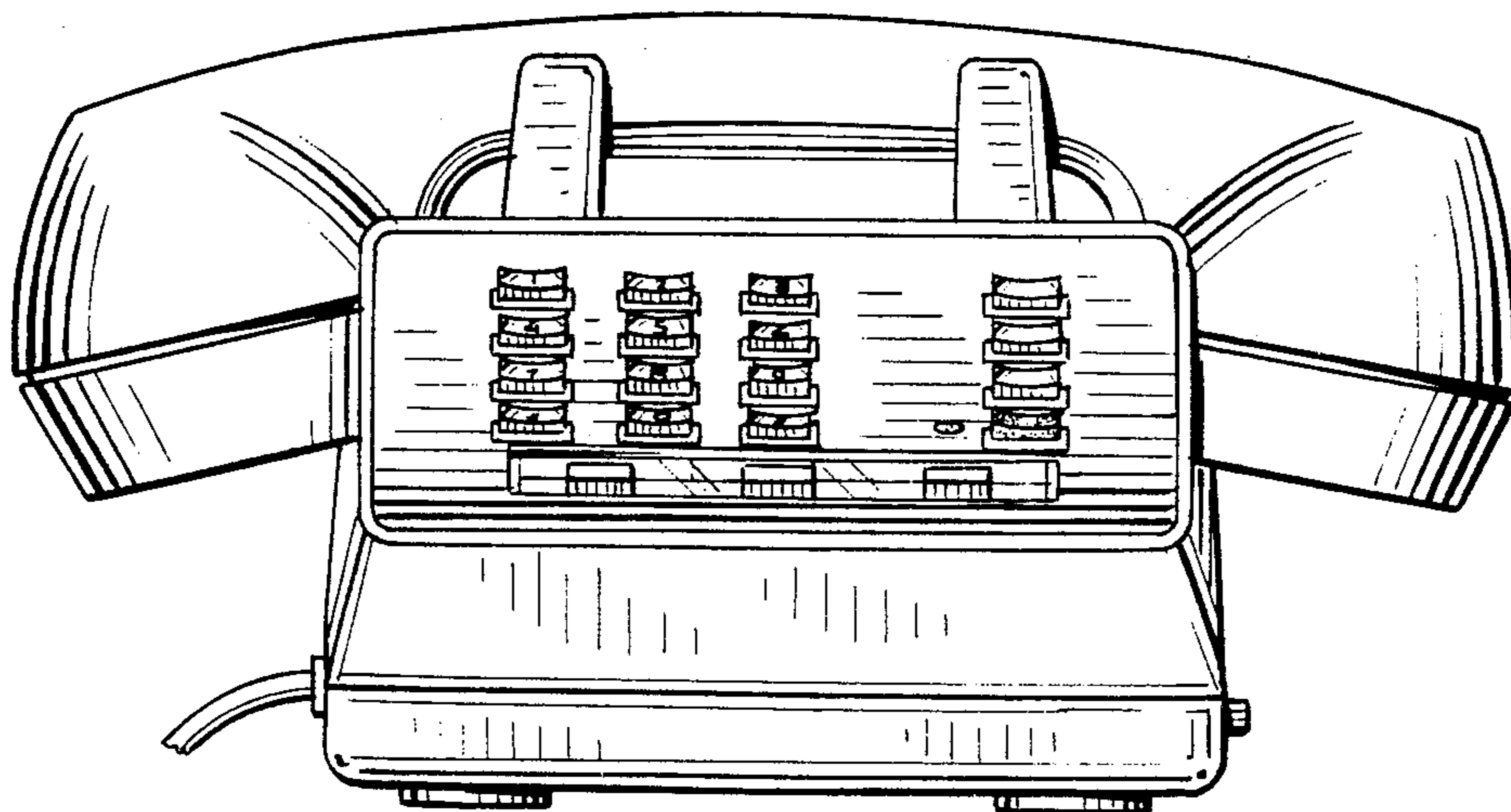

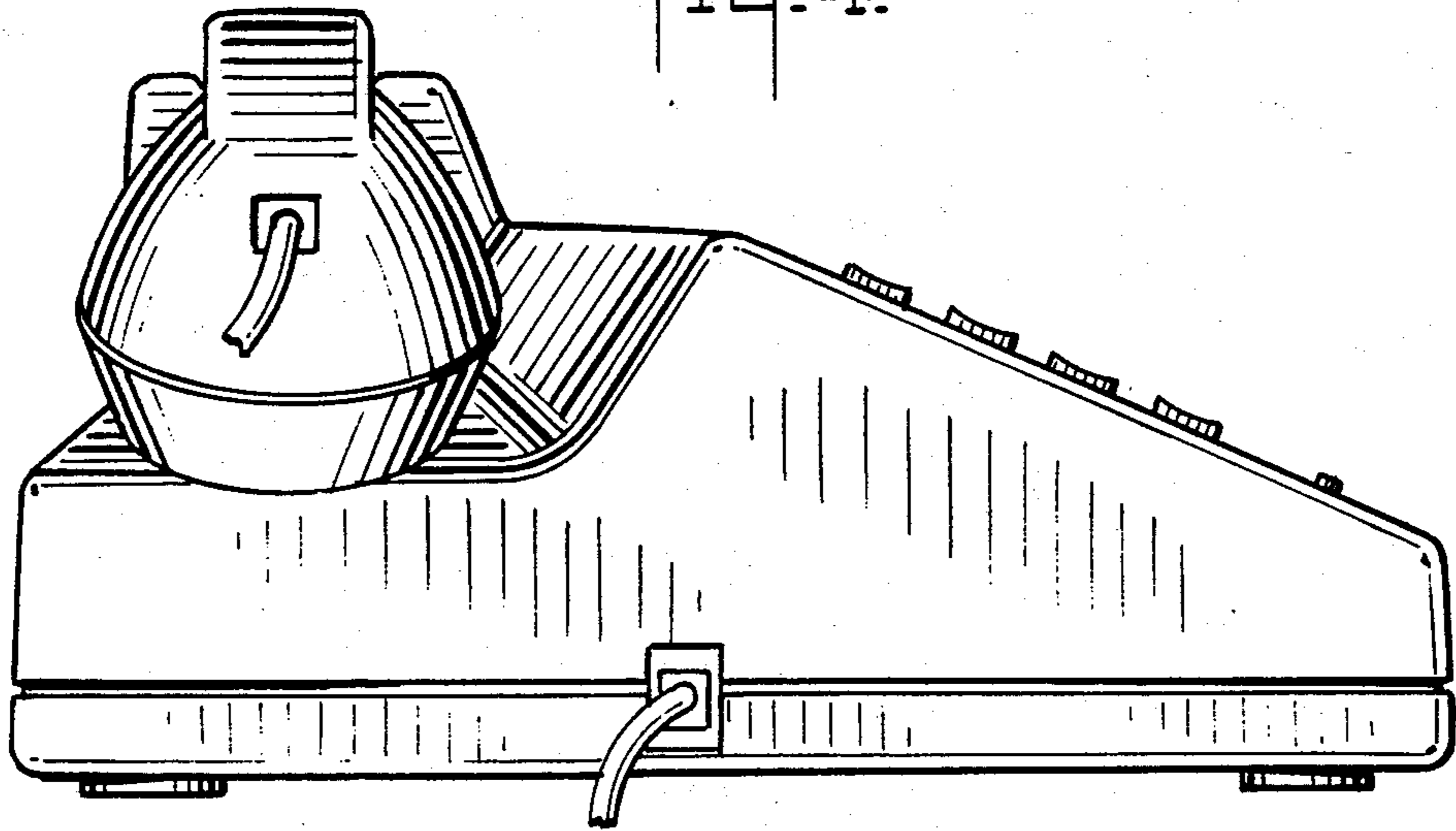

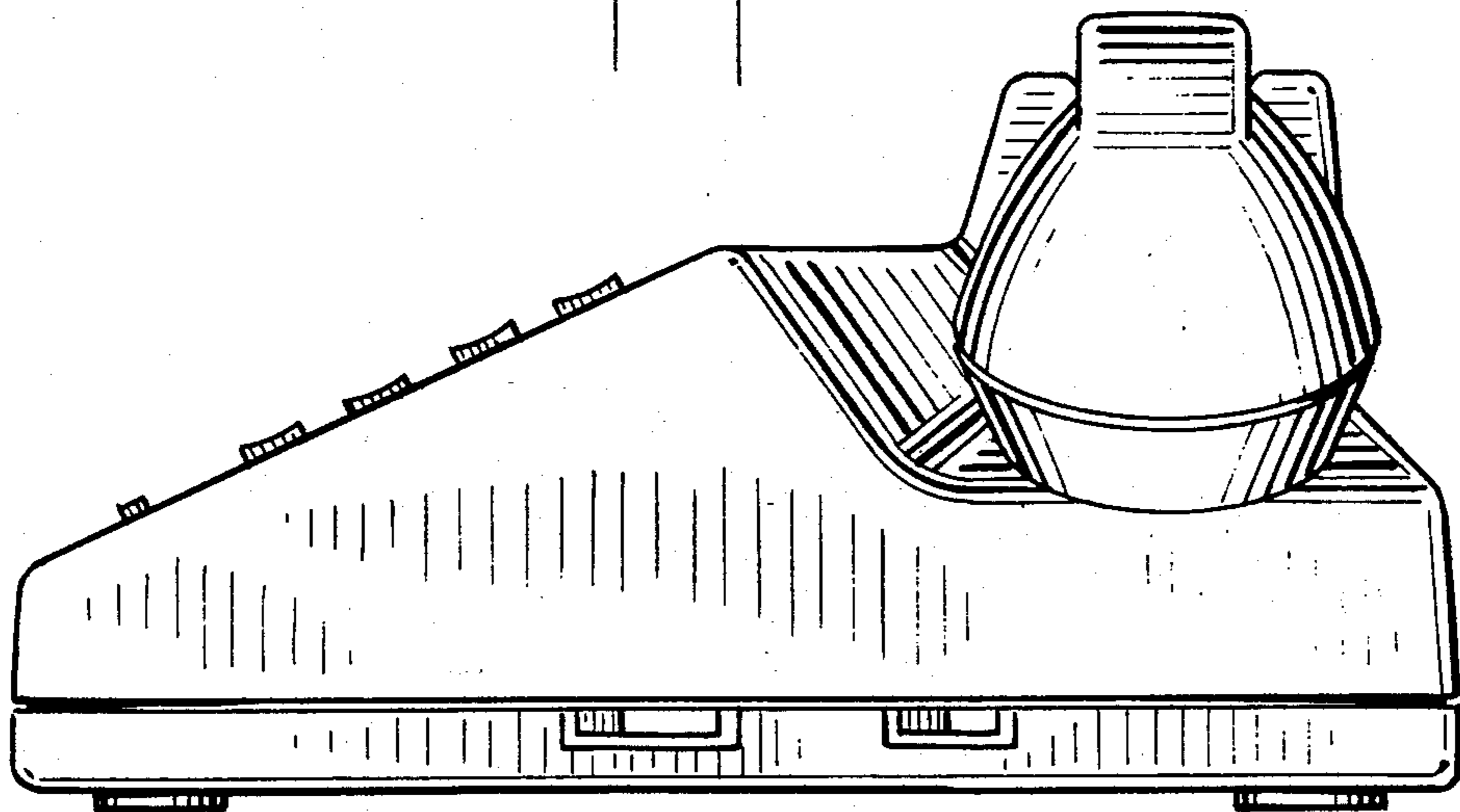

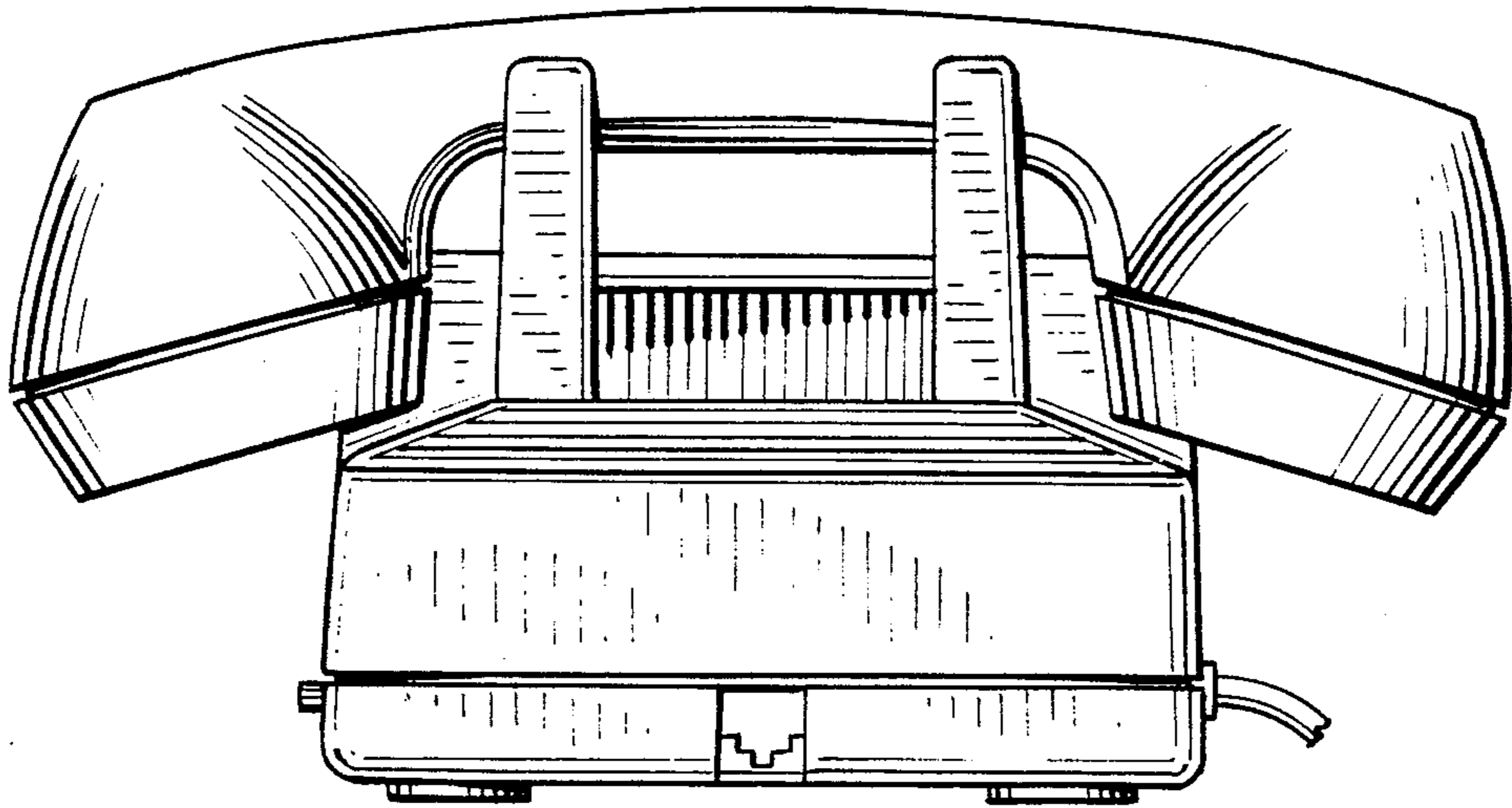
