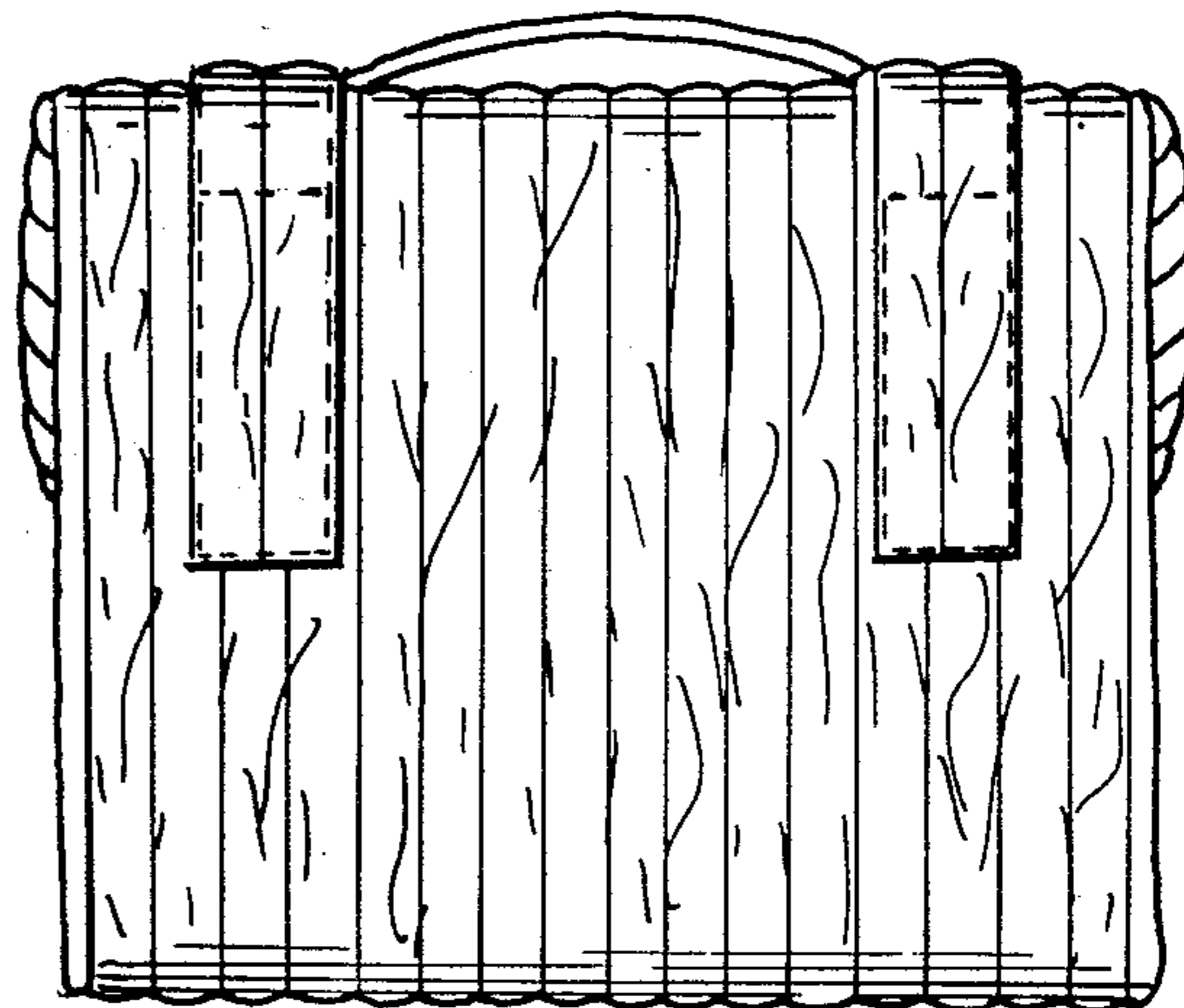
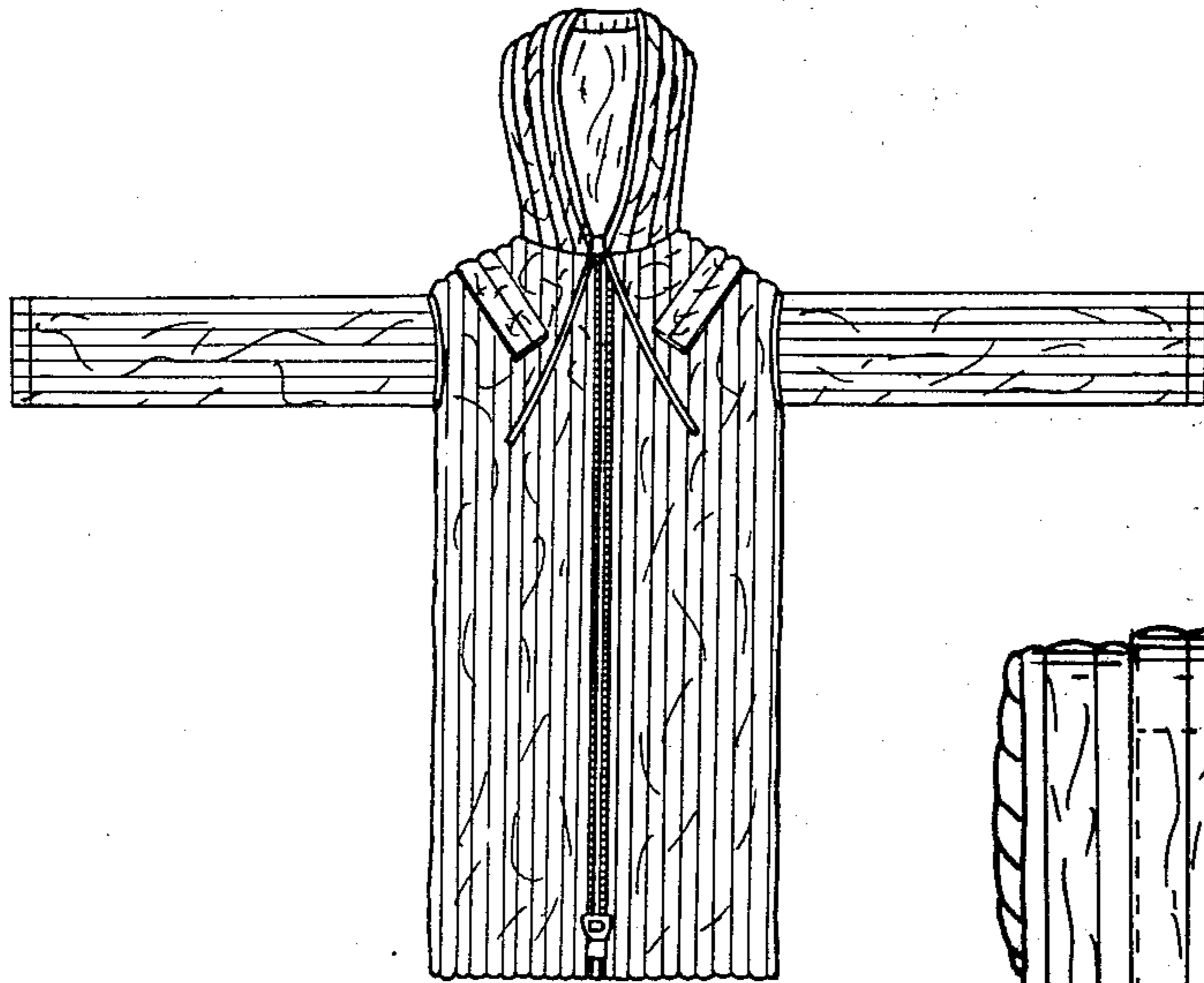

[57] **CLAIM**

The ornamental design for a stadium coat or the like, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a stadium coat showing my new design in a folded position;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a right side elevational view thereof, the opposite side being a mirror image;
 FIG. 4 is a rear elevational view thereof;
 FIG. 5 is a bottom plan view thereof;
 FIG. 6 is a front elevational view thereof in an unfolded position with the arms crossed;
 FIG. 7 is a top plan view of that shown in FIG. 6;
 FIG. 8 is a right side elevational view of that shown in FIG. 6, the opposite side being a mirror image;
 FIG. 9 is a rear elevational view of that shown in FIG. 6;
 FIG. 10 is a bottom plan view of that shown in FIG. 6;
 FIG. 11 is a front elevational view thereof in an unfolded position with the arms extended; and,
 FIG. 12 is a rear elevational view thereof in an unfolded position with the arms extended.



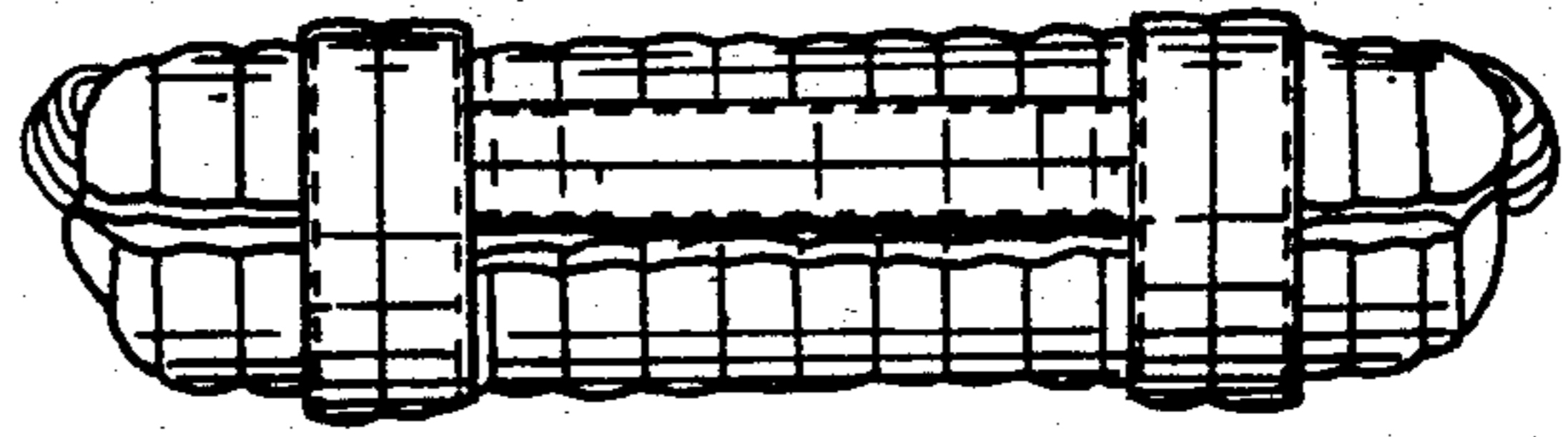

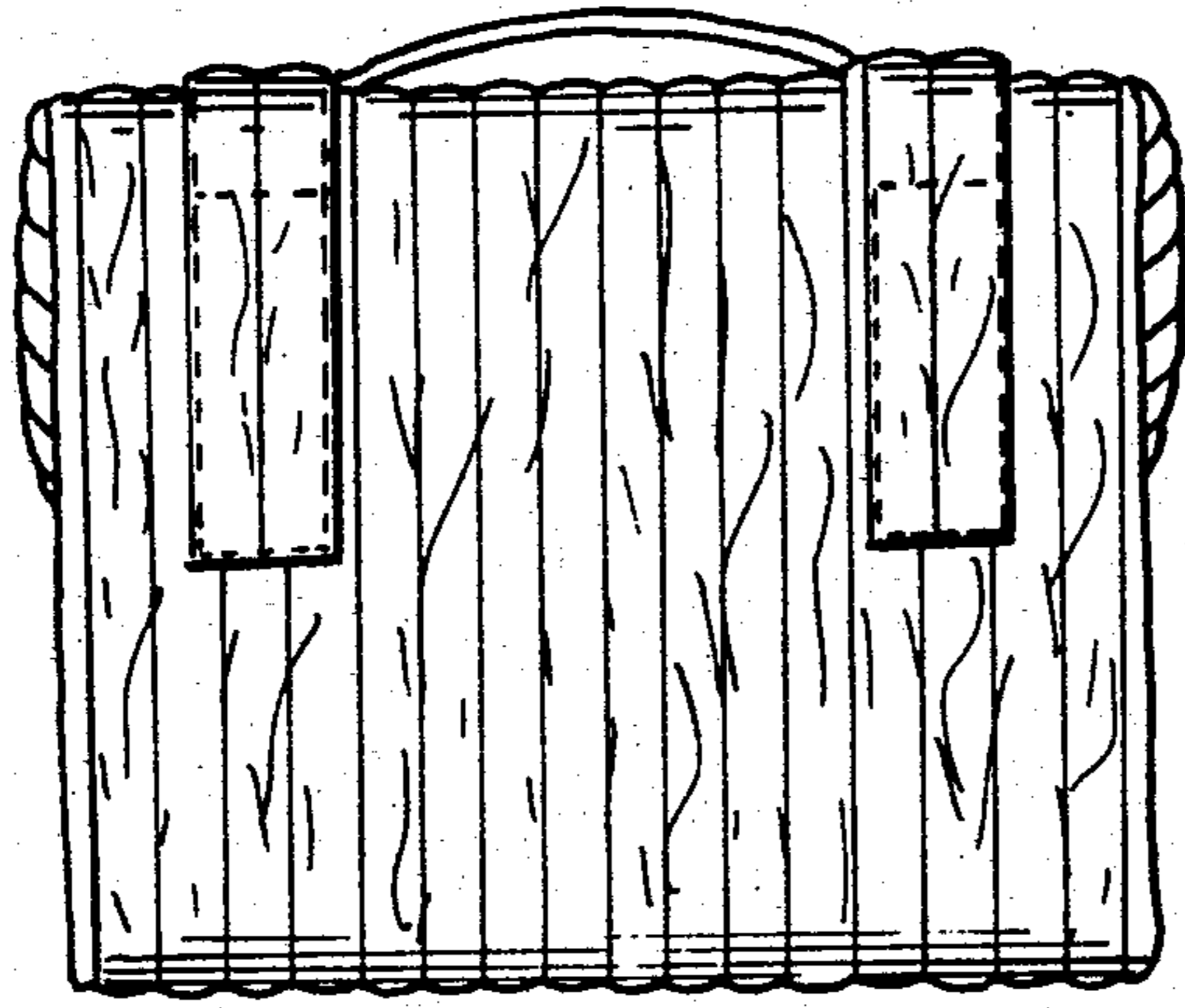

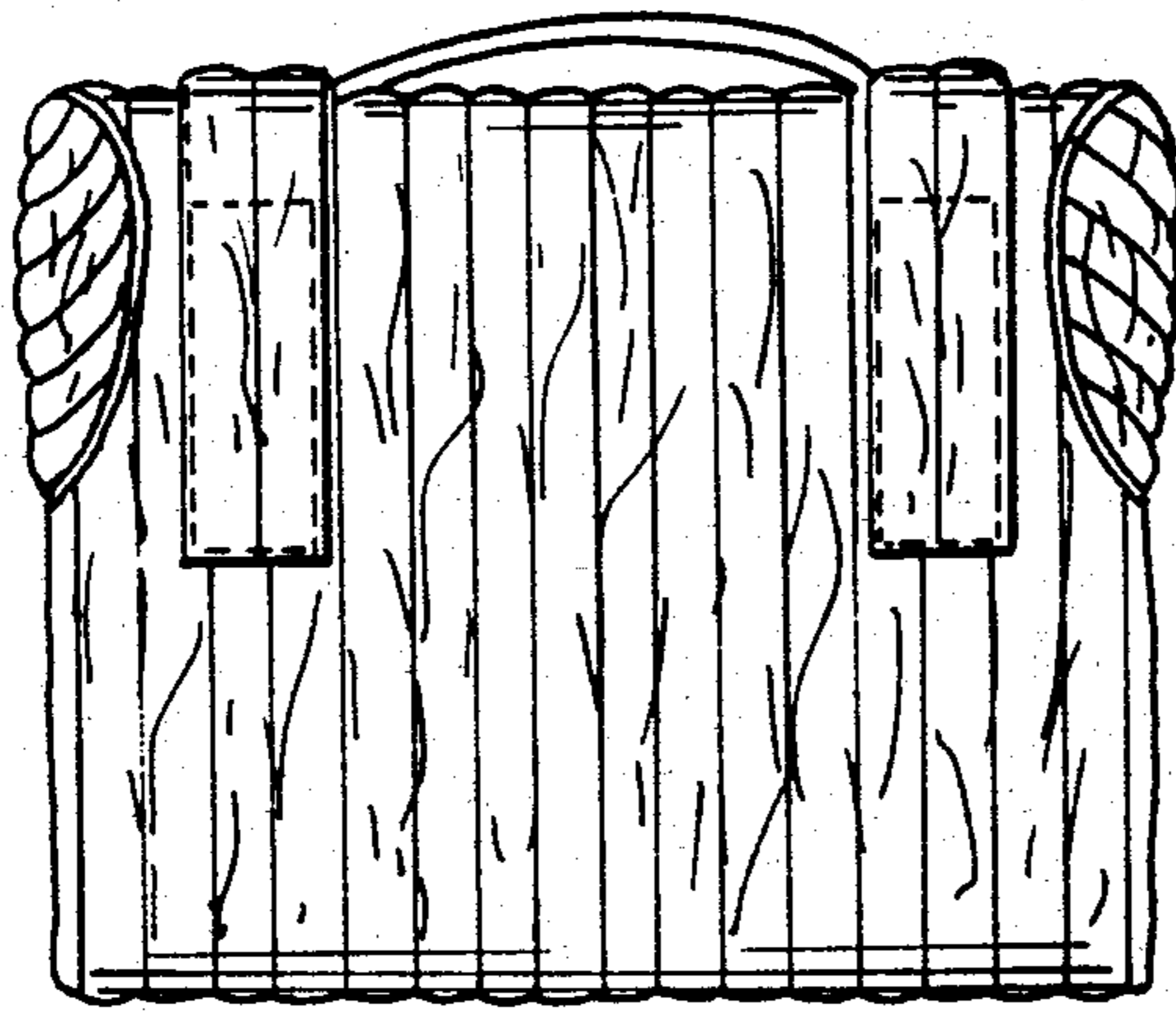

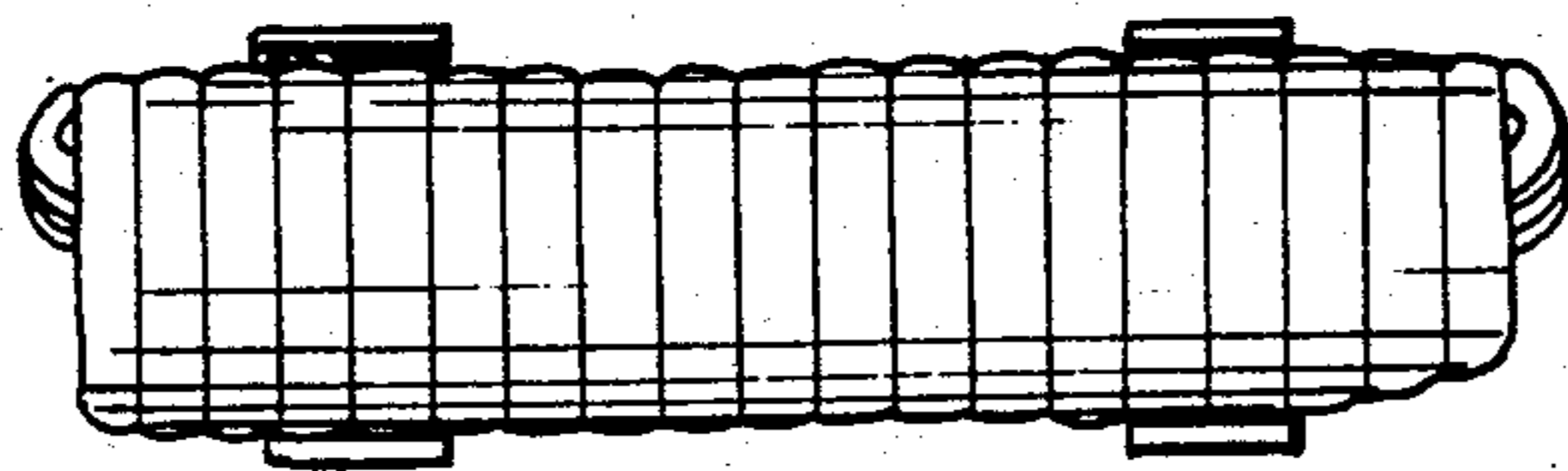

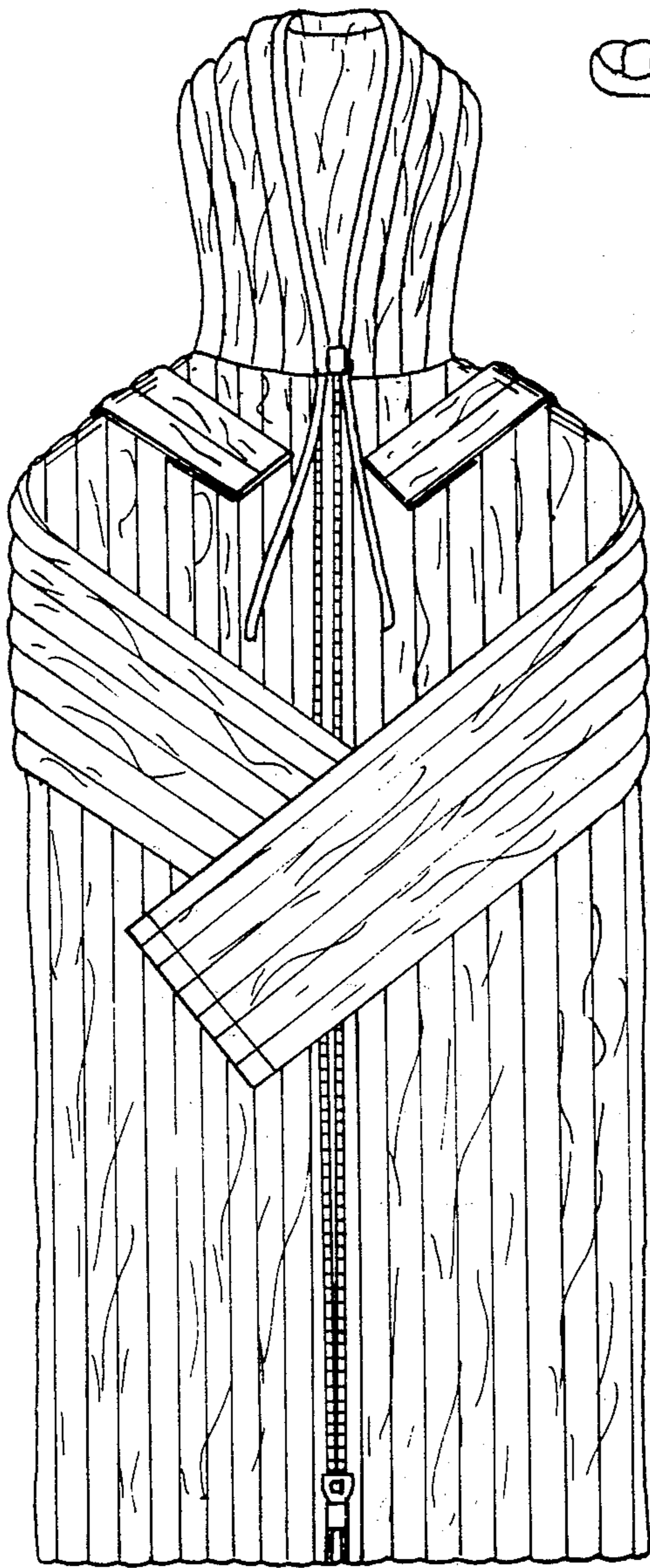

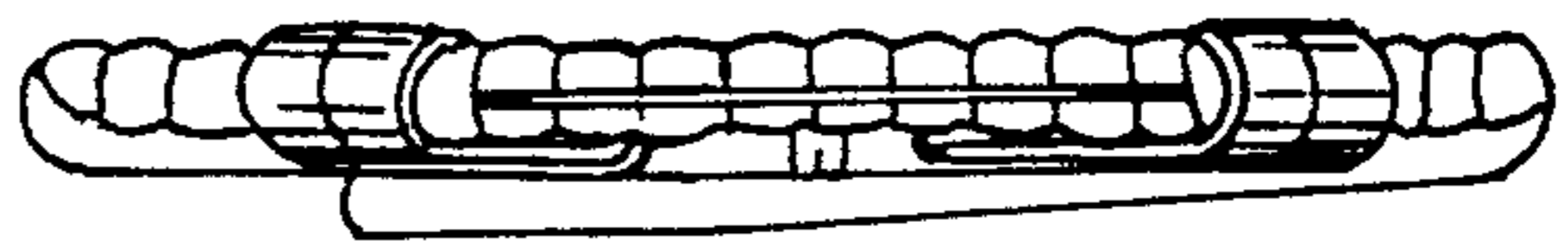

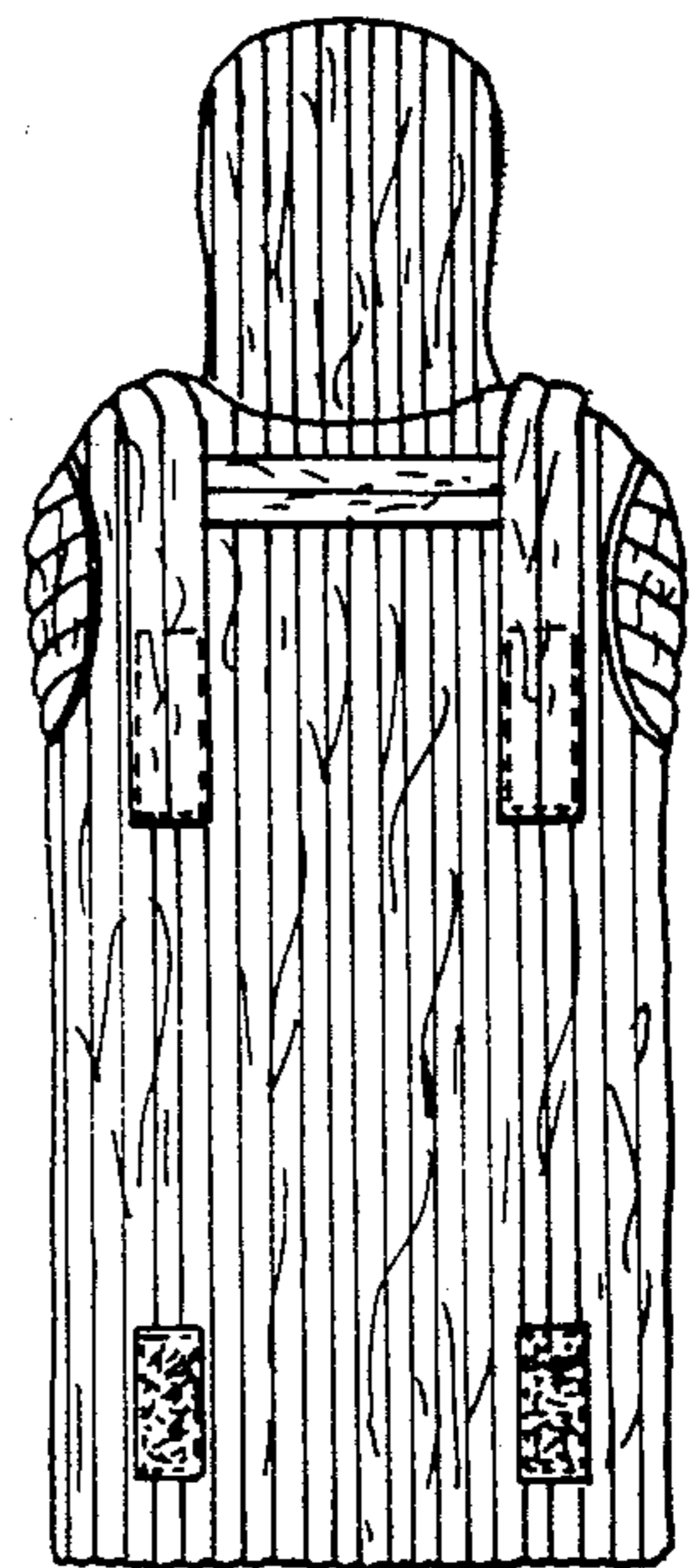

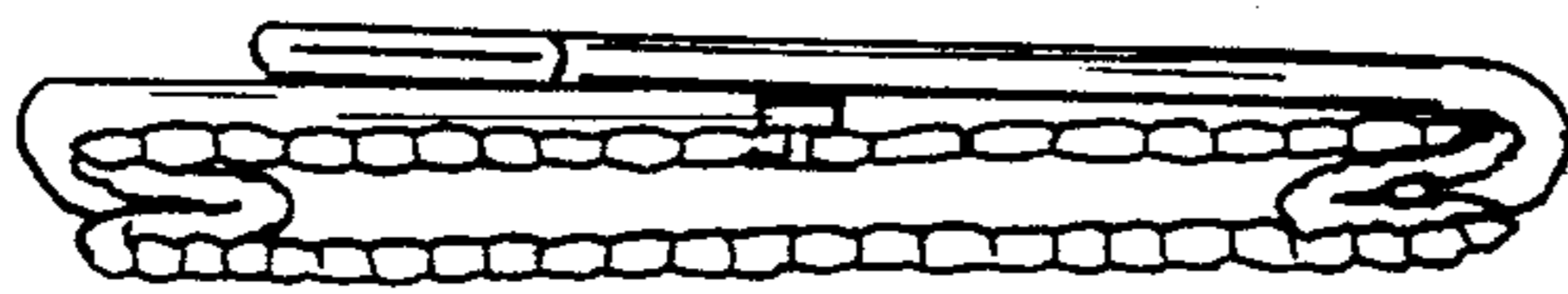

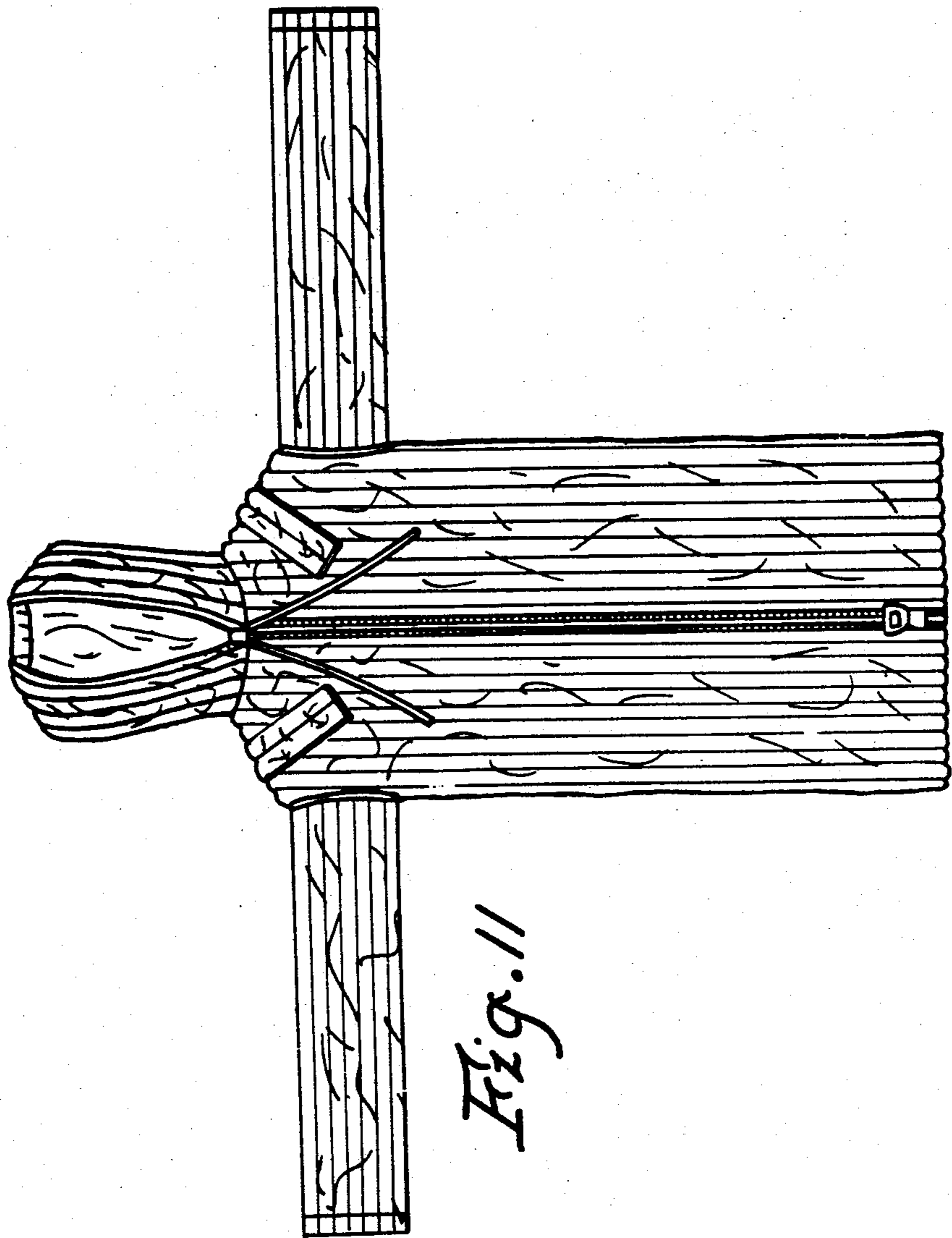

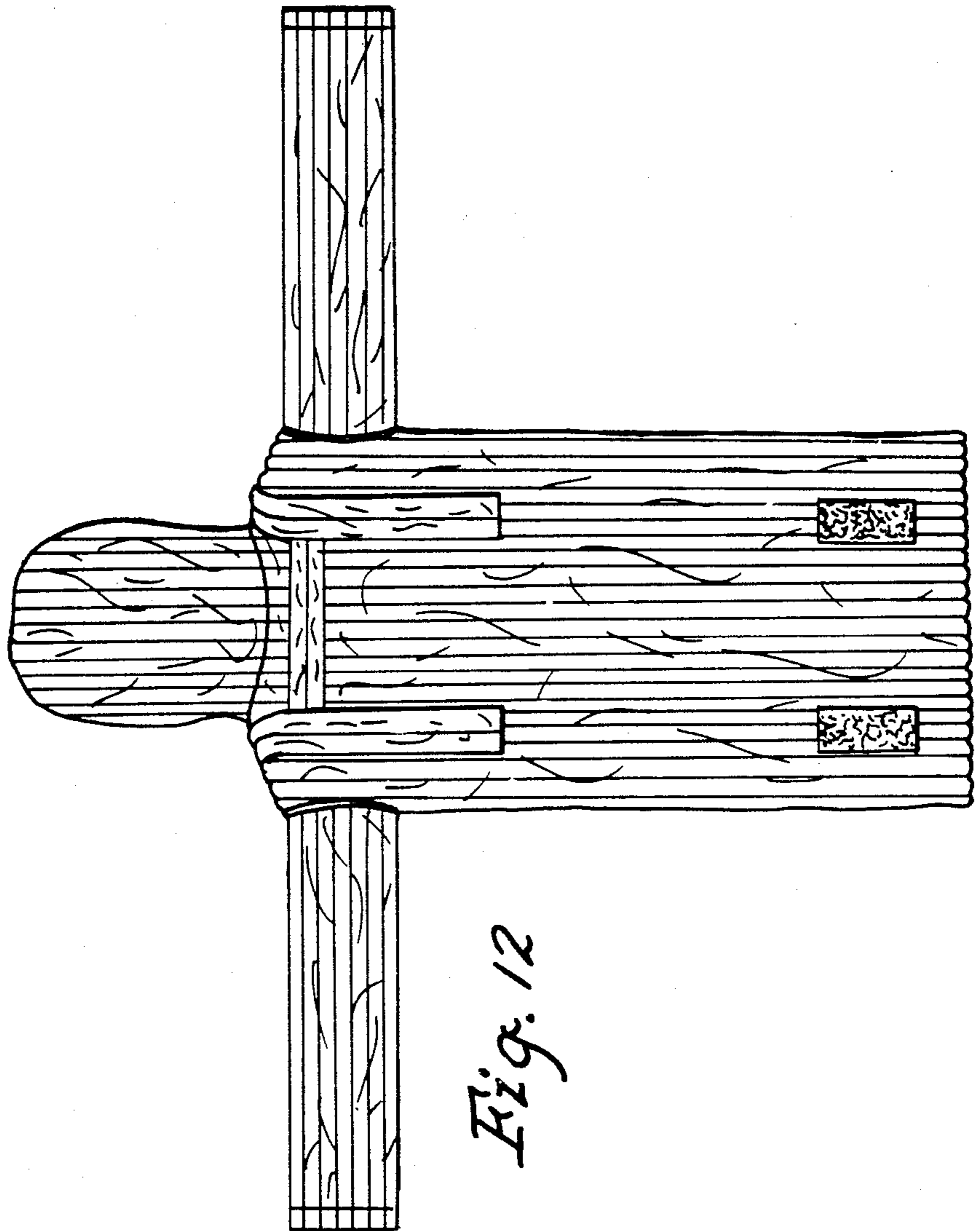
