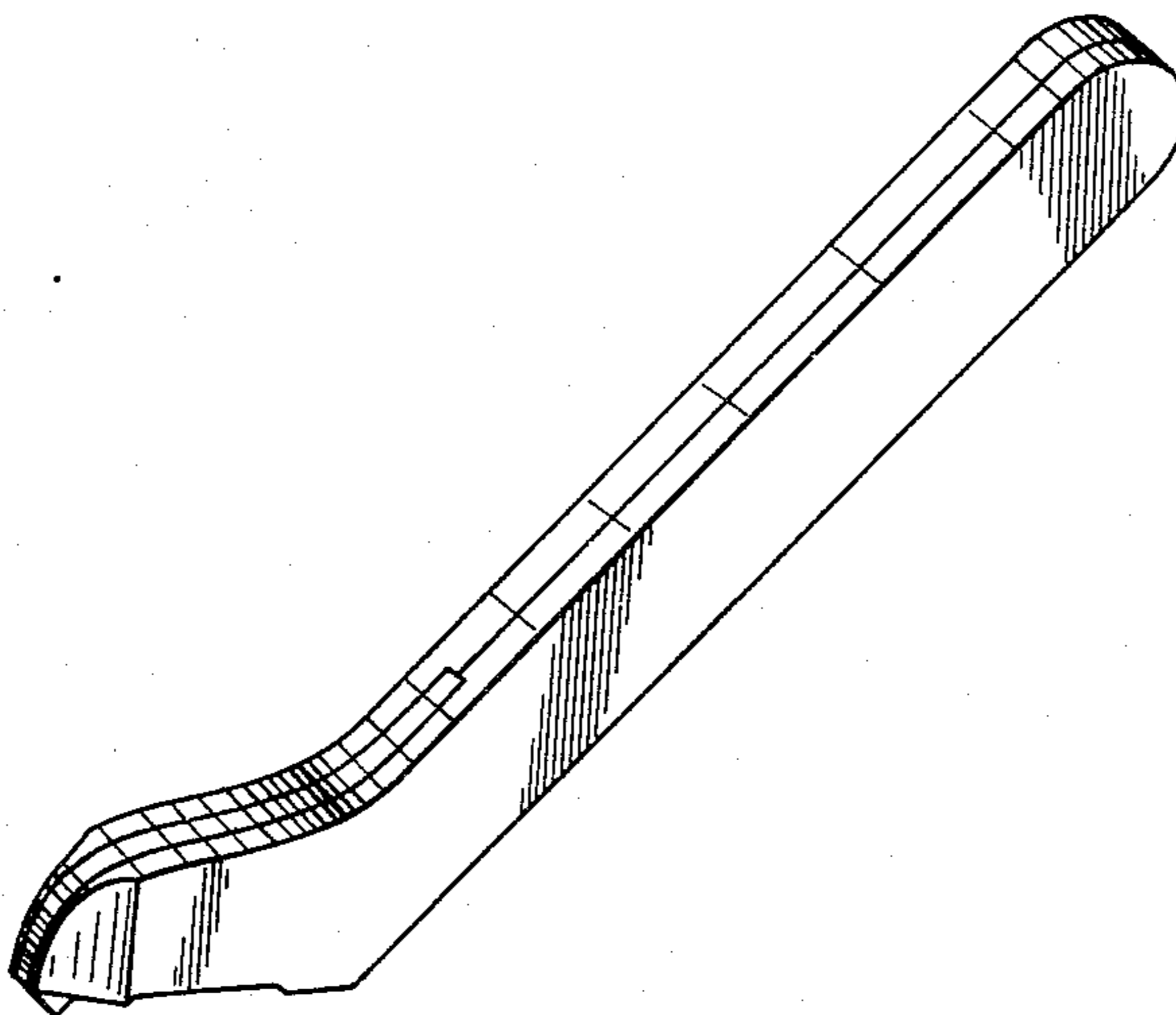

[57] CLAIM

The ornamental design for a coupon clipper, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the coupon clipper showing our new design;
FIG. 2 is a reduced side elevational view thereof, the opposite side being a mirror image thereof;
FIG. 3 is a reduced front elevational view;
FIG. 4 is a reduced rear elevational view thereof;
FIG. 5 is a reduced top plan view thereof;
FIG. 6 is a reduced bottom plan view thereof;
FIG. 7 is a side elevational view of the coupon clipper showing an alternate form of our new design with the opposite side being a mirror image;
FIG. 8 is a front elevational view thereof;
FIG. 9 is a rear elevational view thereof;
FIG. 10 is a top plan view thereof; and
FIG. 11 is a bottom plan view thereof.



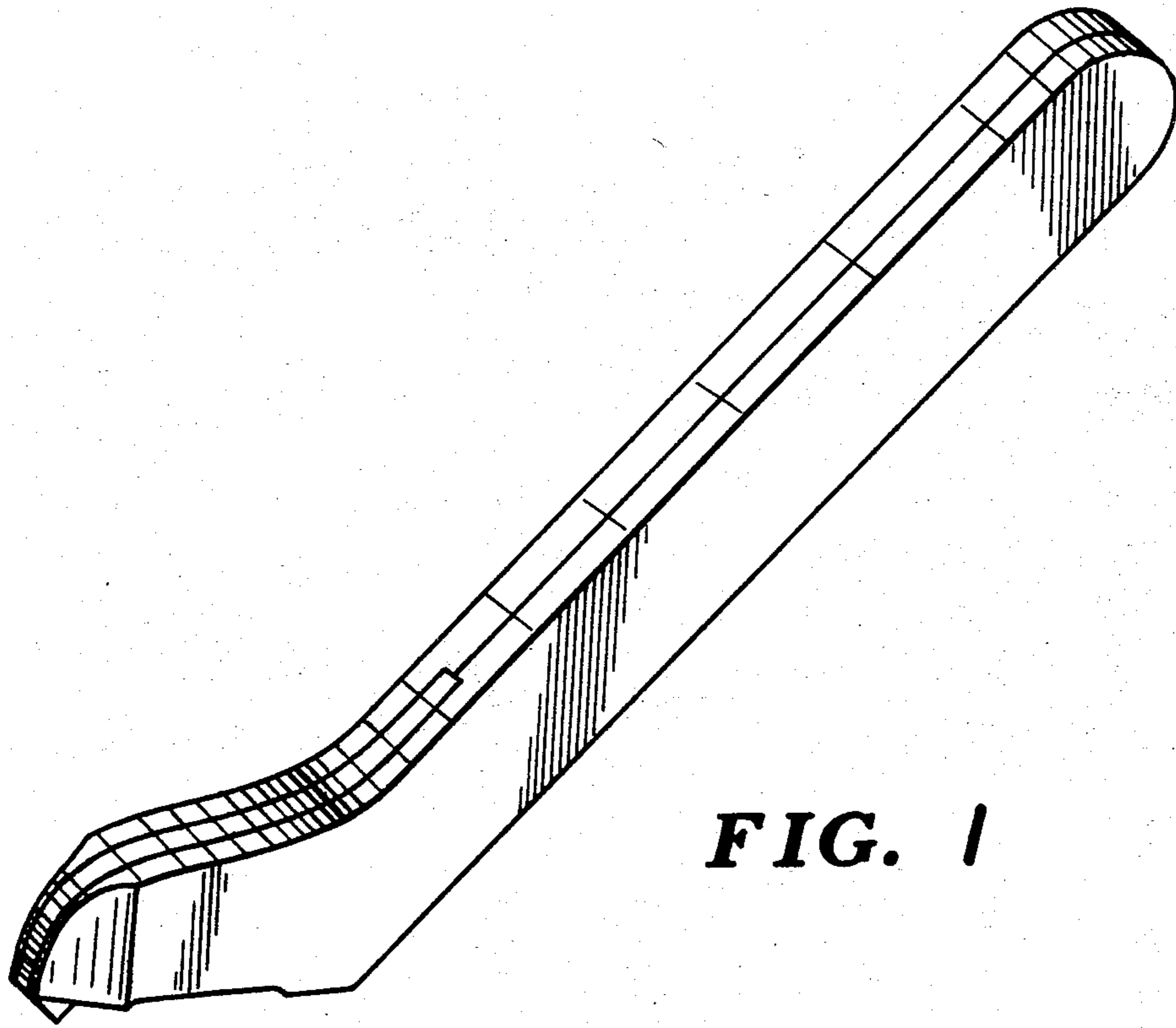

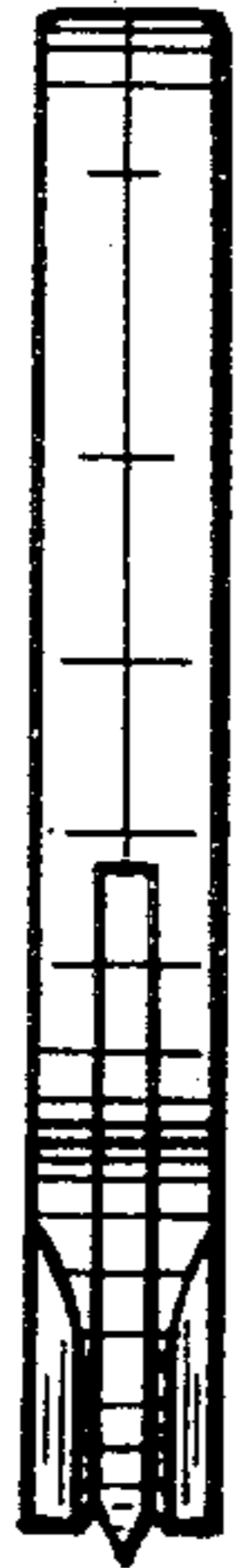

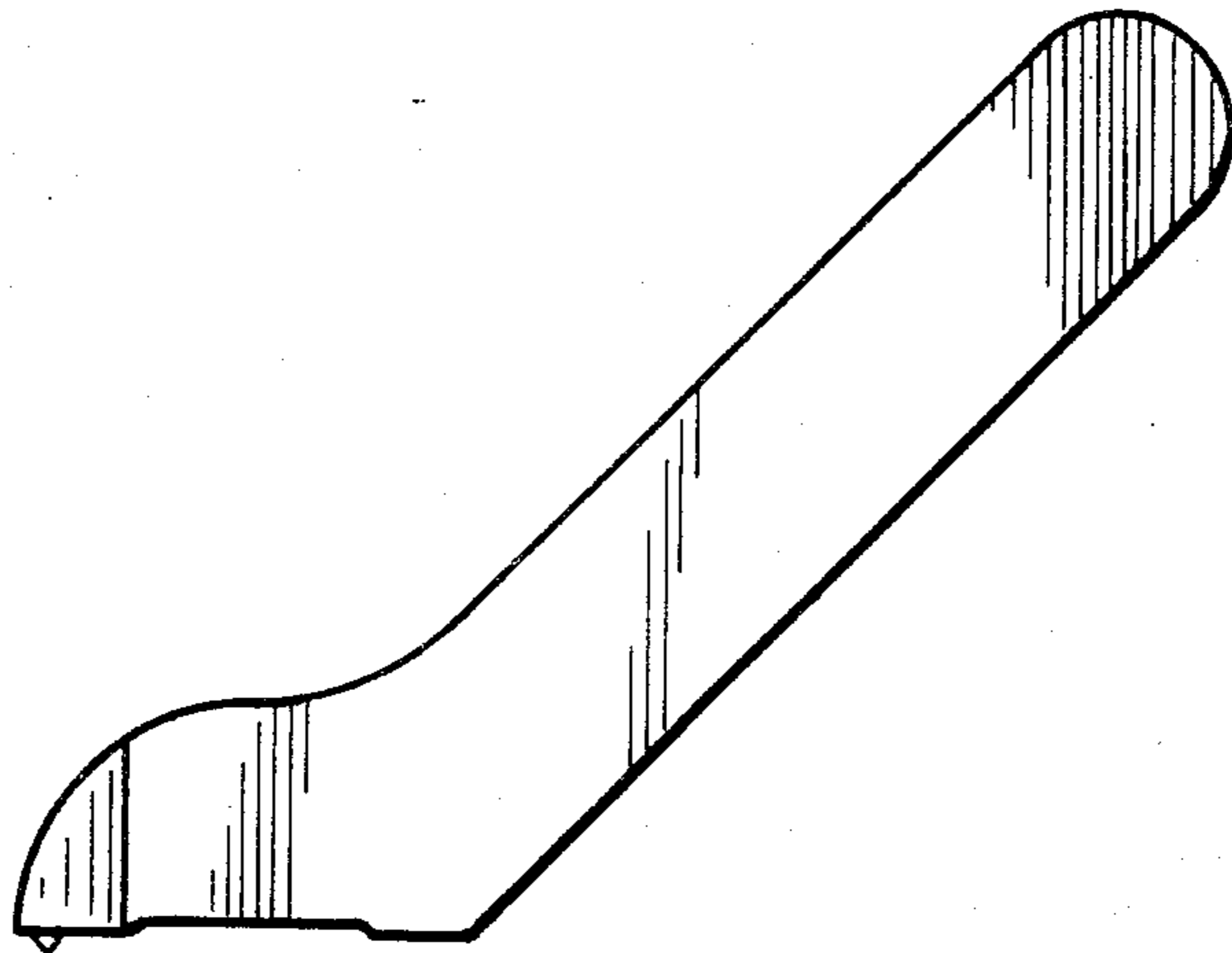

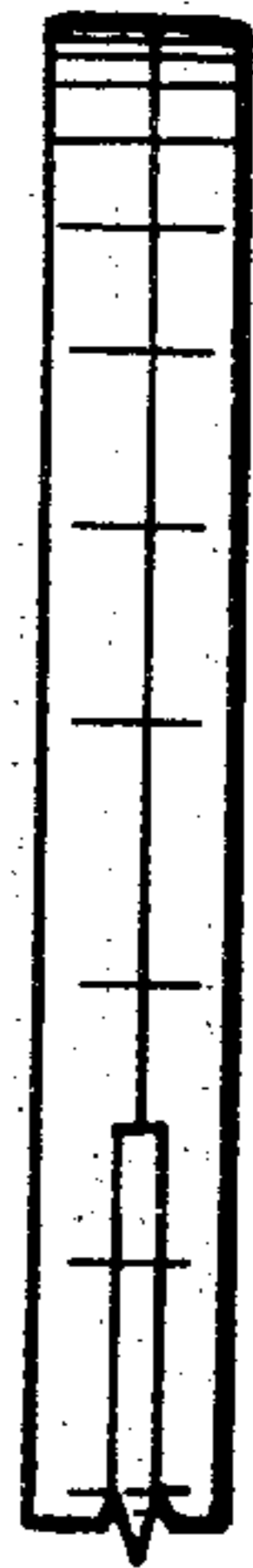

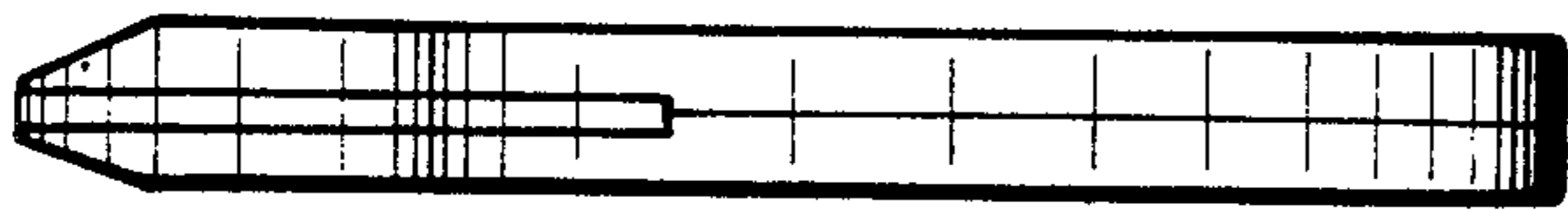

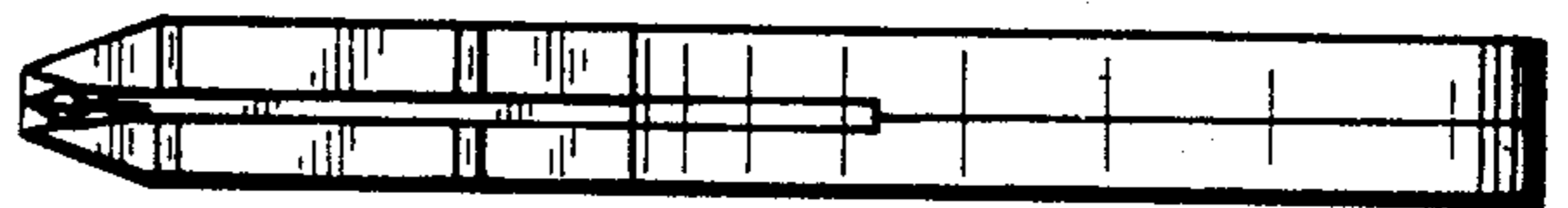

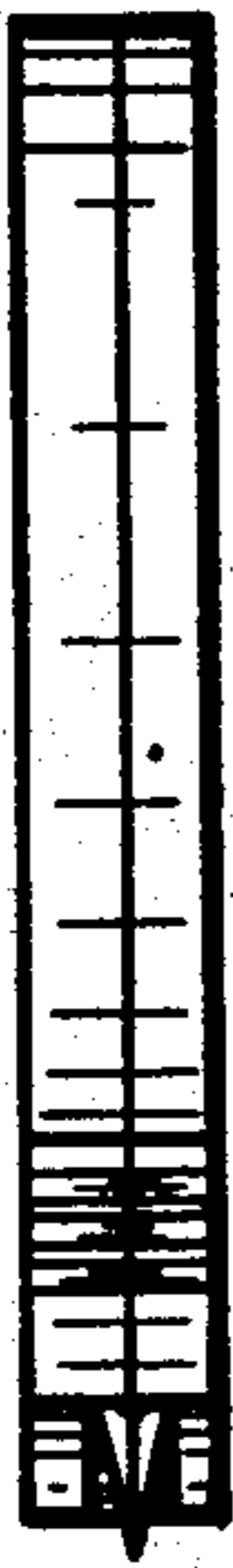

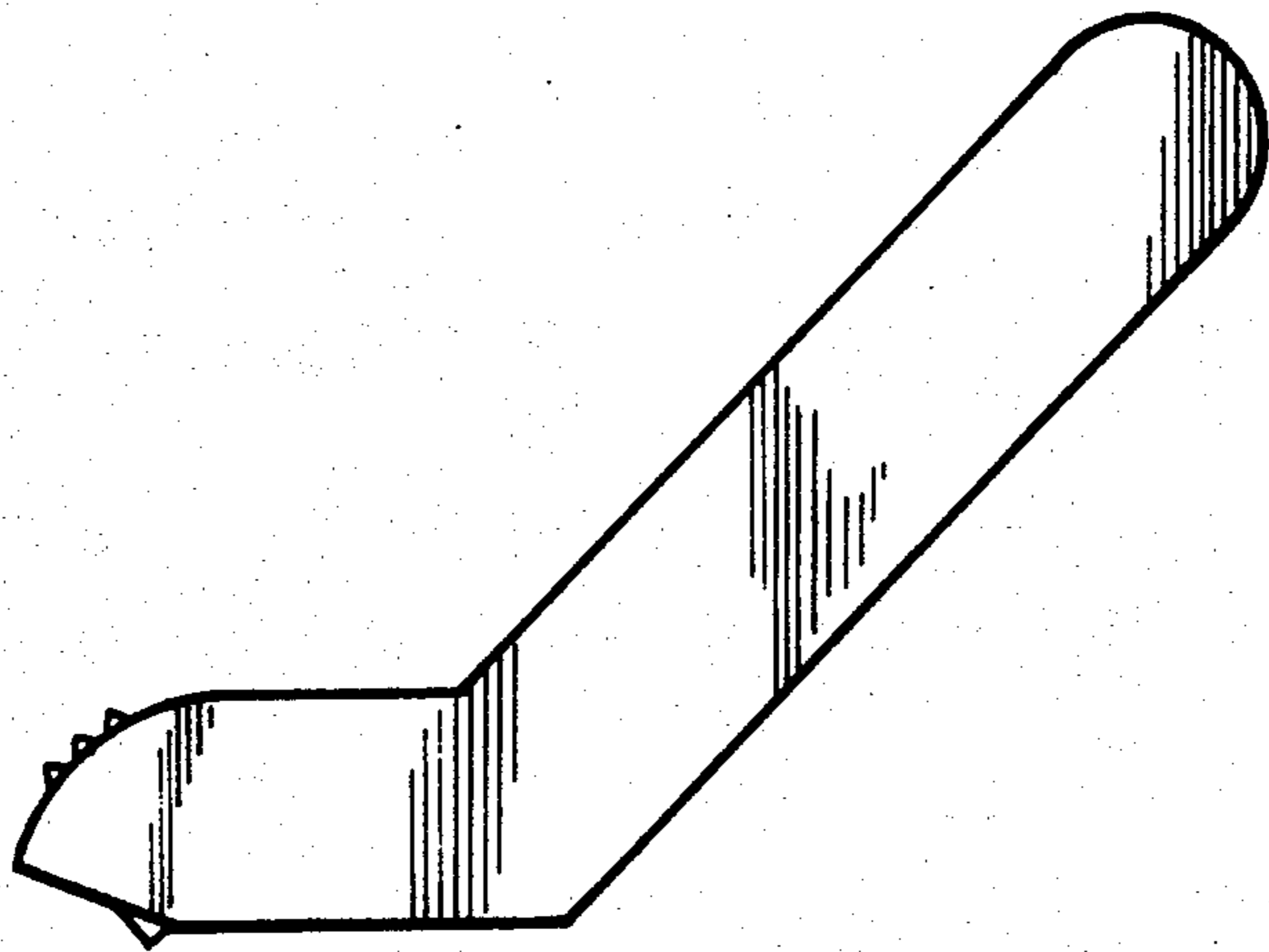

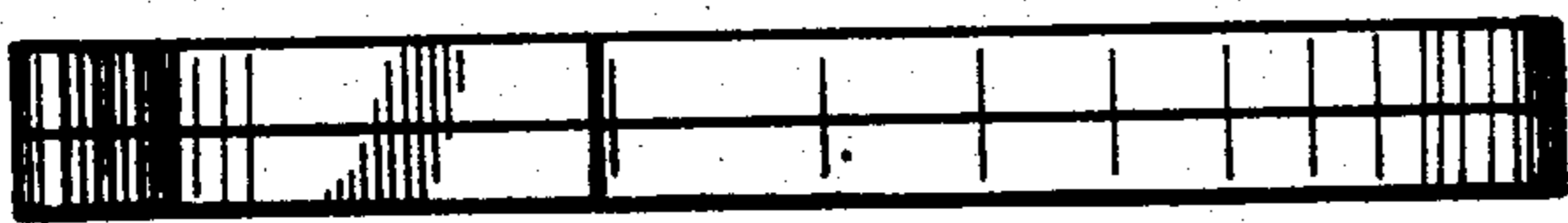
