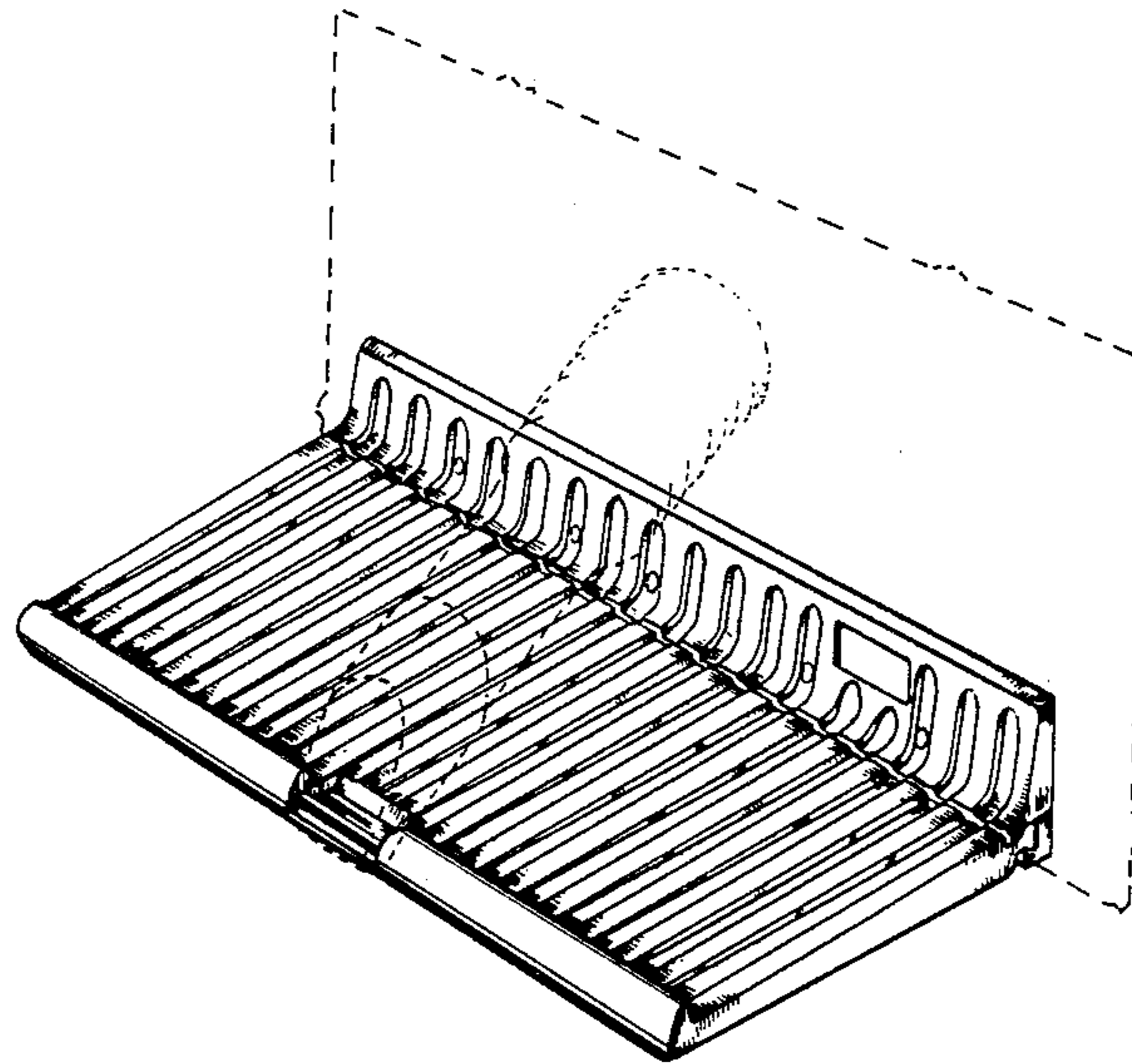

[57] CLAIM

The ornamental design for a boat leveler trim tab, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a boat leveler trim tab showing our new design, the broken lines being for illustrative purposes only and form no part of the claimed design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a front elevation view thereof;  
FIG. 4 is a bottom plan view thereof;  
FIG. 5 is a rear elevation view thereof;  
FIG. 6 is a side elevational view thereof;  
FIG. 7 is a fragmentary sectional view thereof taken along line 7—7 in FIG. 2;  
FIG. 8 is a fragmentary sectional view thereof taken along line 8—8 in FIG. 2; and  
FIG. 9 is a cross-sectional view thereof taken along line 9—9 in FIG. 2.



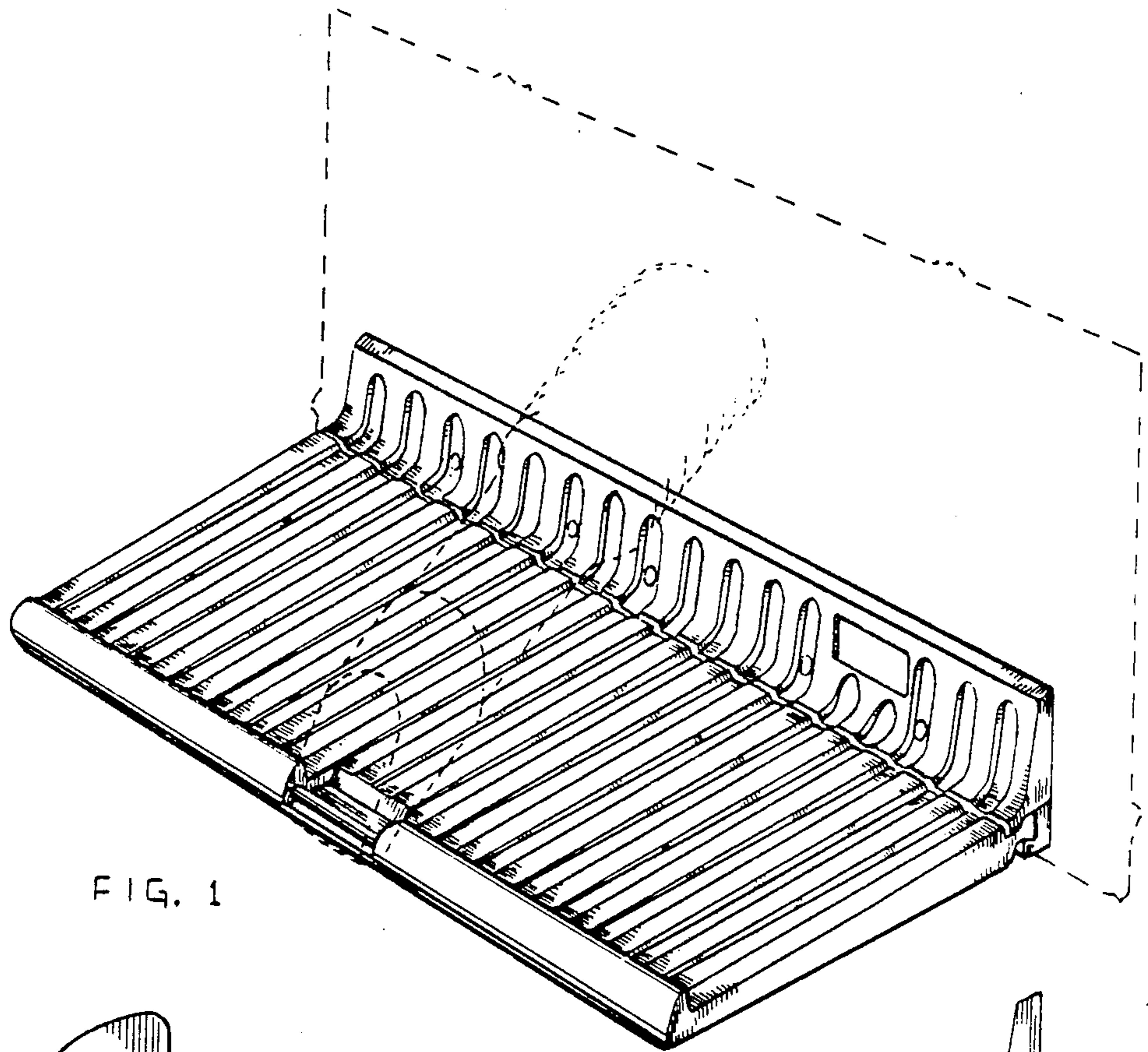

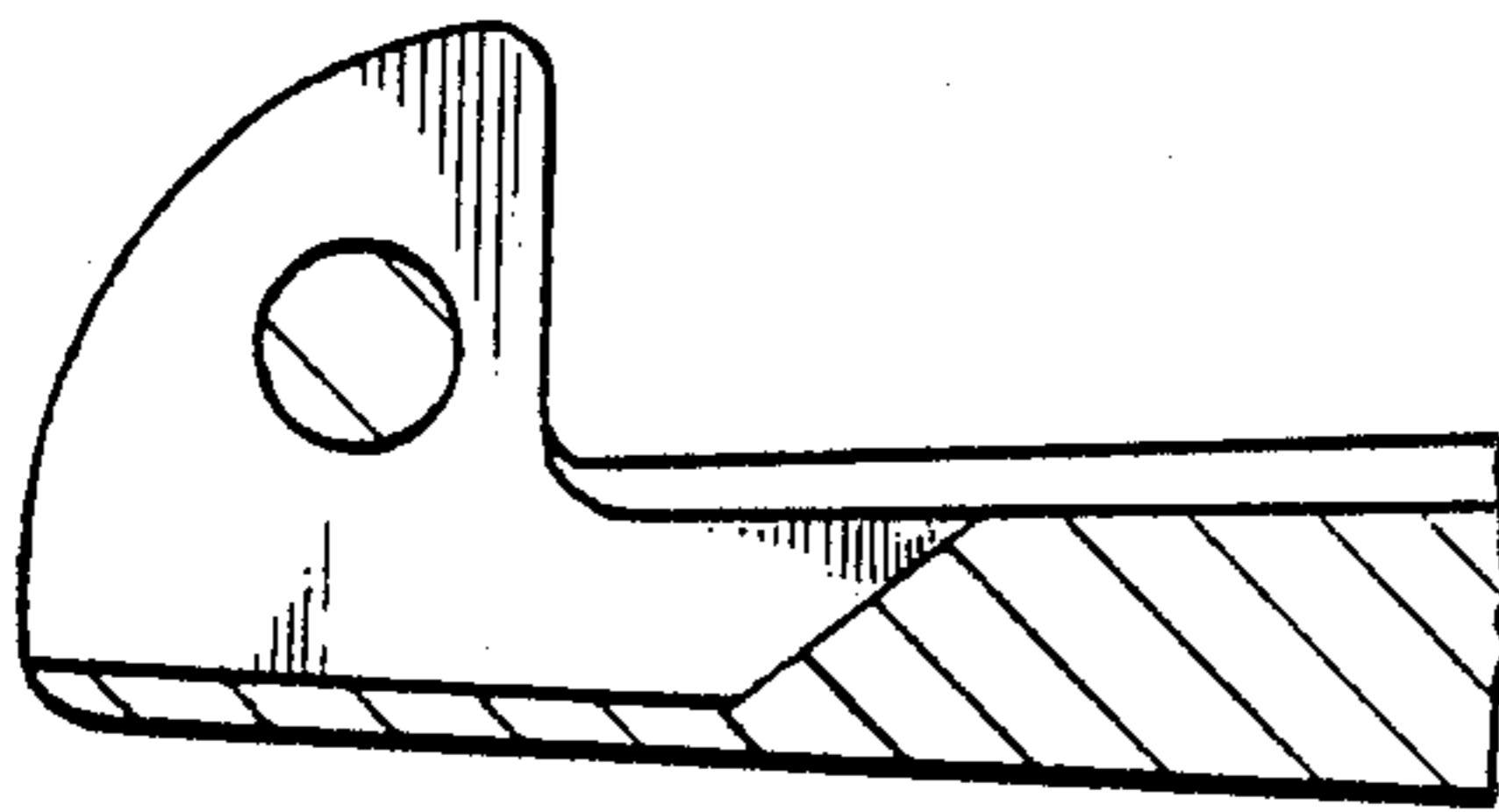

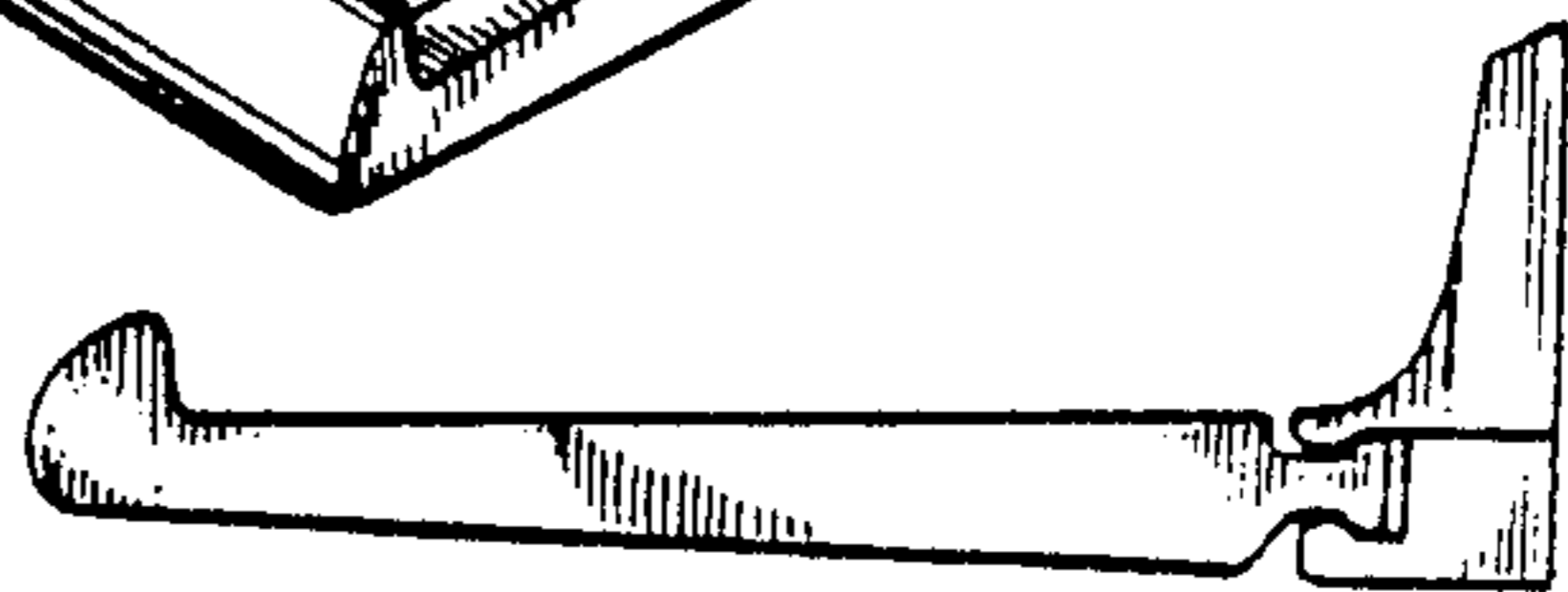

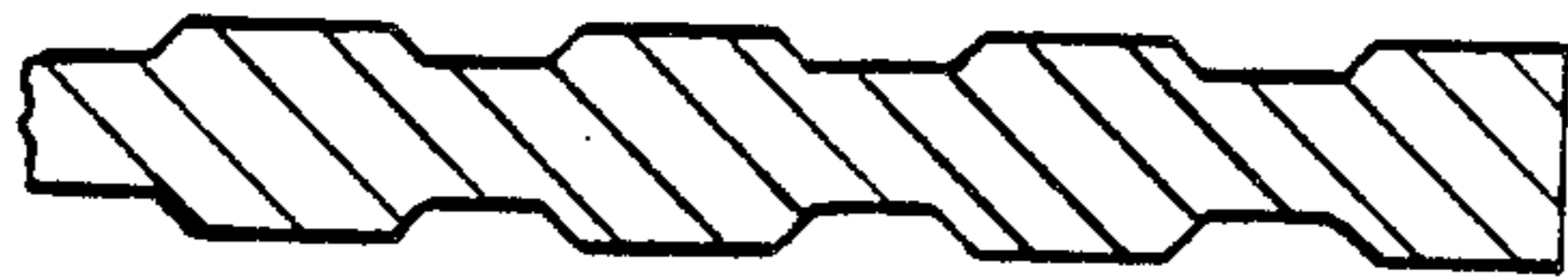

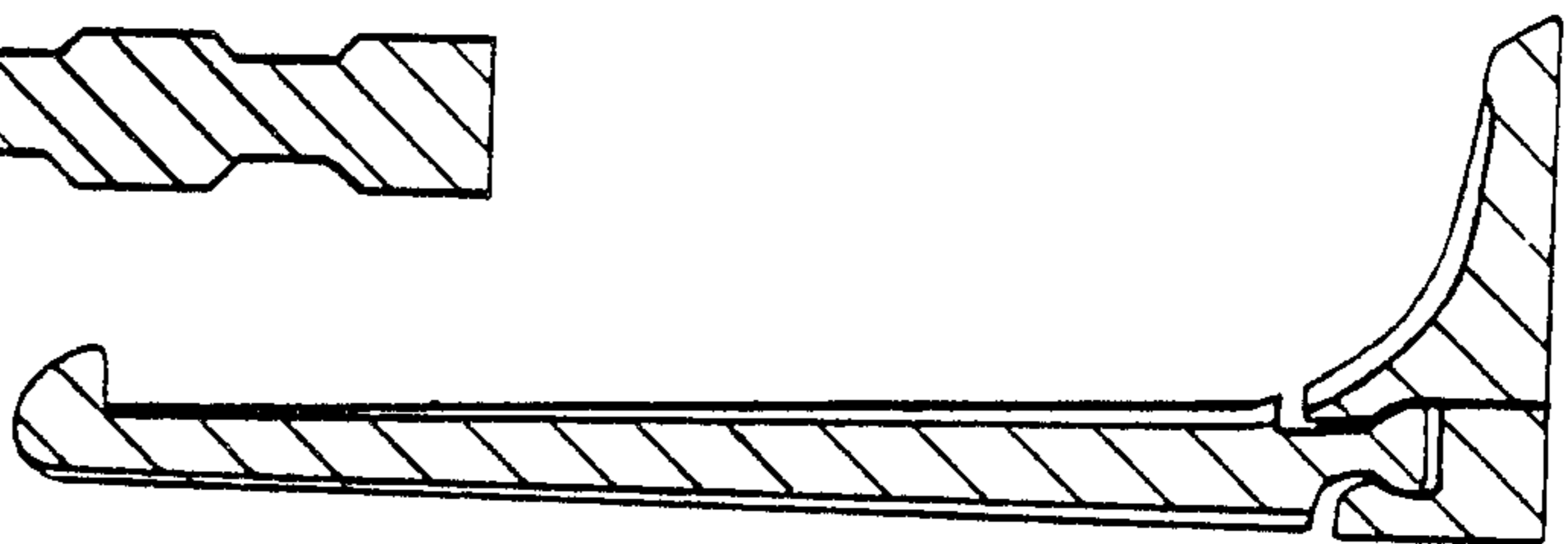

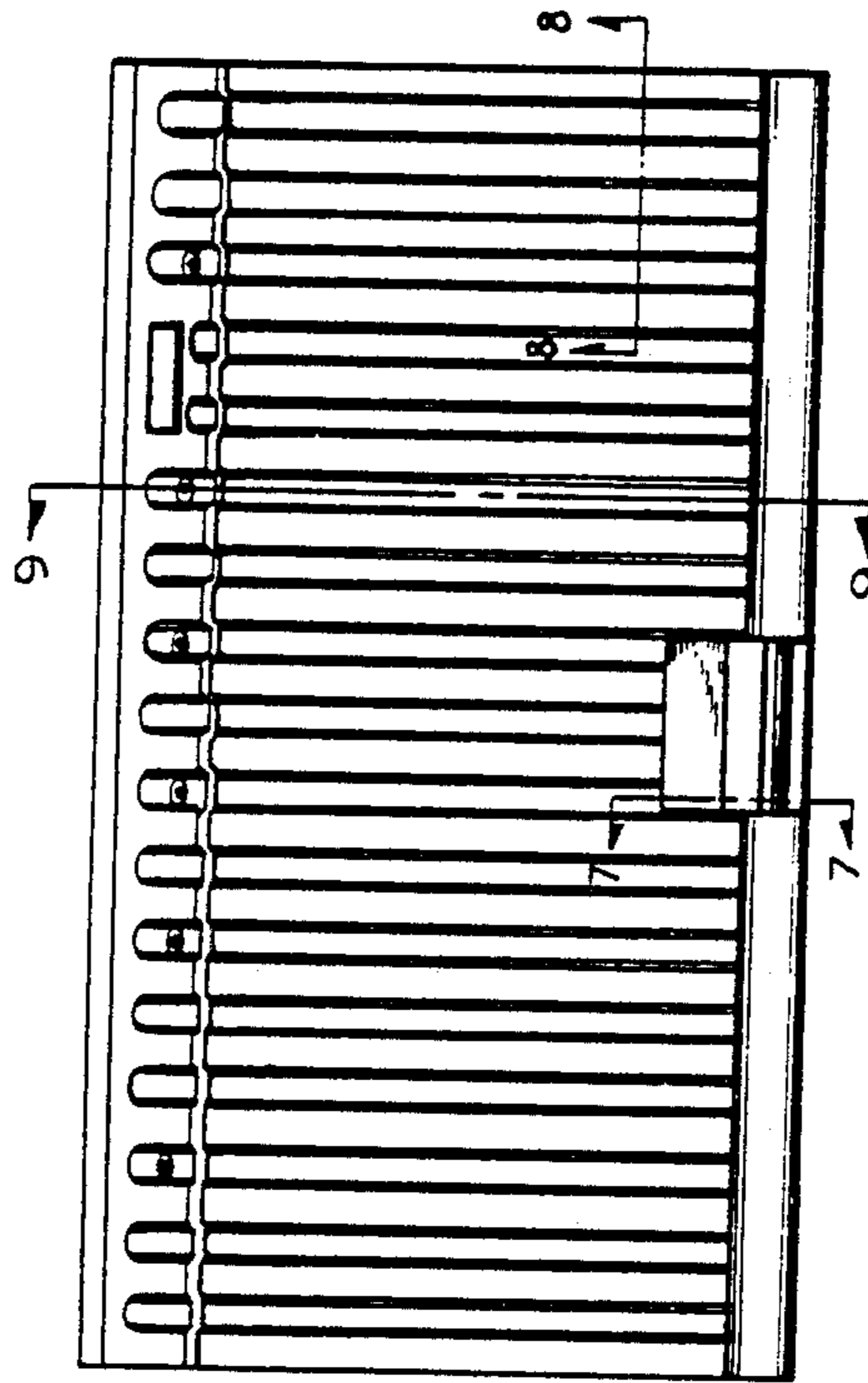

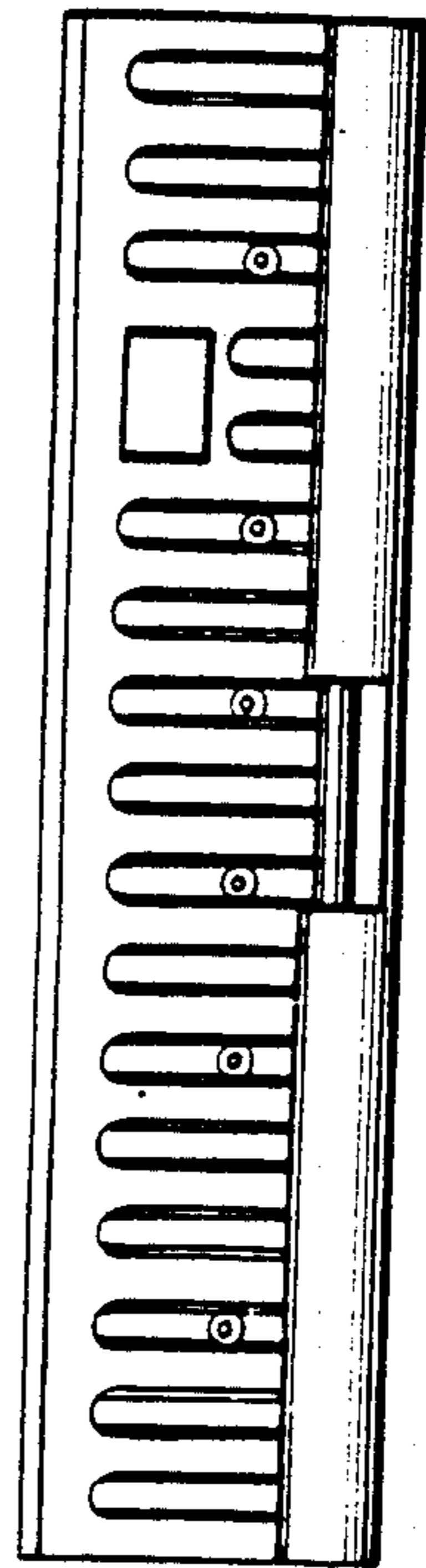

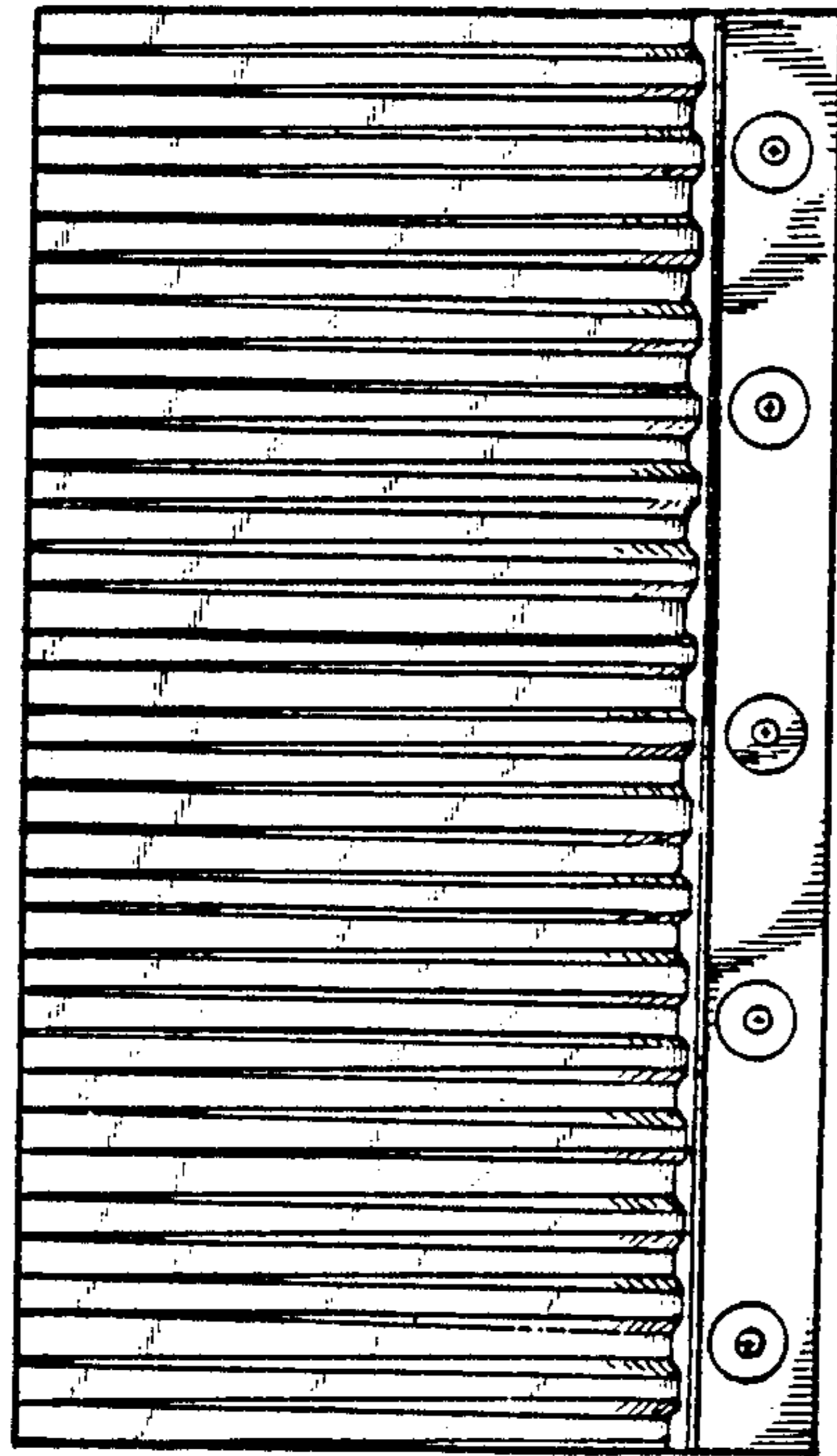

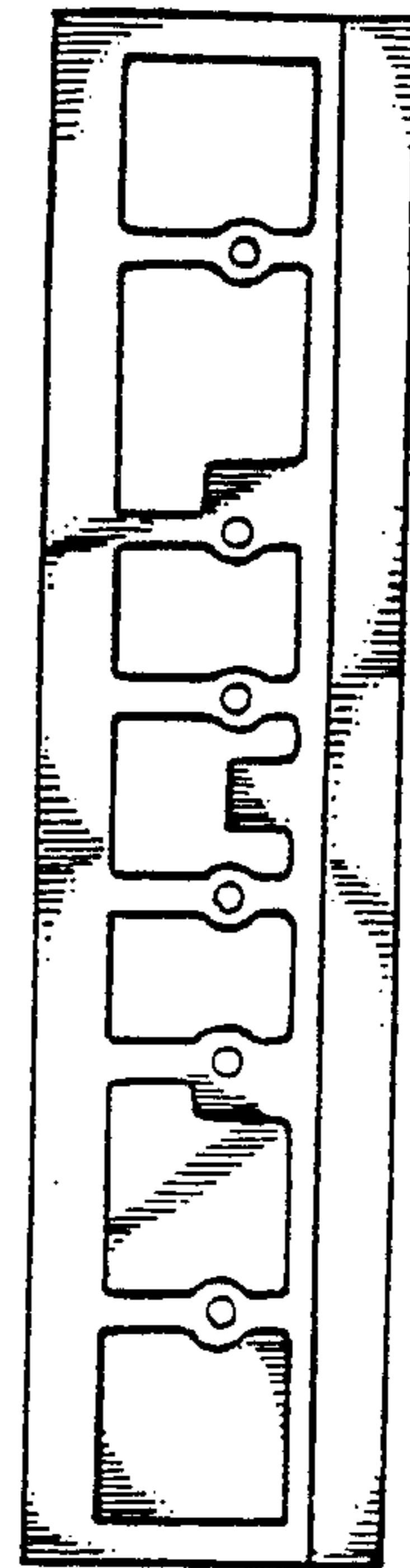
