FIG. 3 is a top plan view thereof;

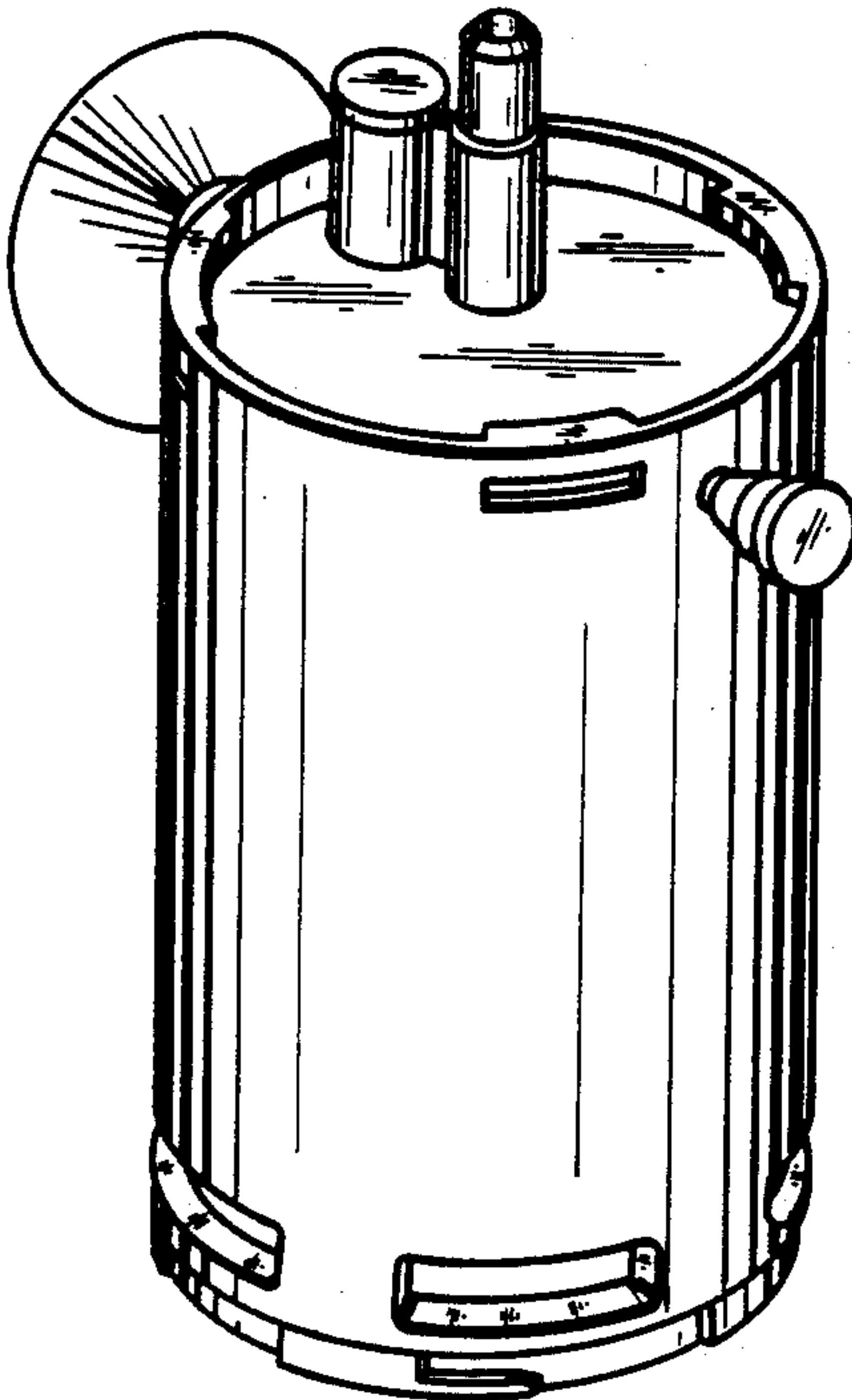
FIG. 4 is a bottom plan view thereof;

FIG. 8 is a vertical sectional view thereof, taken in the direction of line 8—8 of FIG. 3.



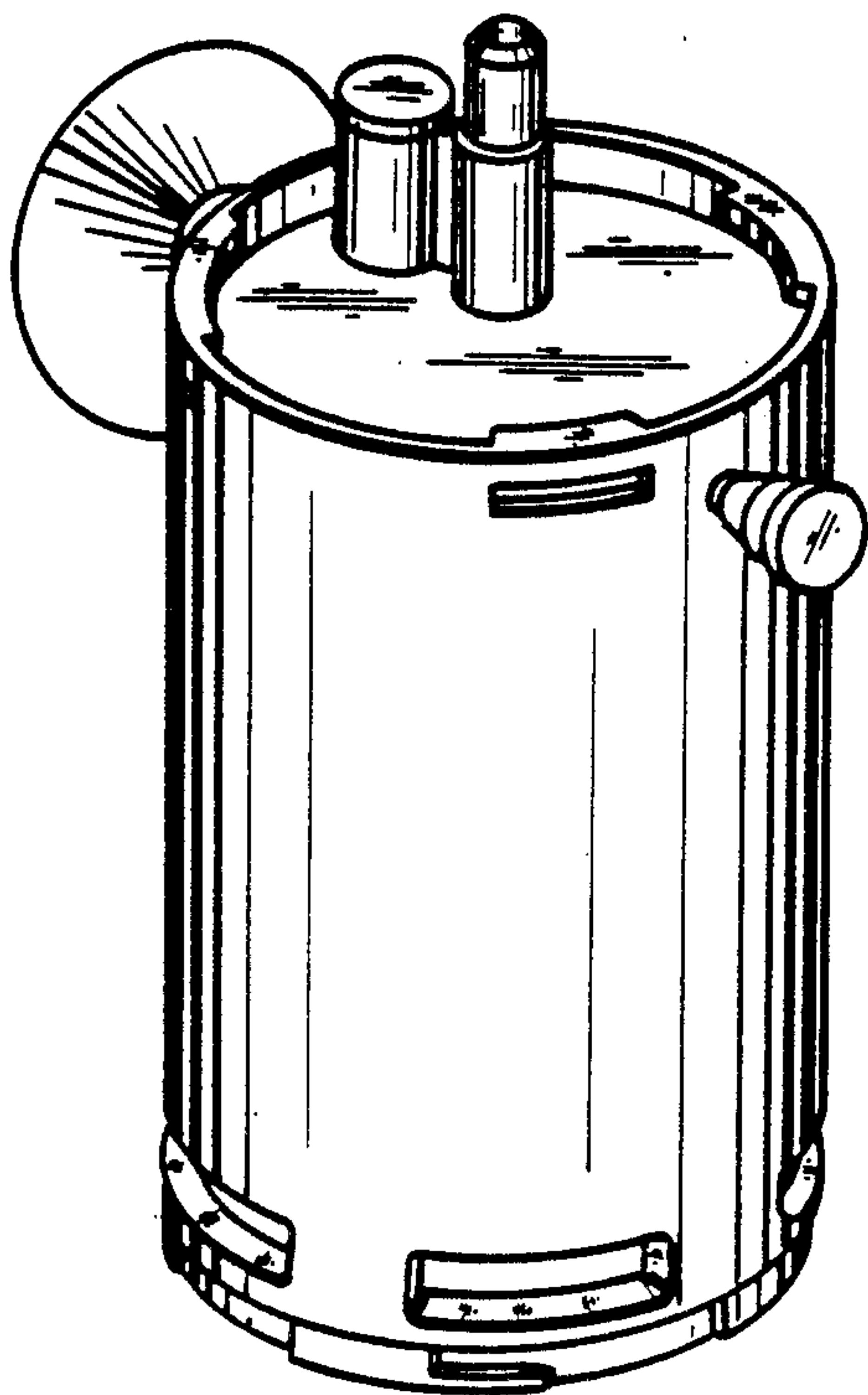

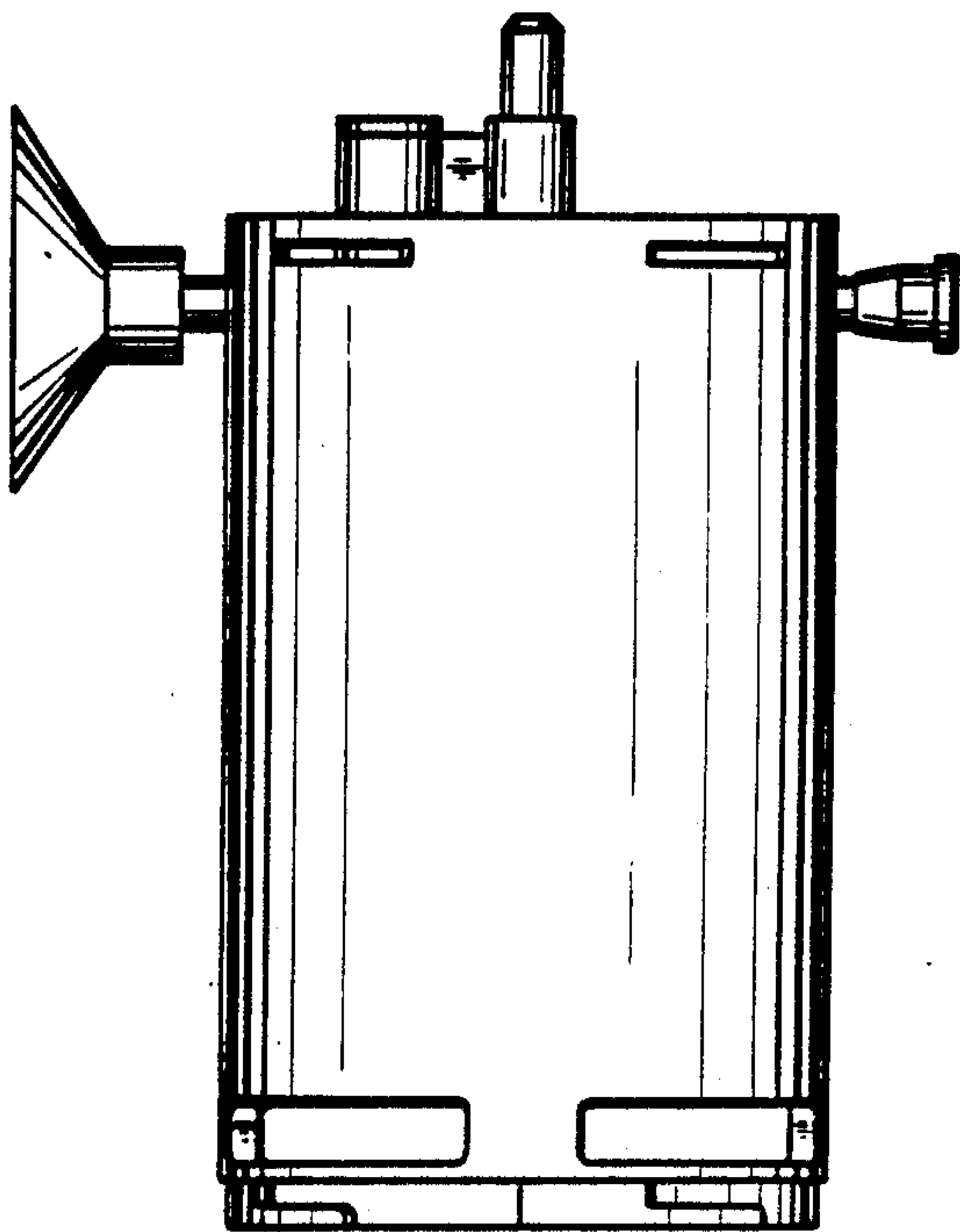

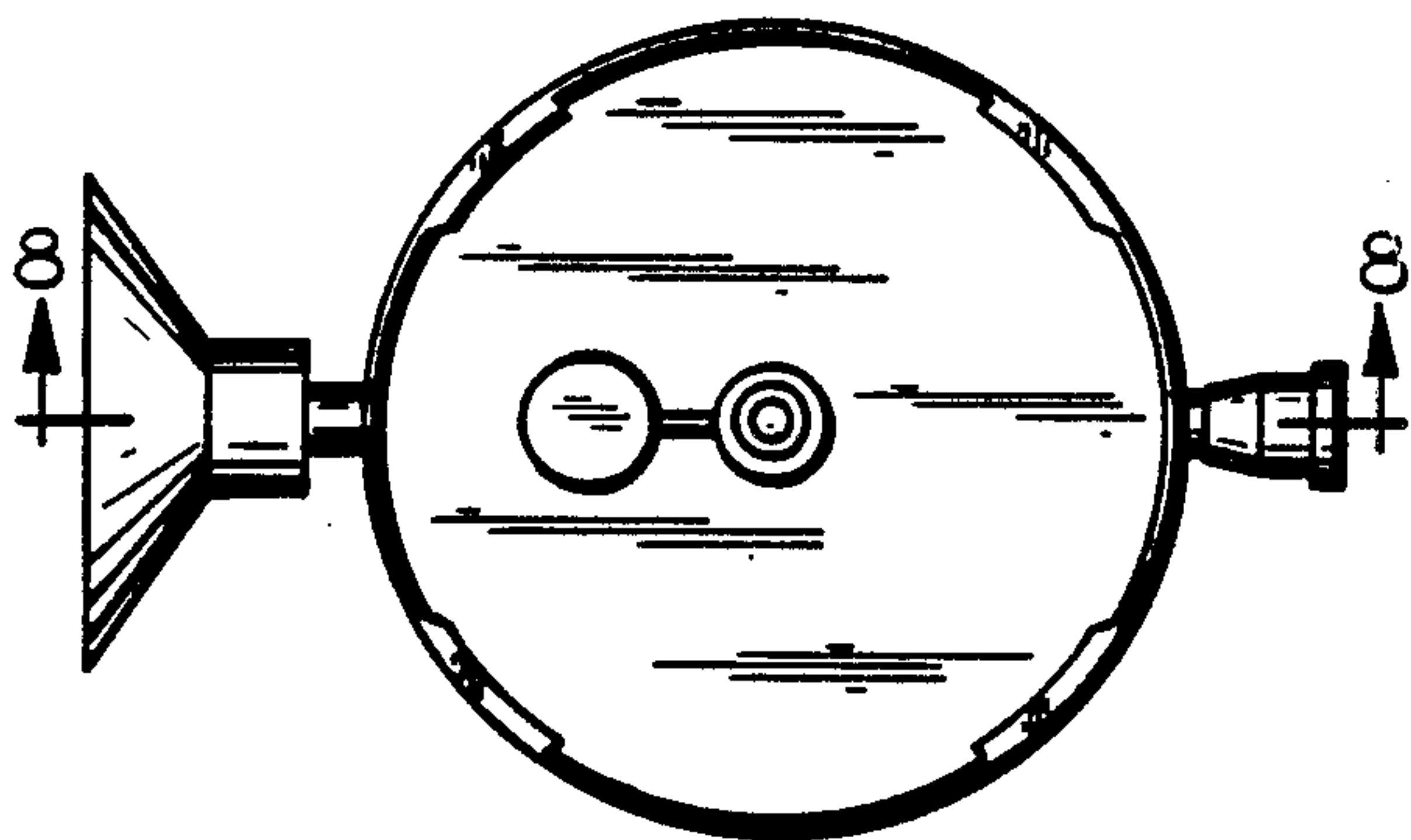

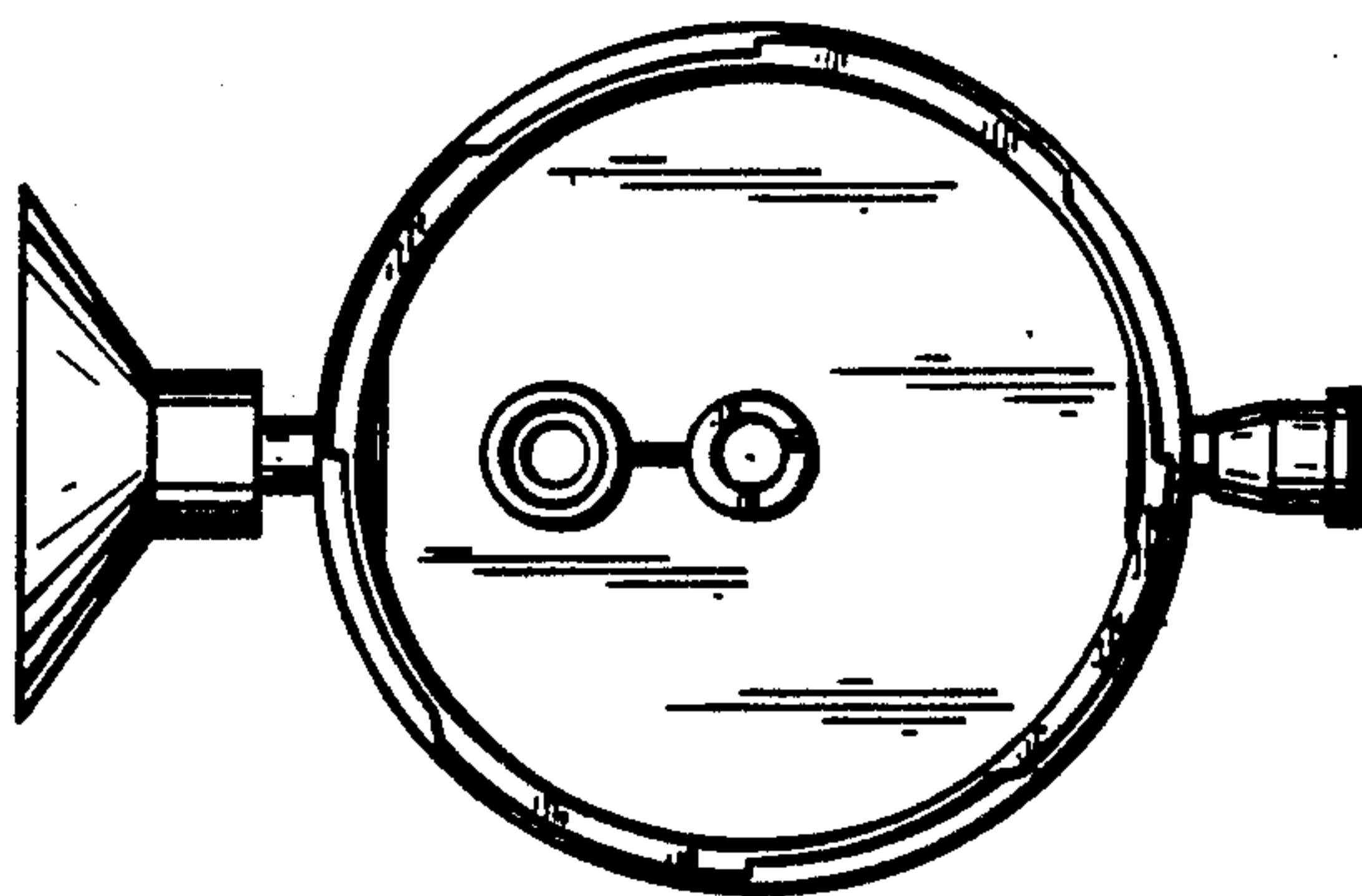

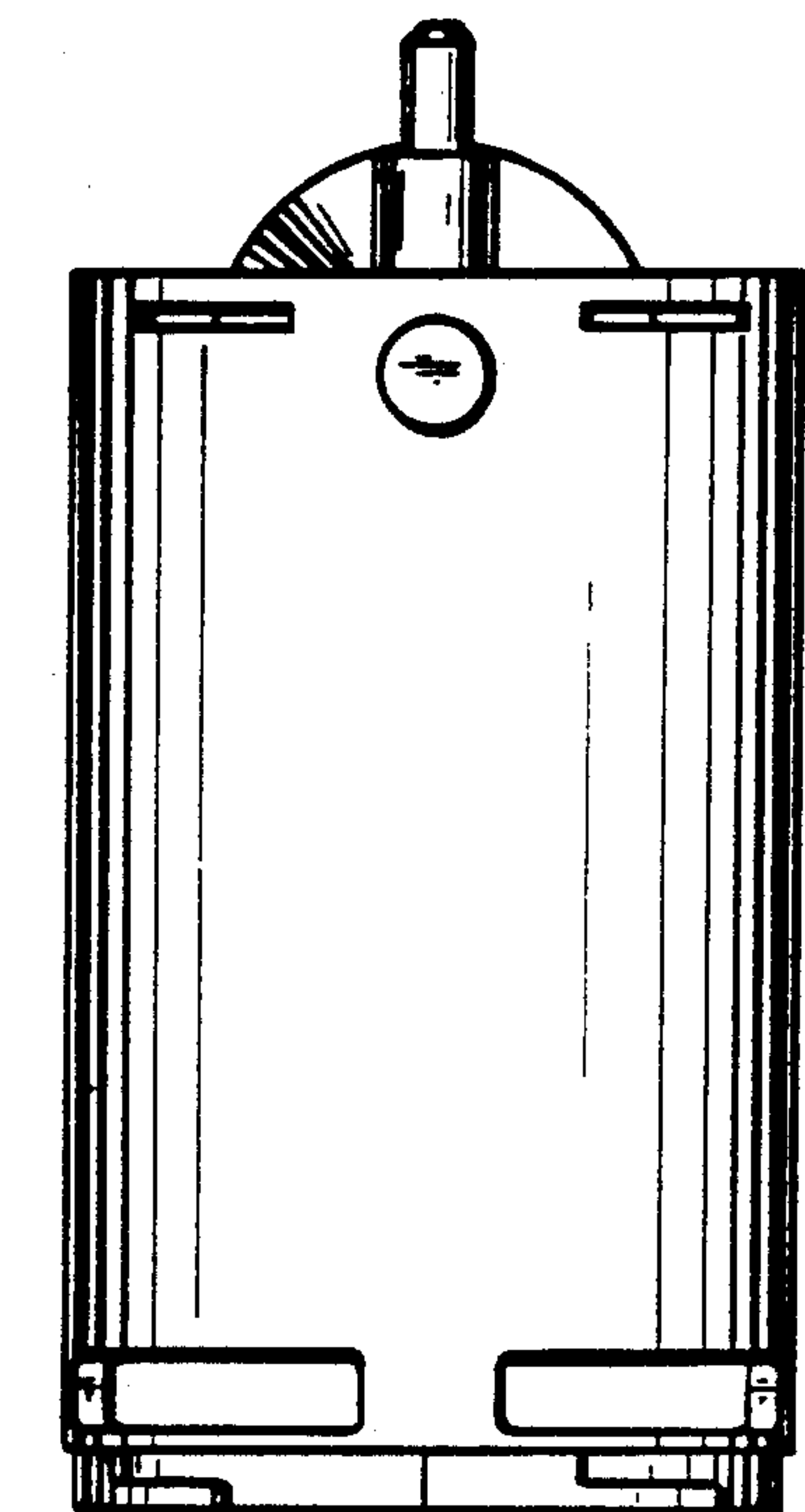

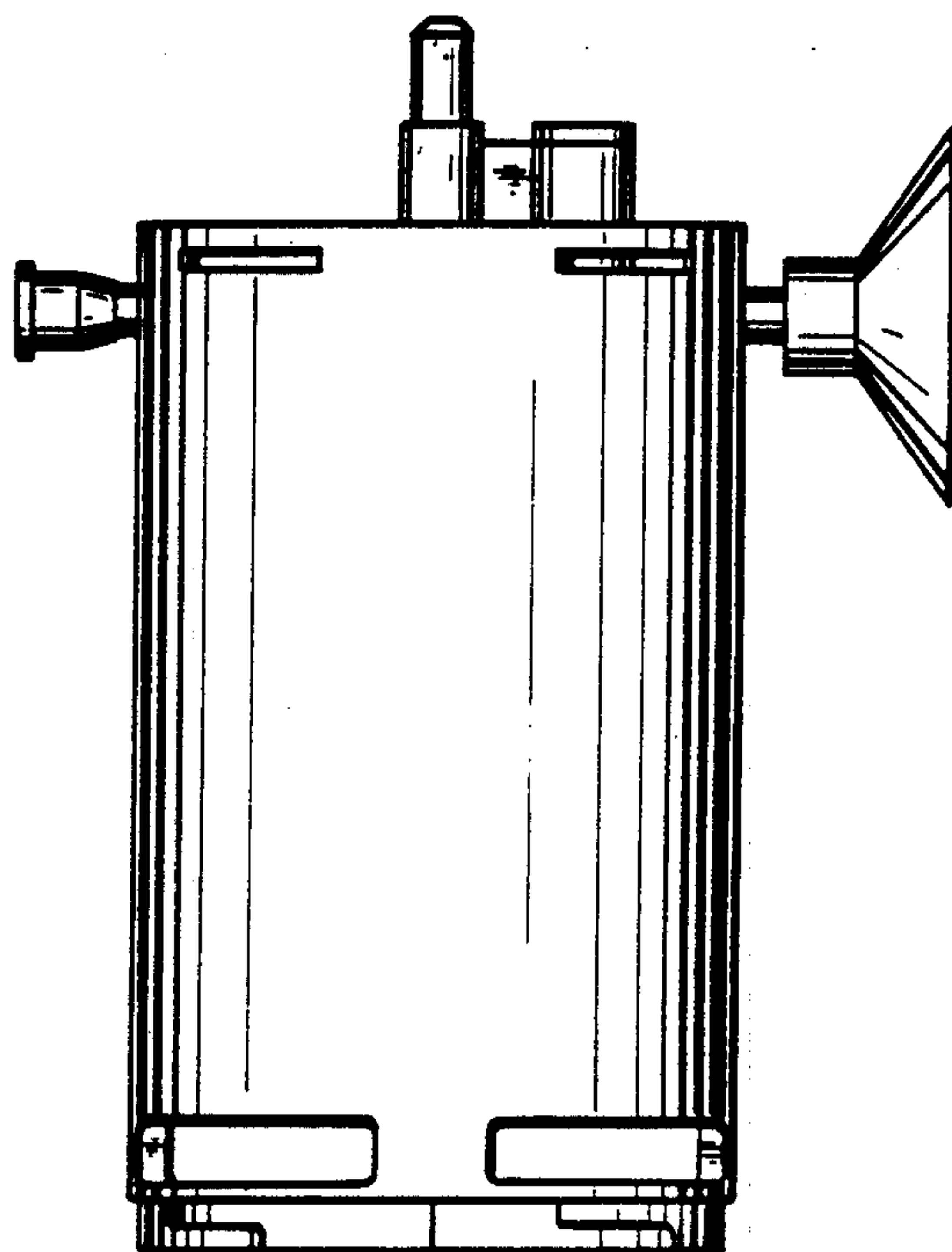

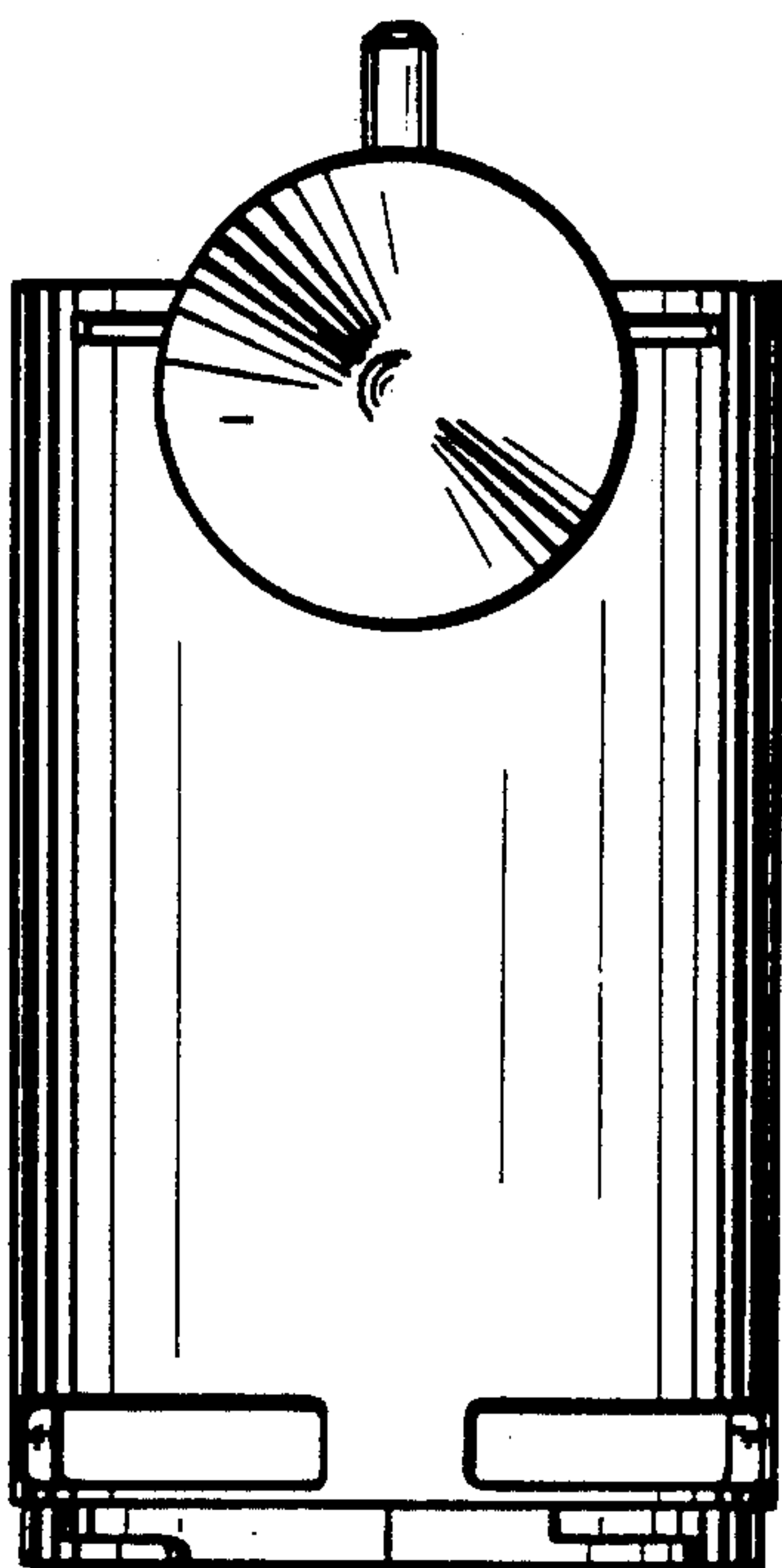

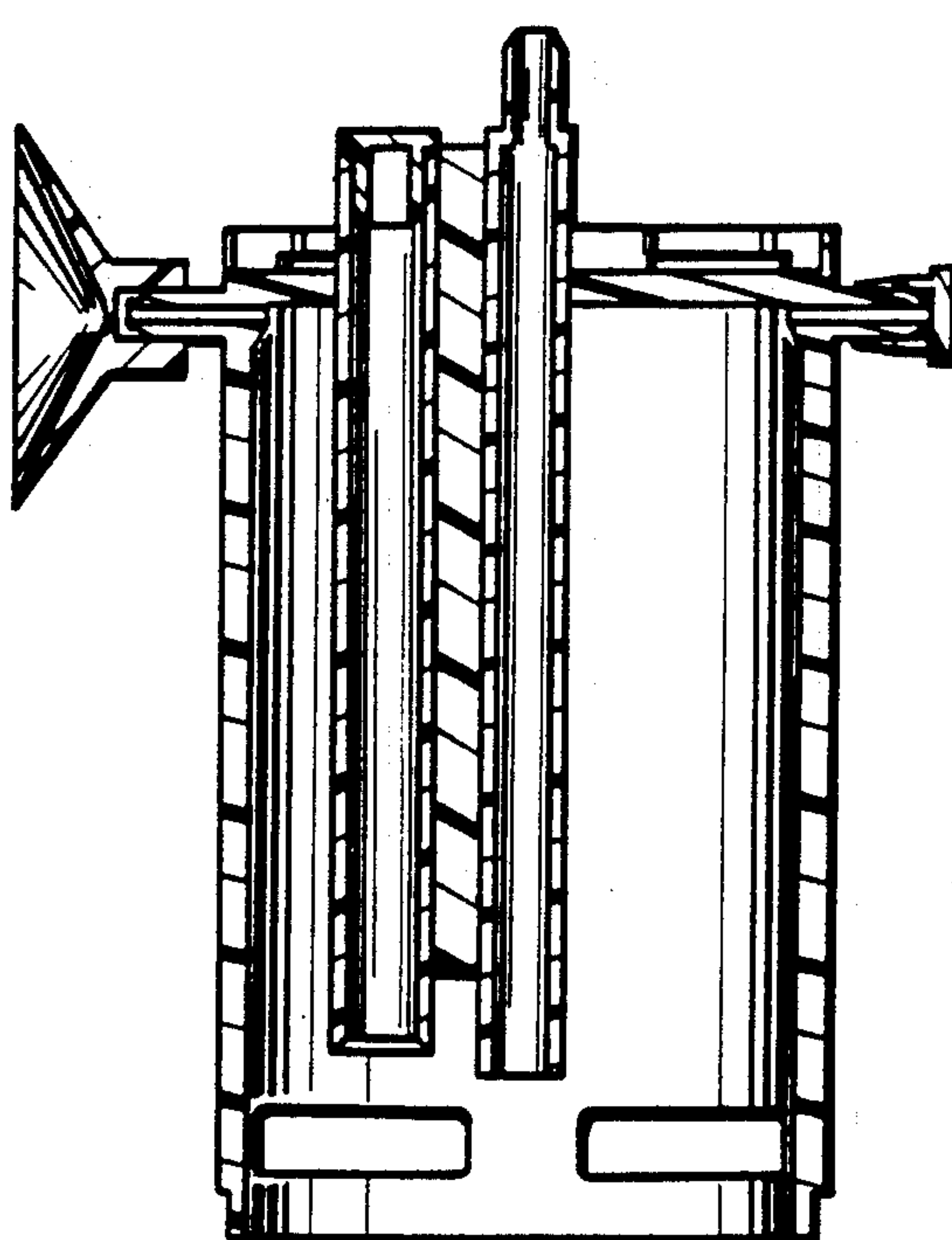
