[57] CLAIM

The ornamental design for a pouring attachment for bottles, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a pouring attachment for bottles, showing our new design;  
FIG. 2 is a rear elevational view thereof;  
FIG. 3 is a right side elevational view thereof, the left side being a mirror image thereof;  
FIG. 4 is a front elevational view thereof;  
FIG. 5 is a bottom plan view thereof; and  
FIG. 6 is a cross-sectional view thereof, taken on line 6—6 of FIG. 1.

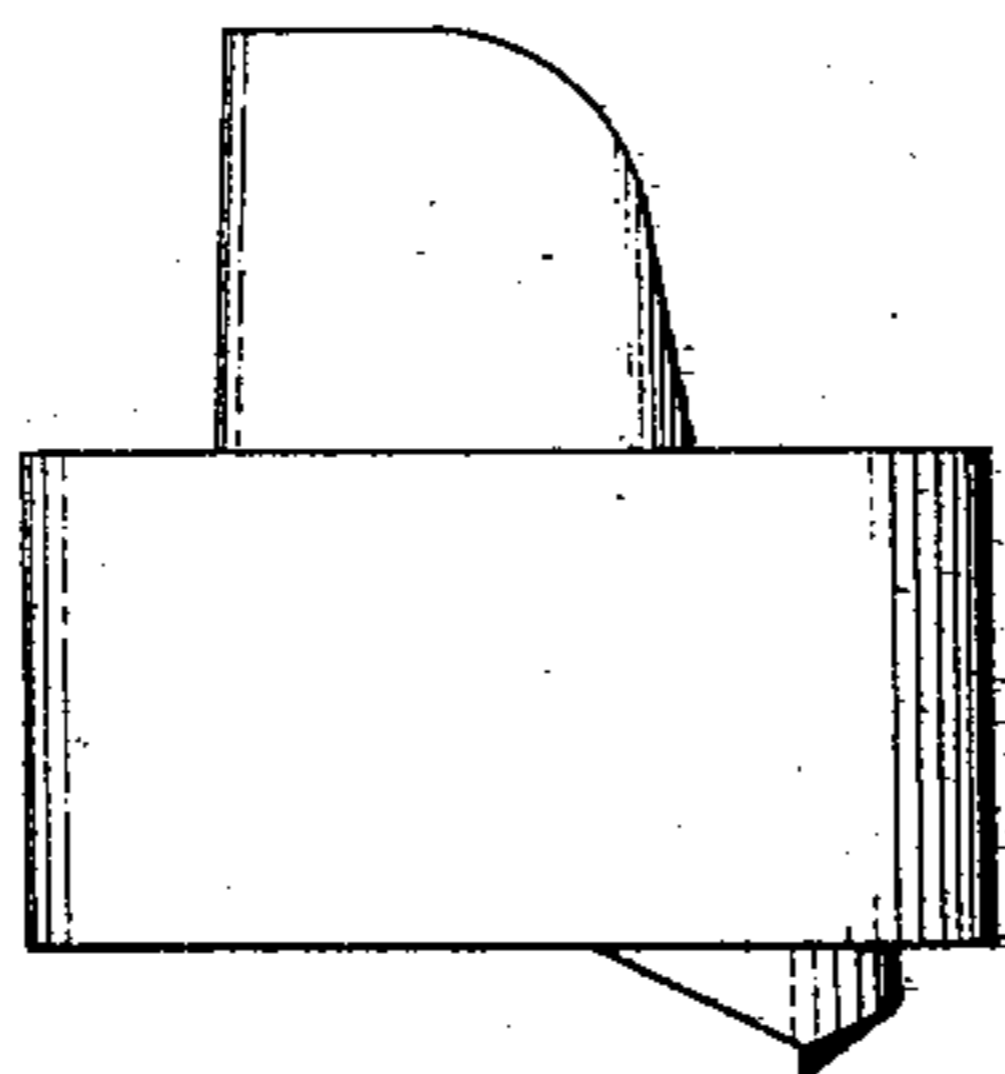
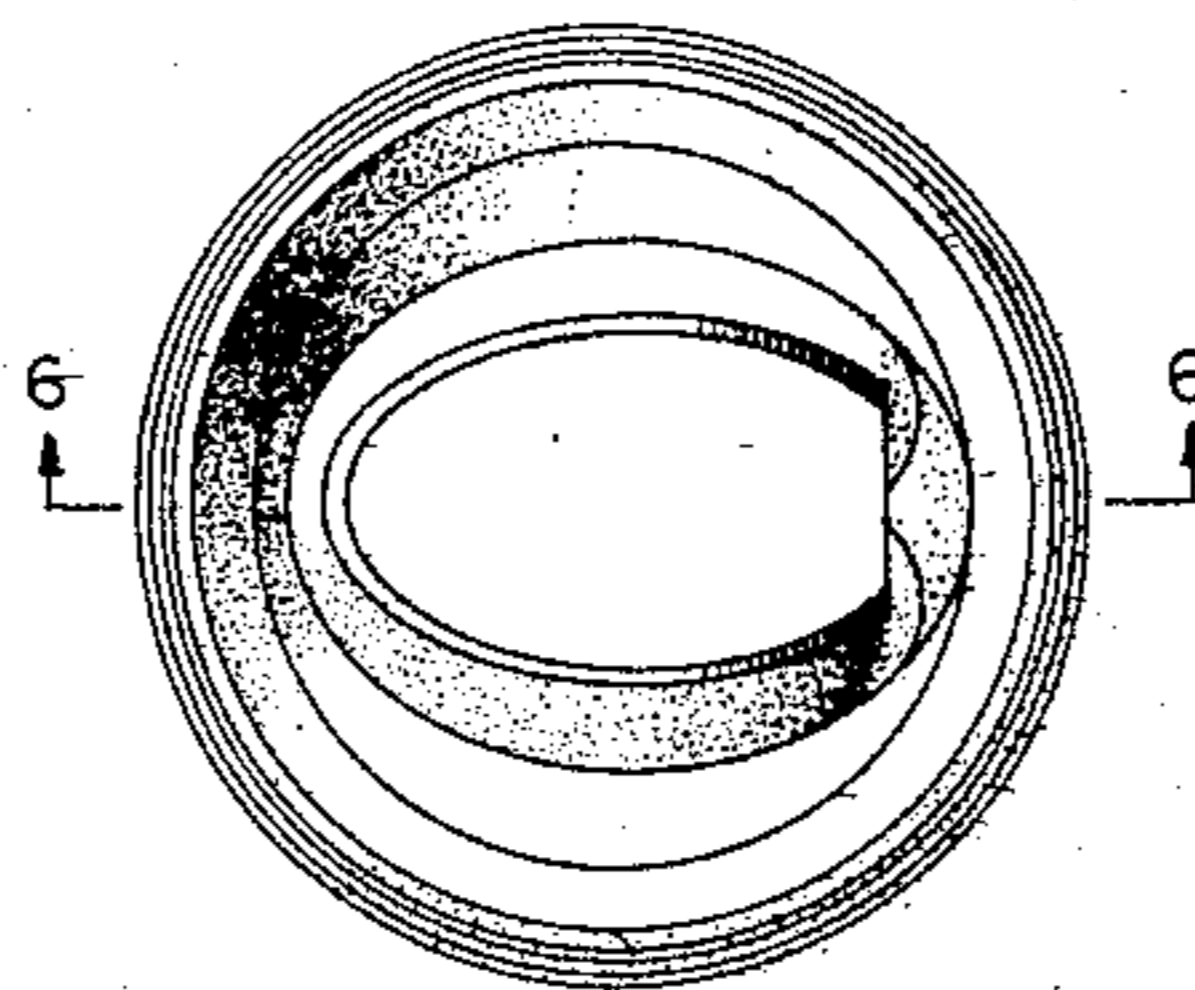

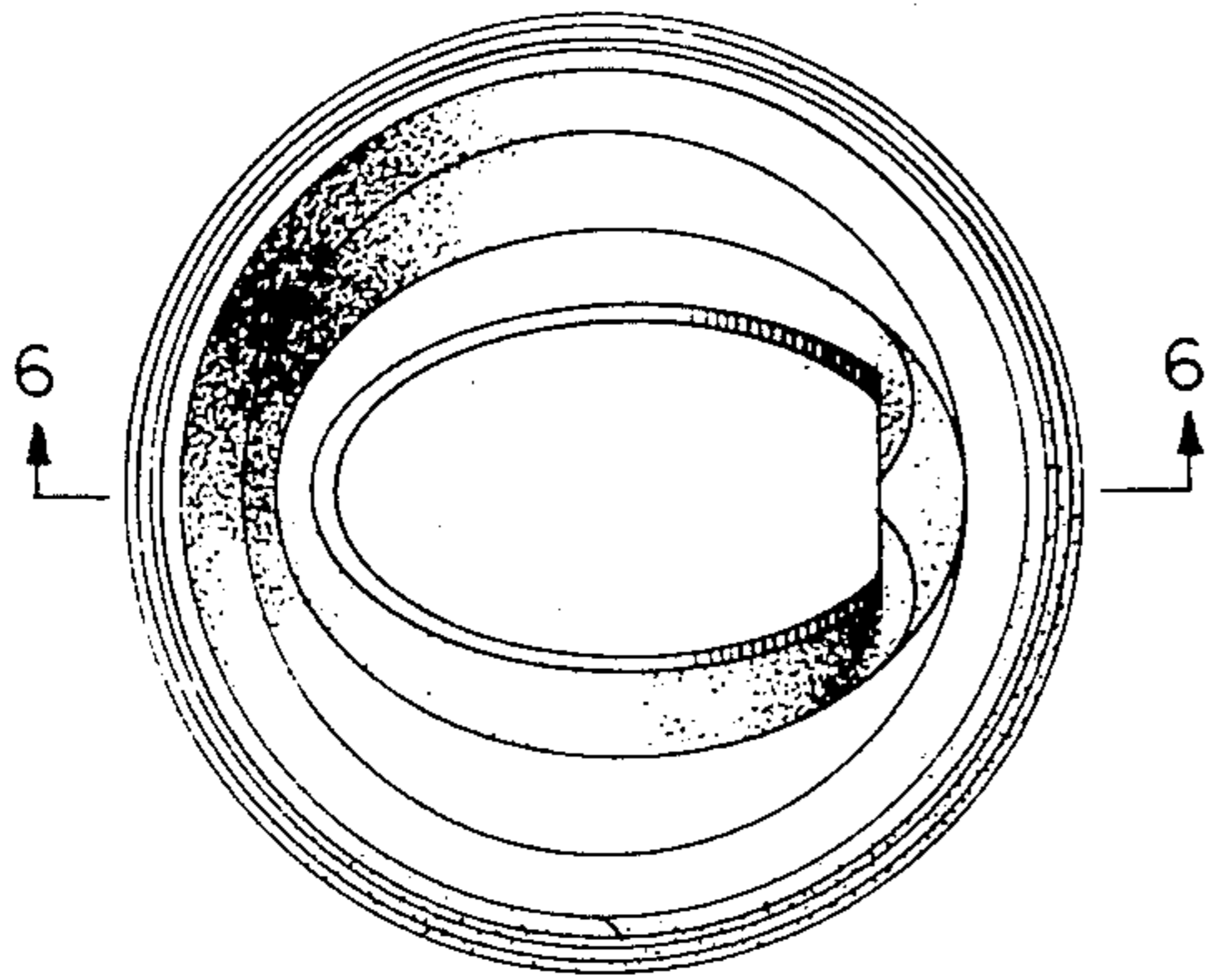

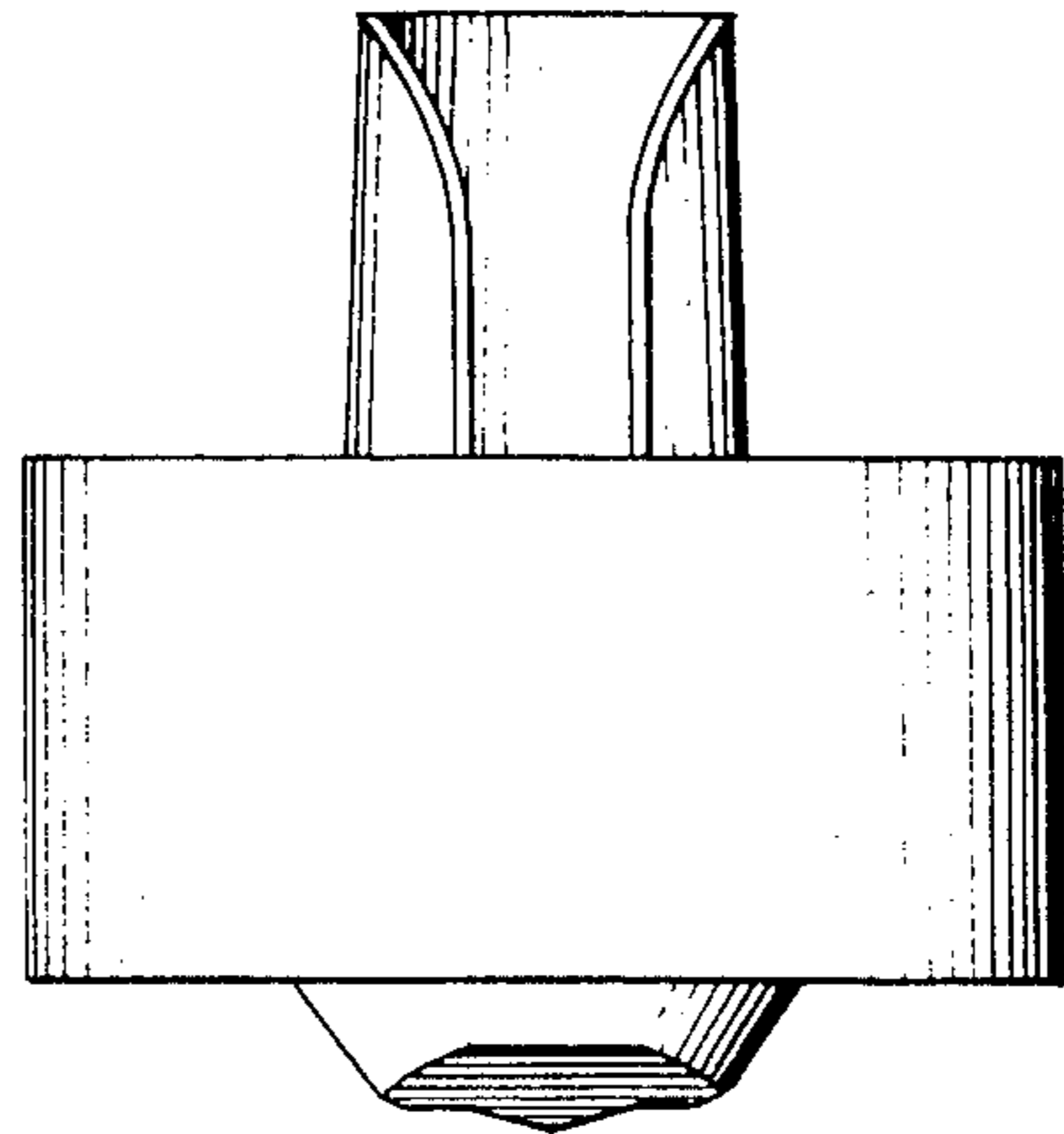

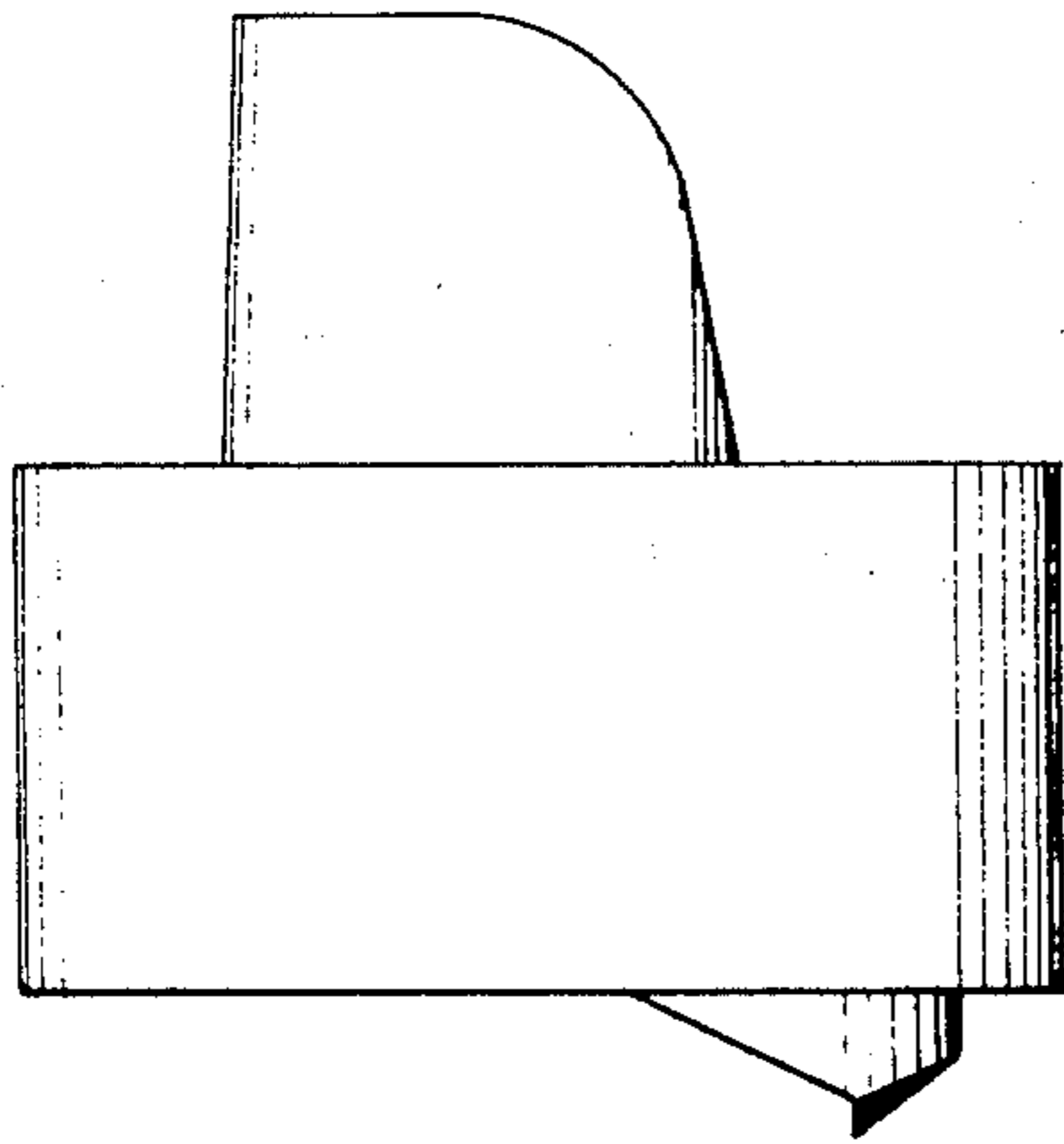

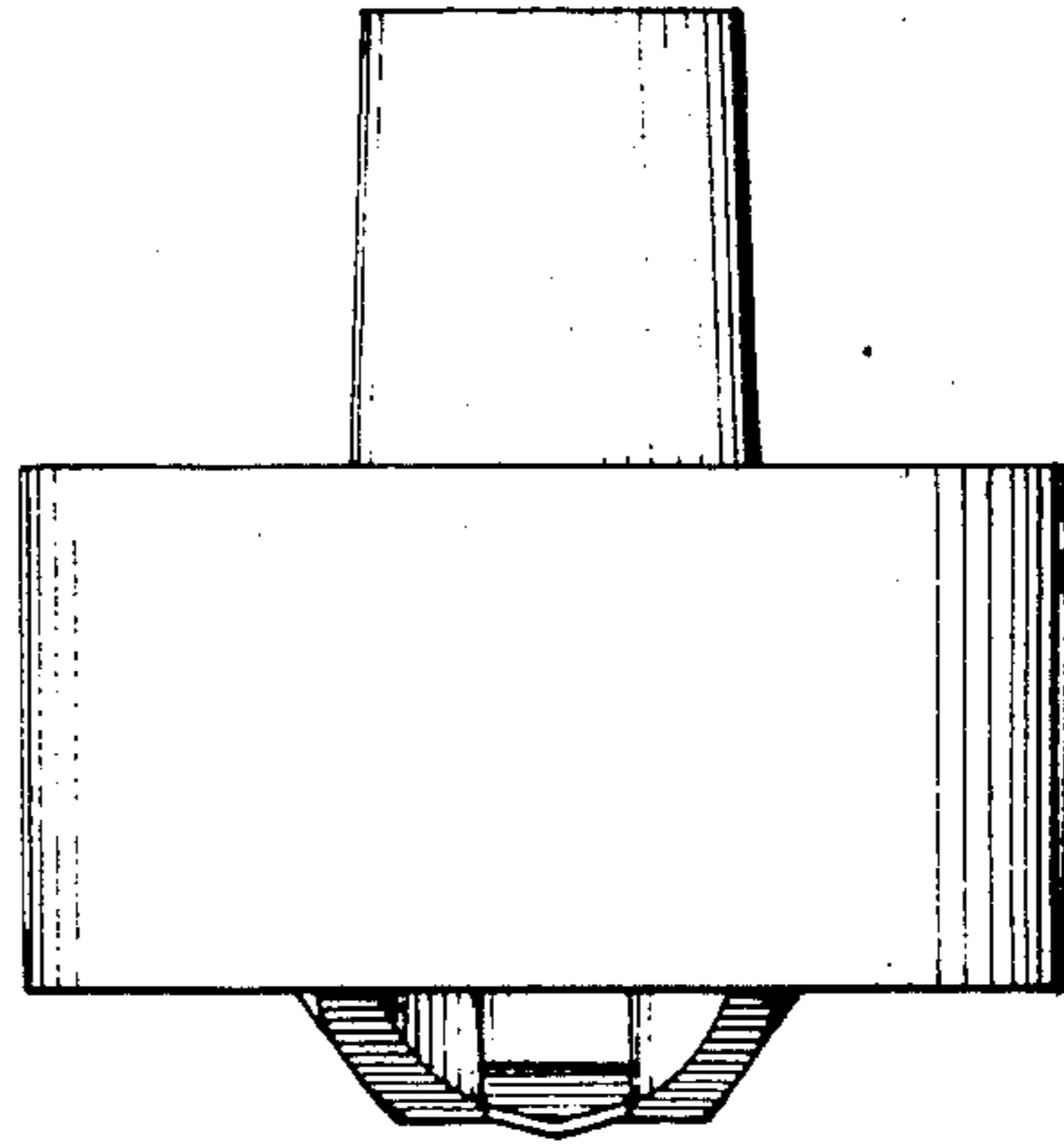

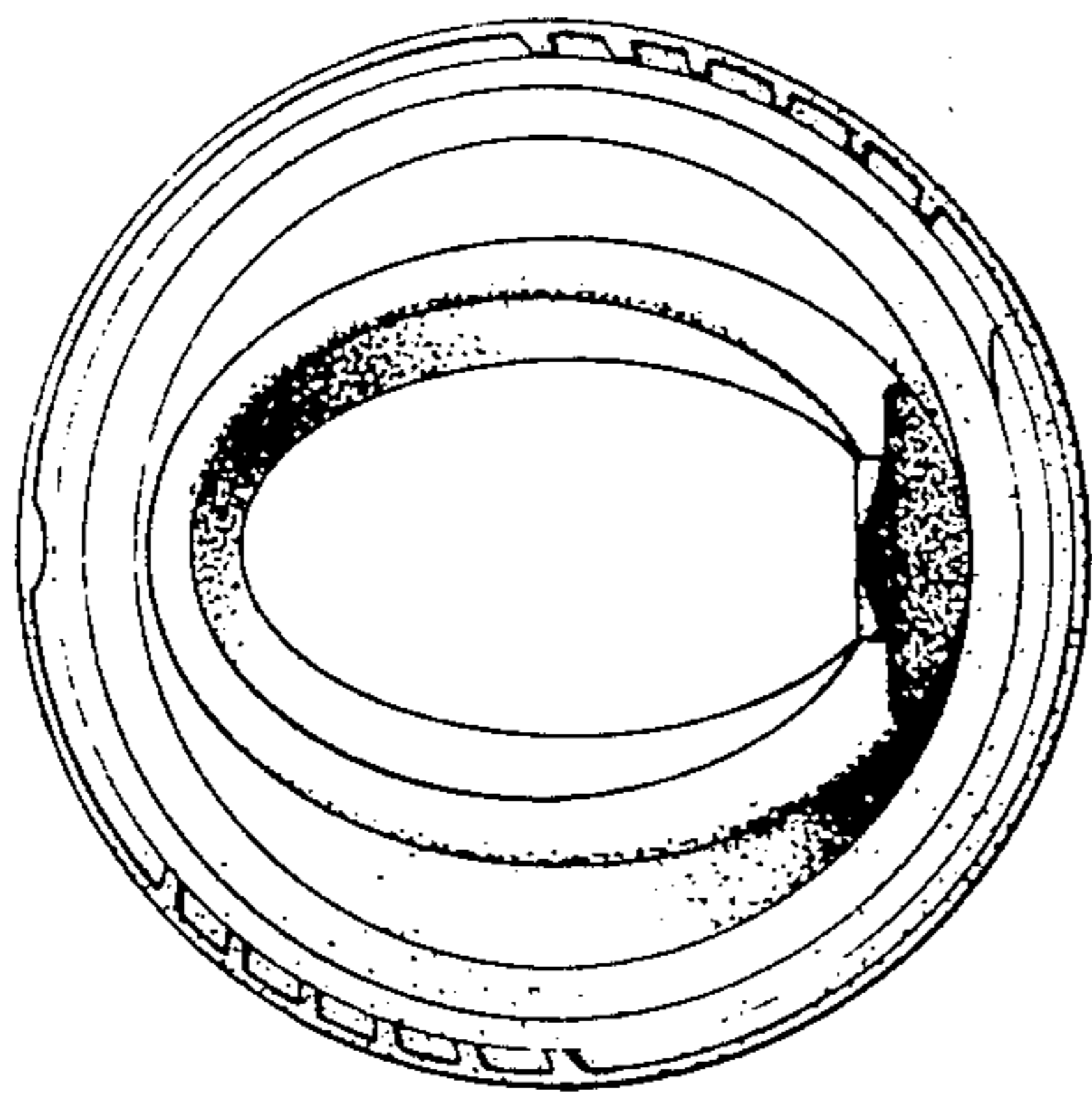
