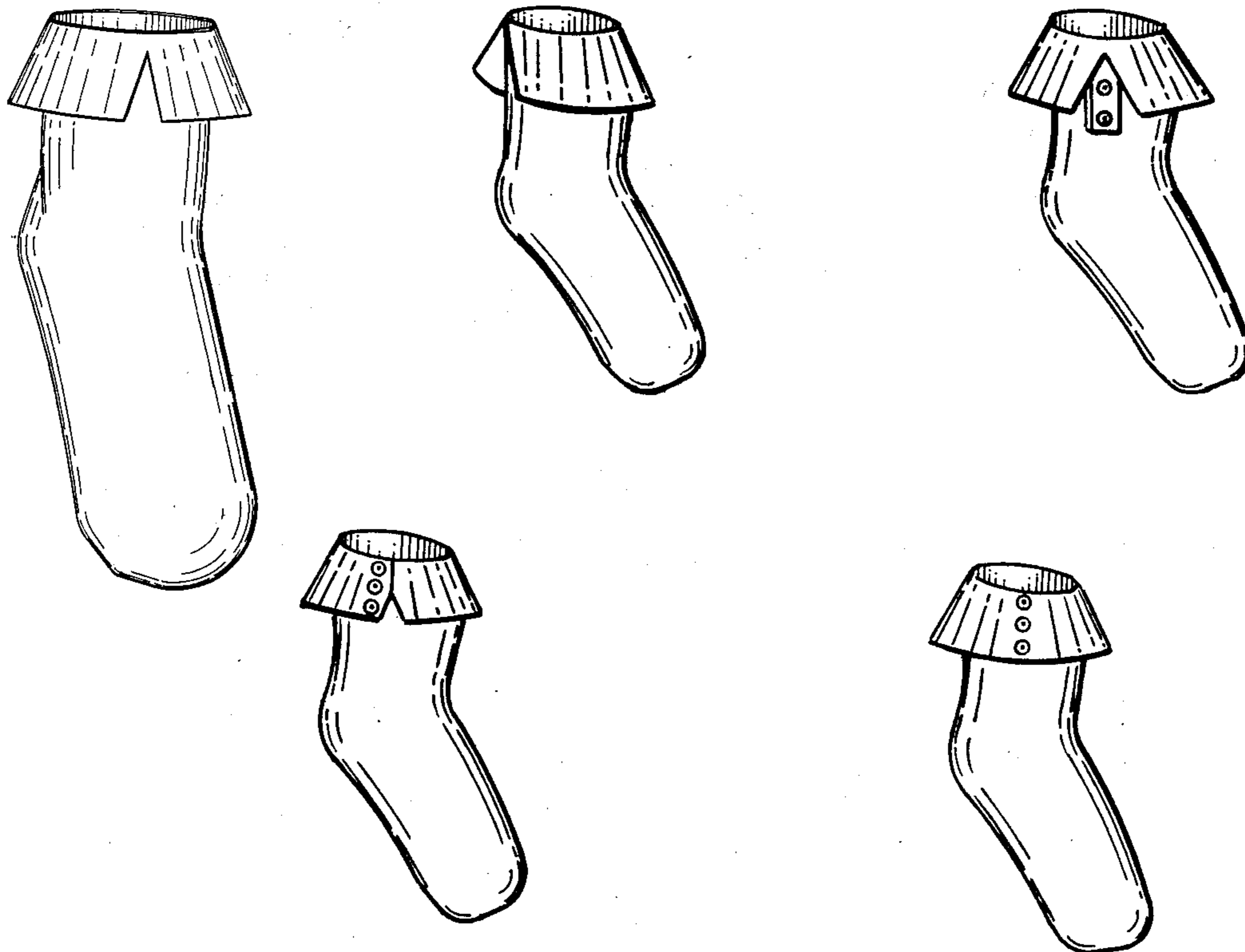

DESCRIPTION

FIG. 22 is a bottom plan view of that shown in FIG. 8.



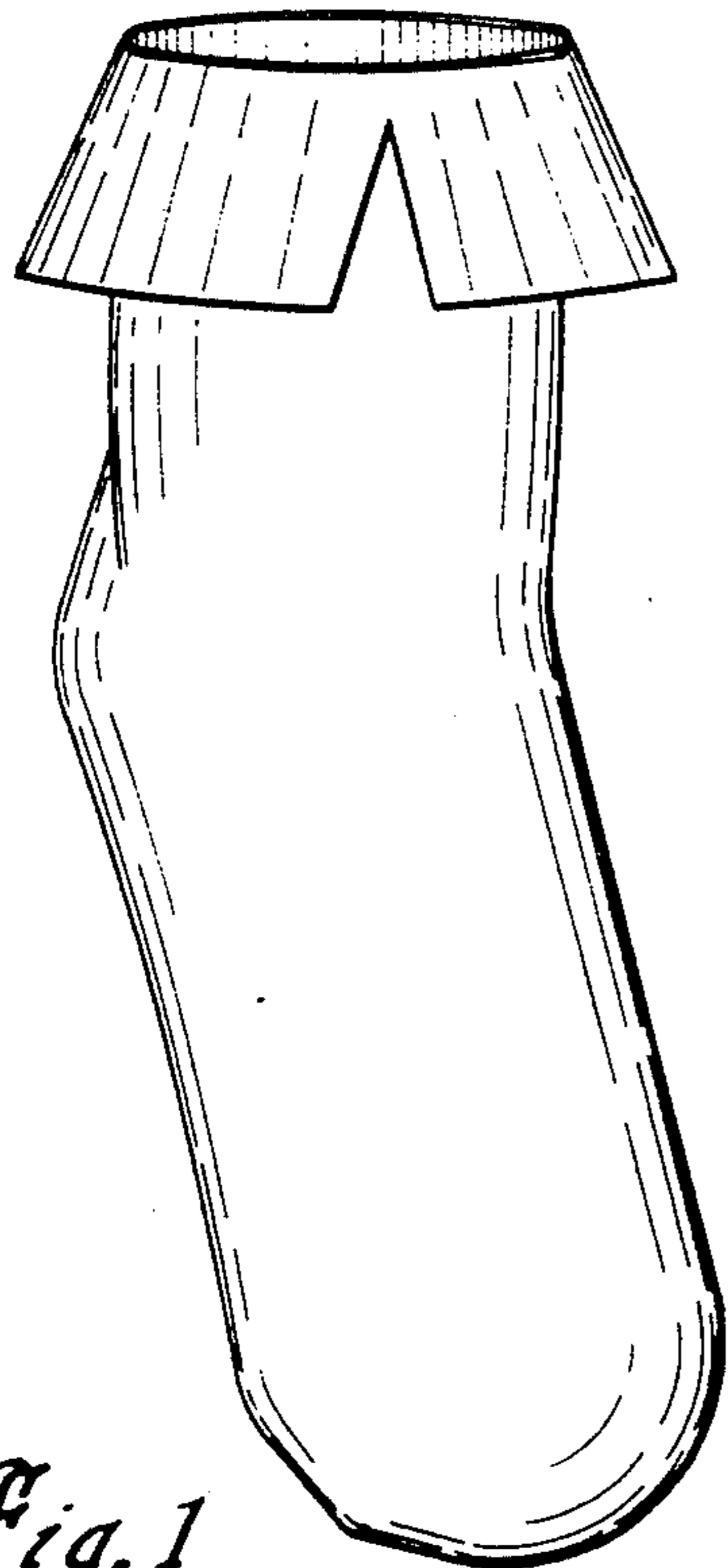

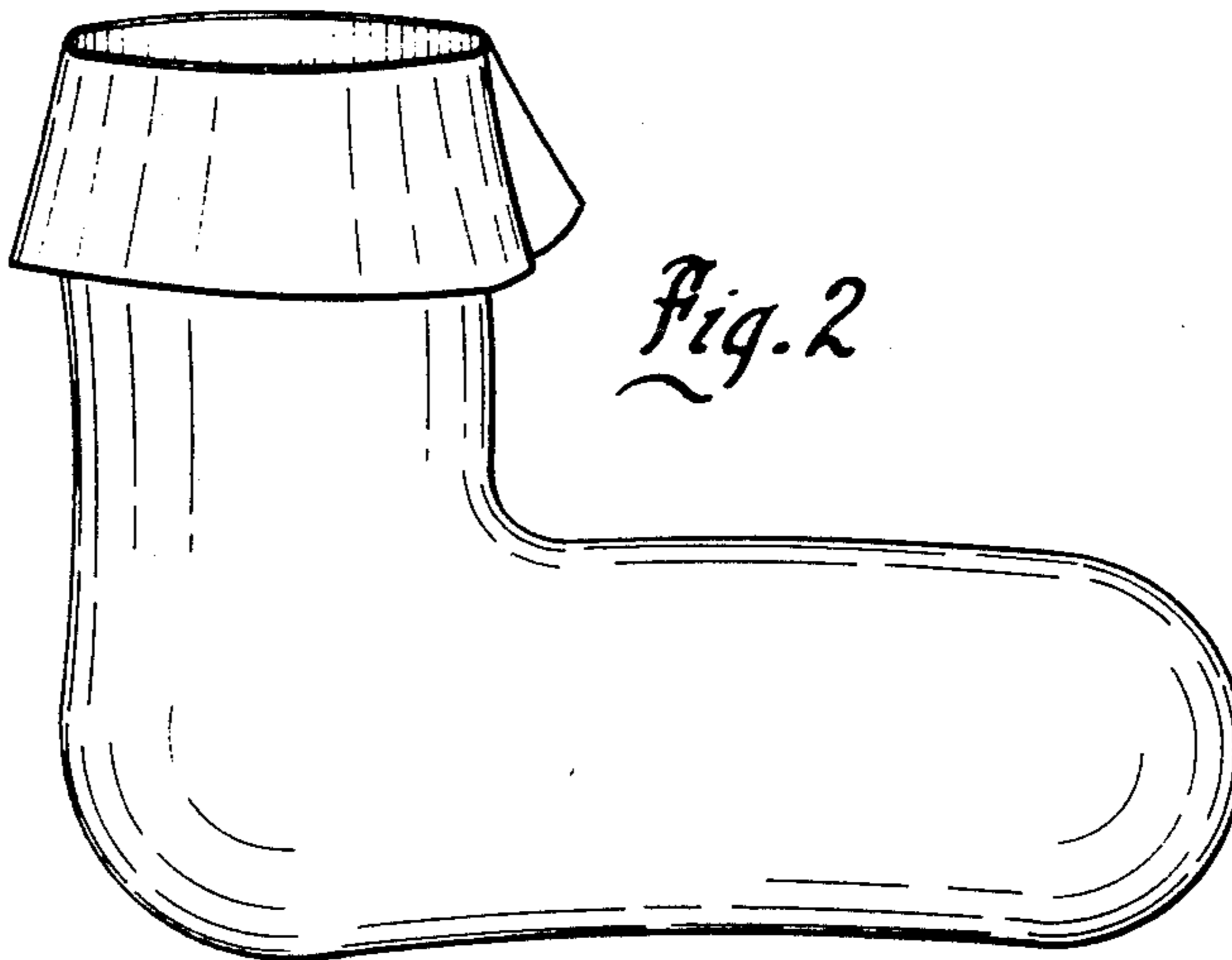

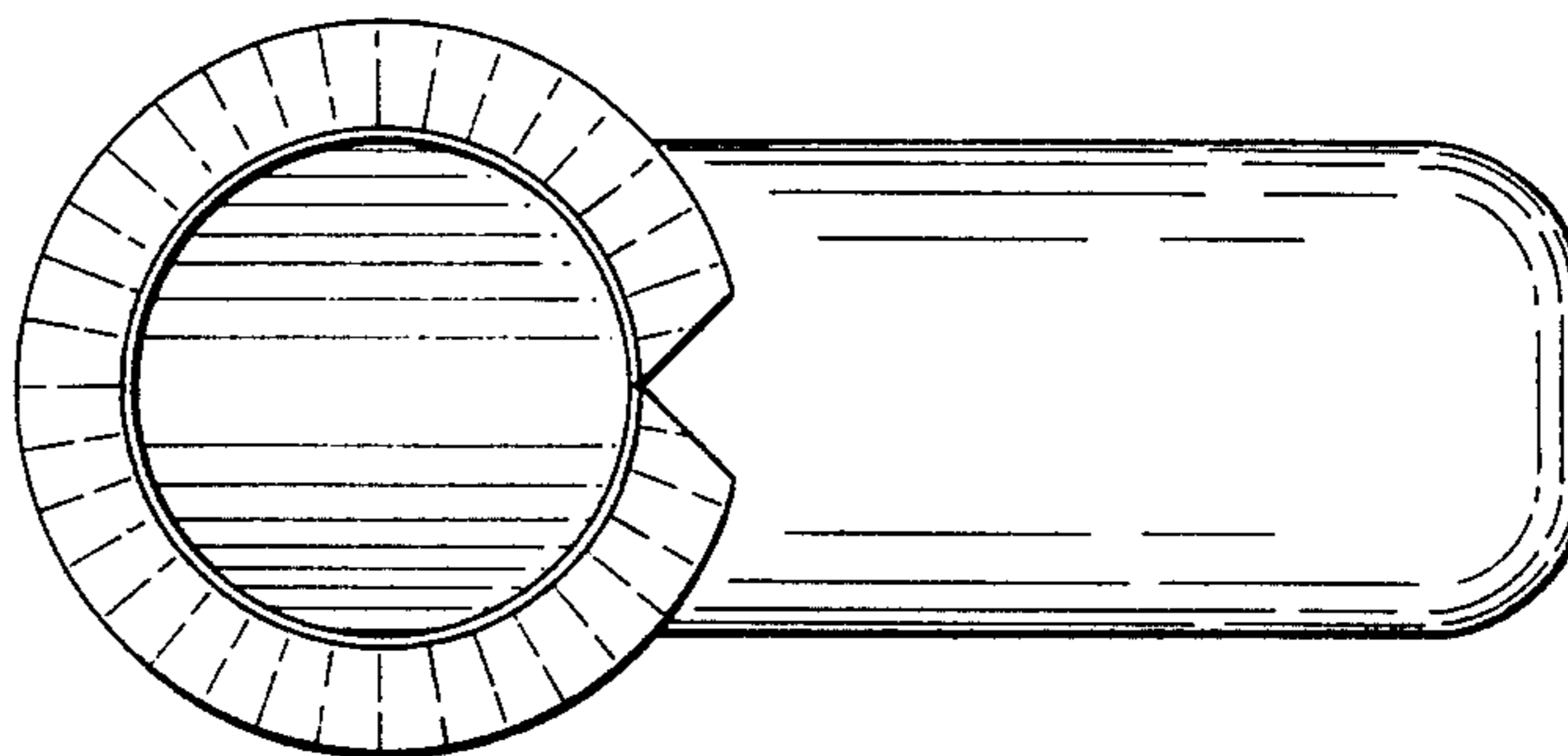

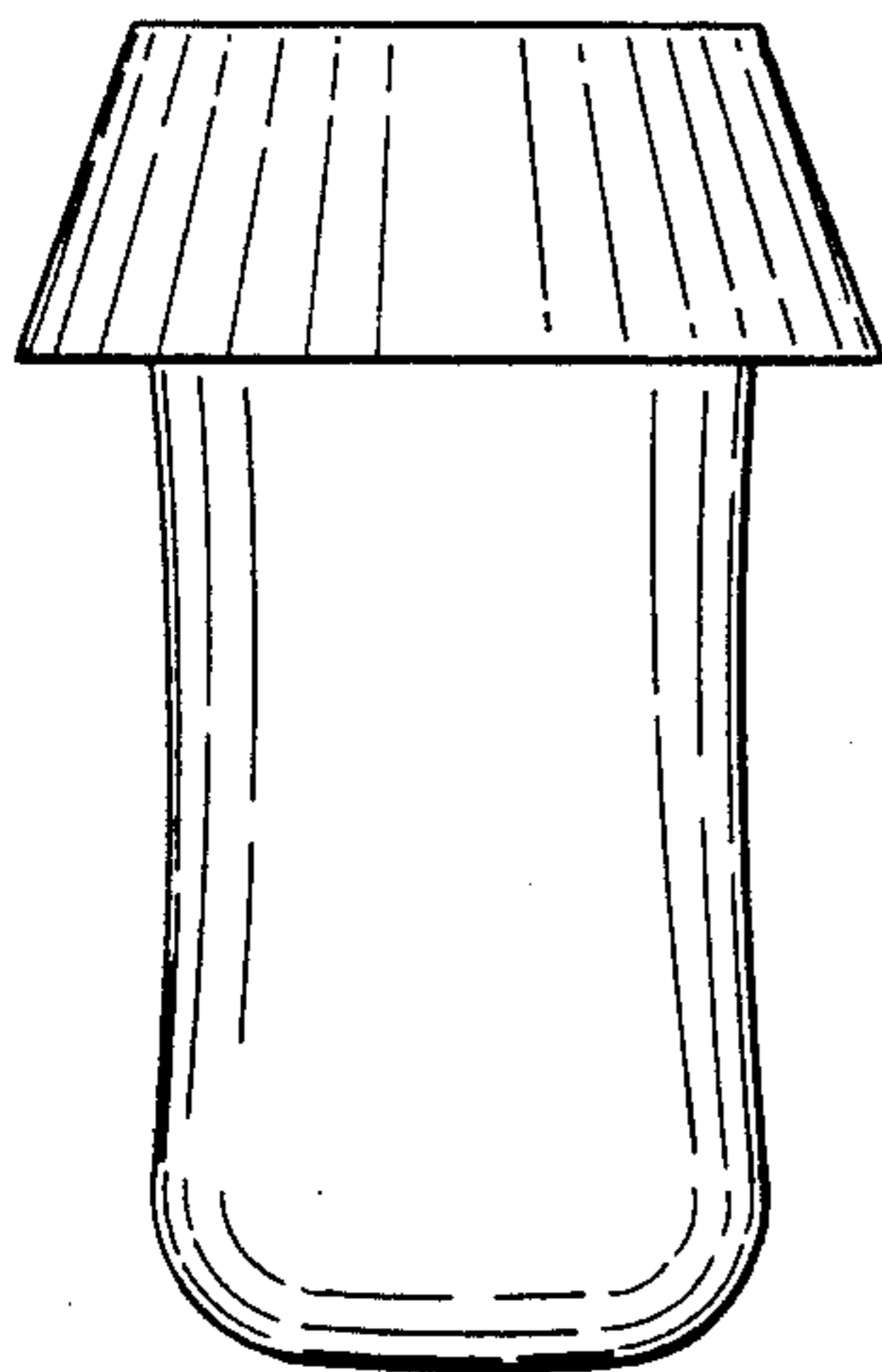

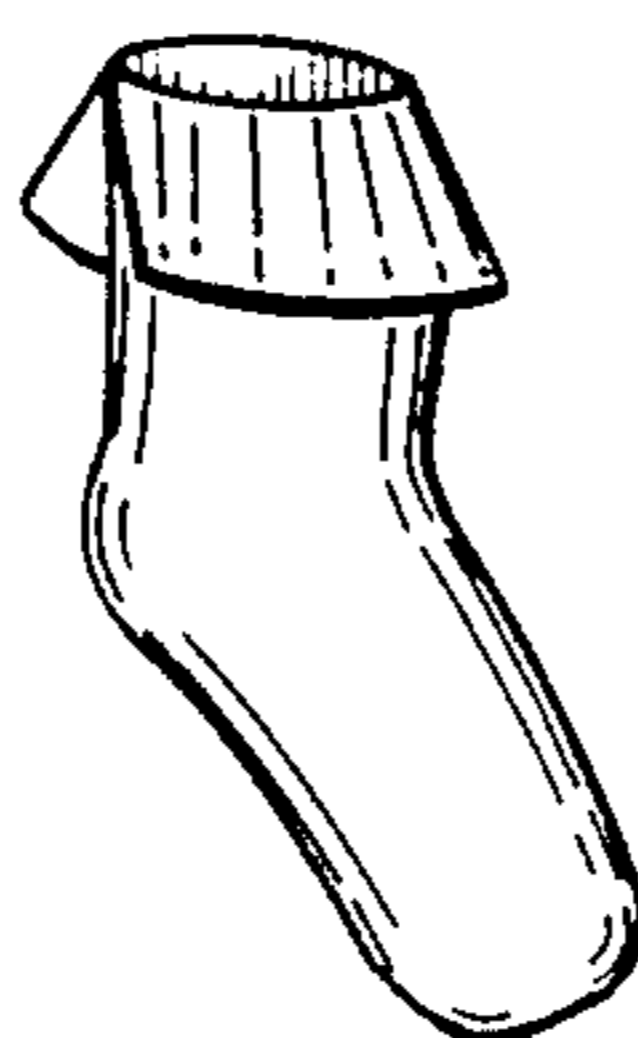

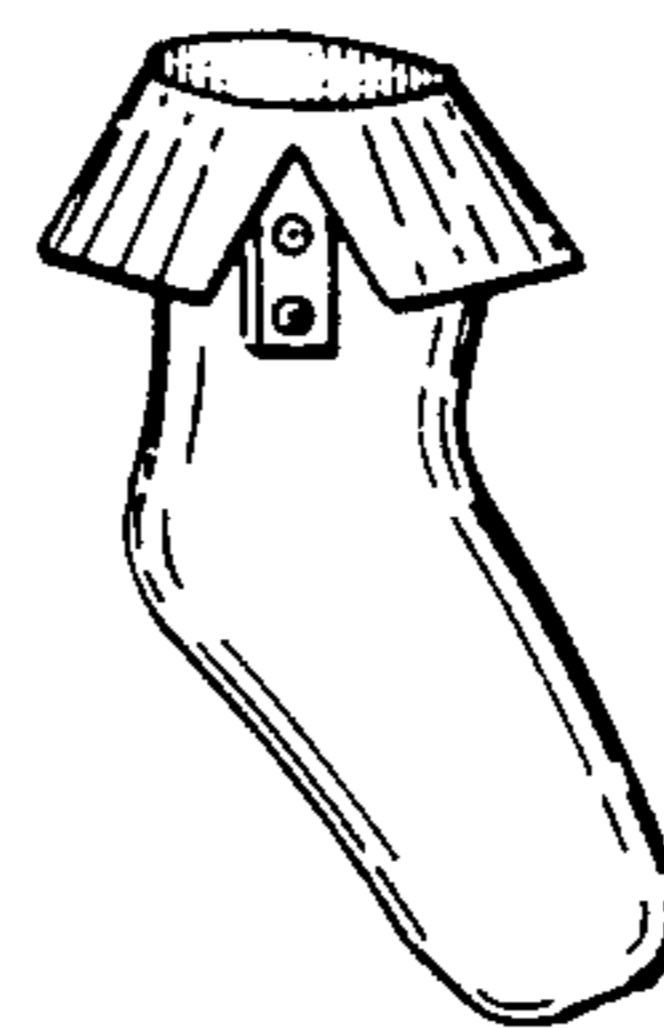

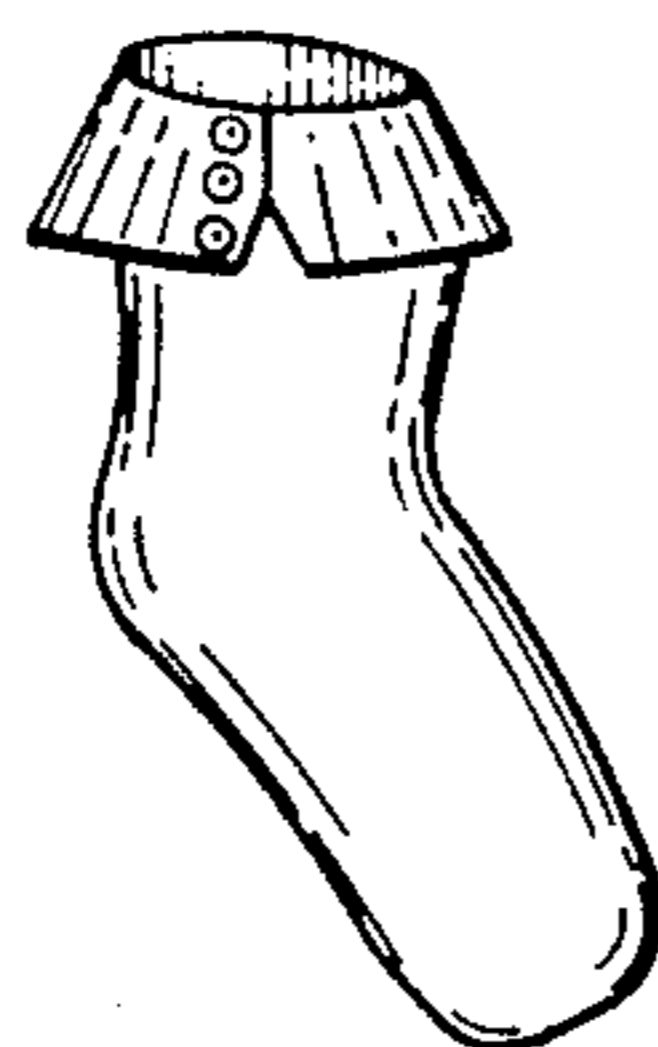

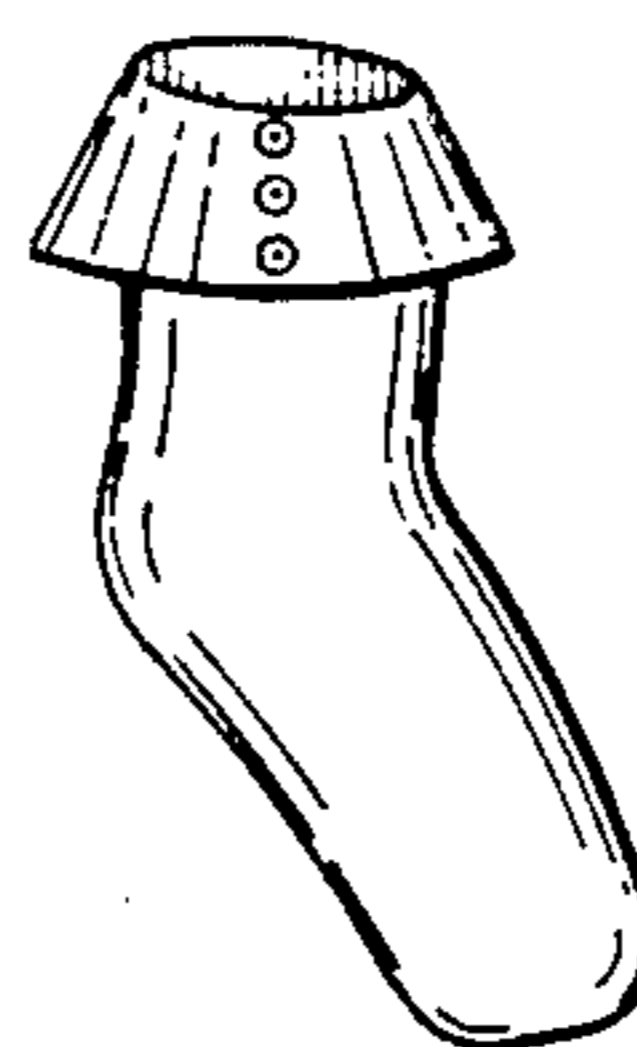

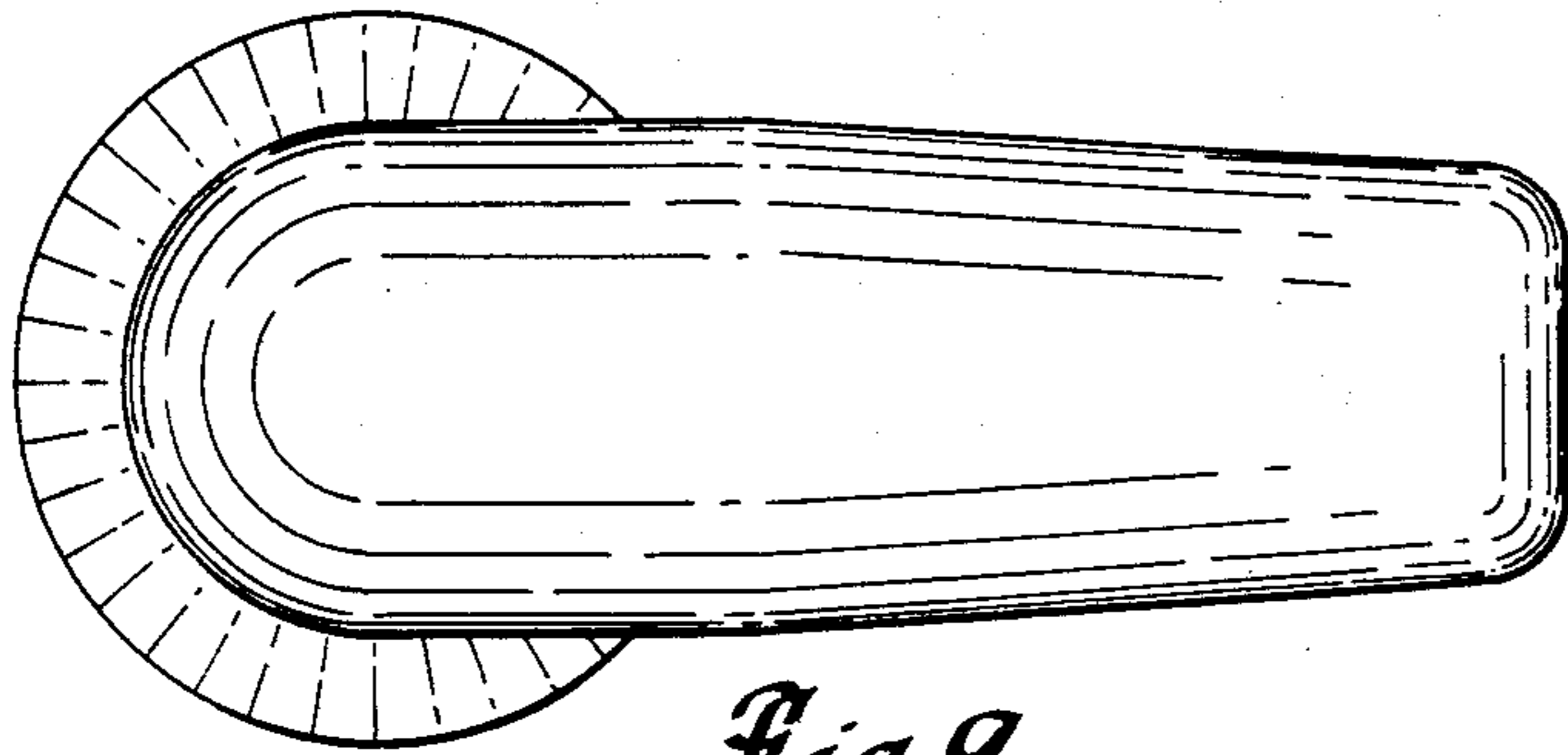

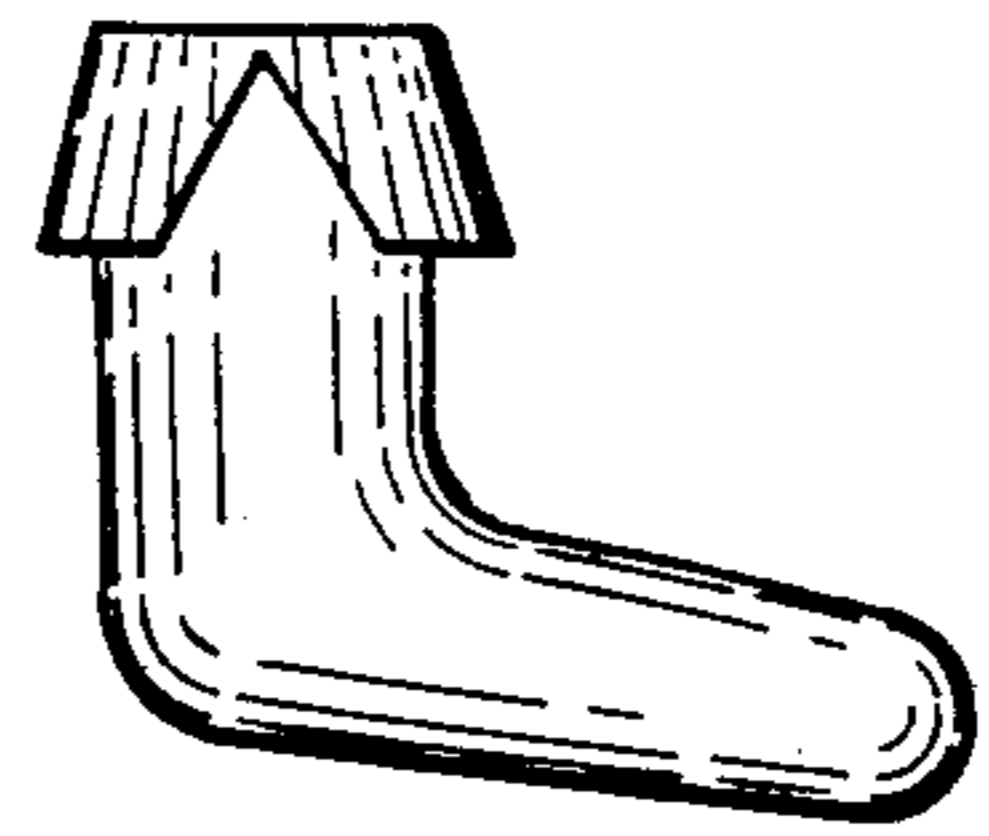

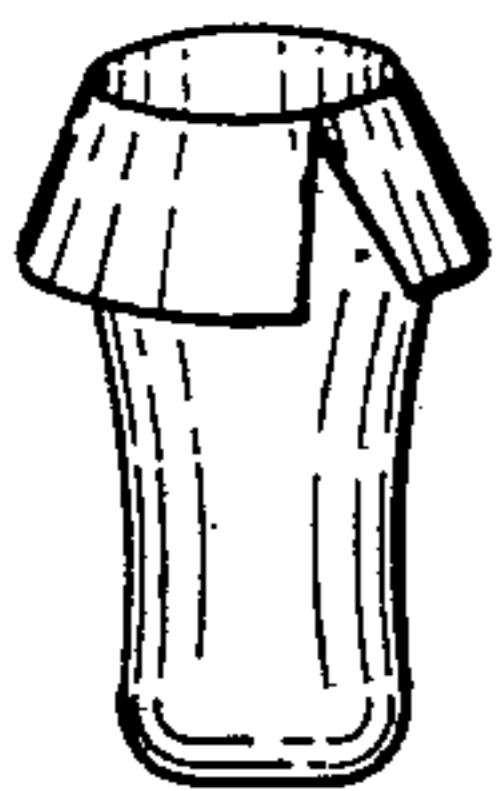

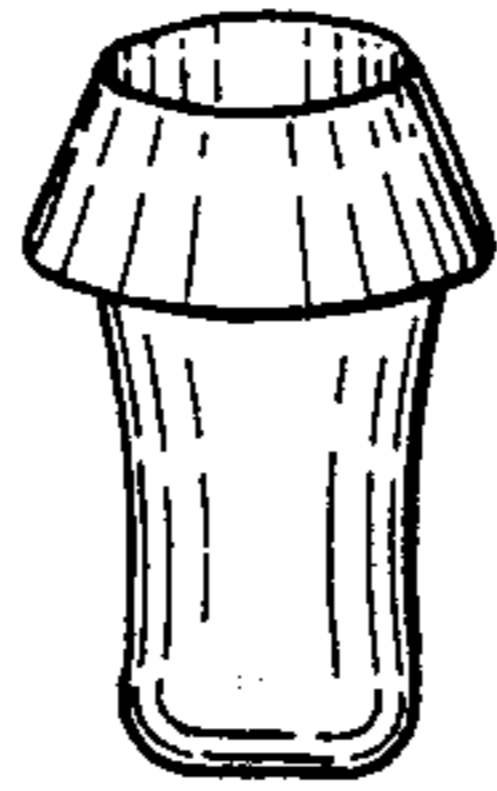

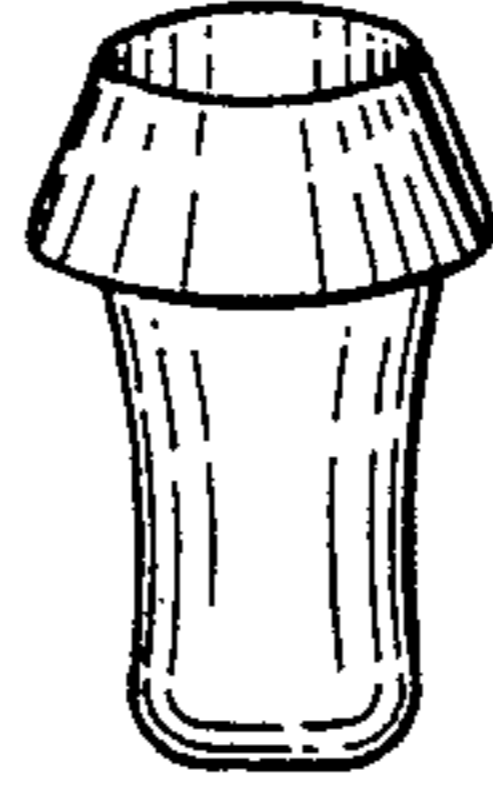

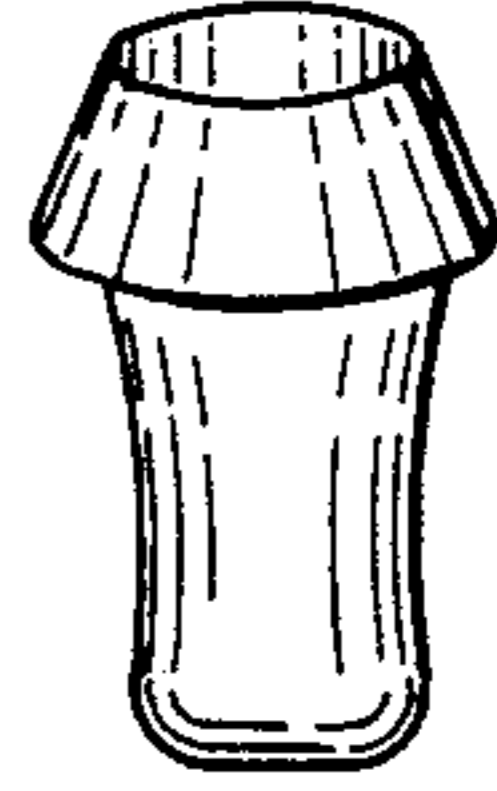

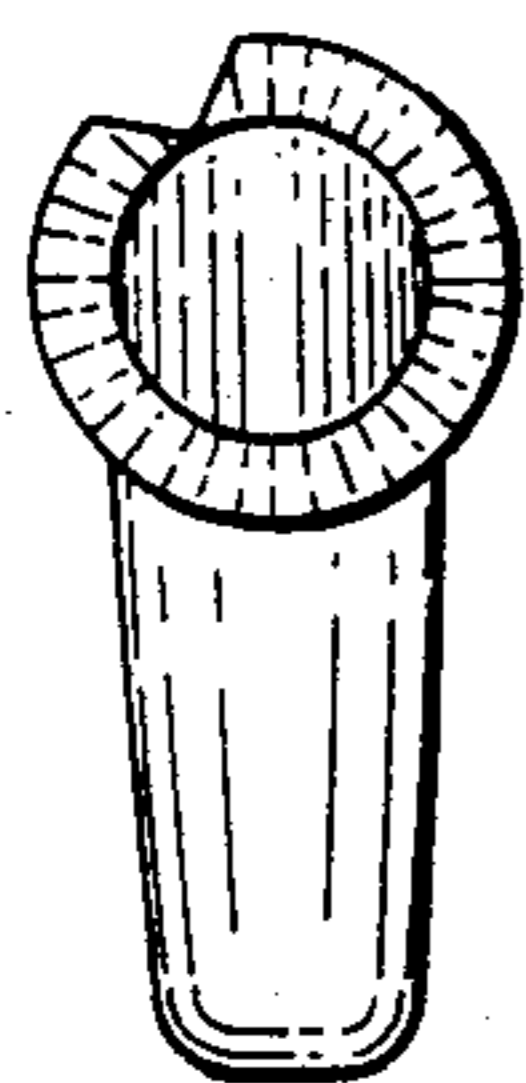

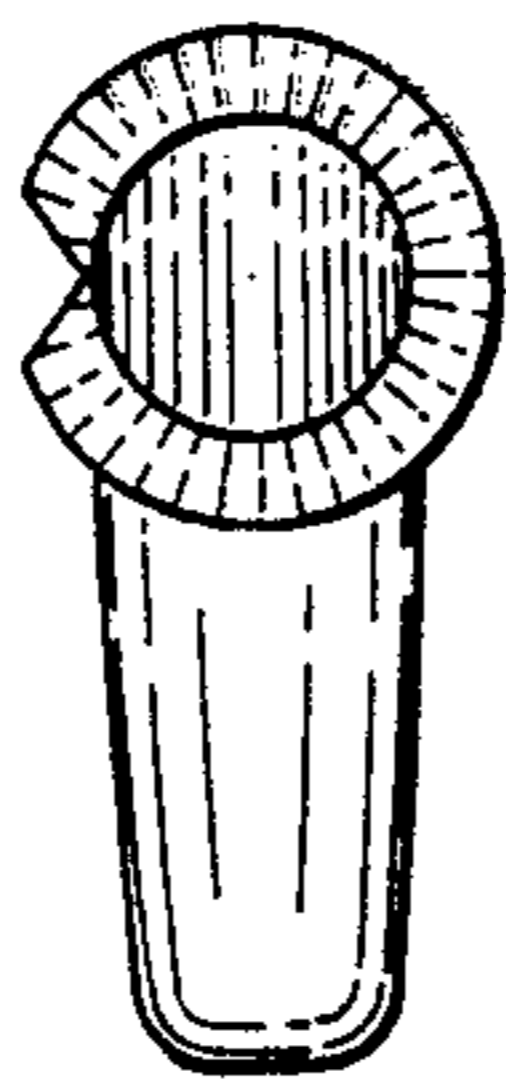

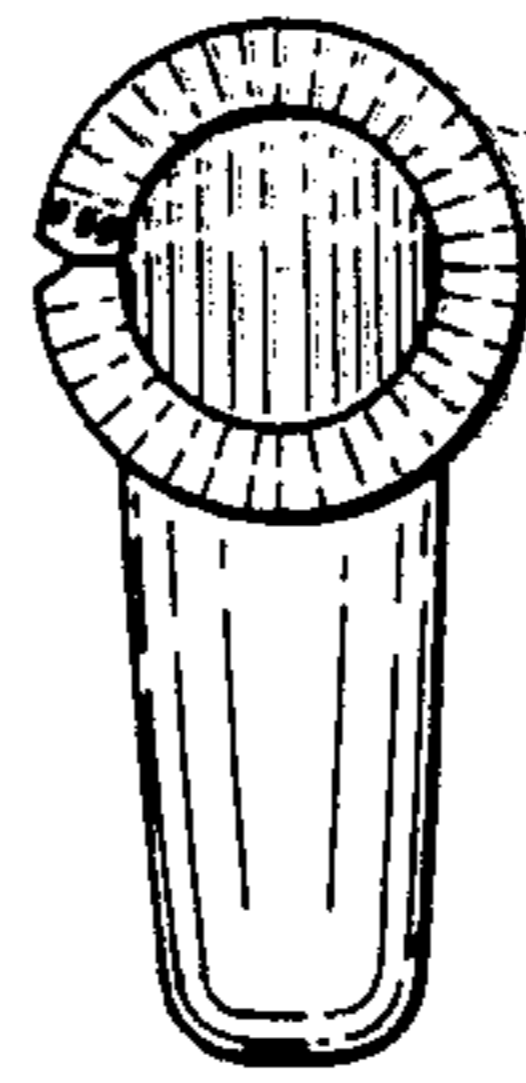

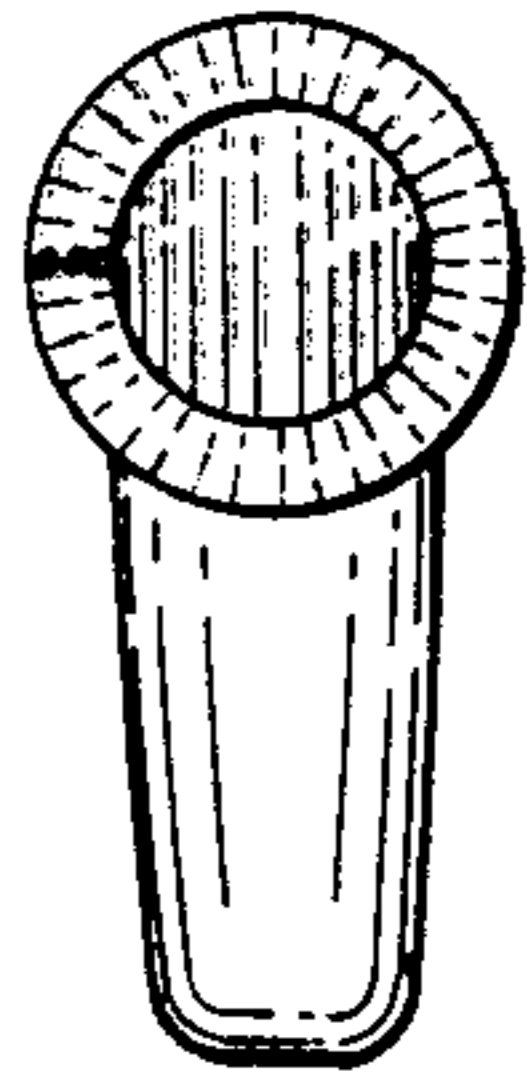

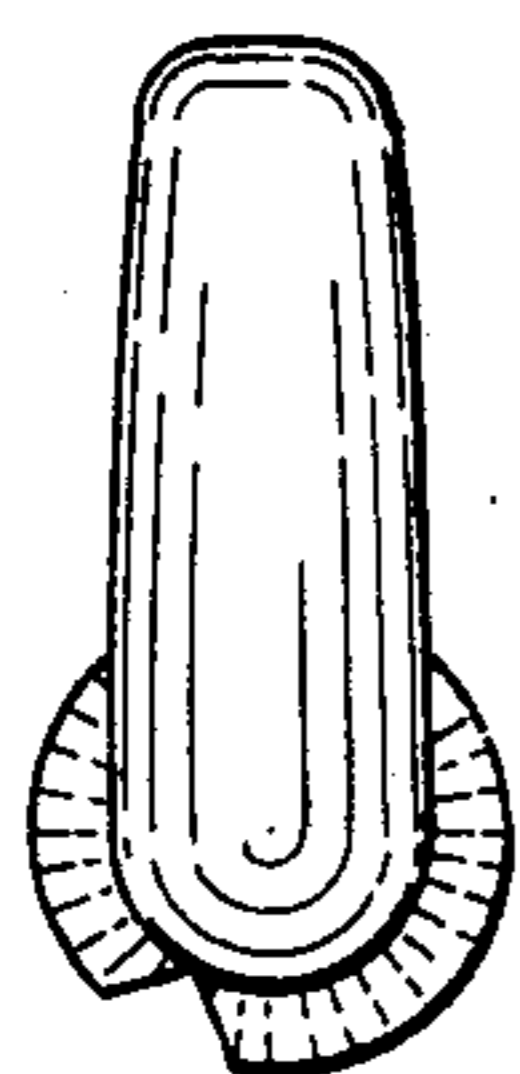

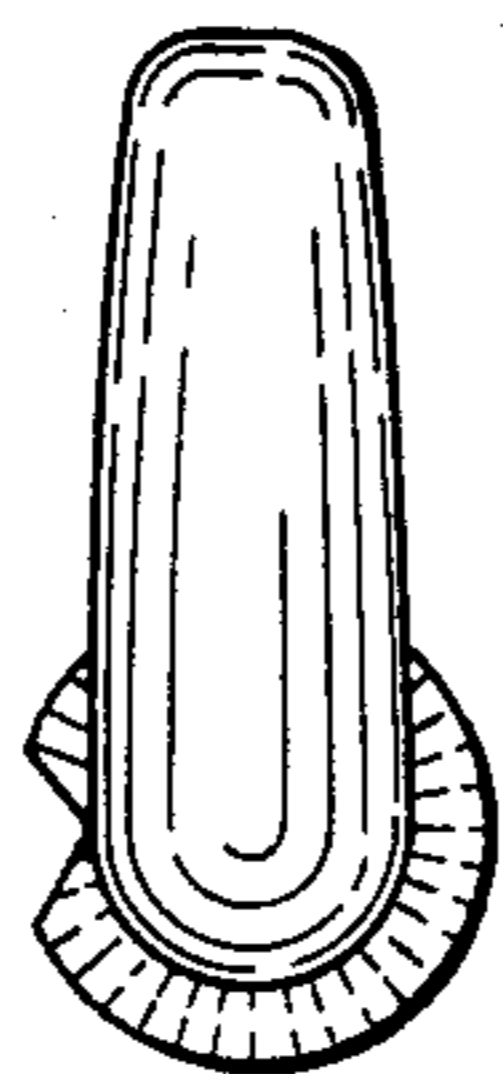

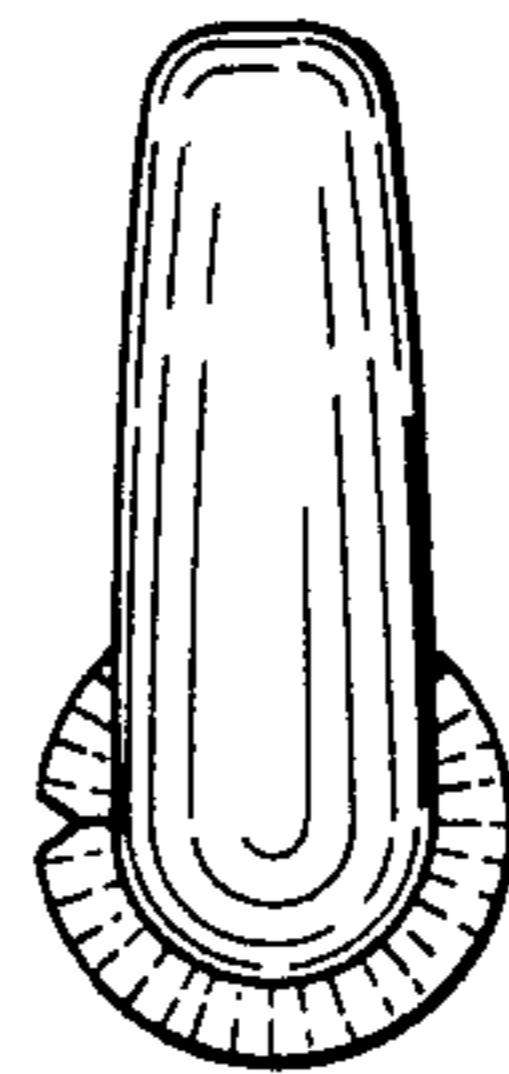

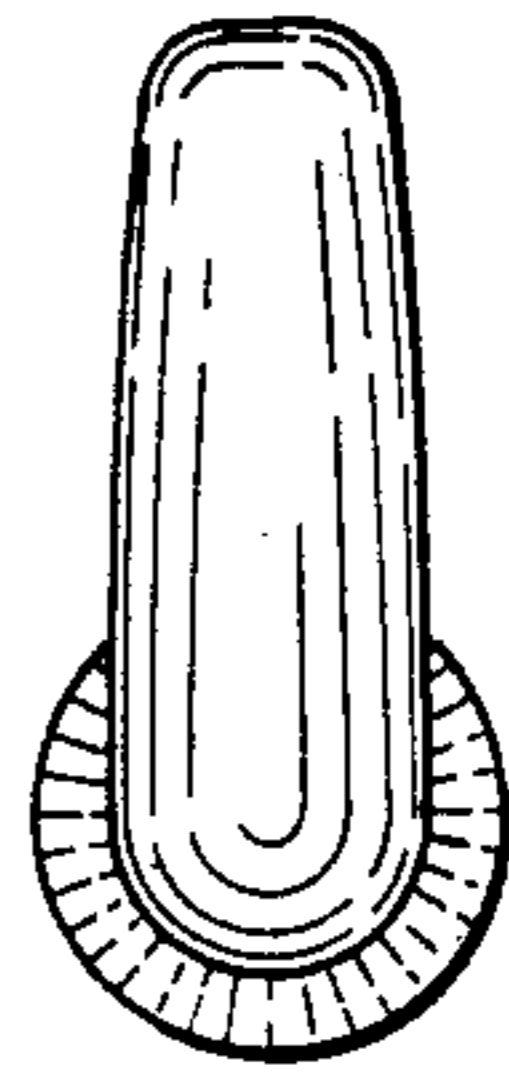
