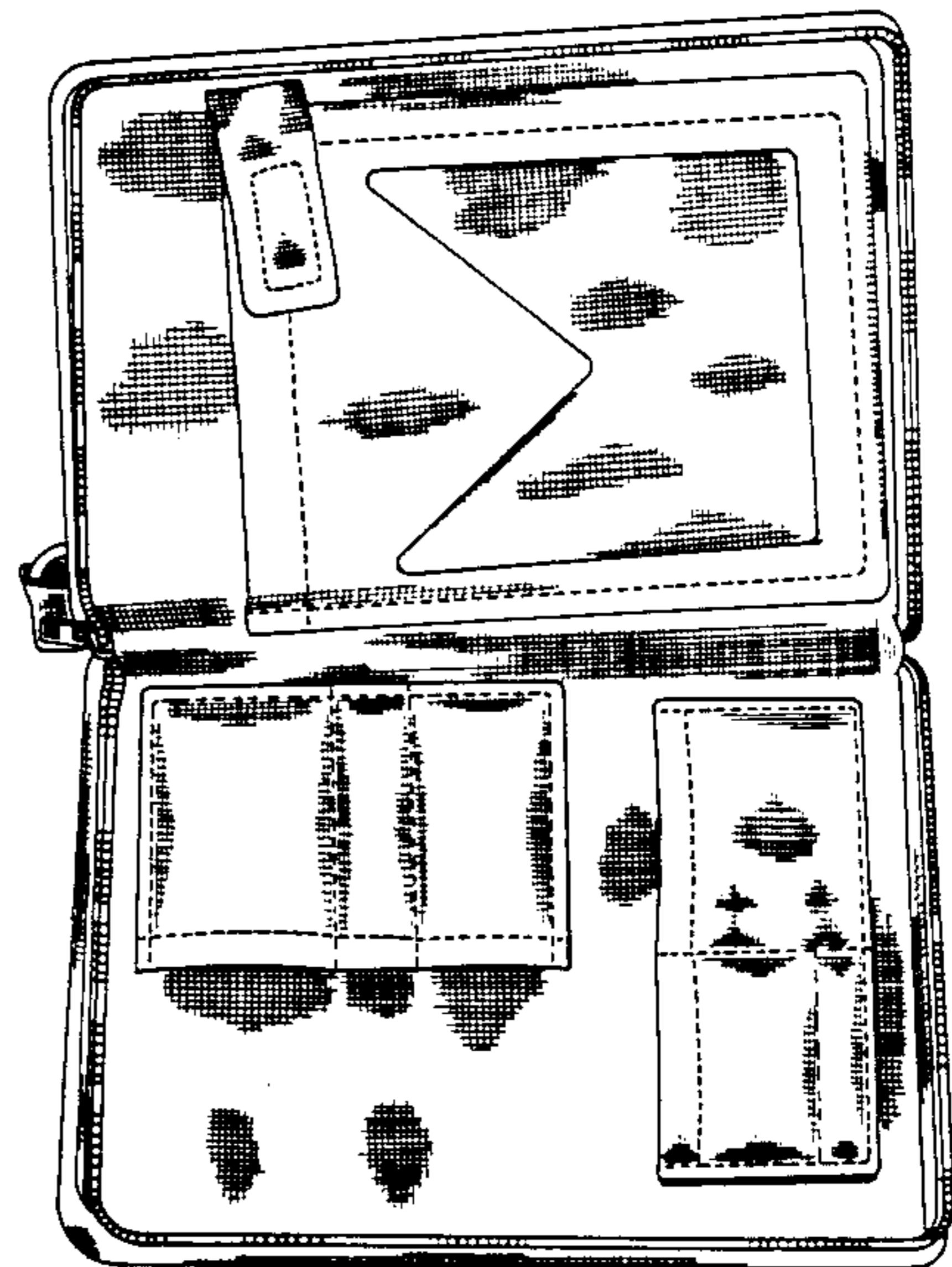
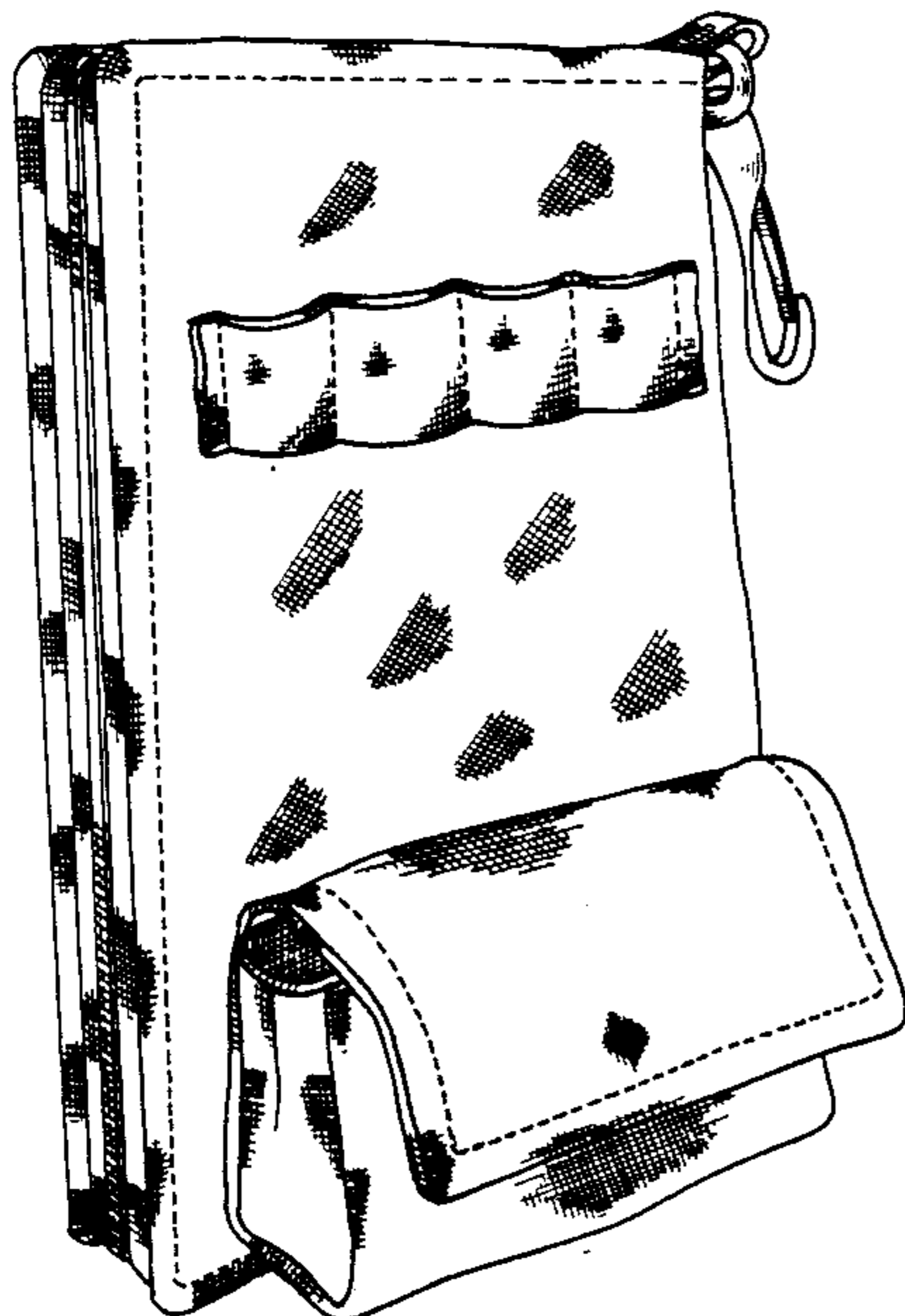

[57] **CLAIM**

The ornamental design for a case for a golf accessory kit, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a case for a golf accessory kit showing my new design;  
FIG. 2 is a front, elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a bottom plan view thereof;  
FIG. 5 is a top plan view thereof;  
FIG. 6 is a left side elevational view thereof;

FIG. 8 is a perspective view thereof in the open position.



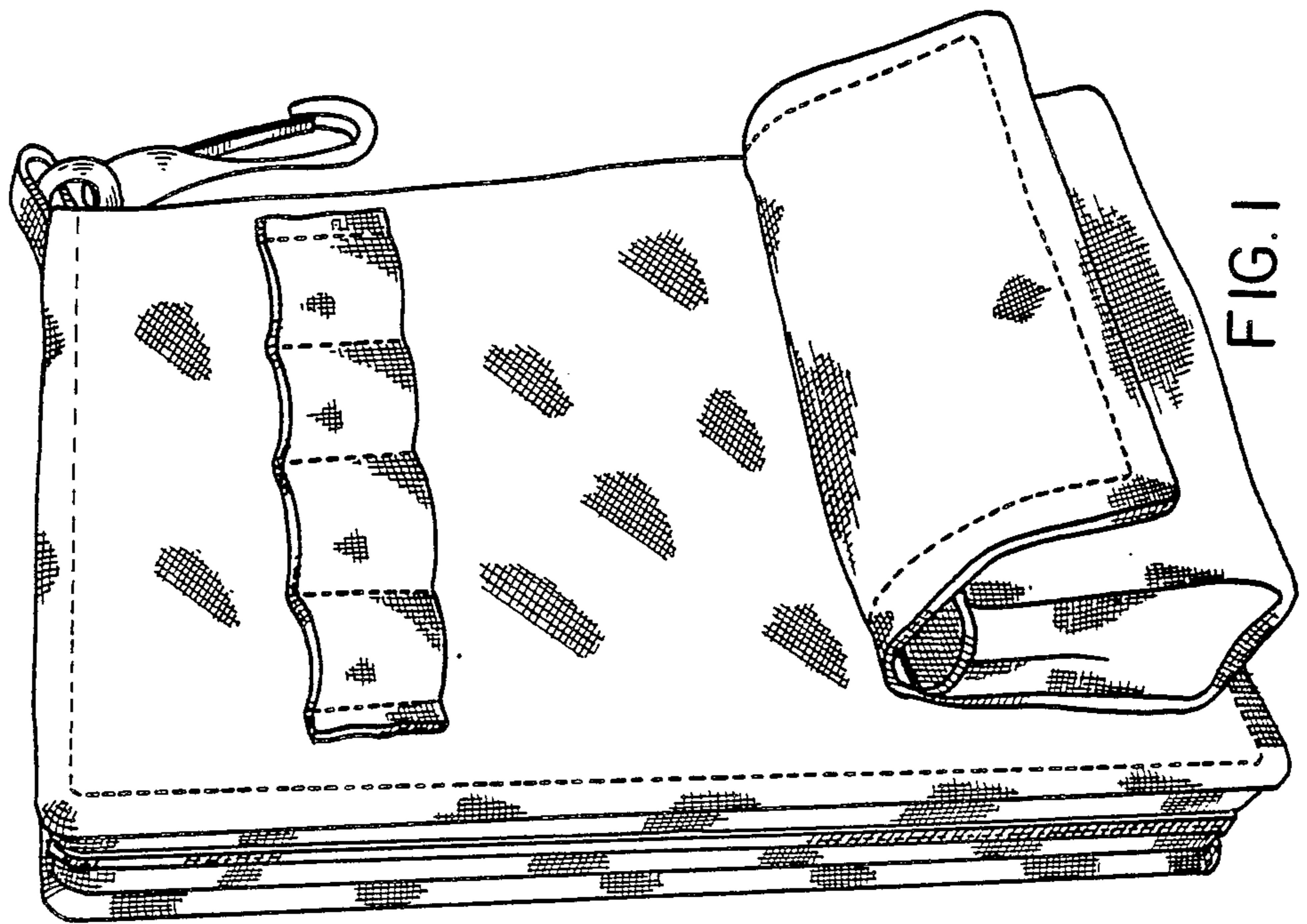

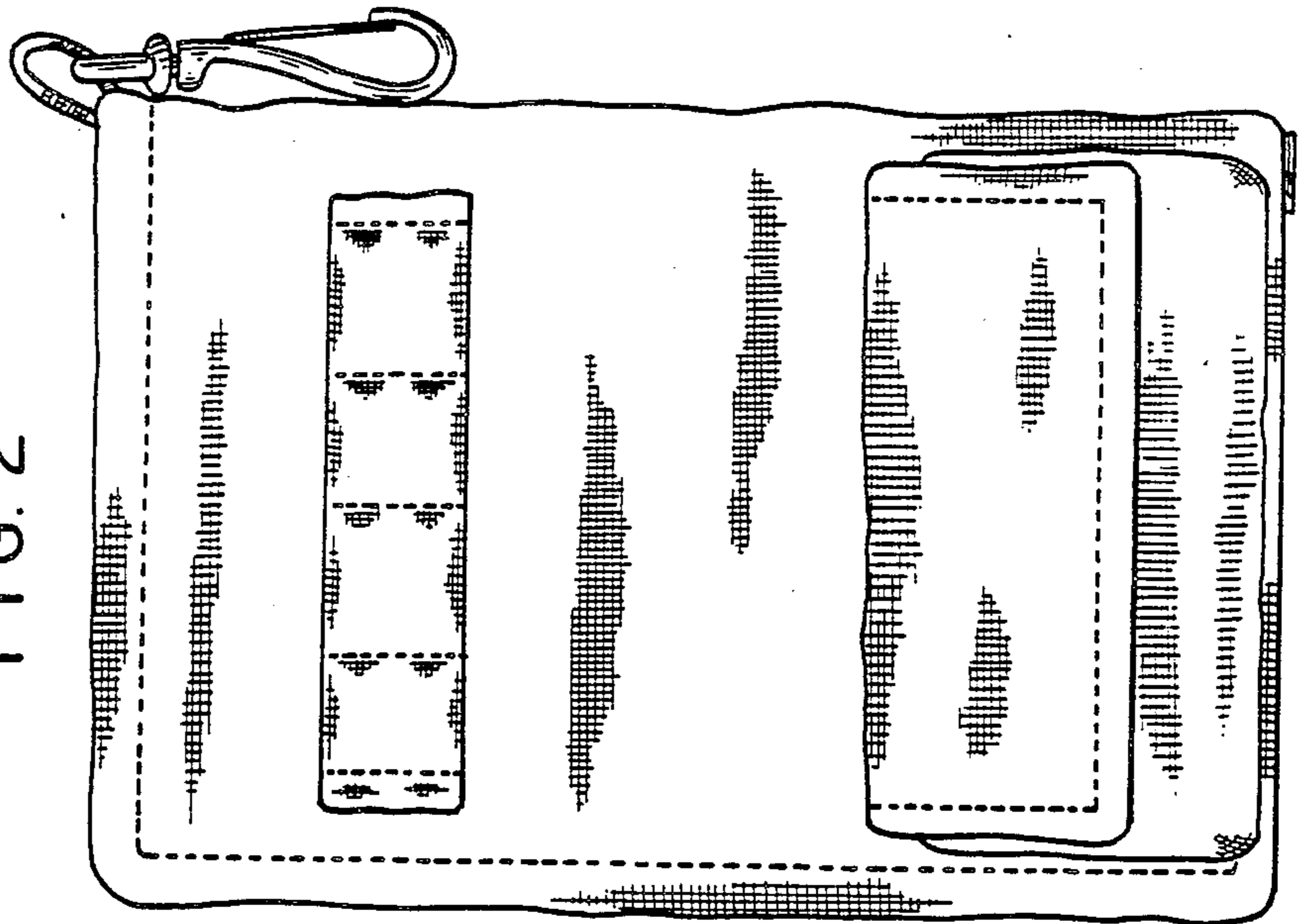

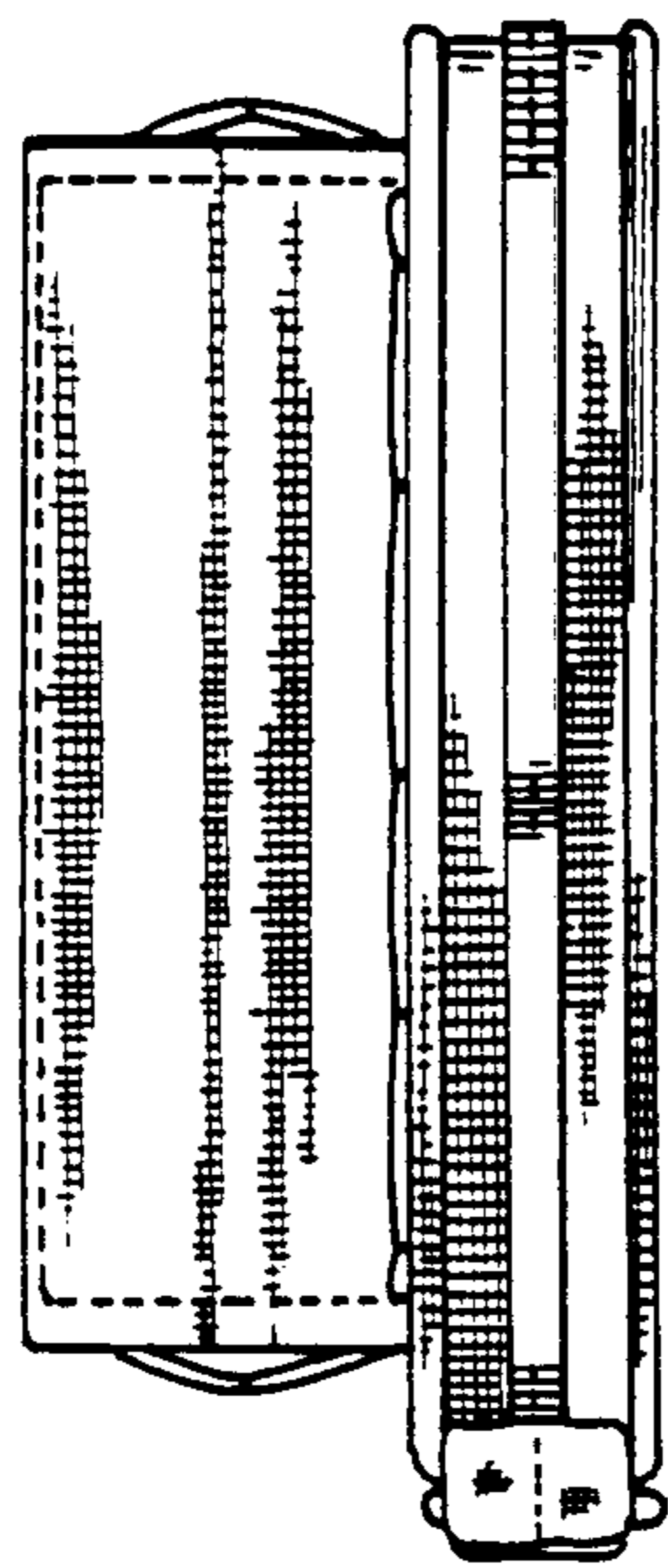

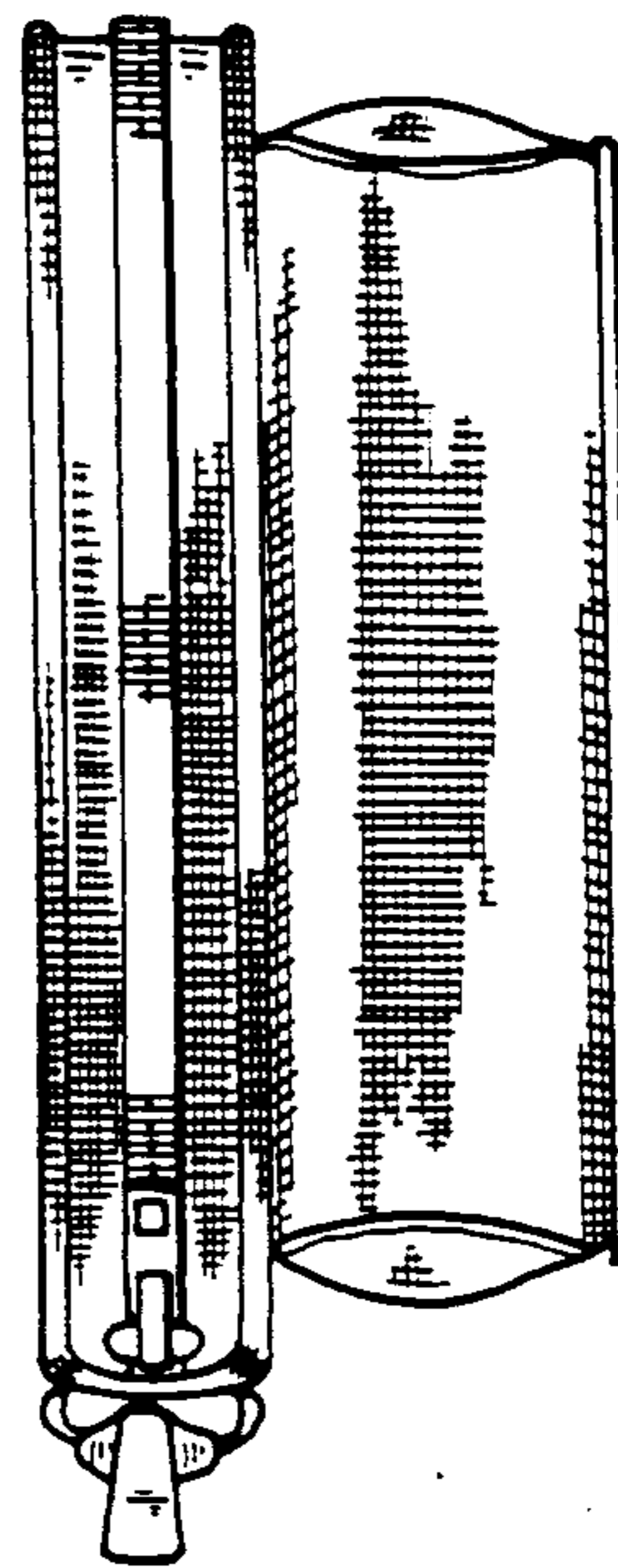
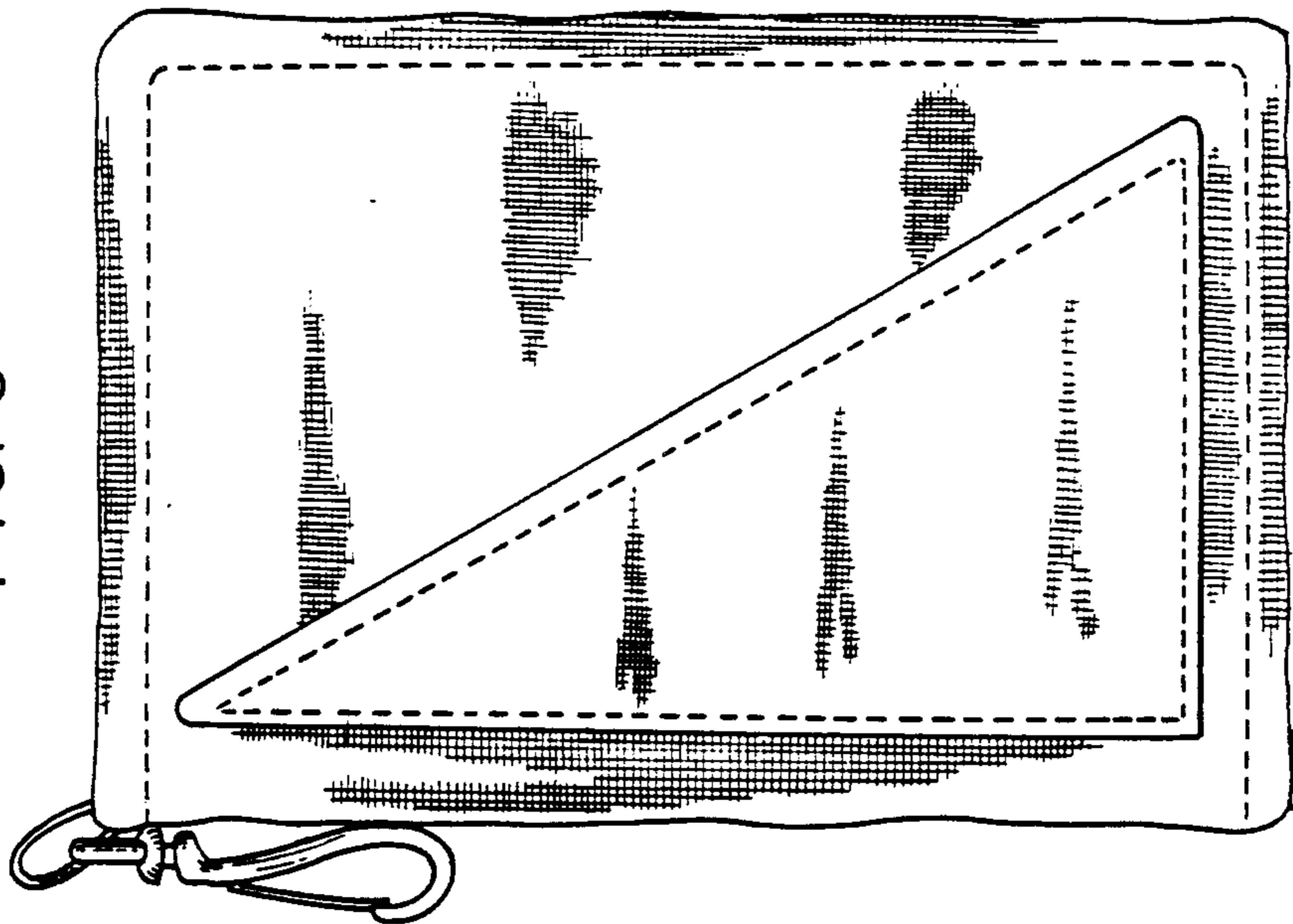

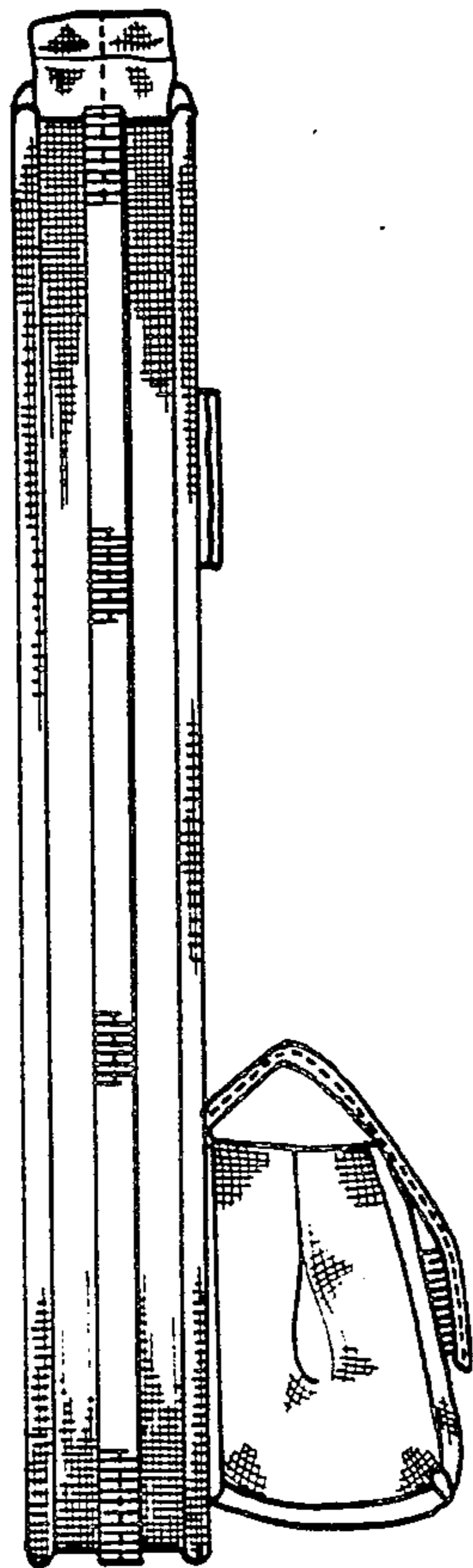

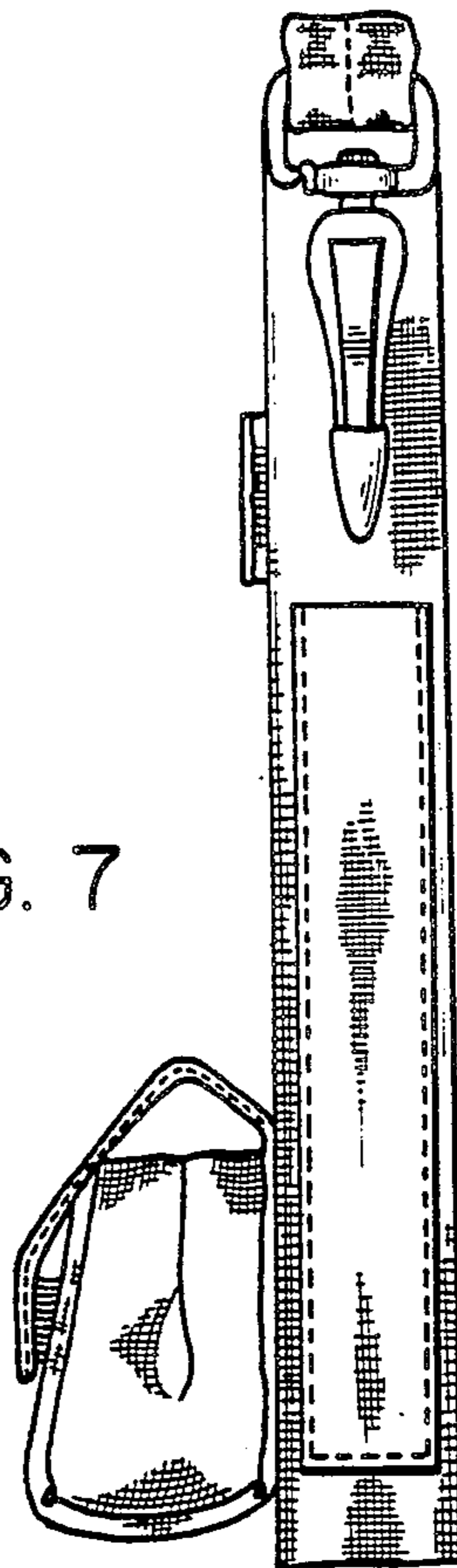

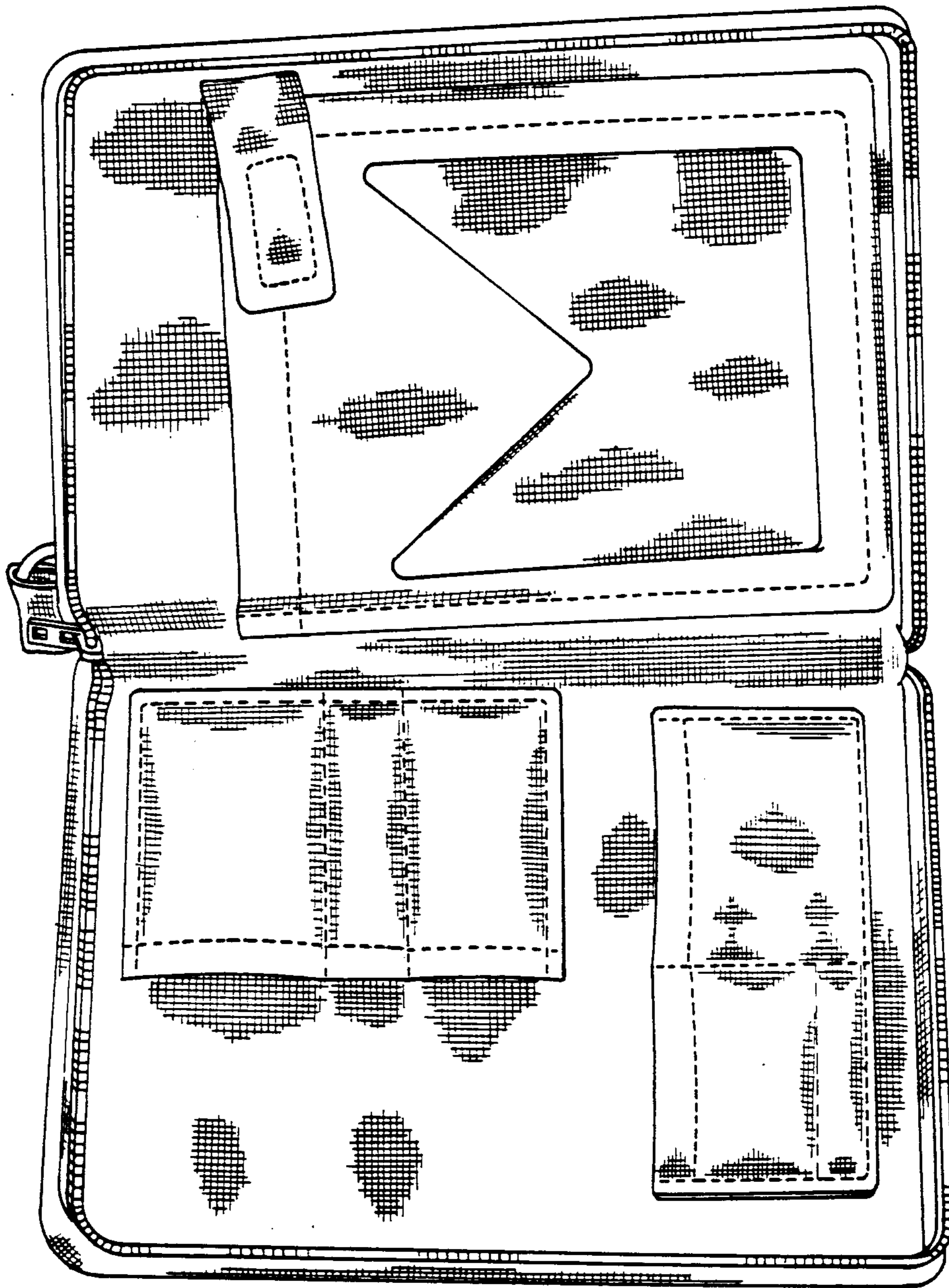
