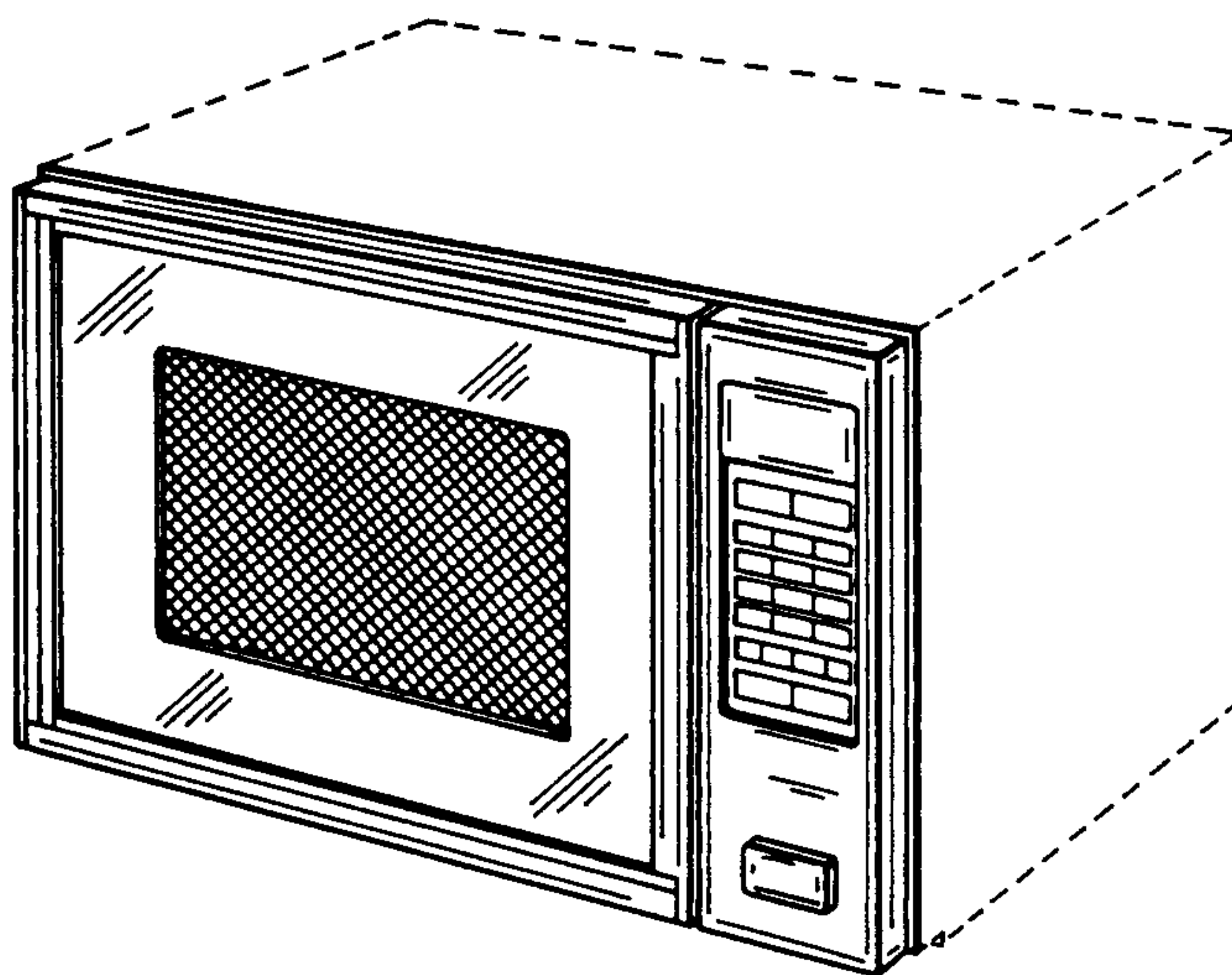

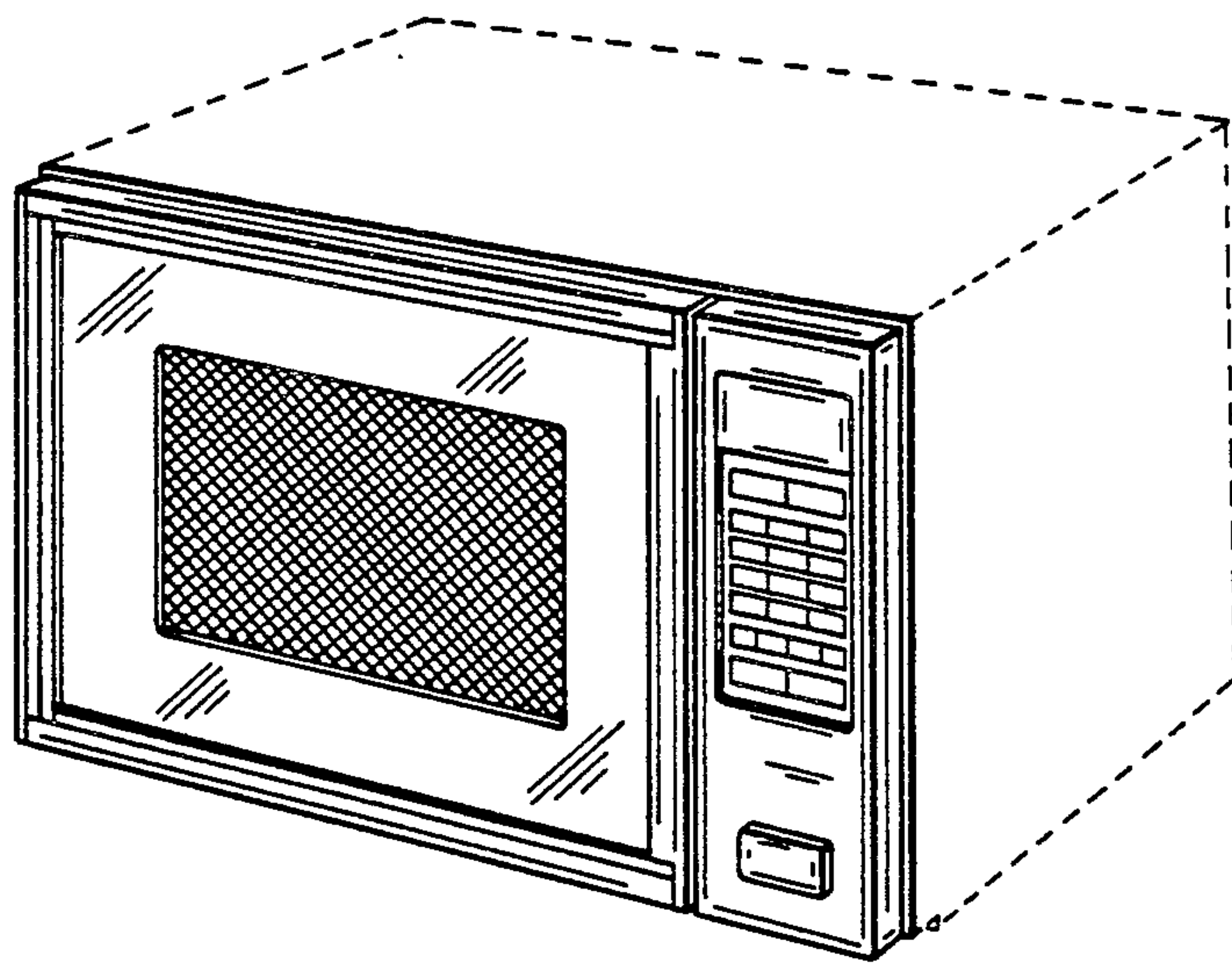
[57] **CLAIM**

The ornamental design for a front panel for a microwave oven, as shown and described.

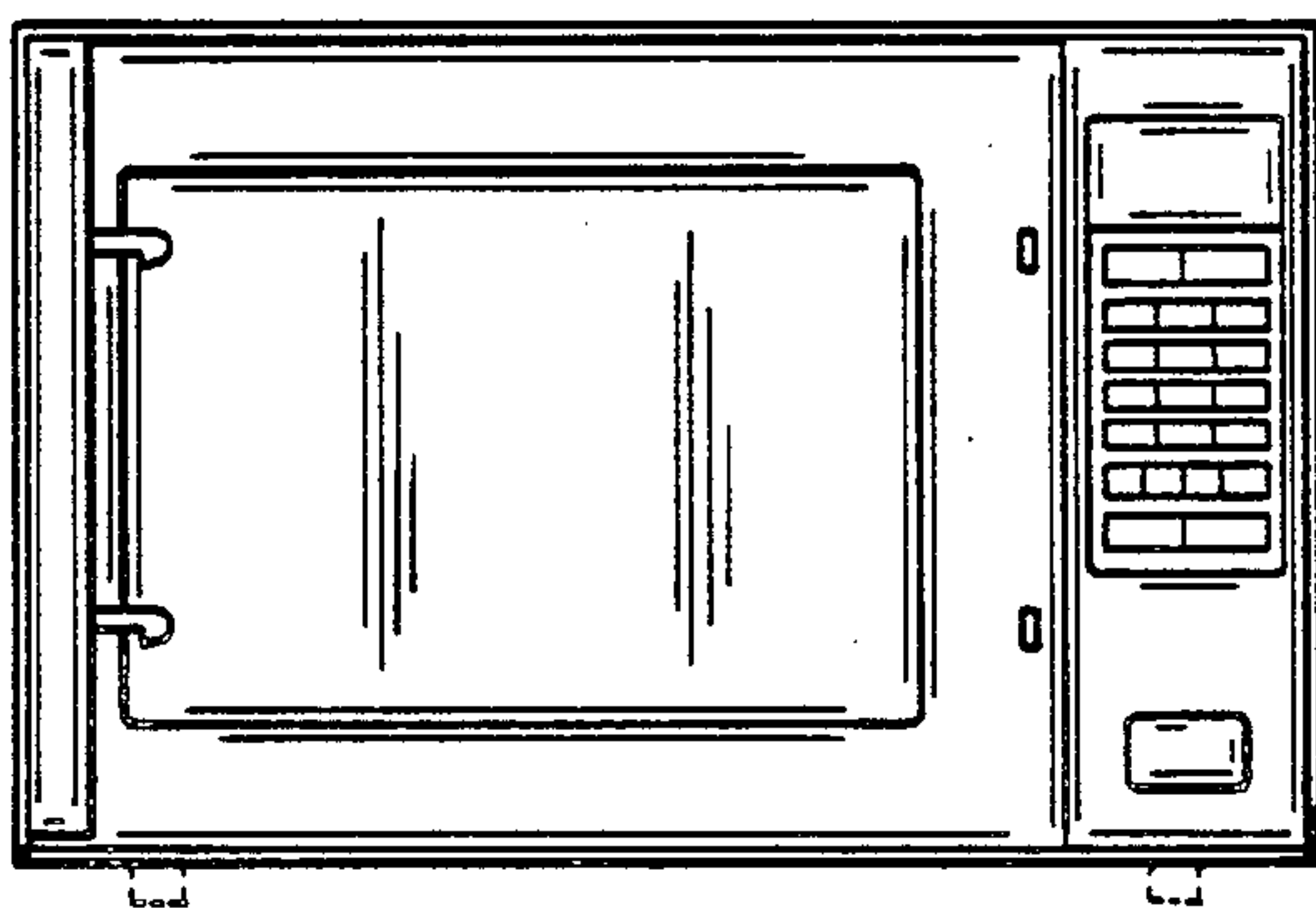
### DESCRIPTION

FIG. 1 is a perspective view of the front panel for a microwave oven showing our new design;  
FIG. 2 is a front elevational view thereof with door open;  
FIG. 3 is a front elevational view thereof with door closed;  
FIG. 4 is a top plan view thereof;  
FIG. 5 is a bottom plan view thereof;  
FIG. 6 is a right side elevational view thereof; and  
FIG. 7 is a left side elevational view thereof.

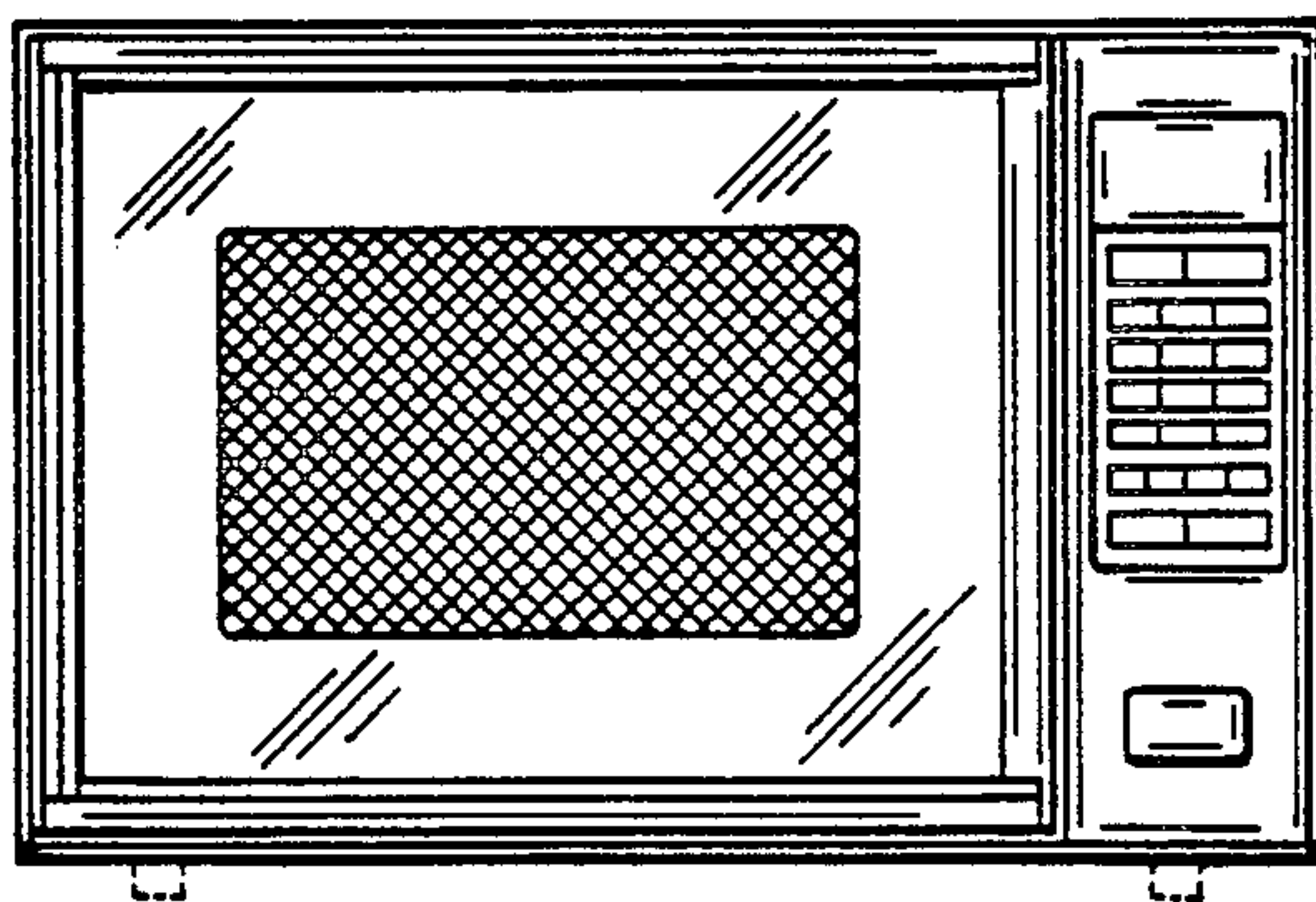




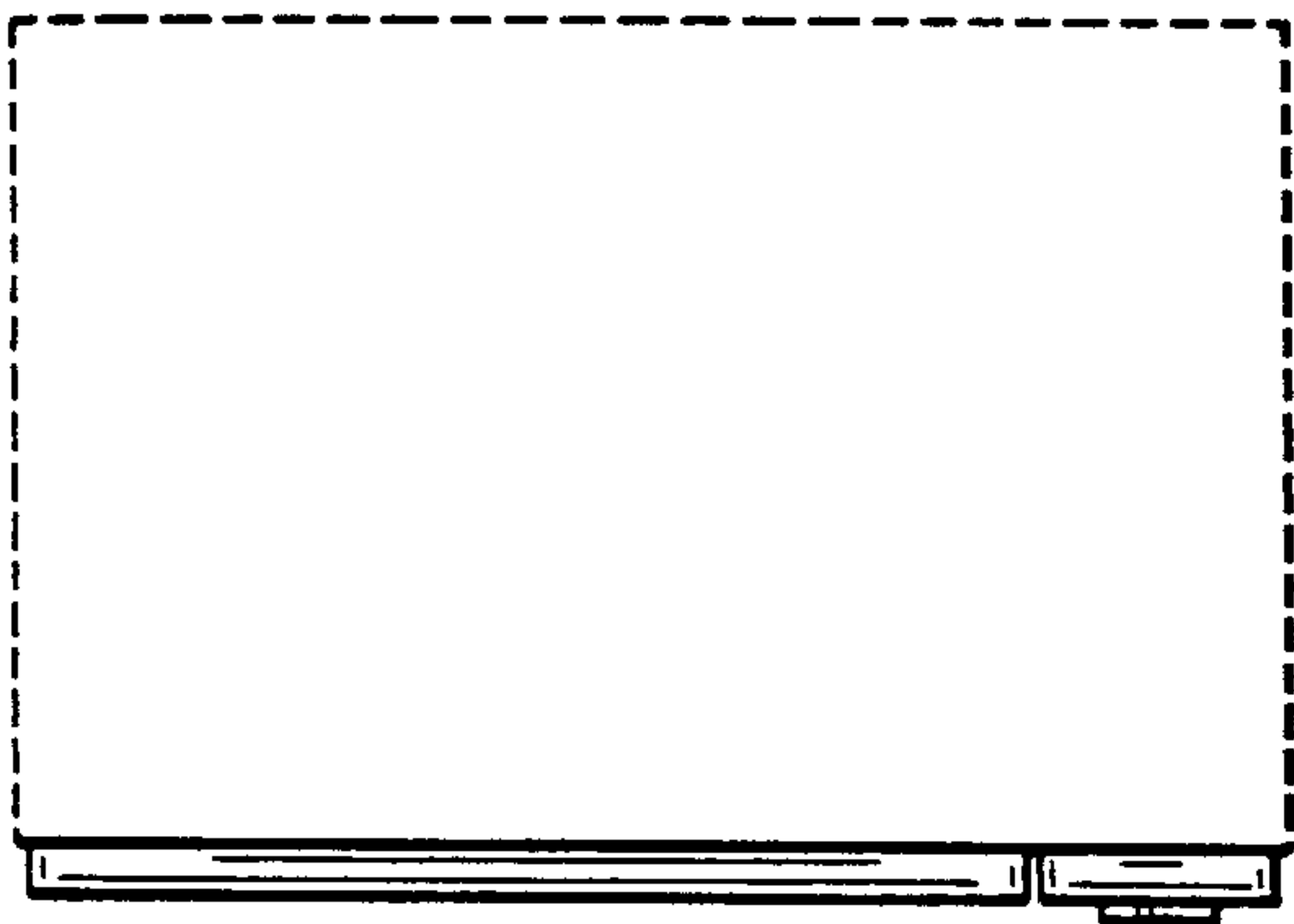

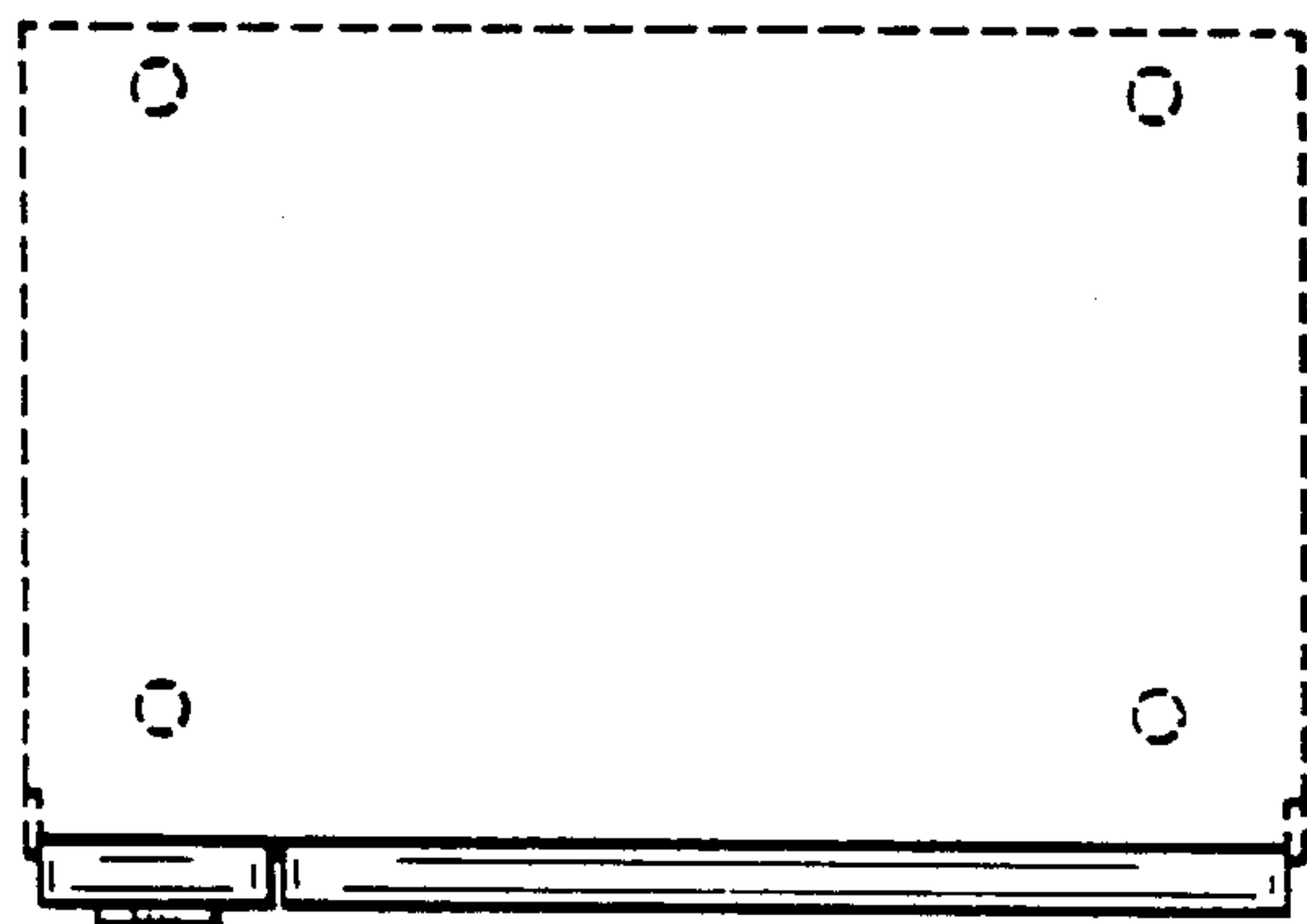

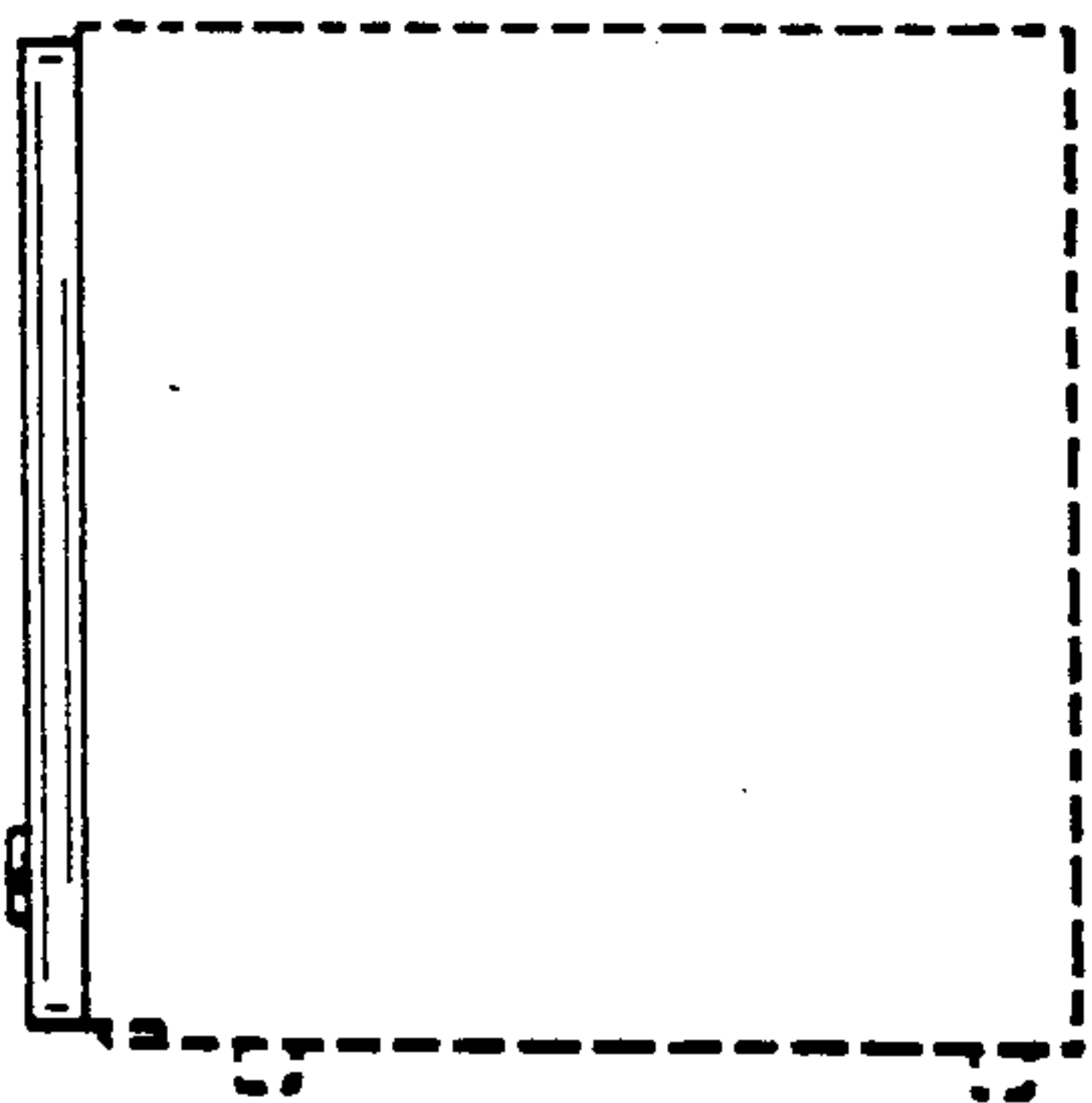

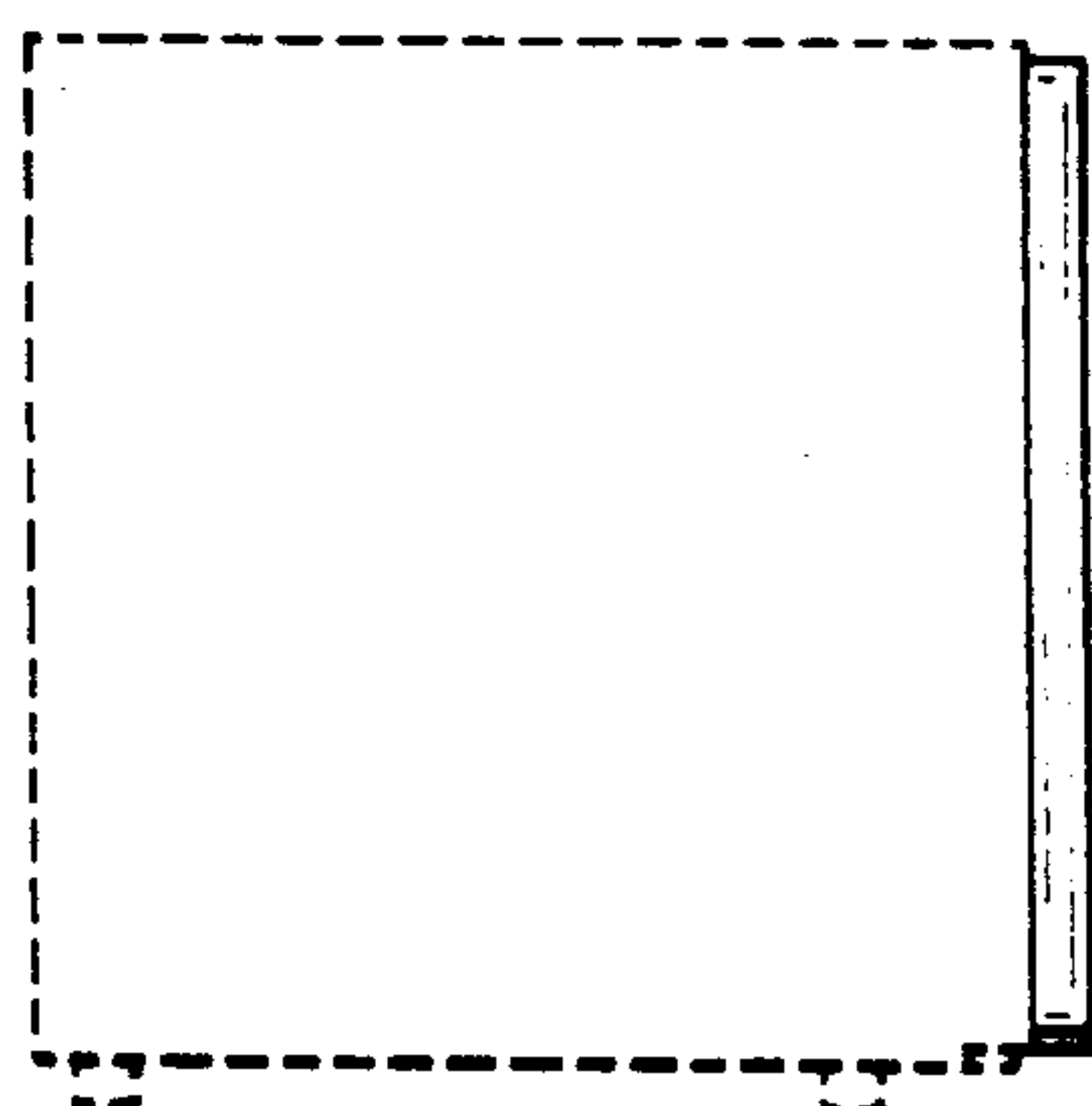
