The ornamental design for an applicator container, as shown and described.

DESCRIPTION

FIG. 1 is a front view of an applicator container showing my new design, the back of the container having the same appearance;

FIG. 2 is a top plan view of the design shown in FIG. 1;

FIG. 3 is a side view of the design shown in FIG. 1, the other side of the container having the same appearance; and

FIG. 4 is a bottom plan view of the design shown in FIG. 1.

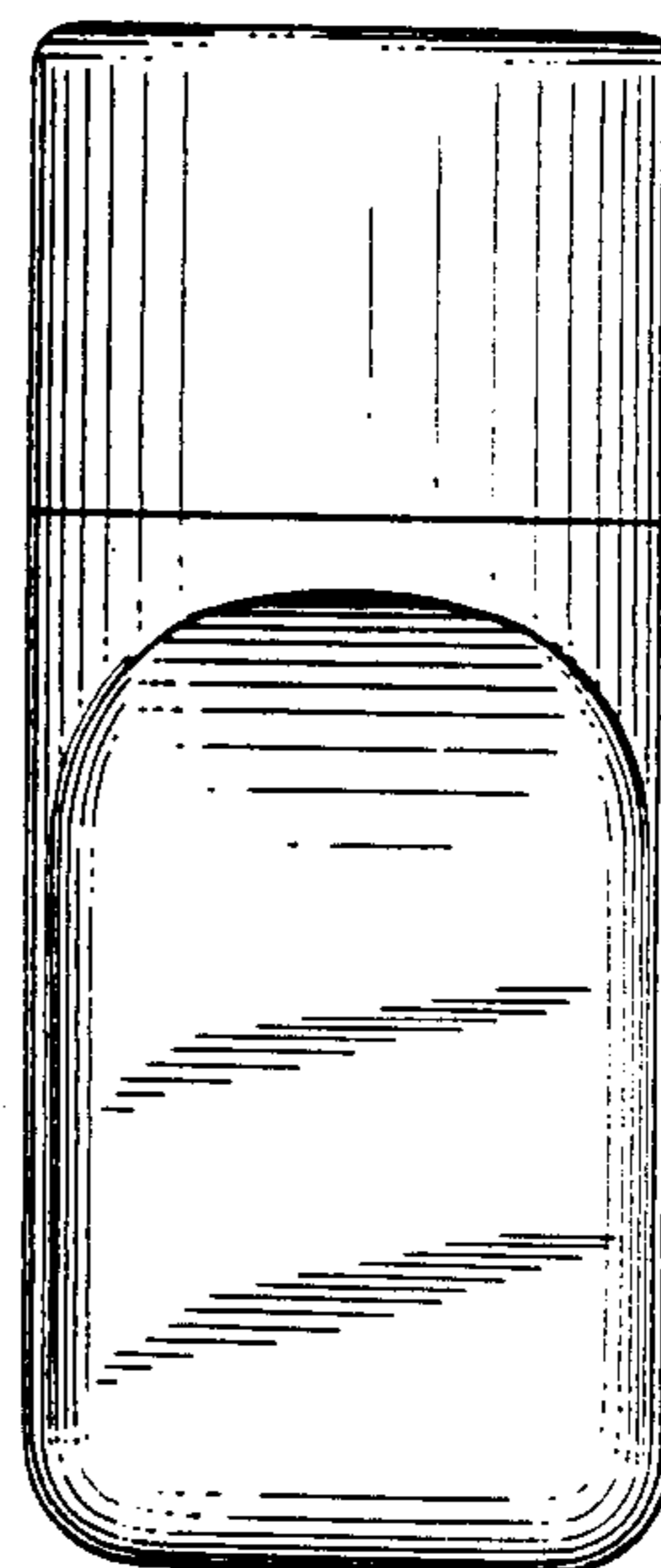
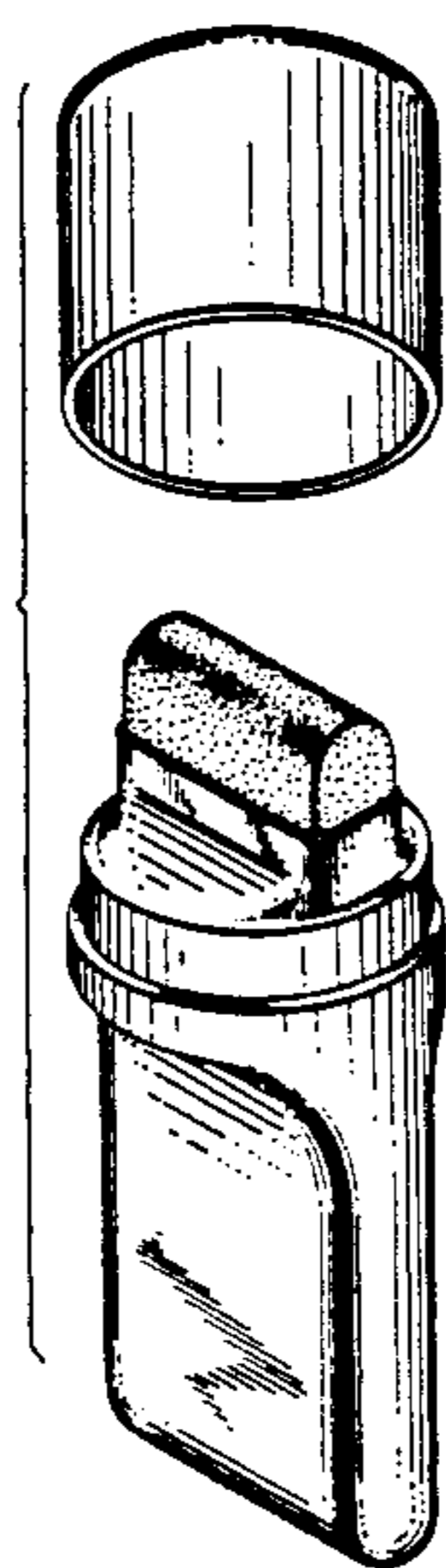

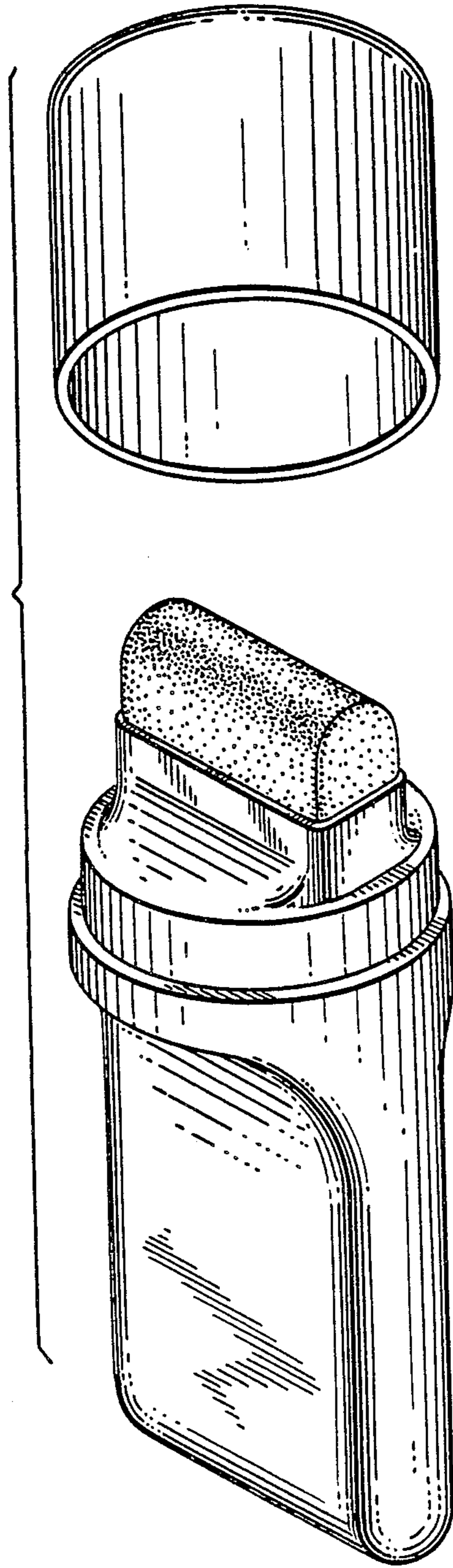

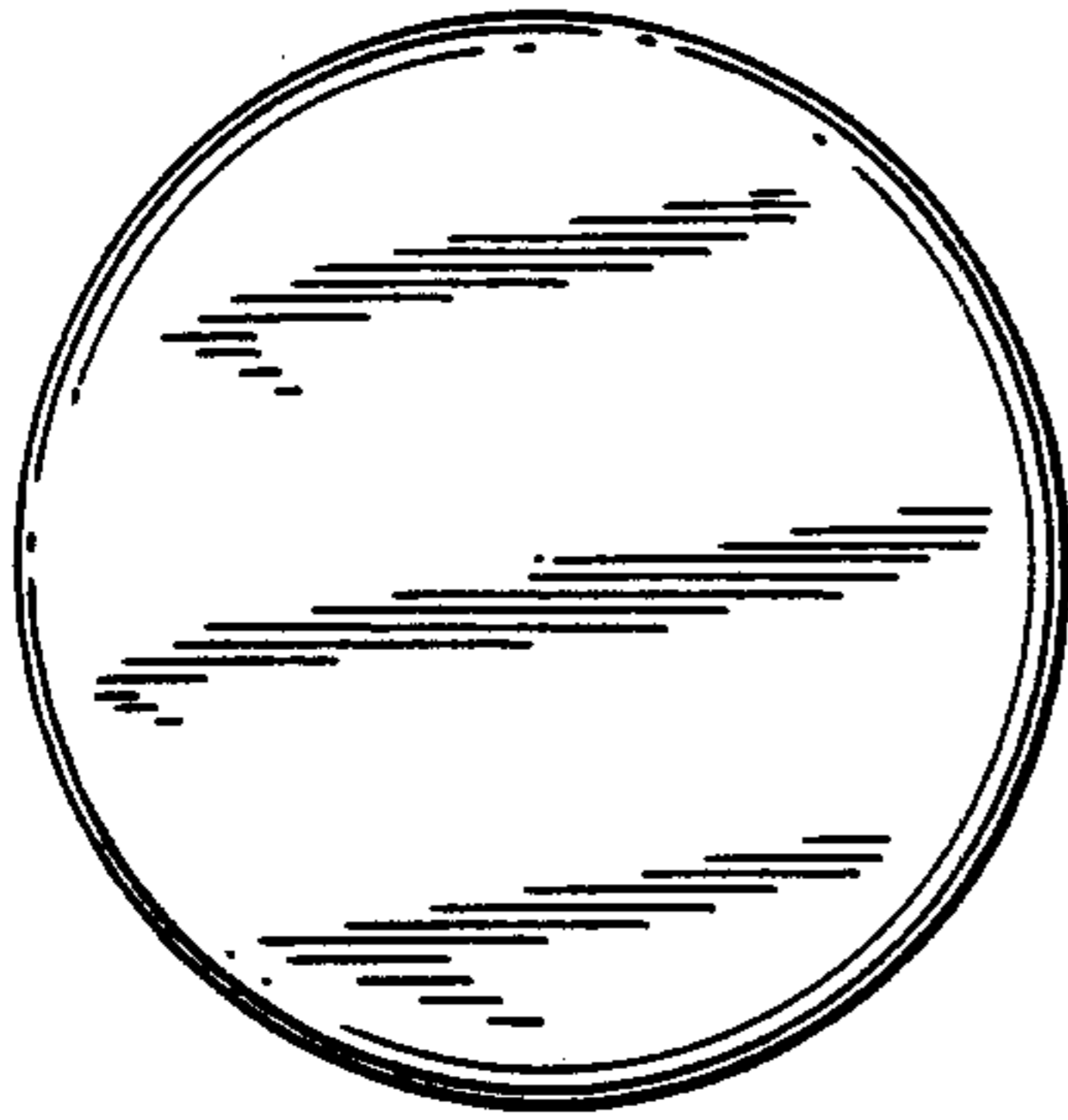

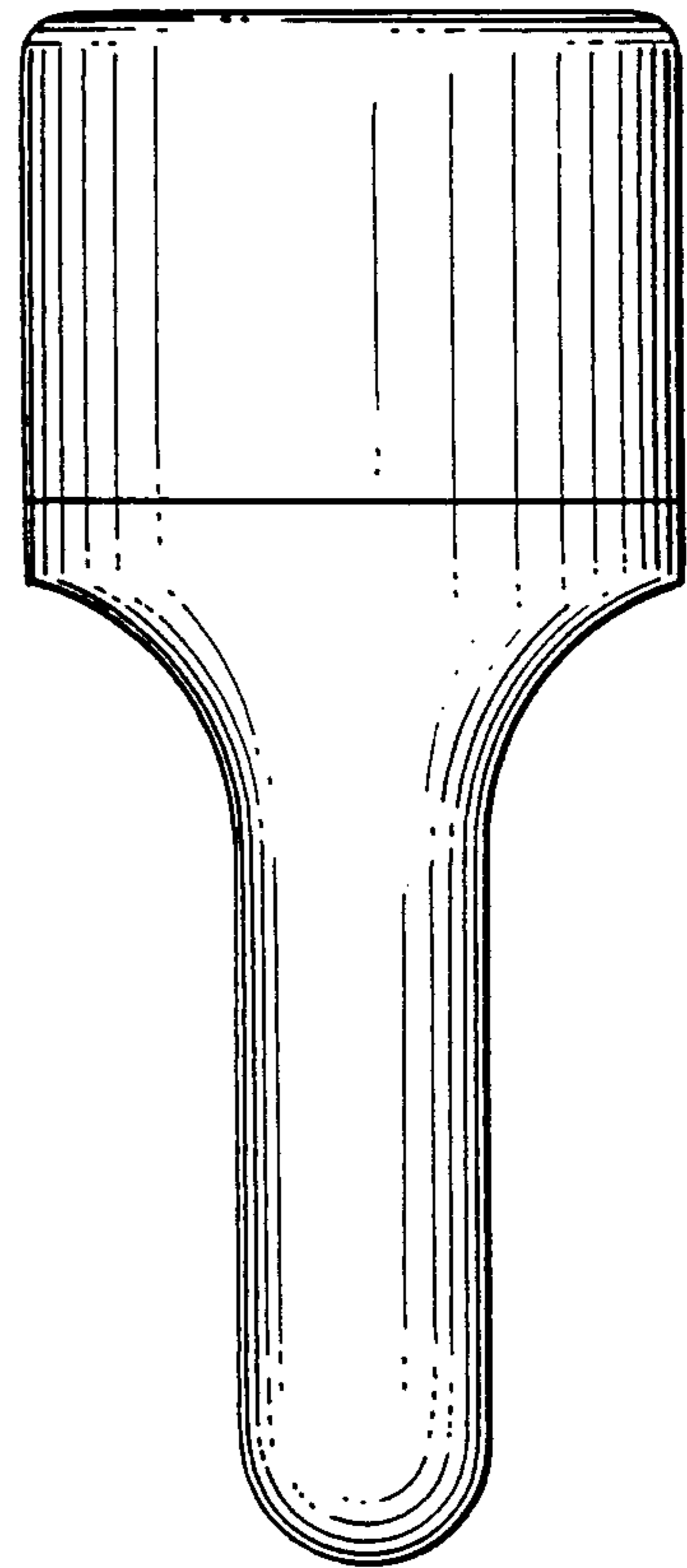

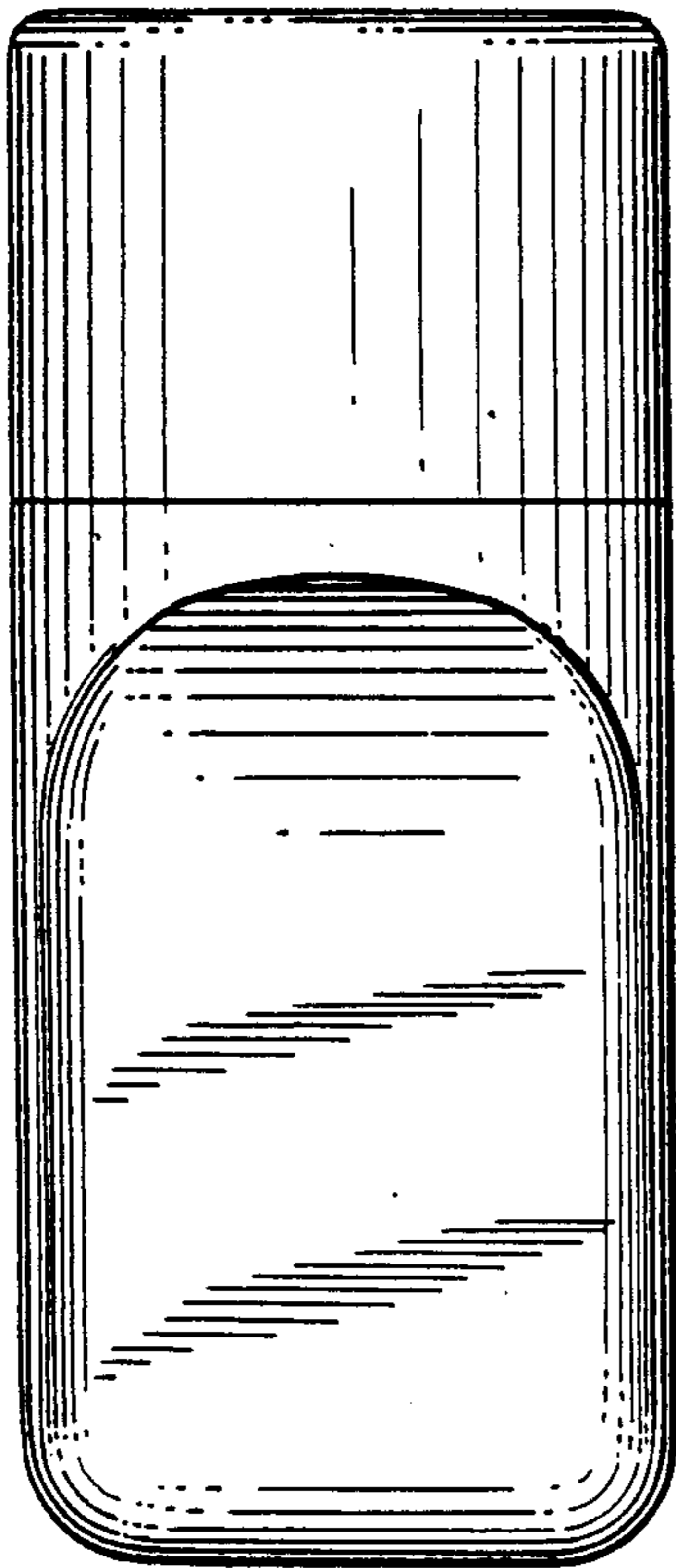
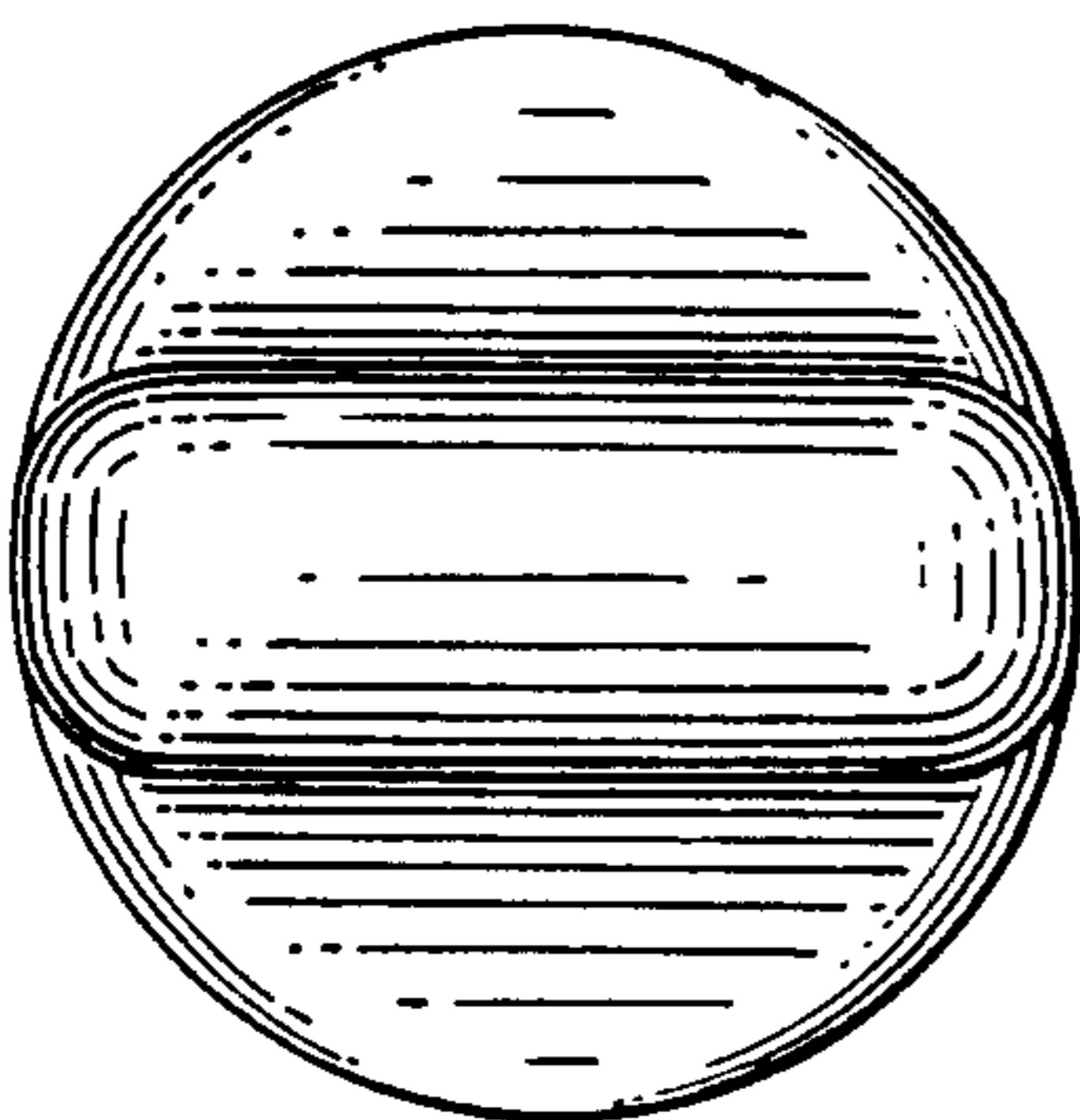
