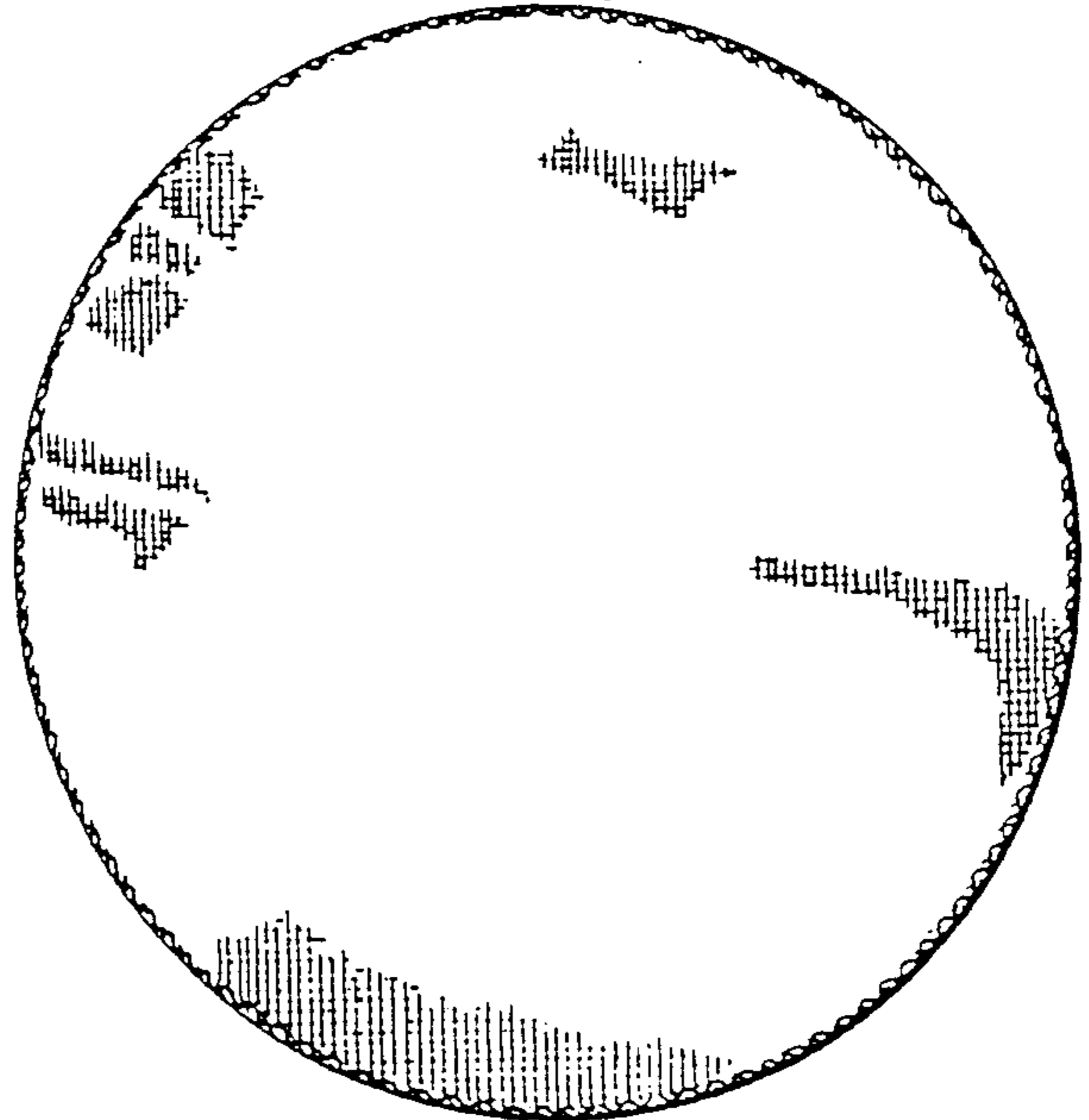
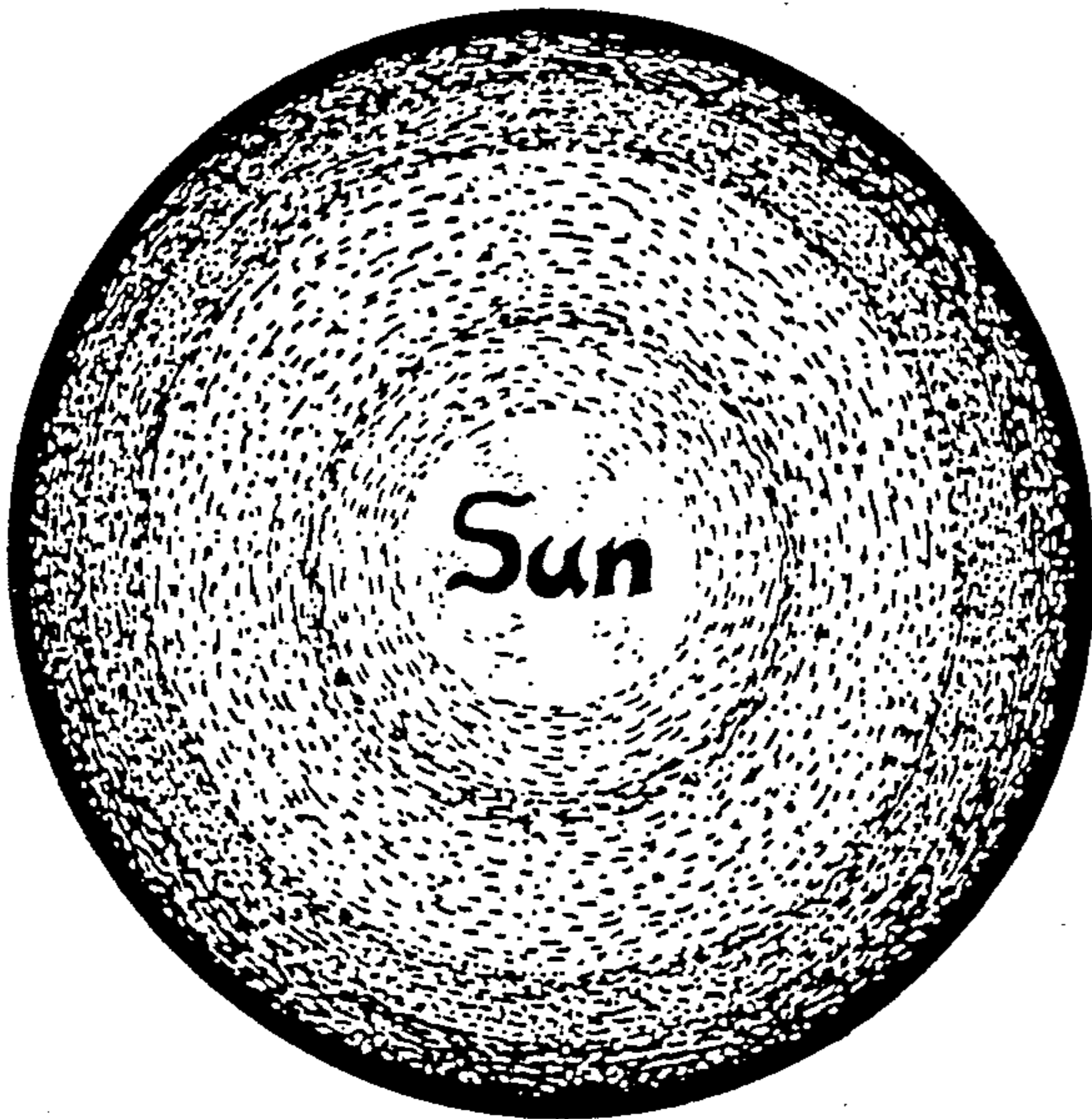
The ornamental design for a circular towel, as shown.

FIG. 3 is a bottom plan view thereof.



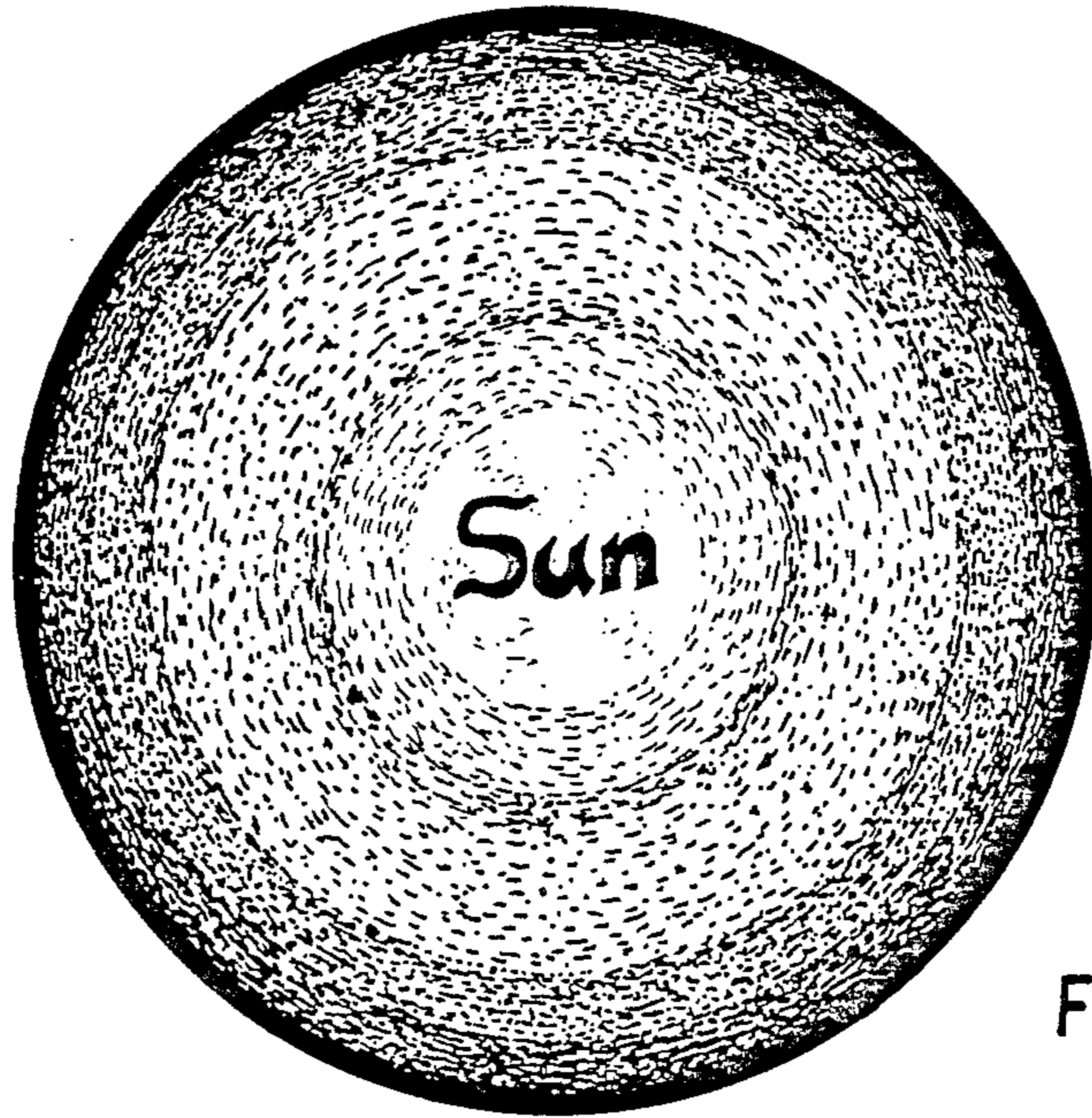

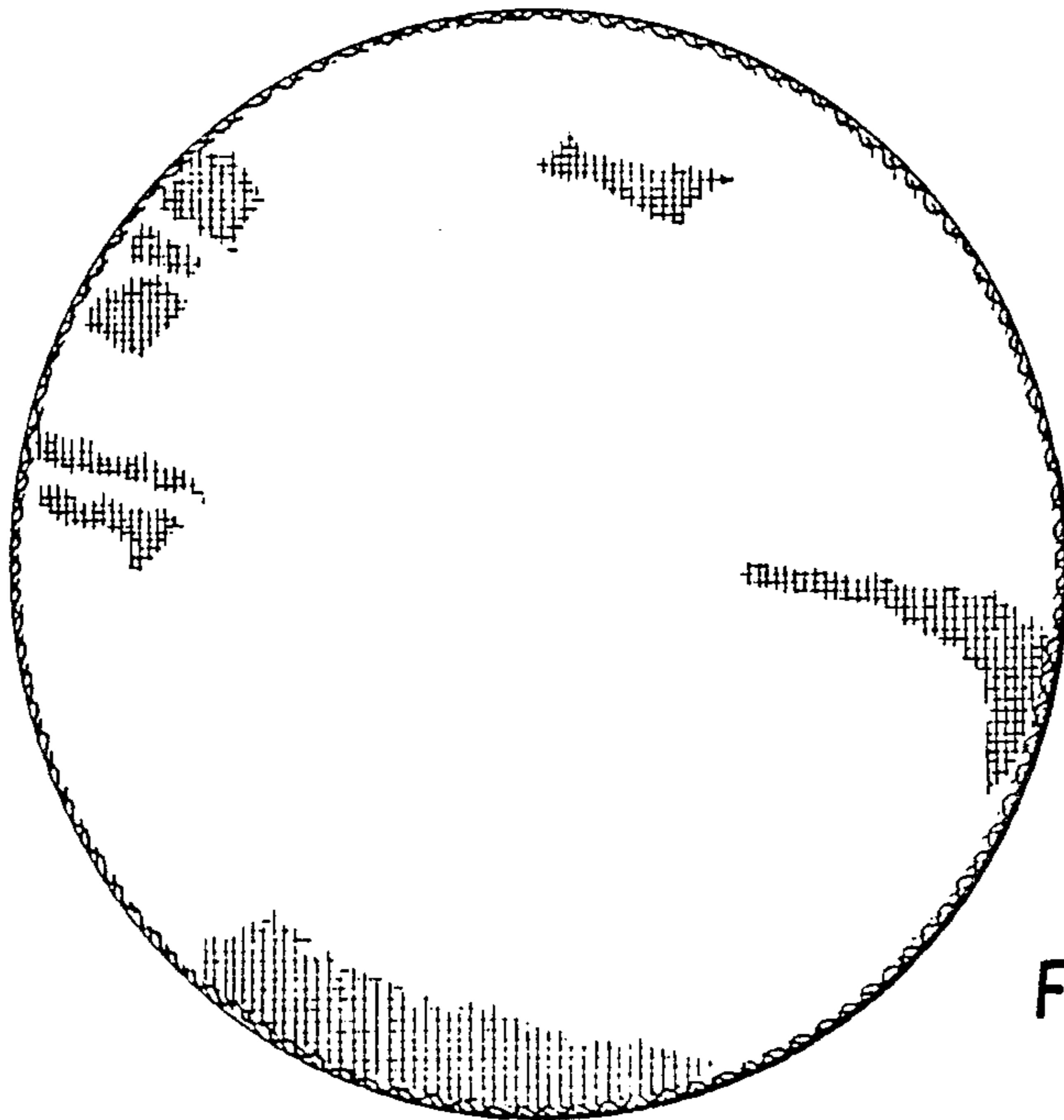
