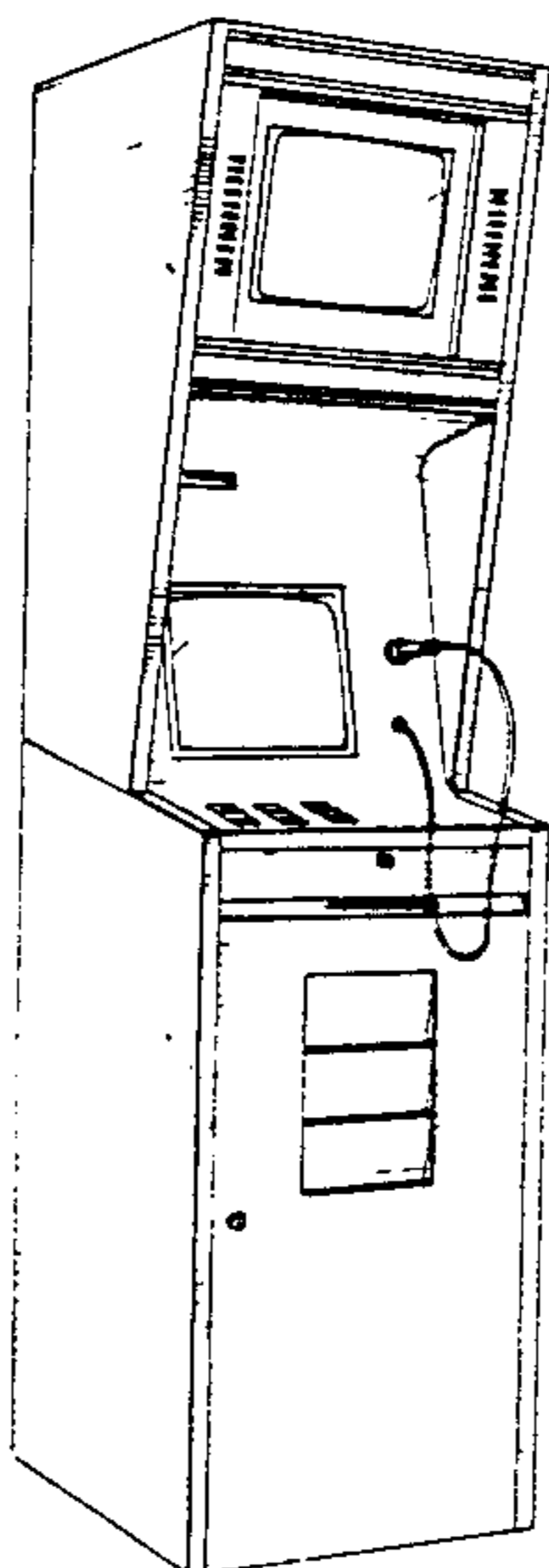

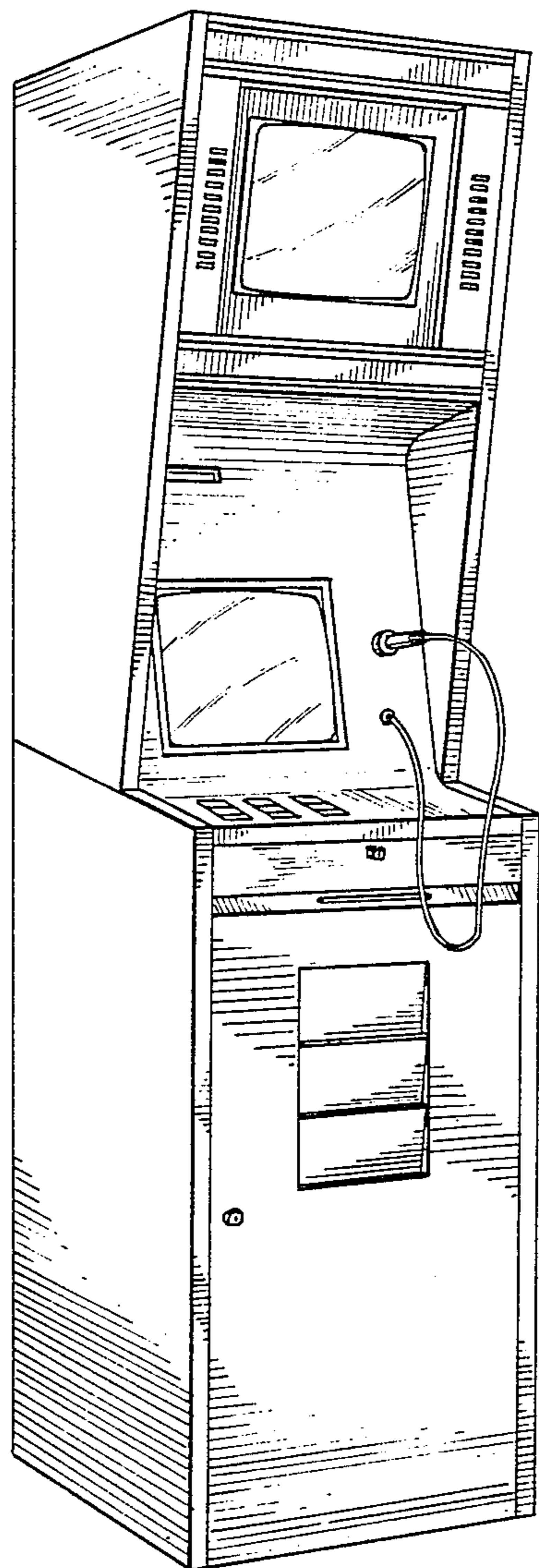
The ornamental design for a computer console, as shown and described.

**DESCRIPTION**

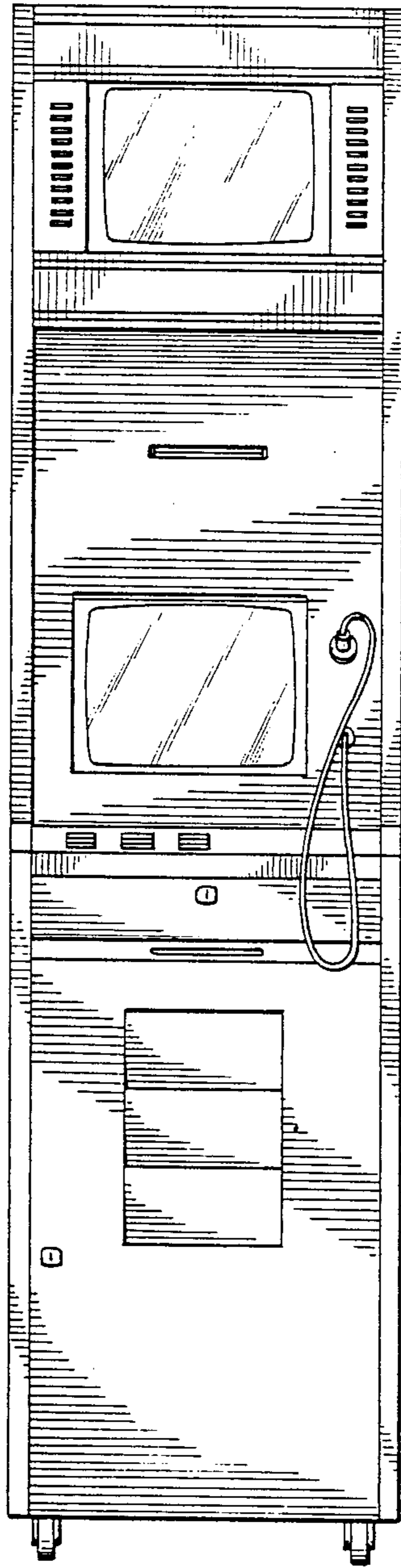
FIG. 1 is a front perspective view of a computer console showing my new design;

 The rear of the console is flat and unornamented.



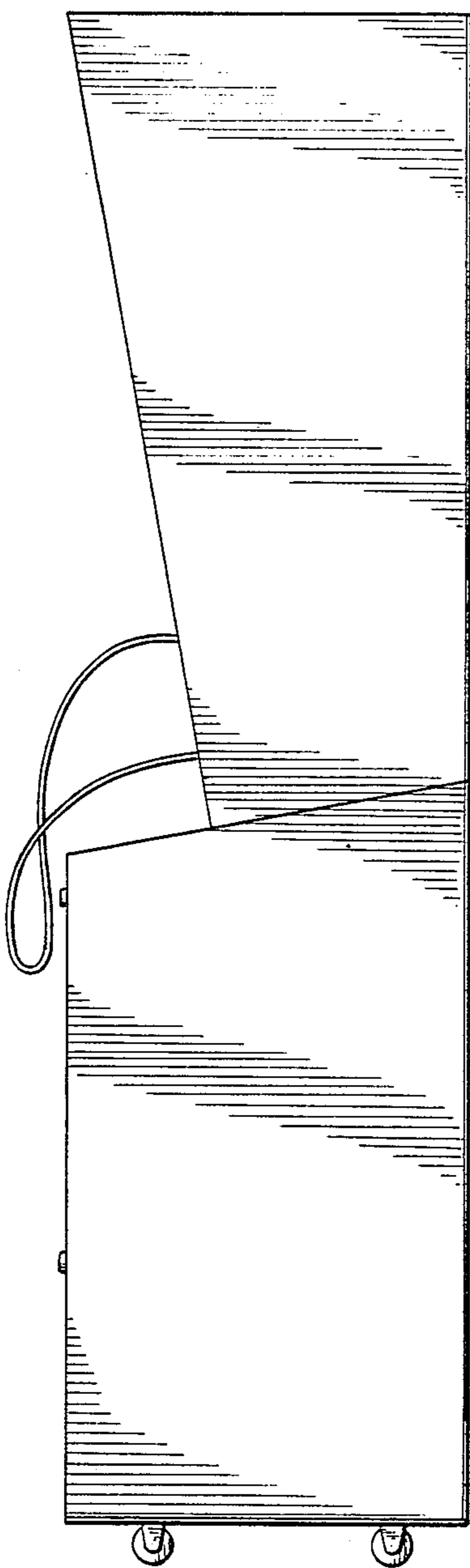

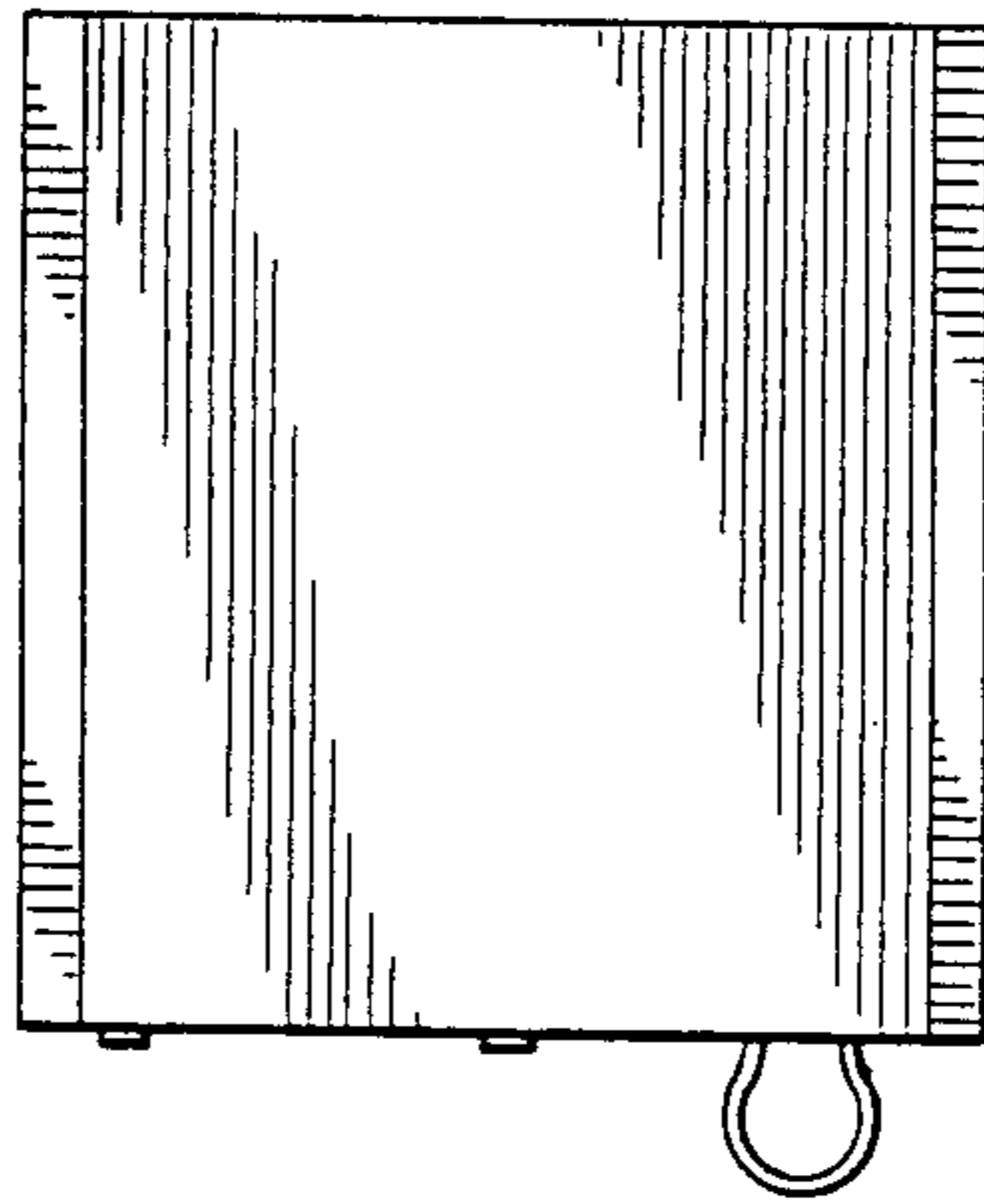
