DESCRIPTION

FIG. 1 is a left side, top and front perspective view of a teleconference control unit showing our new design;

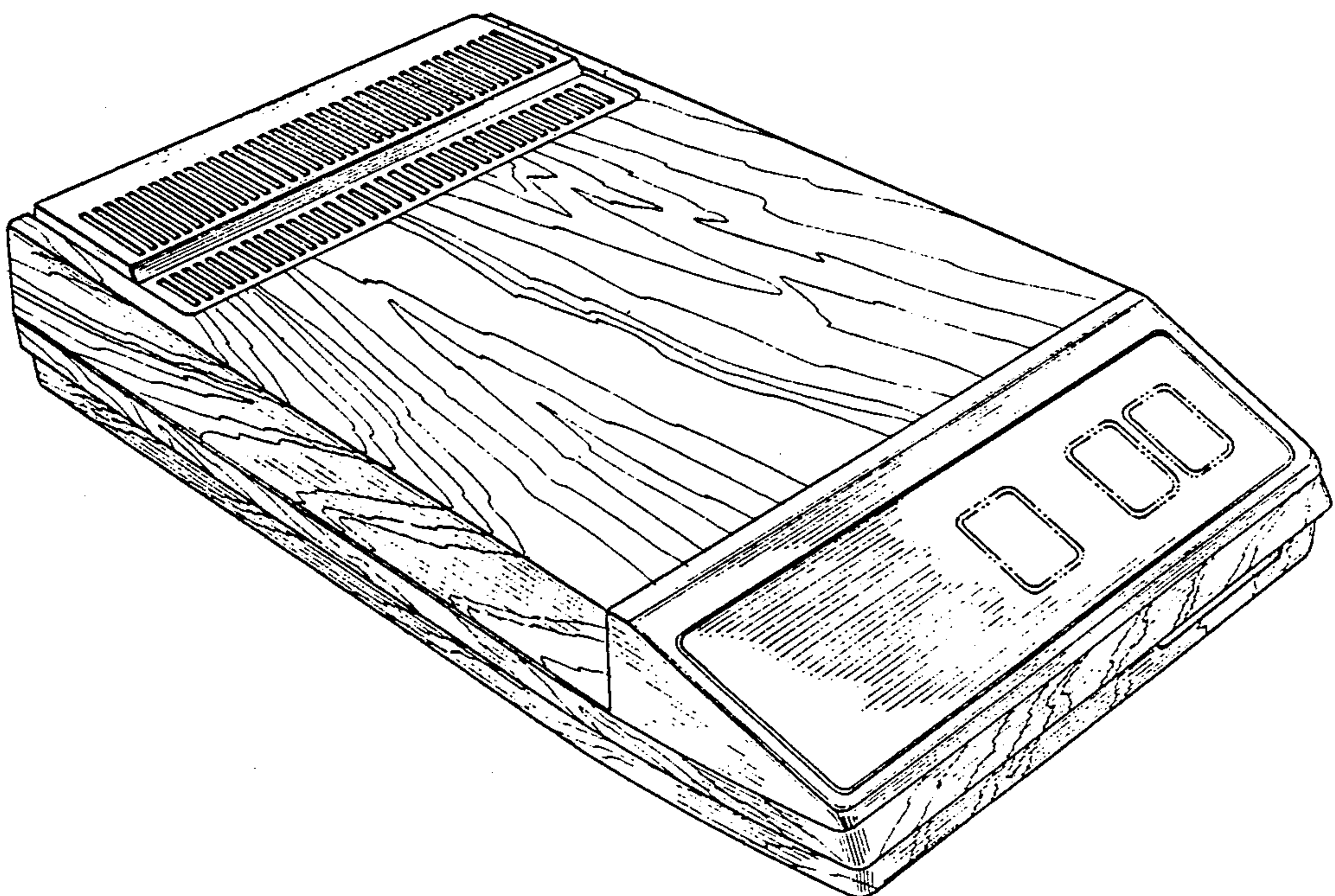
FIG. 2 is a top plan view thereof;

FIG. 3 is a right side elevational view thereof;

FIGS. 4 and 5 are respectively front and rear elevational views thereof; and,

FIG. 6 is a bottom plan view thereof.

The broken line showing of control buttons in the key pad area of FIGS. 1, 2 and 4 is for illustrative purposes only and forms no part of the claimed design.



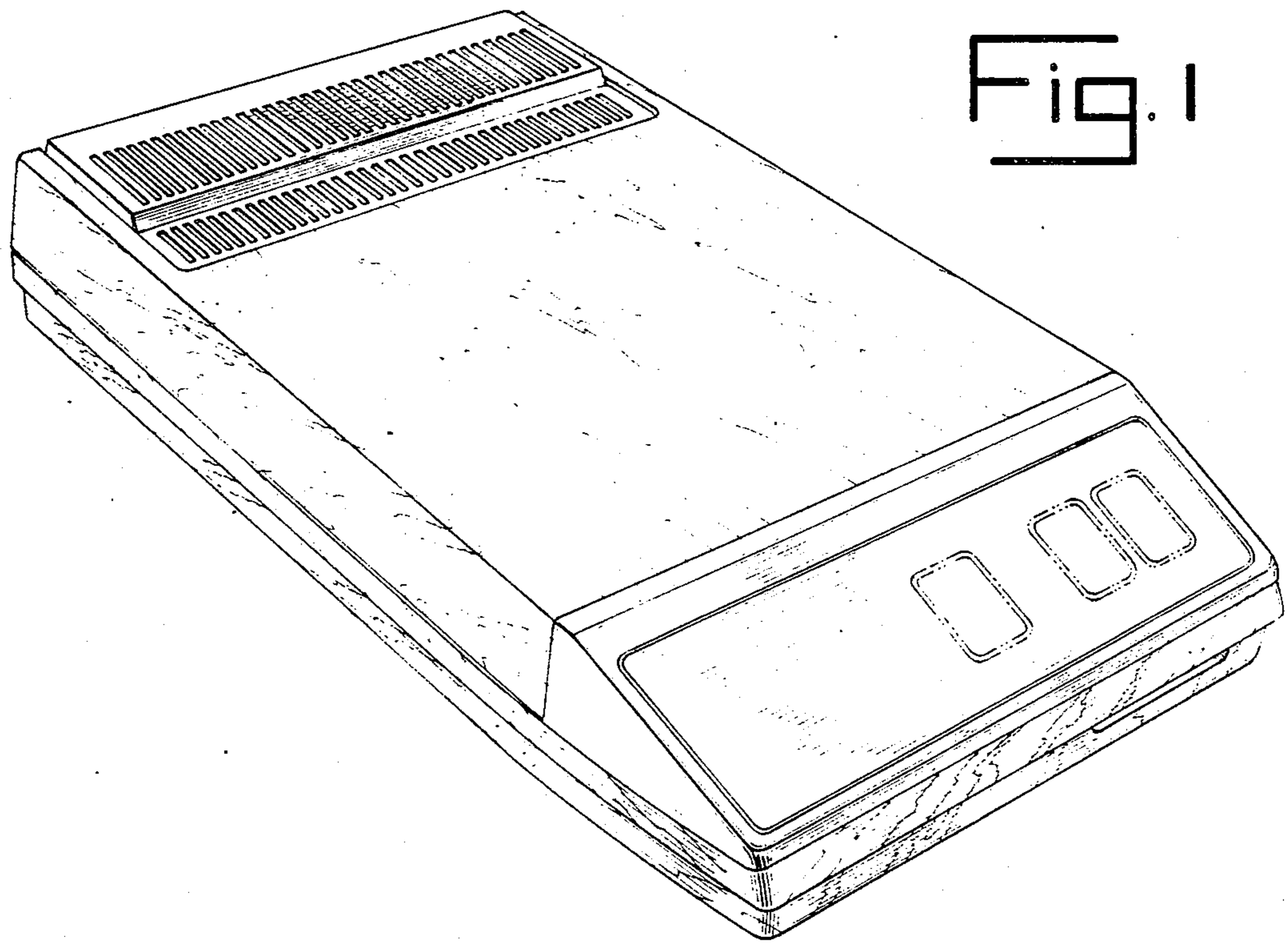

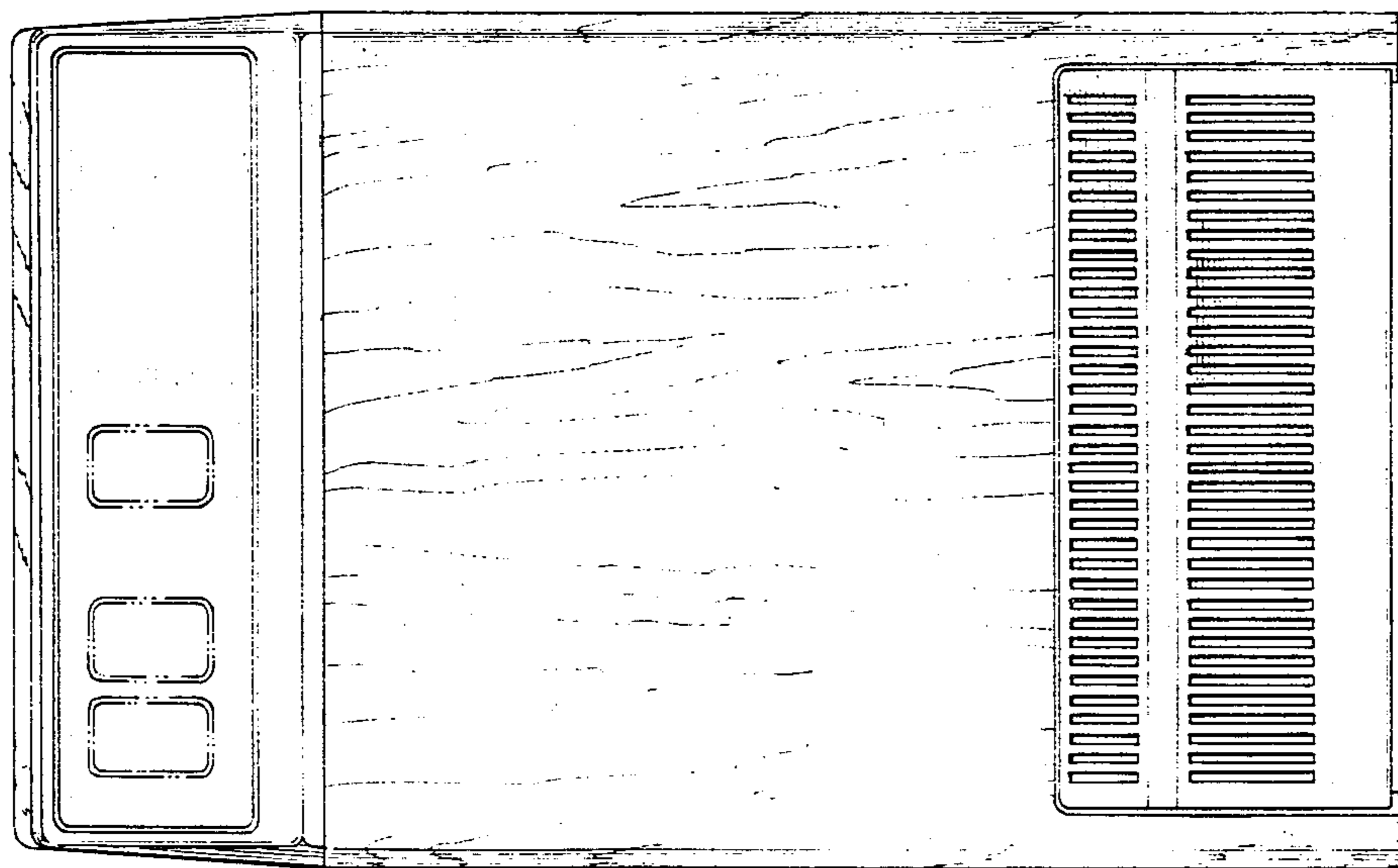

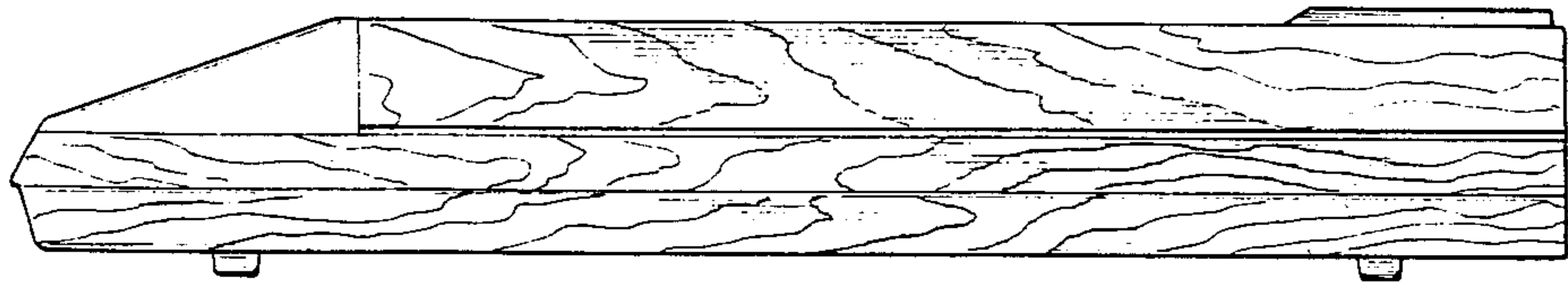

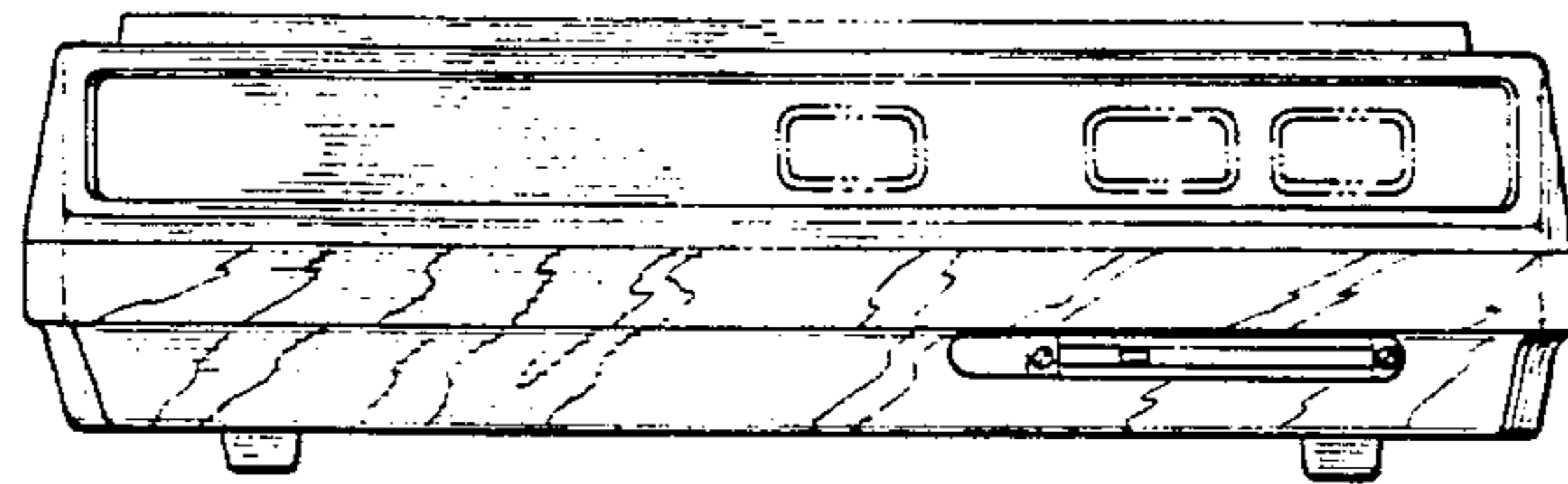

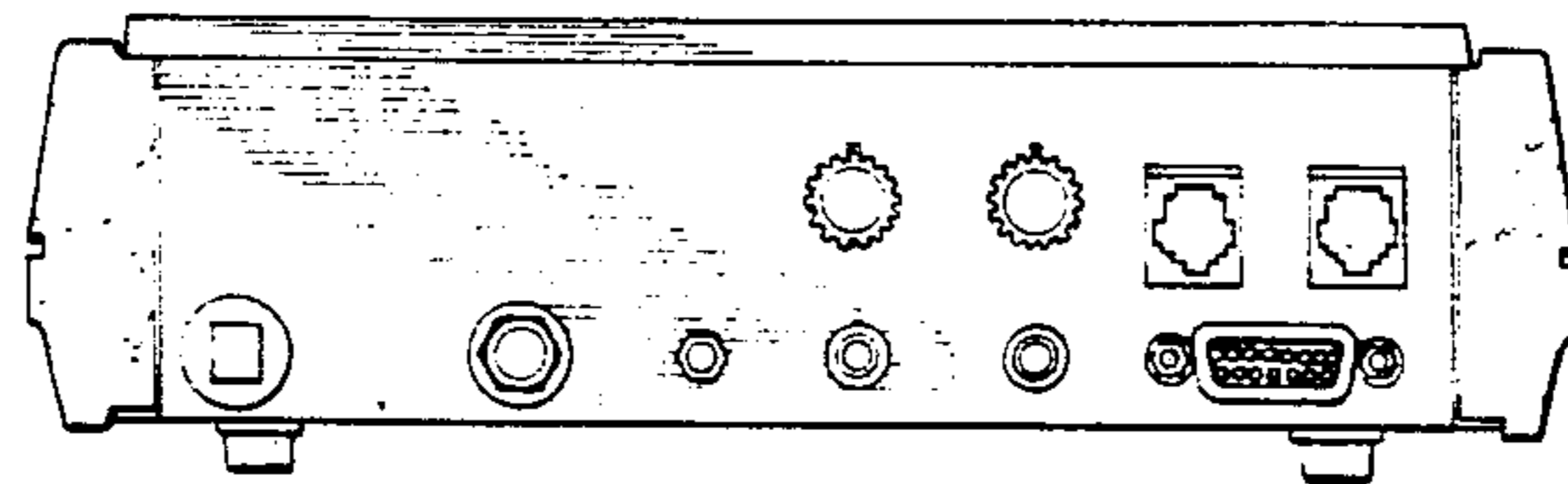
