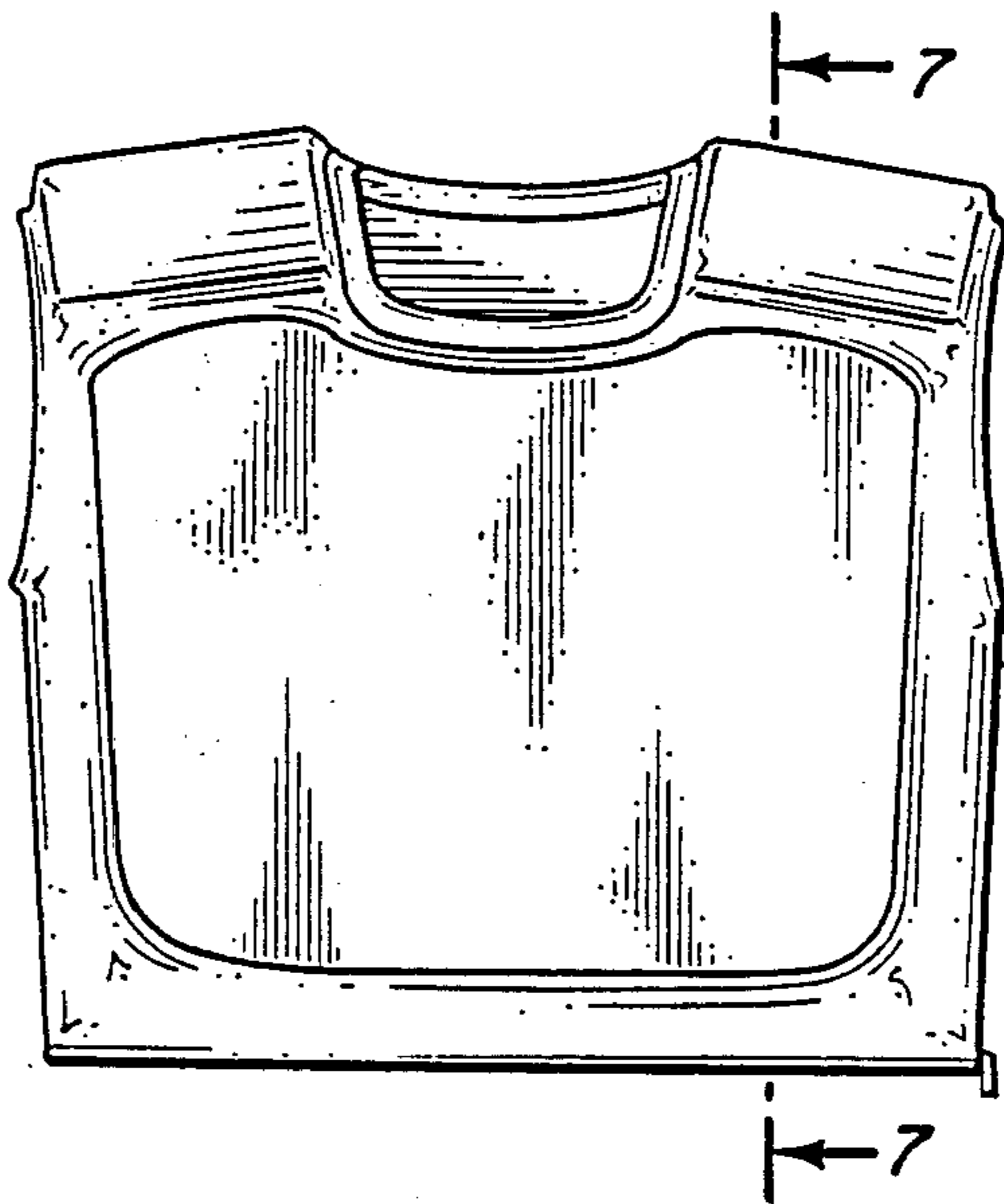

[57] CLAIM

The ornamental design for a flotation aid, as shown and described.

FIG. 1 is a front elevational view of a flotation aid, showing my new design;
 FIG. 2 is a right side elevational view thereof;
 FIG. 3 is a left side elevational view thereof;
 FIG. 4 is a rear elevational view thereof;
 FIG. 5 is a top plan view thereof;
 FIG. 6 is a bottom plan view thereof;
 FIG. 7 is an enlarged sectional view taken along line 7—7 of FIG. 1 thereof;
 FIG. 8 is a front elevational view of a flotation aid, showing a second embodiment, the sole difference from the first embodiment being the continuous one piece foam insert;
 FIG. 9 is an enlarged sectional view taken along line 9—9 of FIG. 8;

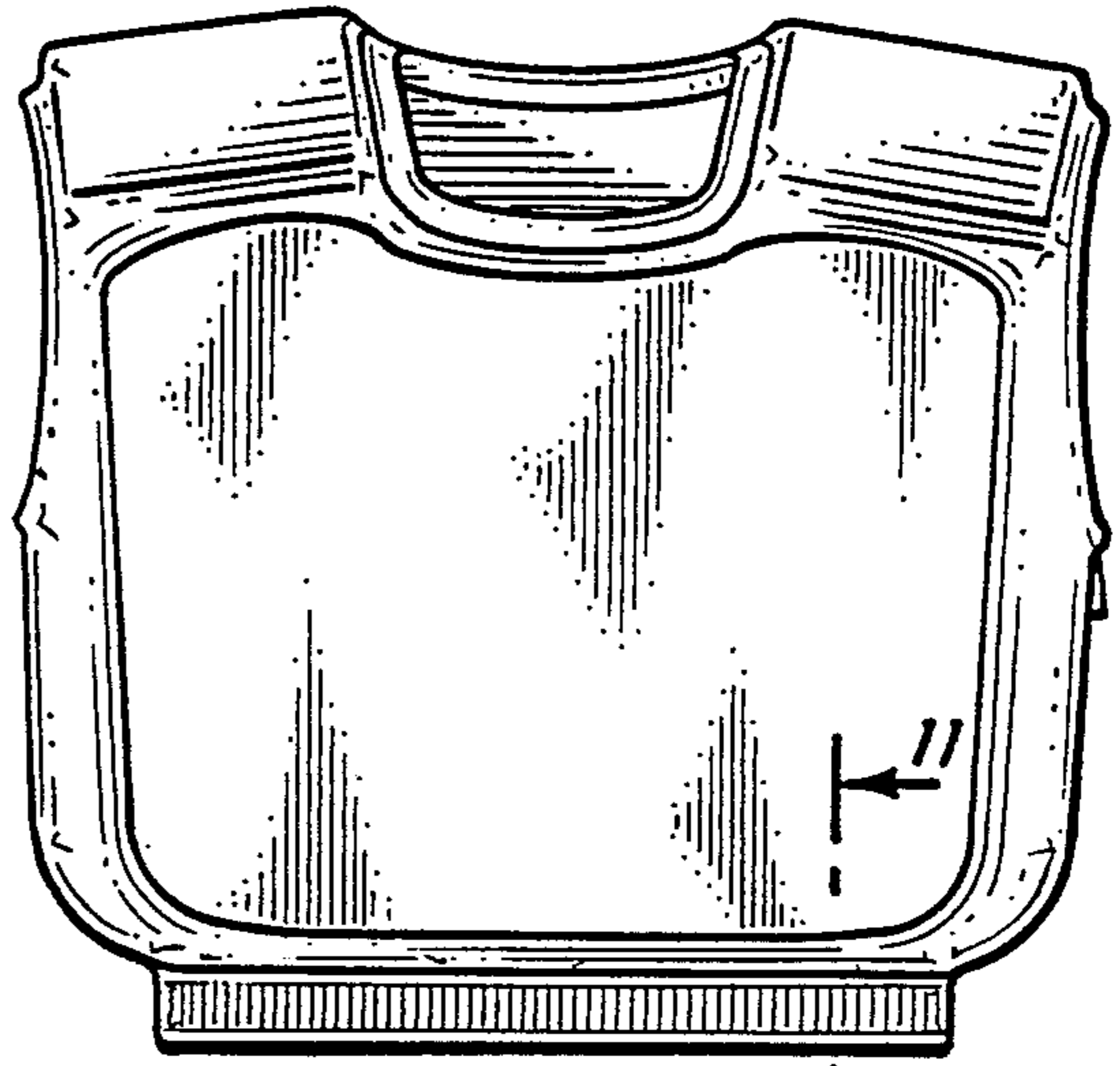


Fig. 10. |←11

 FIG. 10 is a front elevational view of a flotation aid, showing a third embodiment, the sole difference from the first embodiment being in the elastic waste band attached to the lower portion of the flotation aid;
 FIG. 11 is an enlarged sectional view taken along line 11—11 of FIG. 10;
 FIG. 12 is a front elevational view of a flotation aid, showing a fourth embodiment, the sole difference from the first embodiment being in the additional sleeves attached thereto;
 FIG. 13 is a front elevational view of a flotation aid, showing a fifth embodiment;
 FIG. 14 is a side elevational view of FIG. 13;
 FIG. 15 is a rear elevational view of FIG. 13;
 FIG. 16 is a top plan view of FIG. 13; and,
 FIG. 17 is a bottom plan view of FIG. 13.



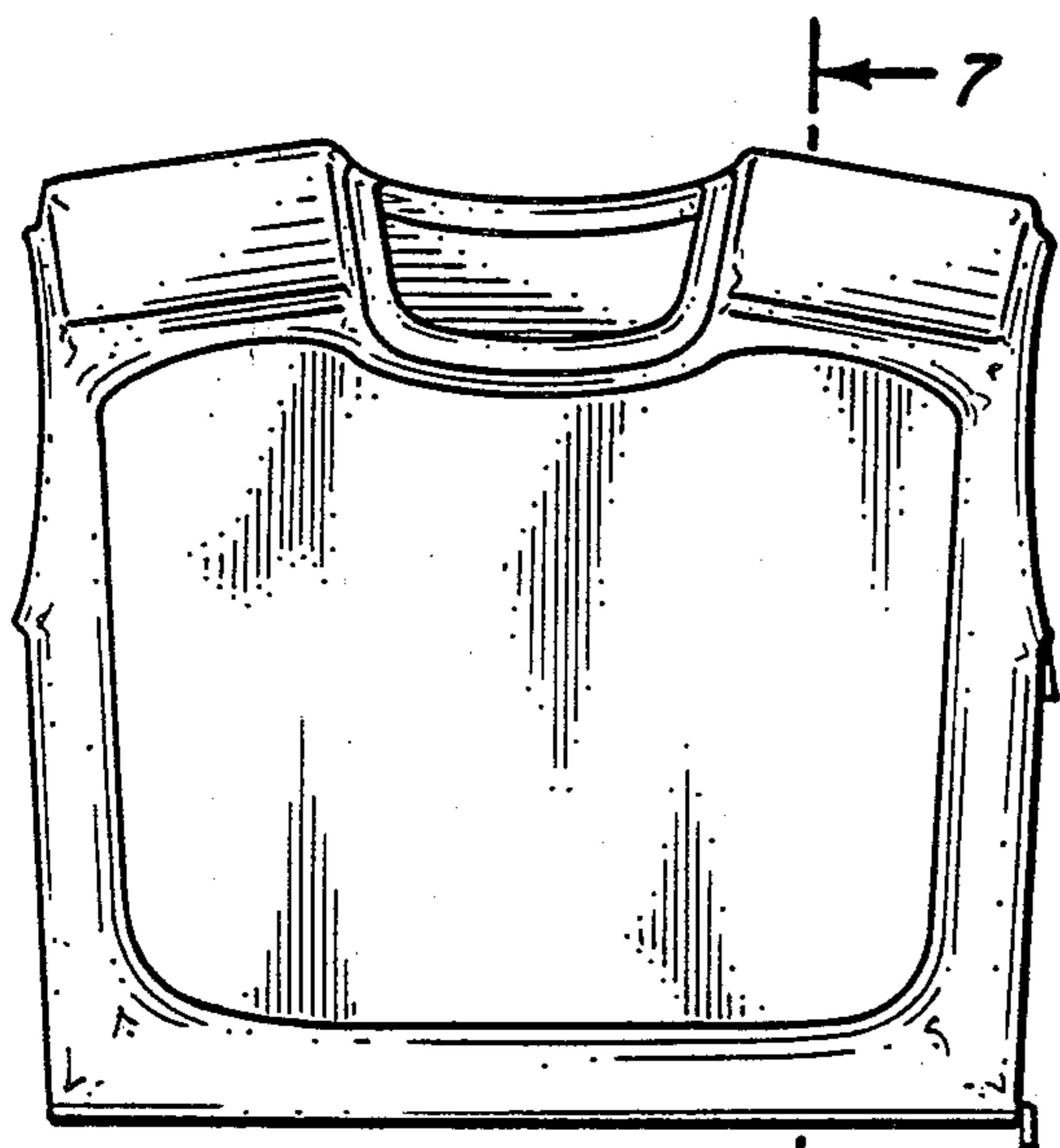

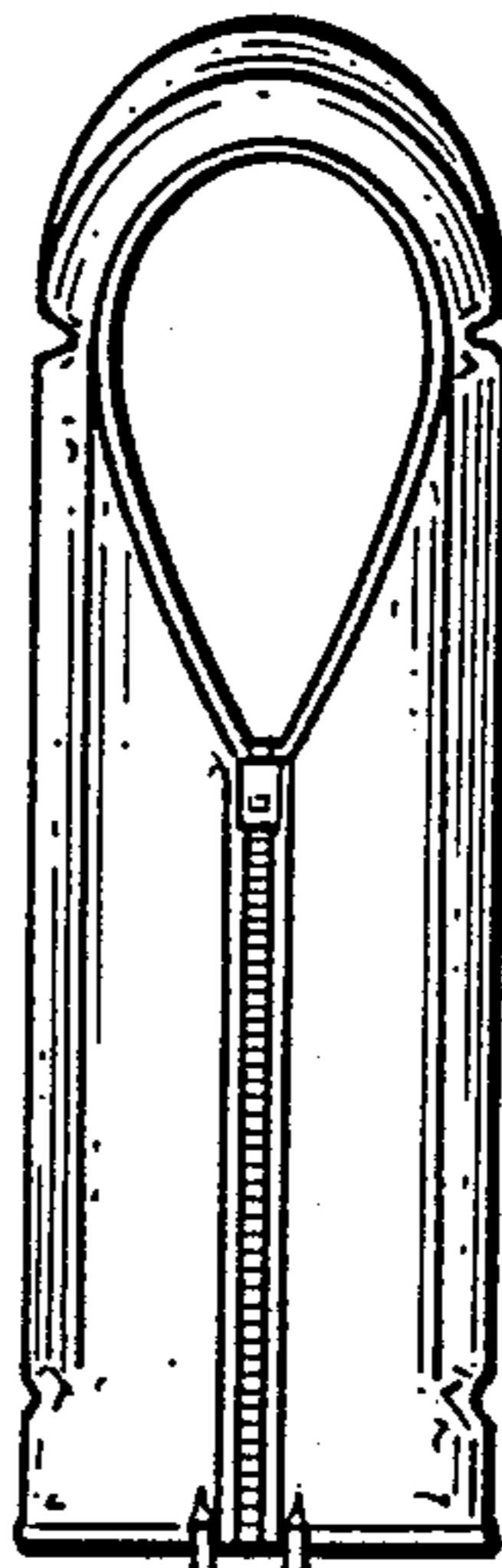

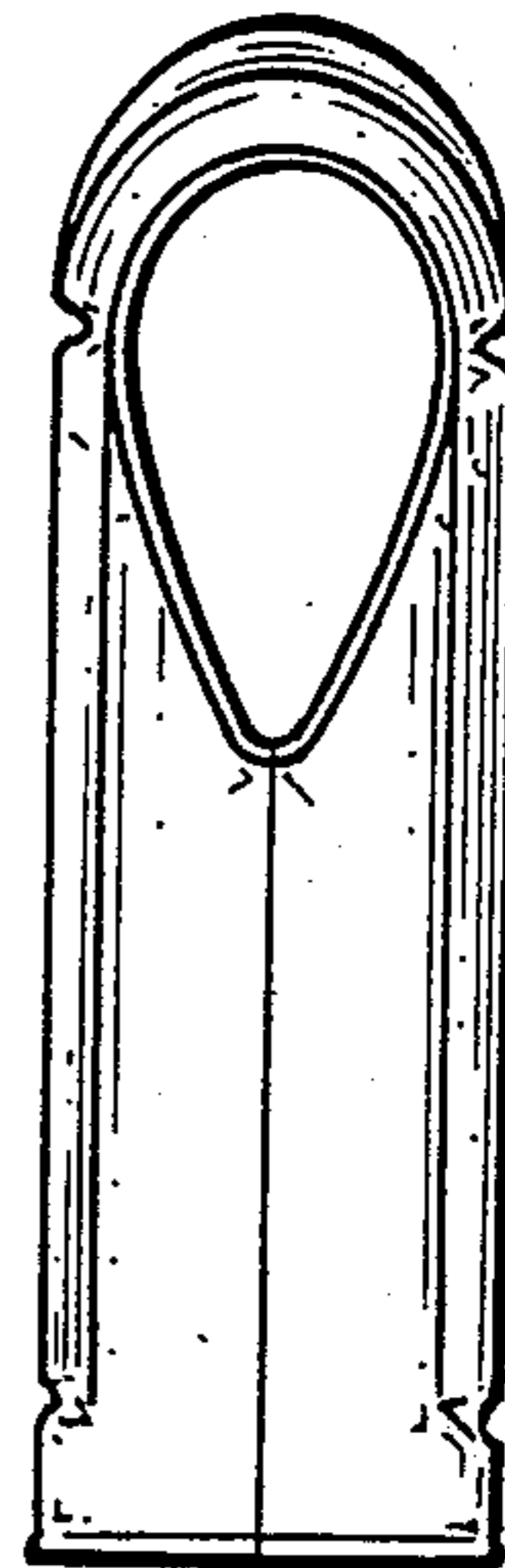

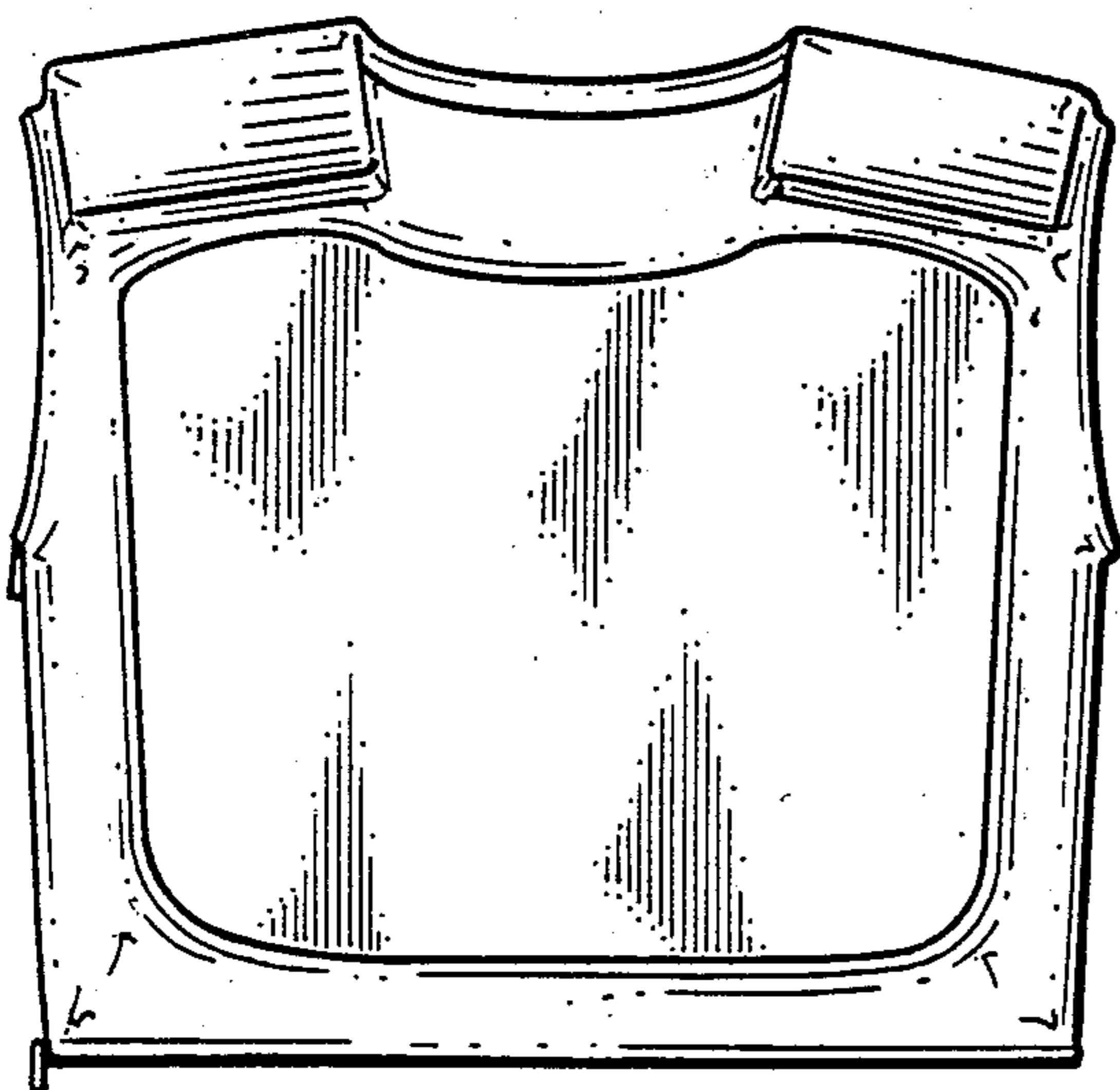

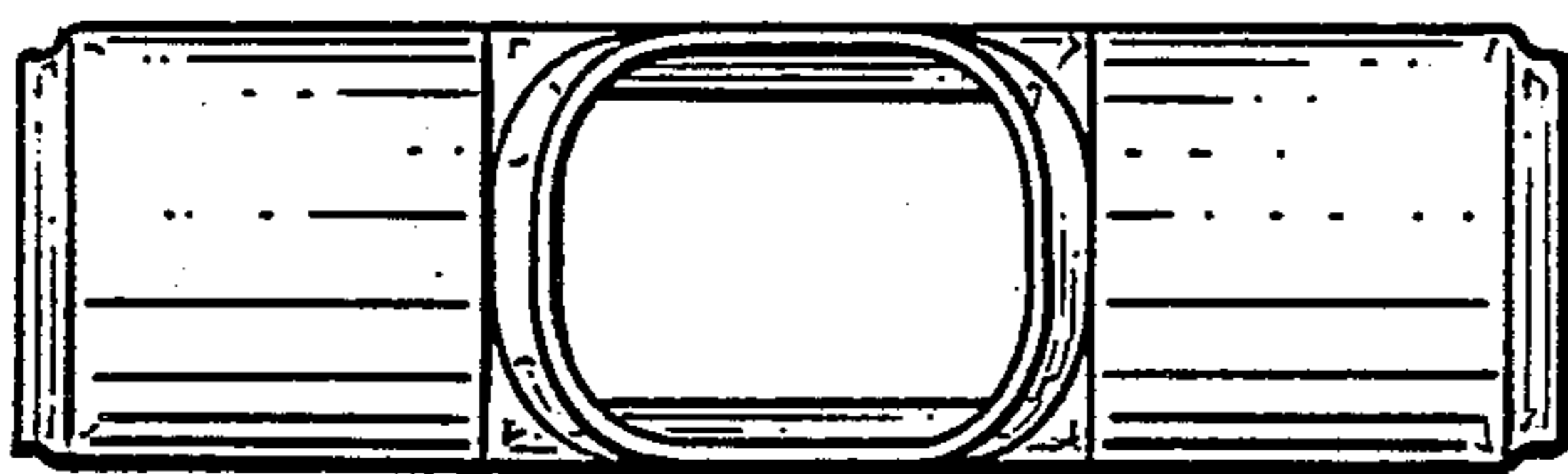

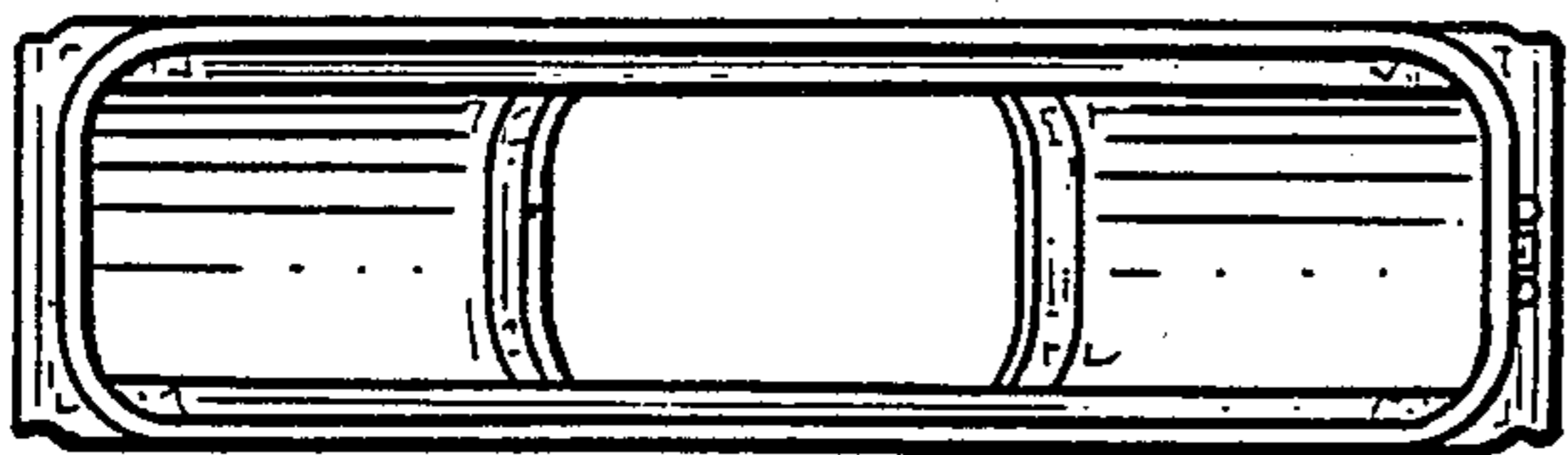

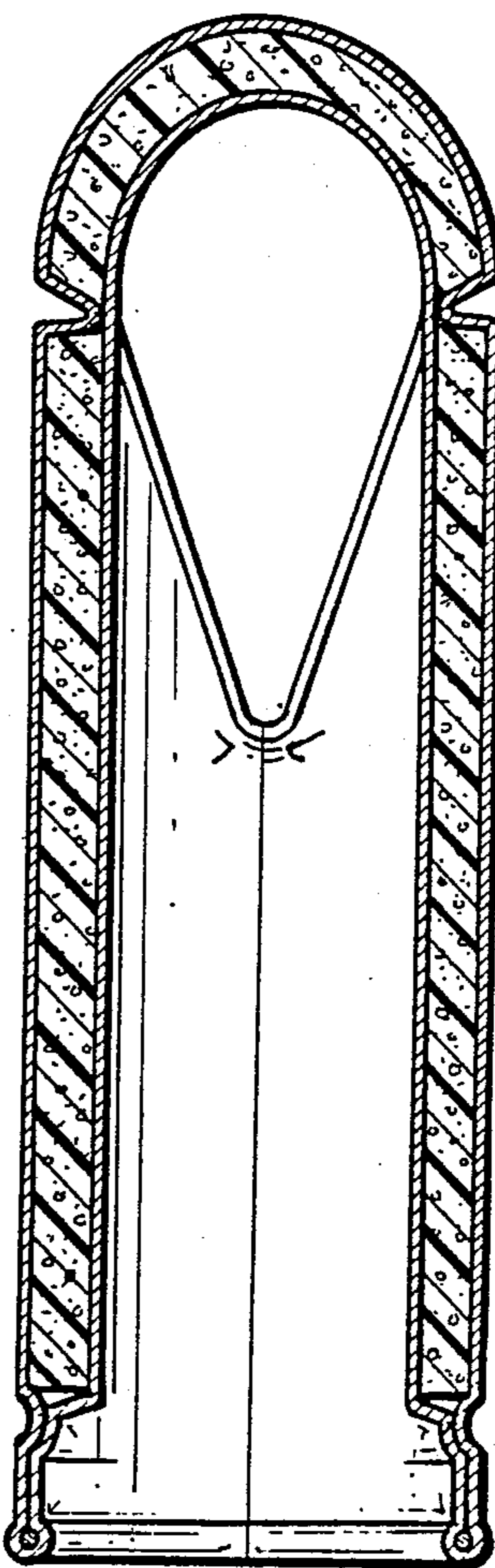

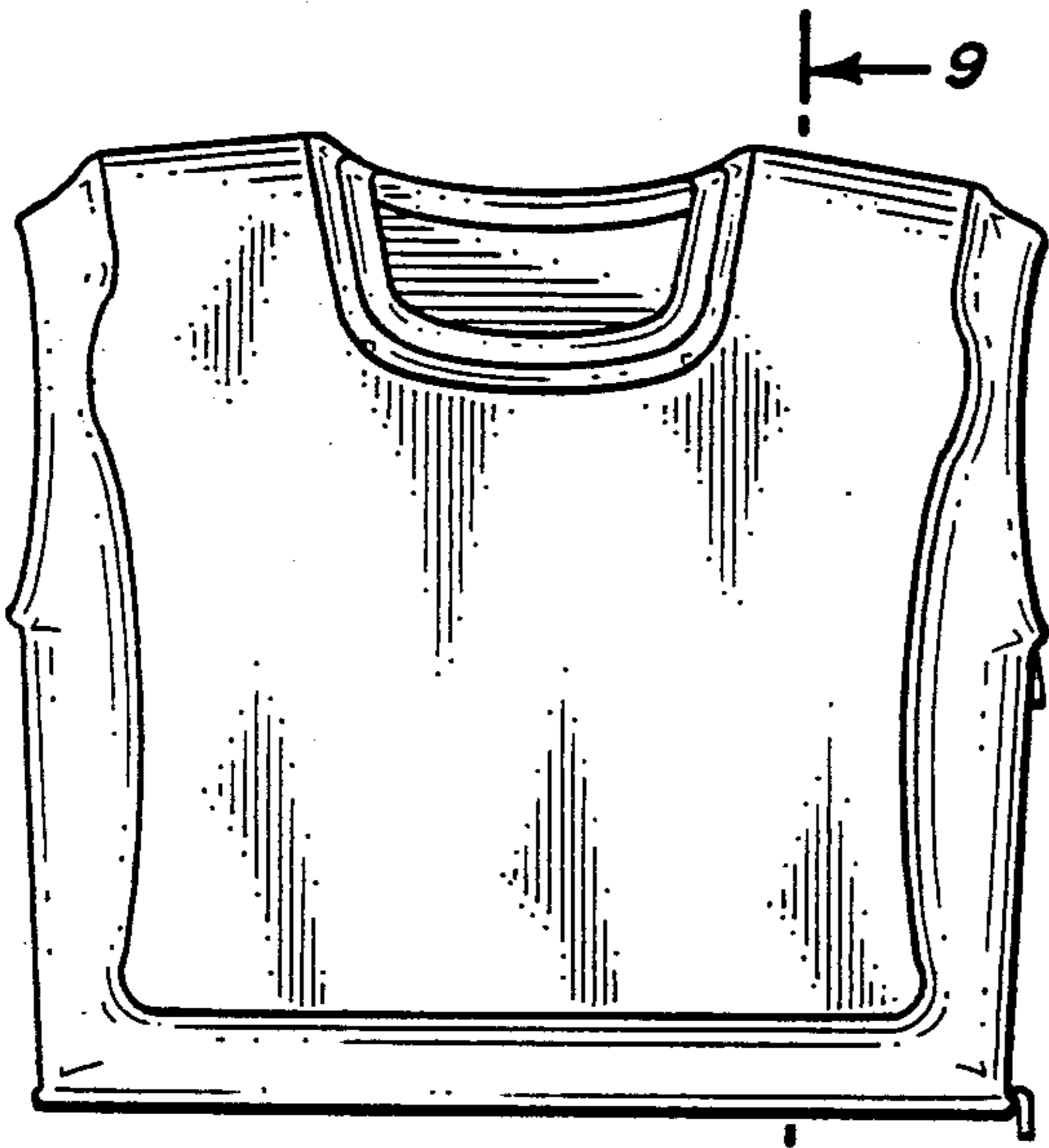

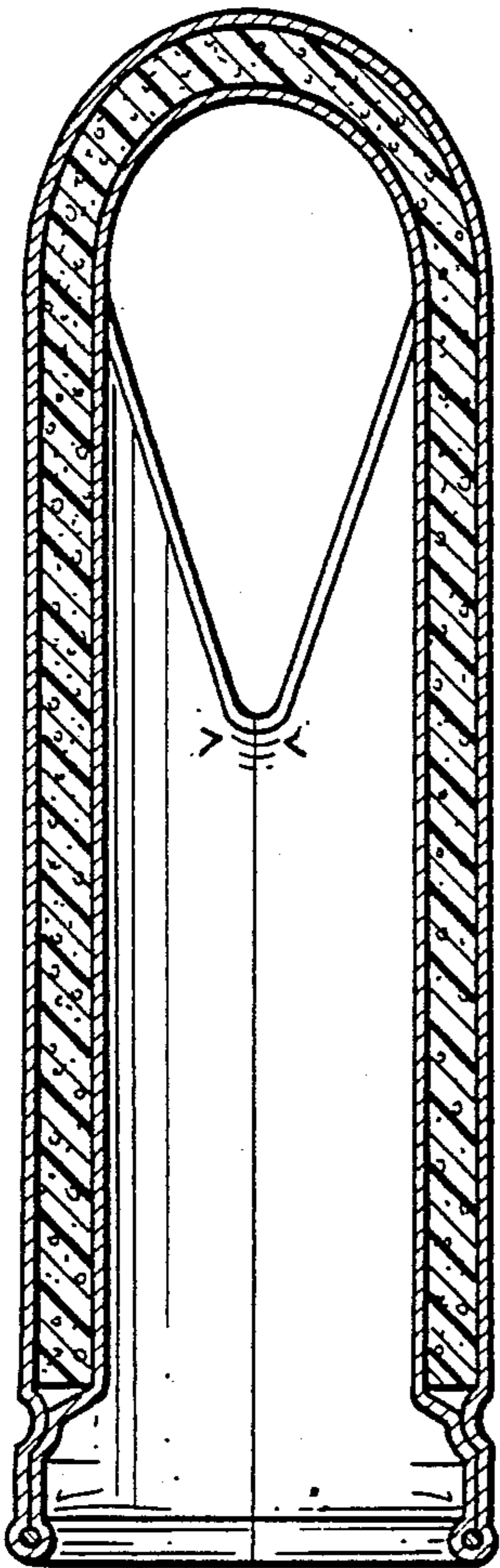

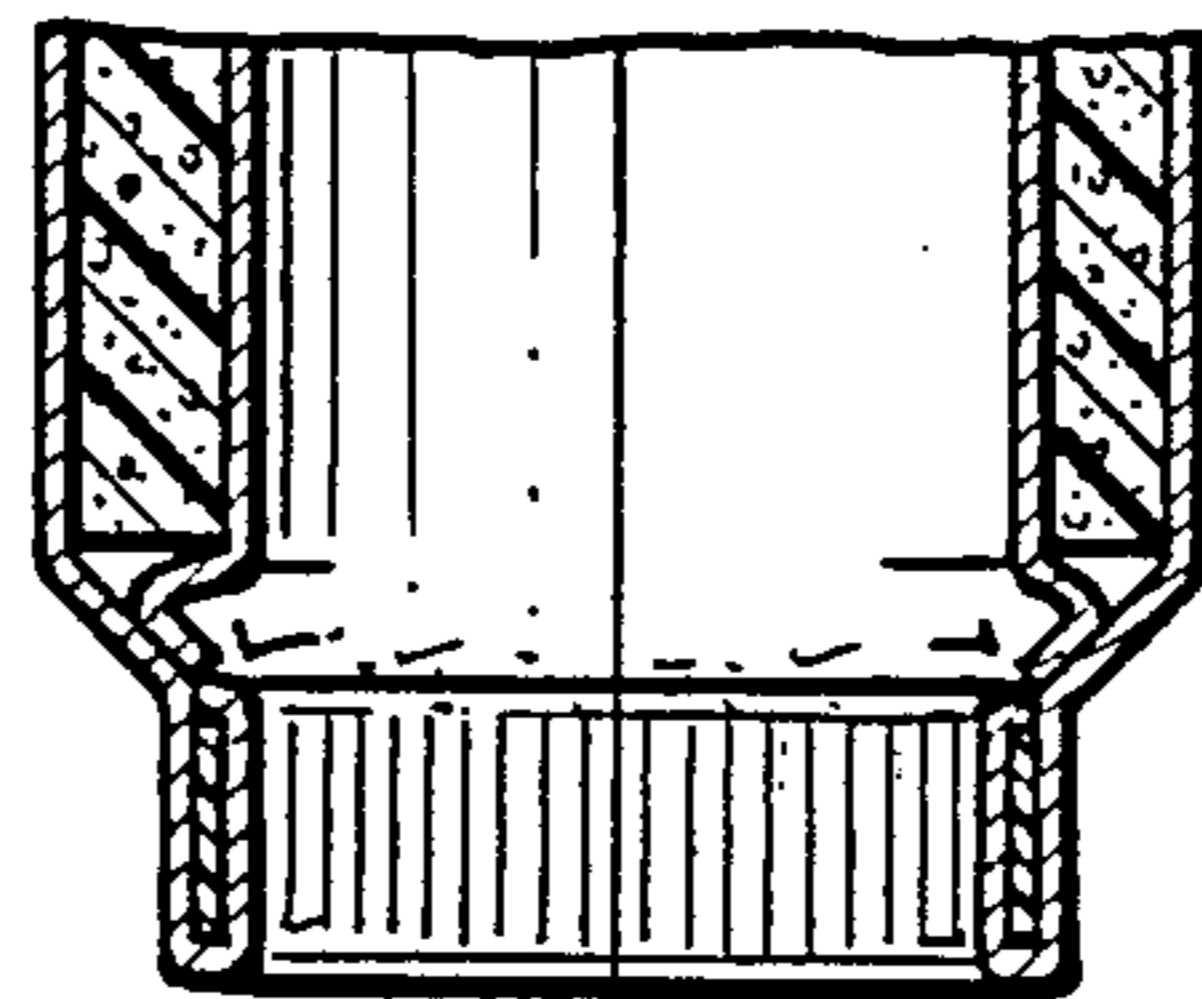

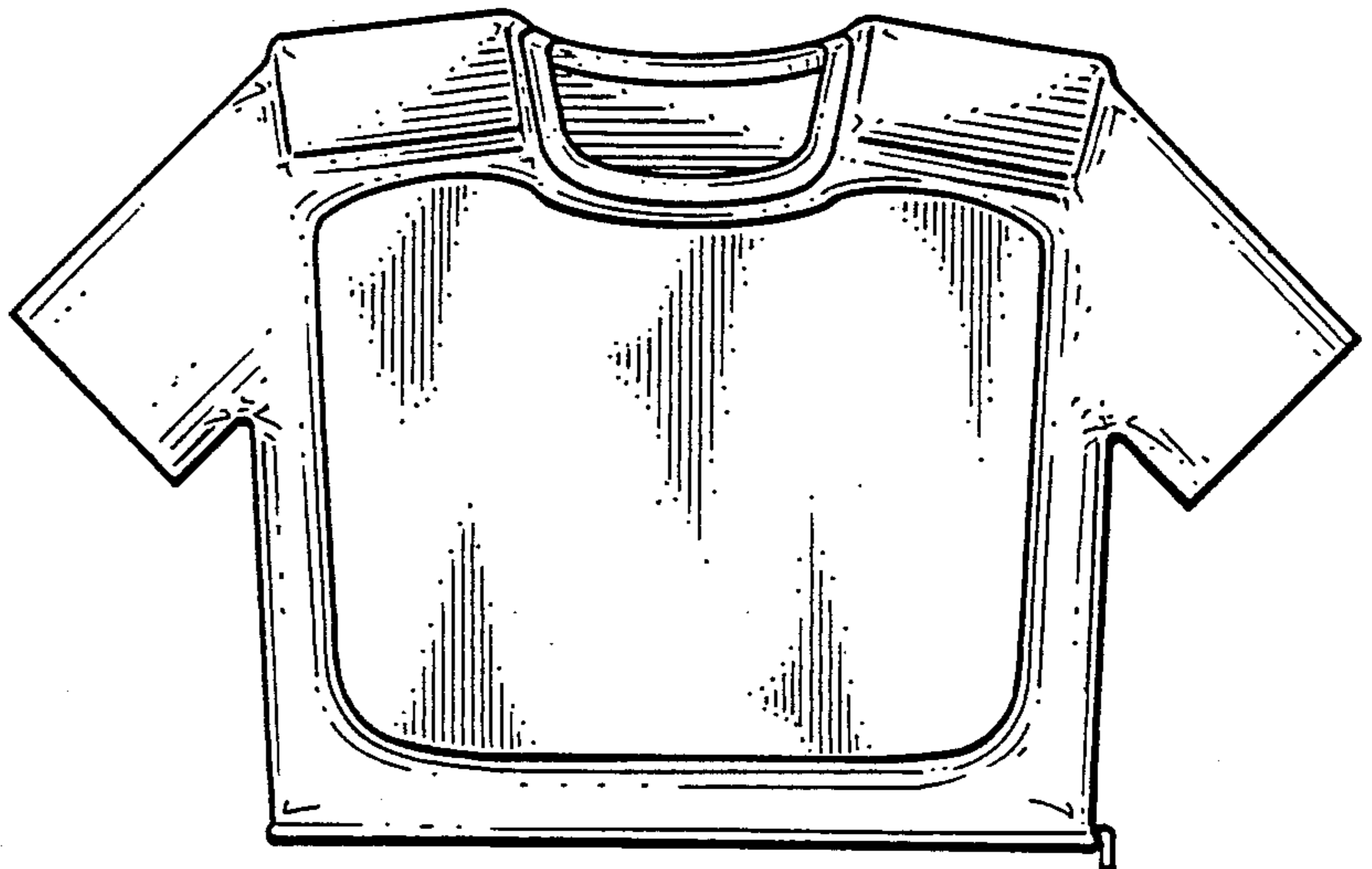

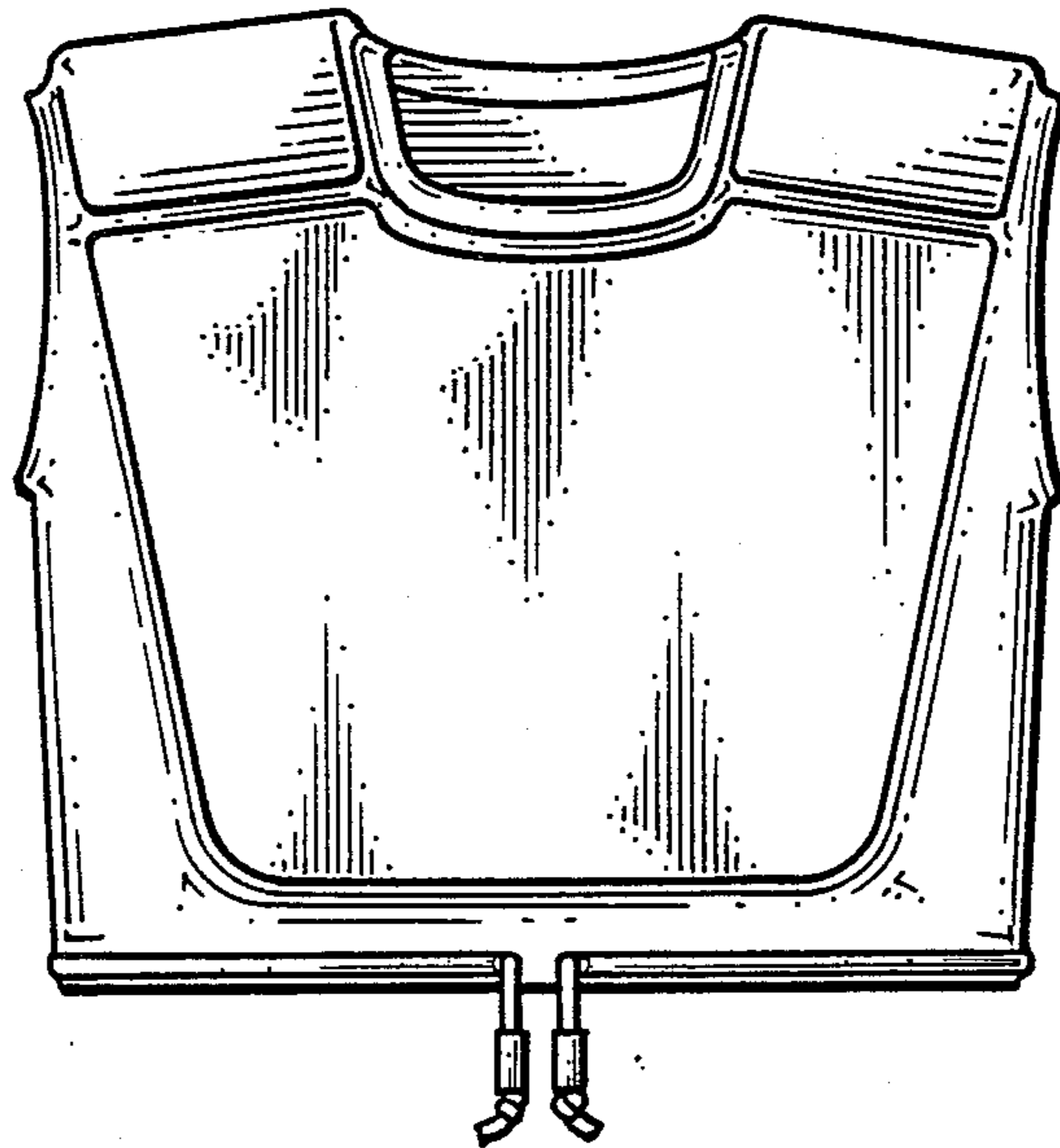

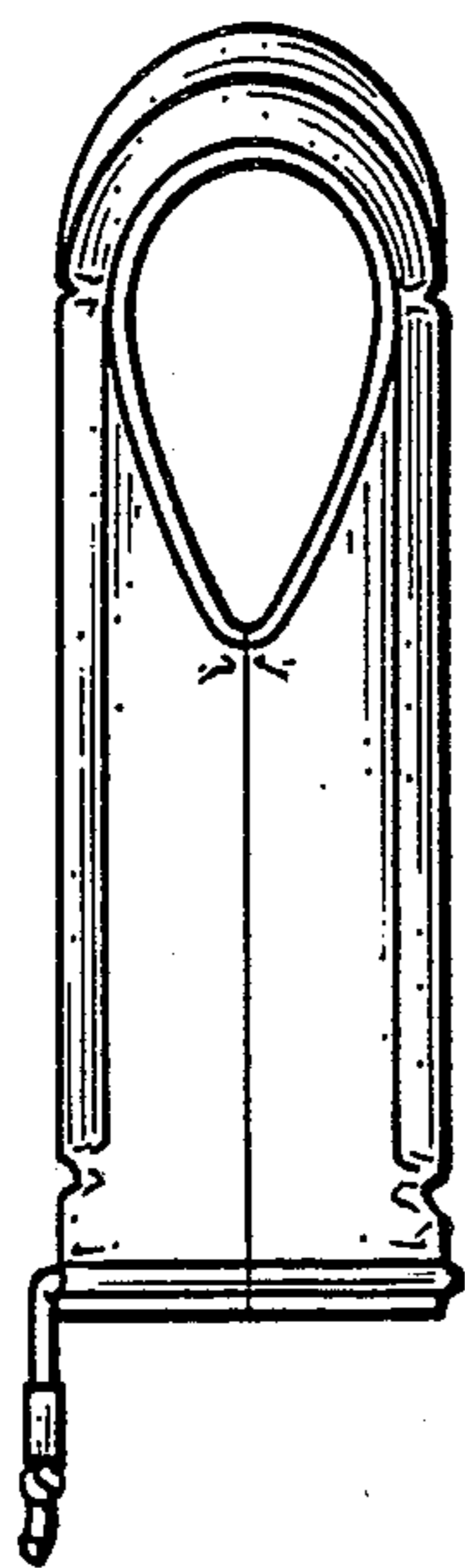

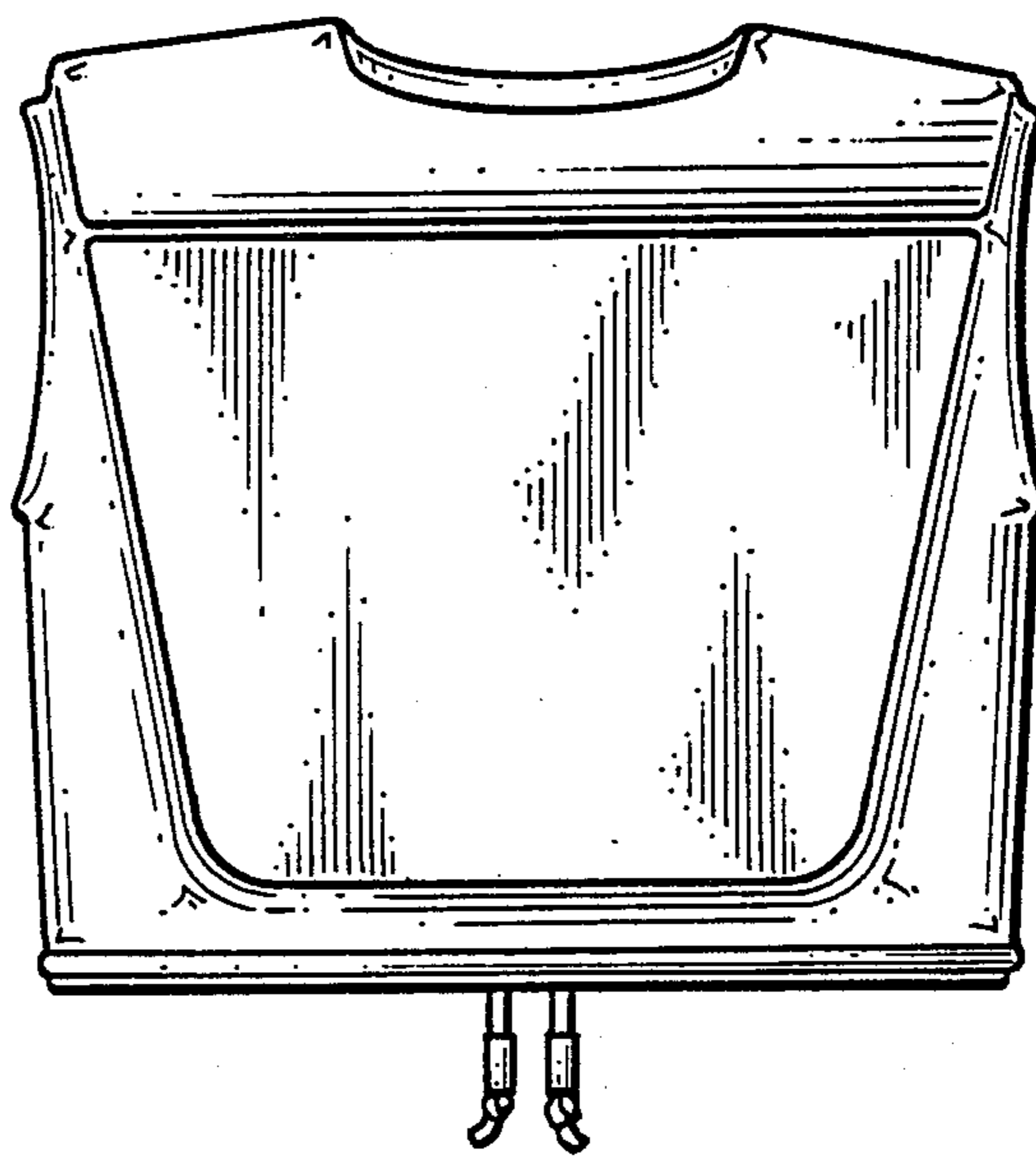

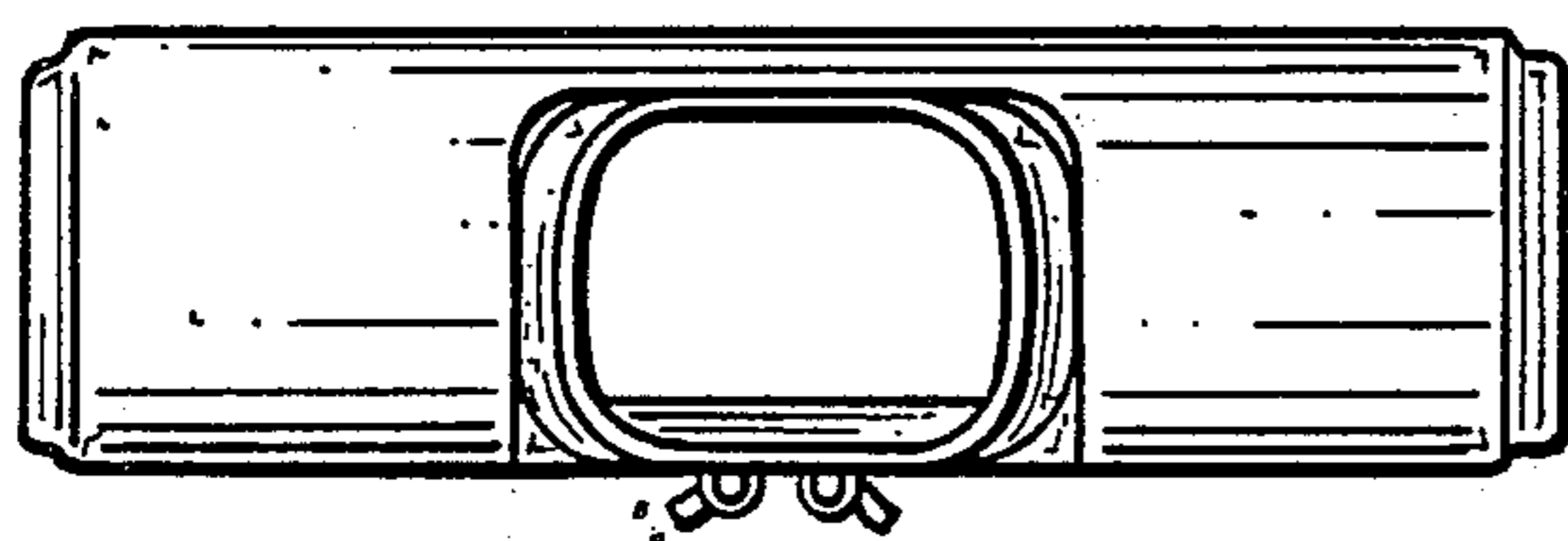

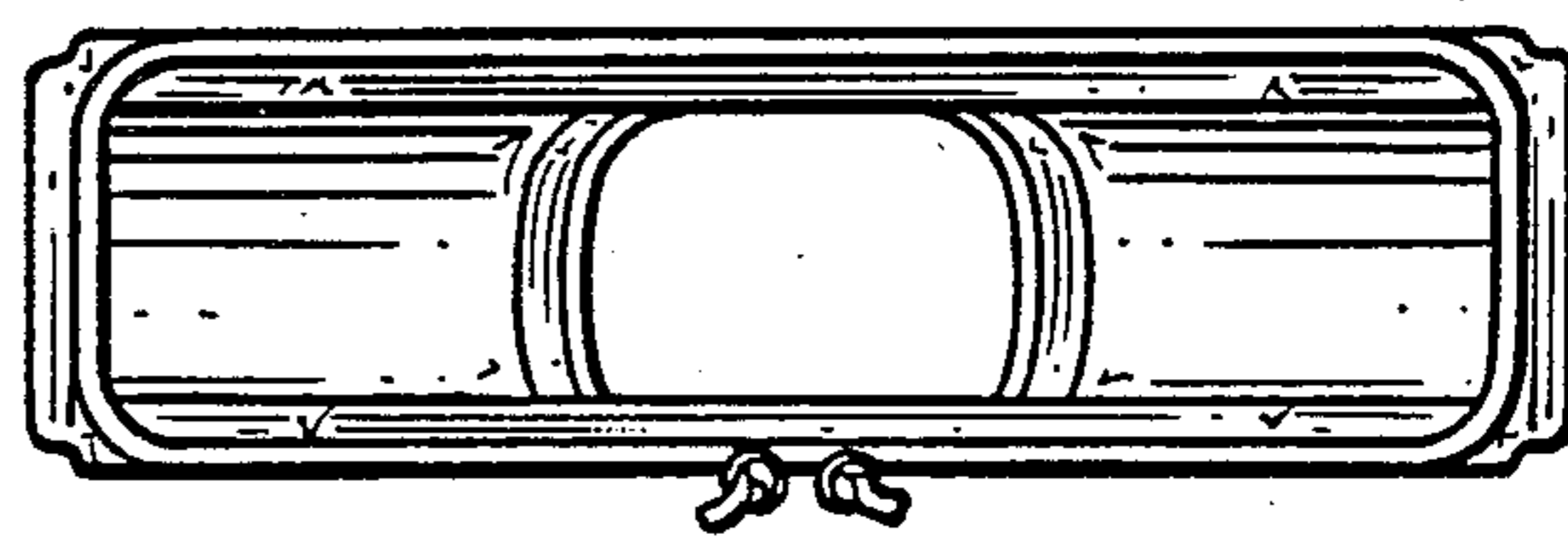
