DESCRIPTION

FIG. 1 is a perspective view of a display showing my new design, the VCR cassette shown in broken lines for illustrative purposes only;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a bottom plan view thereof;
 FIG. 4 is a front elevational view thereof;
 FIG. 5 is a left side elevational view thereof, the opposite side being a mirror image;
 FIG. 6 is a rear elevational view thereof; and,
 FIG. 7 is a plan view thereof, shown in an unassembled condition.

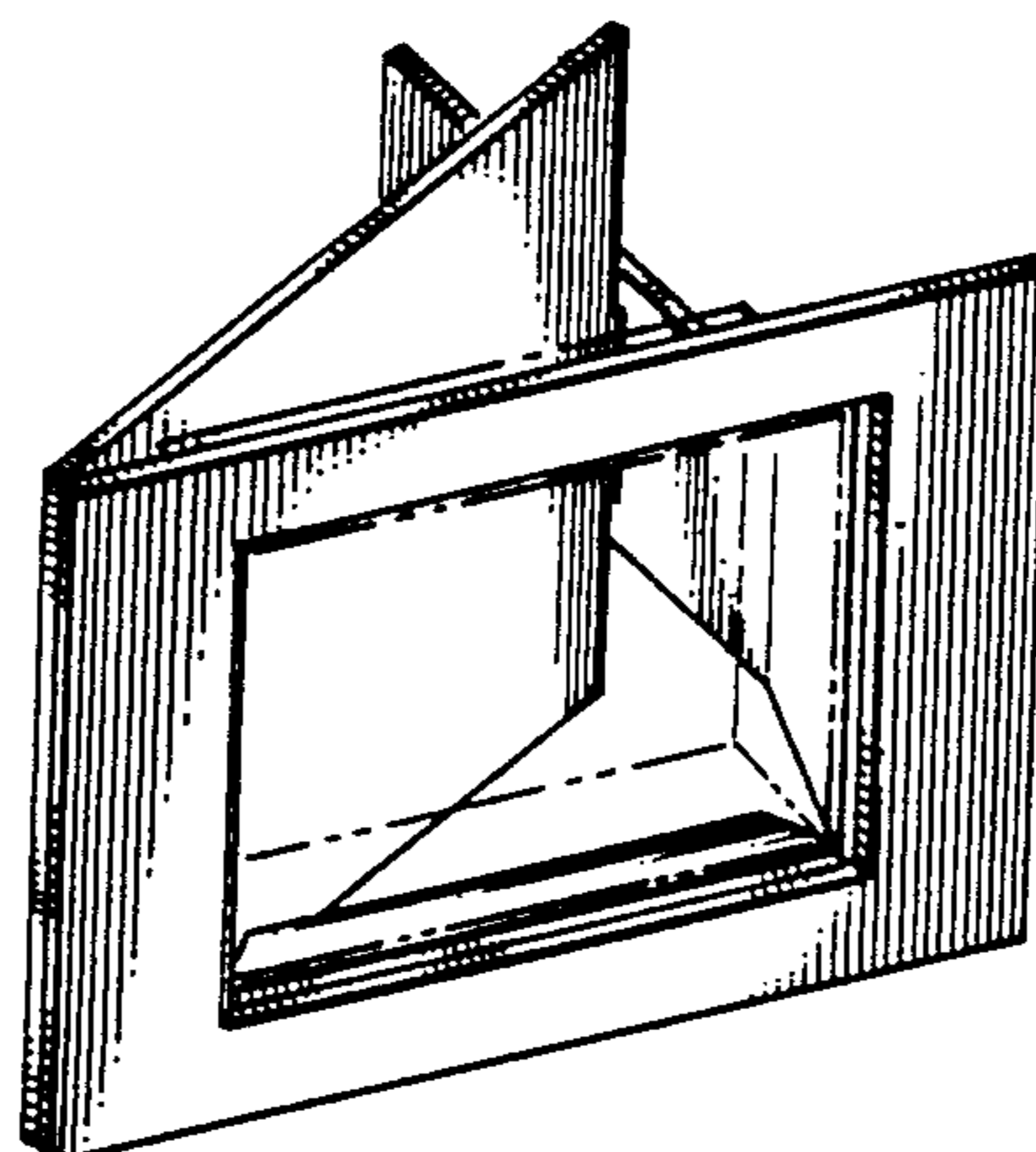
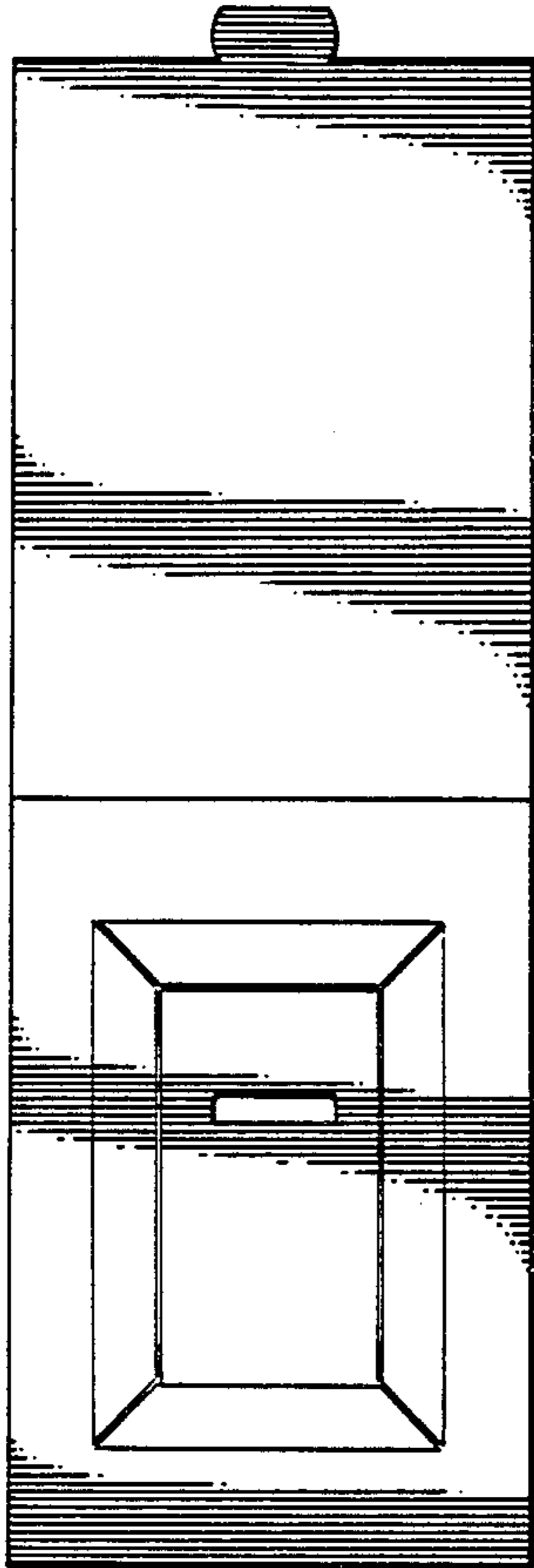

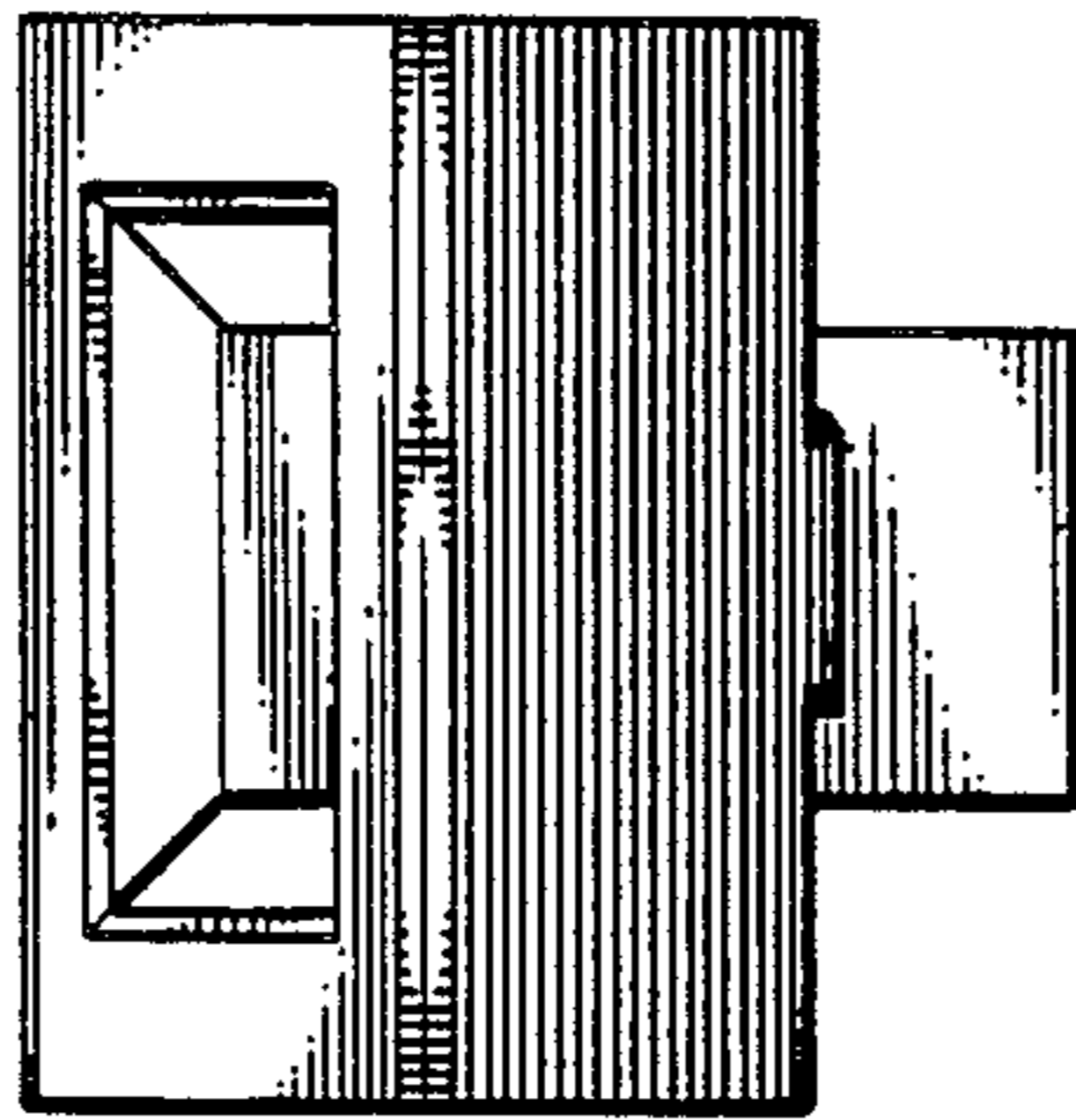
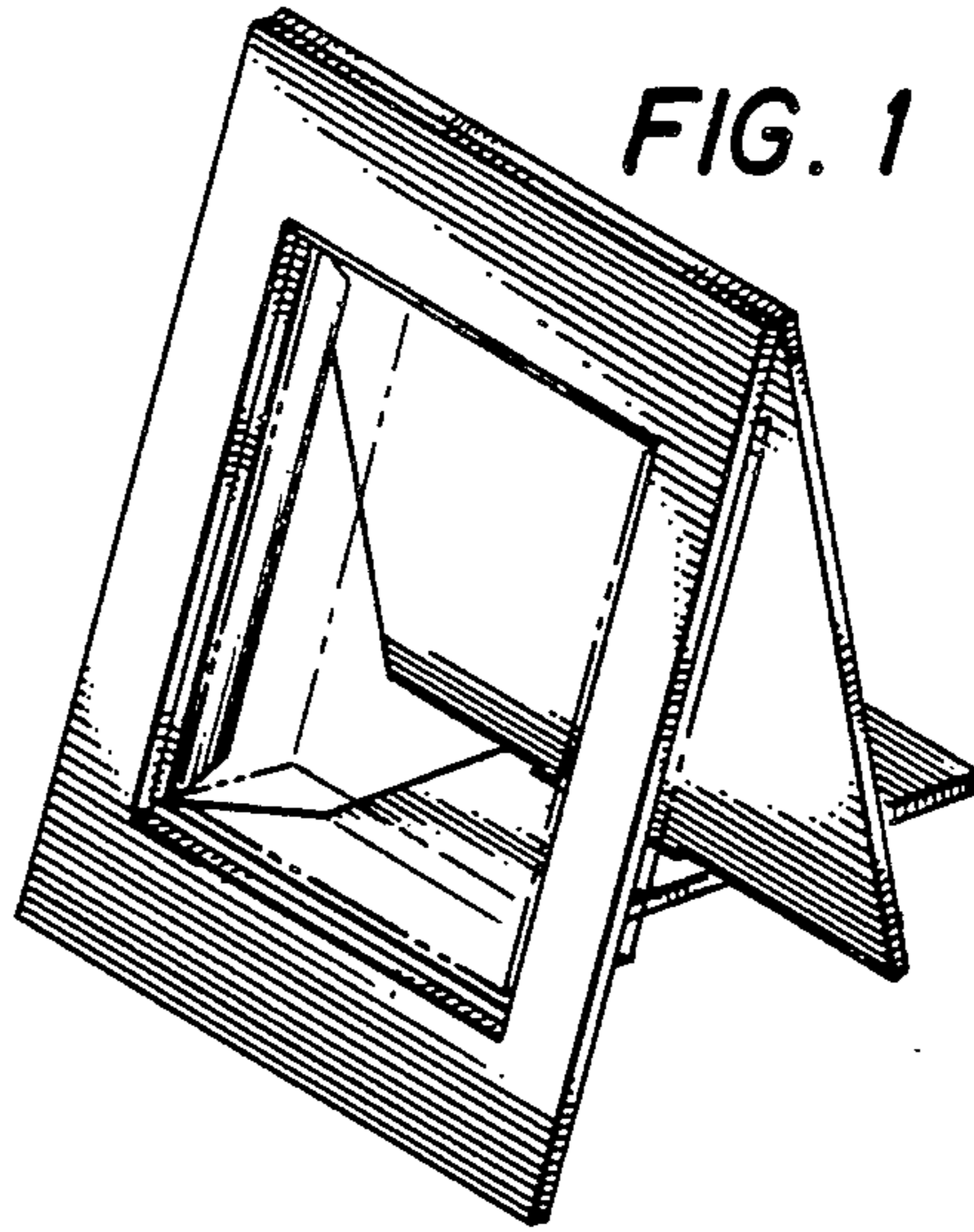

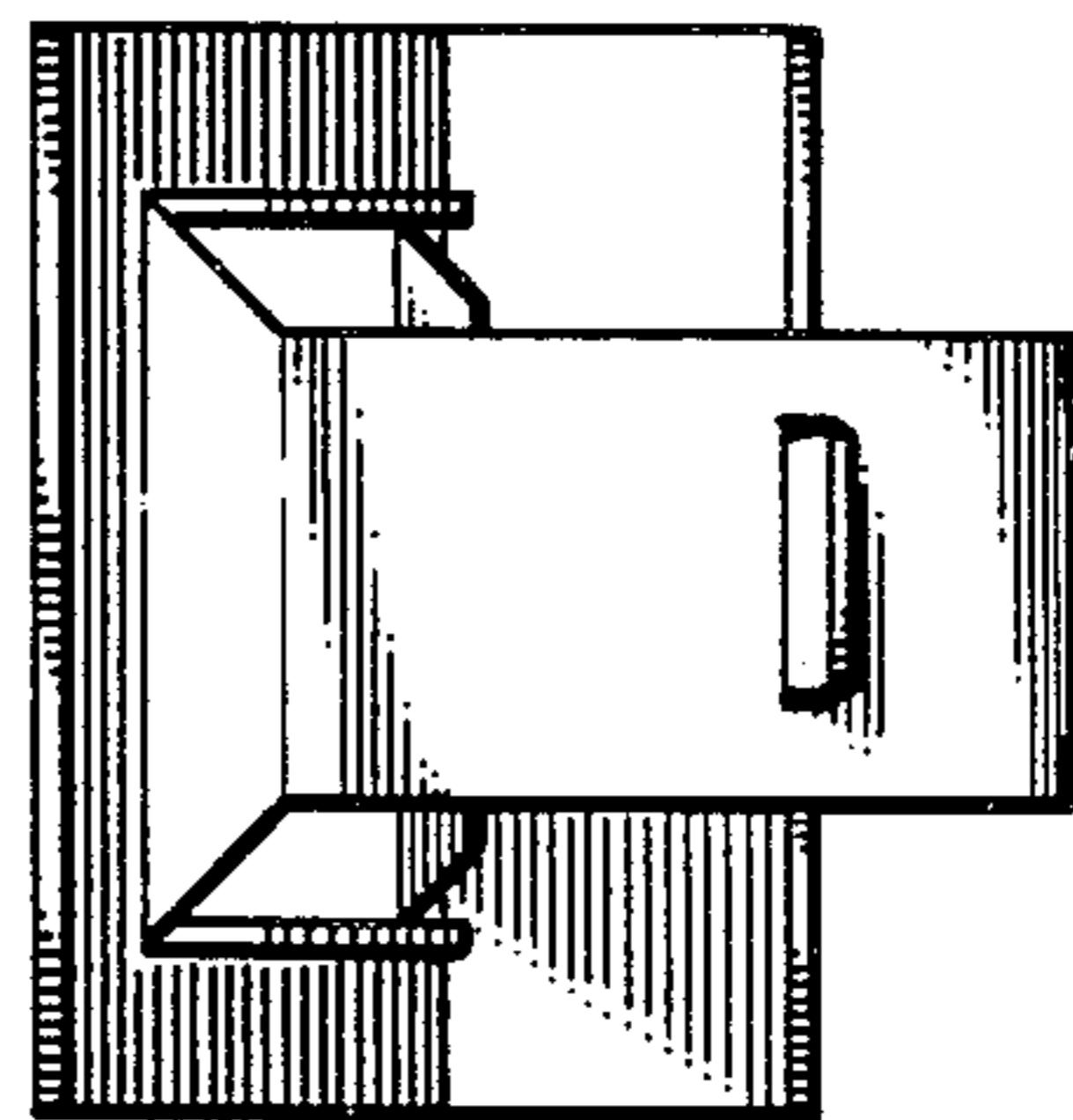

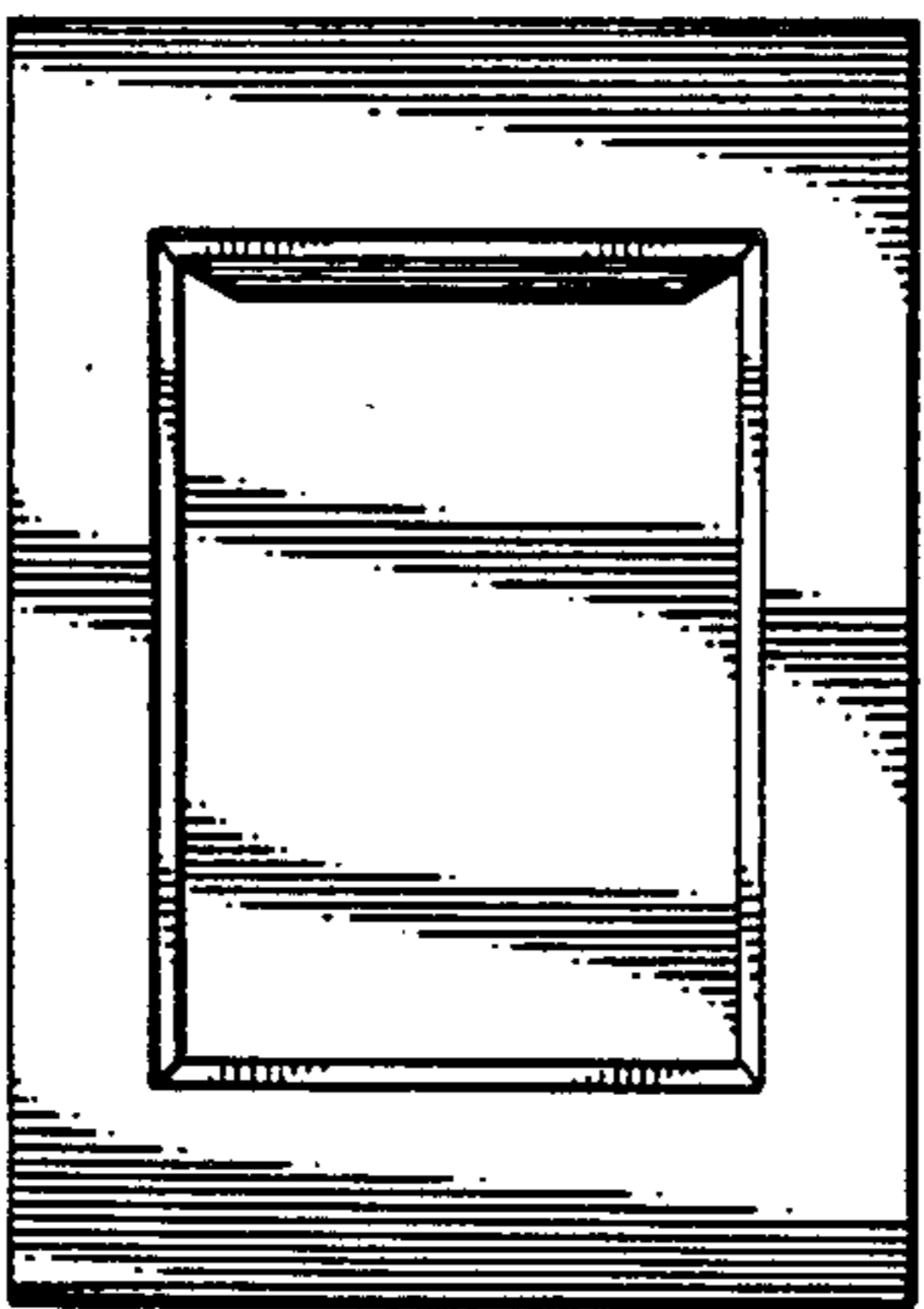

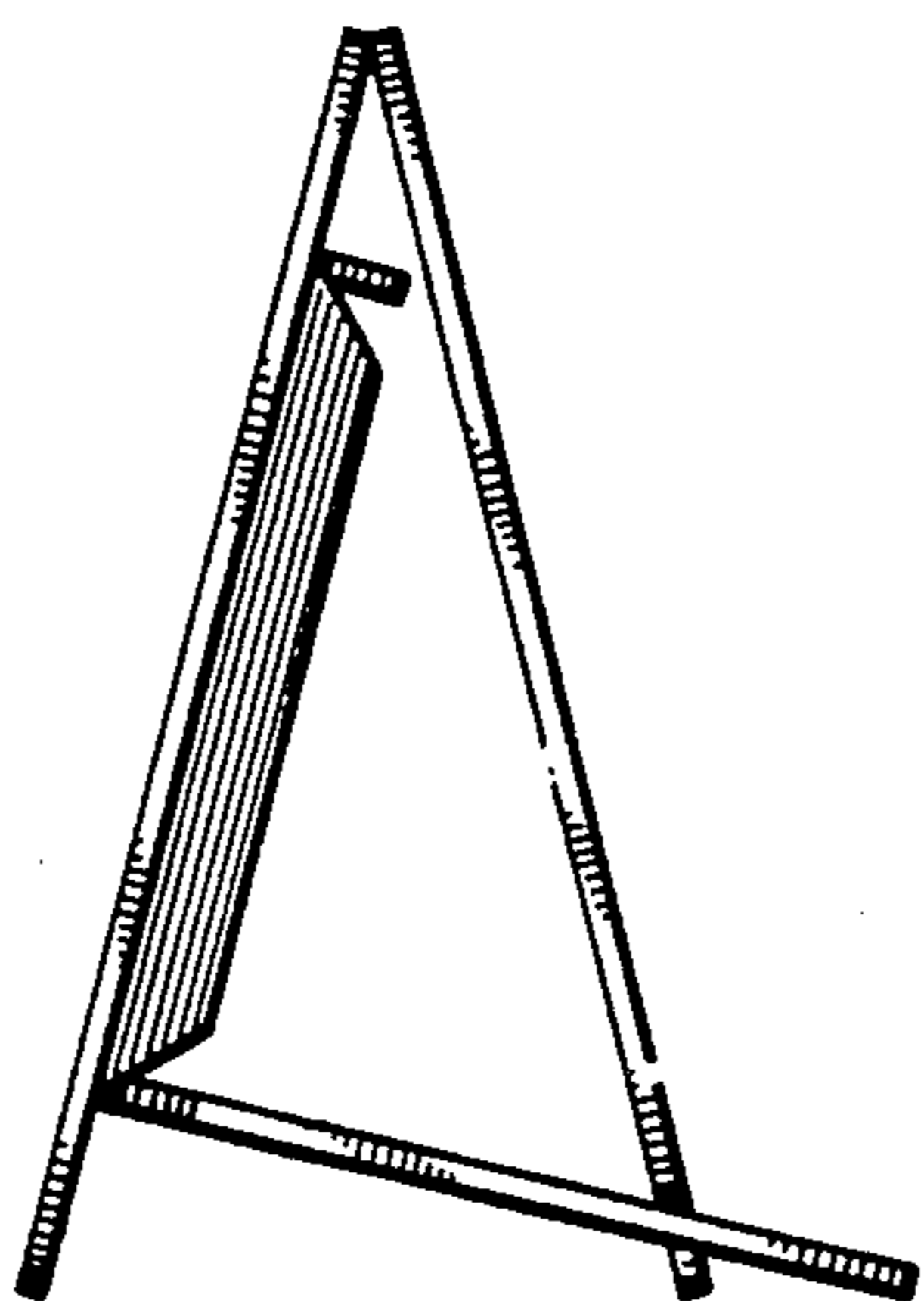

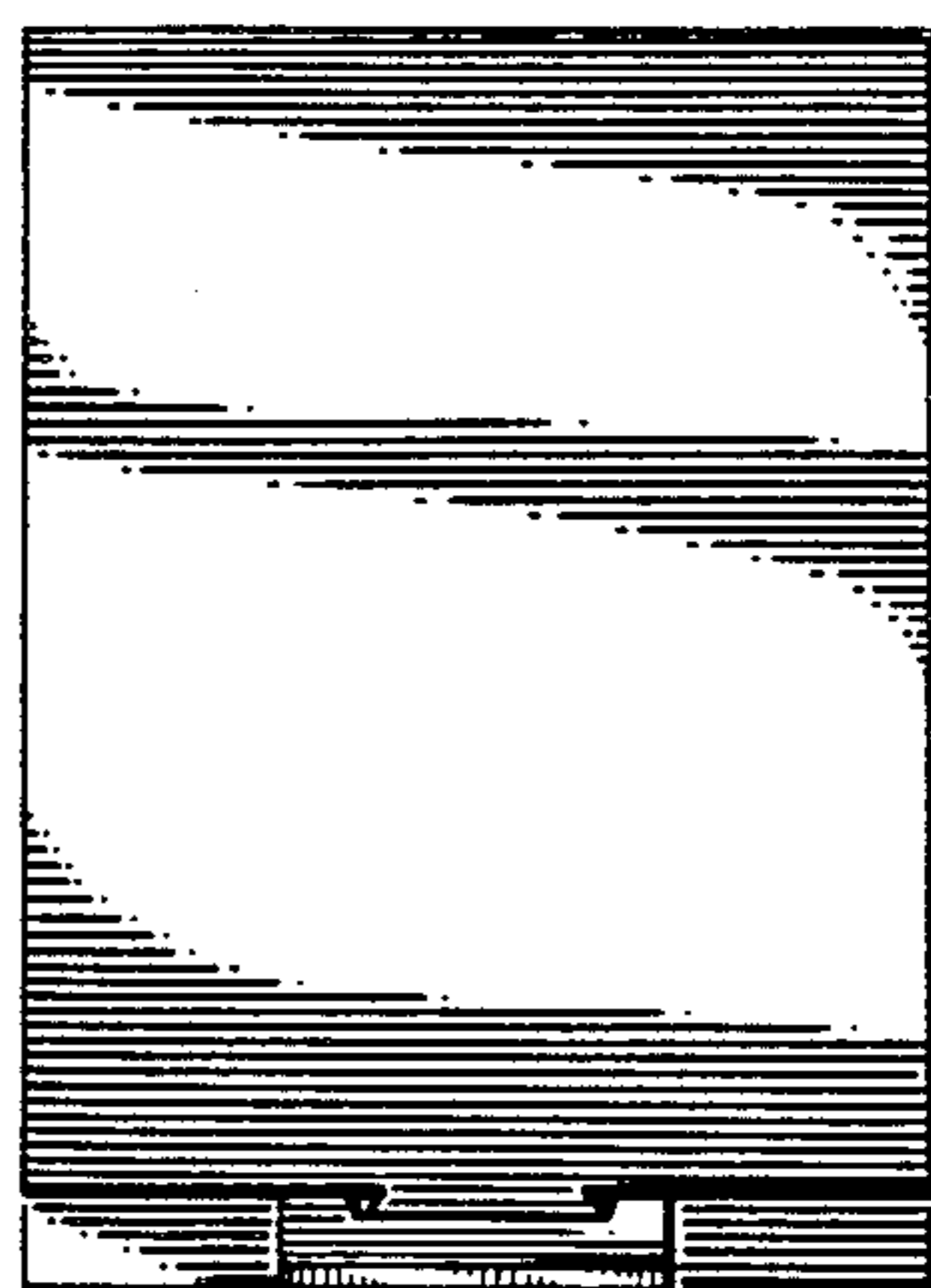
