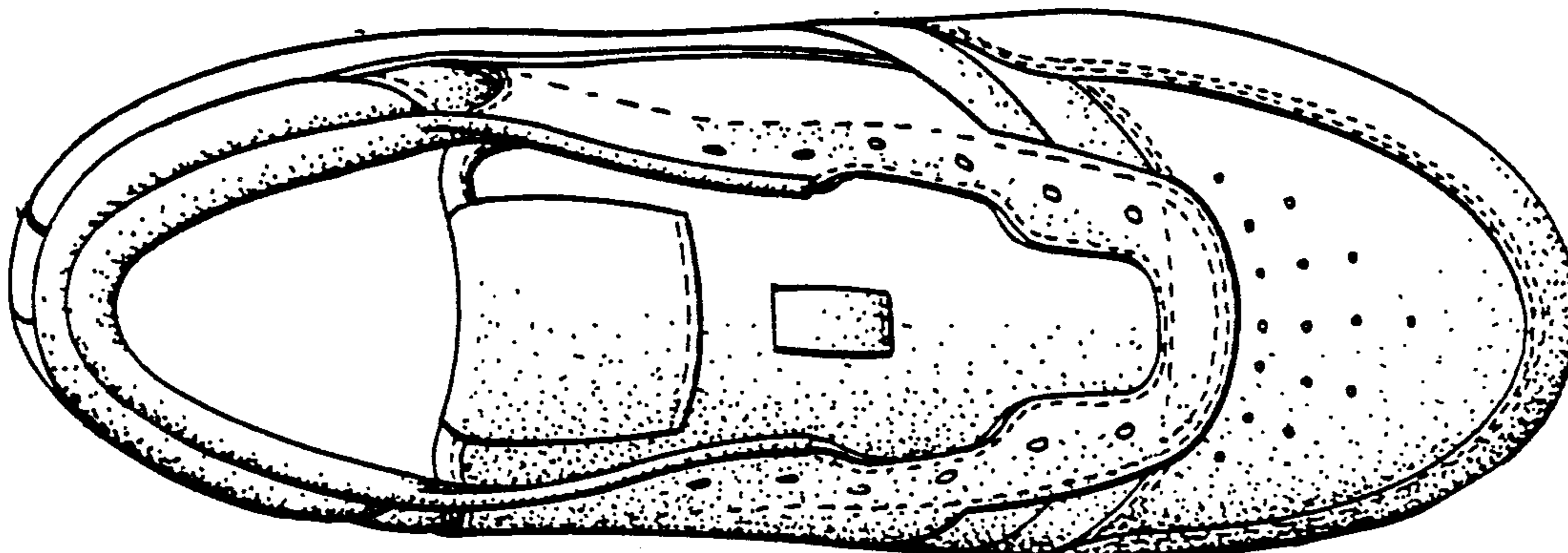
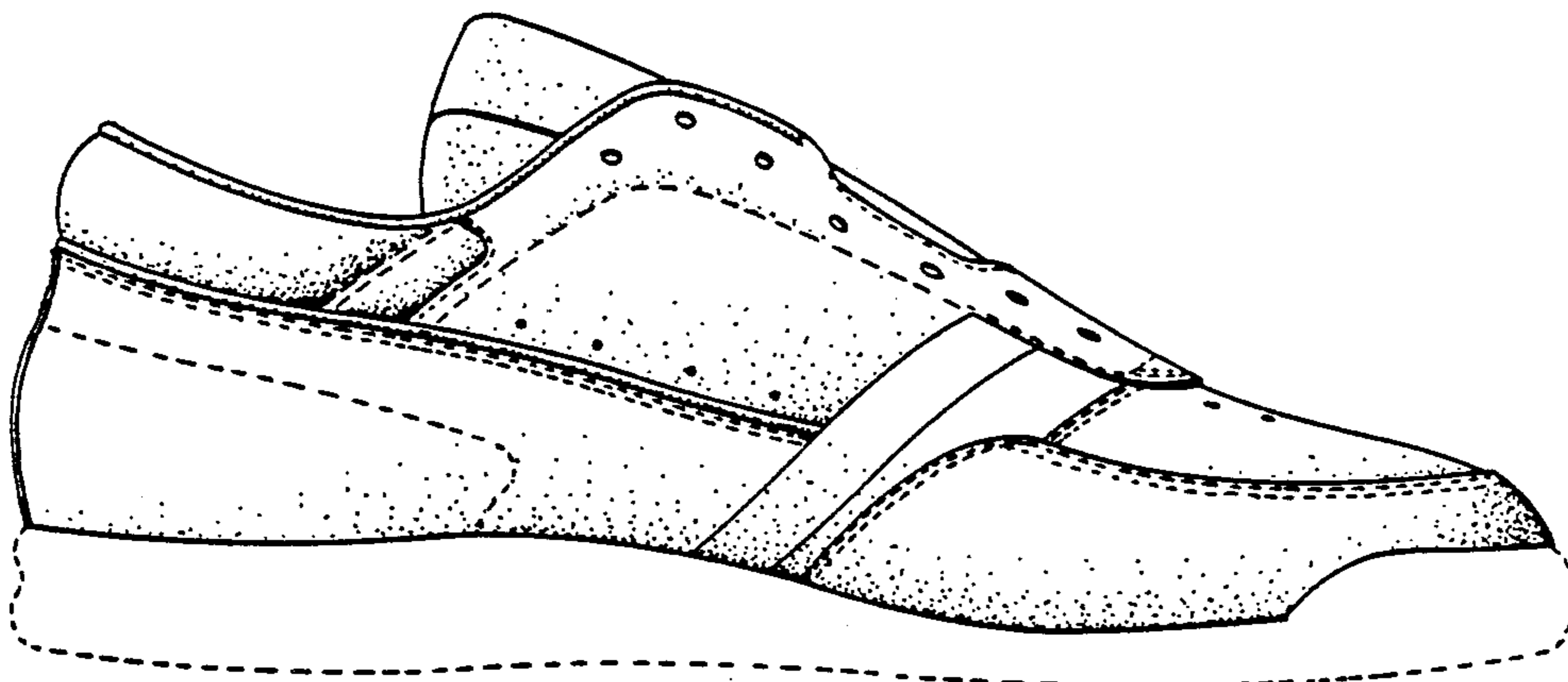

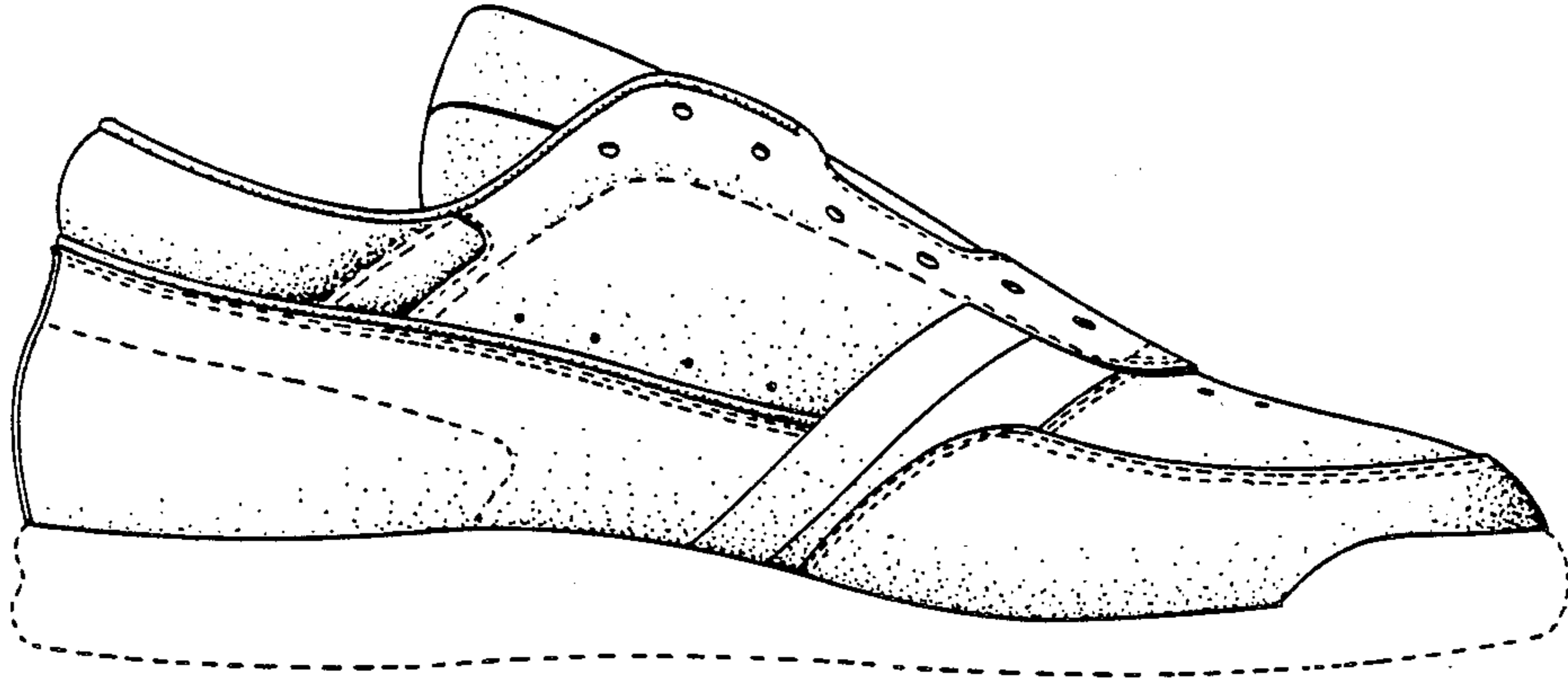
The ornamental design for a shoe upper, as shown and described.

**DESCRIPTION**

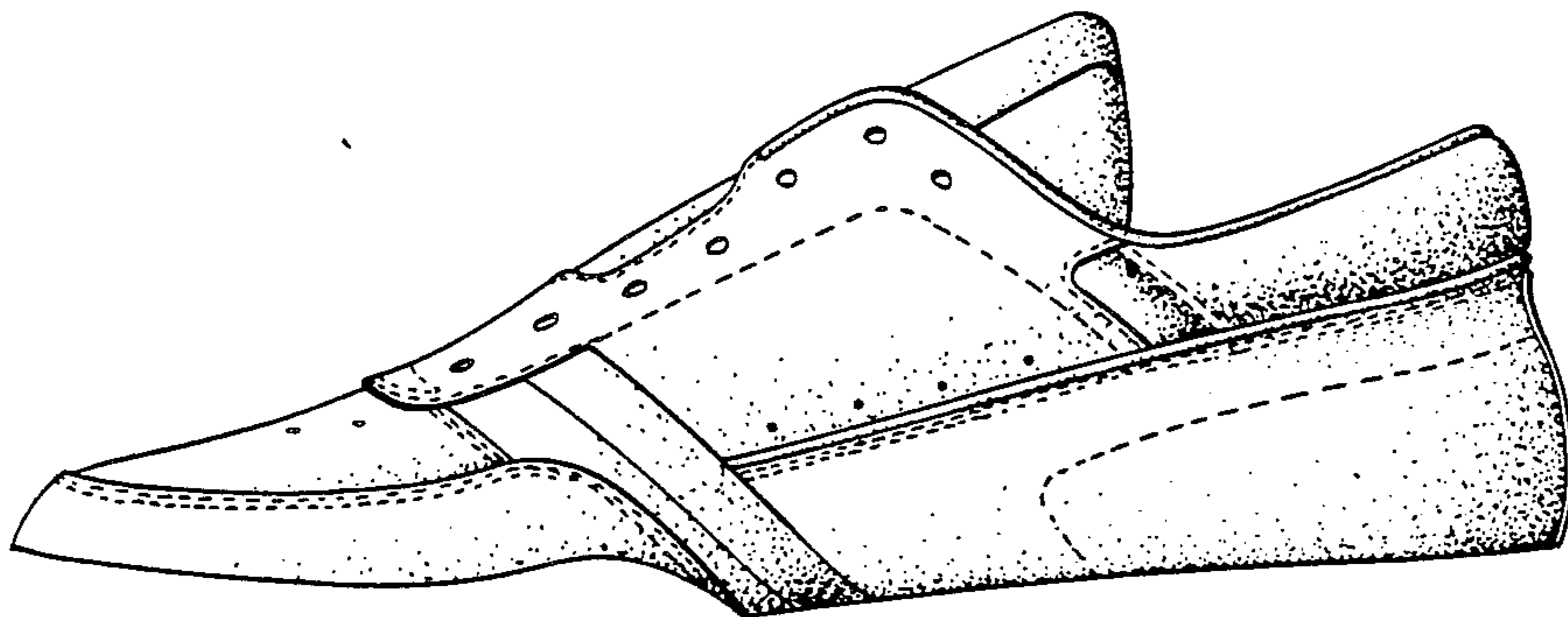

 FIG. 5 is a rear elevational view thereof.



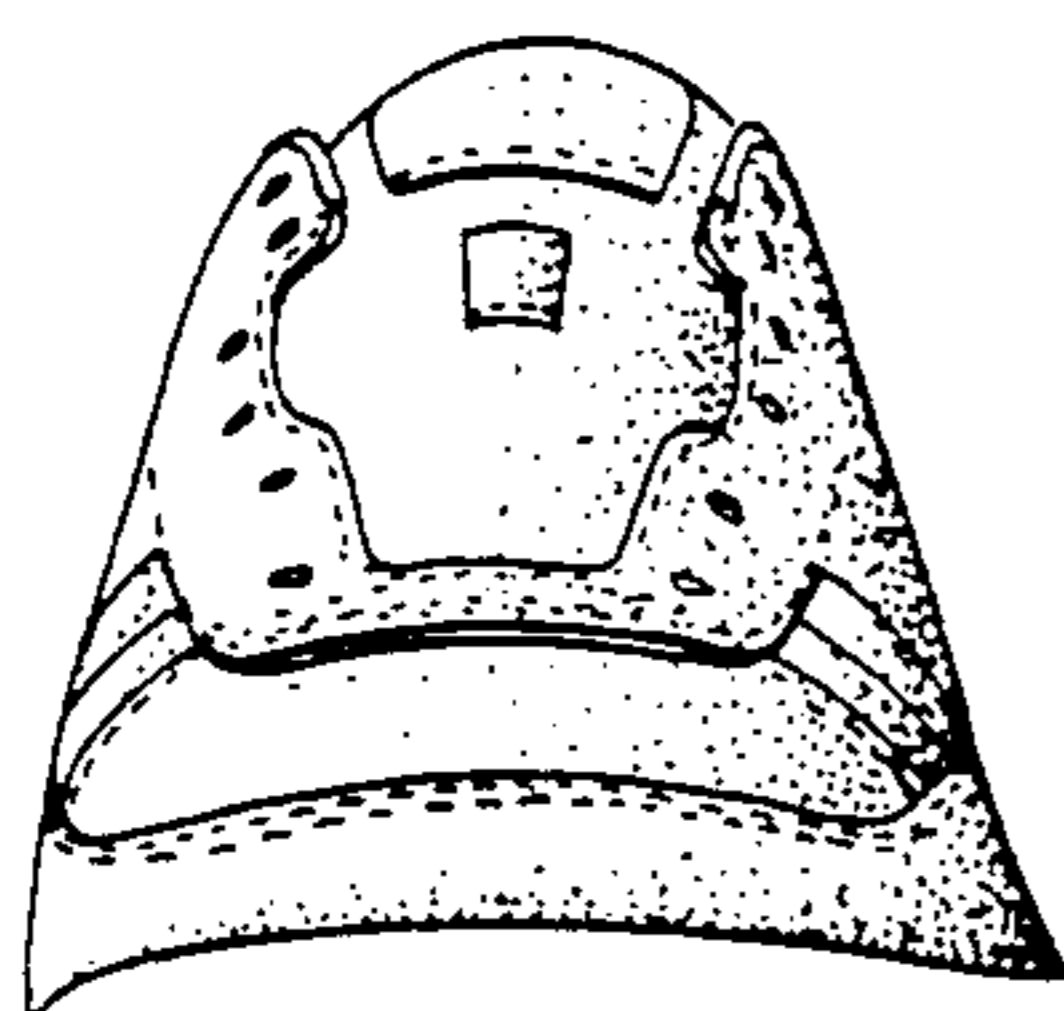
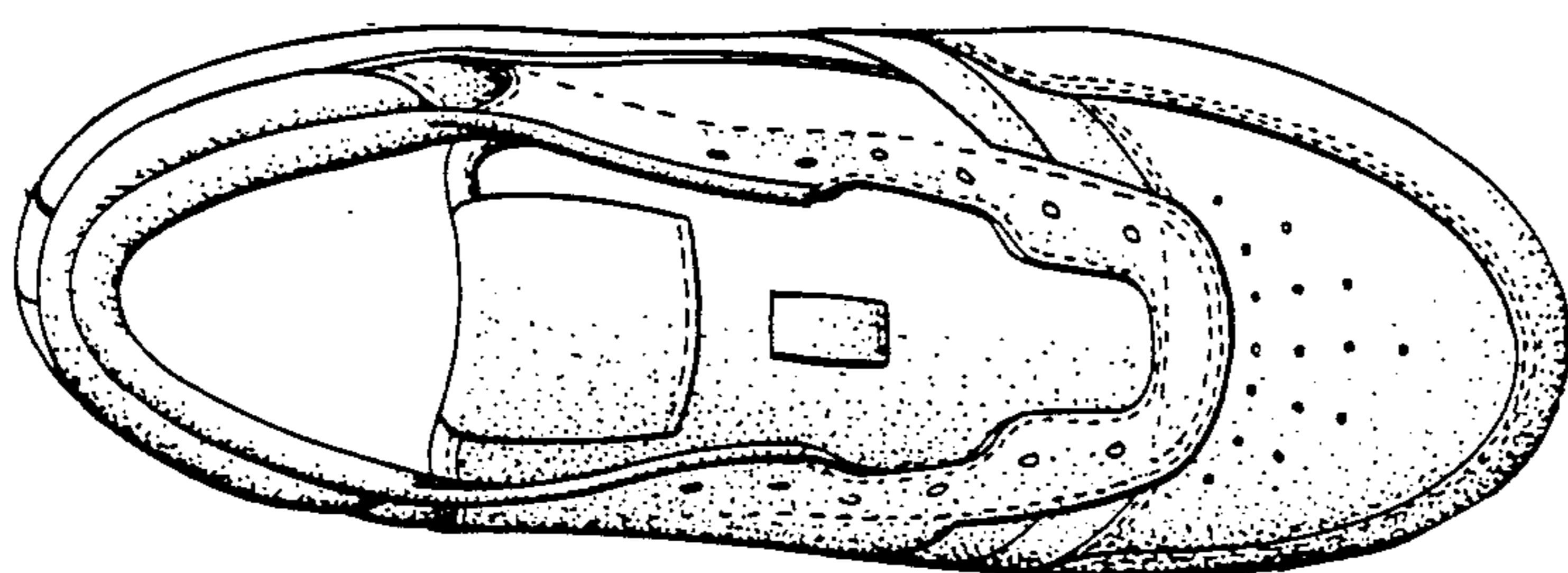

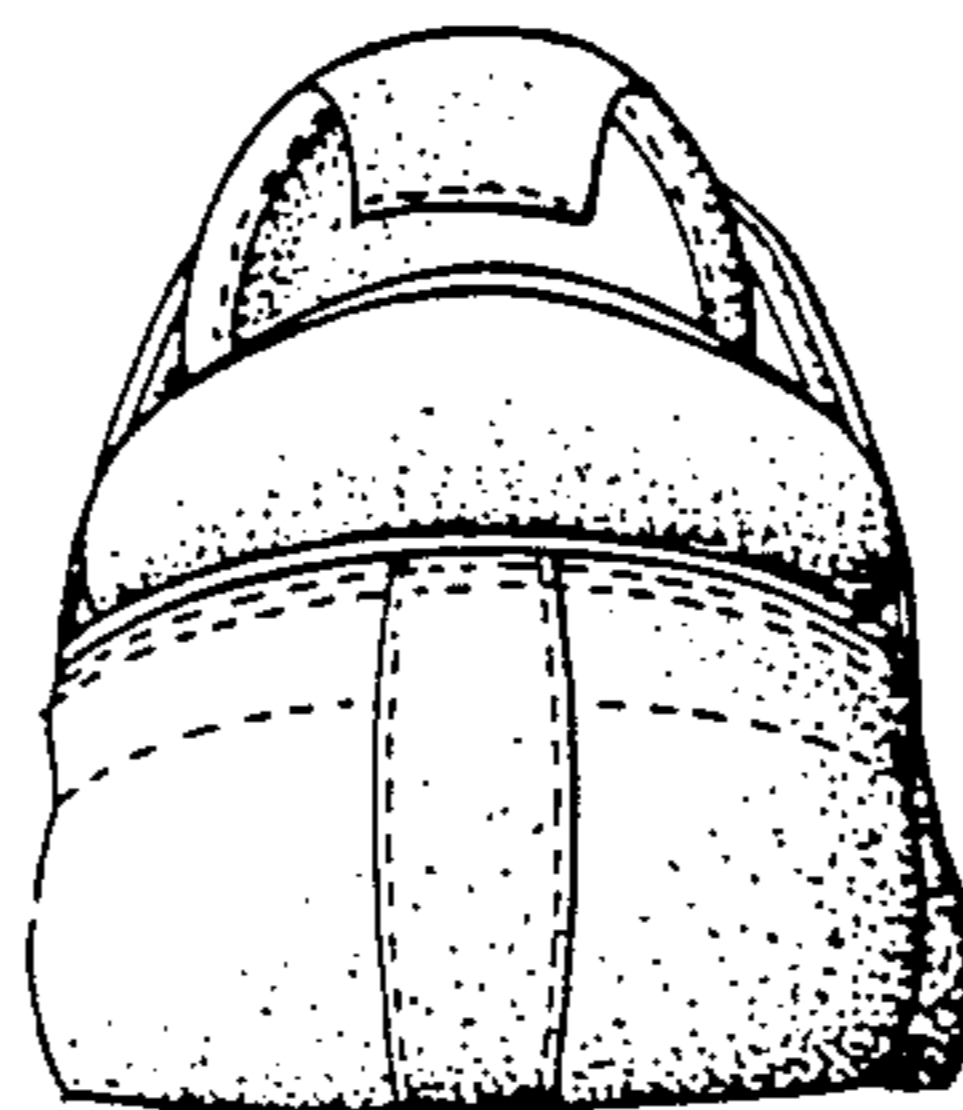
