[57] CLAIM

The ornamental design for an electronic oven, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front, top and right side perspective view of an electronic oven showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a right side elevational view thereof, the left side being a mirror image; FIG. 4 is a top plan view thereof; FIG. 5 is a rear elevational view thereof; and FIG. 6 is a front elevational view thereof, showing the transparent window within the dark colored door during operation.

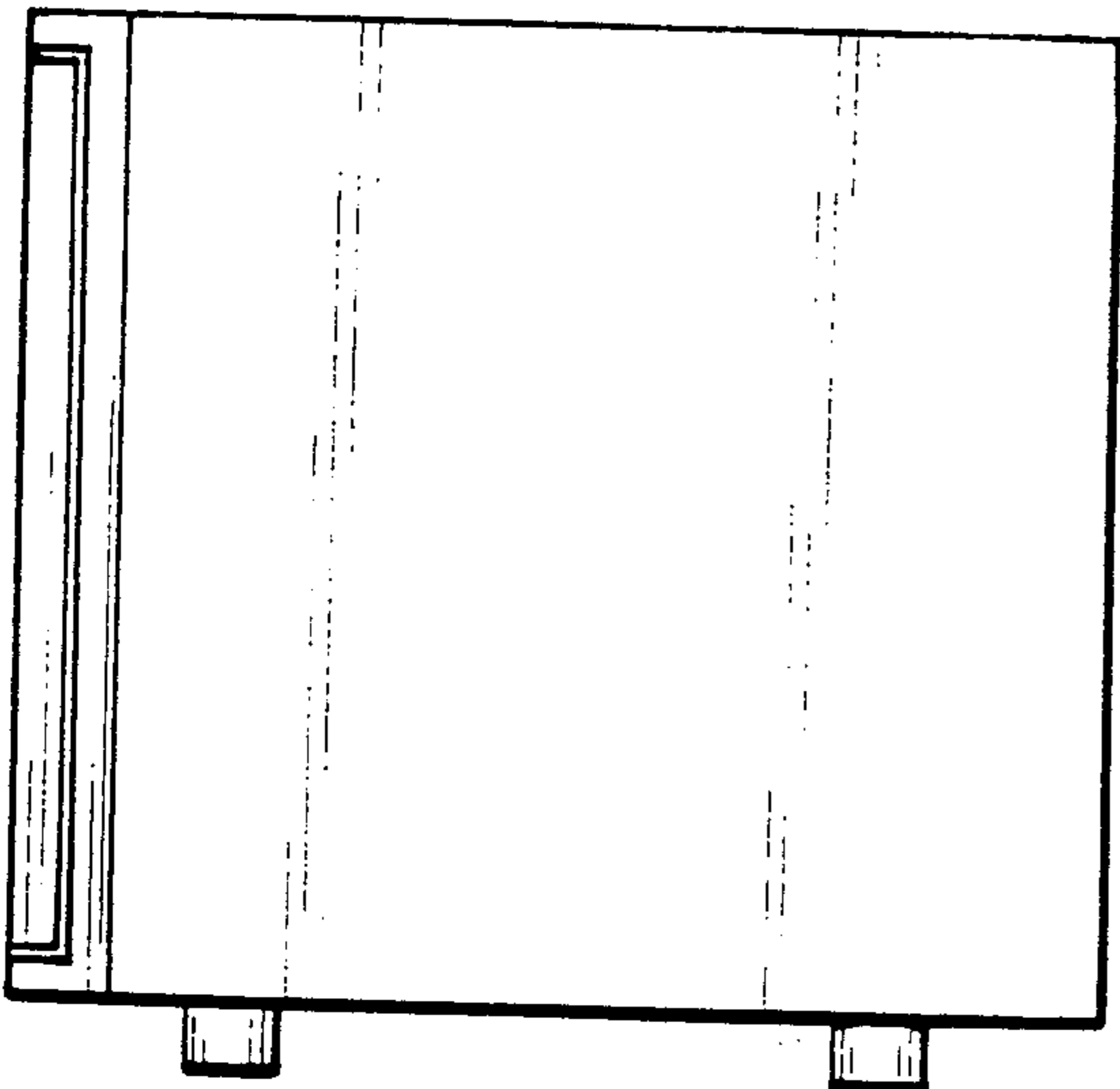
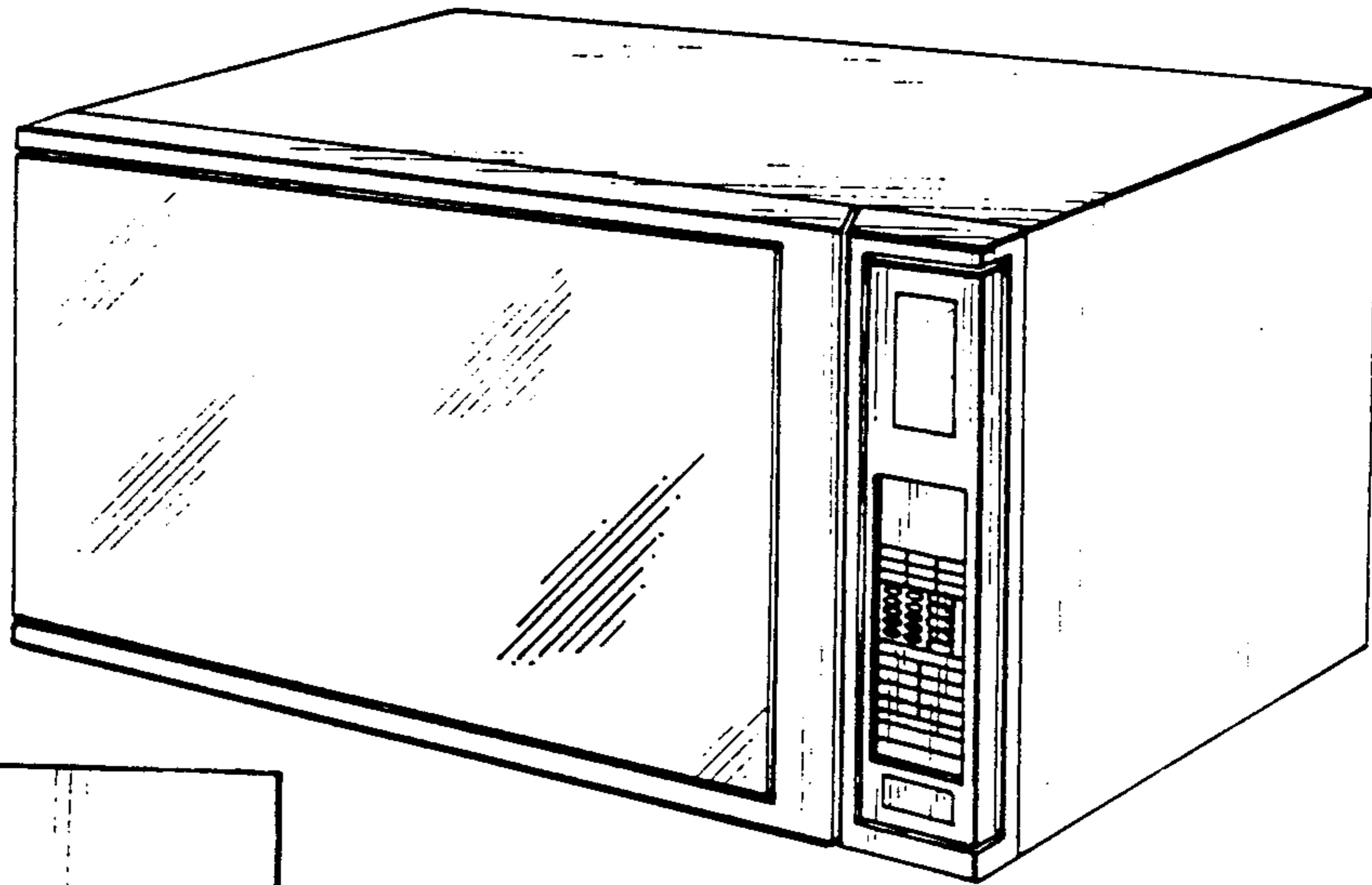

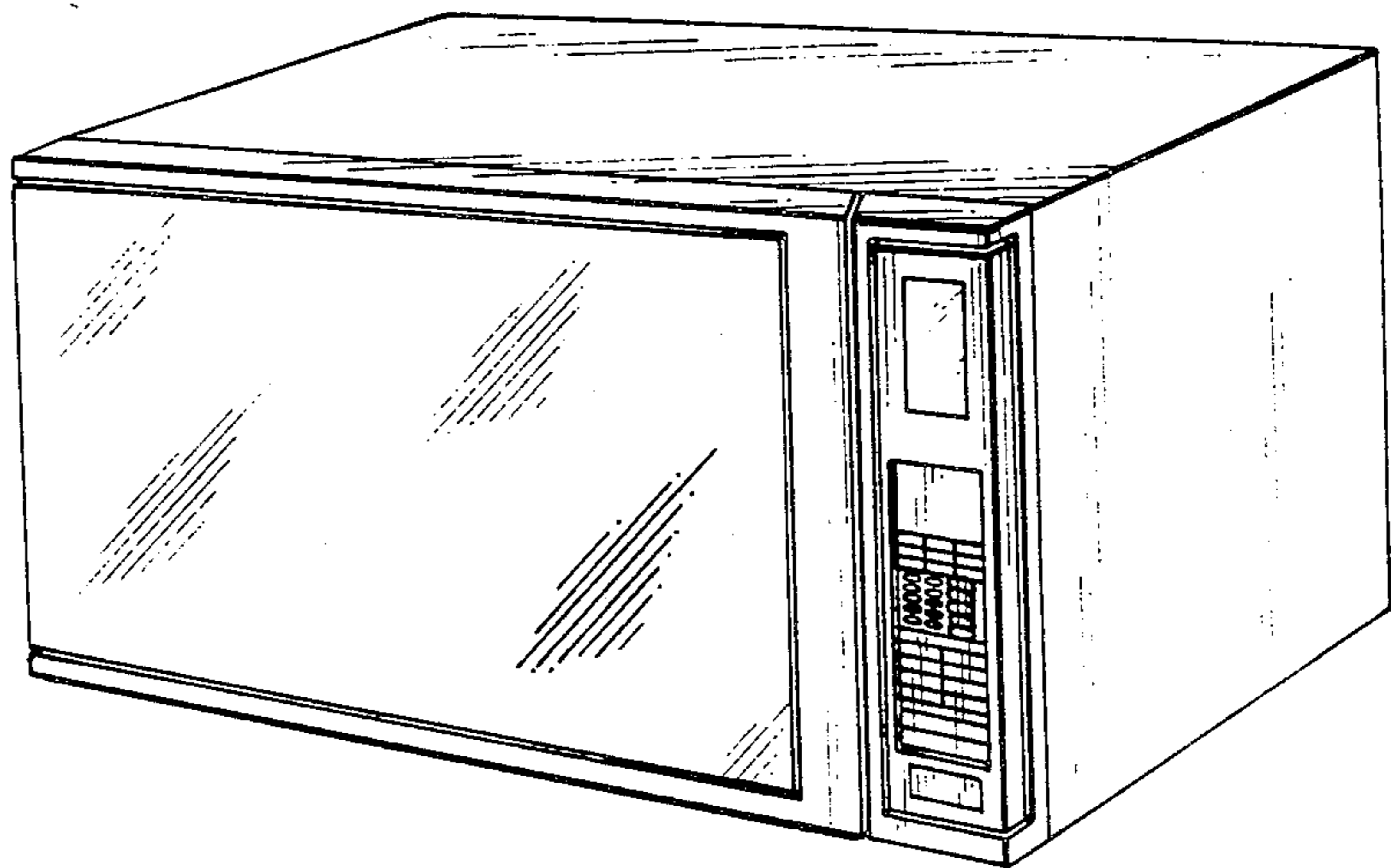

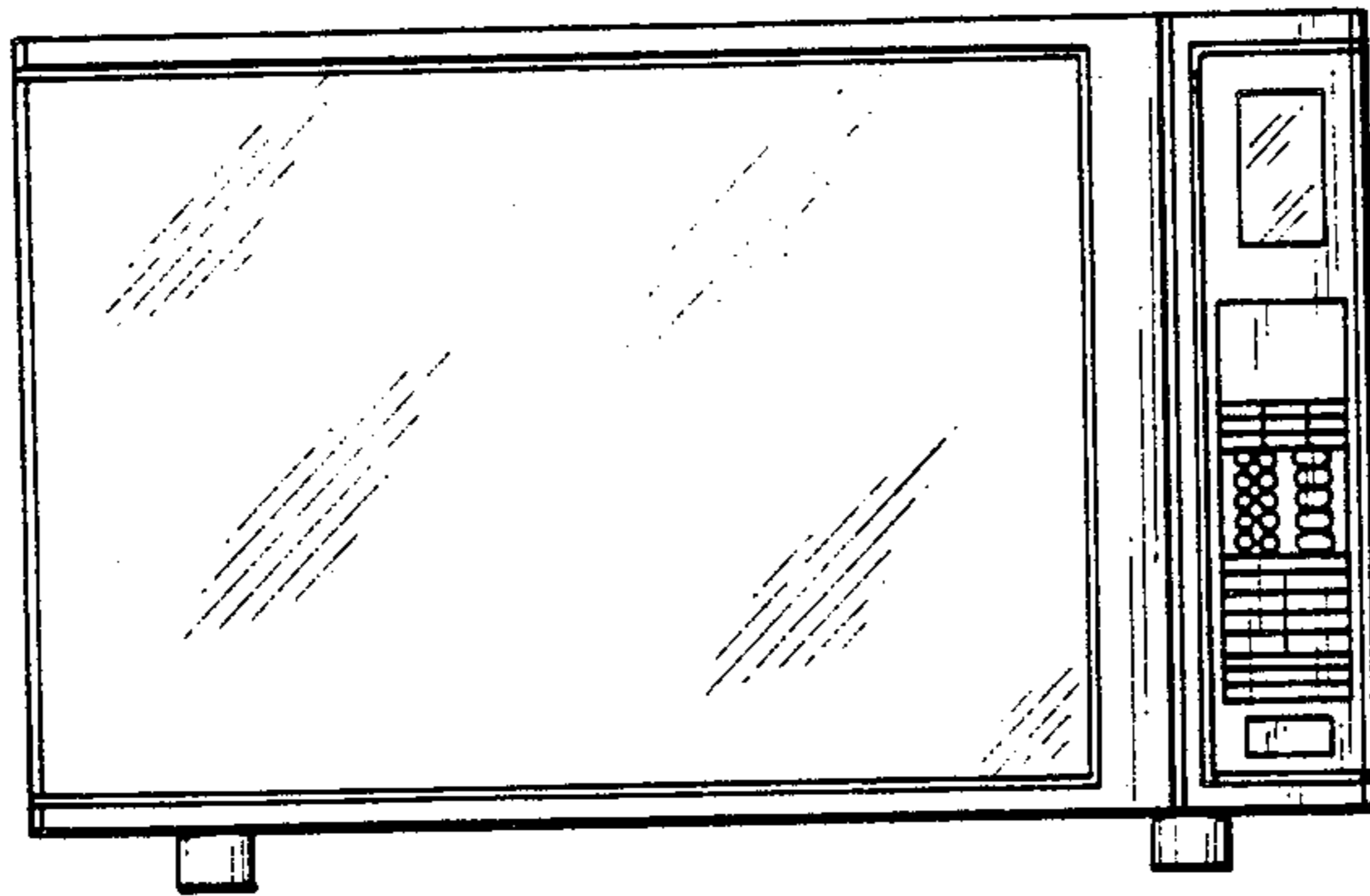

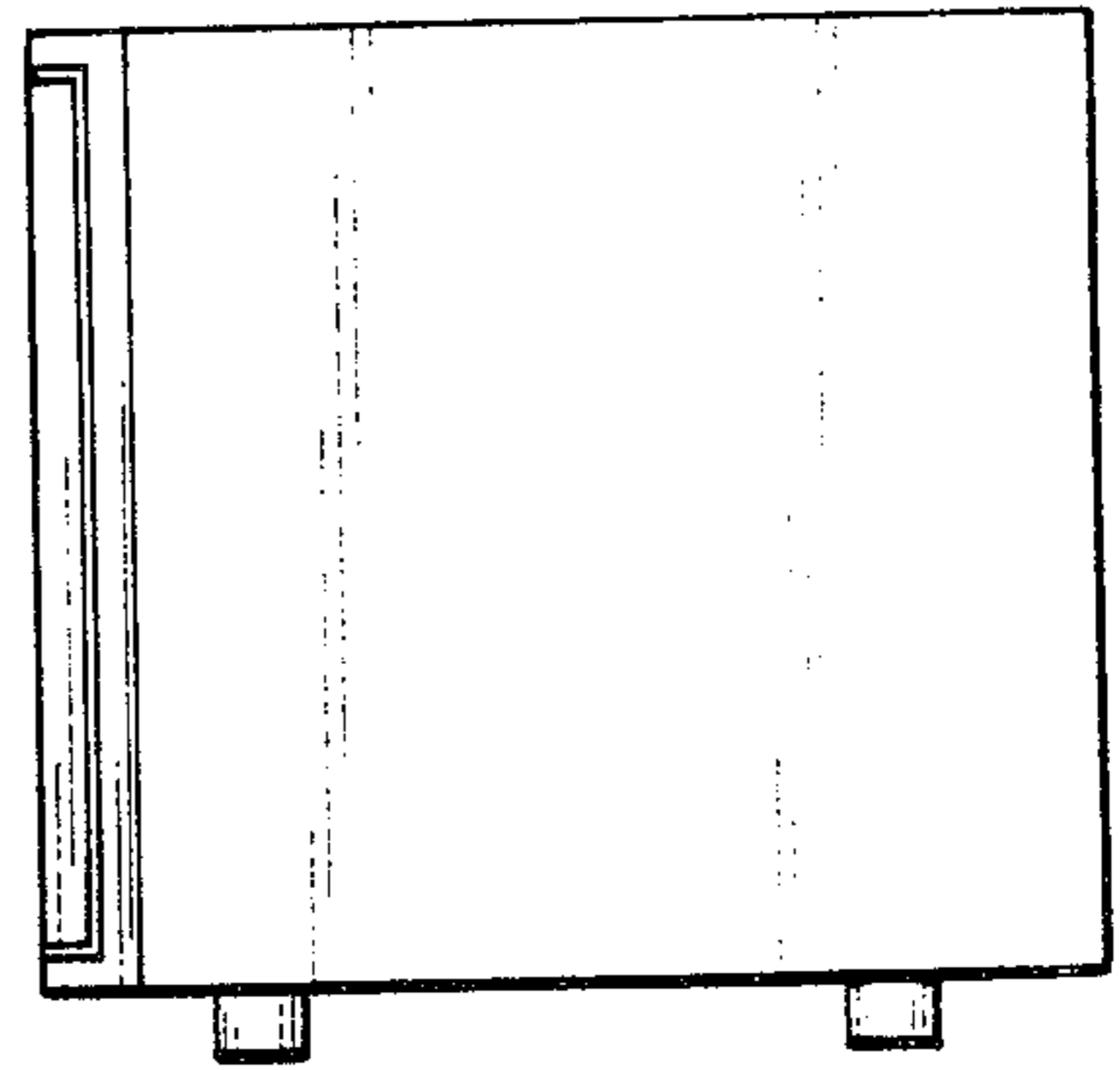

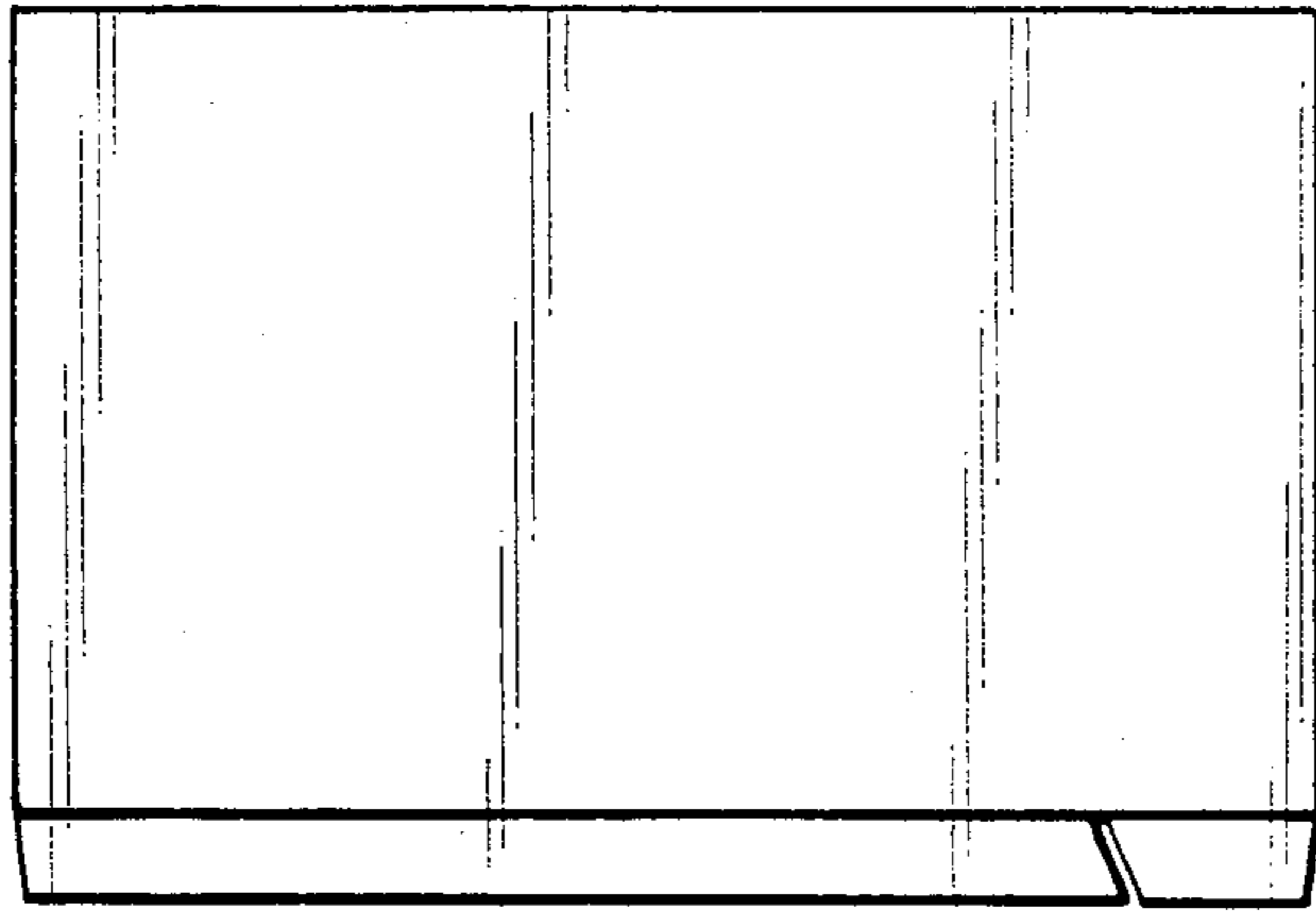

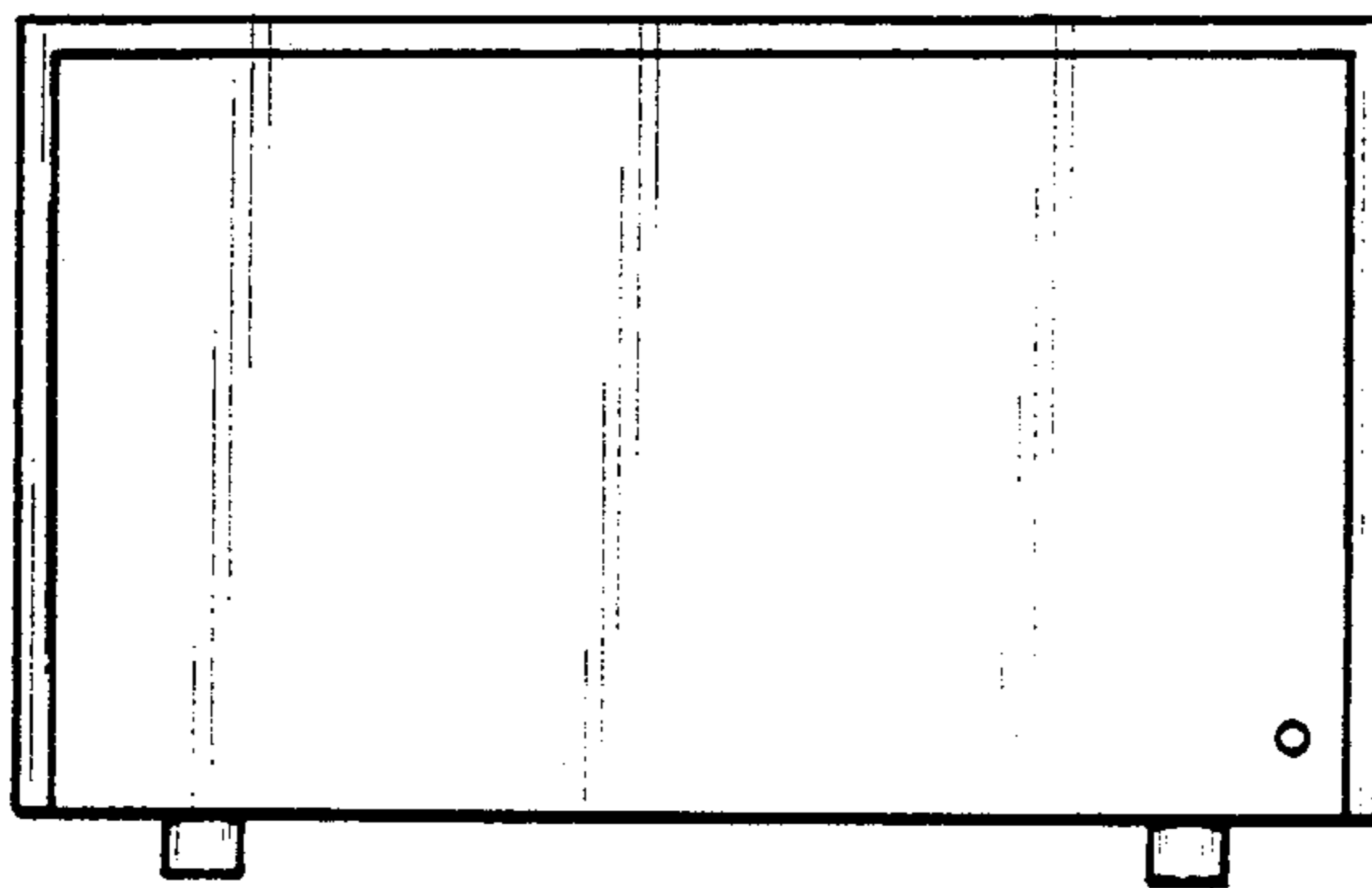
